FIG. 3 is a back view of the drinking vessel.

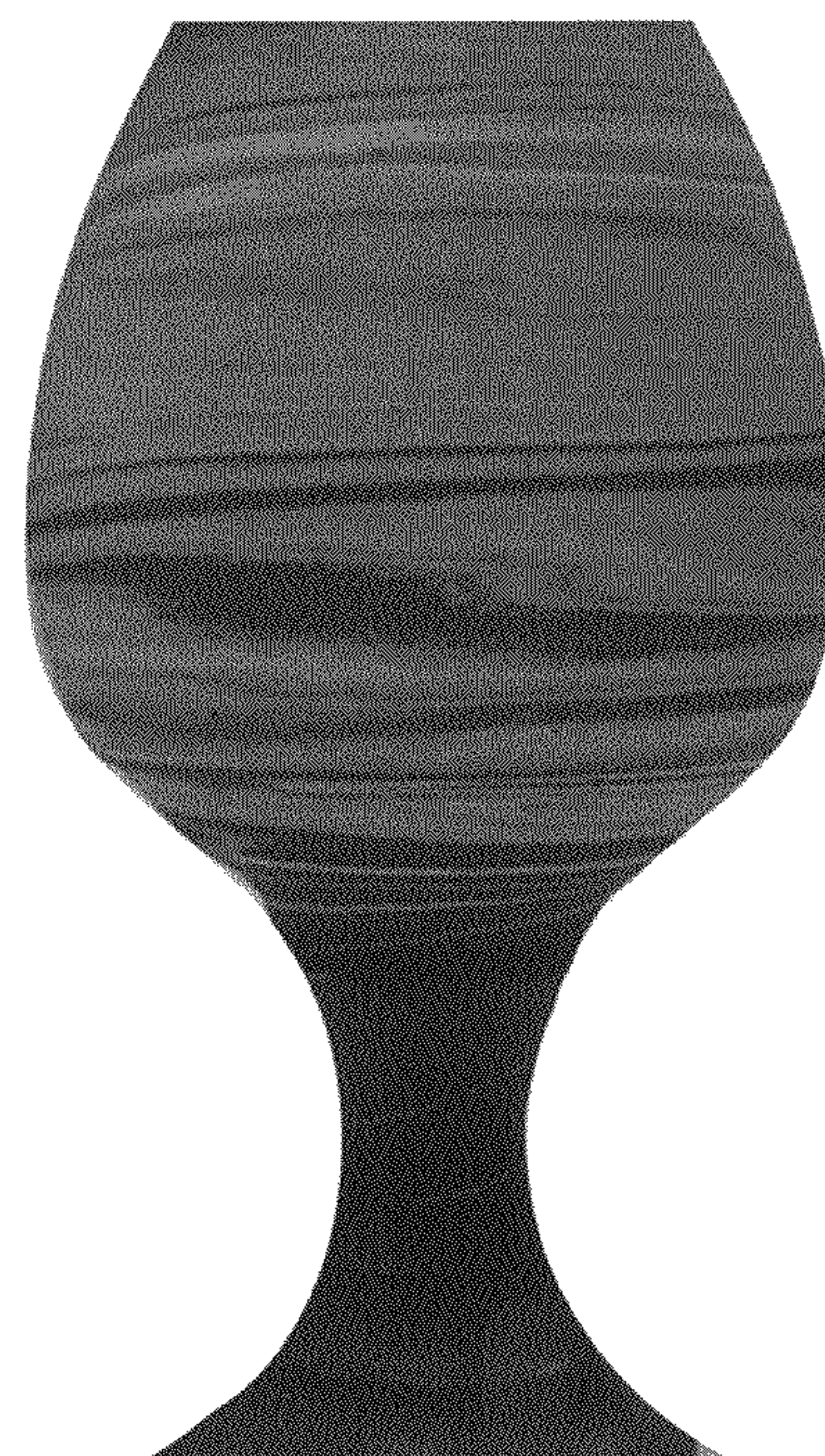
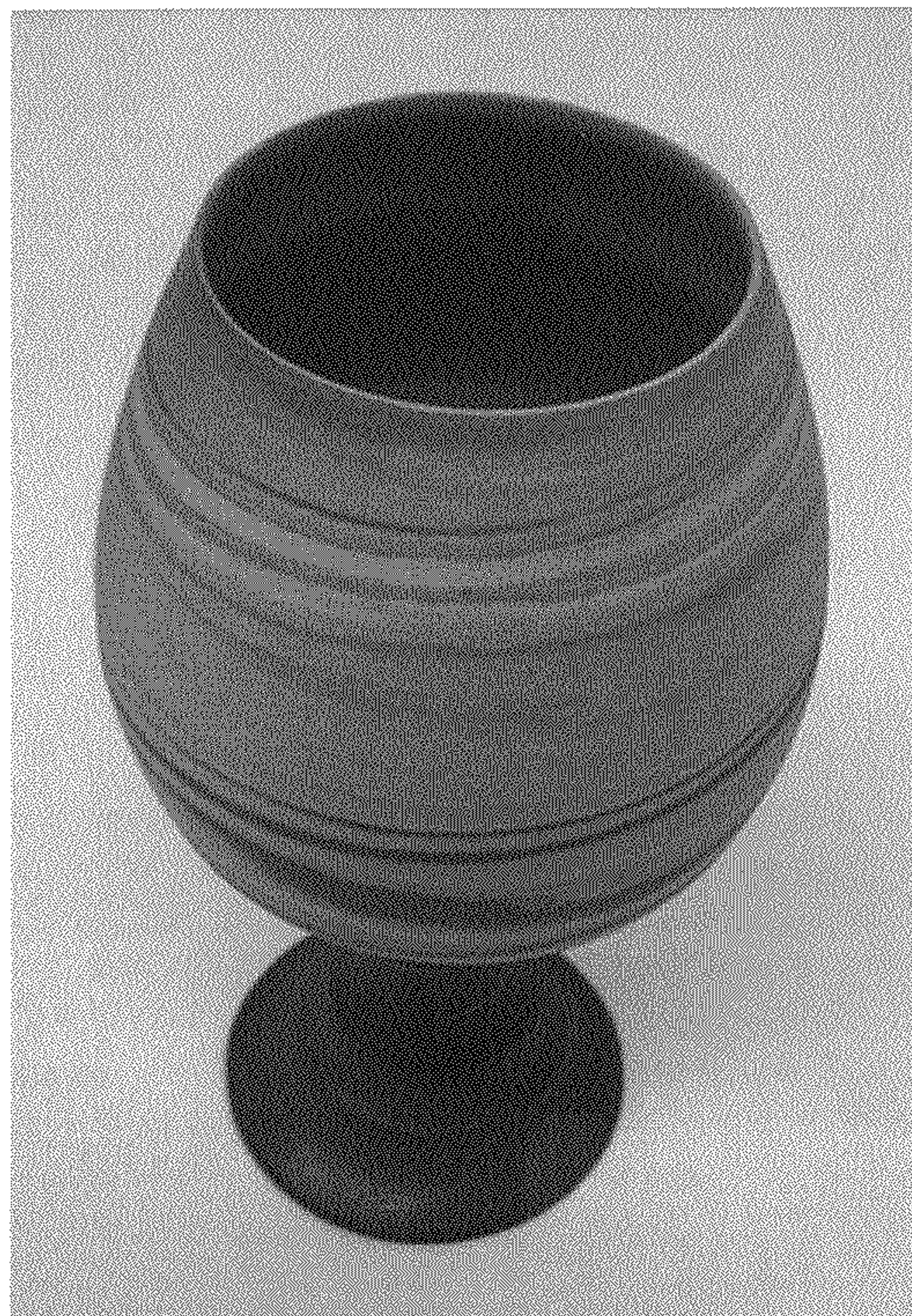
FIG. 4 is a right side view of the drinking vessel.

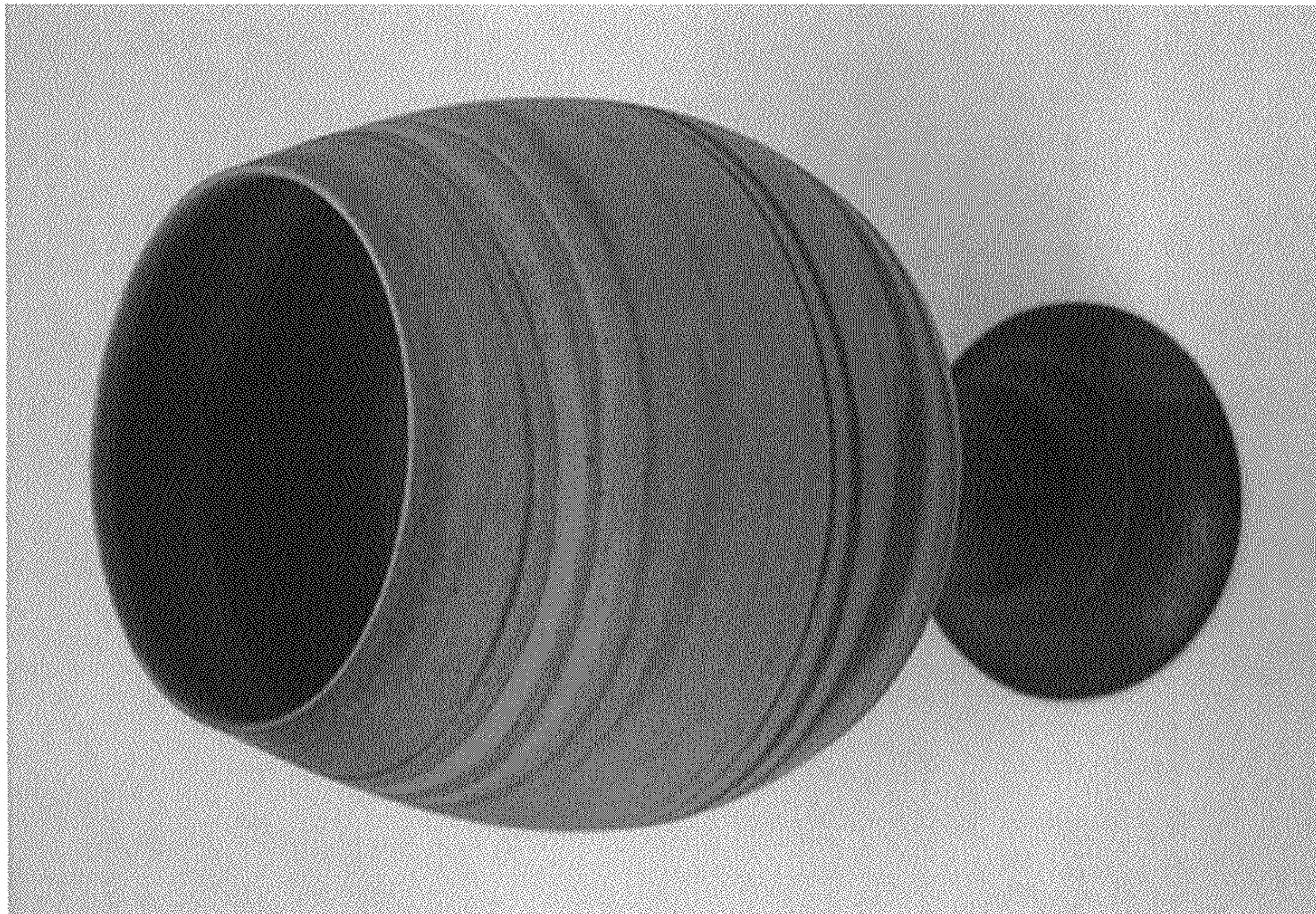

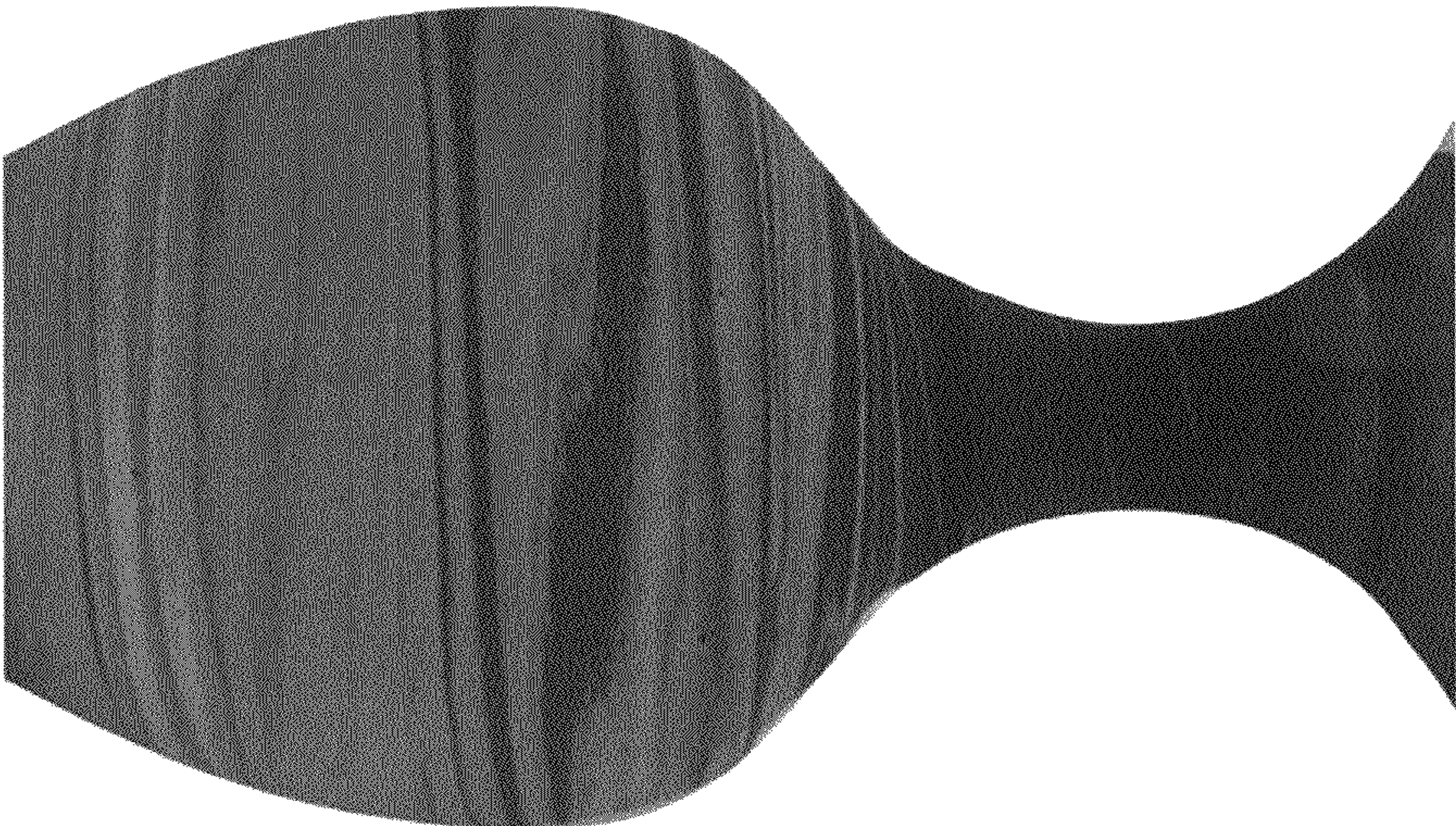

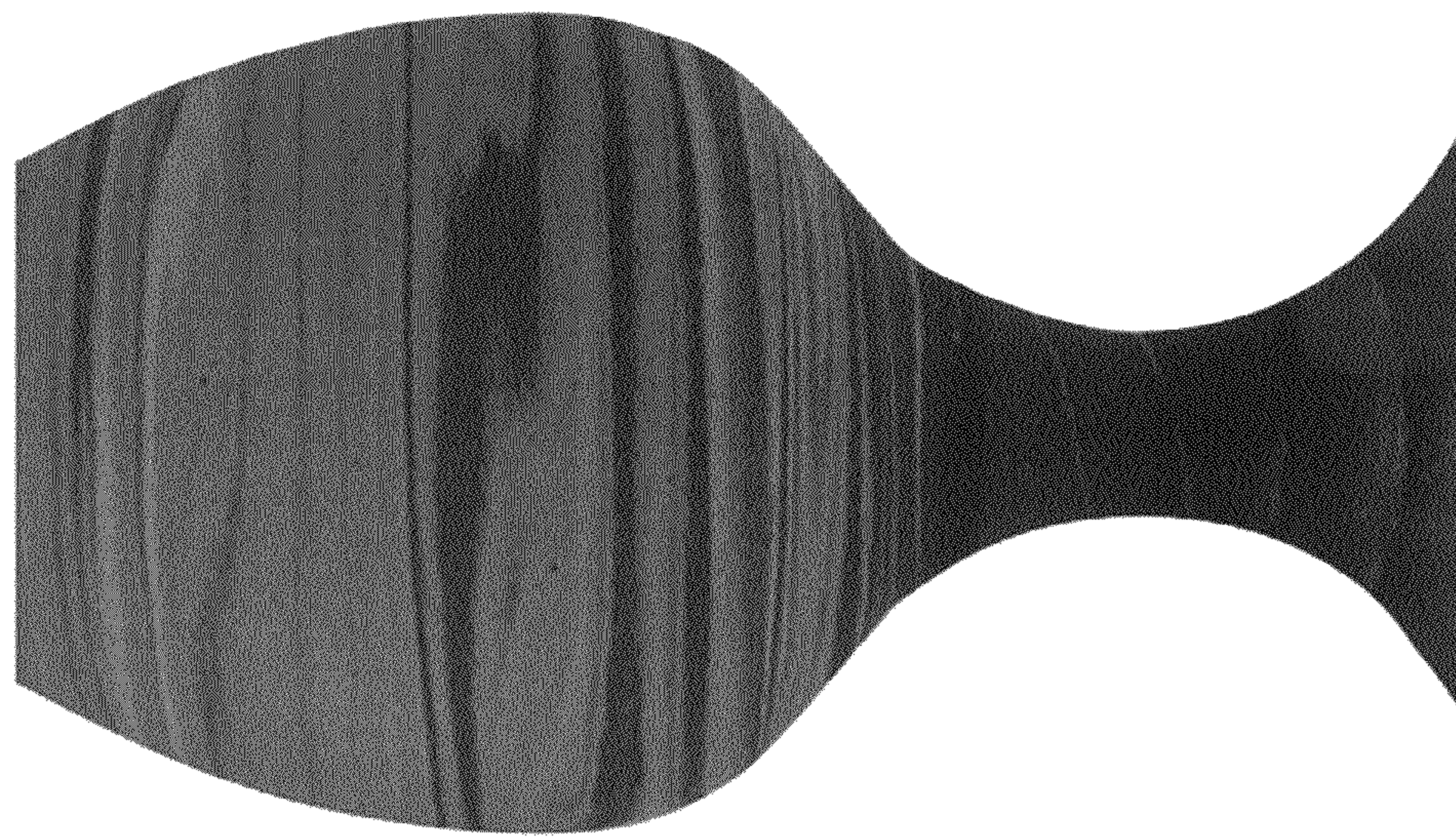

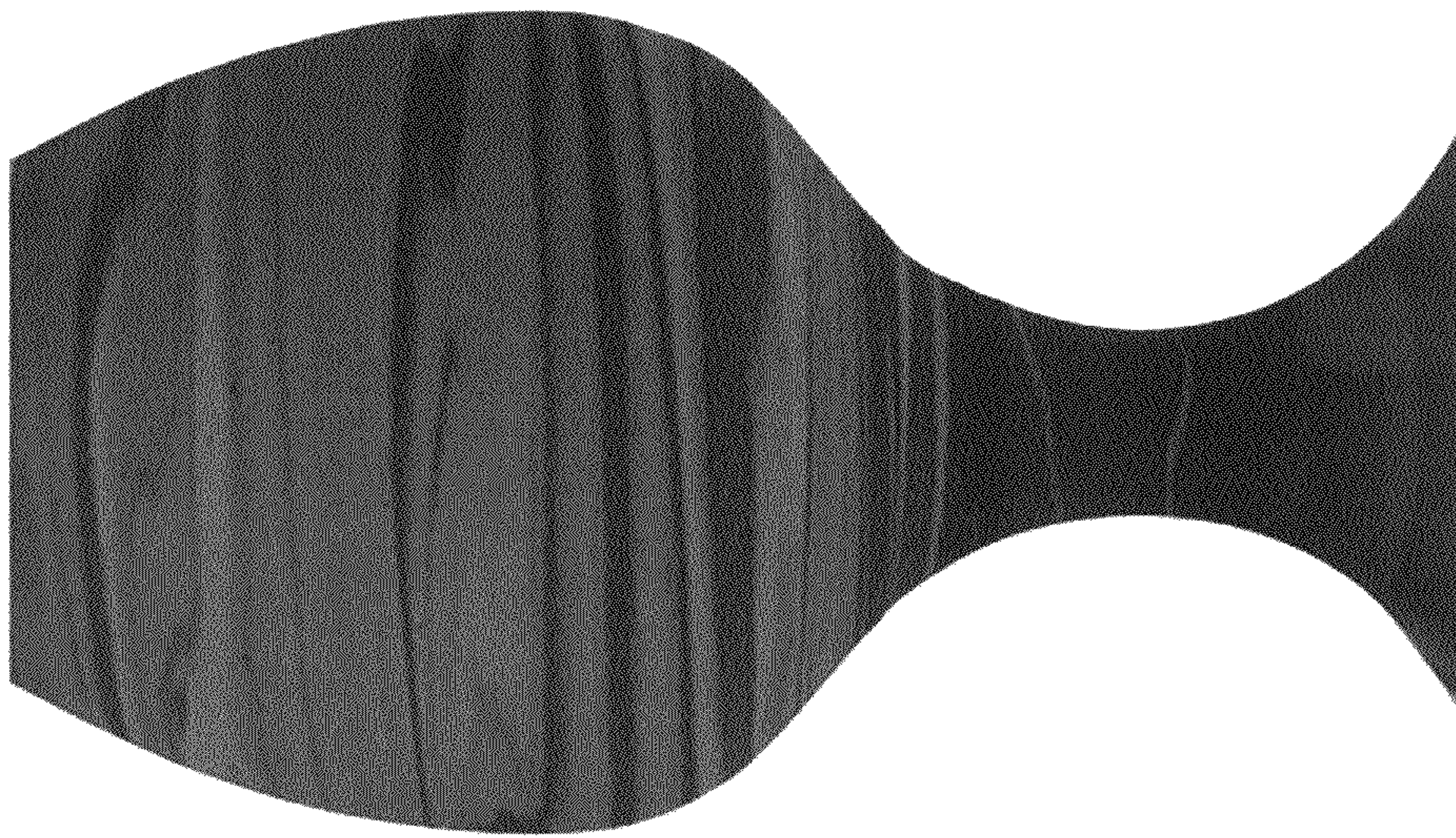

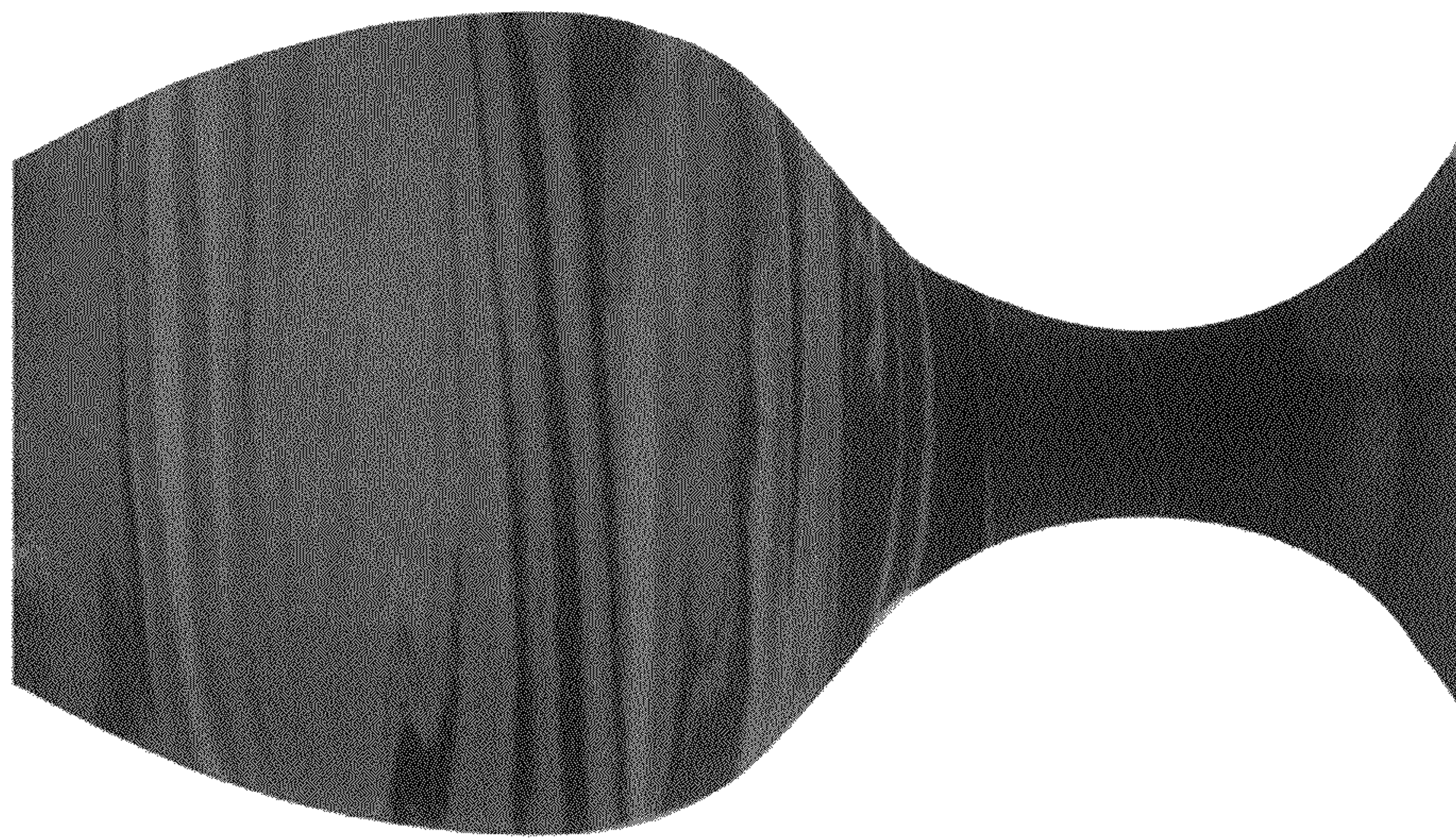

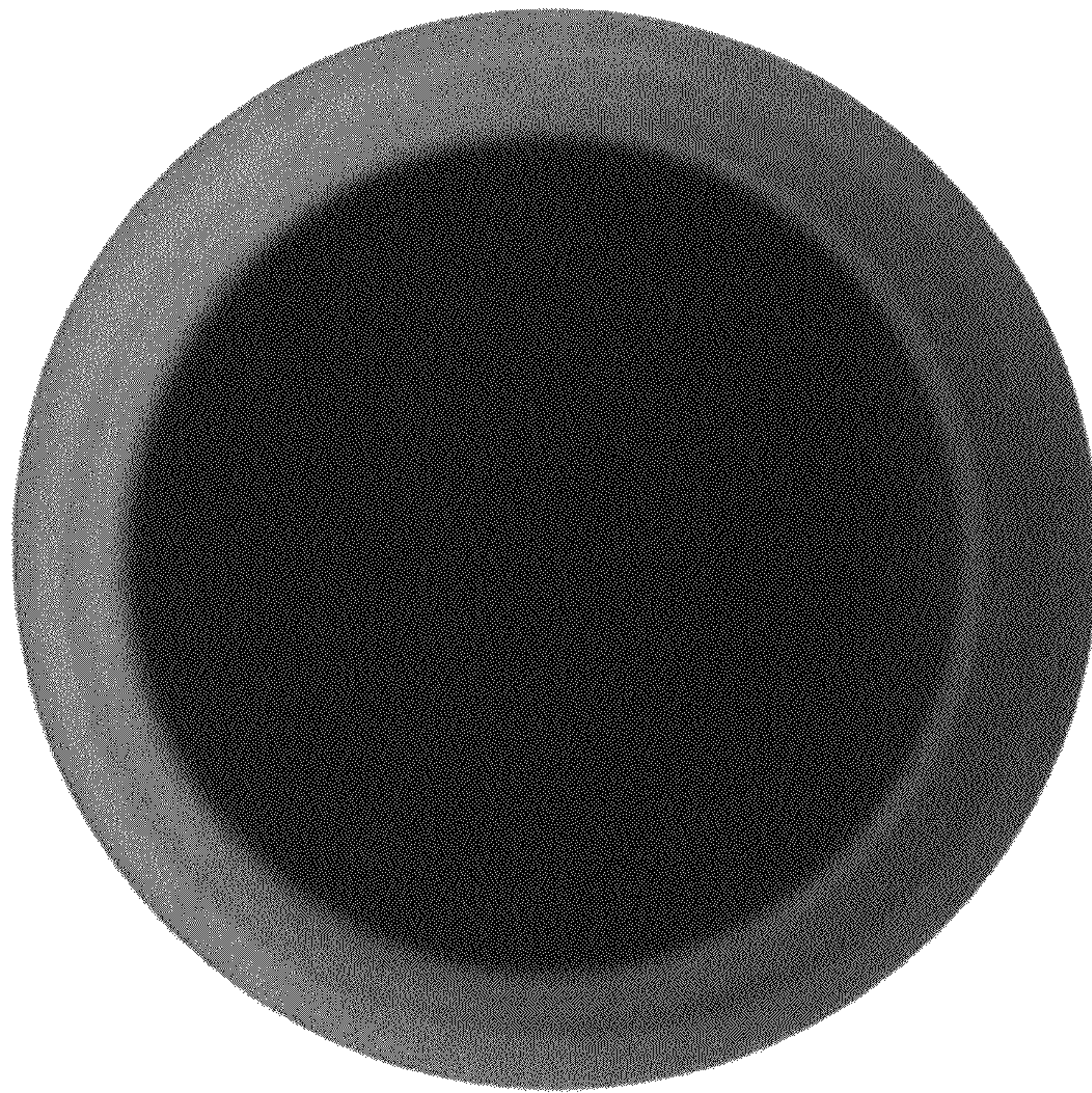
