(57) **CLAIM**

We claim the ornamental design for hour glass bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the hour glass bottle;
FIG. 2 is a front view of the hour glass bottle;
FIG. 3 is a back view of the hour glass bottle;
FIG. 4 is a side view of the hour glass bottle;
FIG. 5 is an opposite side view of the hour glass bottle;
FIG. 6 is a top view of the hour glass bottle; and,
FIG. 7 is a bottom view of the hour glass bottle.
The broken lines shown in the figures are included, for the purpose of illustrating portions of the hour glass bottle and form no part of the claimed design.

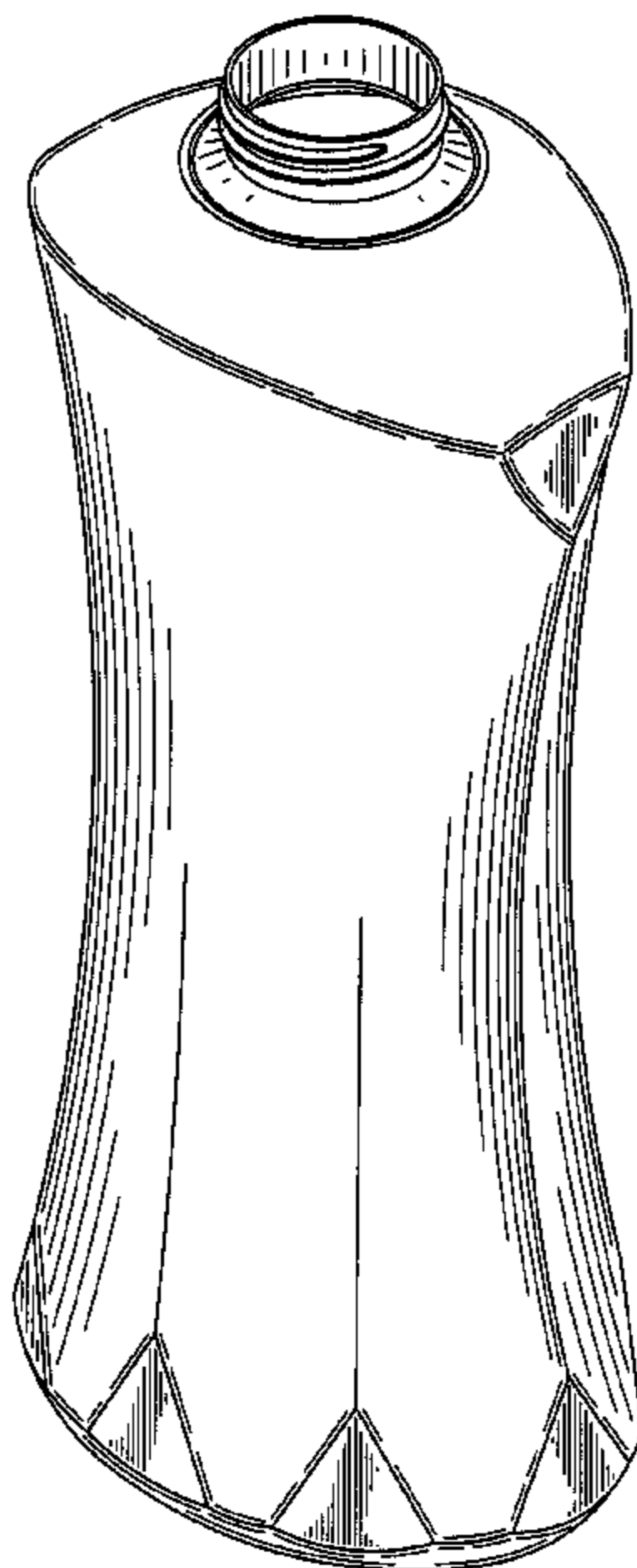

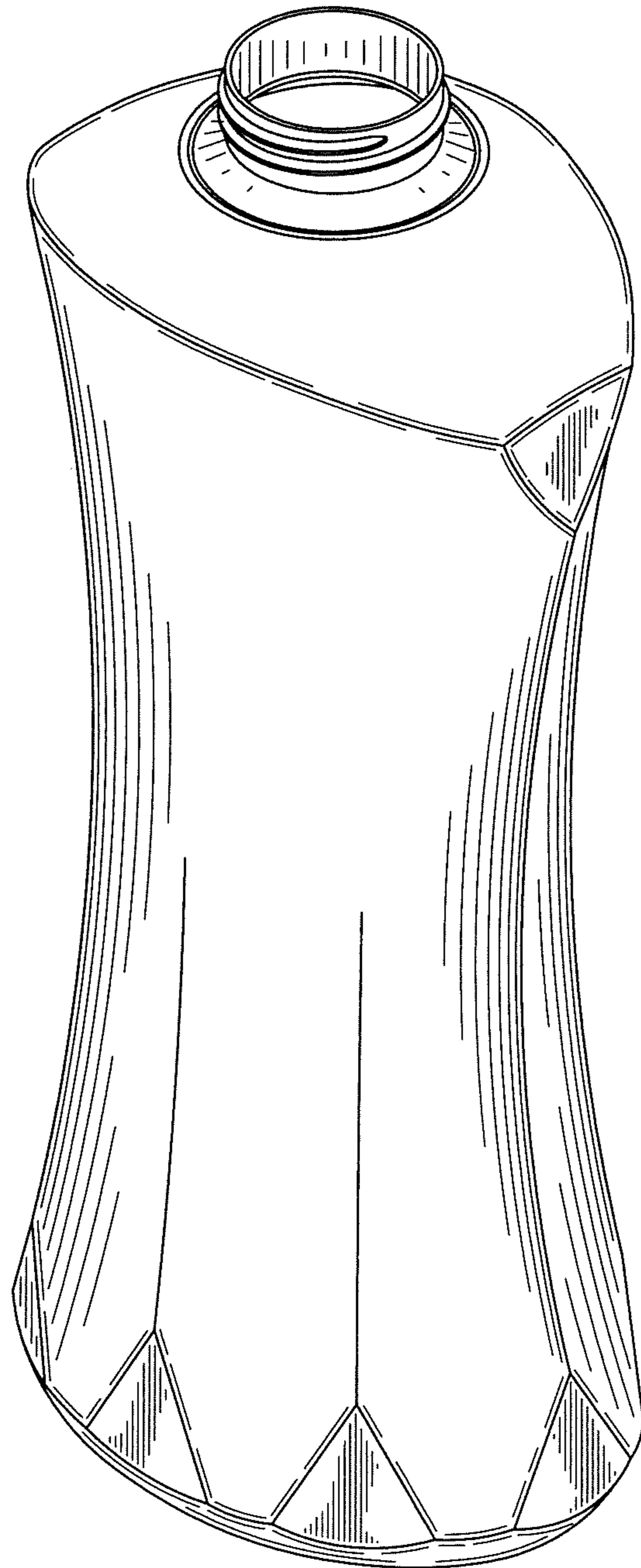

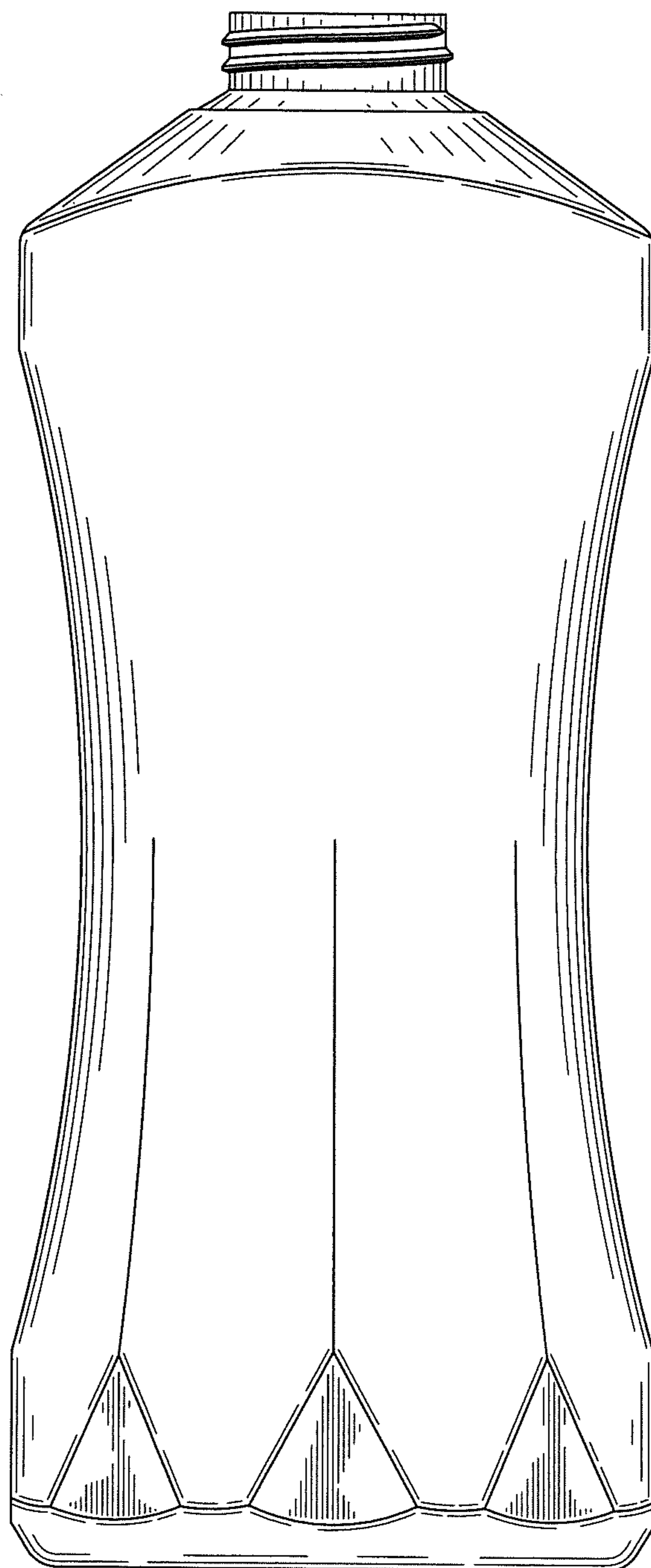

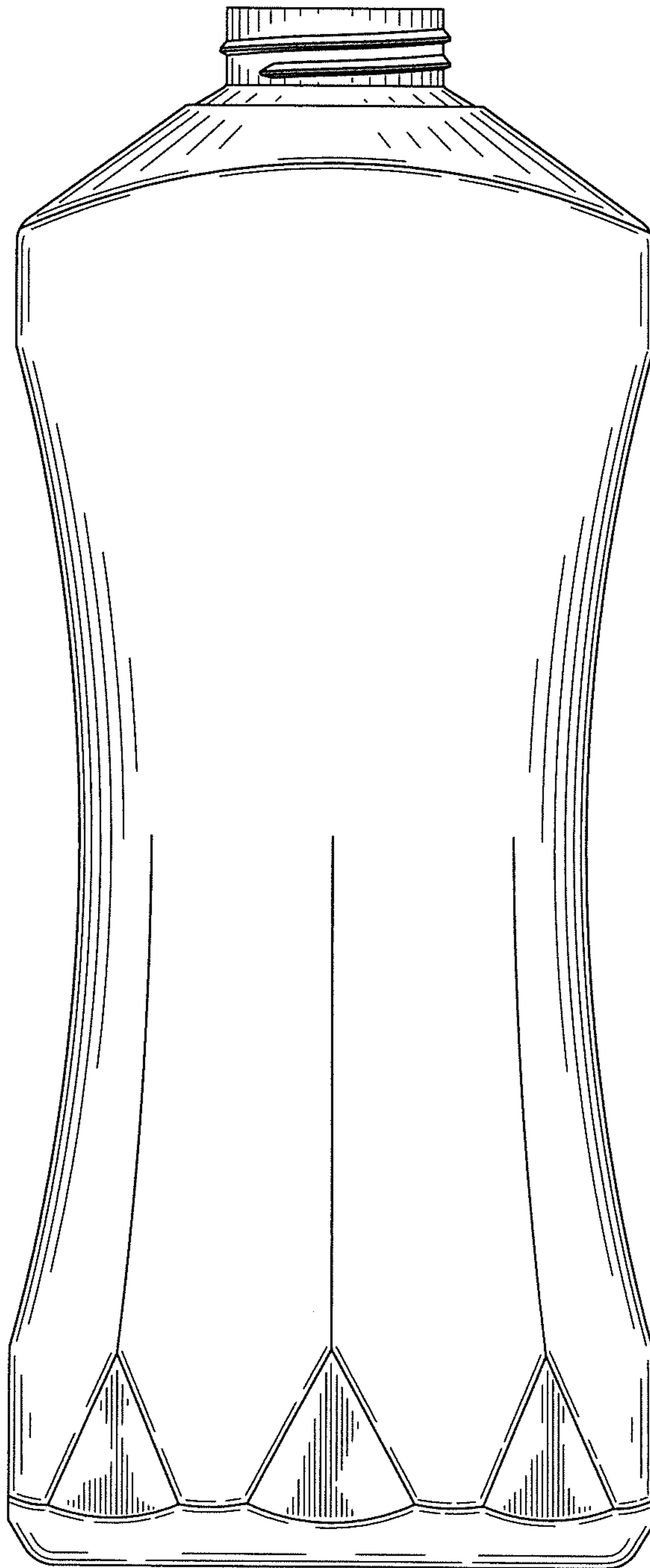

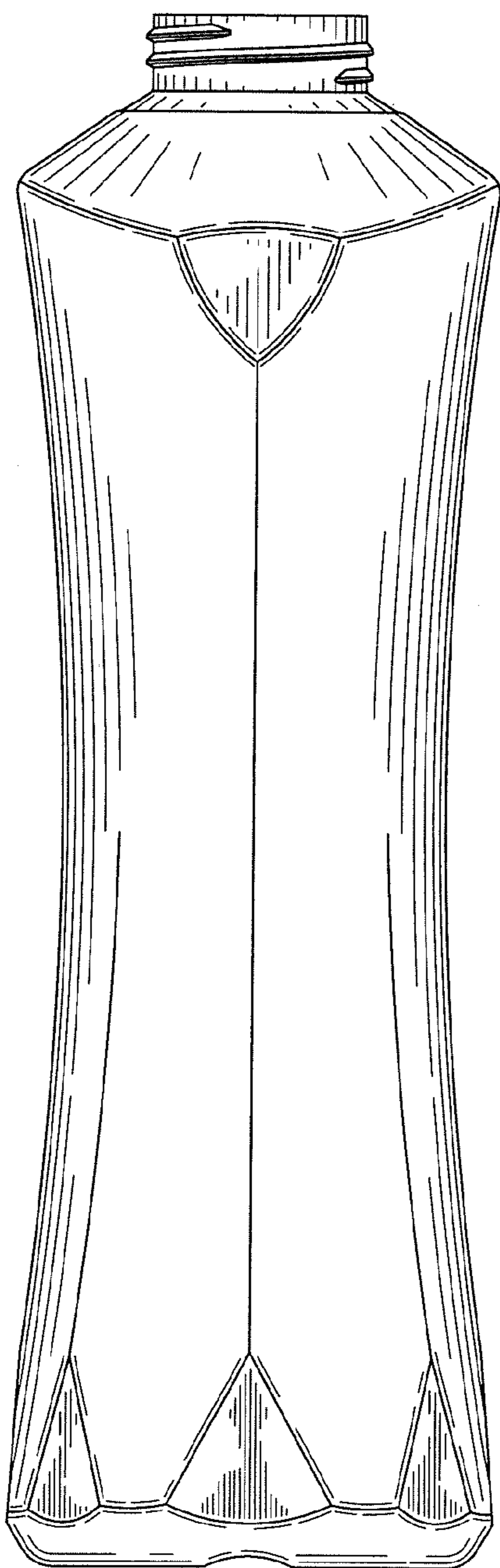

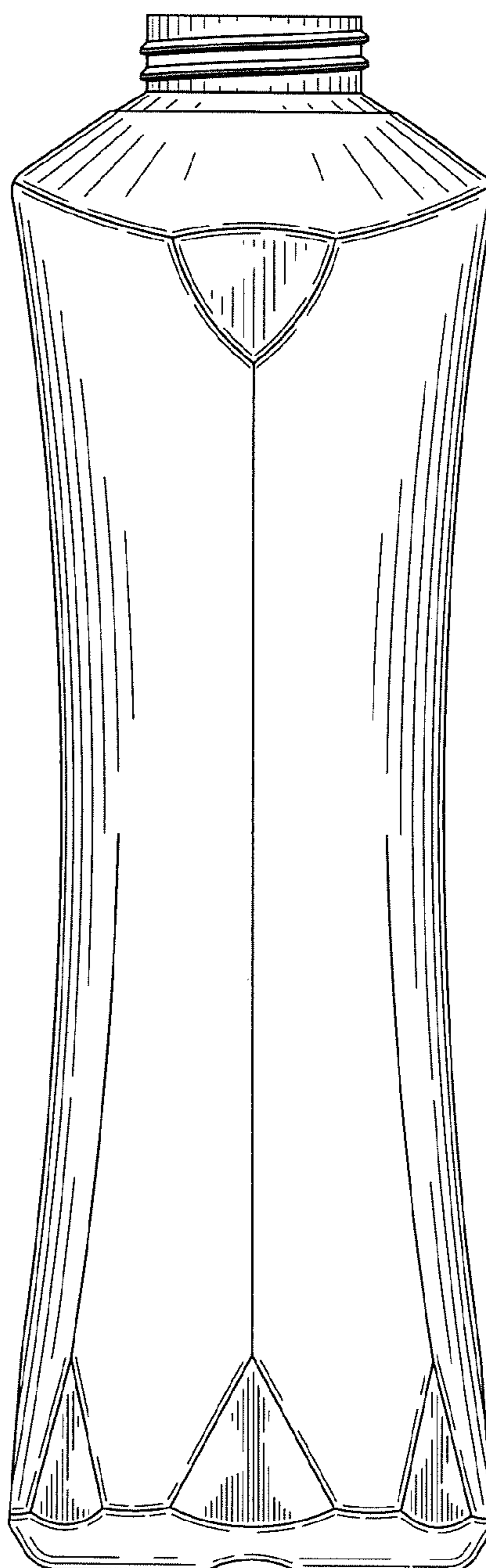

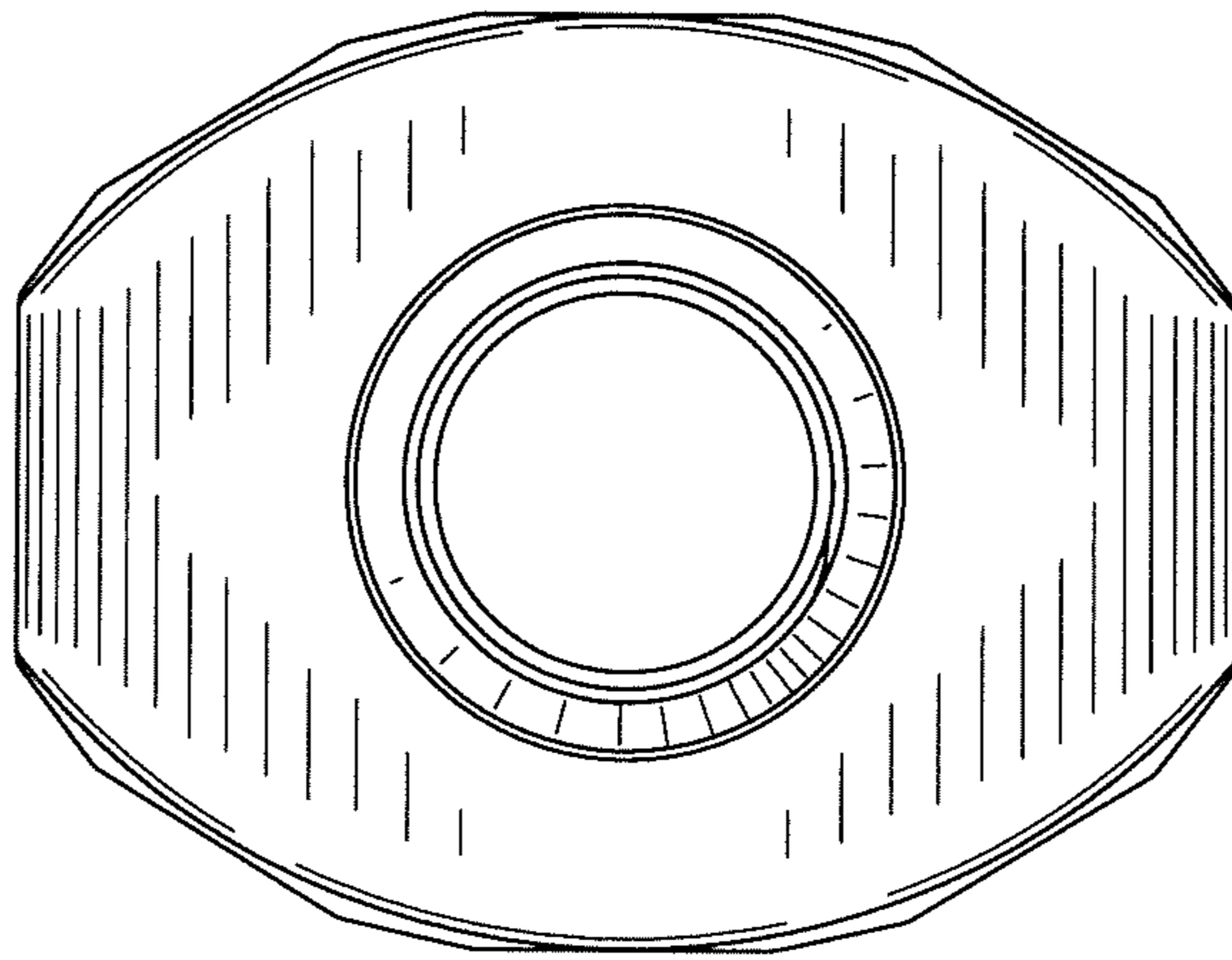
