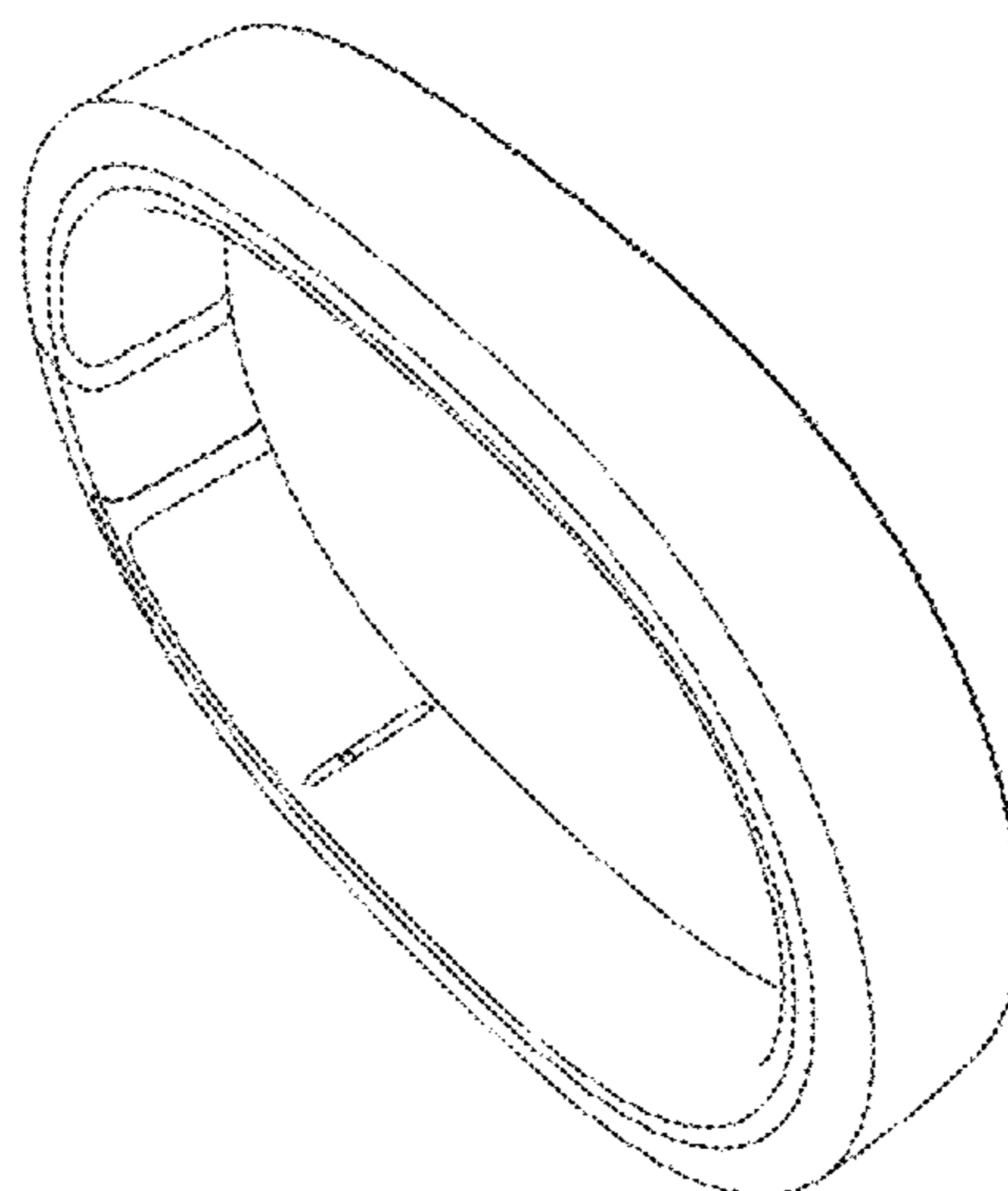

new design;

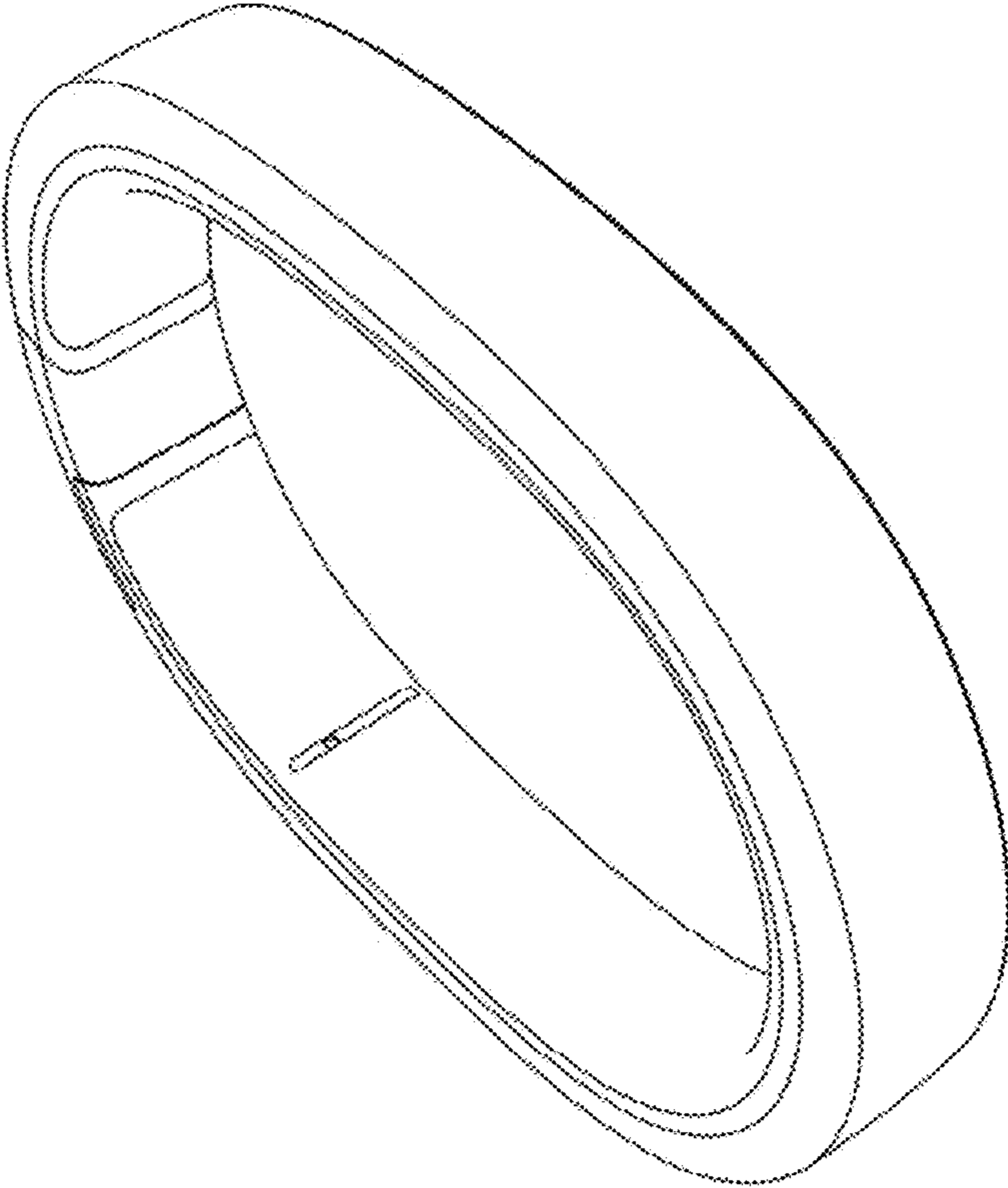

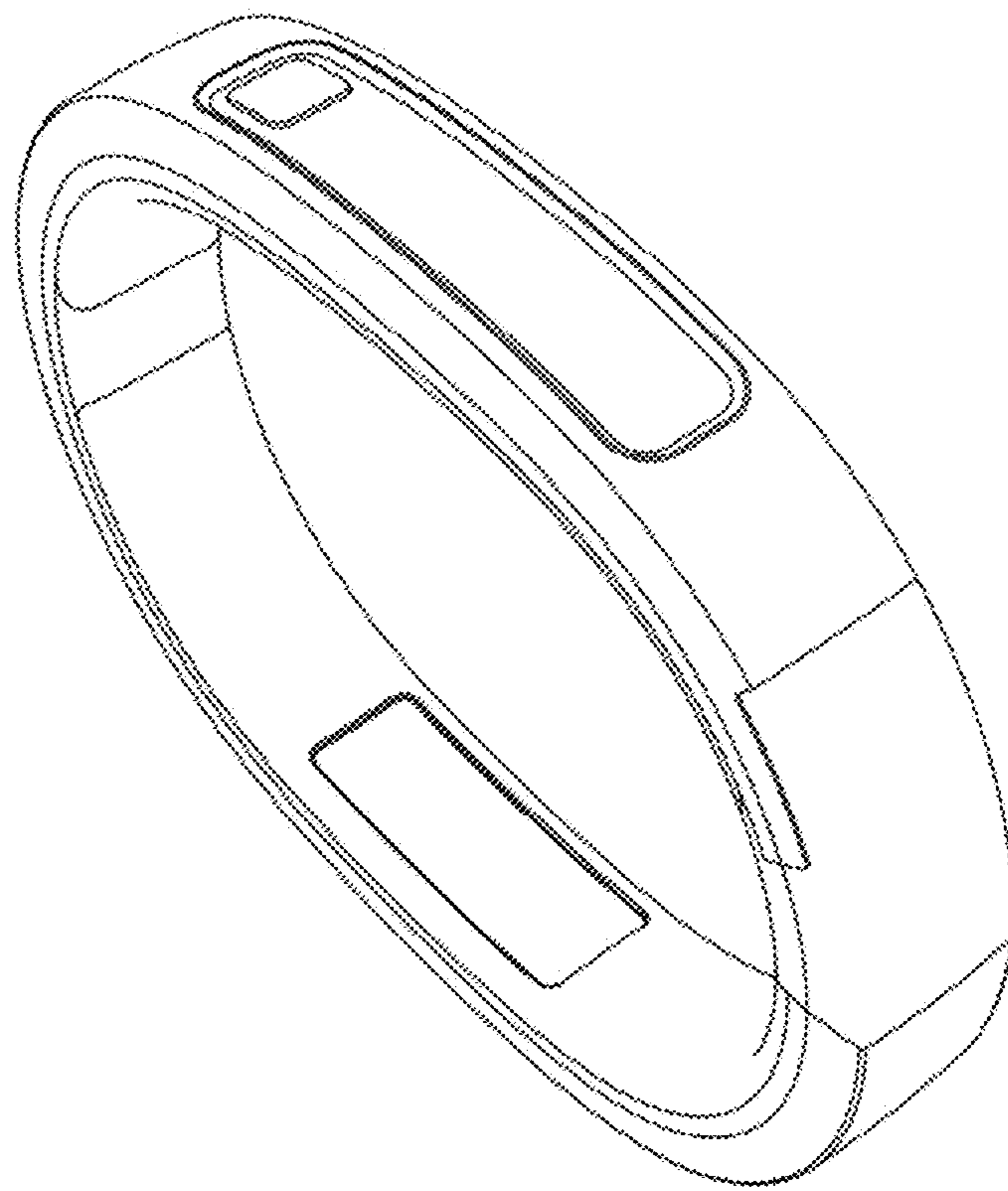

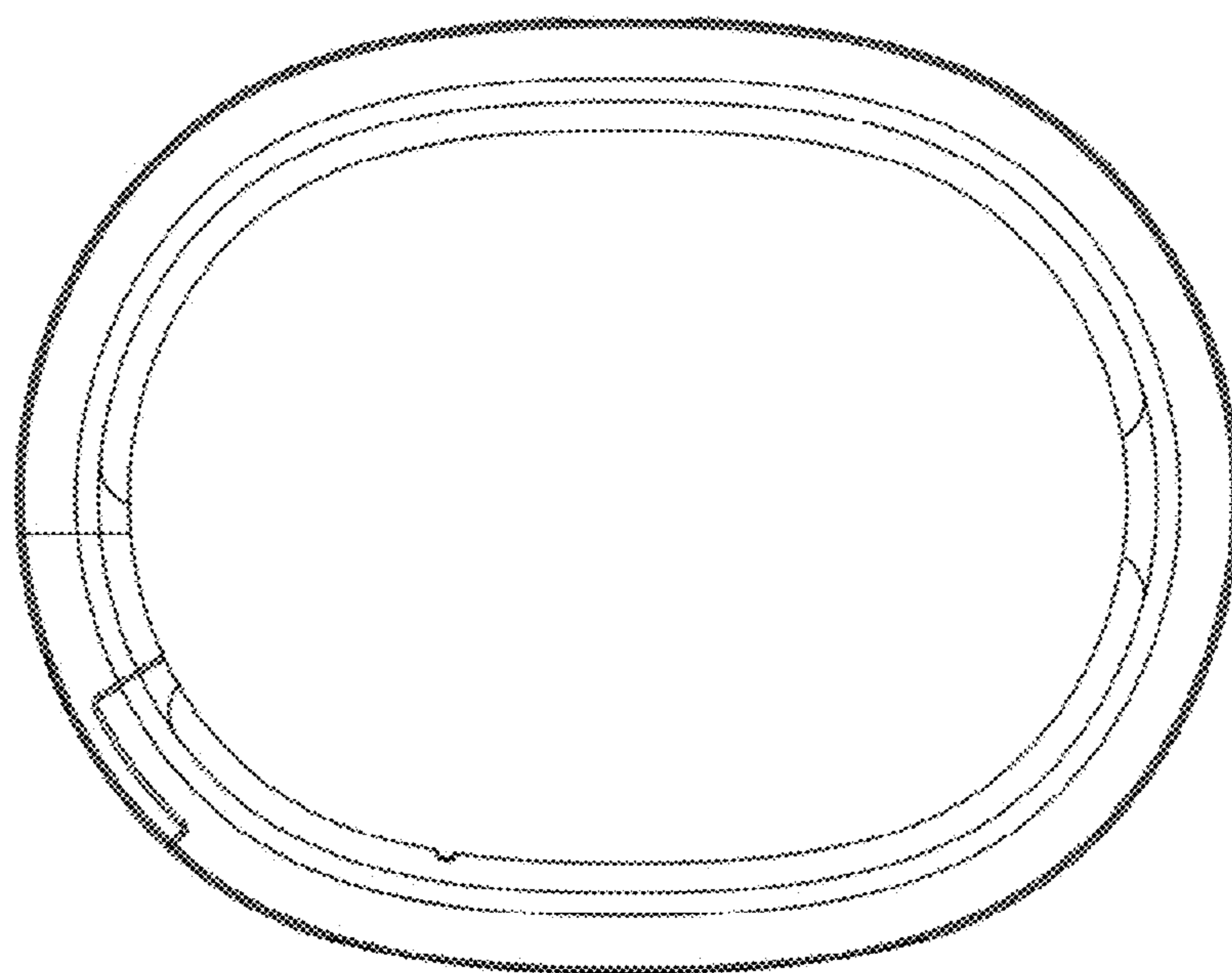

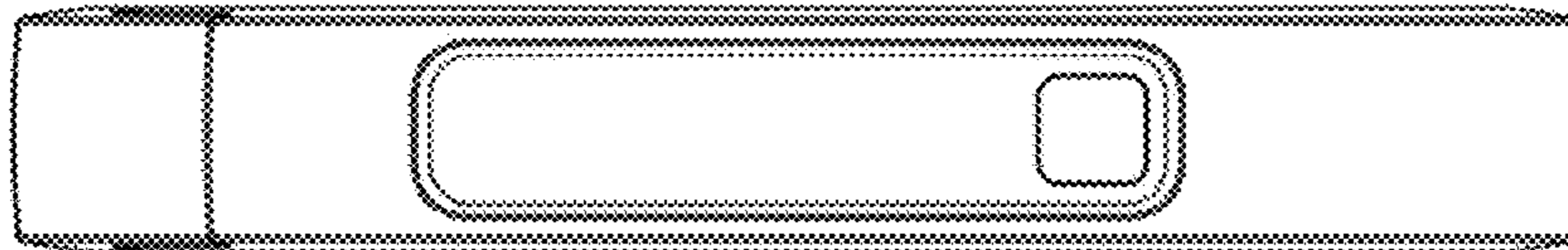

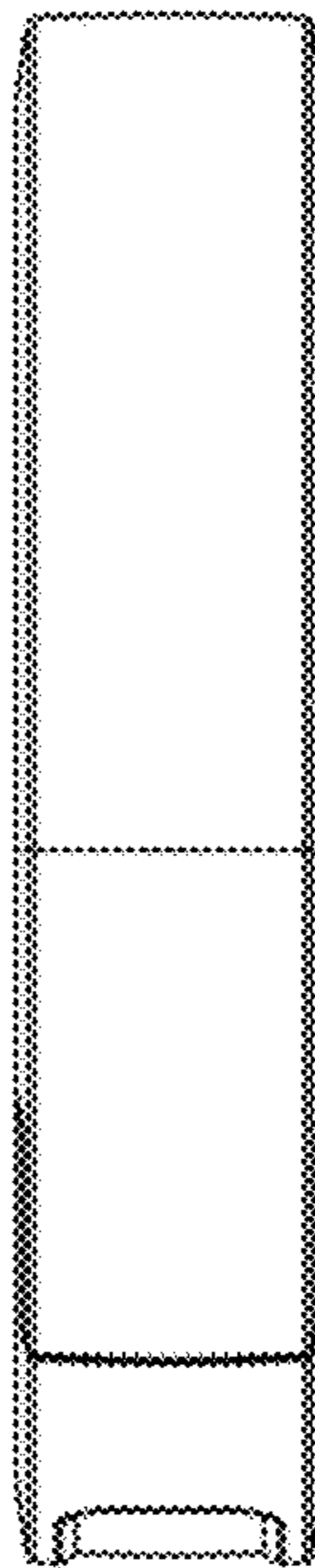

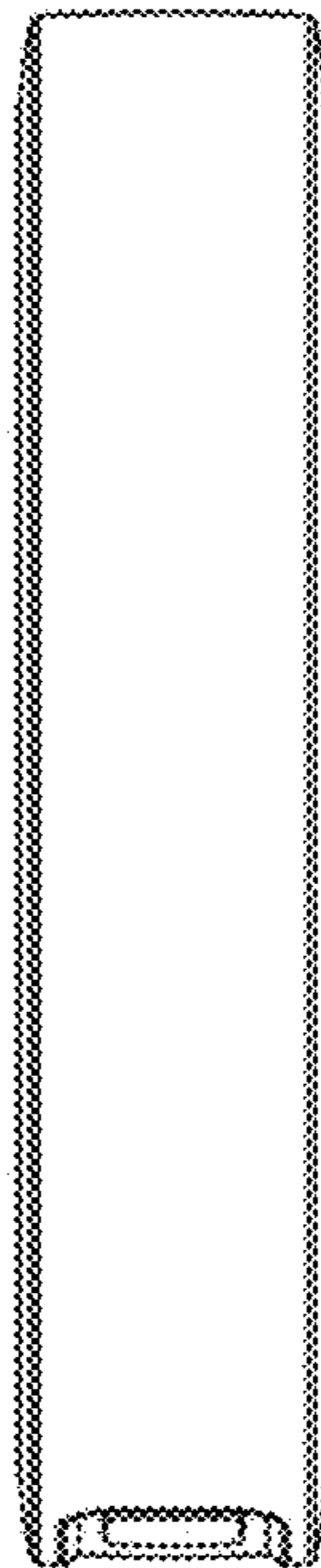

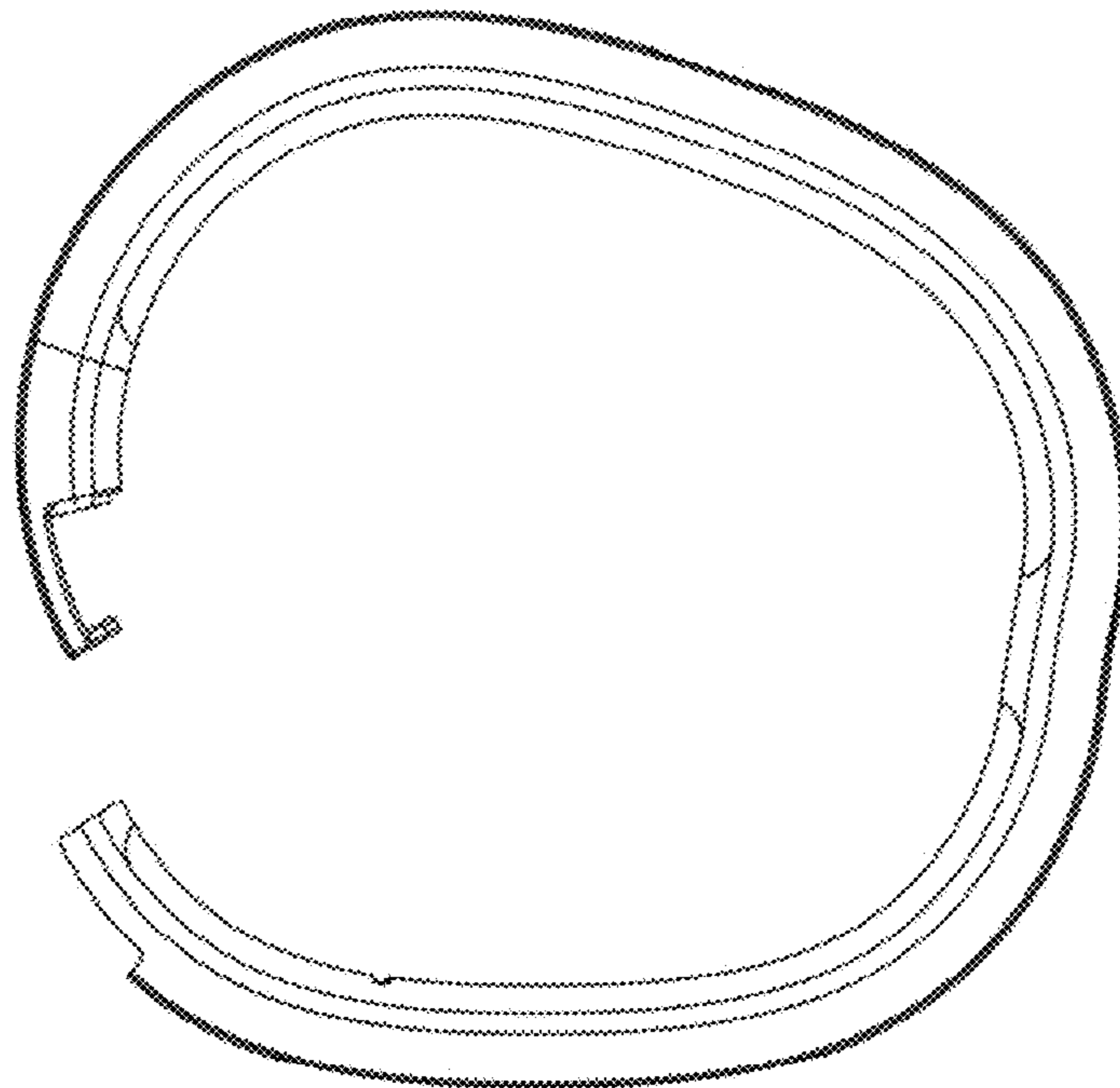

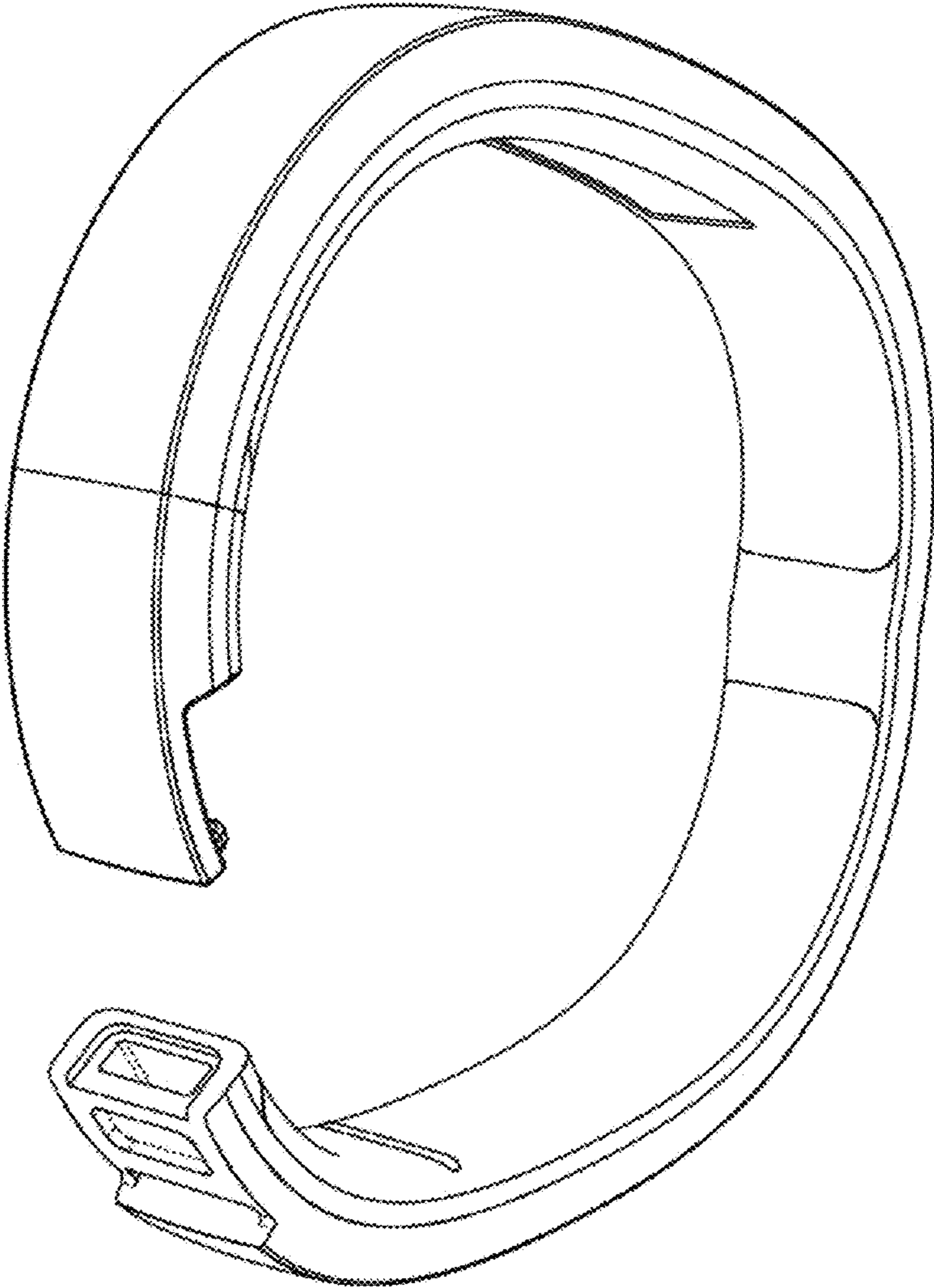
