(57) **CLAIM**

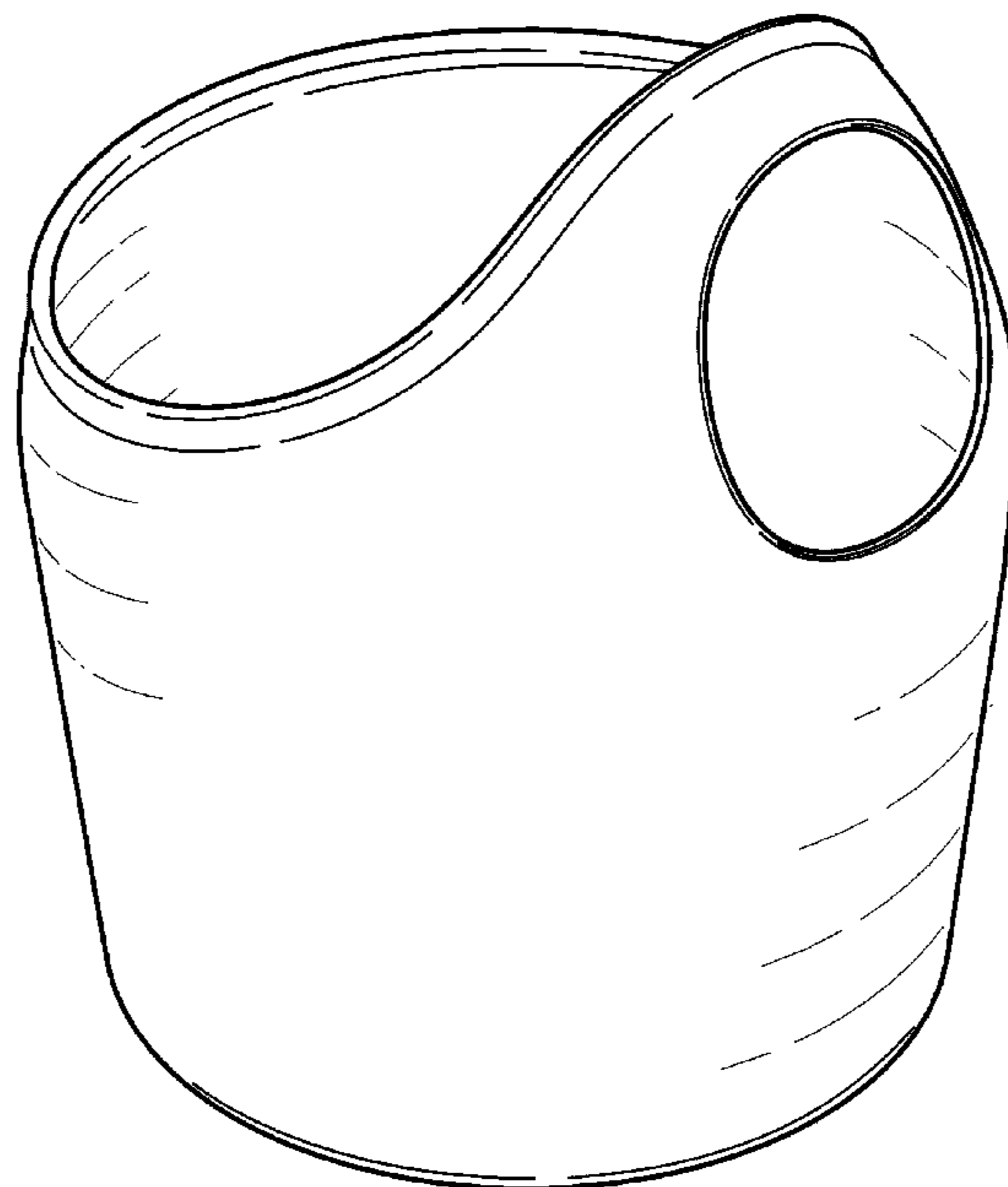
I claim the ornamental design for a plant pot, as shown and described.

DESCRIPTION

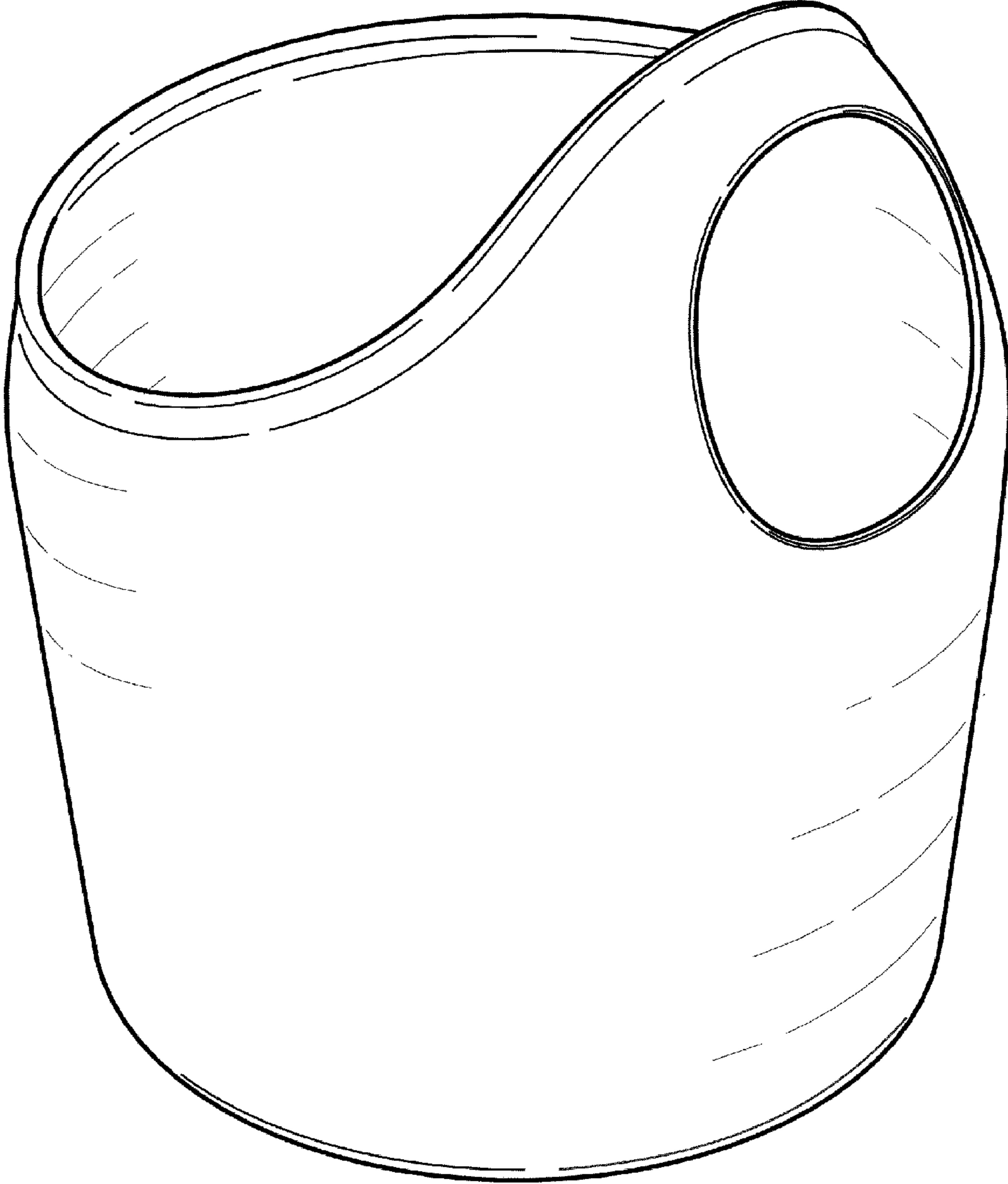

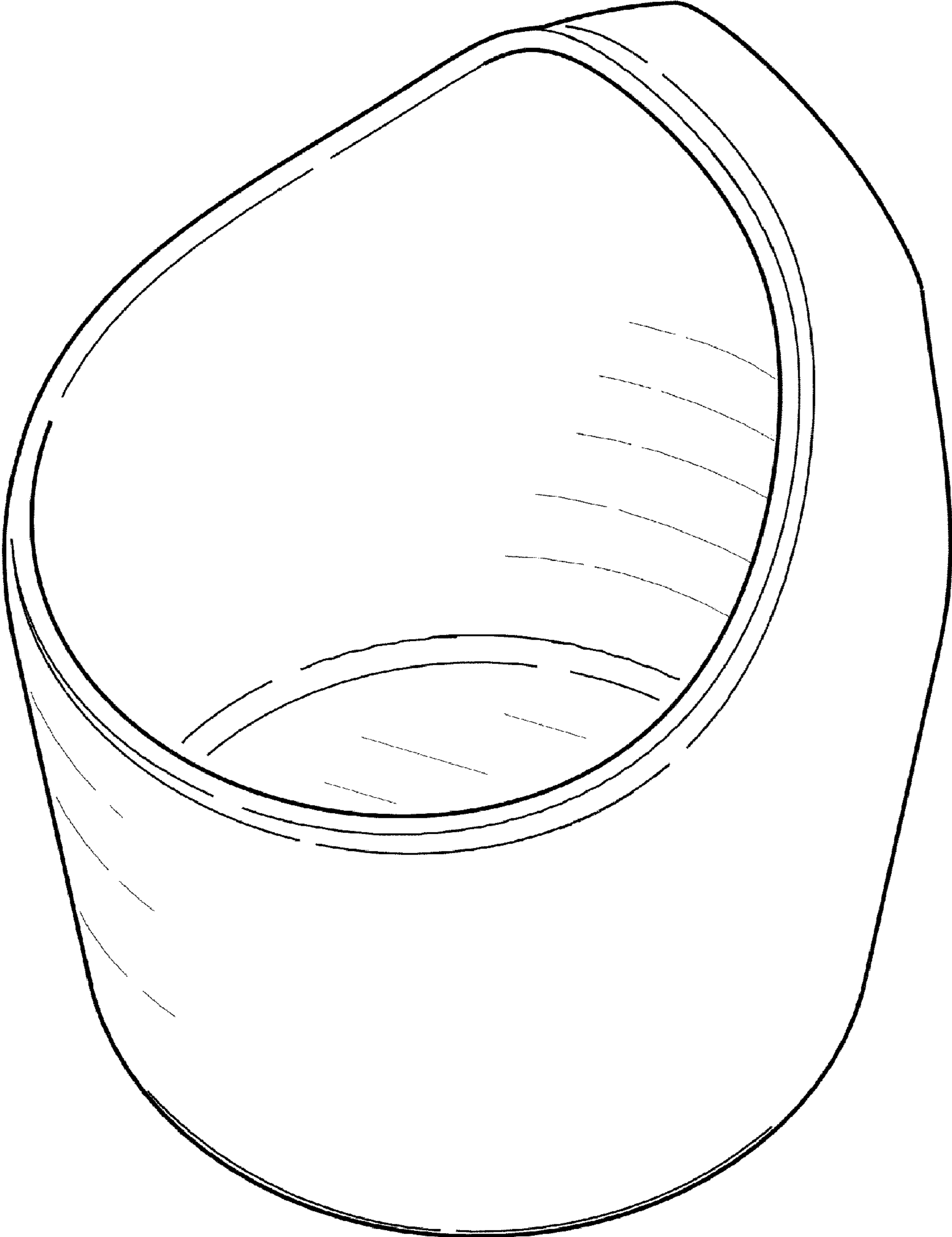

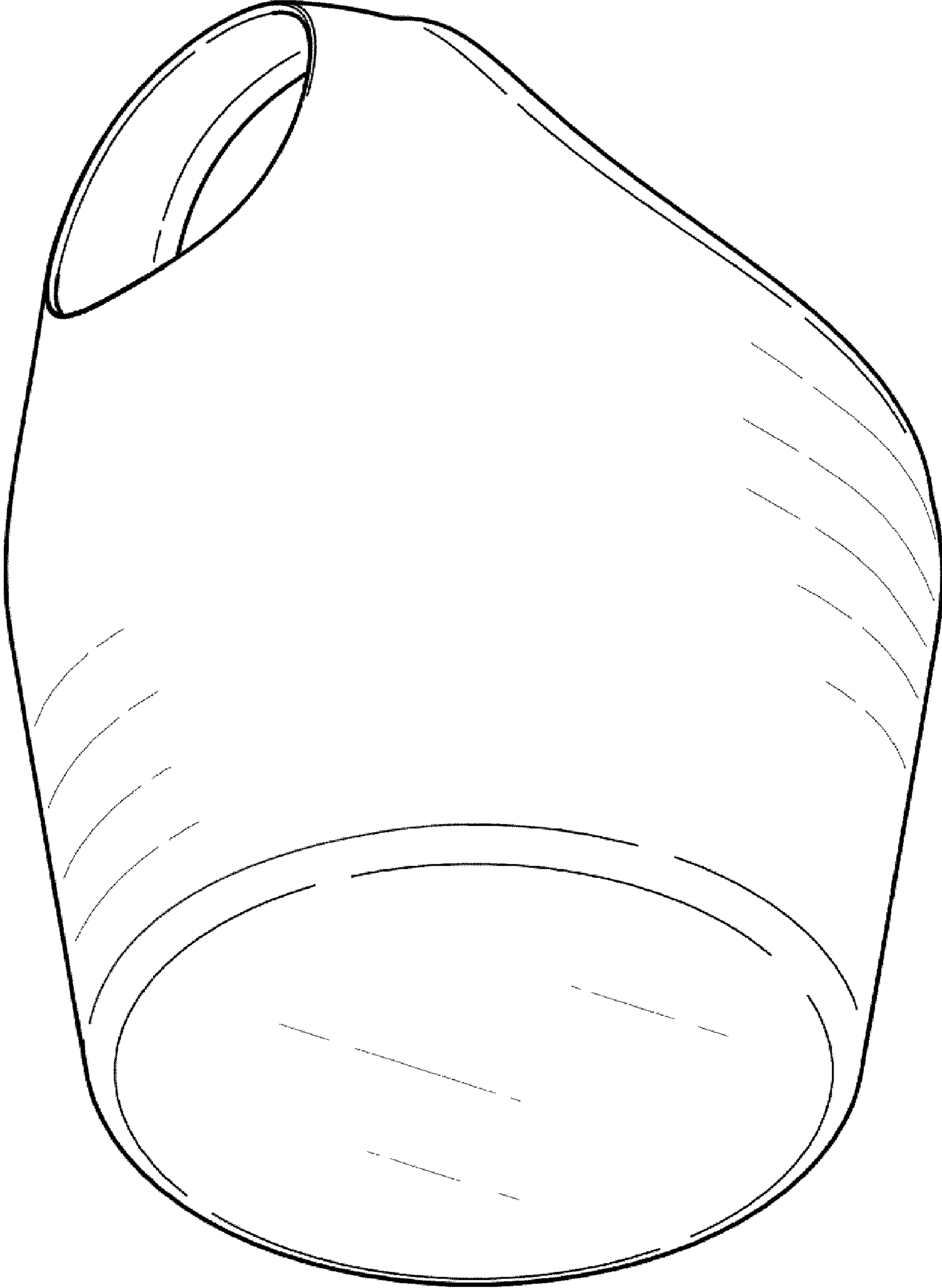

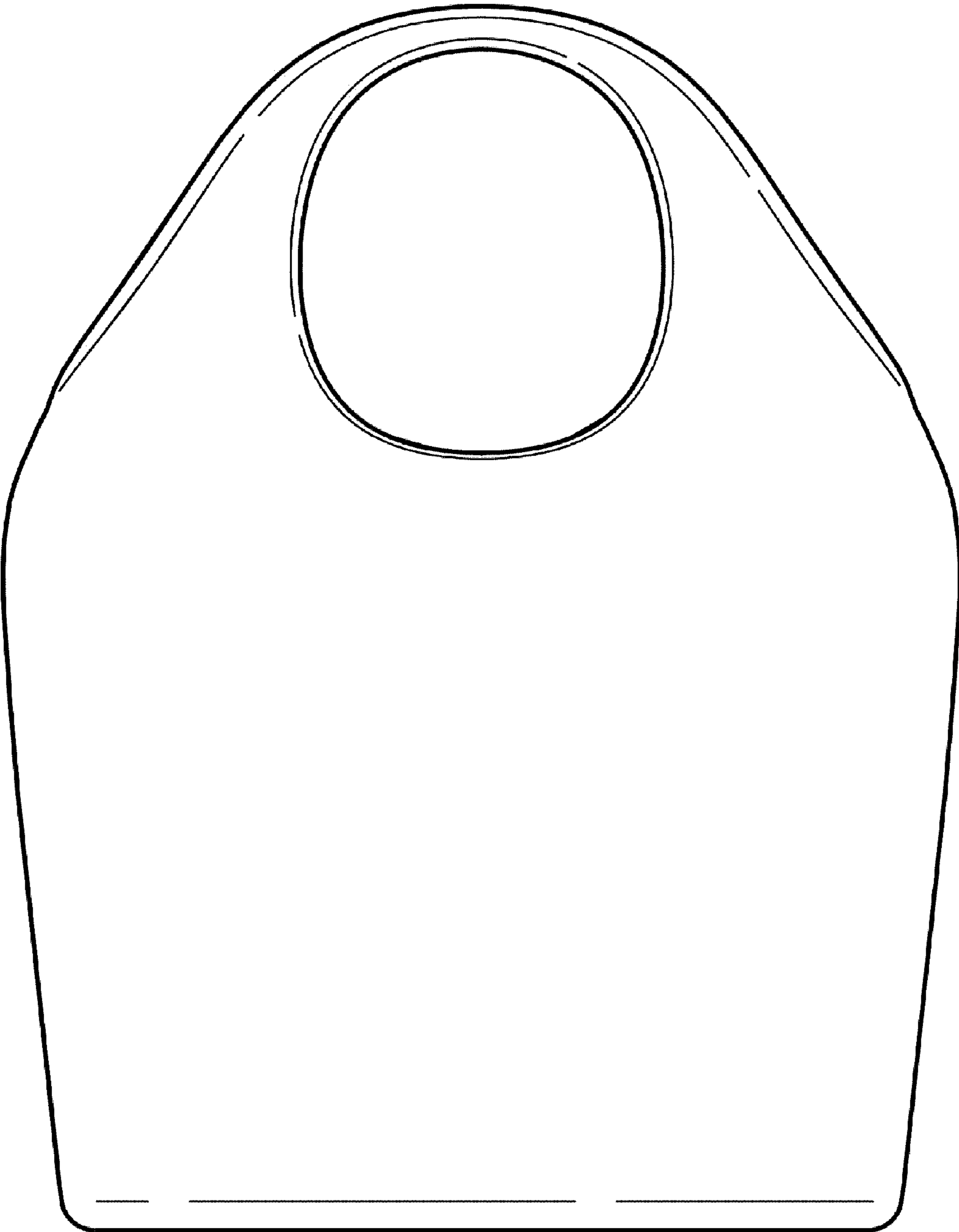

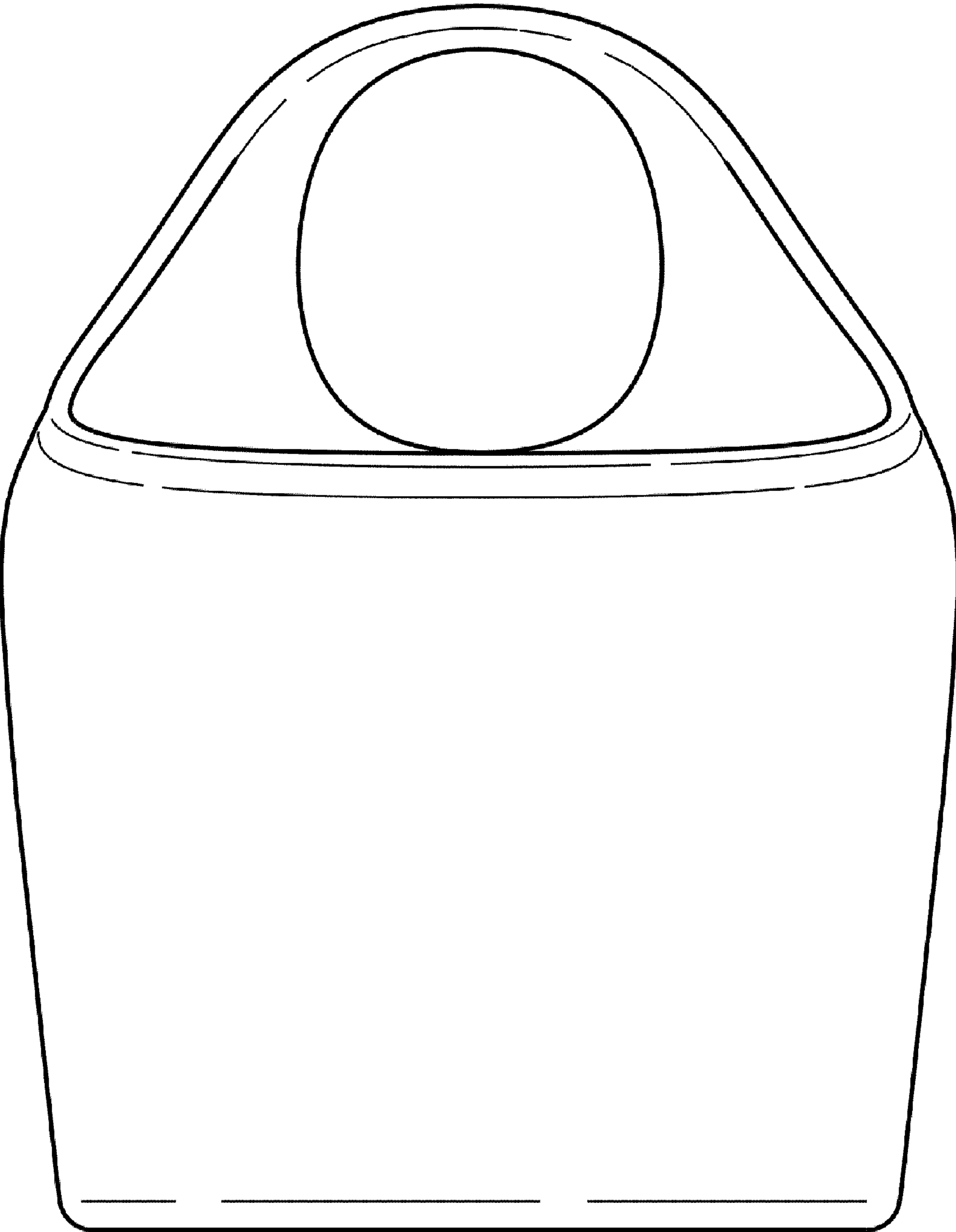

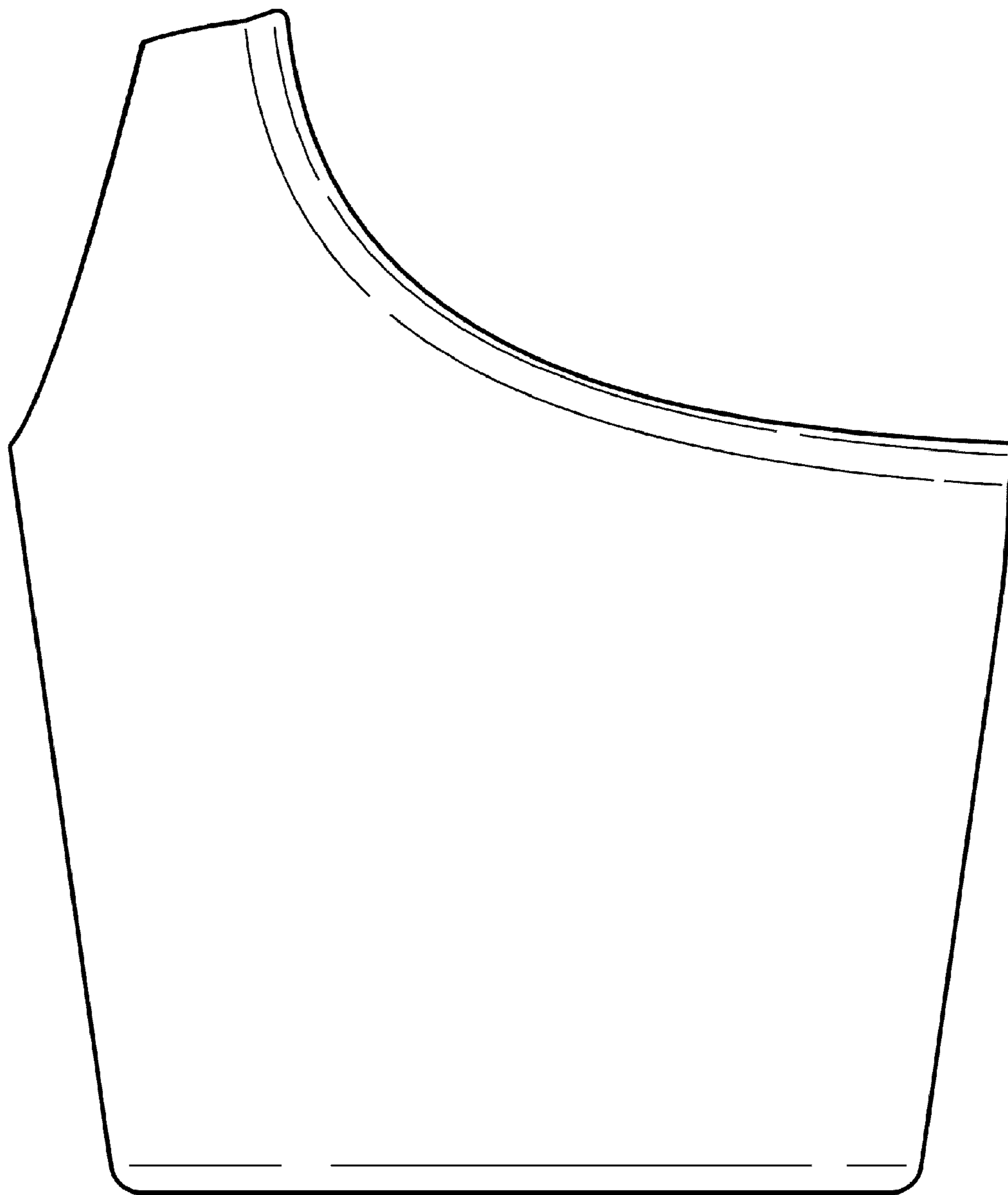

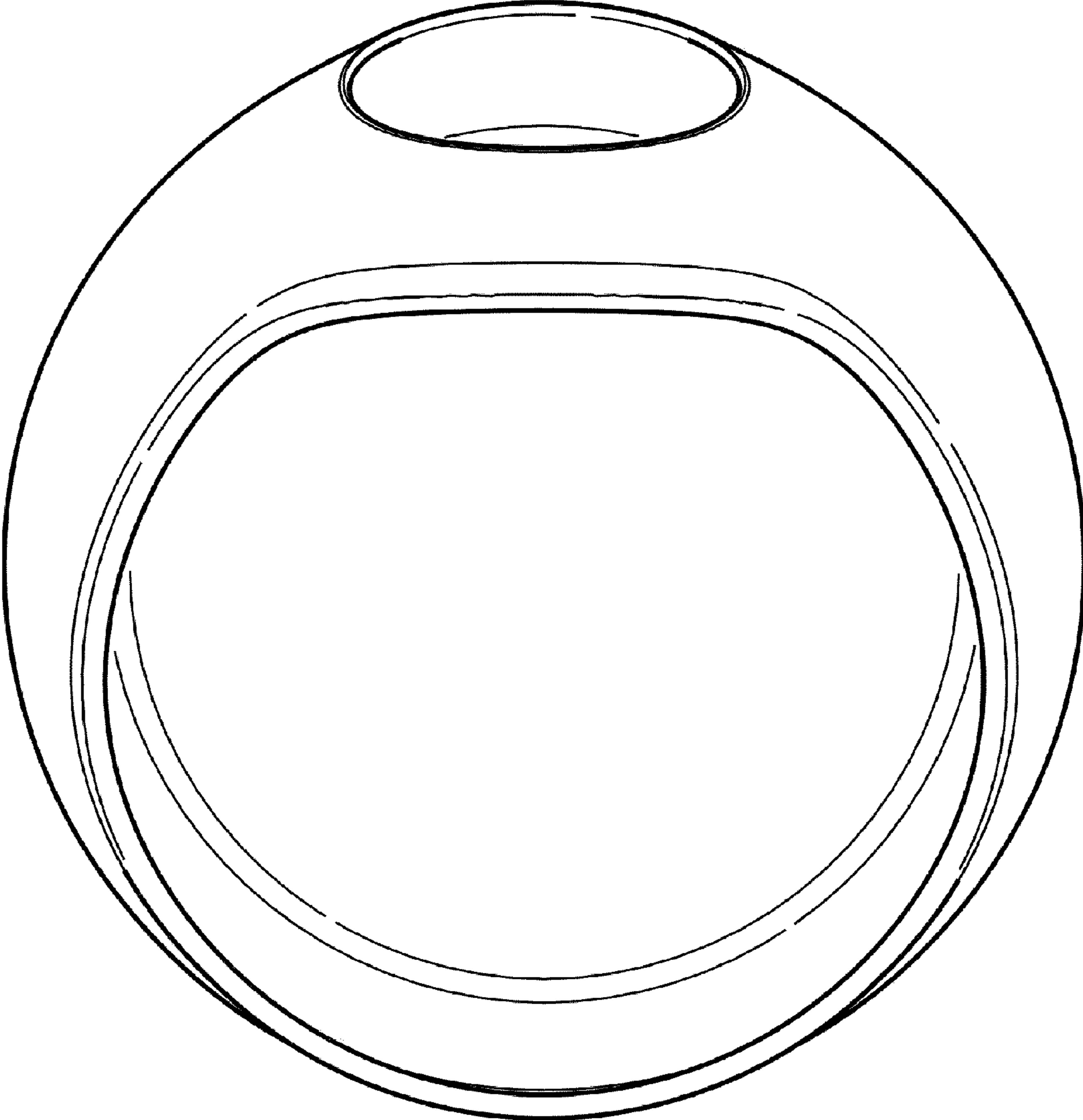
