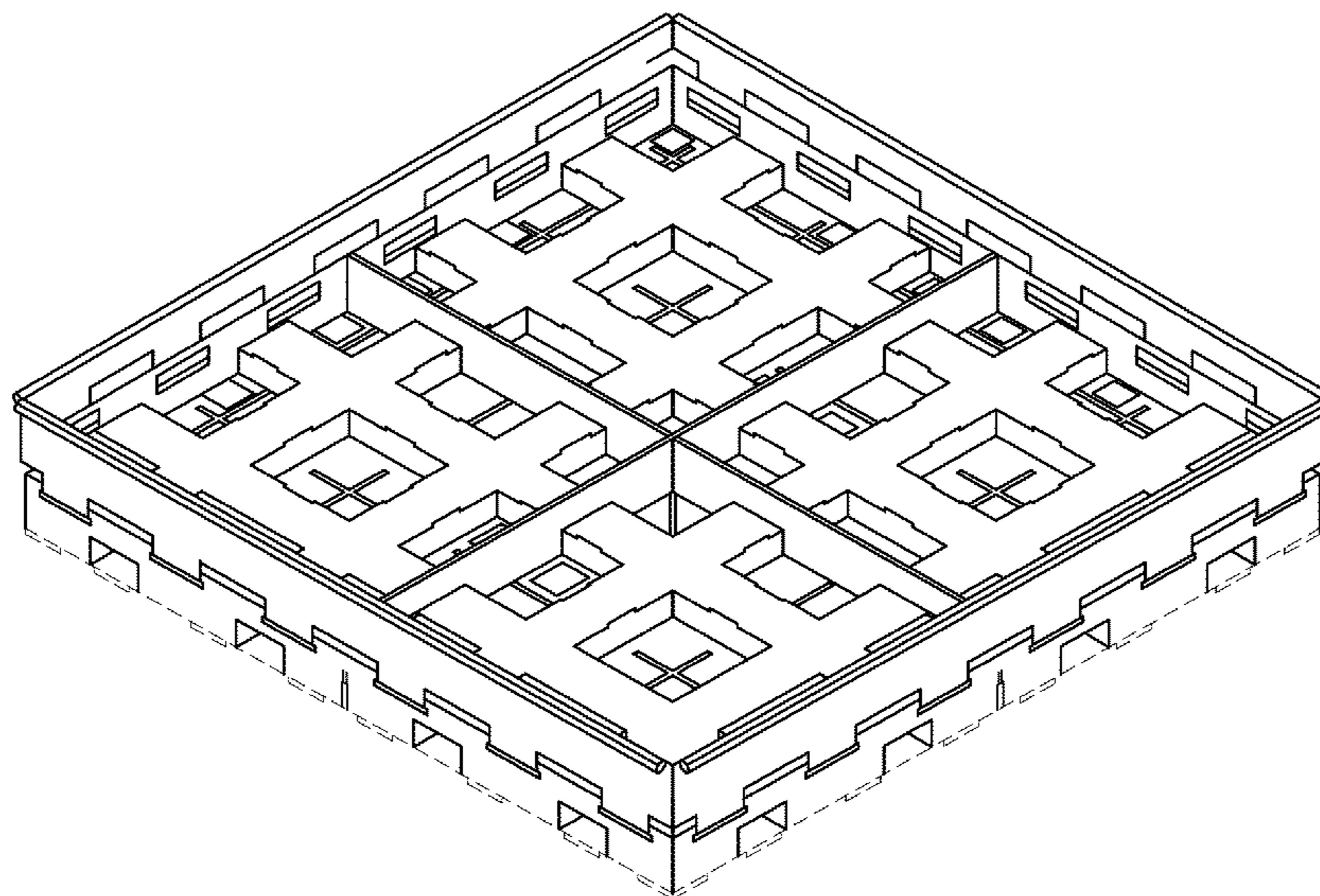

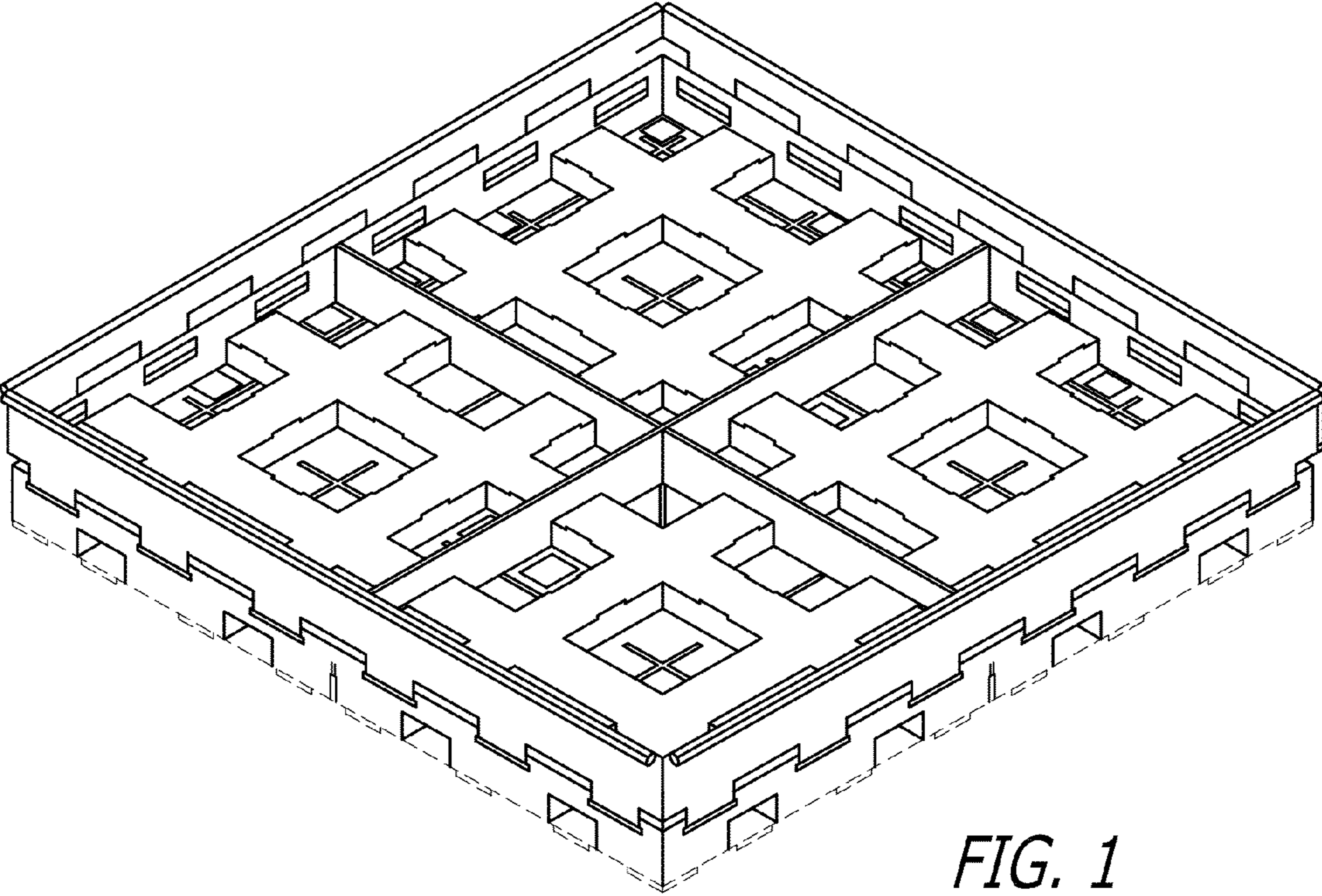
The ornamental design for a turf module, as shown and

**DESCRIPTION**

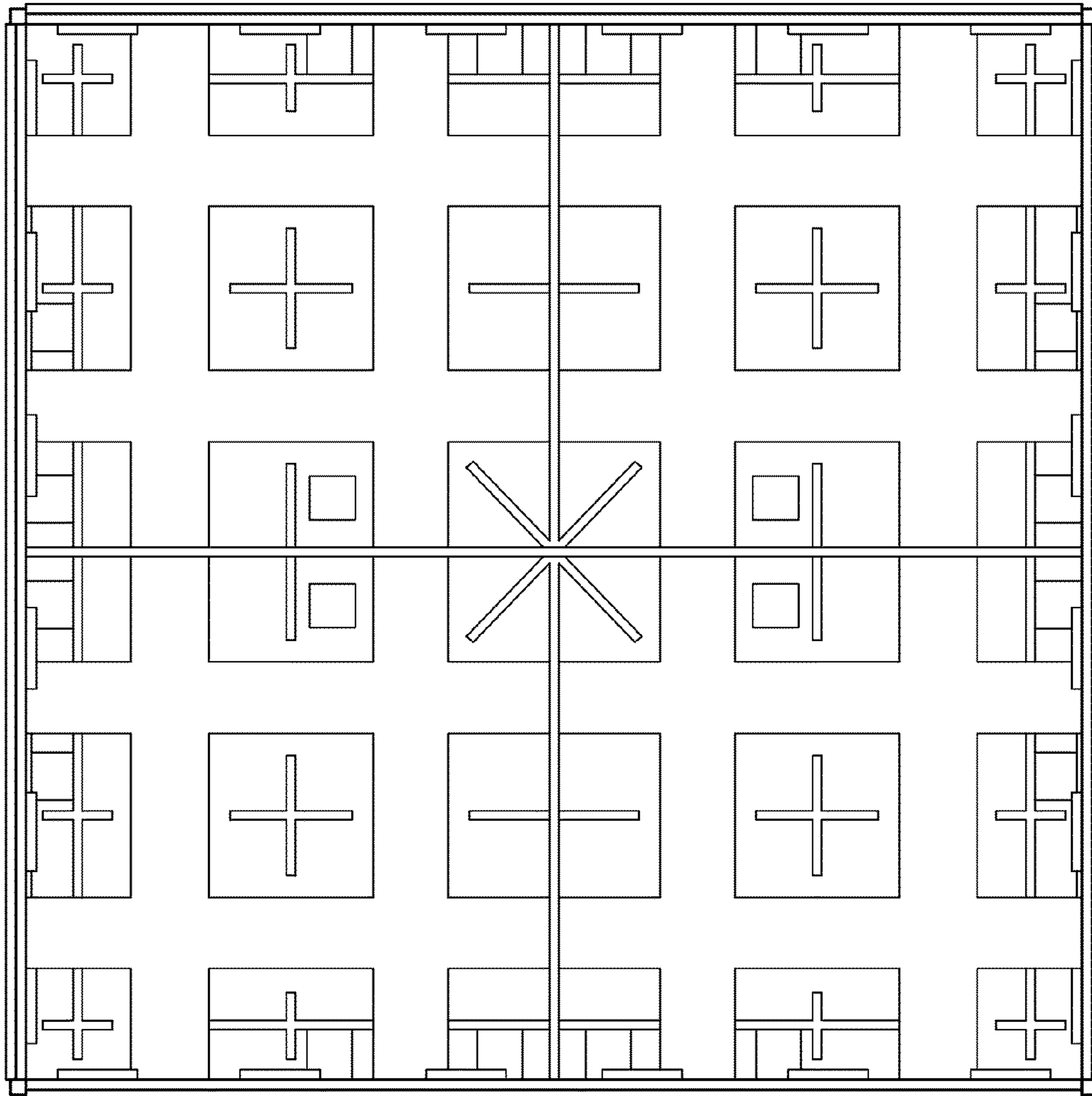
FIG. 1 is a top perspective view of a turf module, showing my

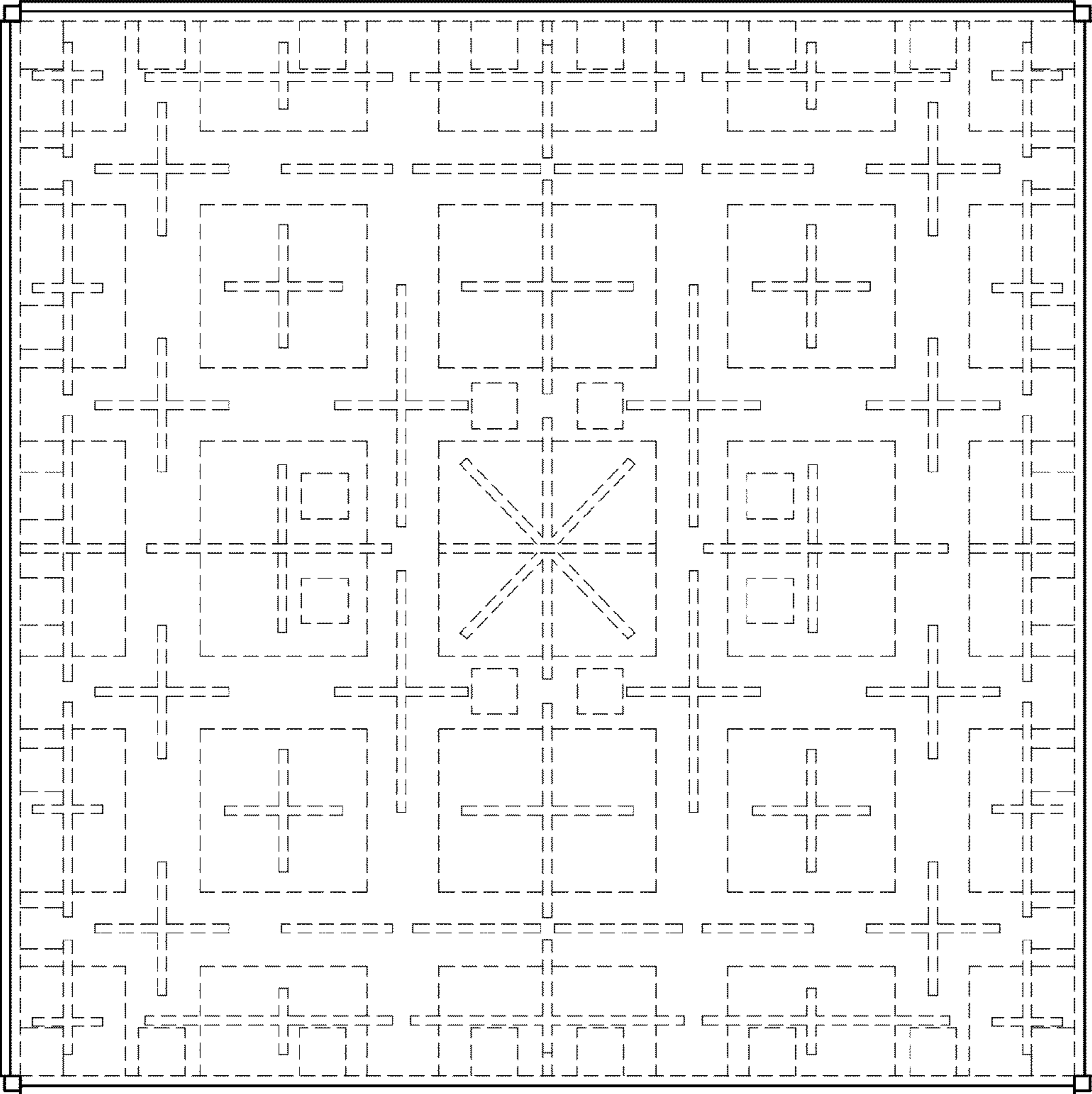
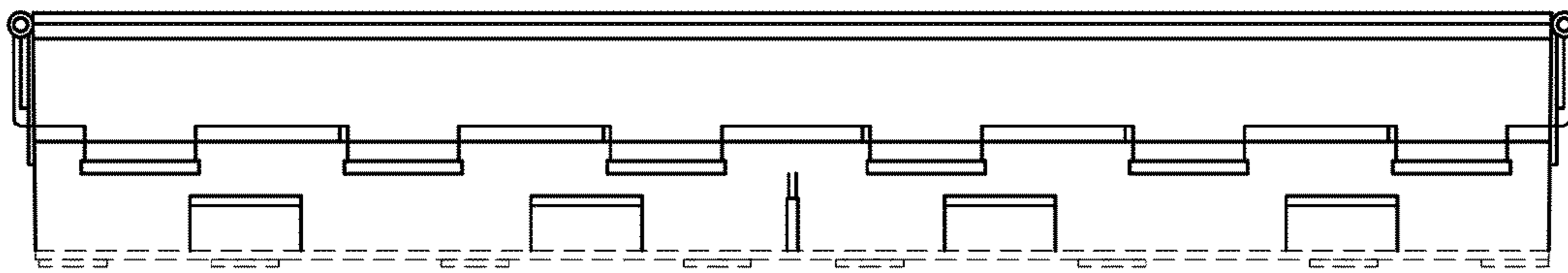
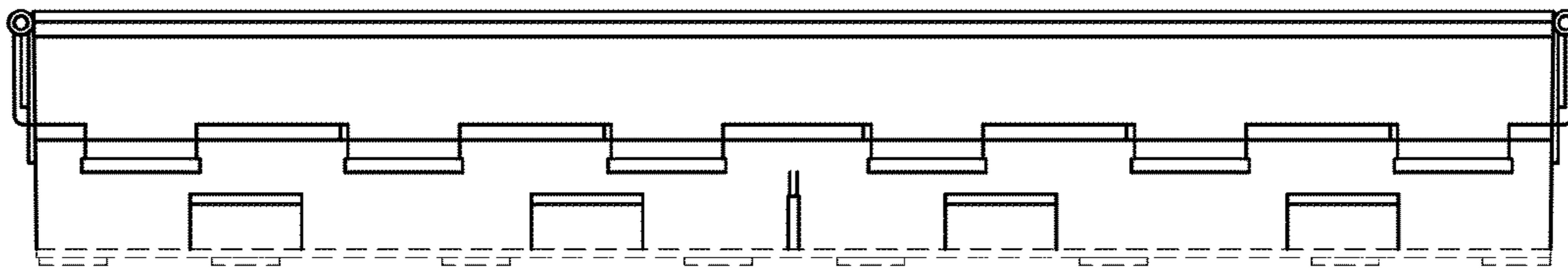


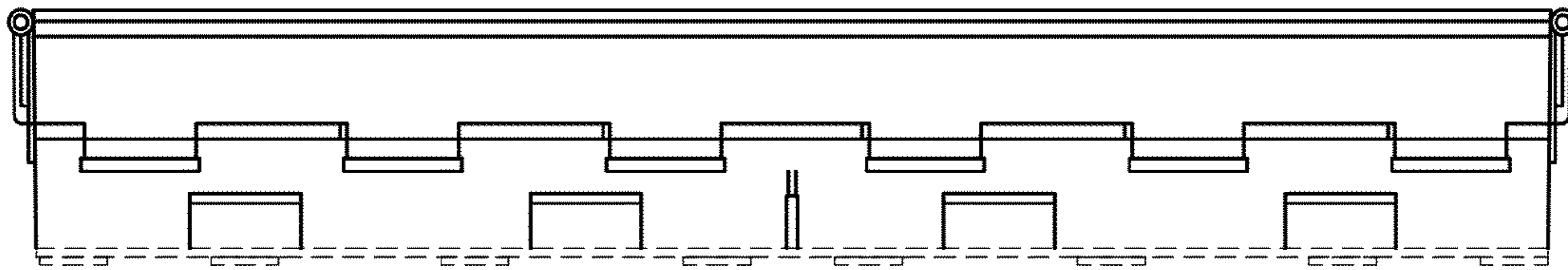
