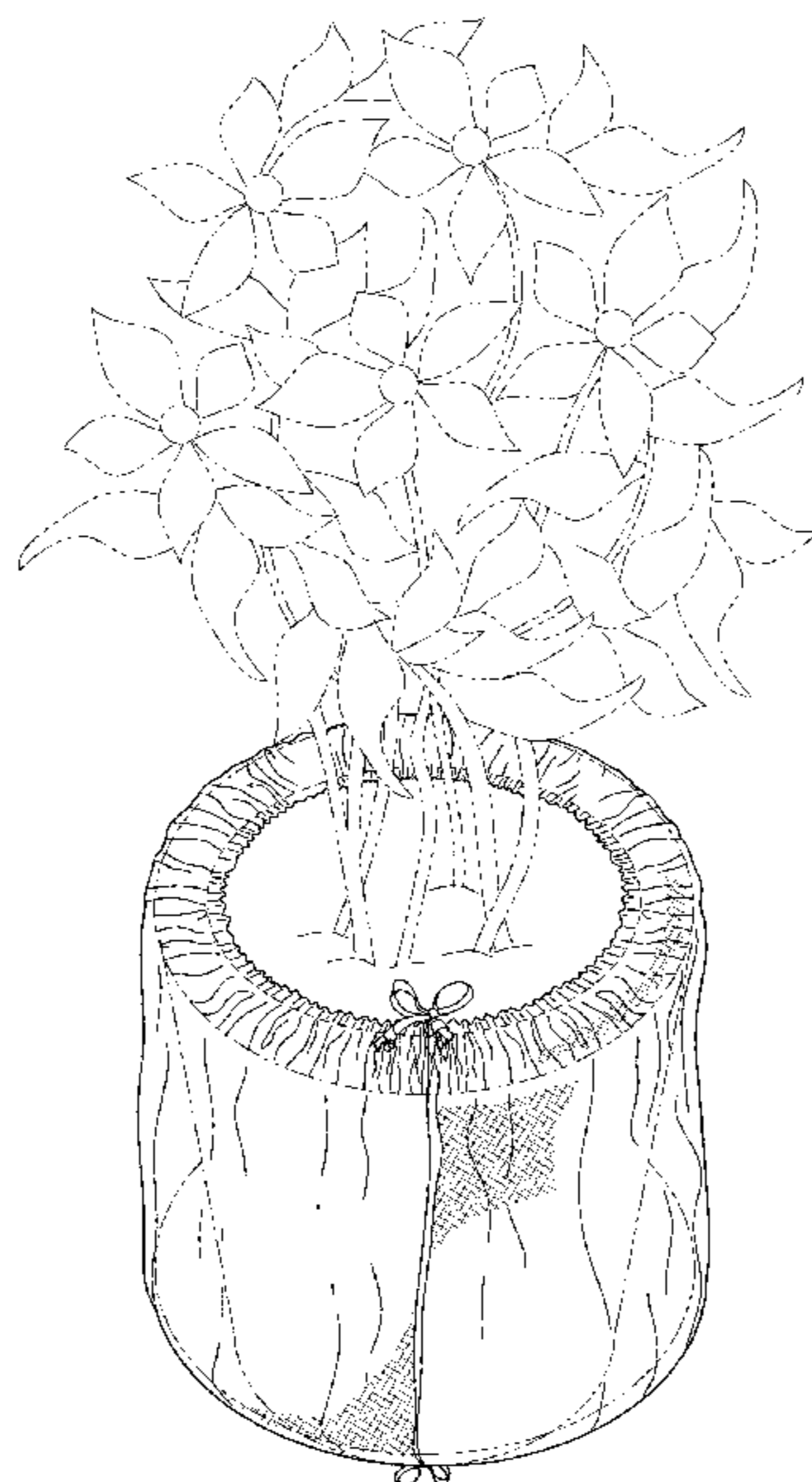

The ornamental design for a skirting for a potted plant container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and top perspective view of skirting for a potted plant container embodying my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a right side elevational view thereof, the left side elevational view being a mirror image;  
FIG. 5 is a bottom plan view thereof; and,  
FIG. 6 is a rear elevational view thereof.

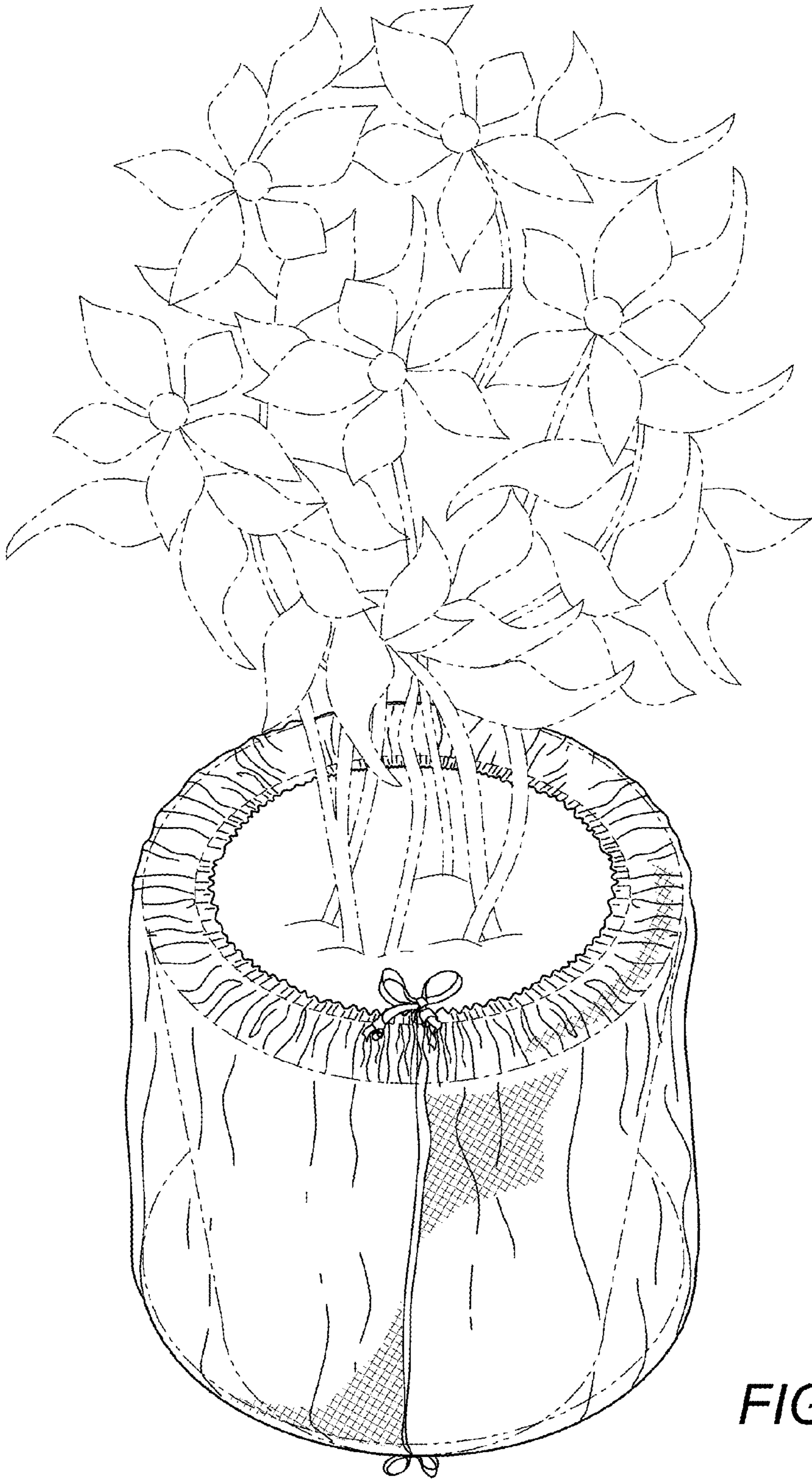
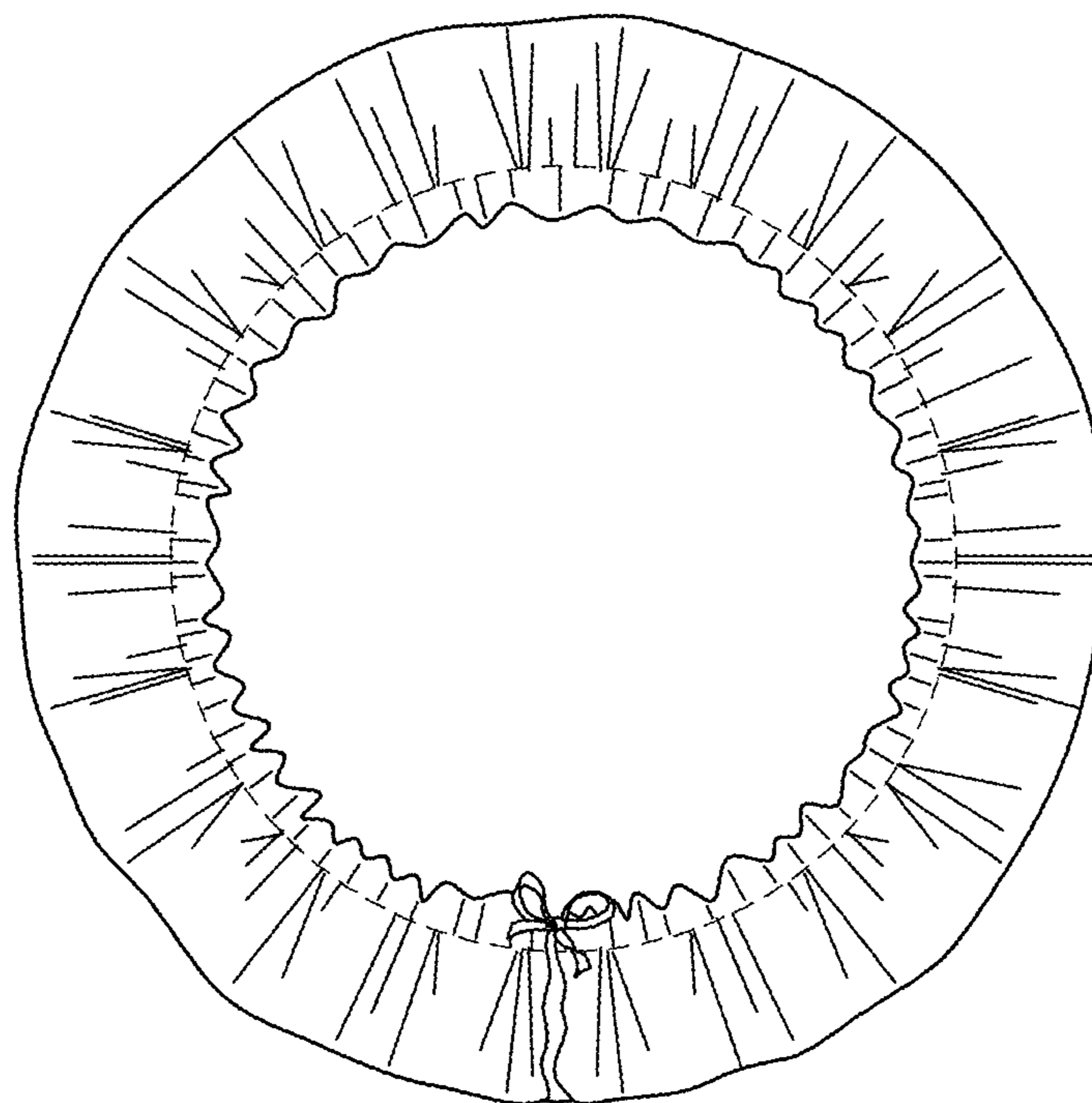
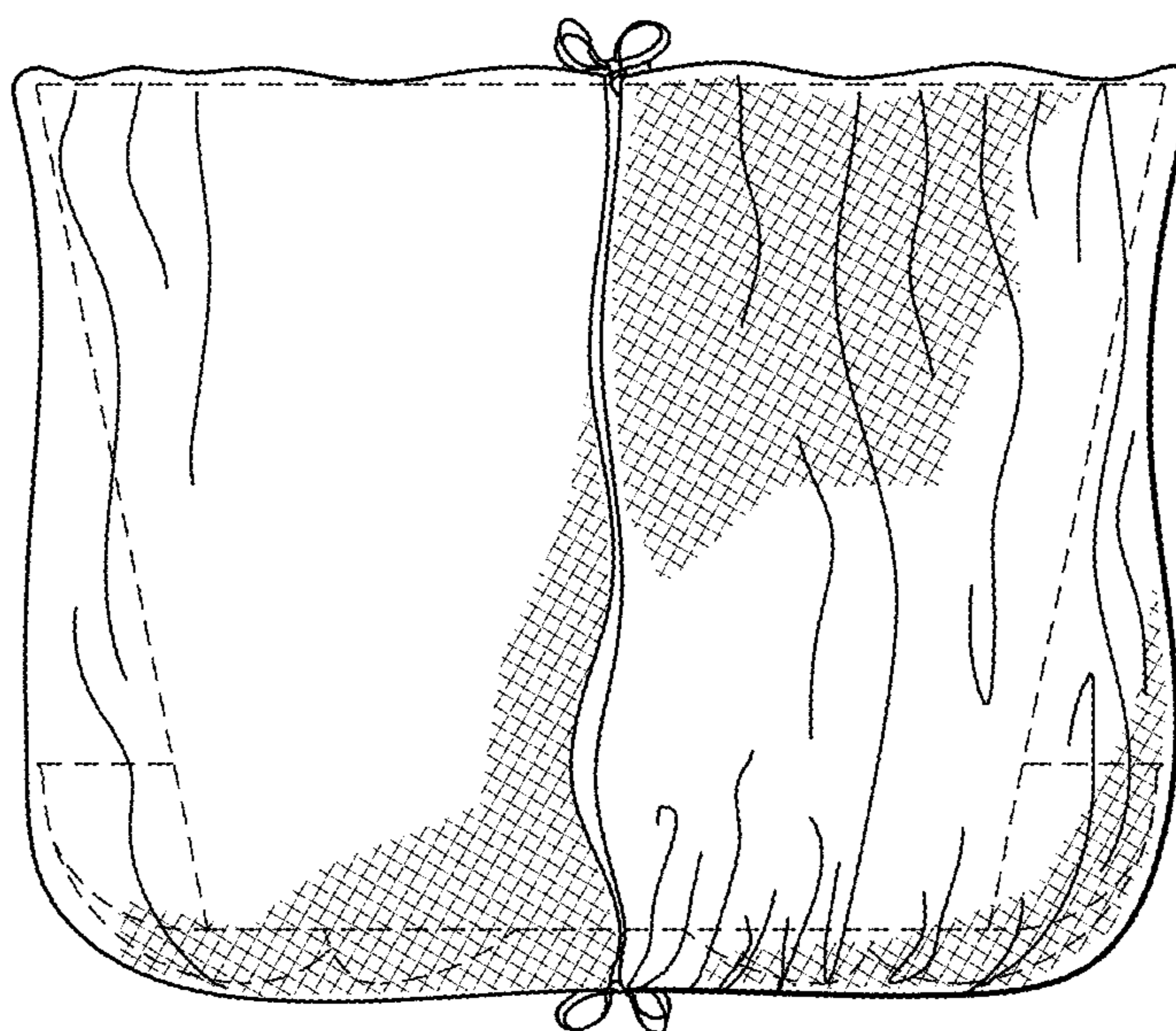


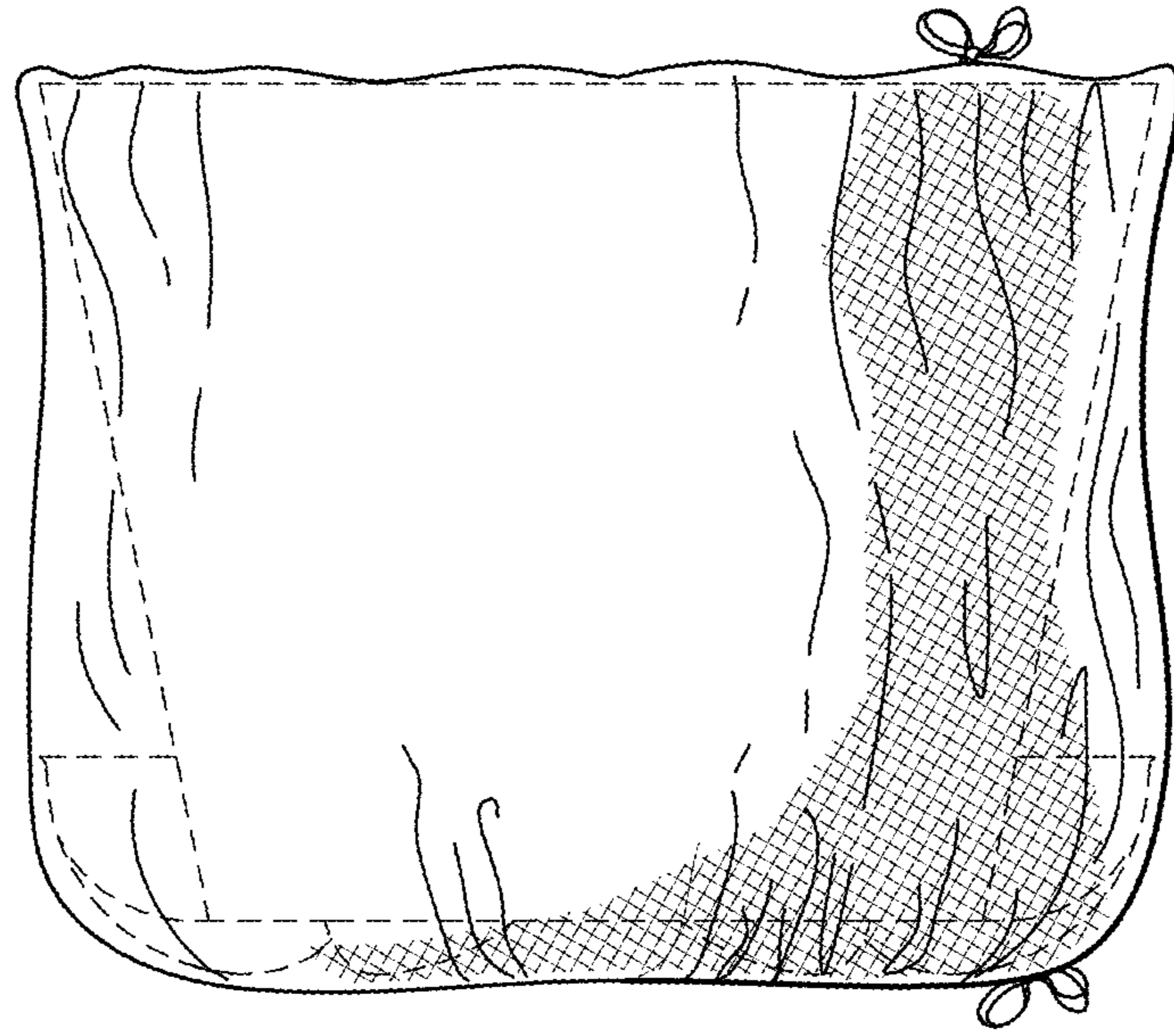

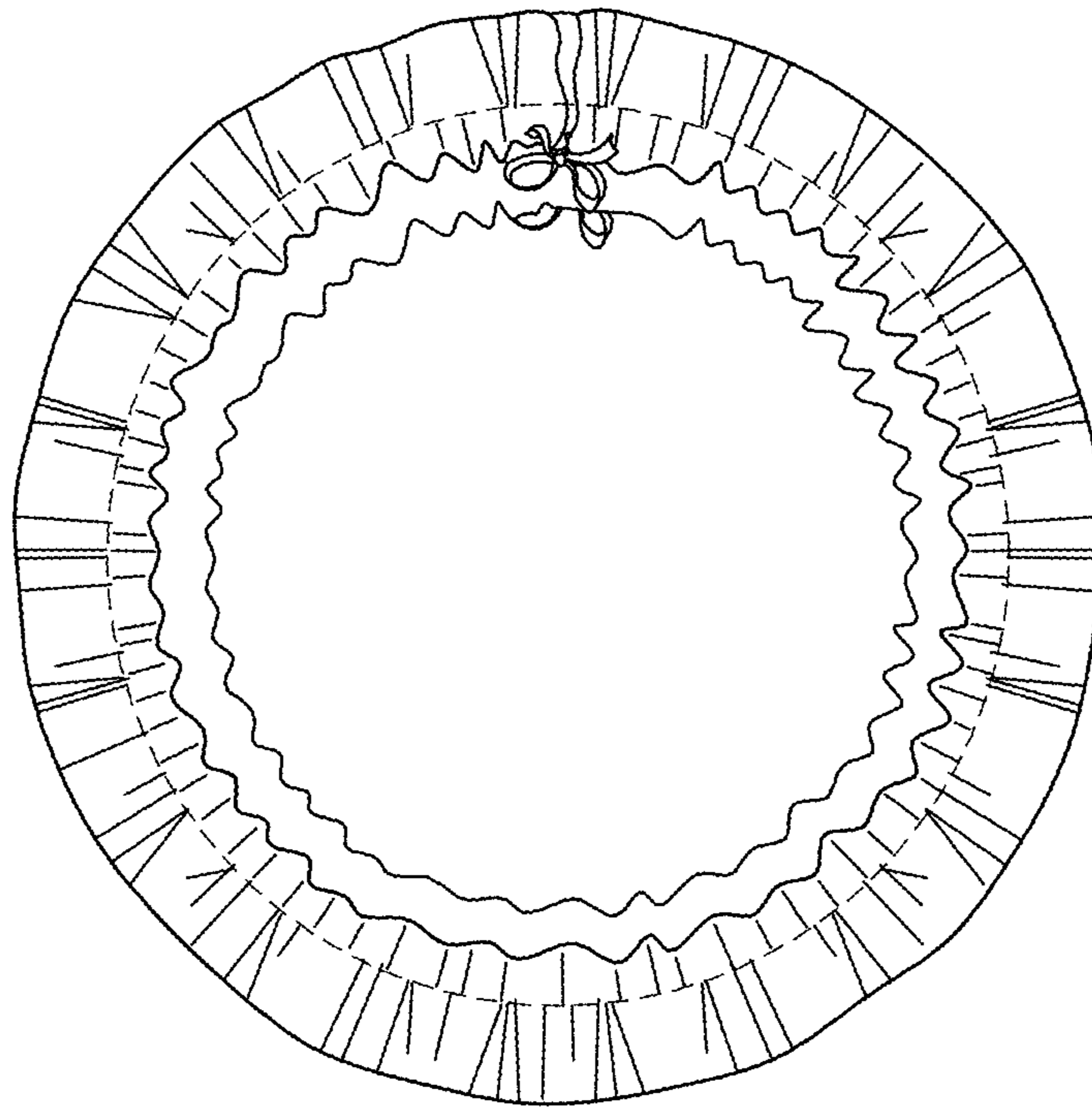

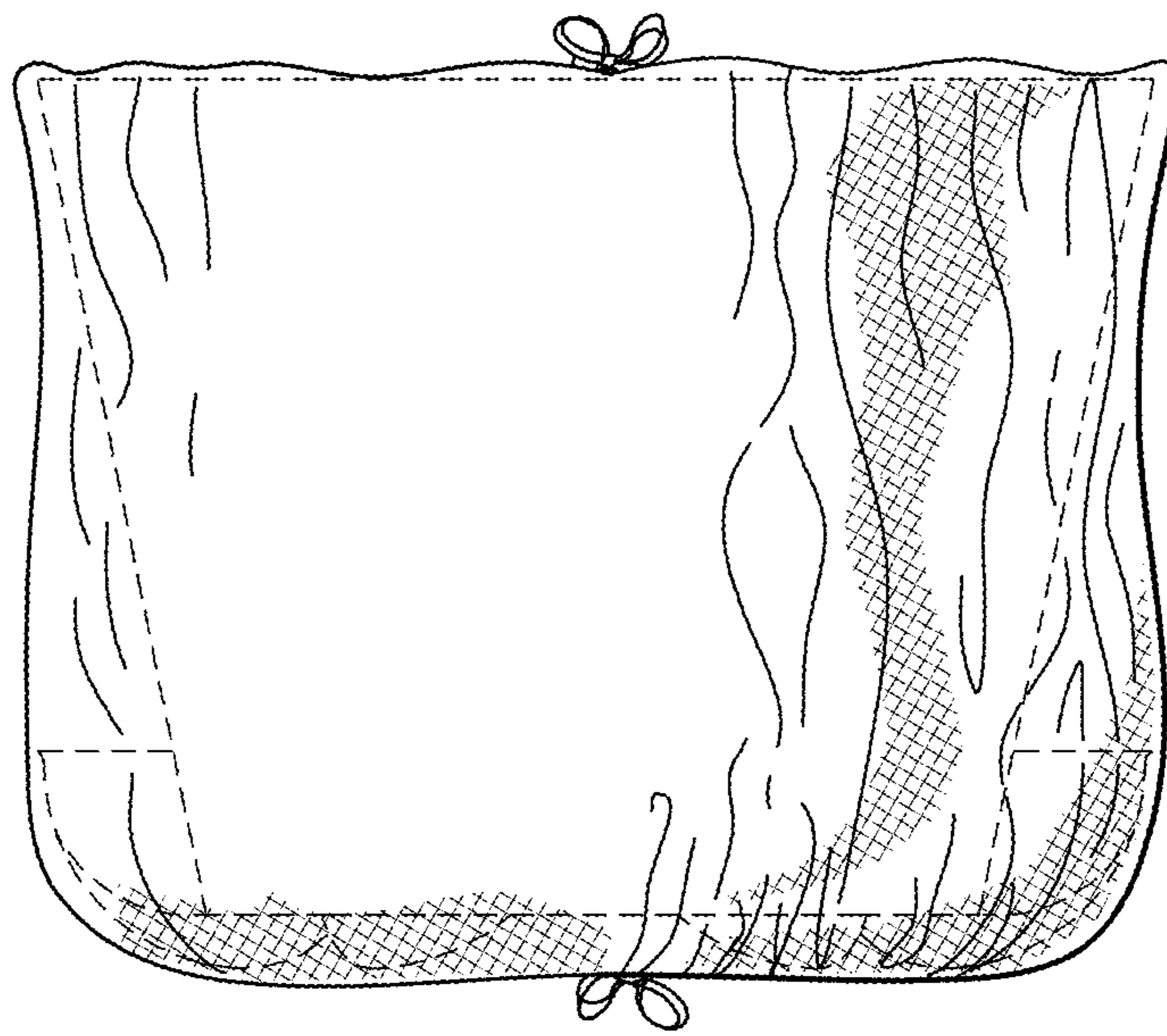
