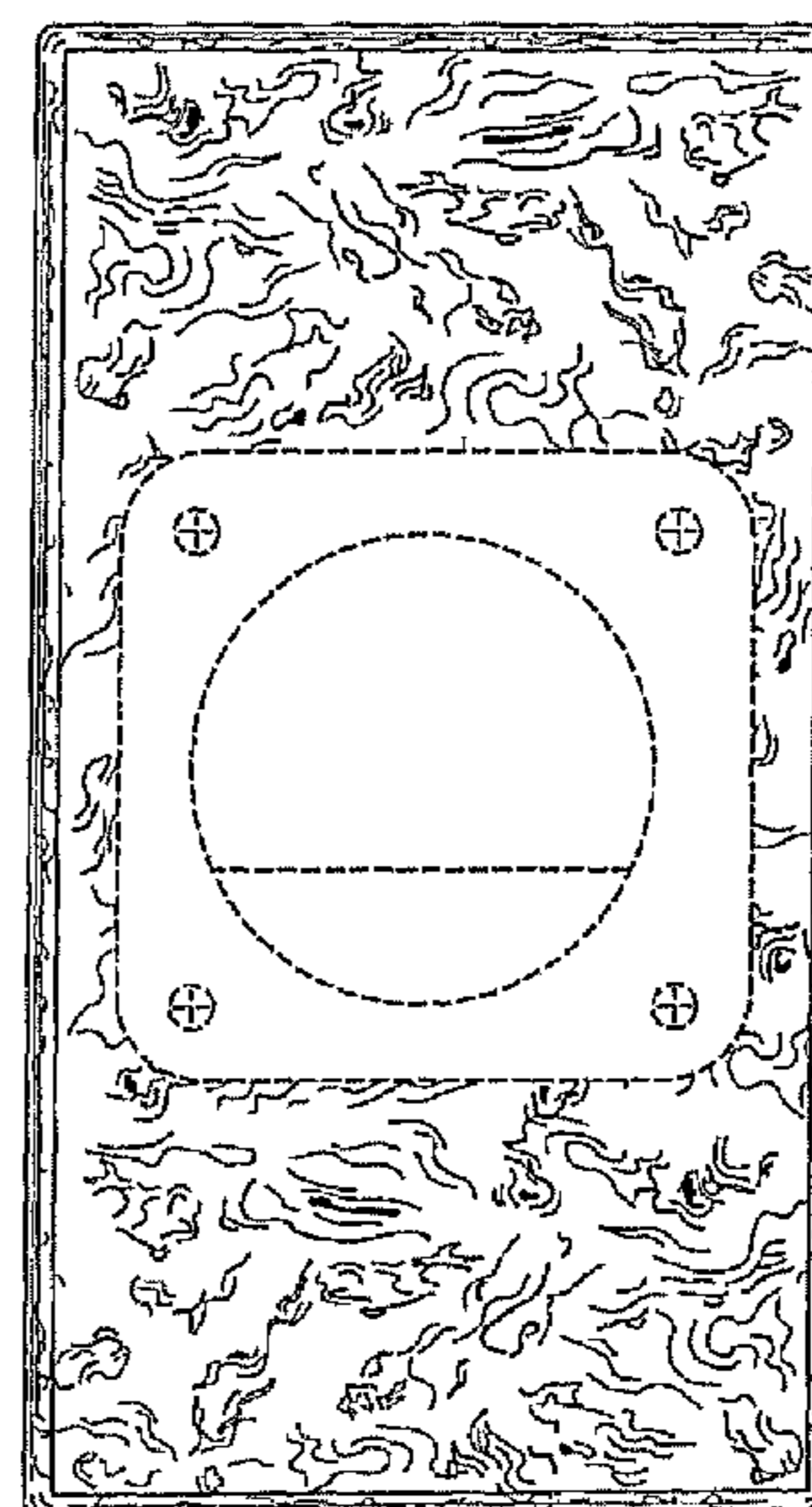
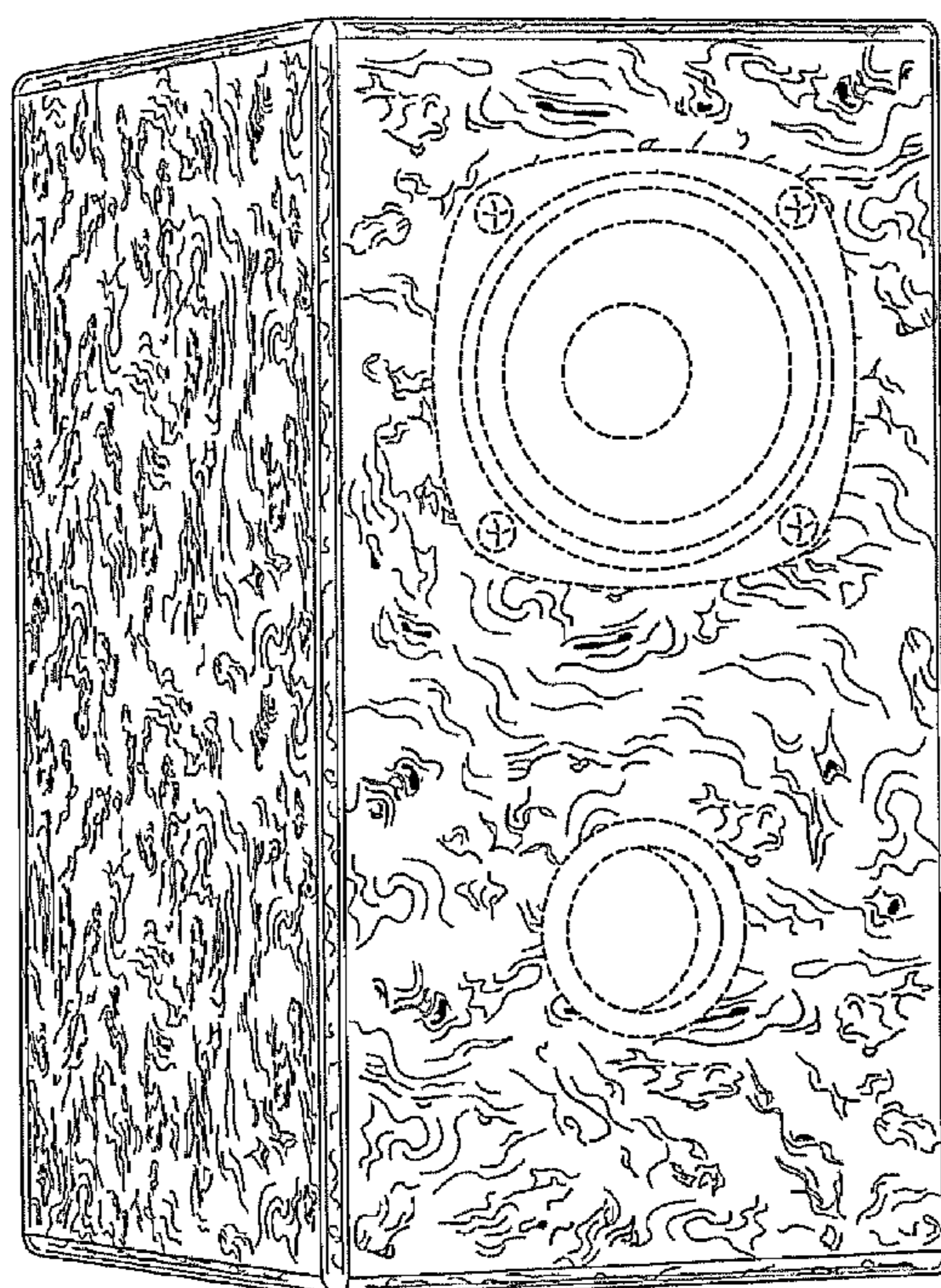
DESCRIPTION

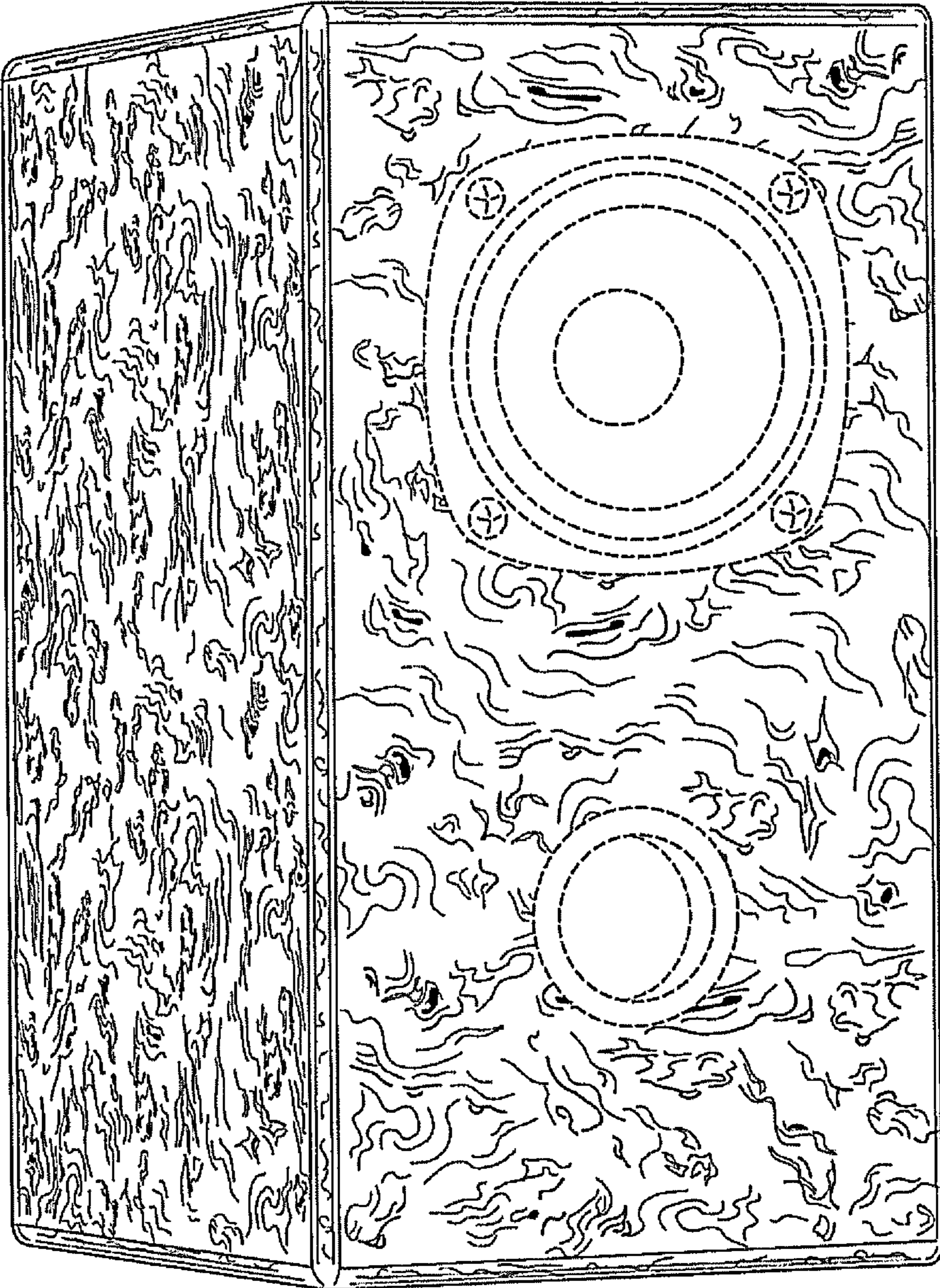

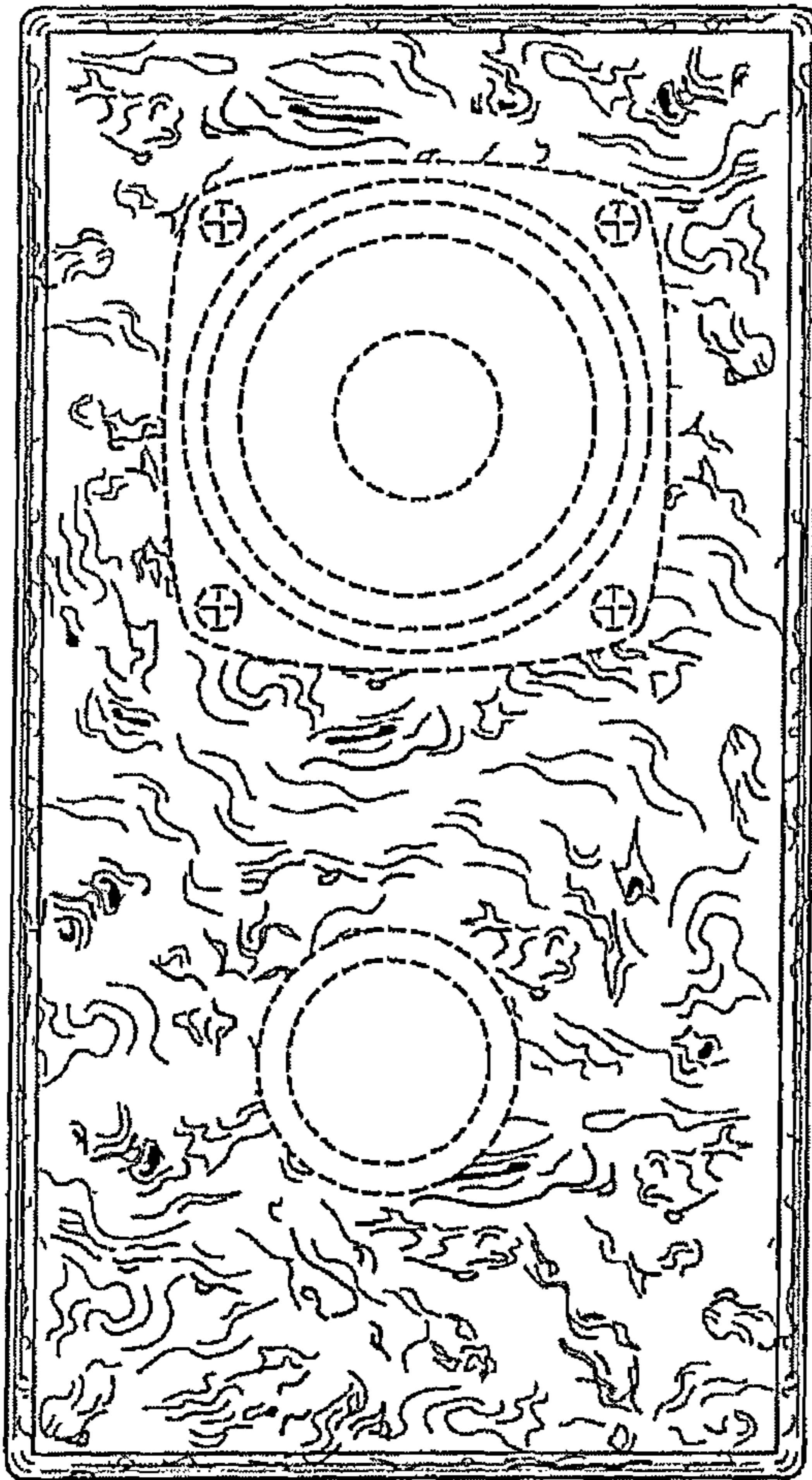

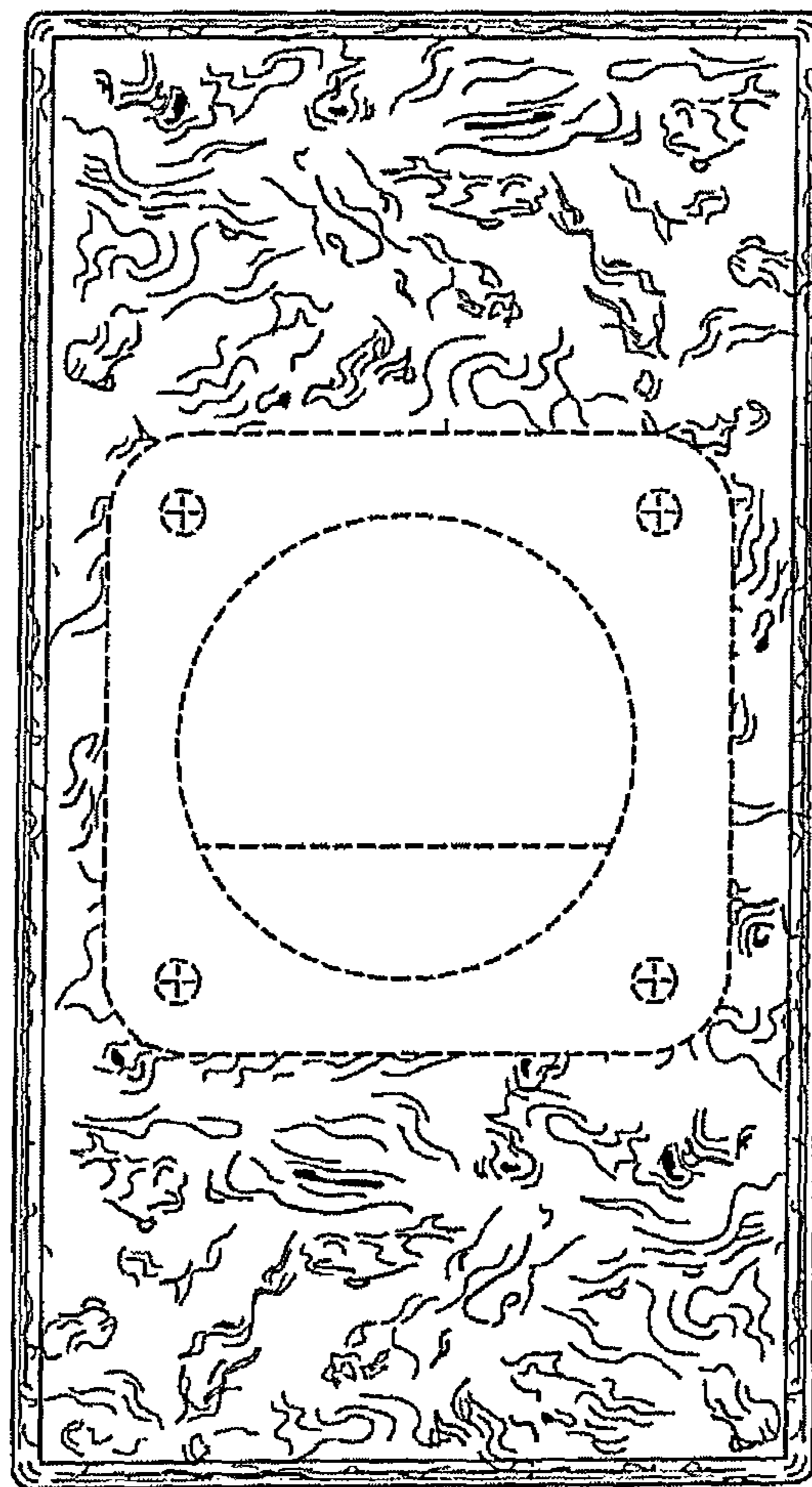

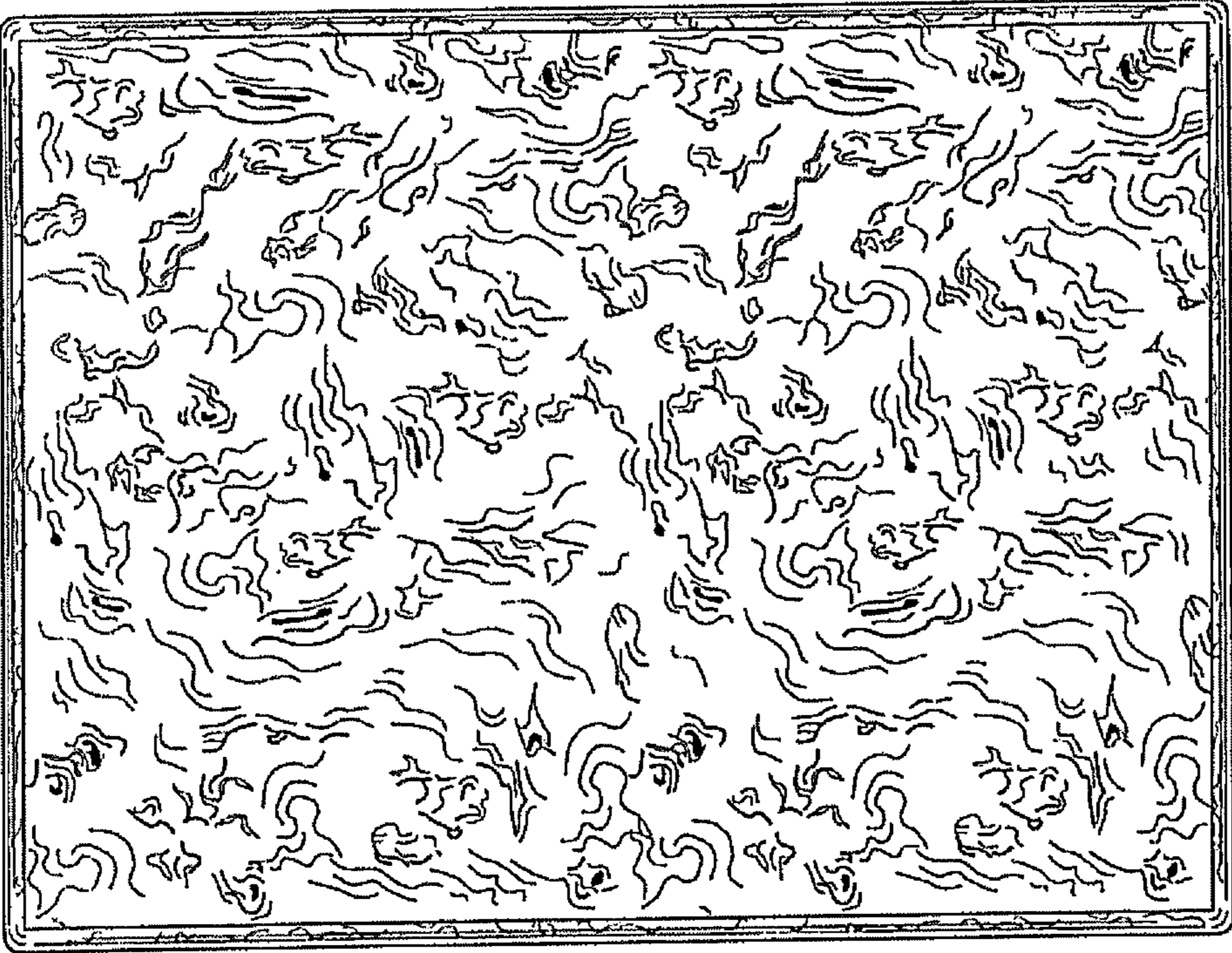

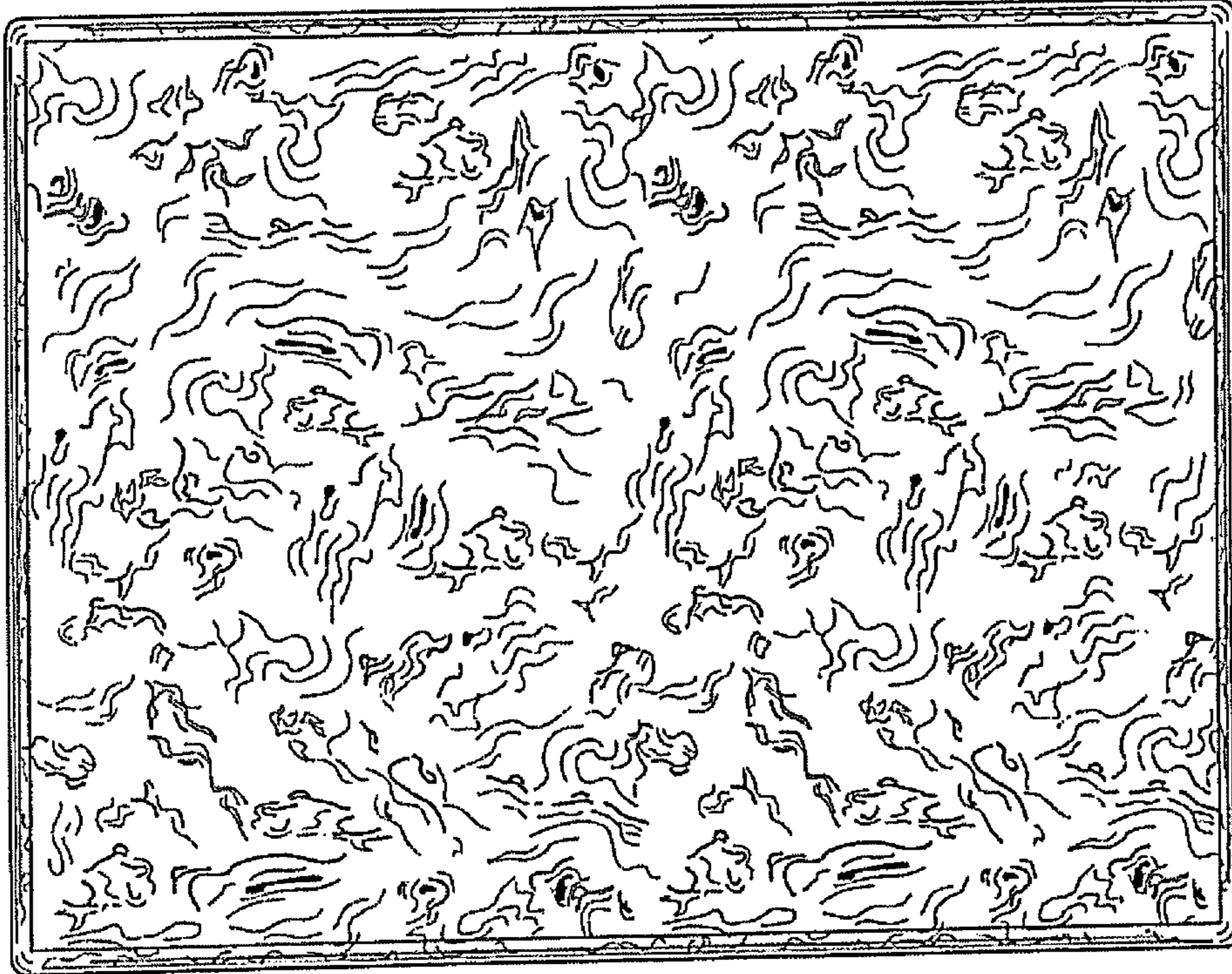

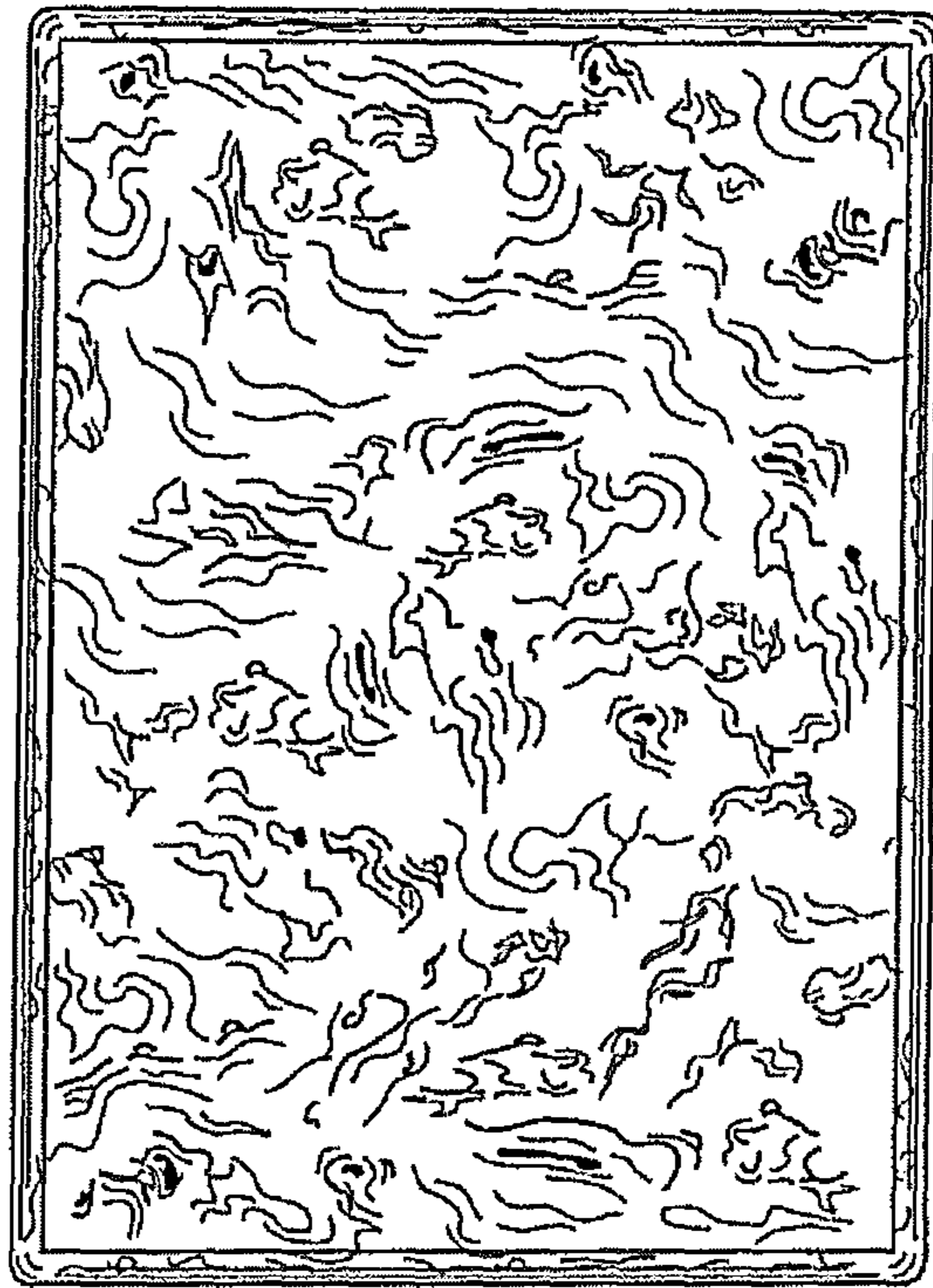
