DESCRIPTION

FIG. 1 is the front perspective view of a notebook computer showing my new design;

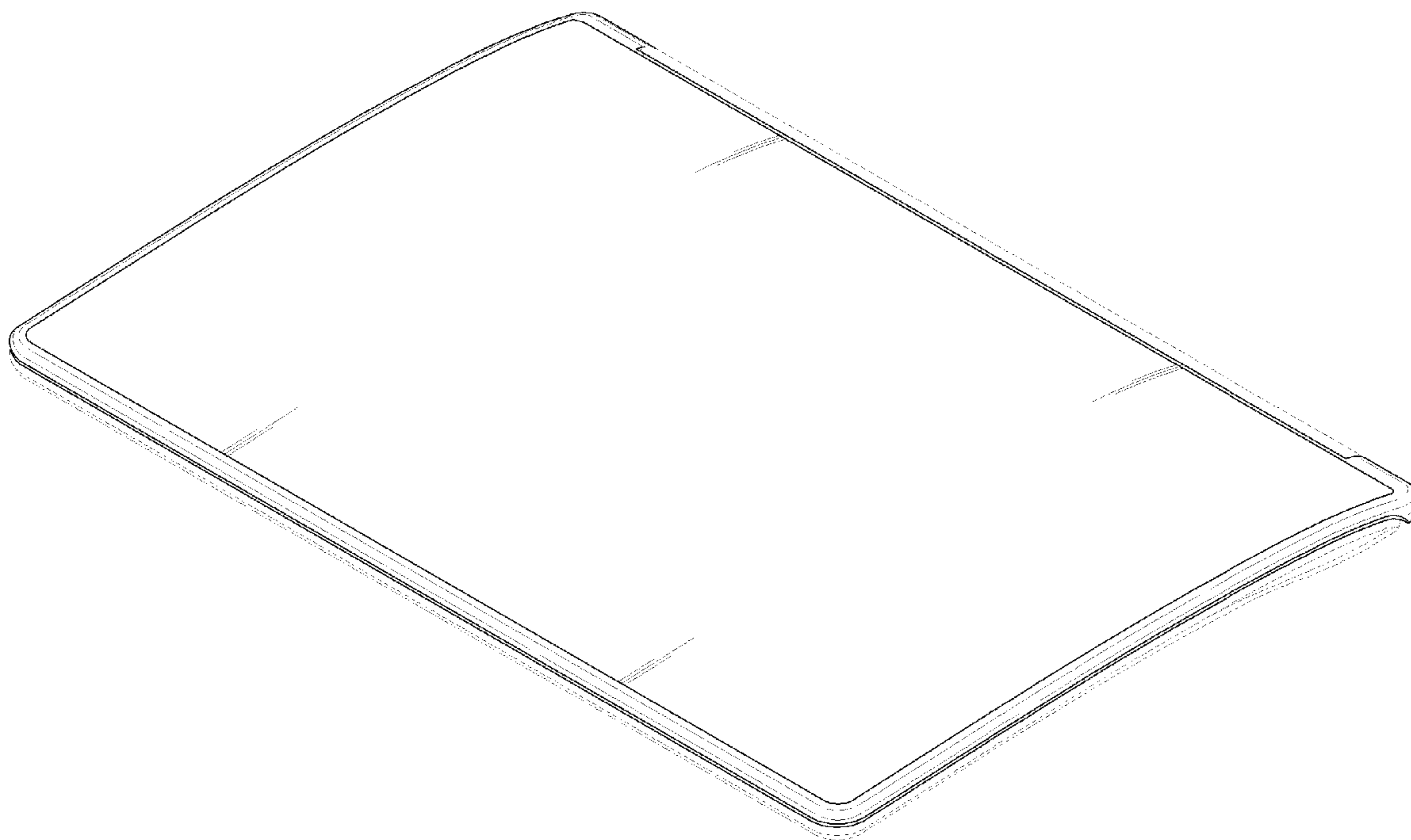

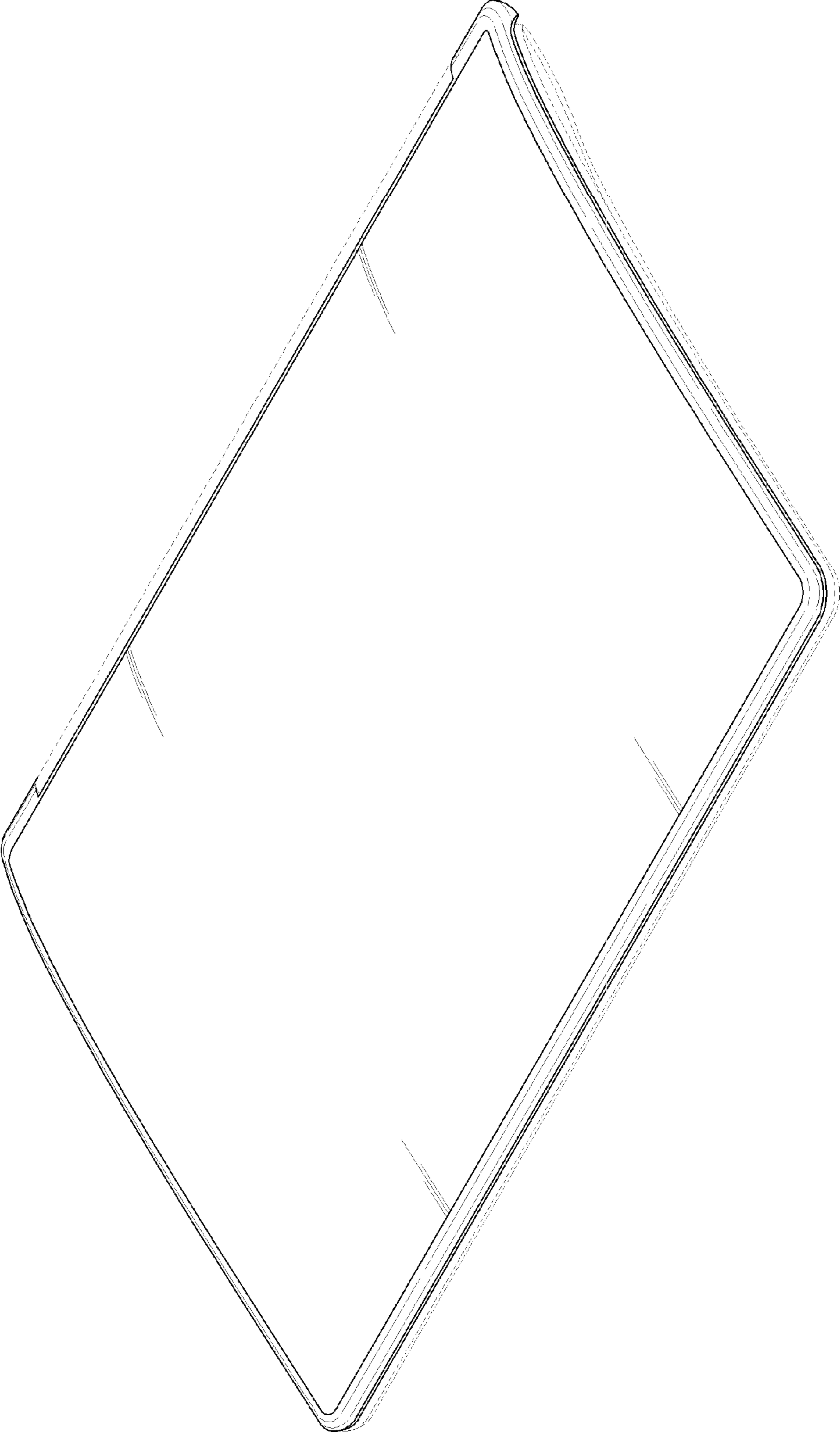

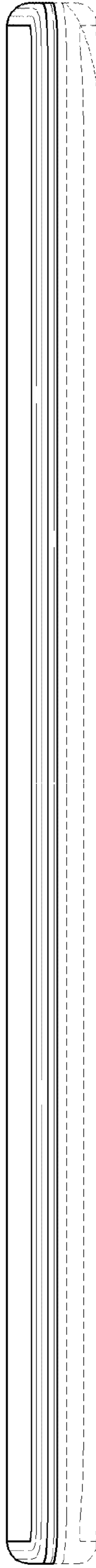

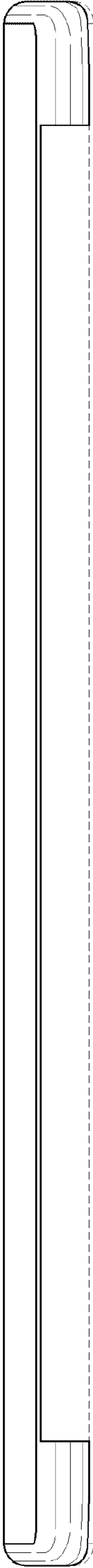

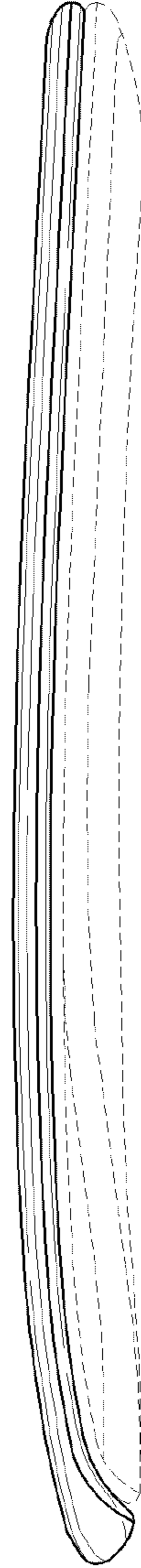

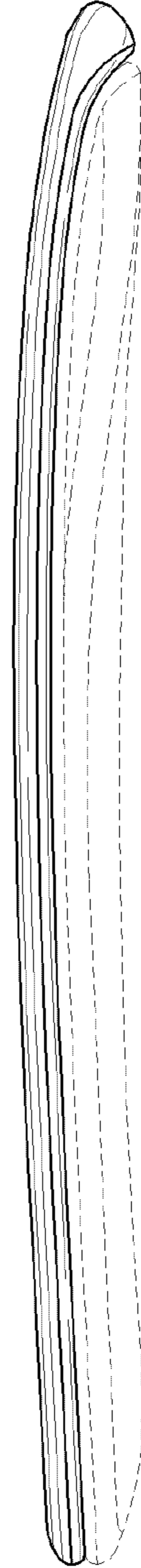

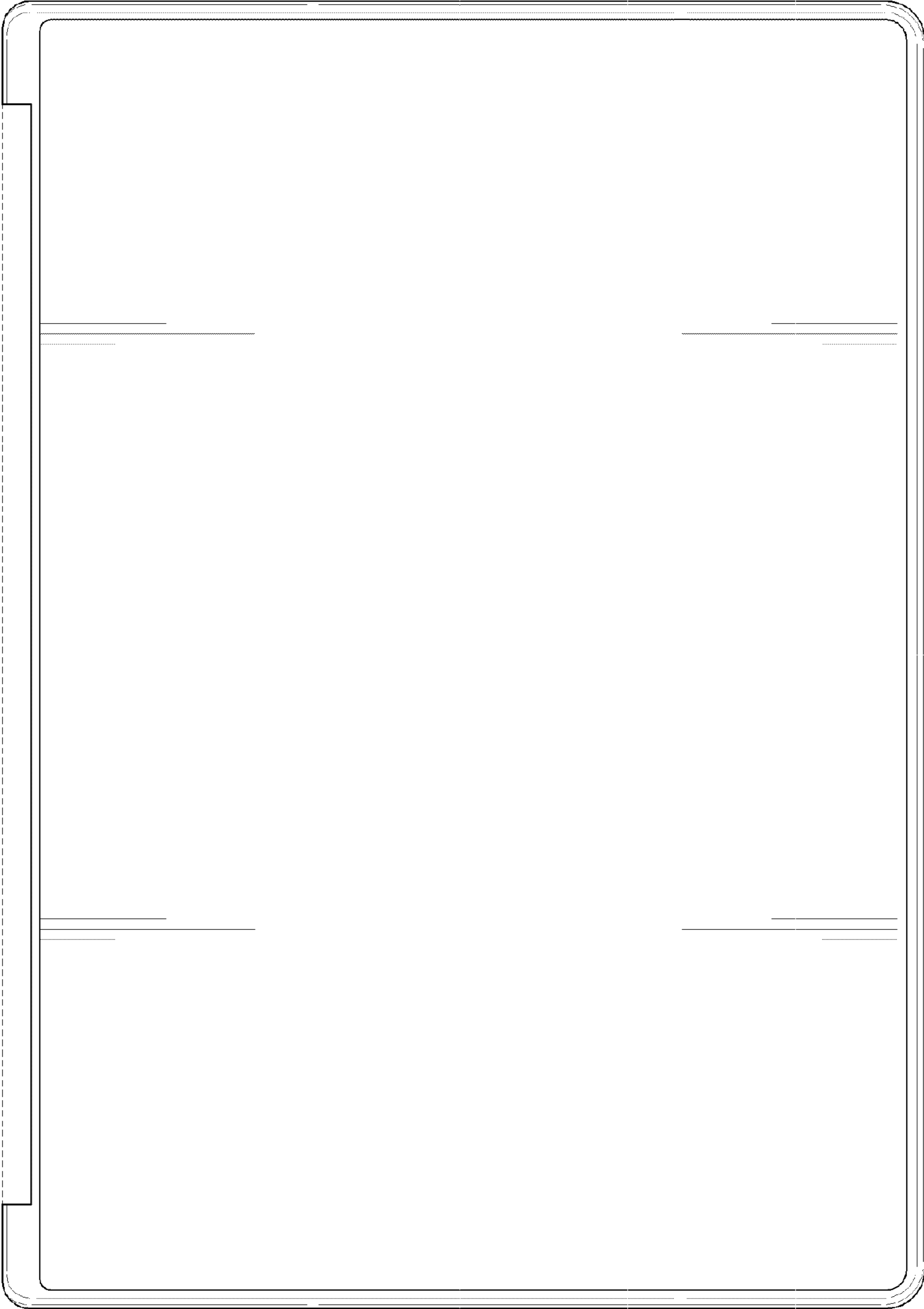
