(57) **CLAIM**

The ornamental design for a TV display screen with an animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side view of a first image of the TV display screen with an animated graphical user interface showing our new design; and,

FIG. 2 is a front side view of a second image of the TV display screen with graphical user interface showing our new design. The appearance of the image transitions sequentially between the images shown in FIGS. 1-2. The process or period in which an image transitions to another forms no part of the claimed design.

The broken lines shown in drawings illustrate portions of the TV, display screen and graphical user interface that form no part of the claimed design.

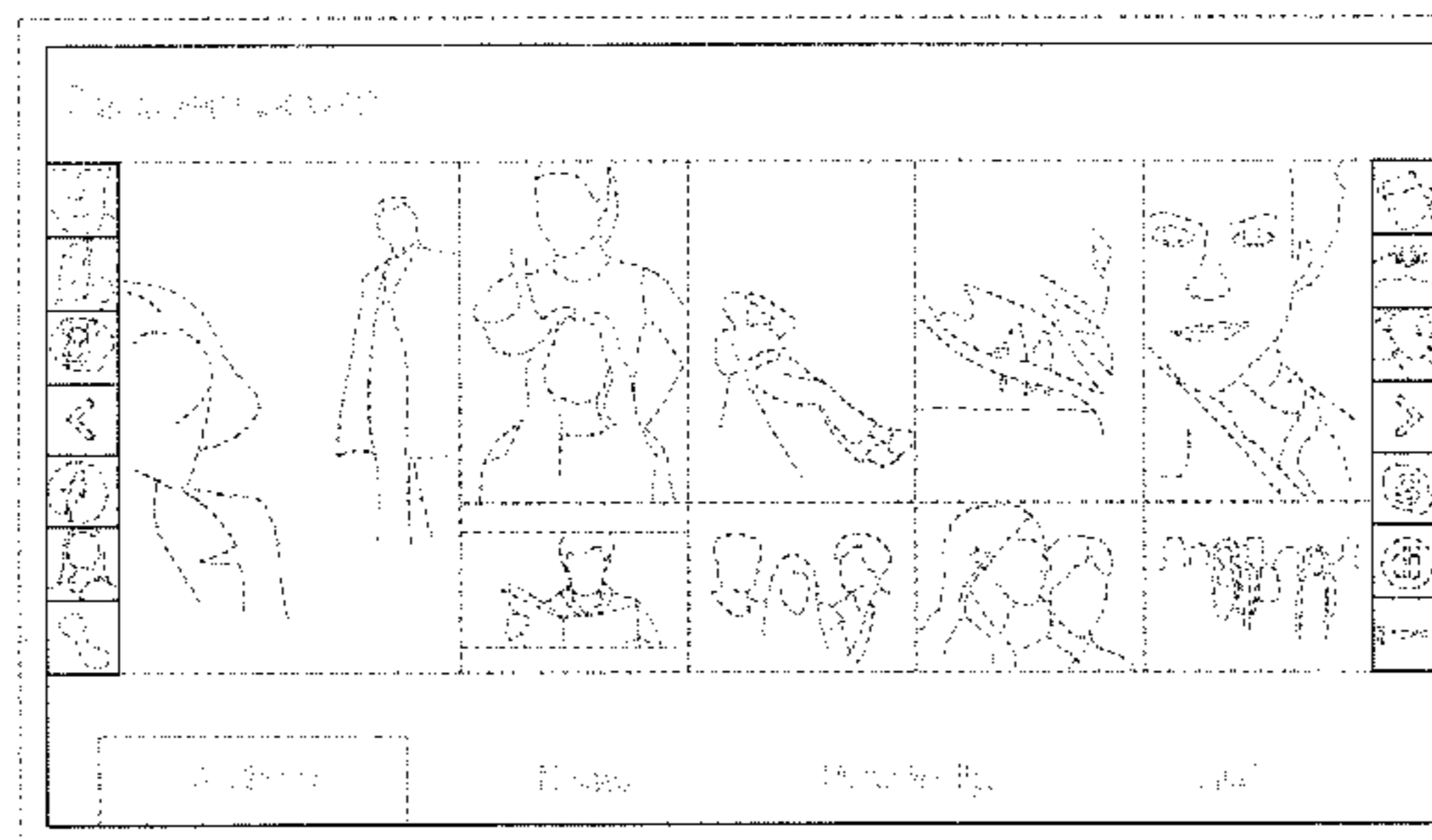
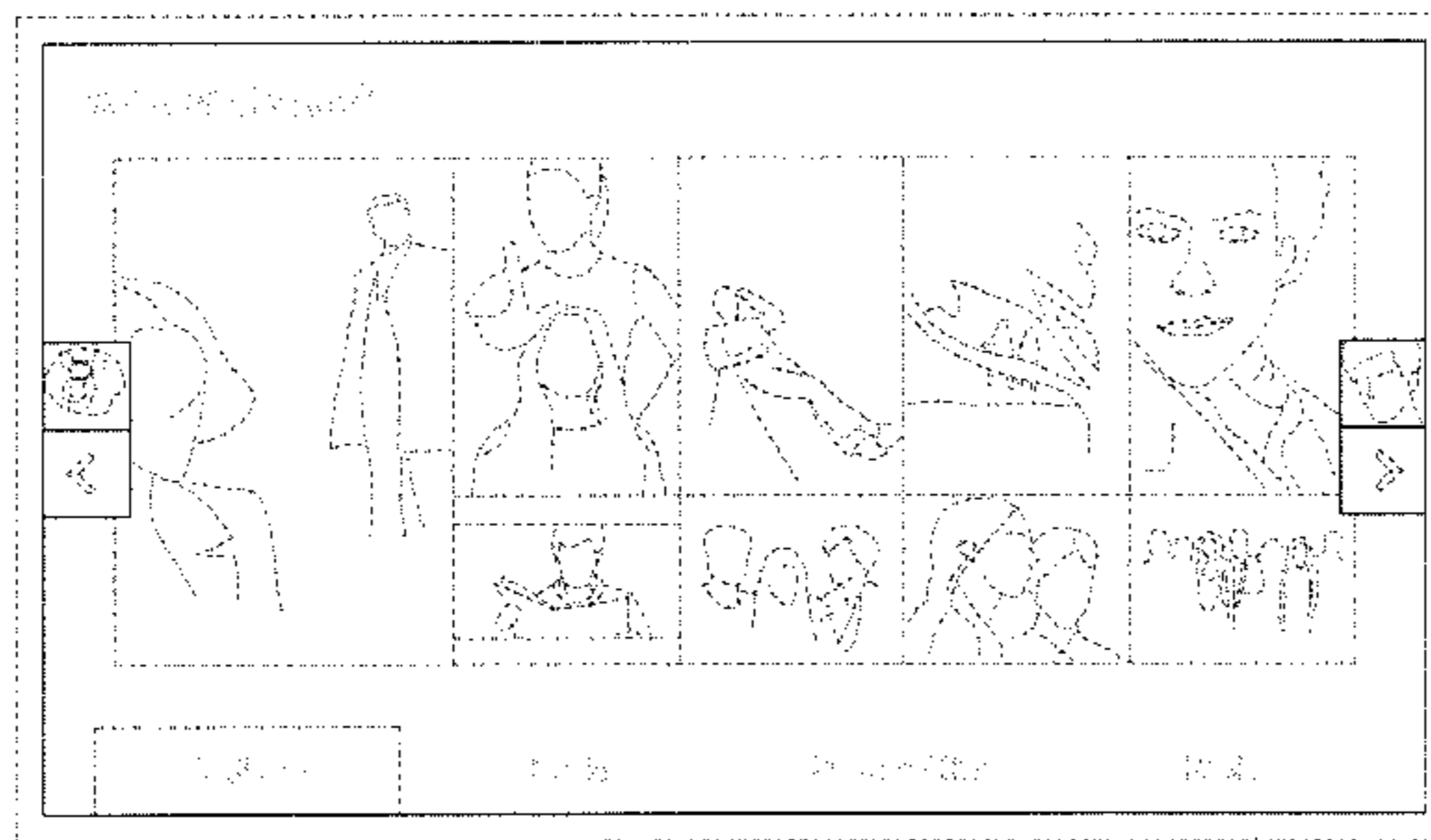

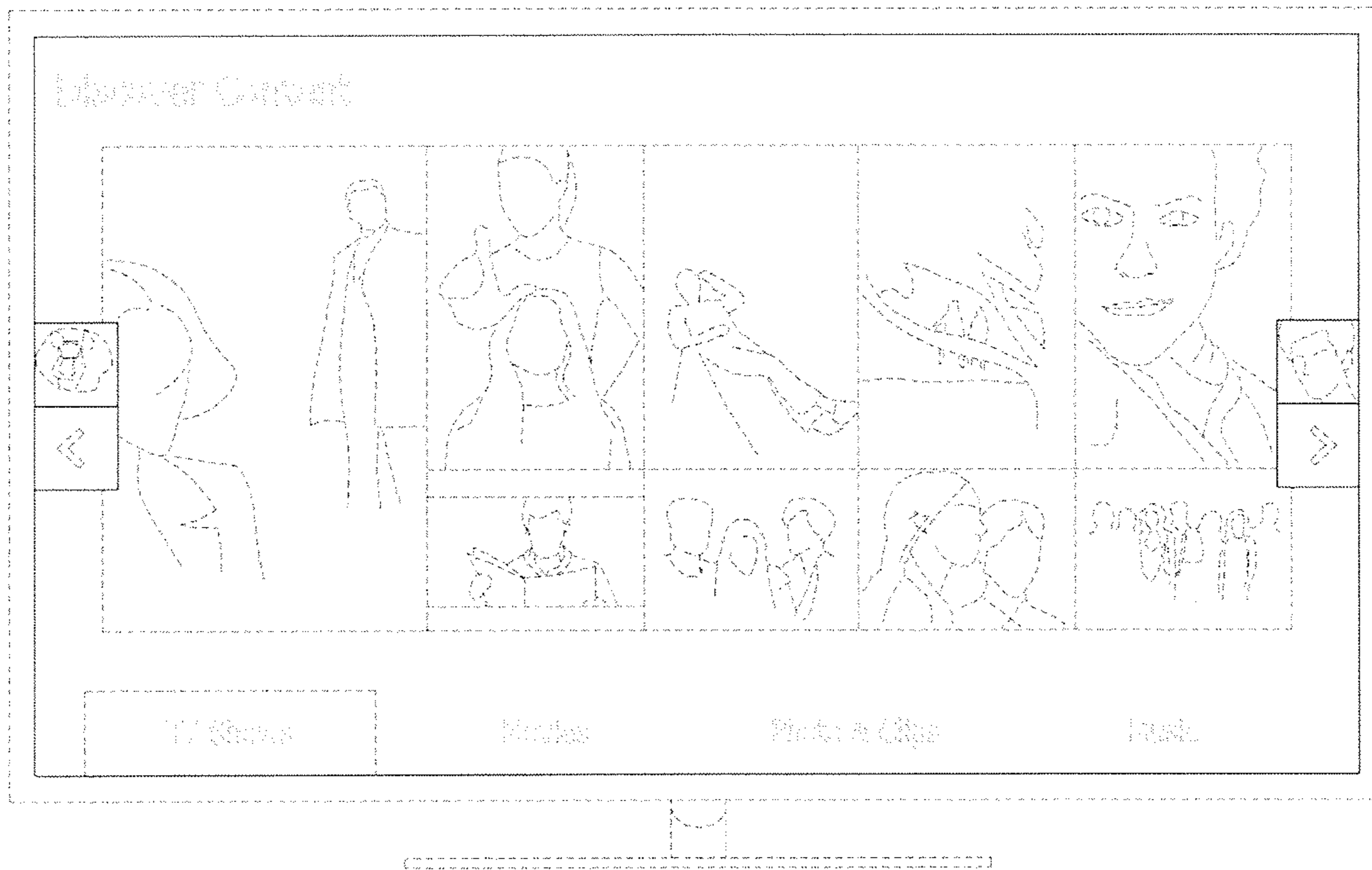
