The ornamental design for a portion of a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first embodiment of a portion of a display screen with graphical user interface showing my new design;

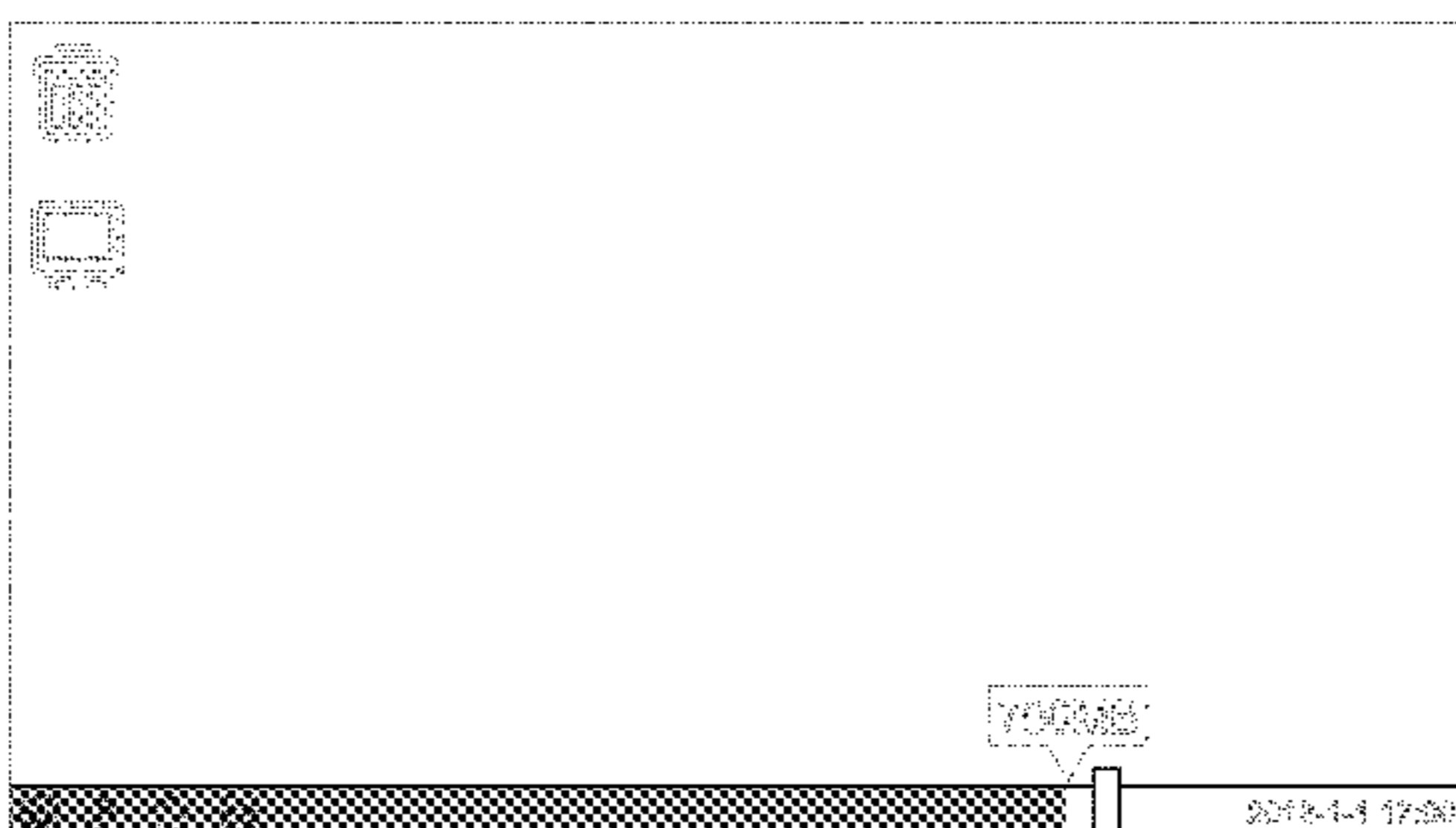
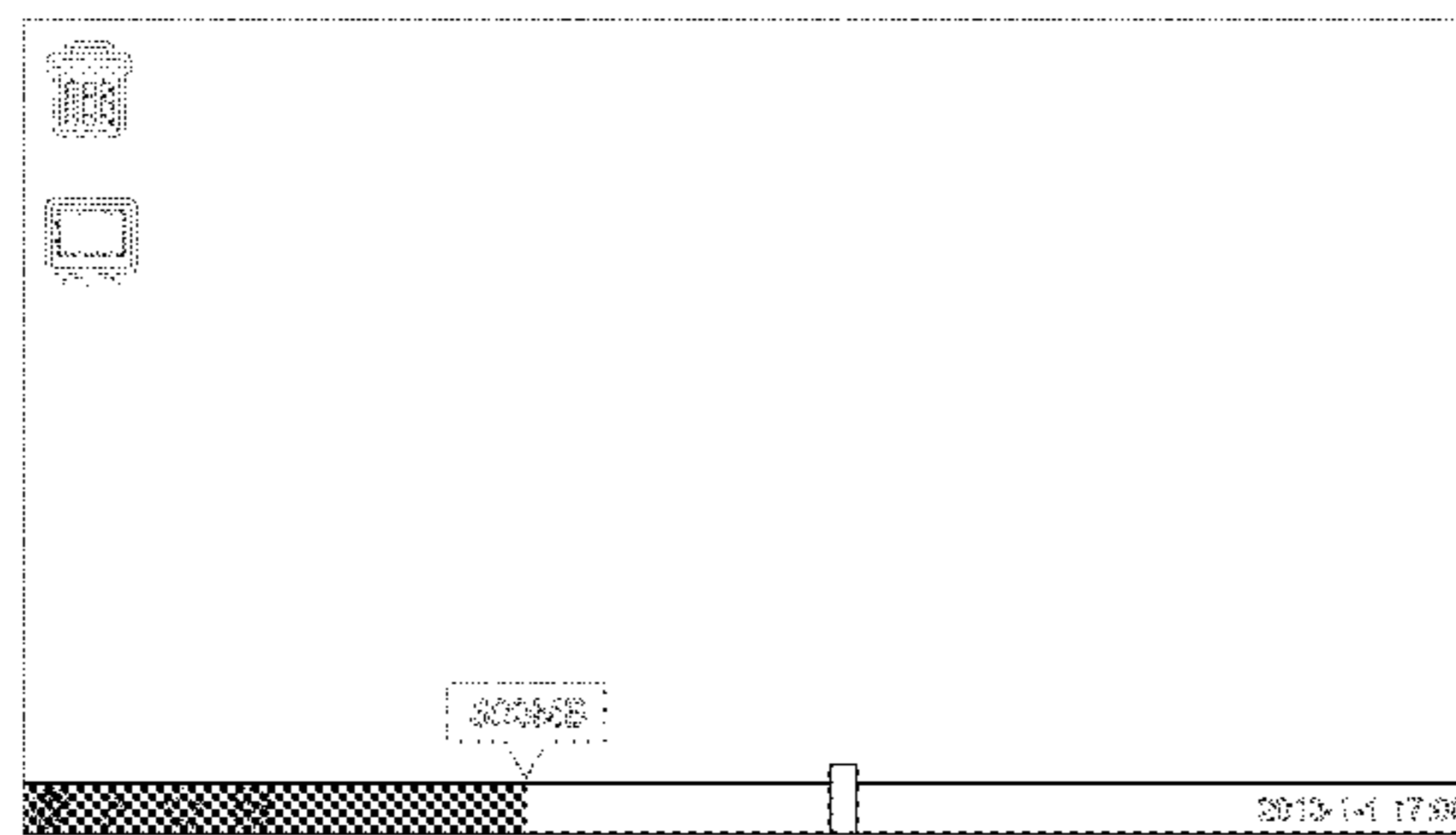
FIG. 2 is a front view of a second embodiment of a portion of a display screen with graphical user interface showing my design;

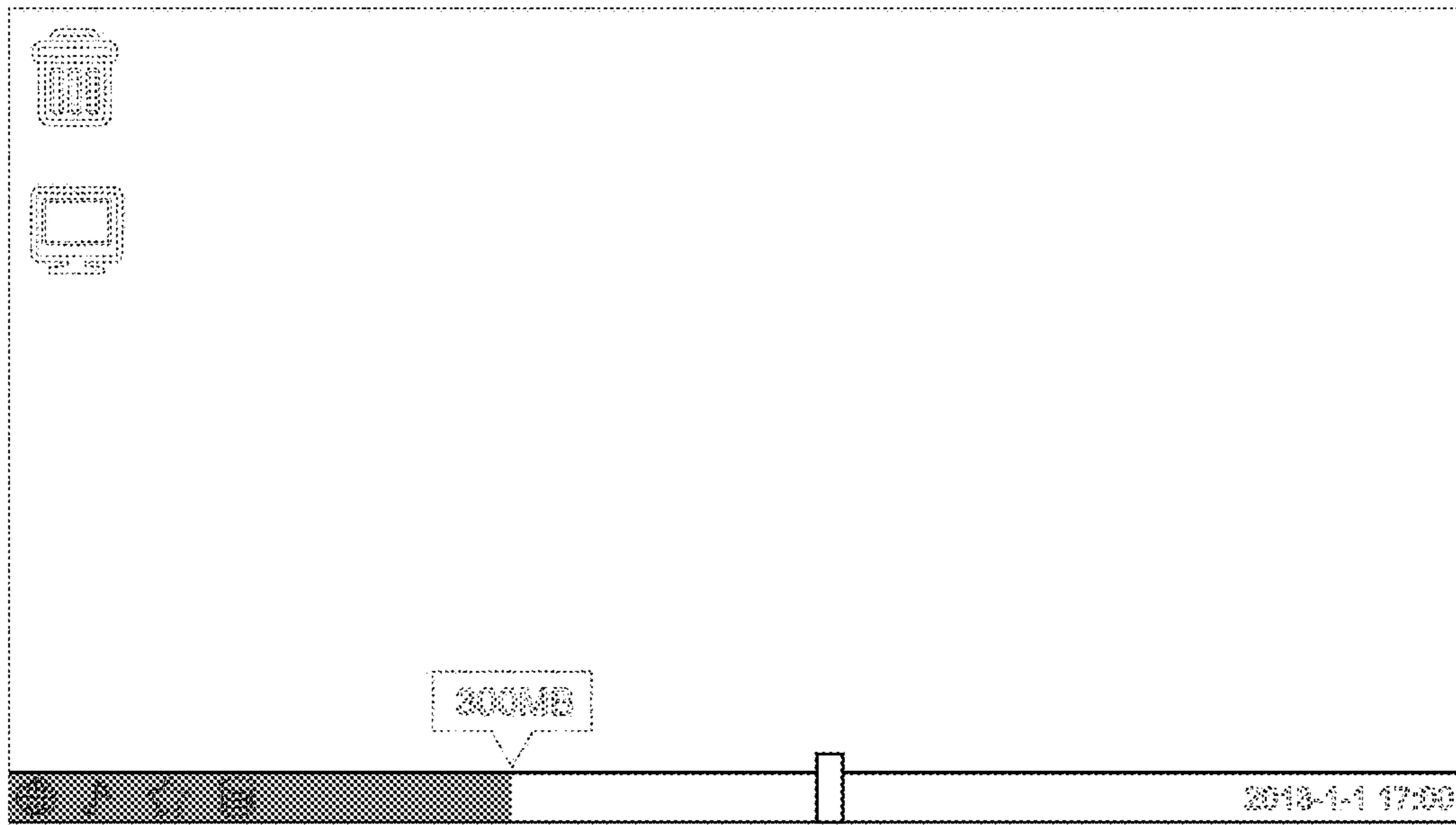

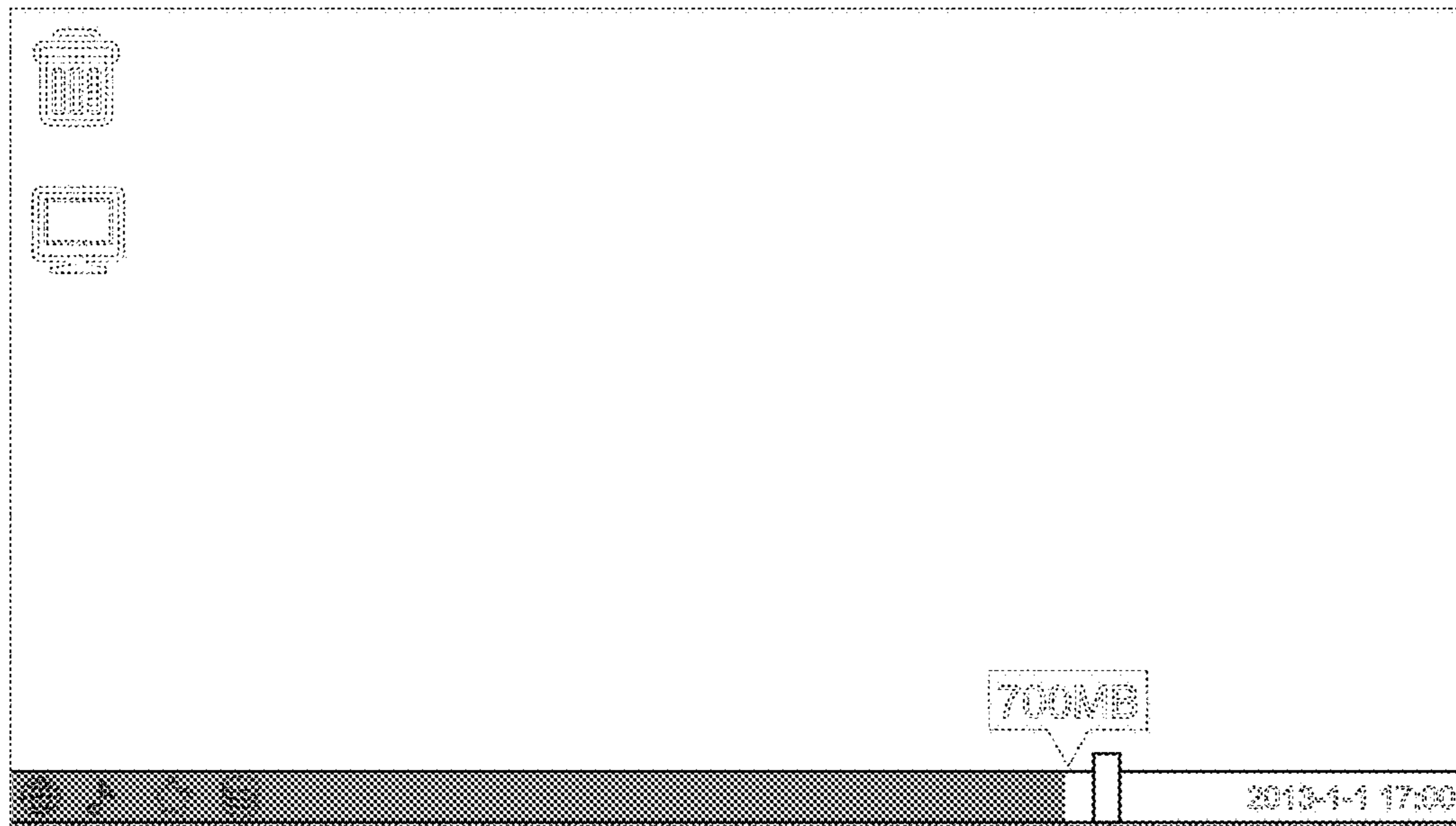

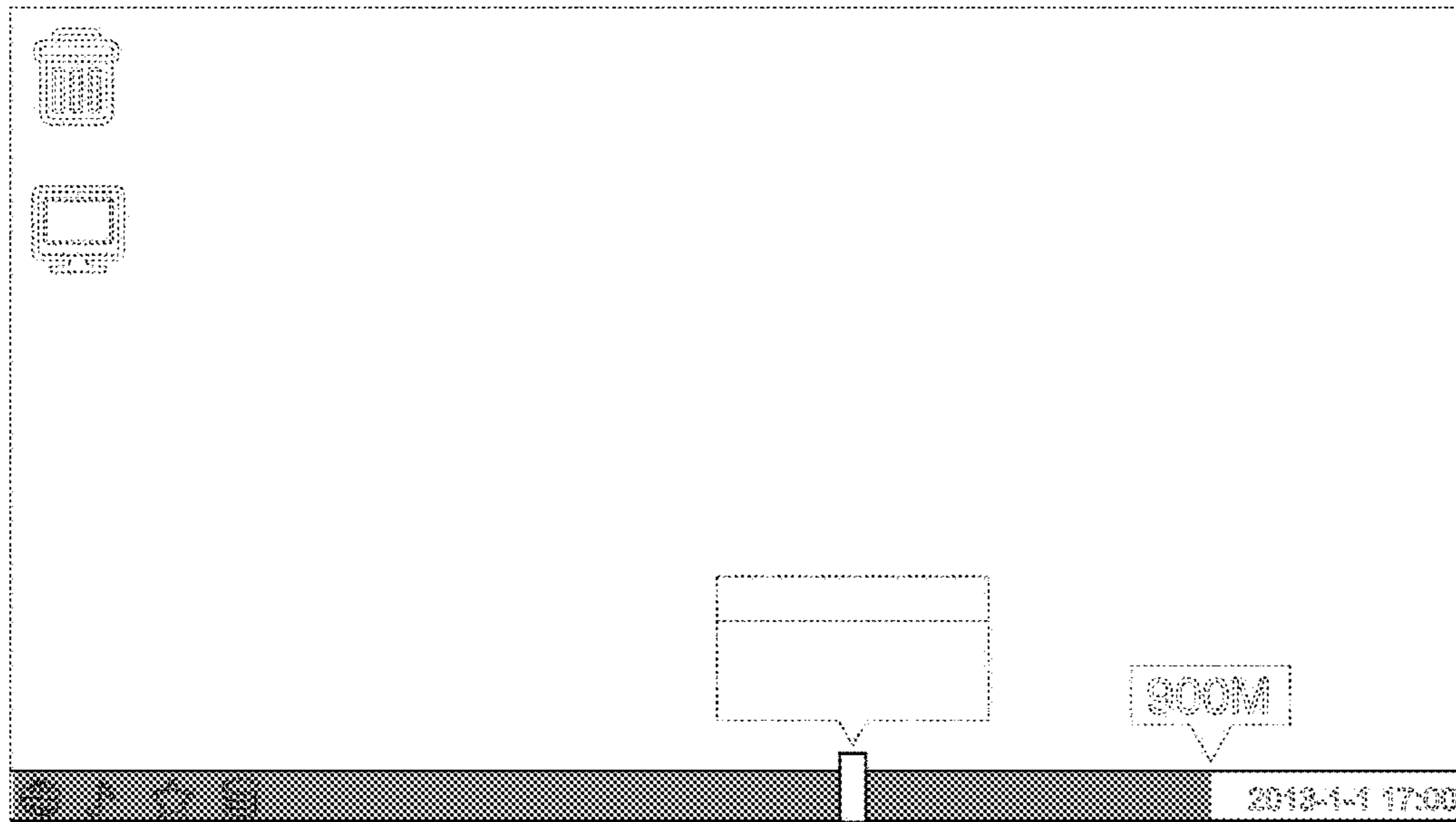

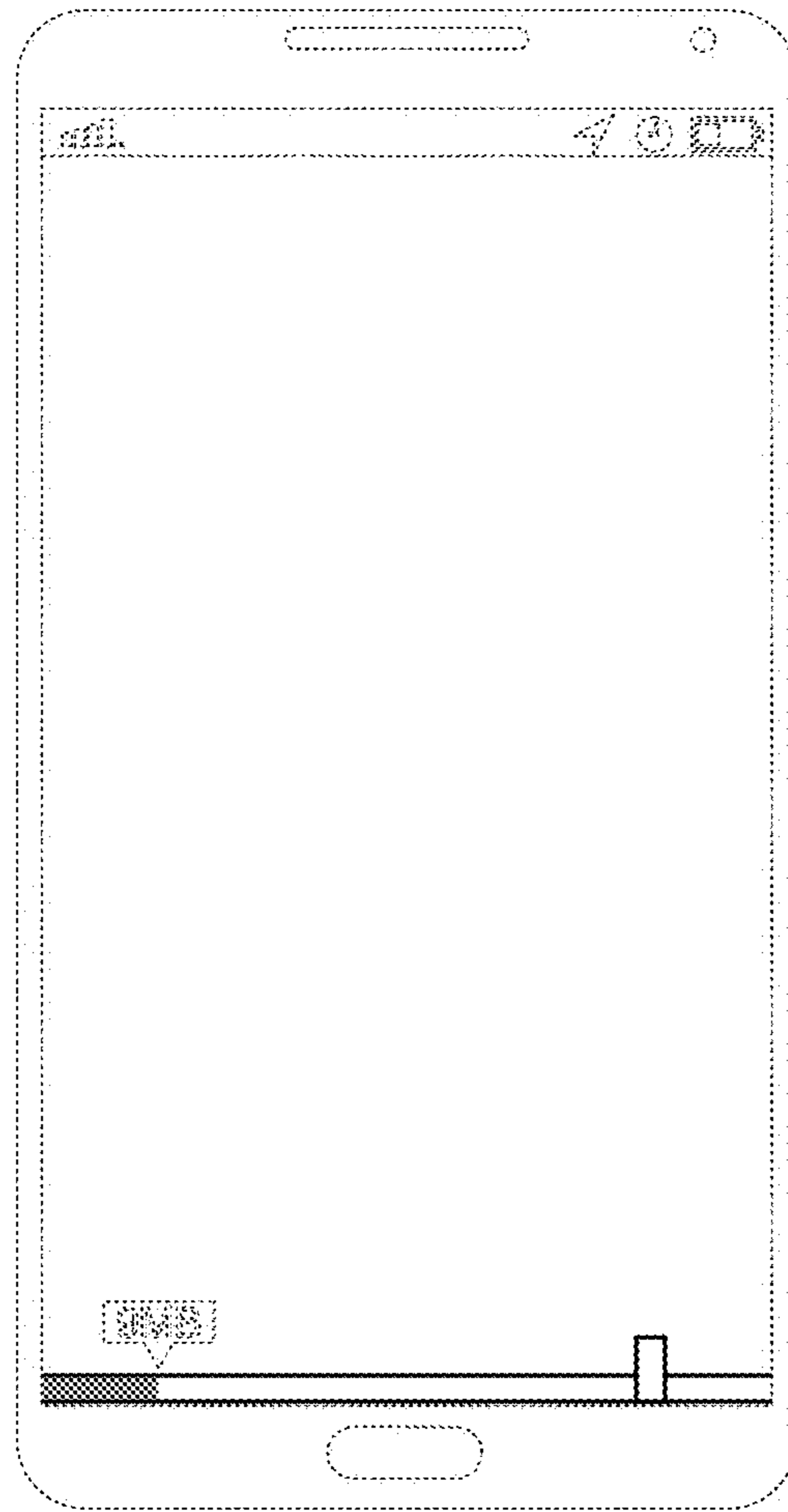
