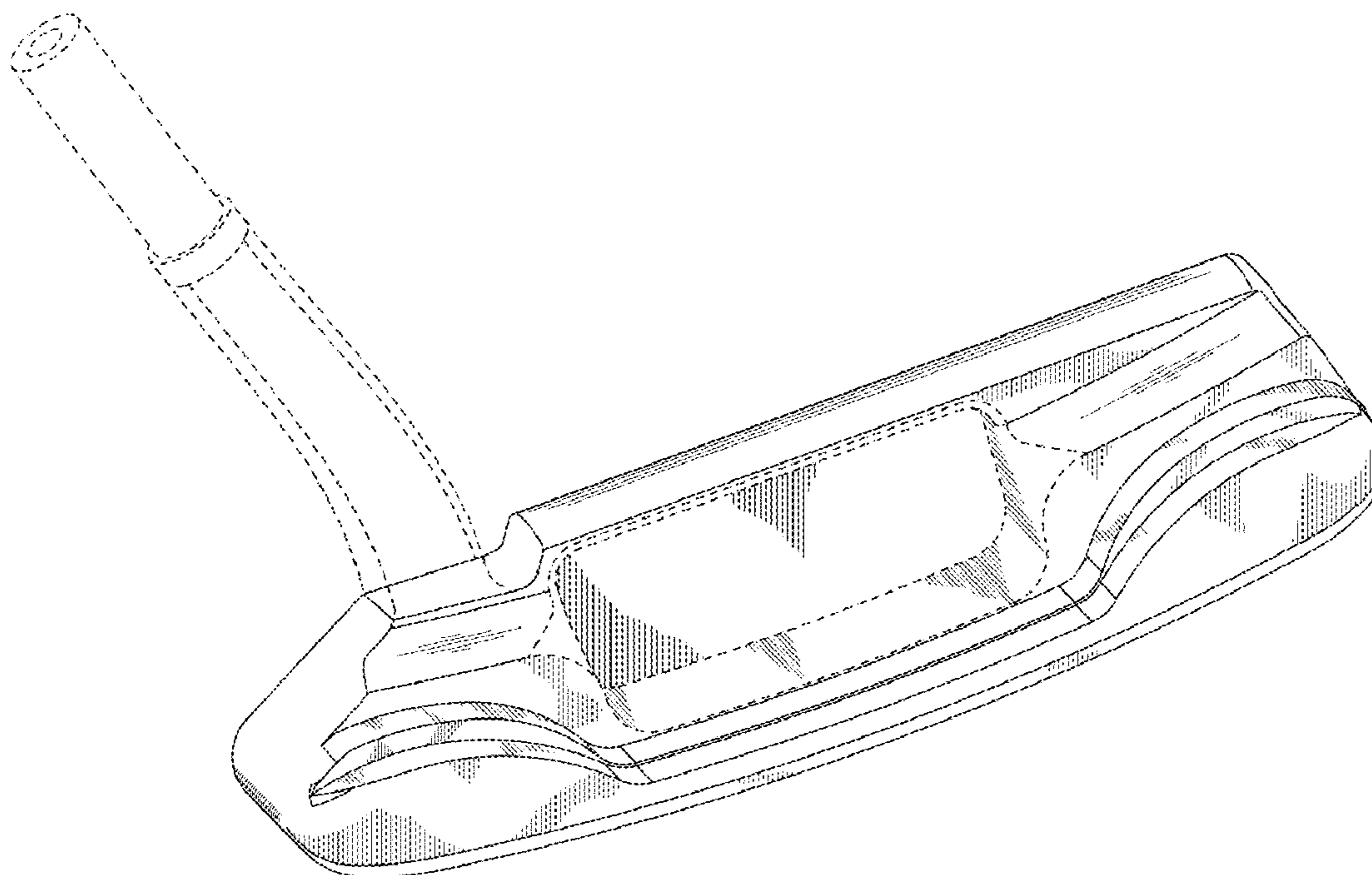
(57) **CLAIM**

The ornamental design for a putter type golf club, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a putter type golf club according to the present design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a front elevational view thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a toe side elevational view thereof; and,  
FIG. 7 is a heel side elevational view thereof.

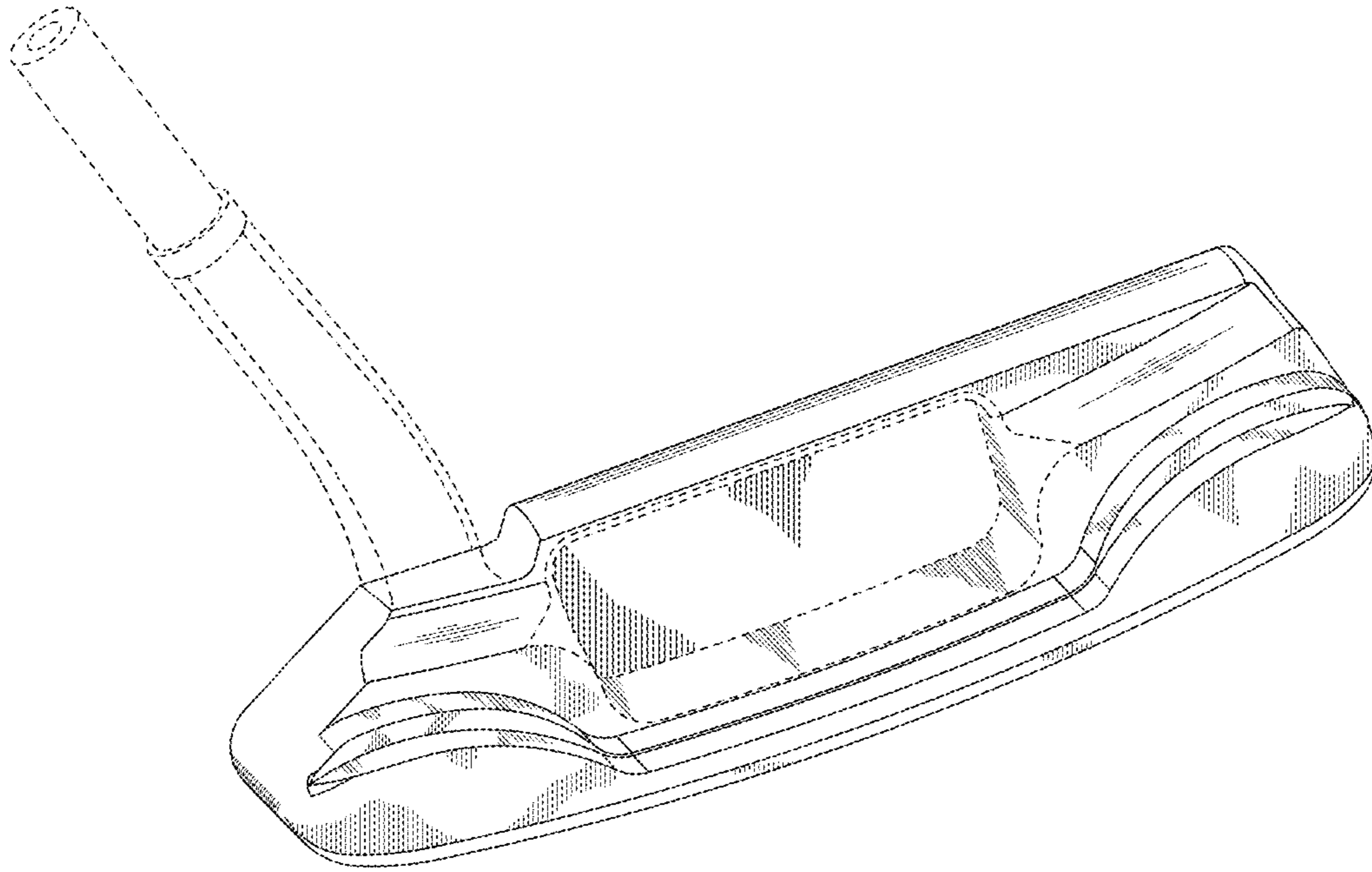

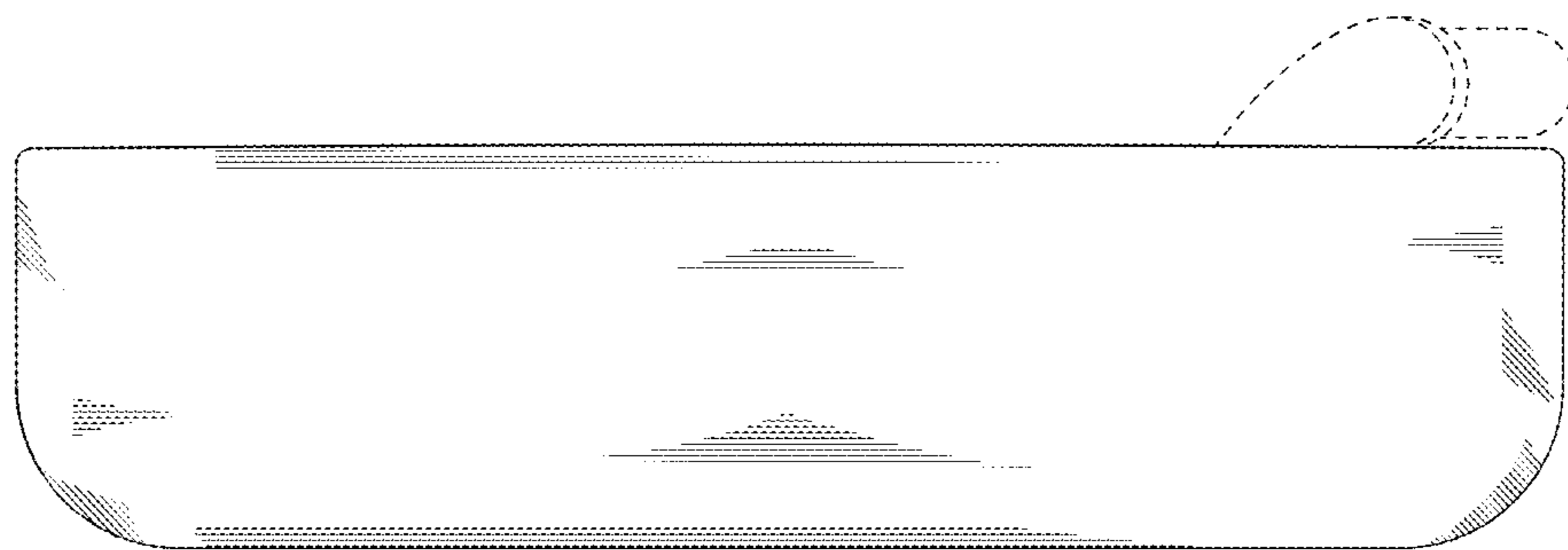

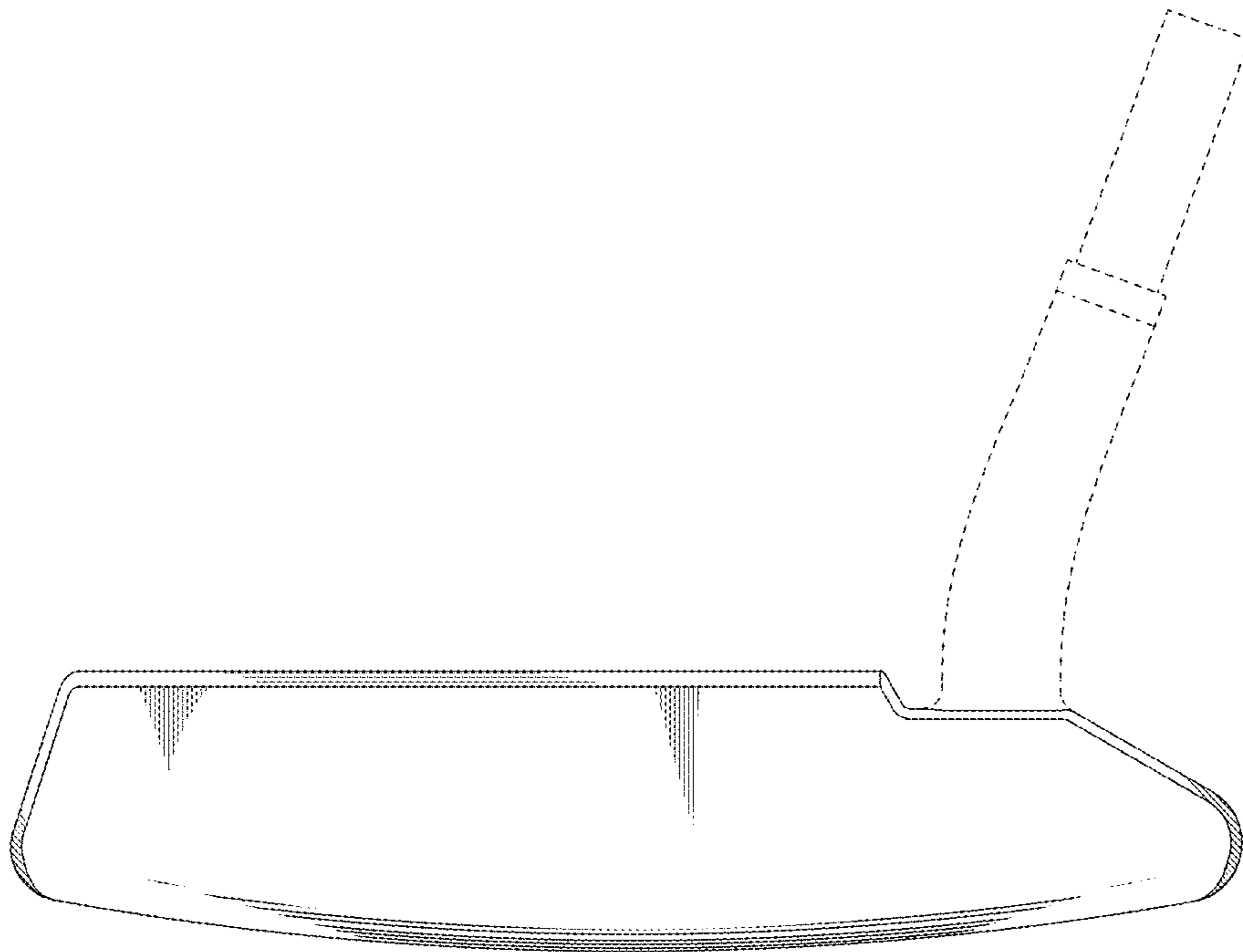

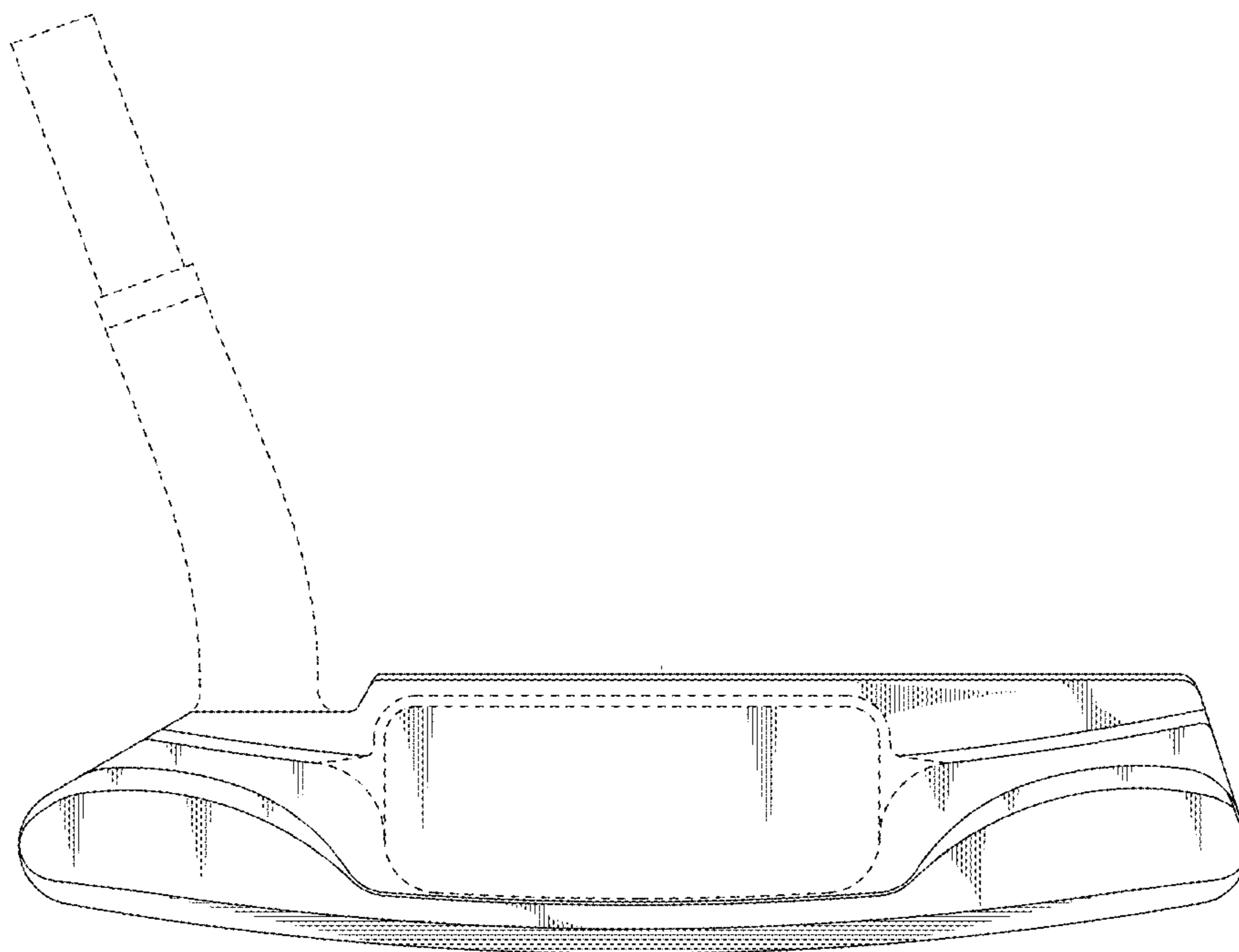

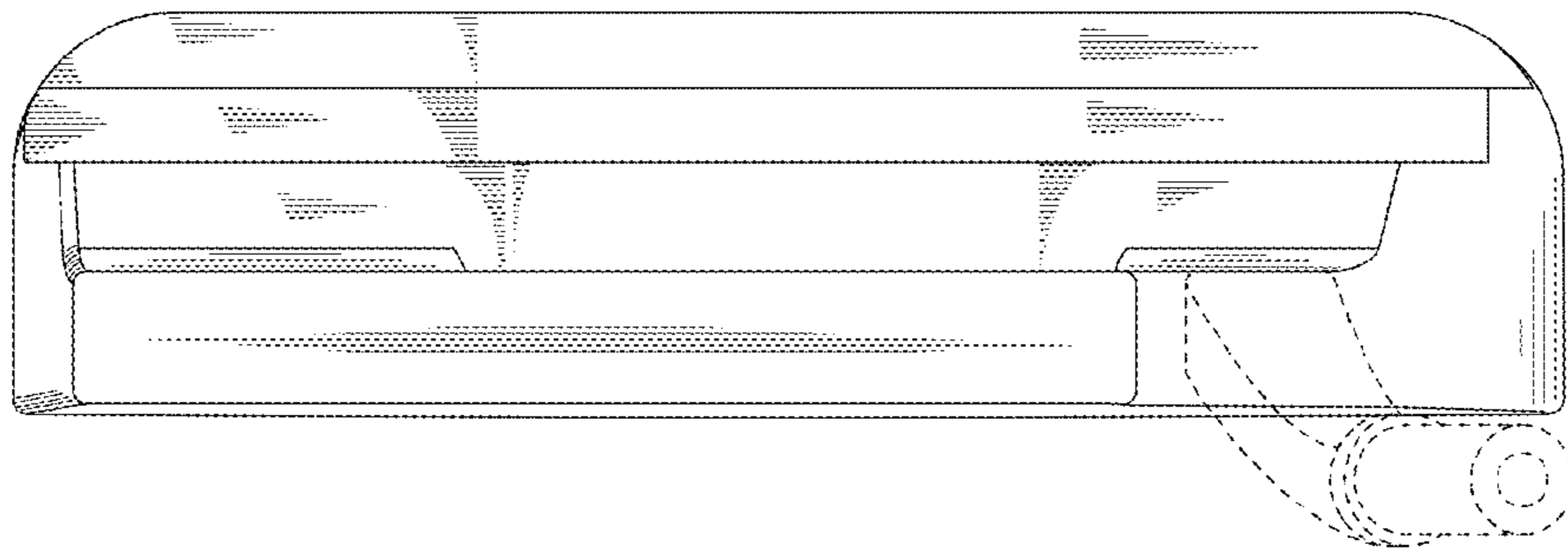

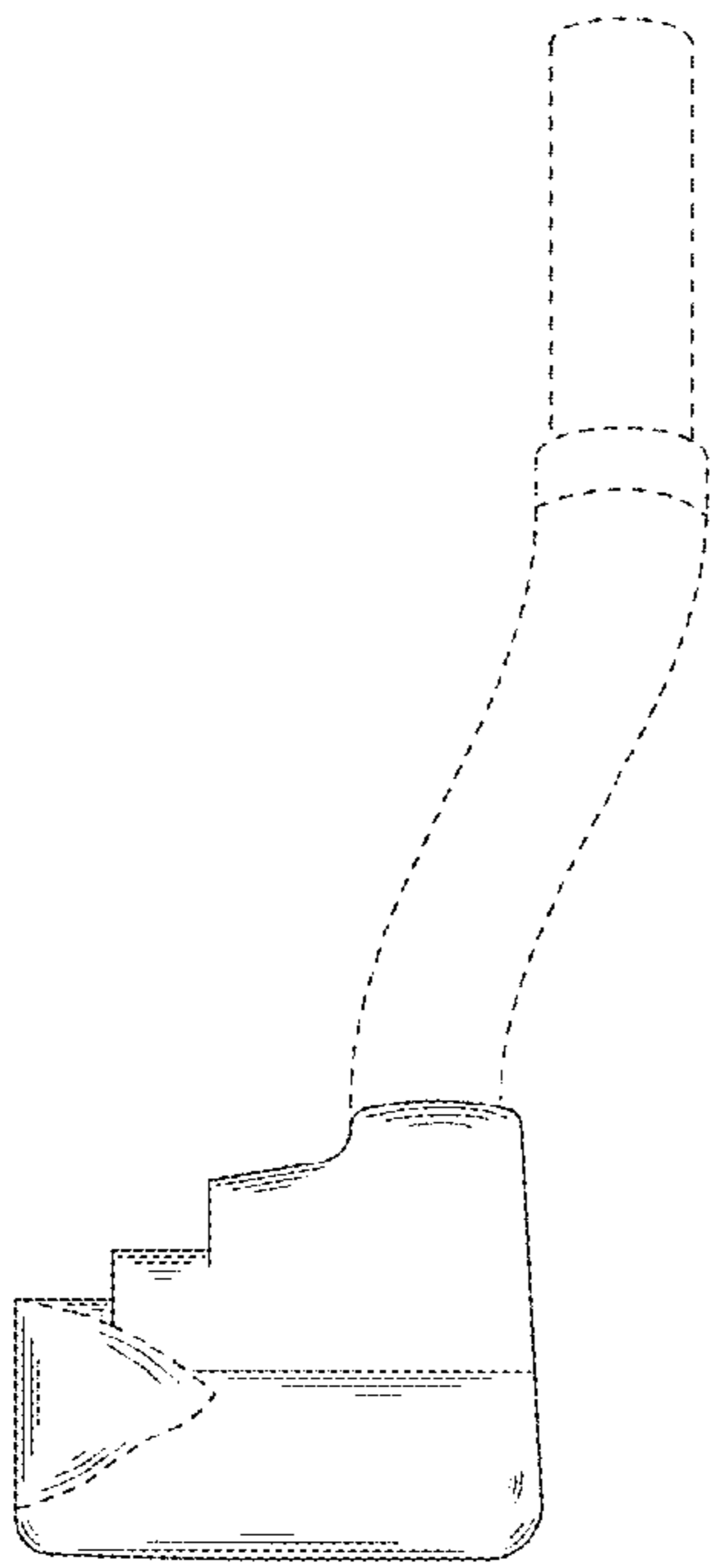

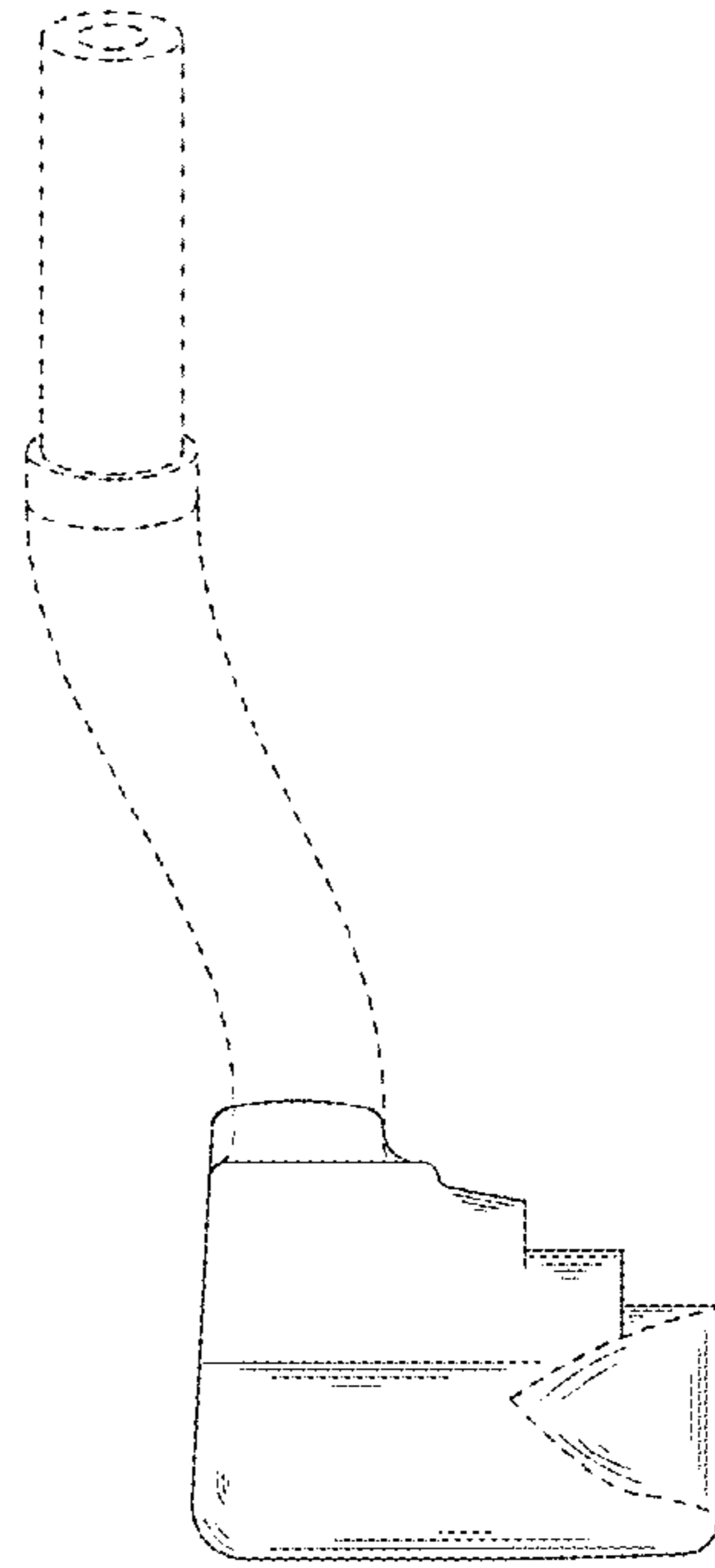
