DESCRIPTION

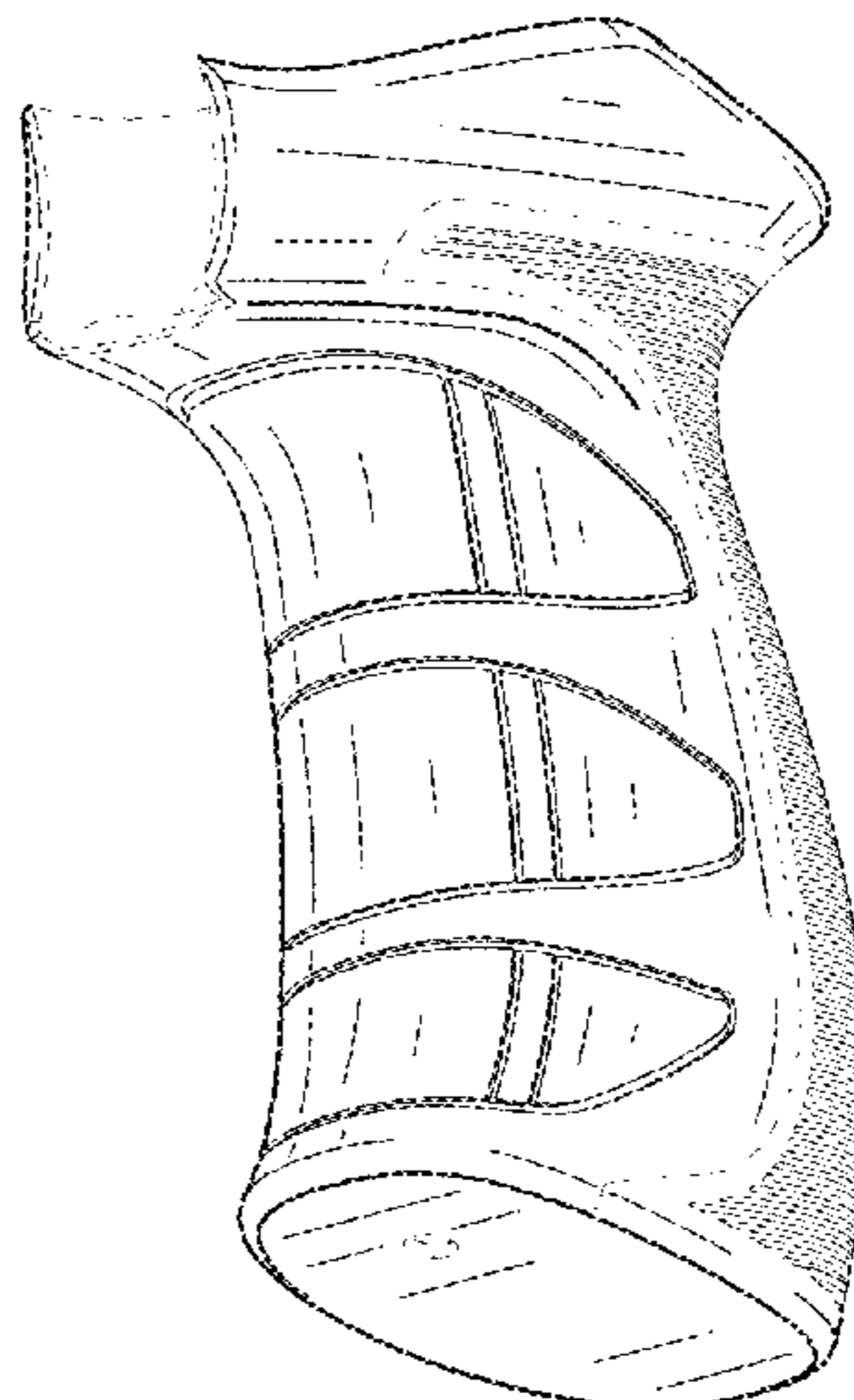
FIG. 1 is a front isometric view of a pistol grip incorporating my new design;

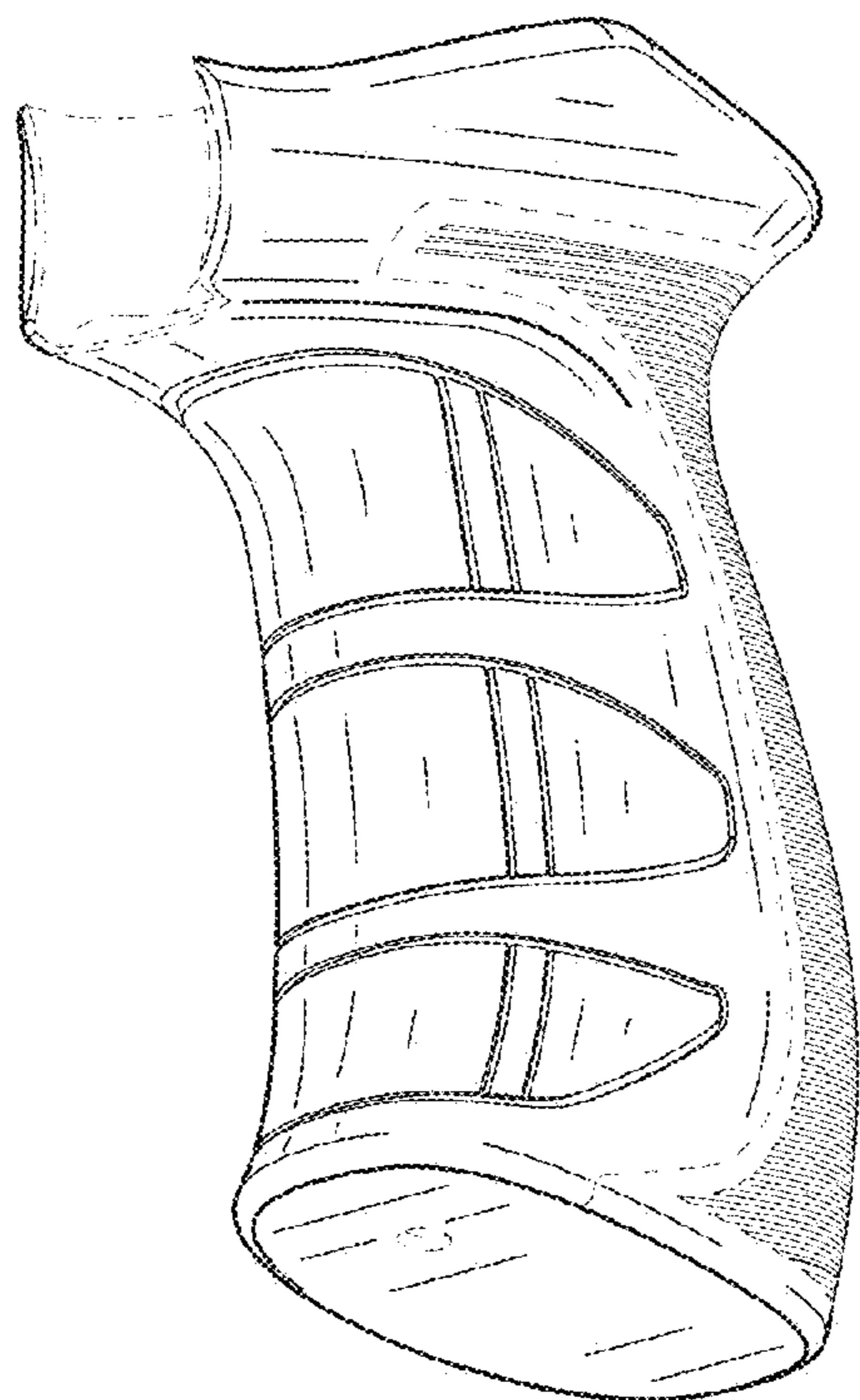

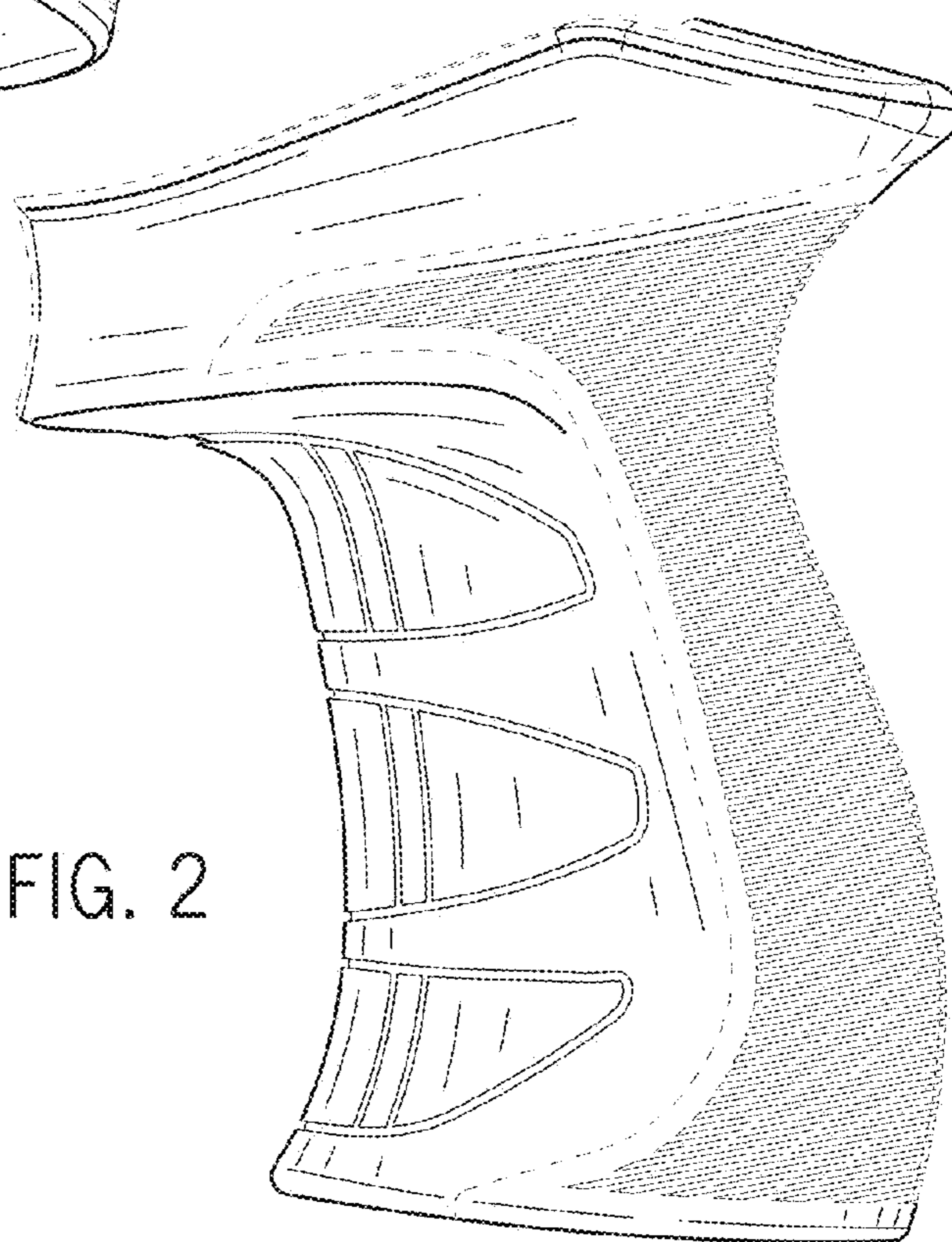

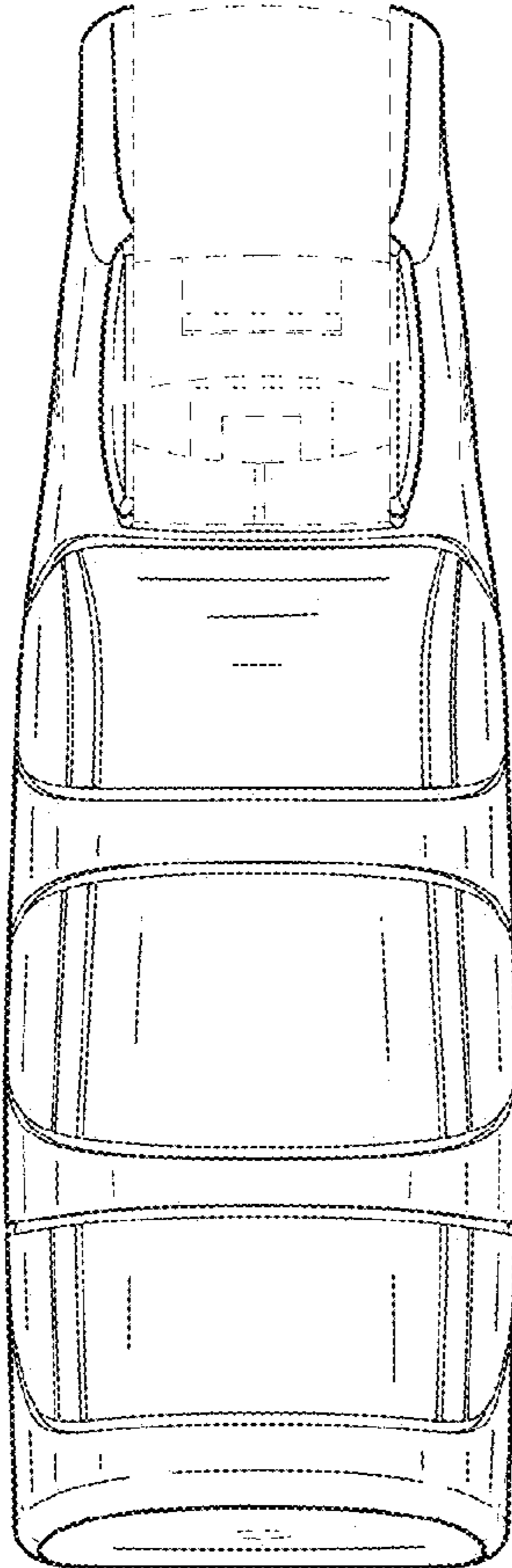

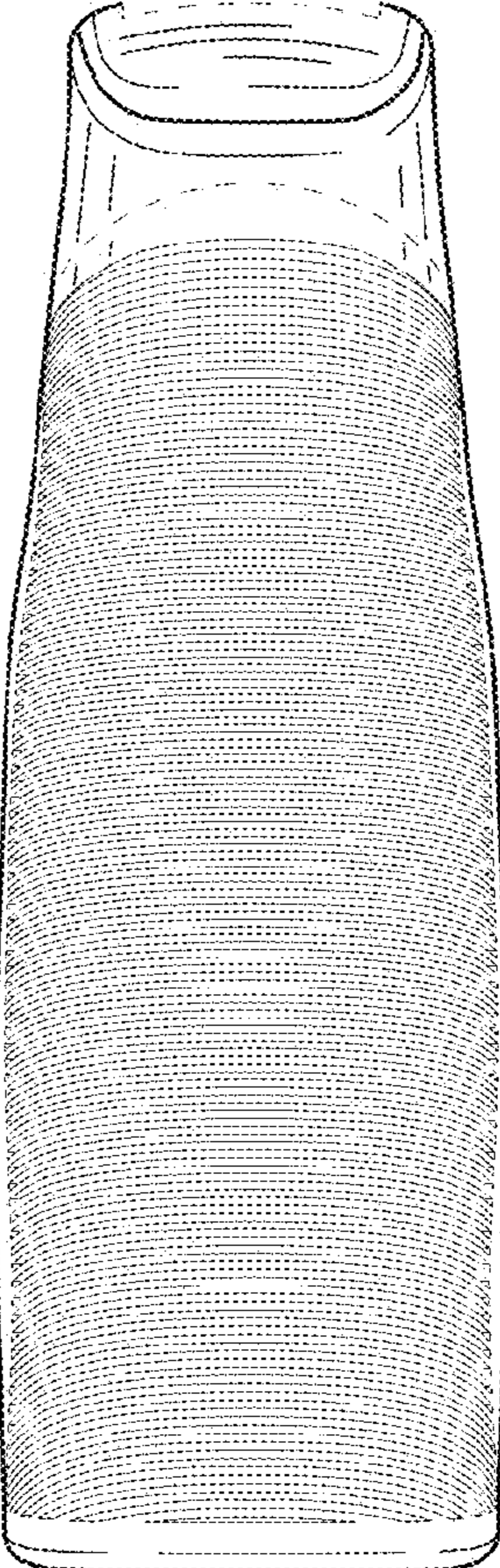

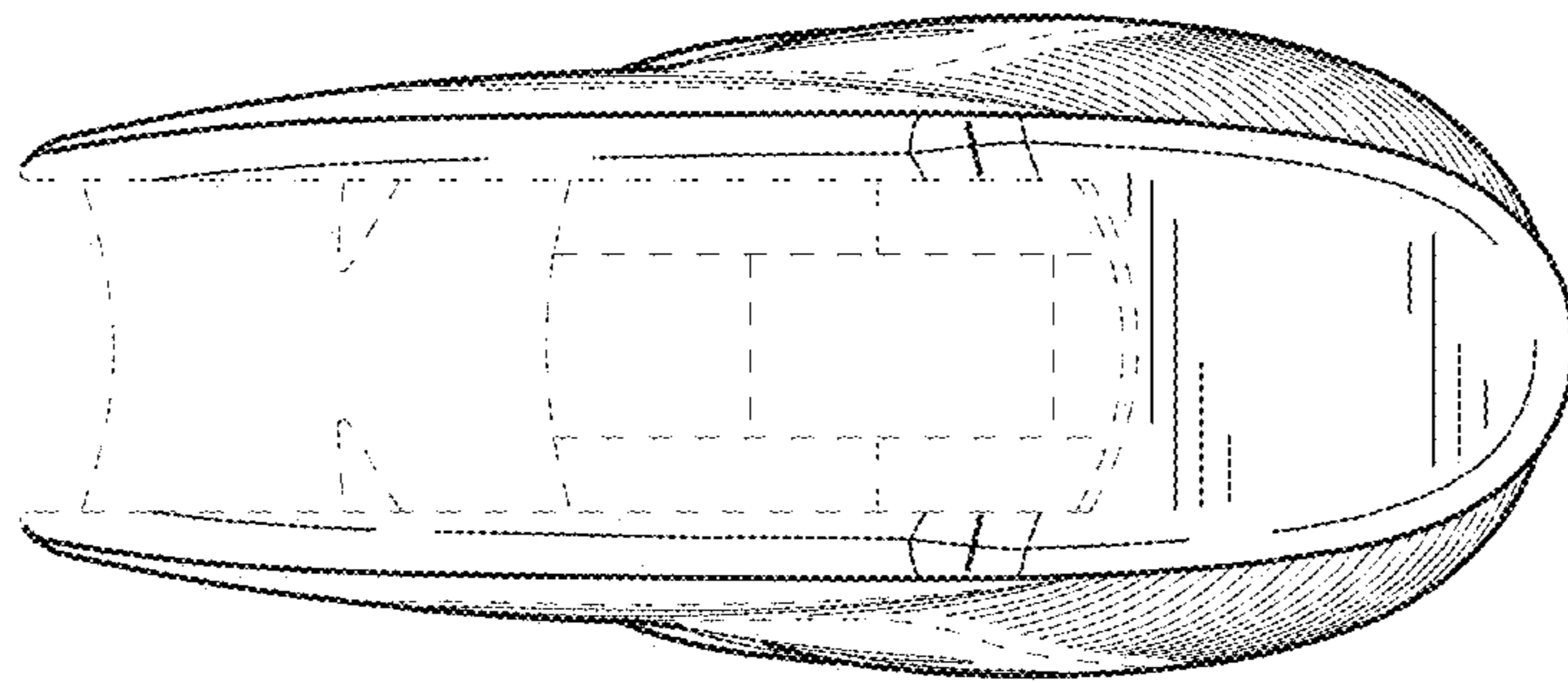

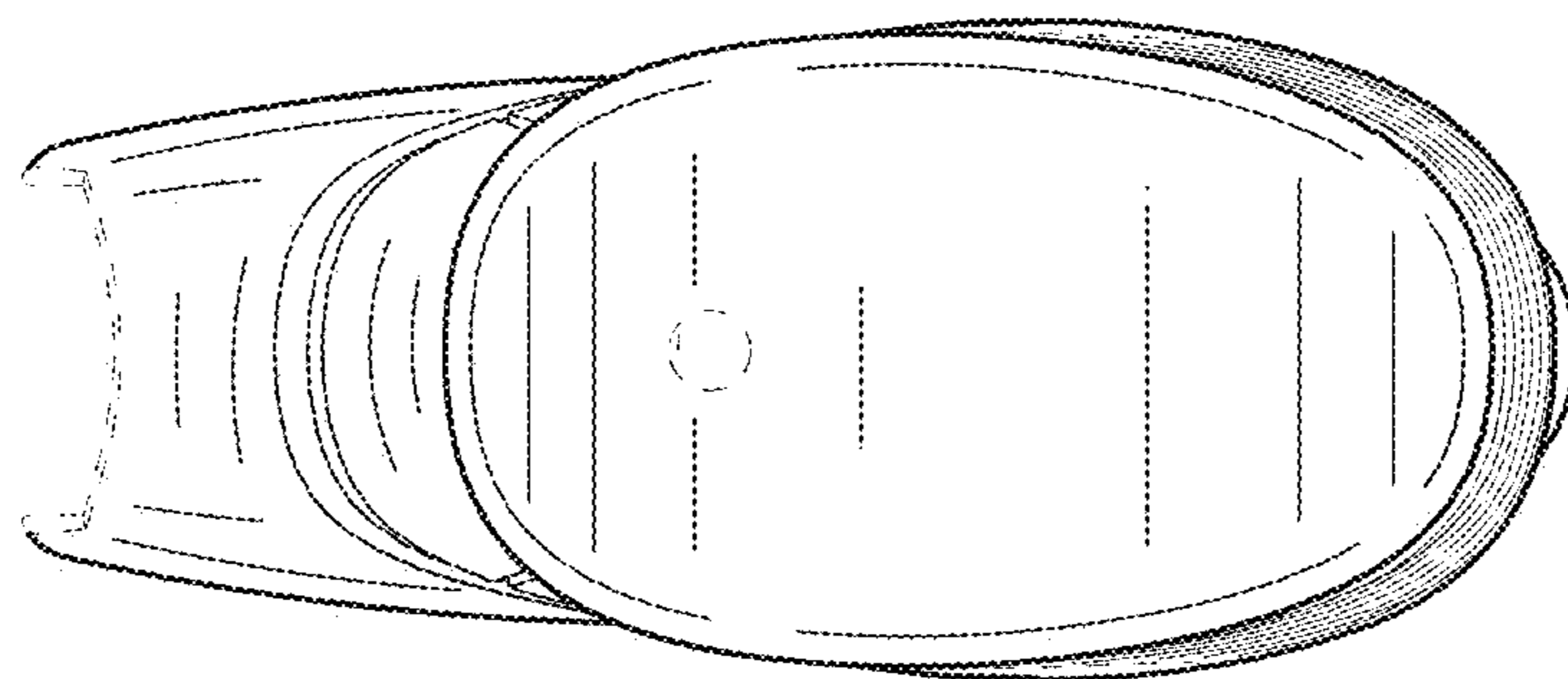
