(57) **CLAIM**

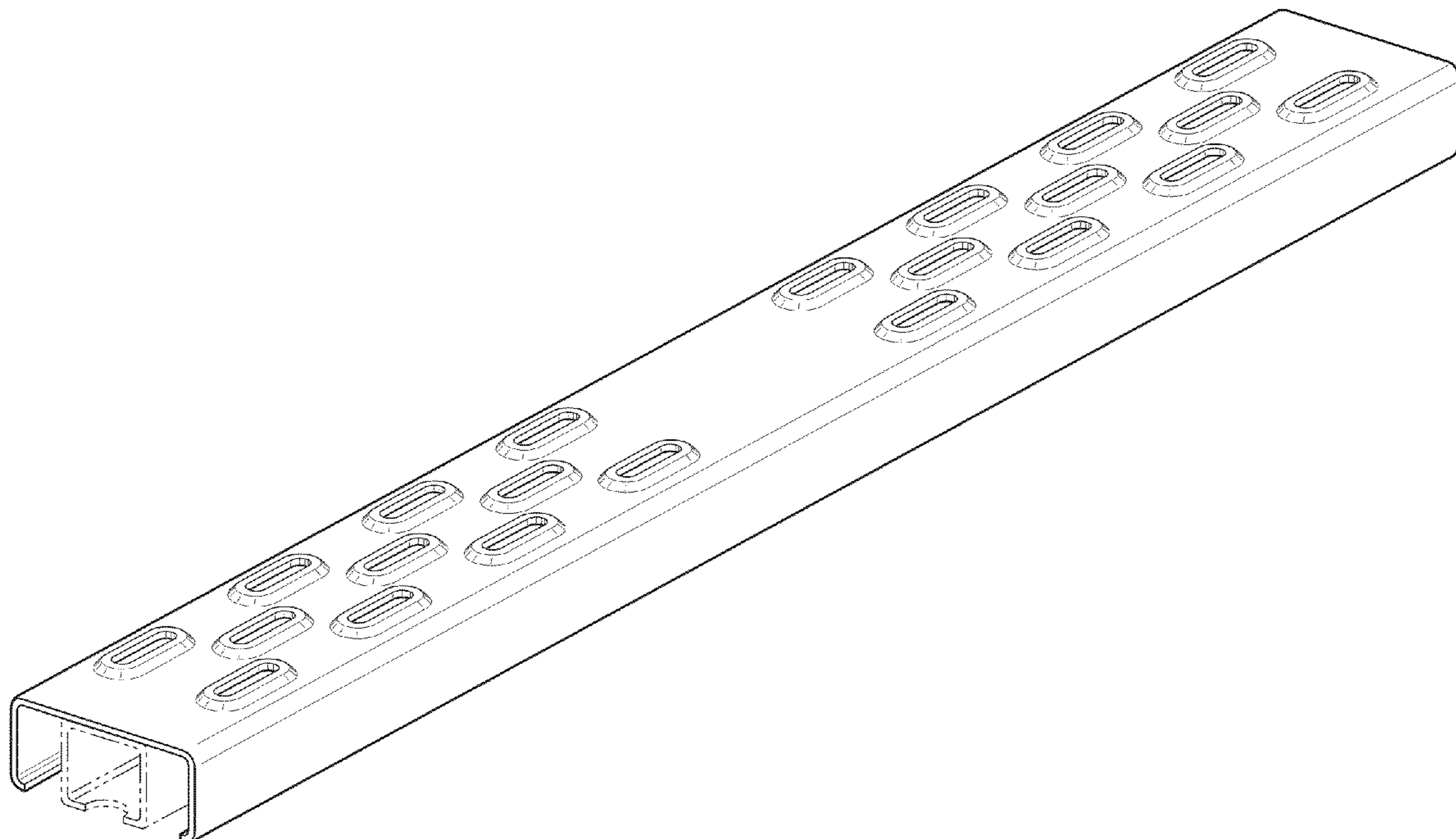
We claim the ornamental design for a ladder rung, as shown herein.

**DESCRIPTION**

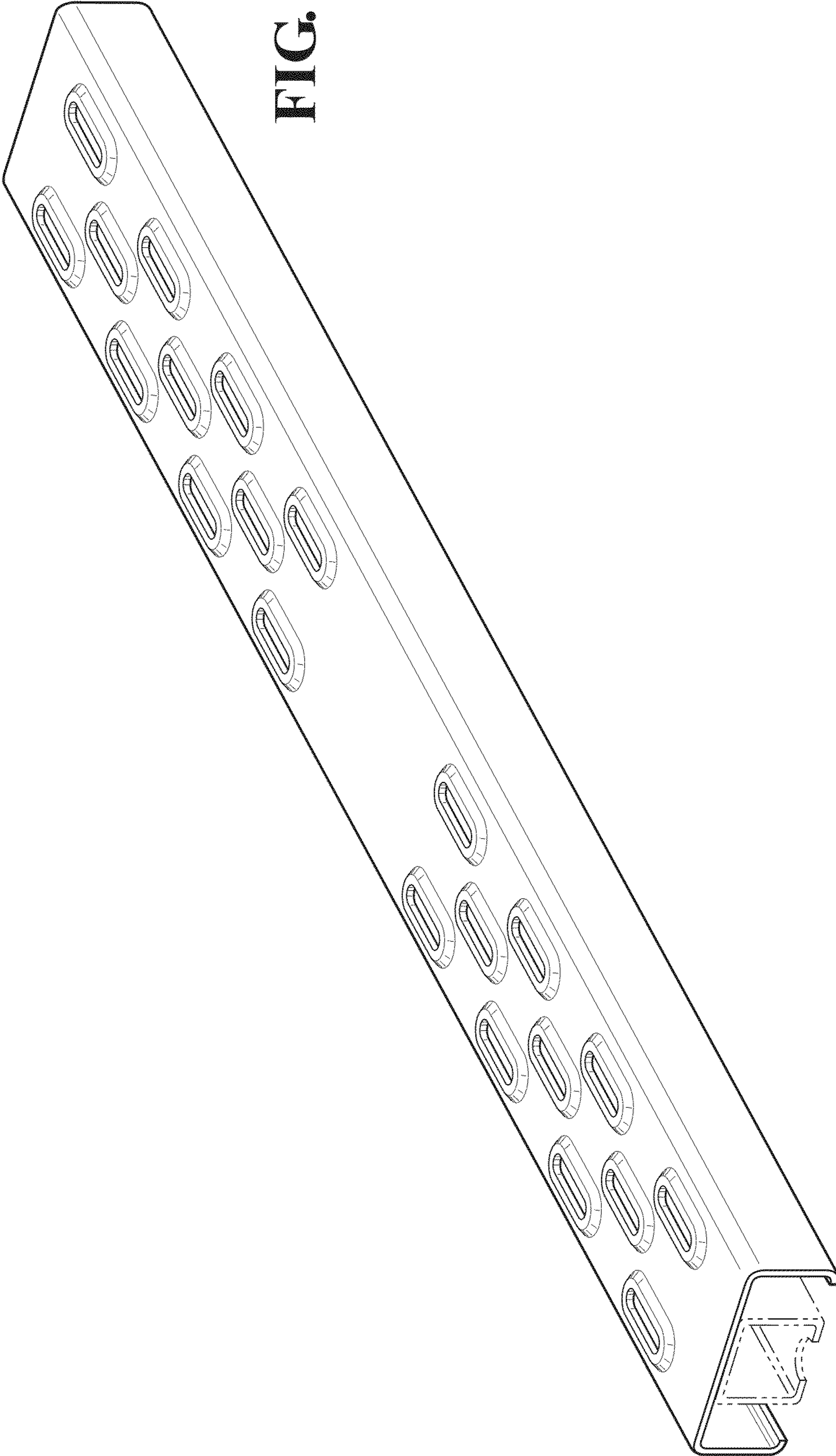
FIG. 1 is a perspective view of a ladder rung with a square tube shown in broken lines;  
 FIG. 2 is a top view of the ladder rung of FIG. 1;  
 FIG. 3 is a front view of the ladder rung of FIG. 1;  
 FIG. 4 is a bottom view of the ladder rung of FIG. 1;  
 FIG. 5 is a left side view of the ladder rung of FIG. 1;  
 FIG. 6 is a rear view of the ladder rung of FIG. 1;  
 FIG. 7 is a right side view of the ladder rung of FIG. 1;  
 FIG. 8 is a perspective view of the ladder rung in a ladder assembly for a hunting tree stand with additional rungs of the ladder assembly, side rails of the ladder assembly, the hunting tree stand, and a tree shown in broken lines; and,  
 FIG. 9 is another perspective view of the ladder rung in the ladder assembly.

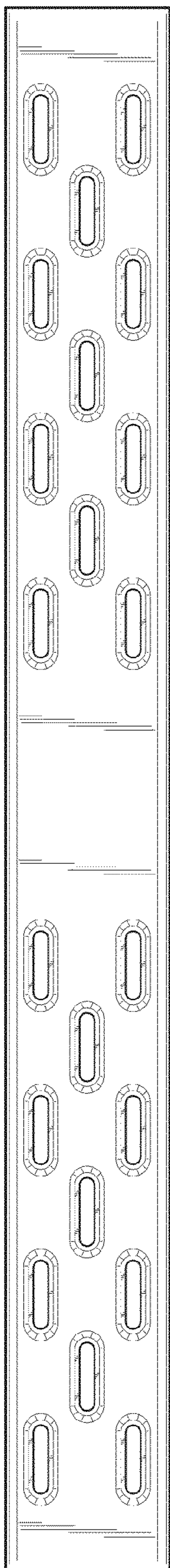

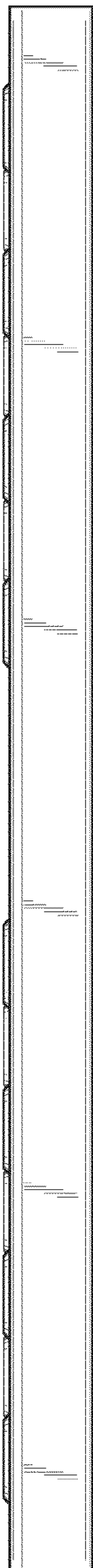

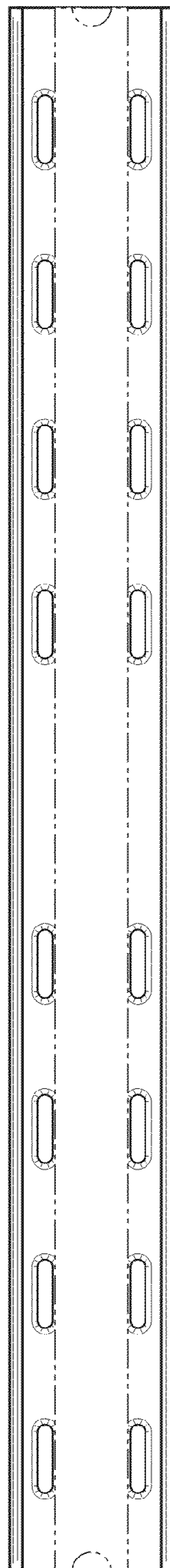

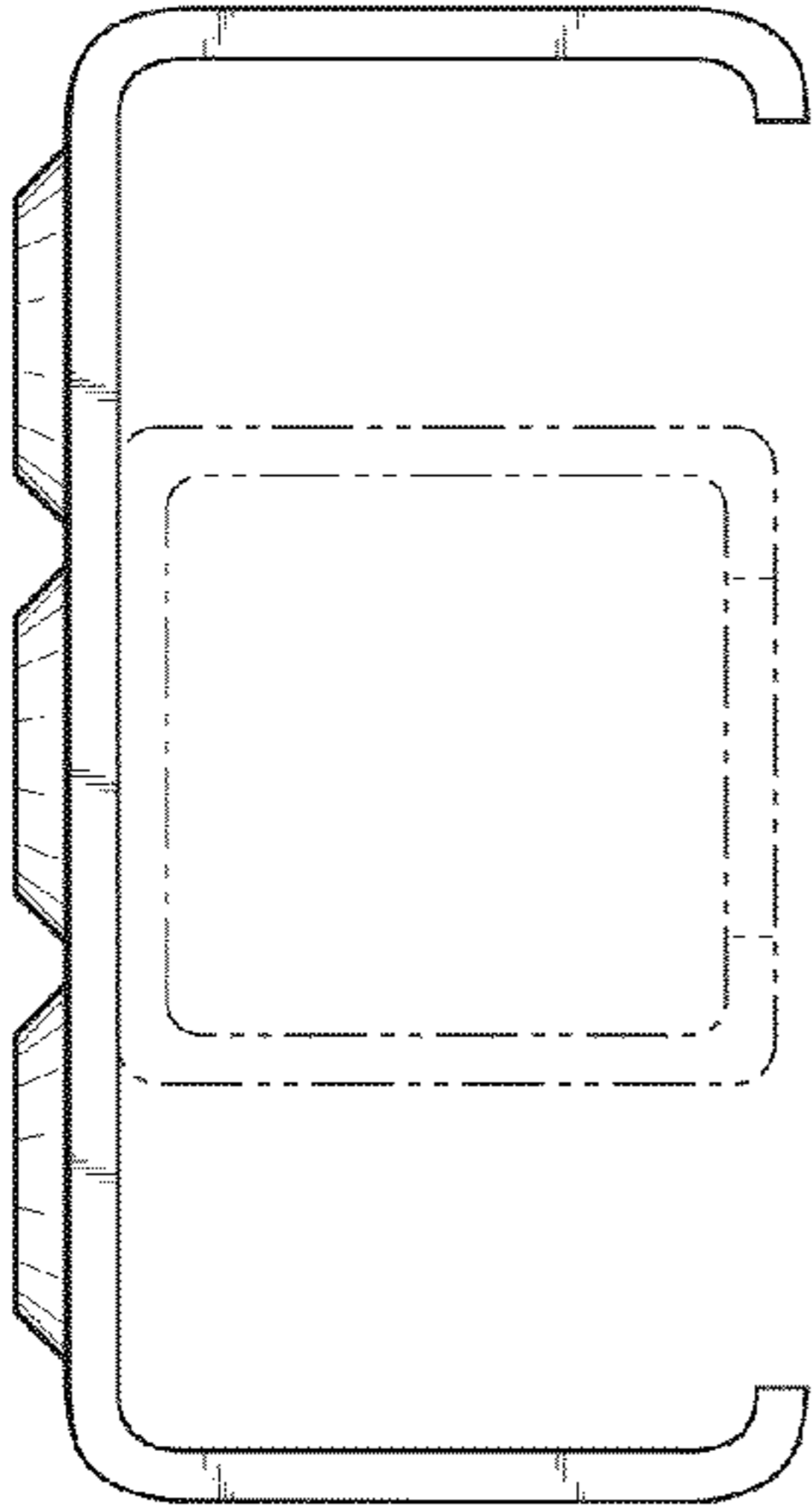

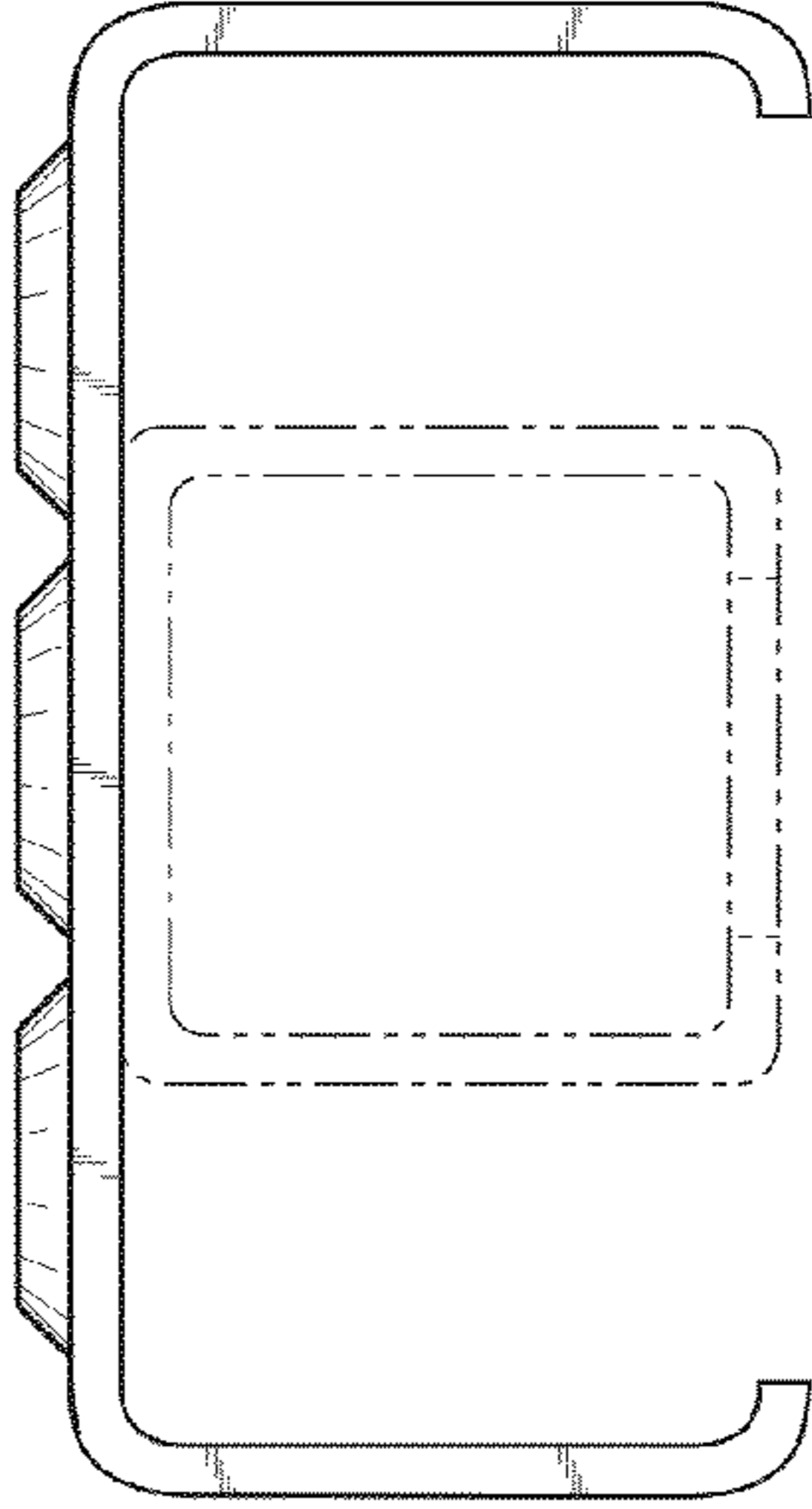
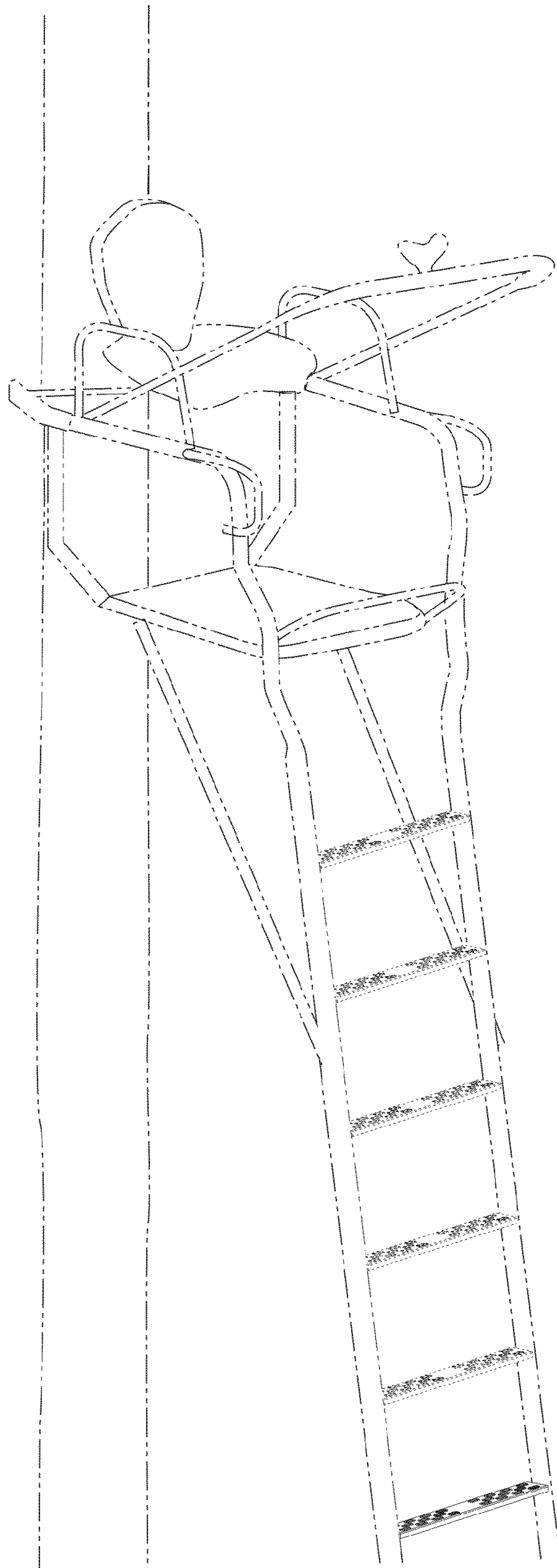

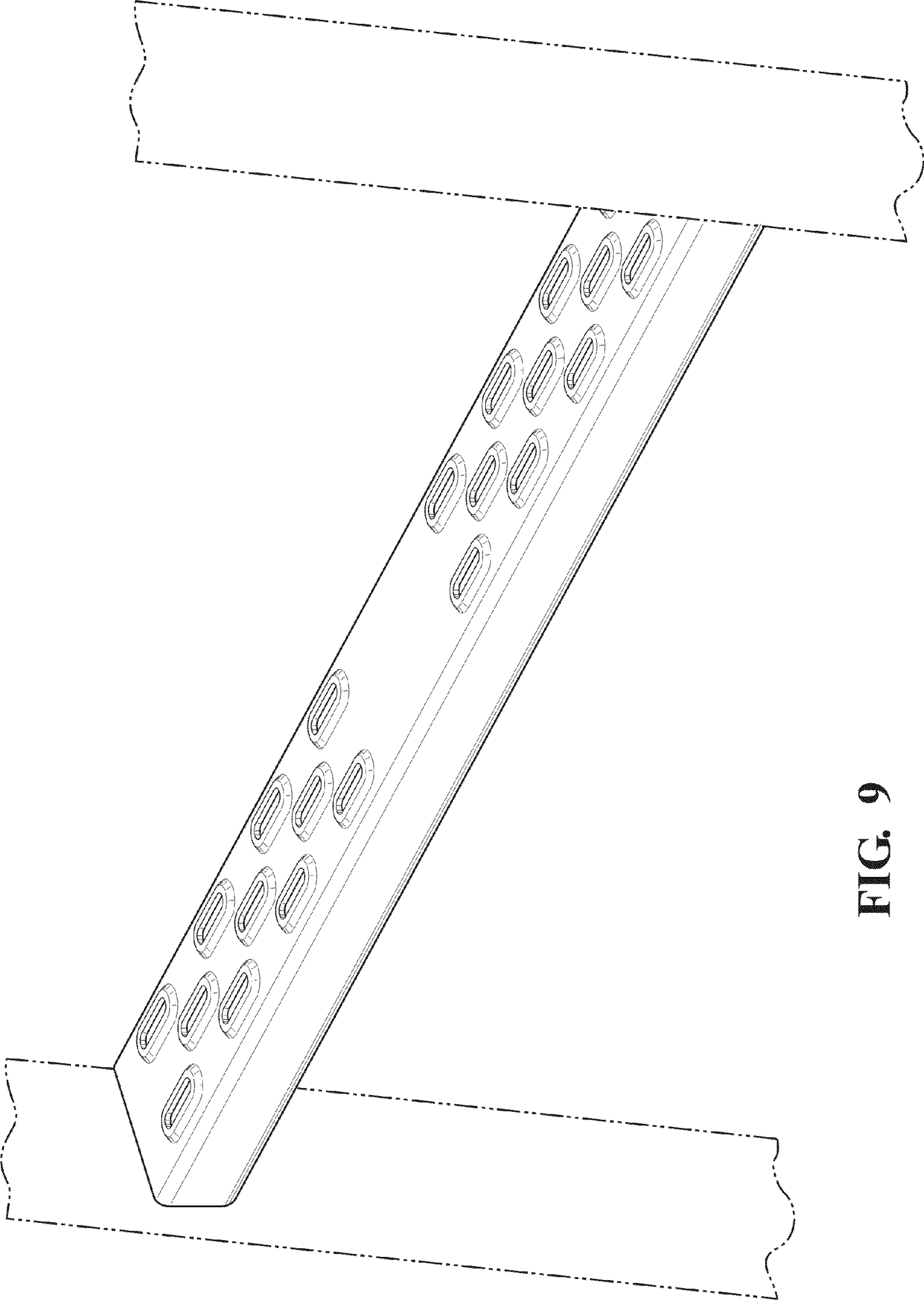
