(57) **CLAIM**

An ornamental design for a garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of one embodiment of a garment.

FIG. 3 is a back elevation view of the embodiment depicted in FIG. 1.

FIG. 4 is a right side elevation view of the embodiment depicted in FIG. 1.

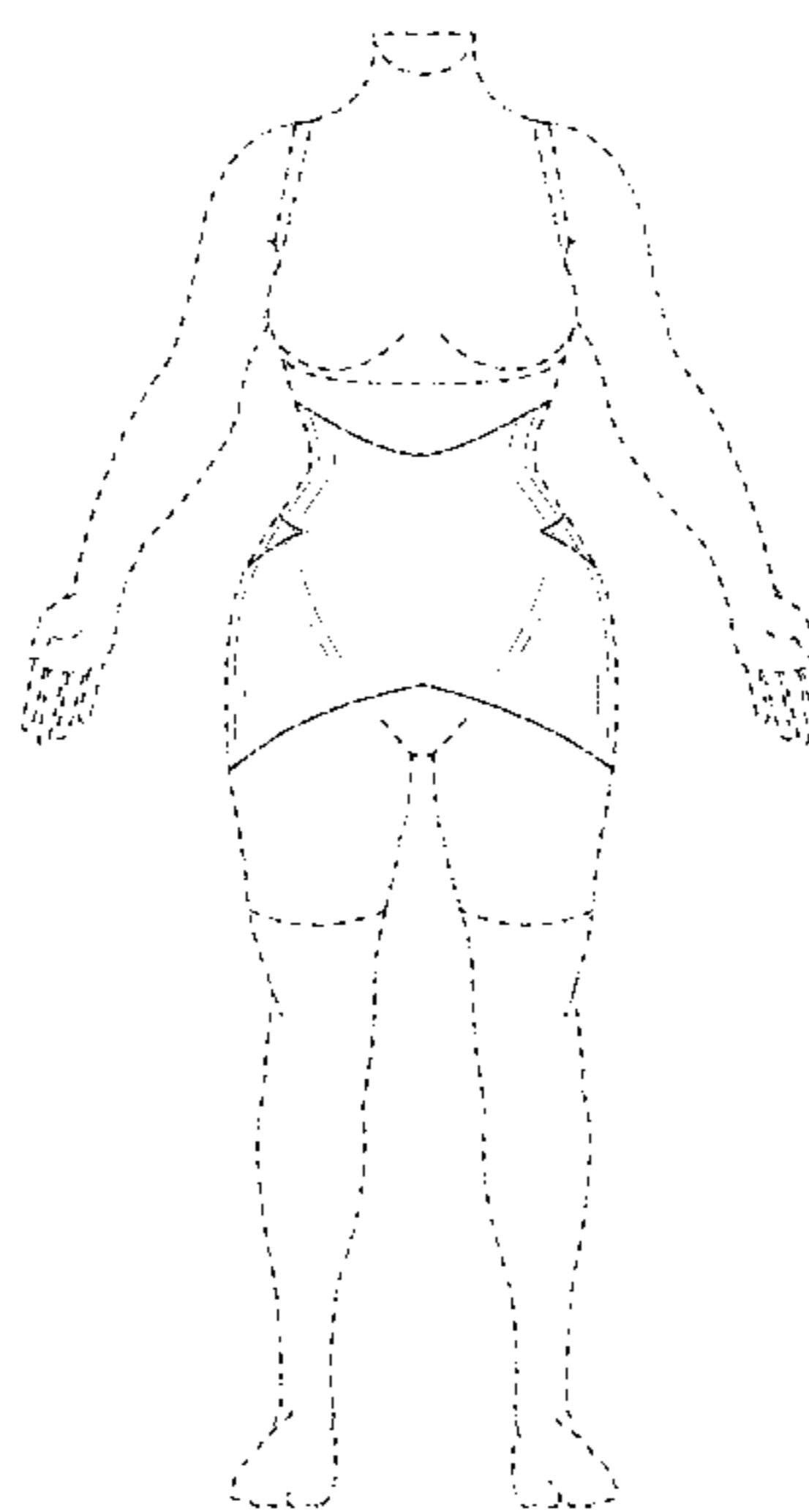
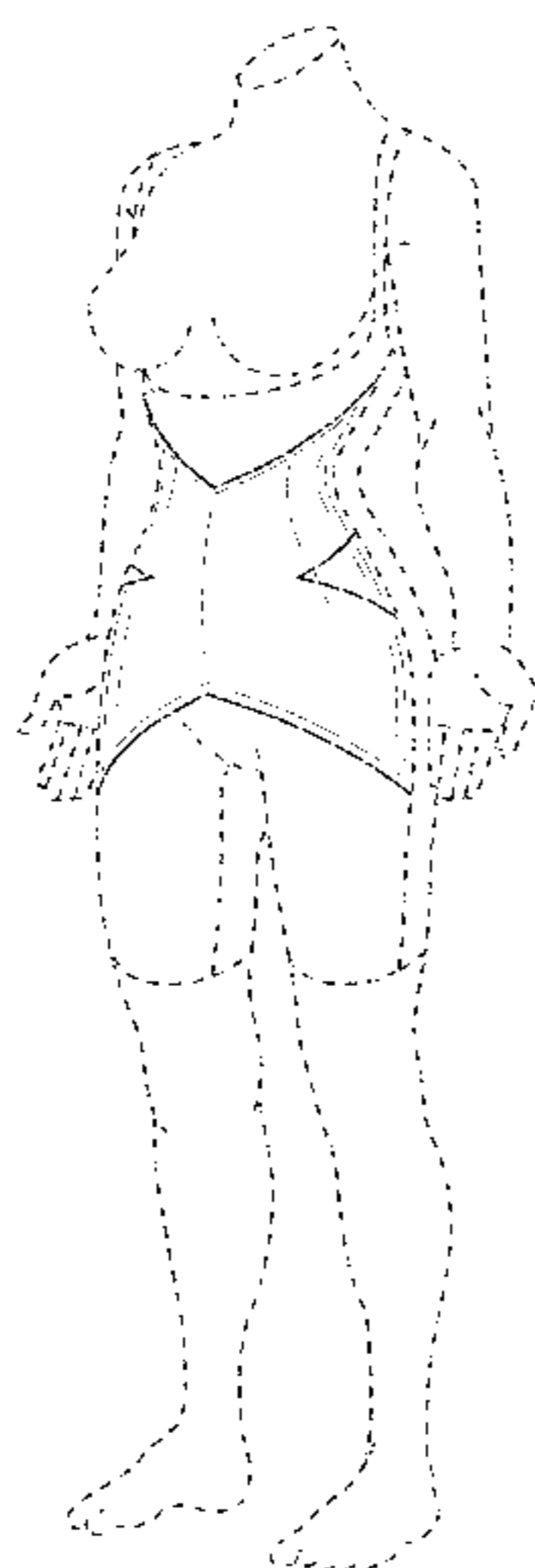
FIG. 5 is a left side elevation view of the embodiment depicted in FIG. 1.

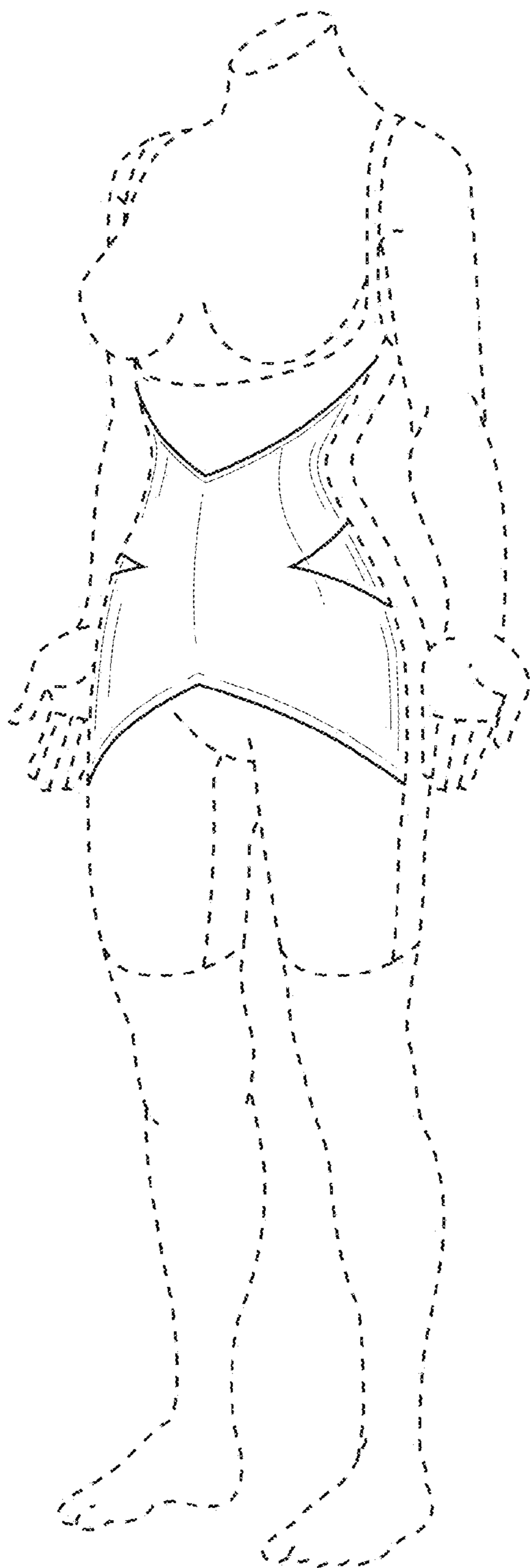

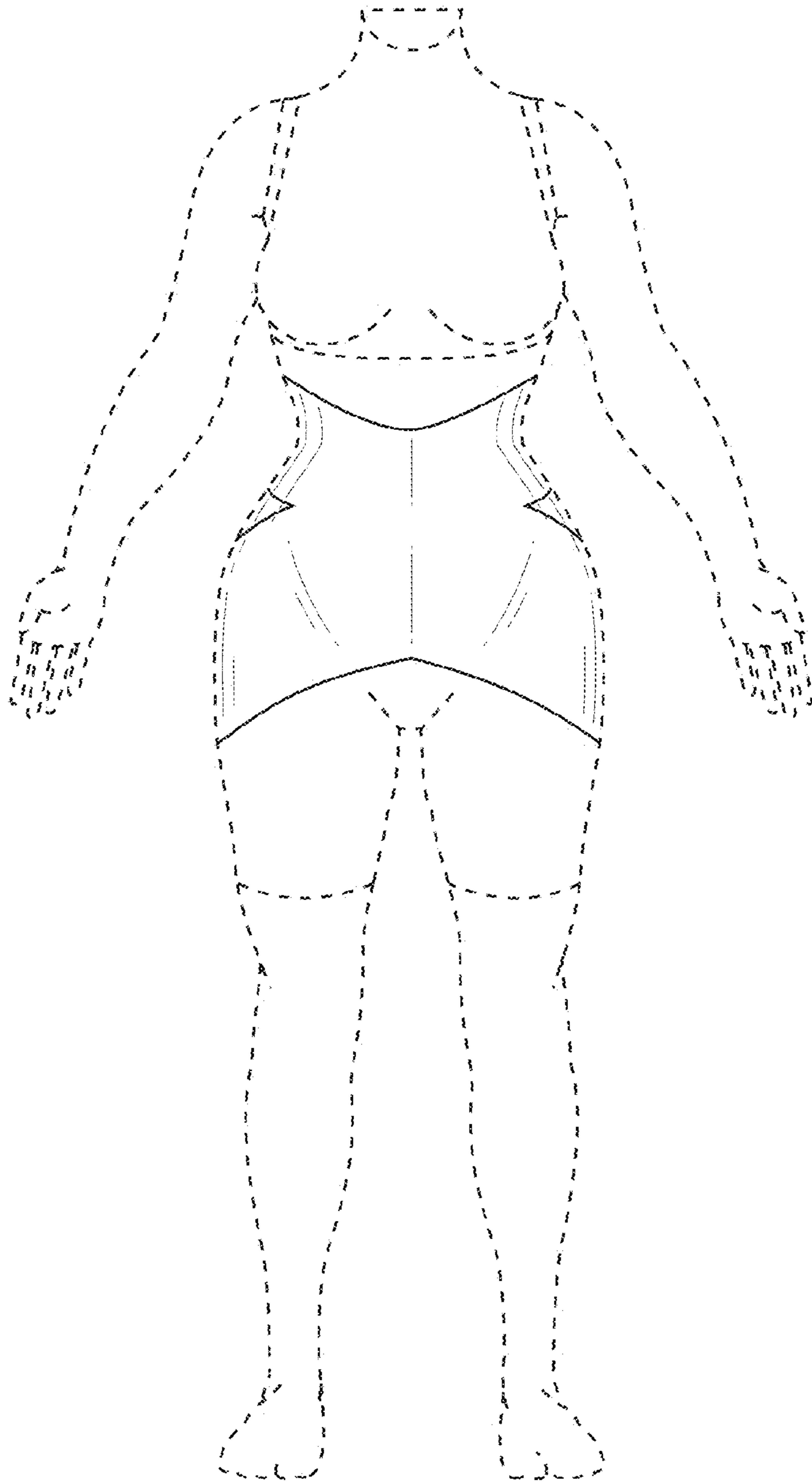

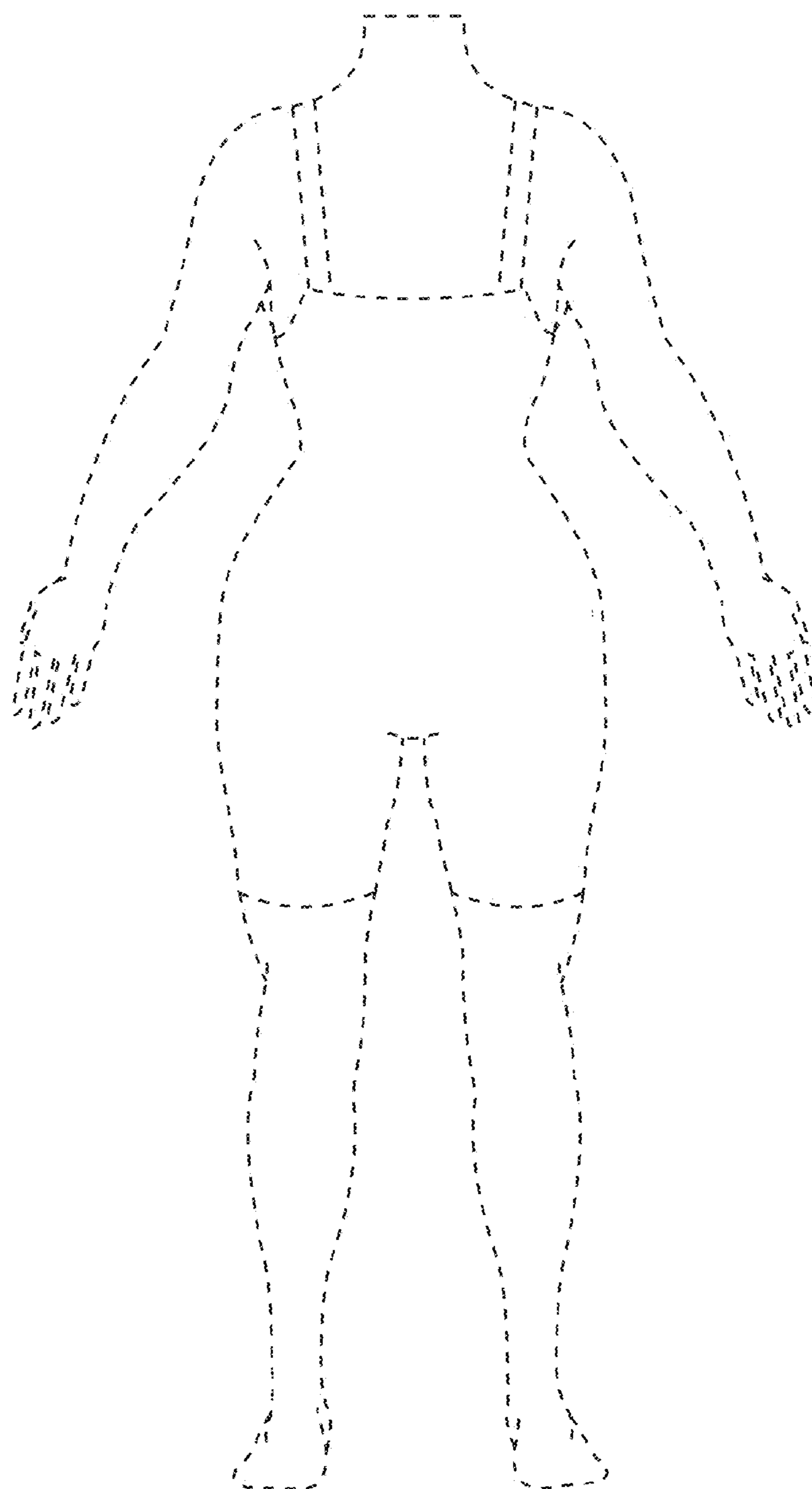

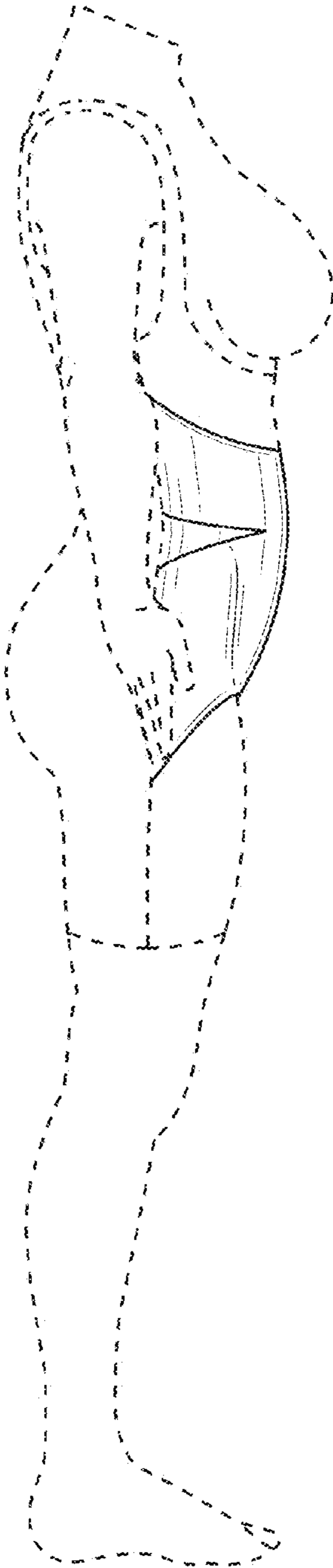

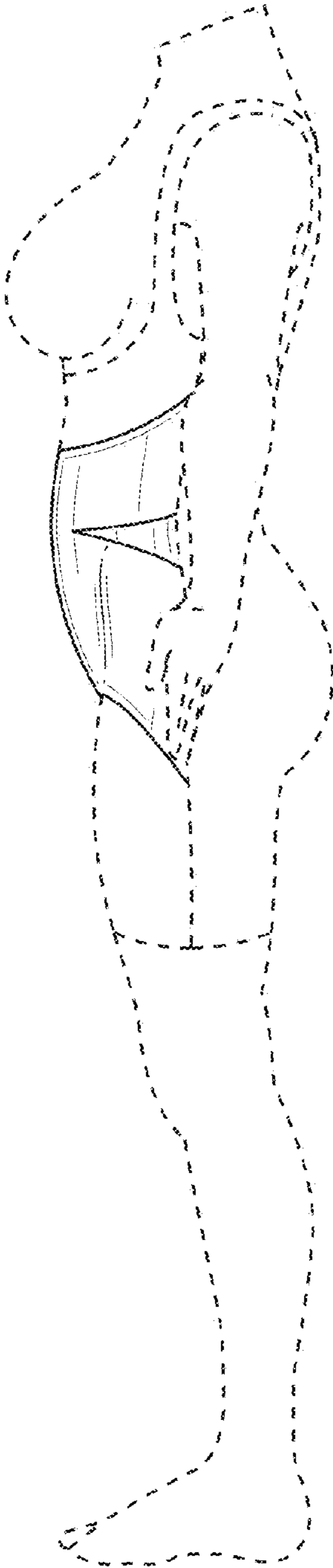

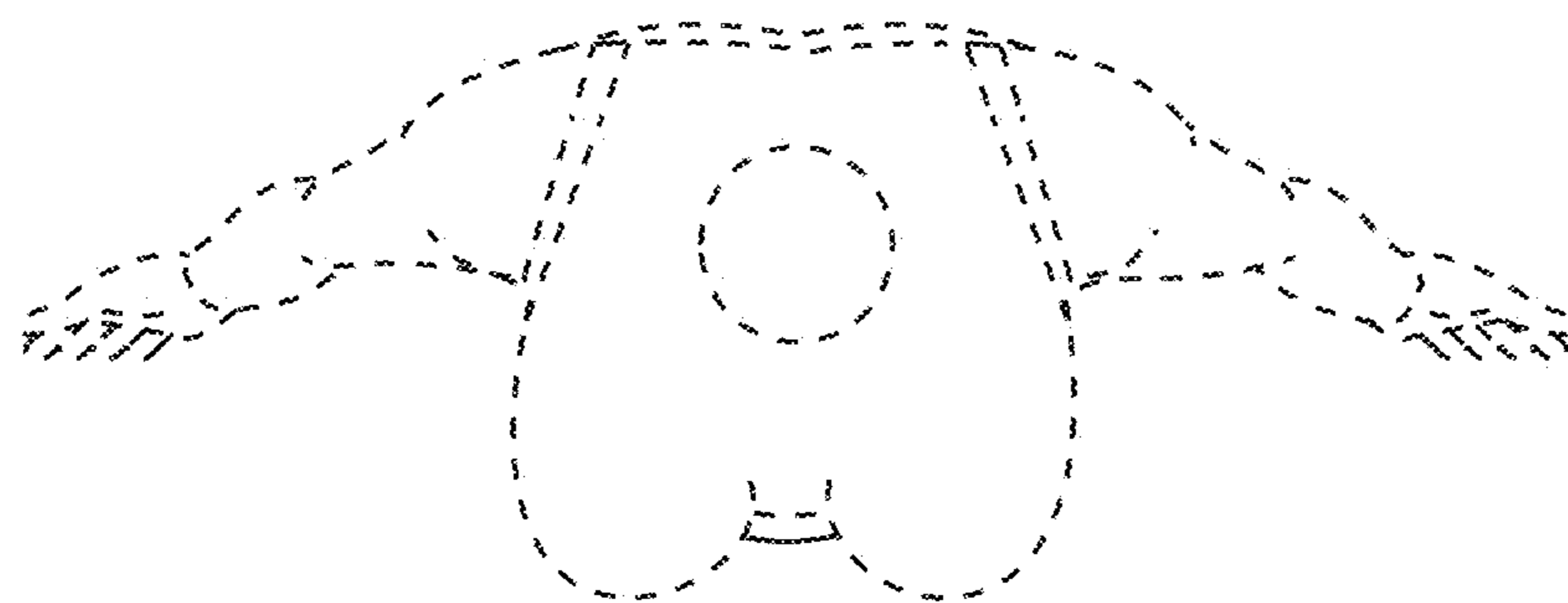

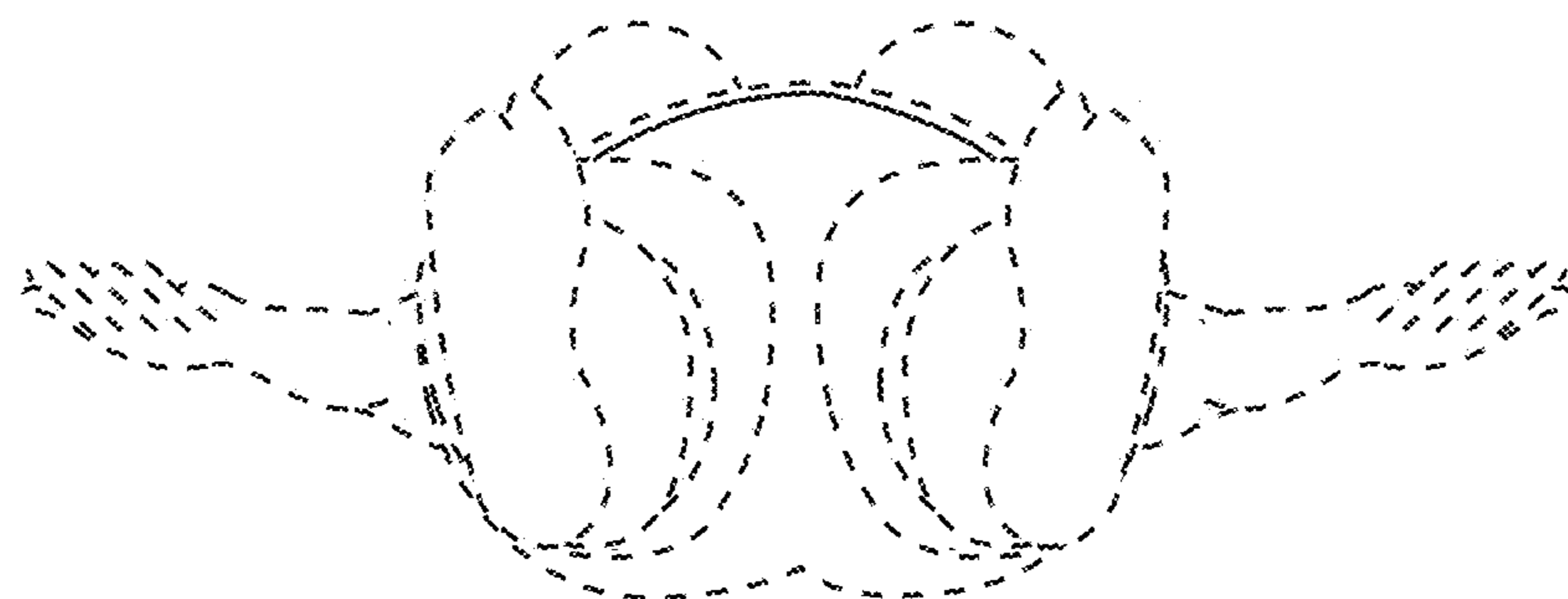
