(57) **CLAIM**

The ornamental design for a pair of convertible pants, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pair of convertible pants of the claimed design.
FIG. 2 is a front elevational view of the pair of convertible pants of FIG. 1;
FIG. 3 is a rear elevational view of the pair of convertible pants of FIG. 1;
FIG. 4 is a right side elevational view of the pair of convertible pants of FIG. 1;
FIG. 5 is a left side elevational view of the pair of convertible pants of FIG. 1;
FIG. 6 is a perspective view of the pair of convertible pants of FIG. 1, shown with the lower legs separated from the remainder of the pair of convertible pants; and,
FIG. 7 is a partial, enlarged view of a portion of the pair of convertible pants of FIG. 1.
The features shown in broken lines are environment only and not part of the claimed design. The interior regions of the pair of convertible pants are not part of the claimed design.

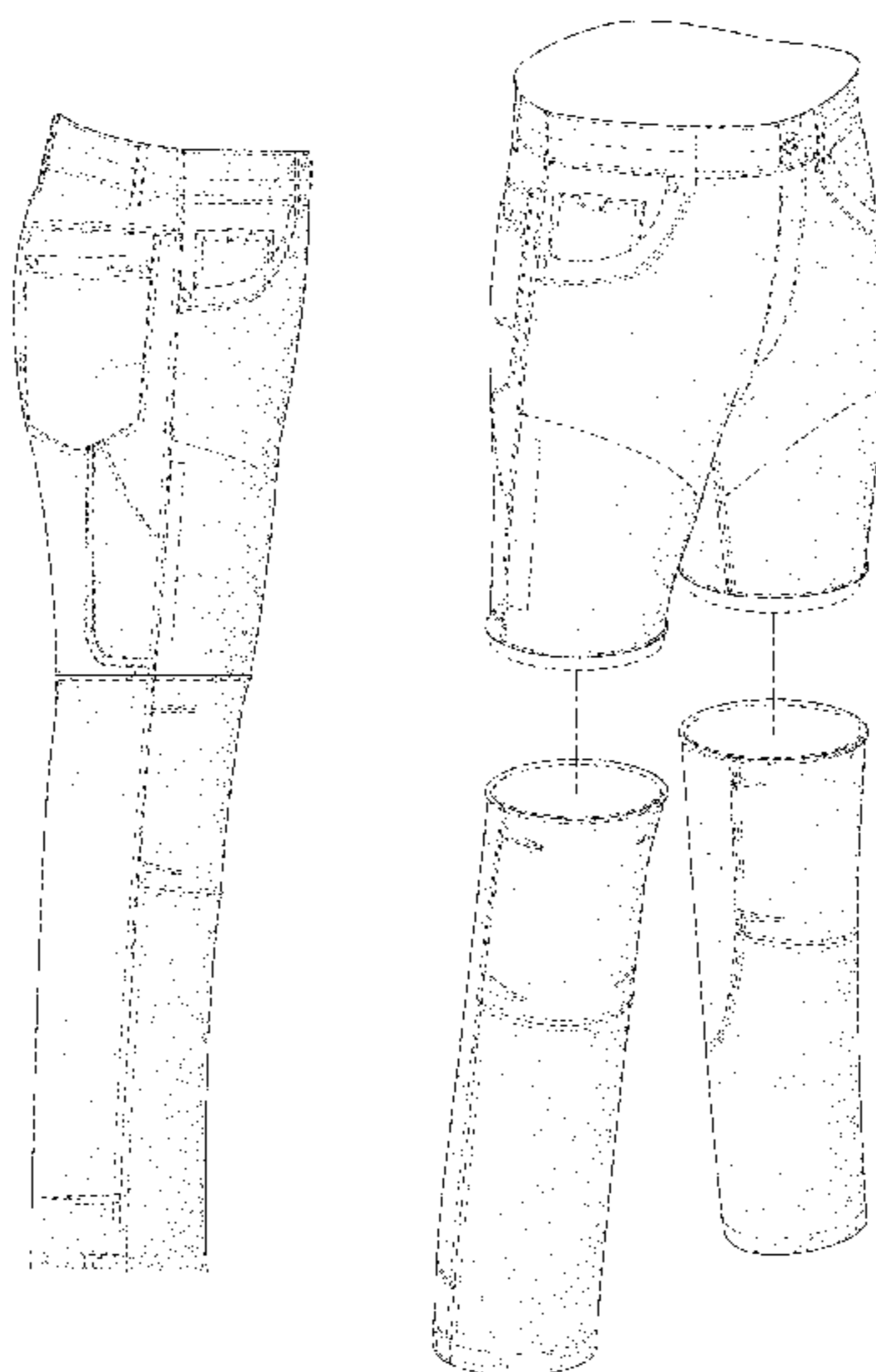

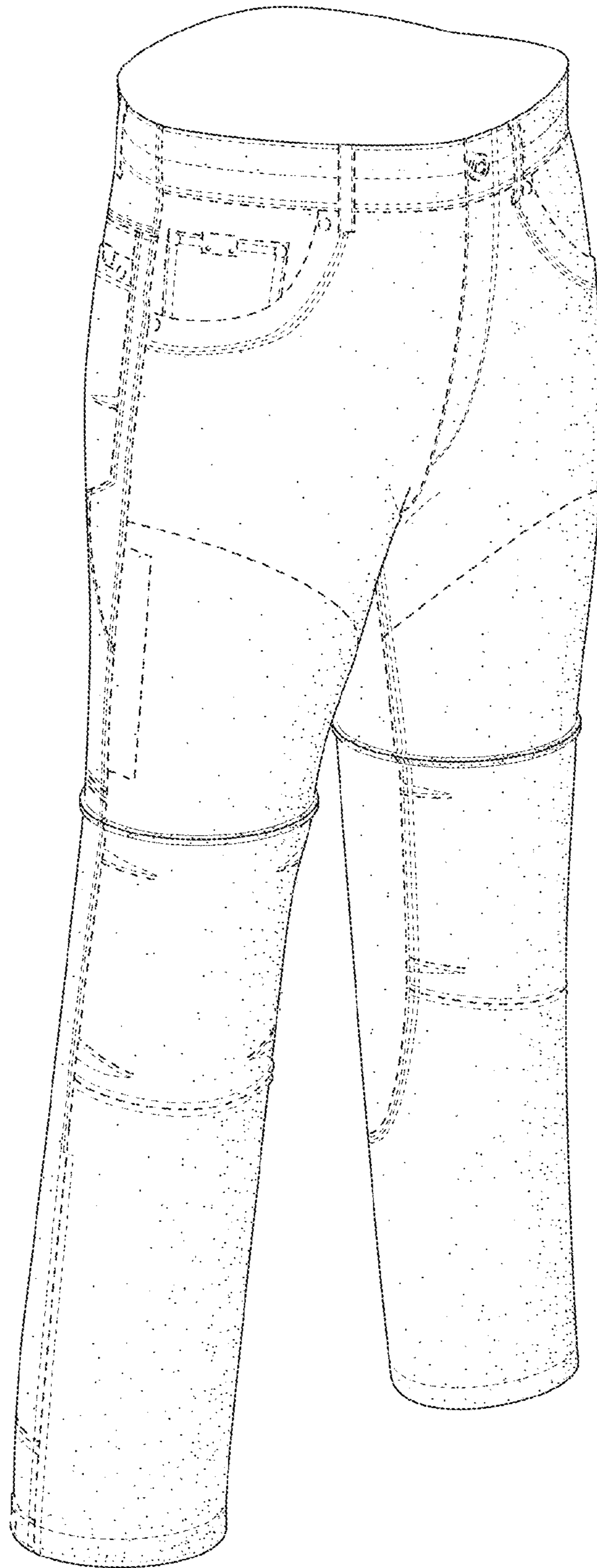

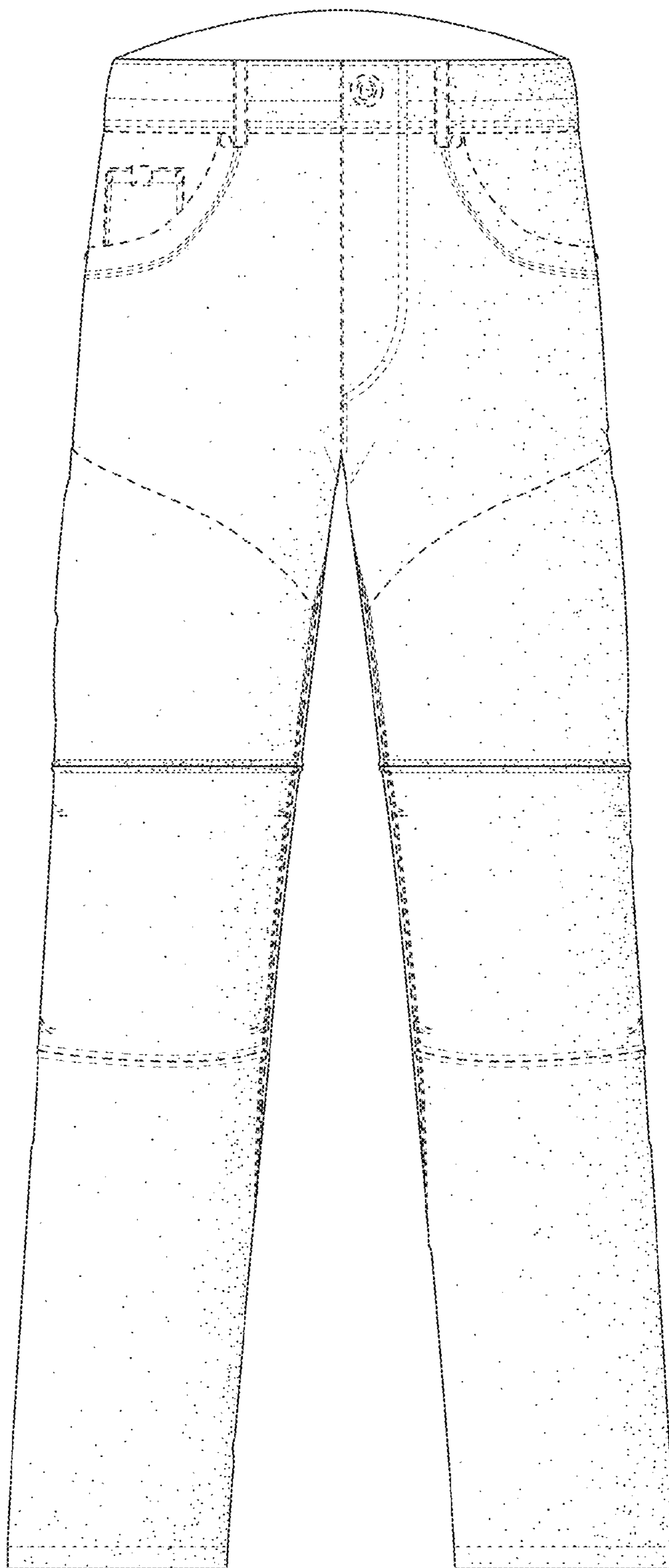

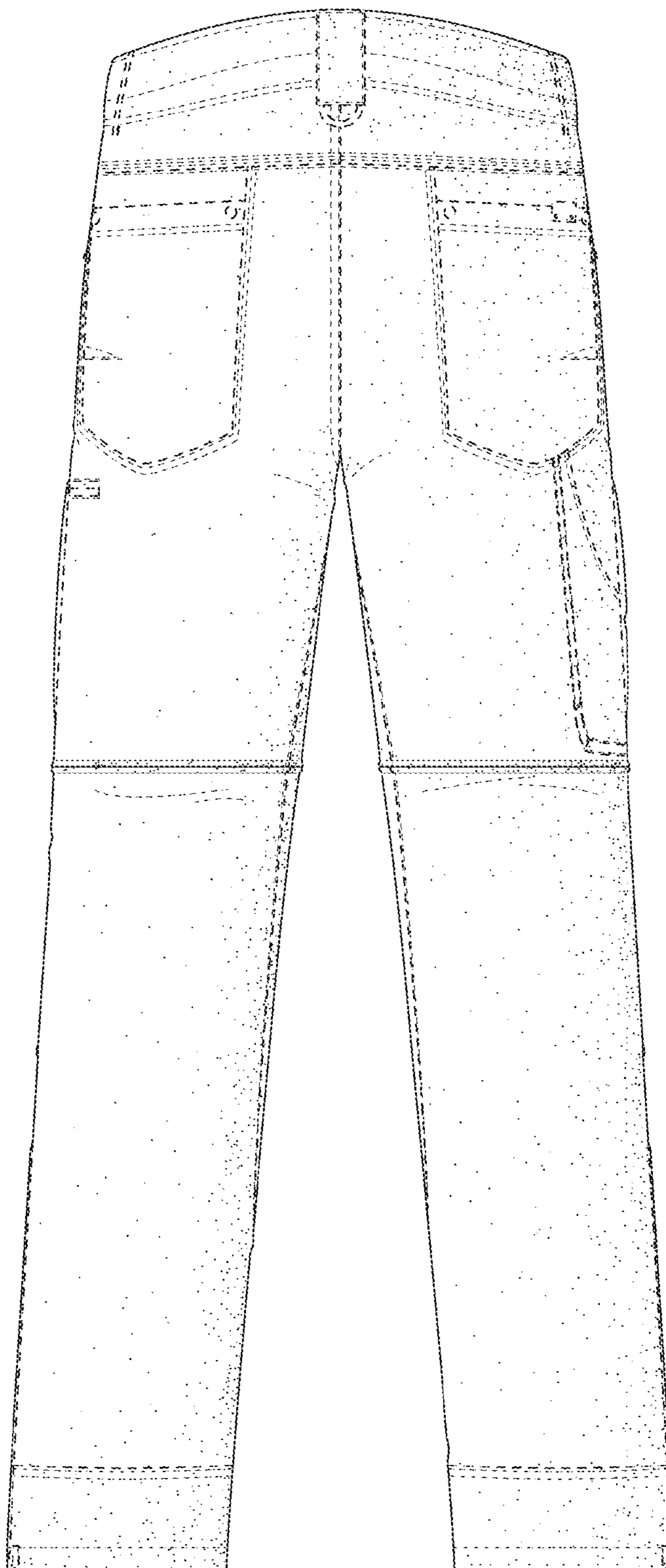

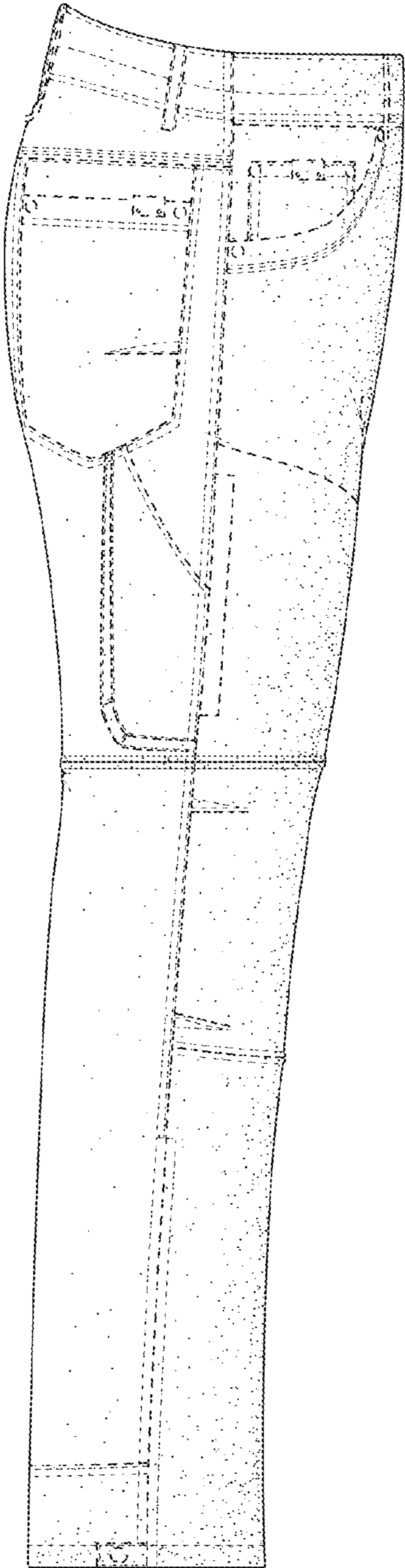

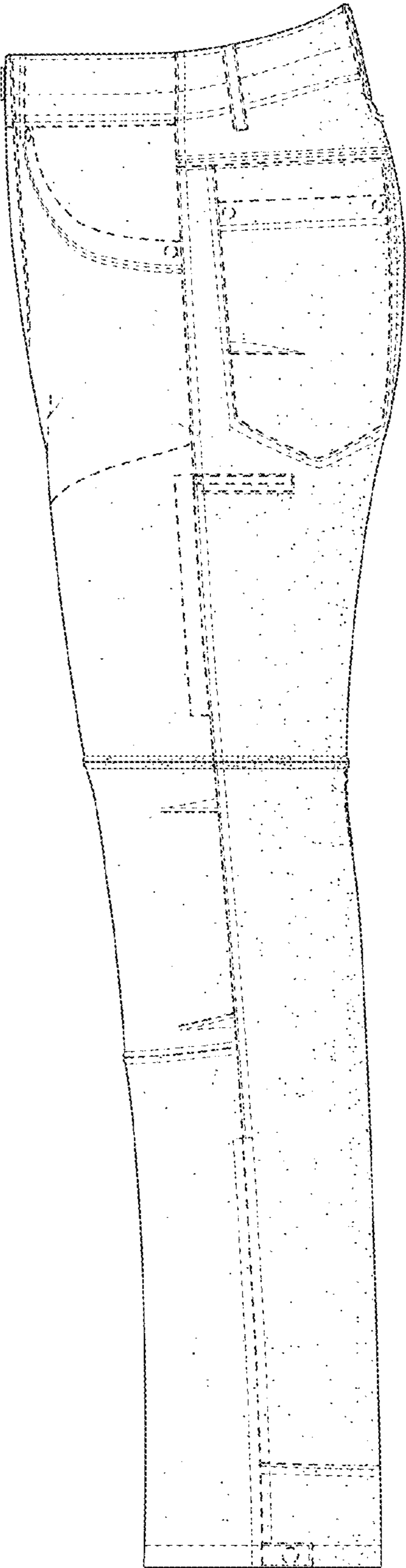

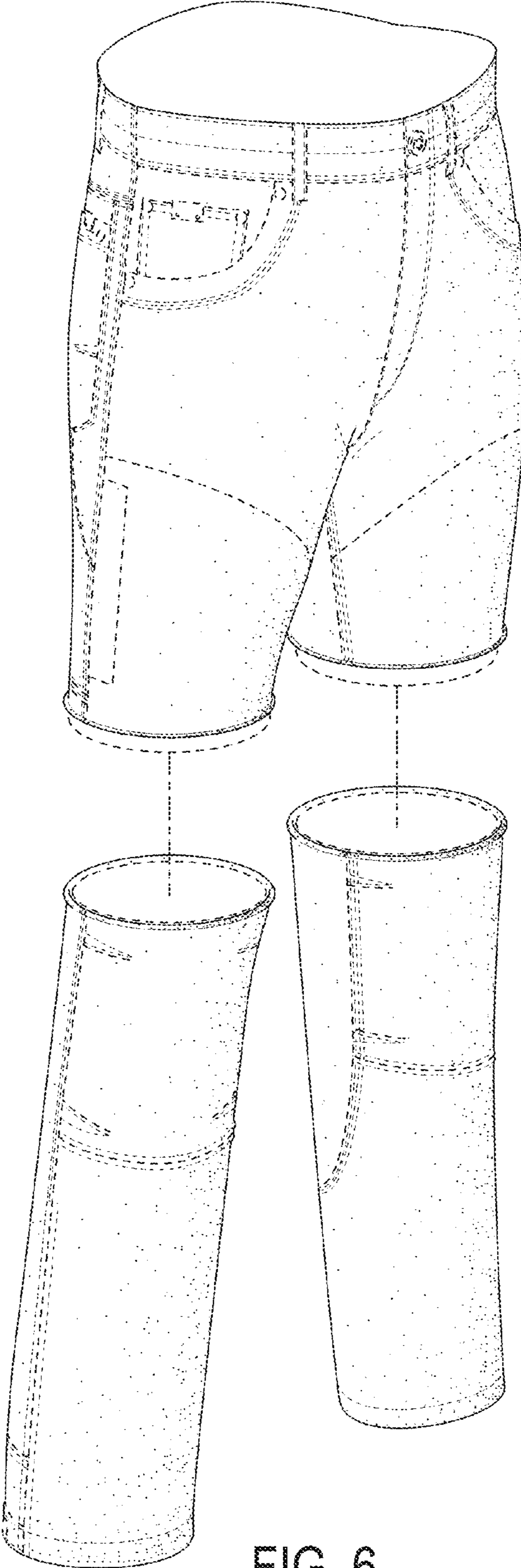

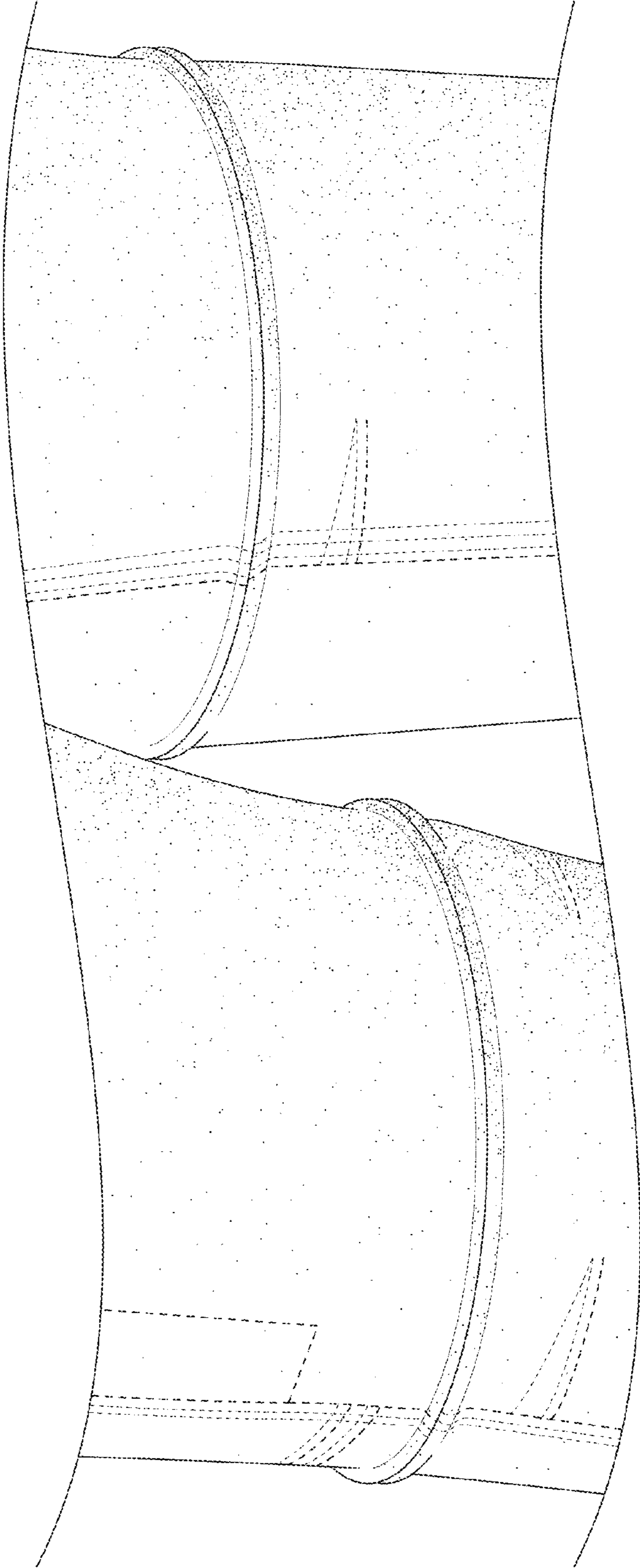
