(57) **CLAIM**

I claim the ornamental design for an upper for a shoe with removable straps, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an upper for a shoe with a removable strap of the present invention.

FIG. 2 is right side view of the shoe shown in FIG. 1.

FIG. 3 is a left side view of the shoe shown in FIG. 1.

FIG. 4 is a top view of the shoe shown in FIG. 1.

FIG. 5 is a rear view of the shoe shown in FIG. 1; and,

FIG. 6 is a front view of the shoe shown in FIG. 1.

The broken line showing of the shoe sole is for illustrative purposes only and forms no part of the claimed design.

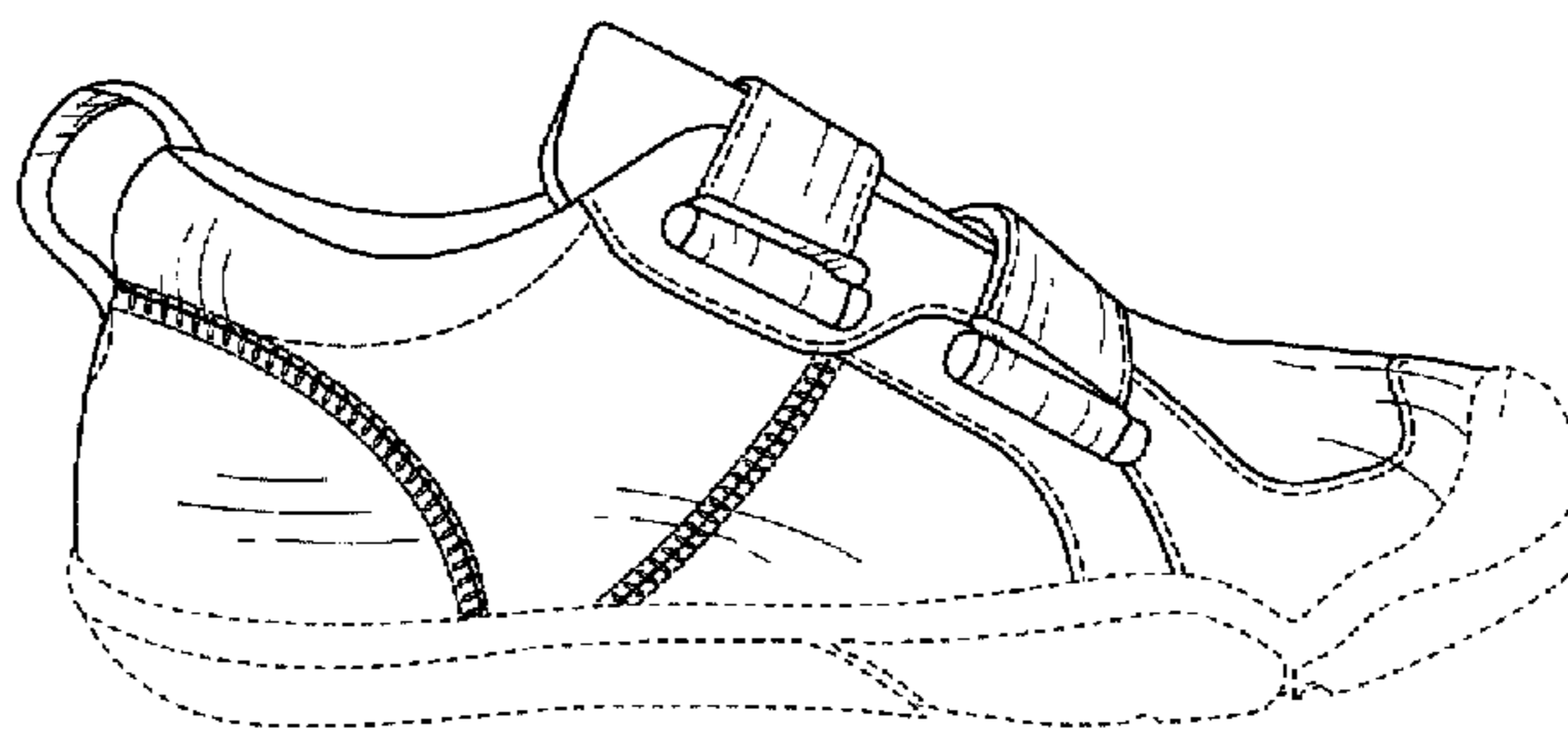
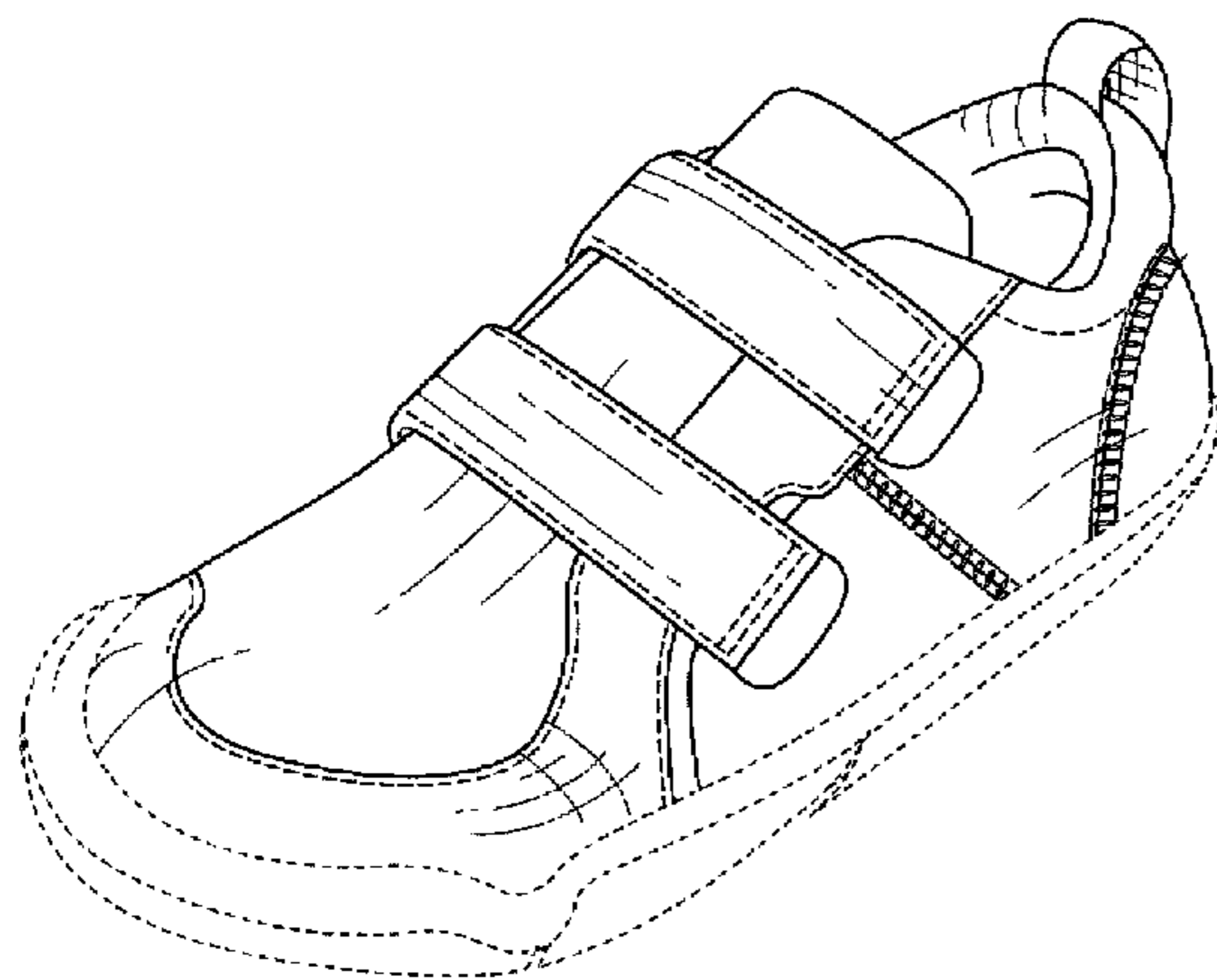

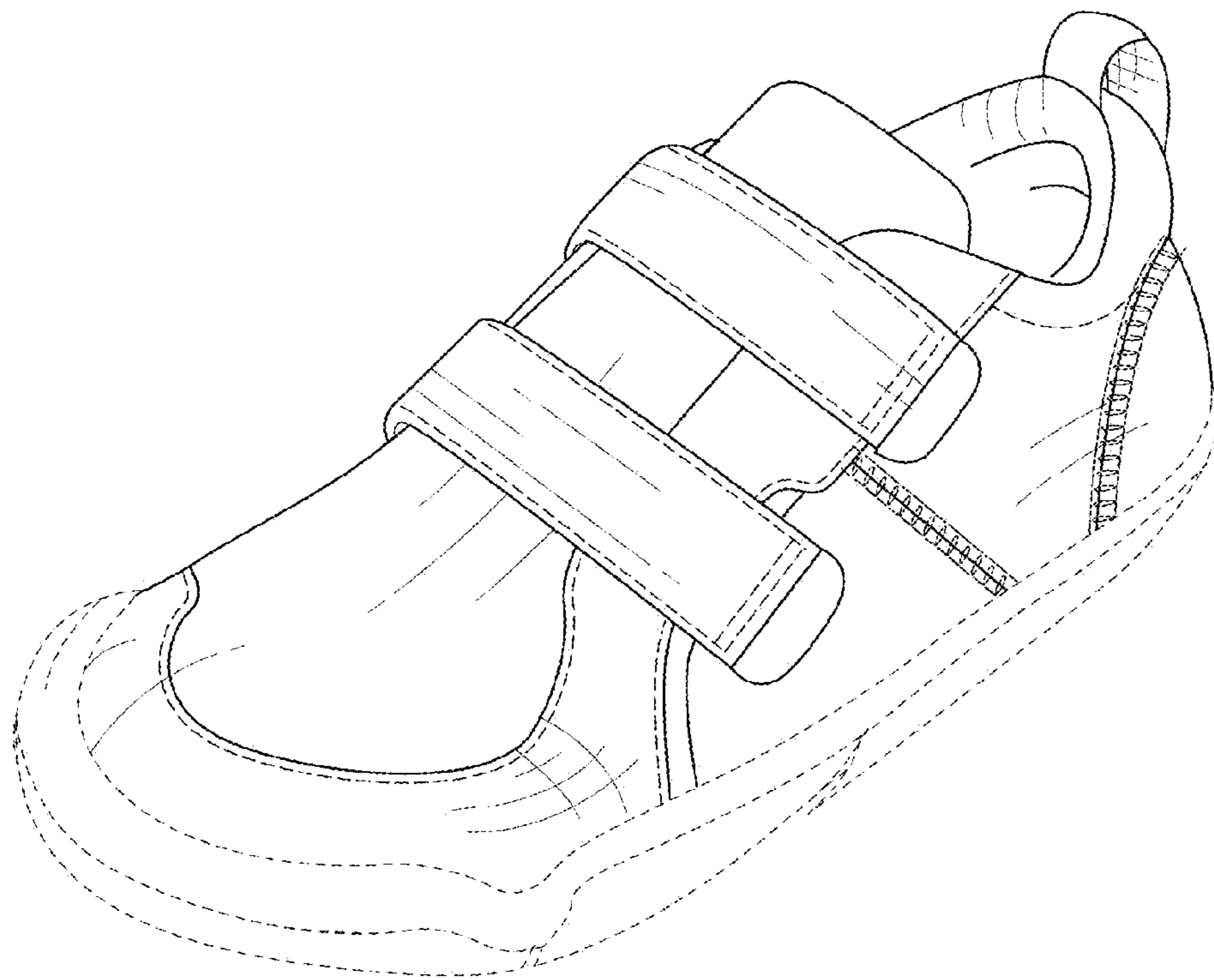

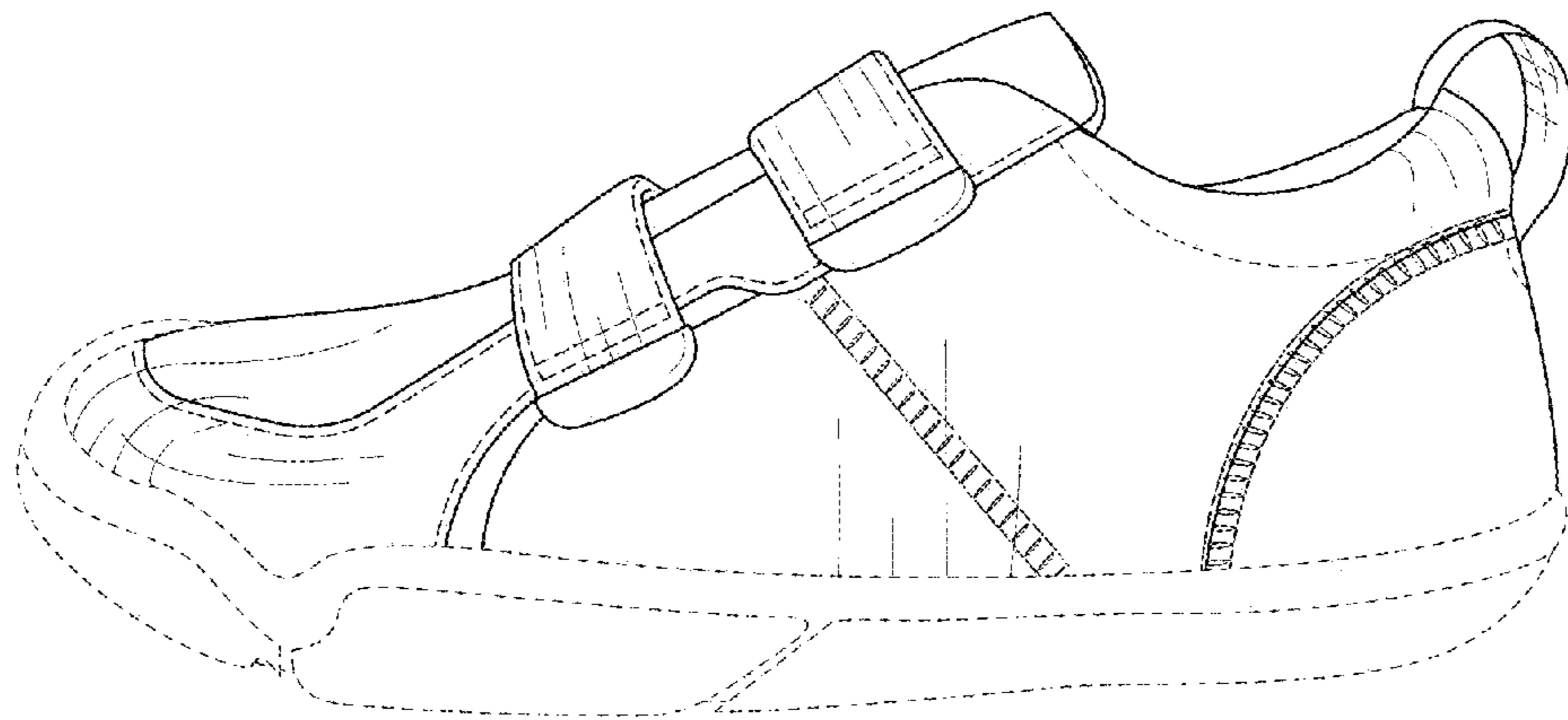

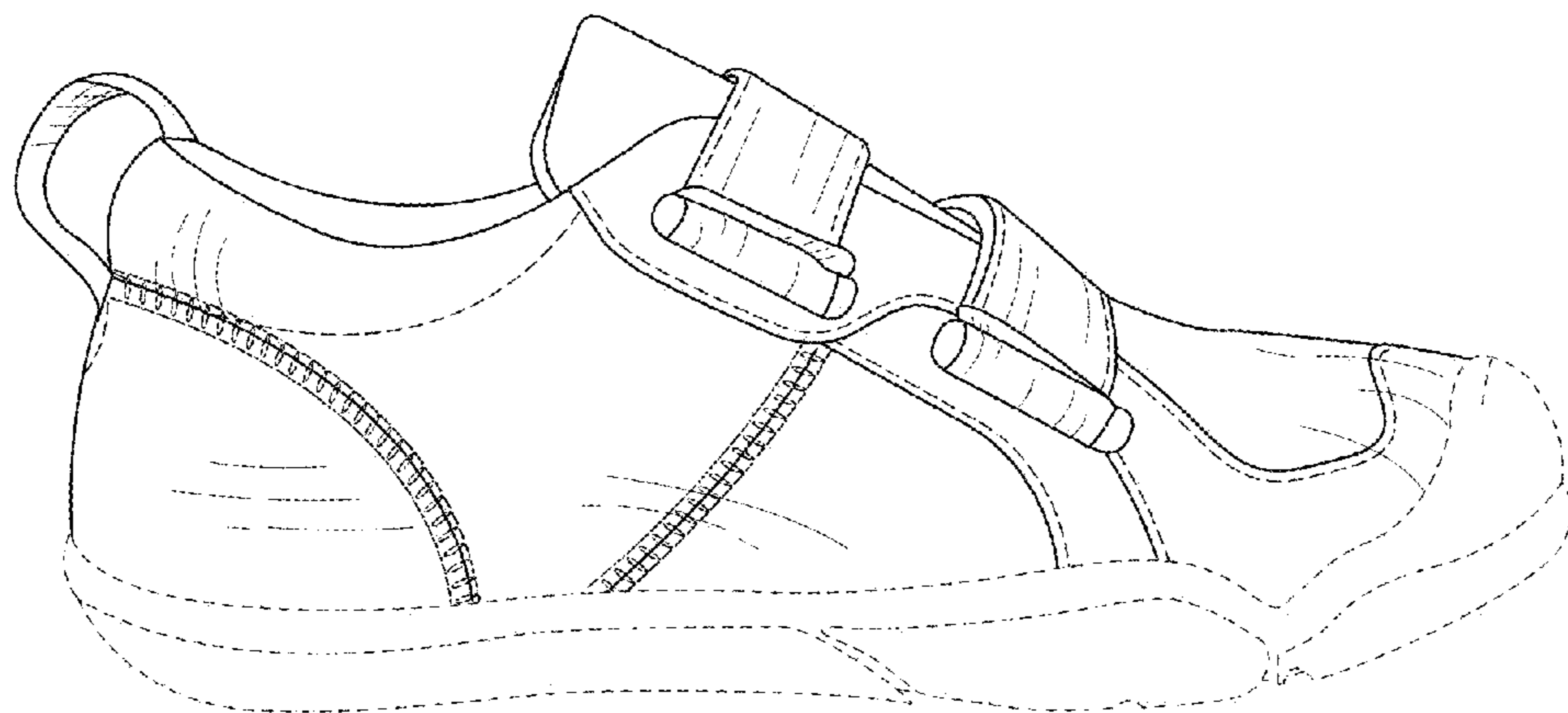

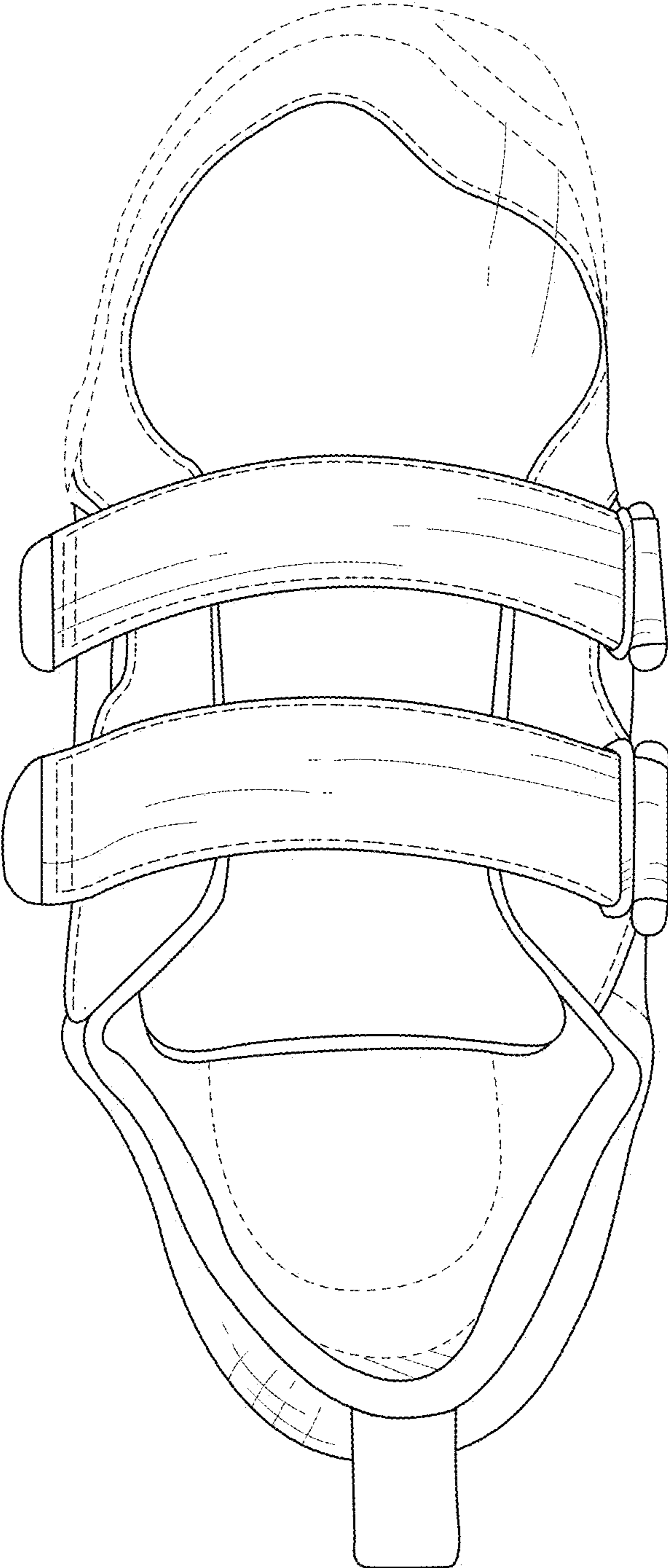

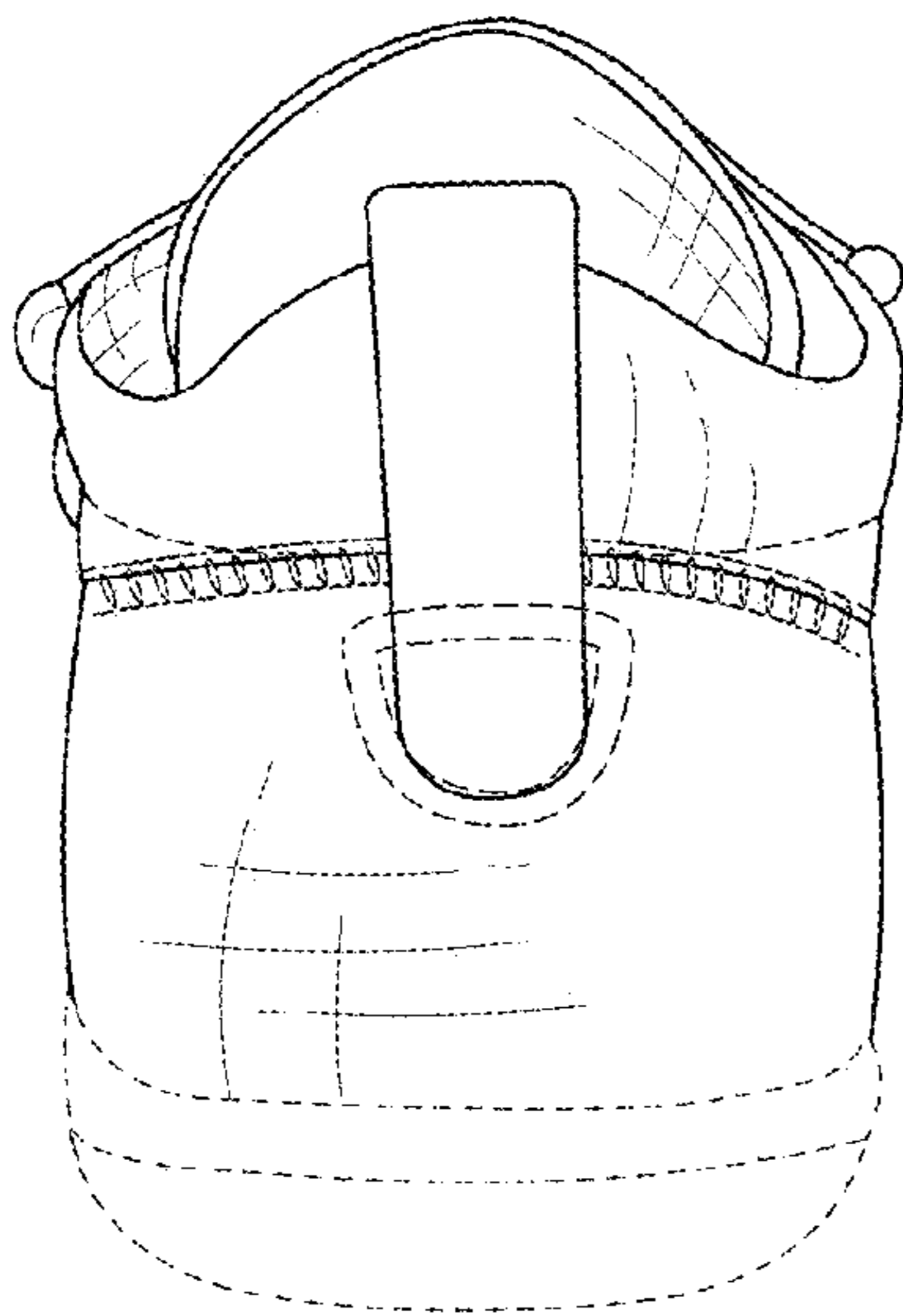
