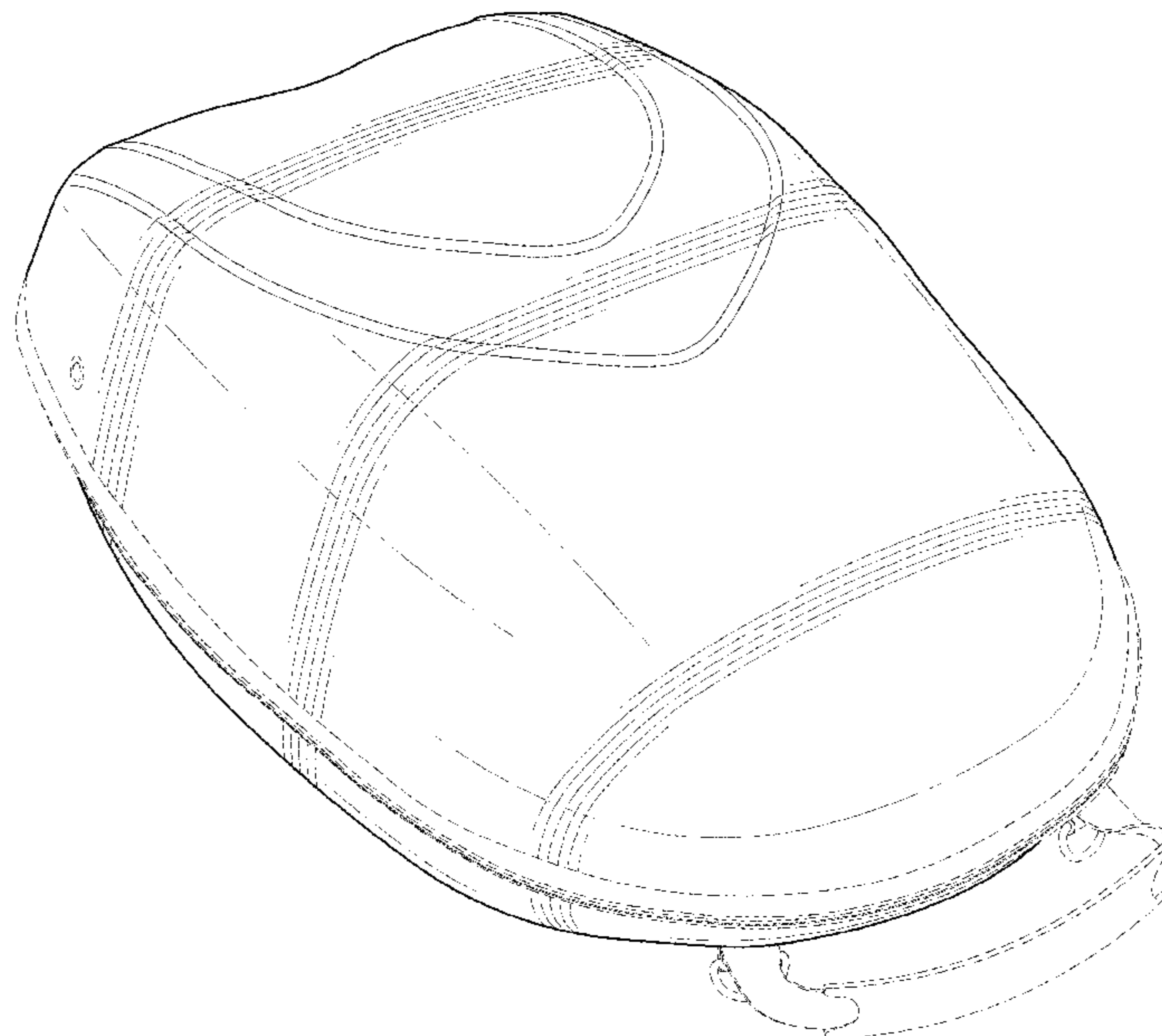
(57) **CLAIM**

The ornamental design for a baseball glove carrying case, as shown and described.

**DESCRIPTION**

FIG. 1 is an upper perspective view of an embodiment of the baseball glove carrying case;  
 FIG. 2 is a lower perspective view of the baseball glove carrying case;  
 FIG. 3 is a front view of baseball glove carrying case;  
 FIG. 4 is a back view of the baseball glove carrying case;

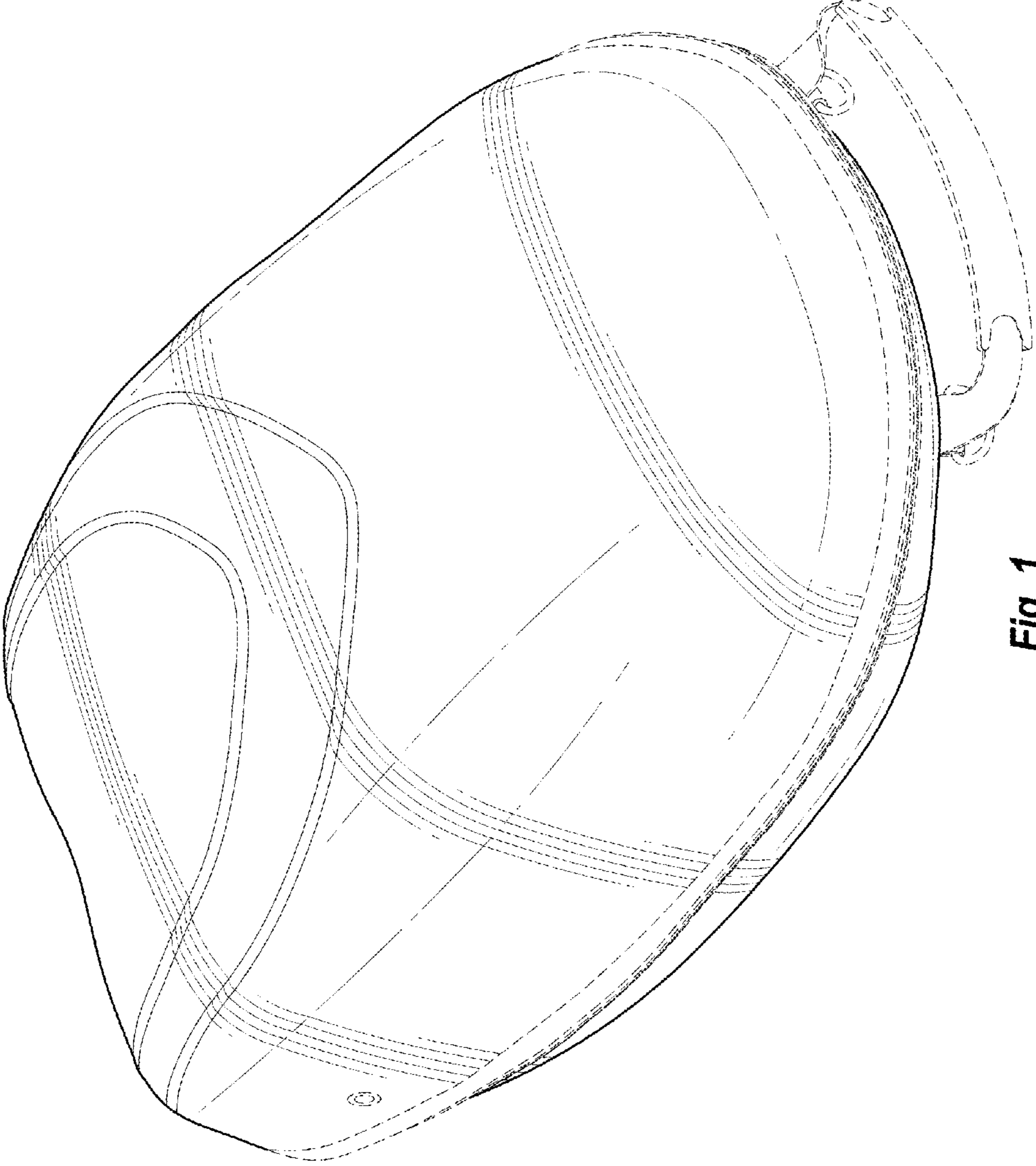

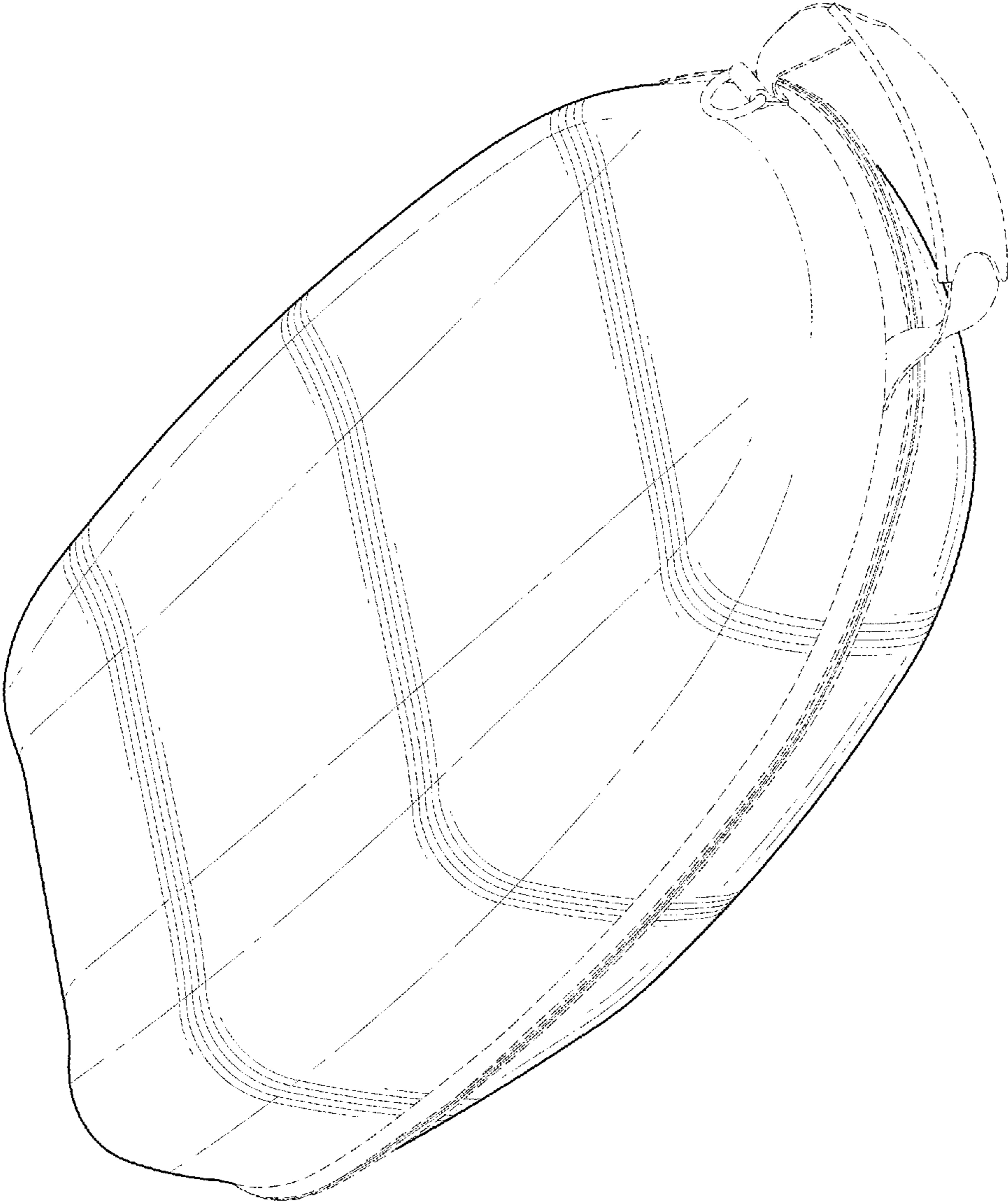

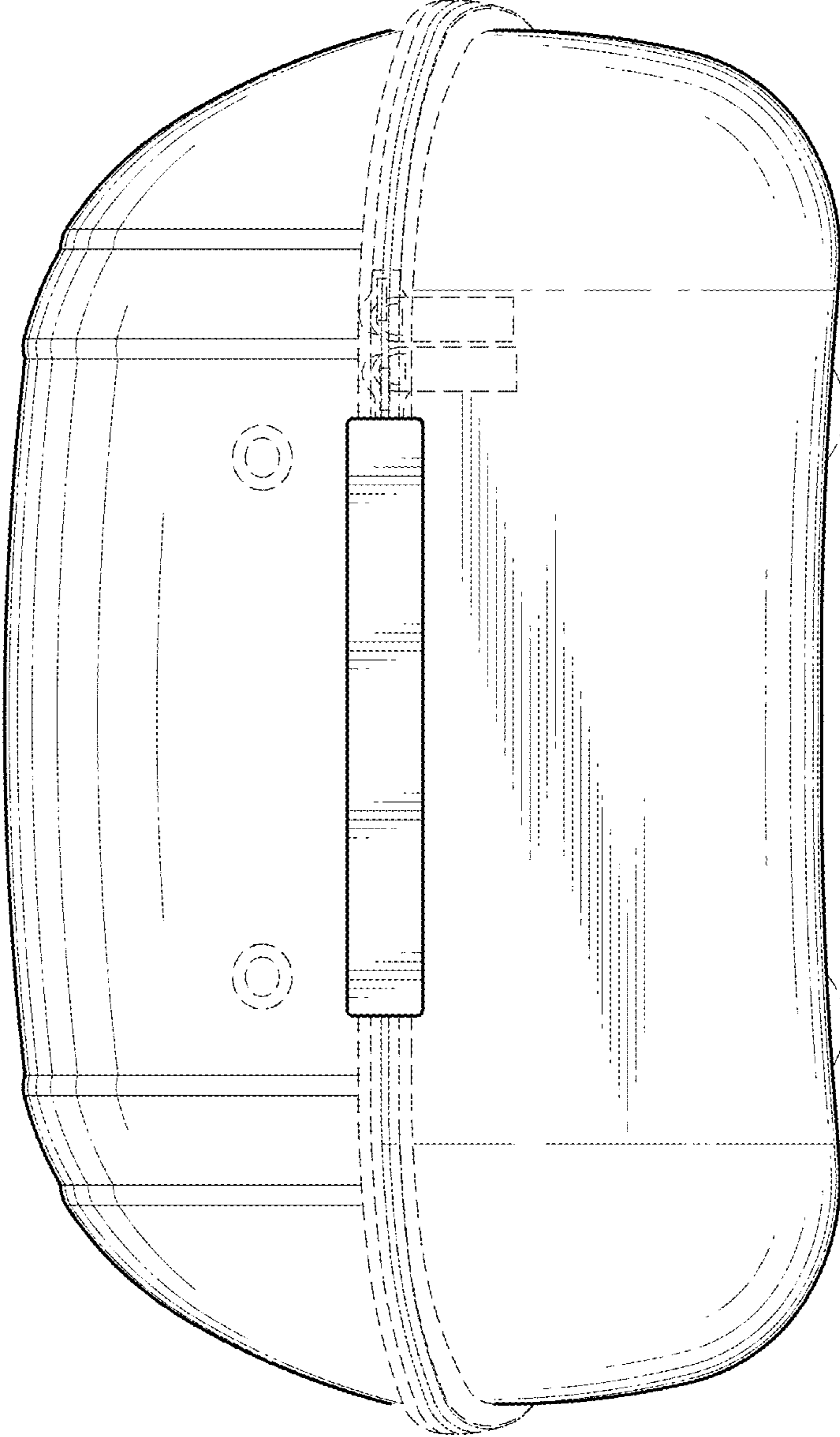

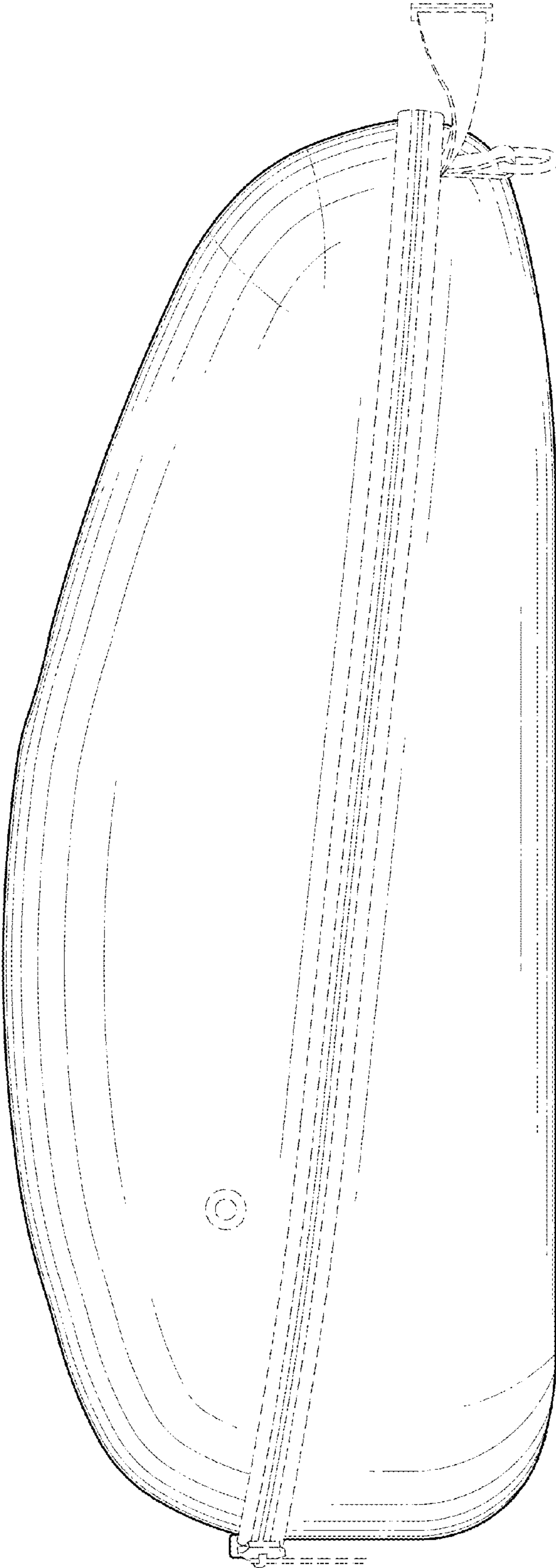

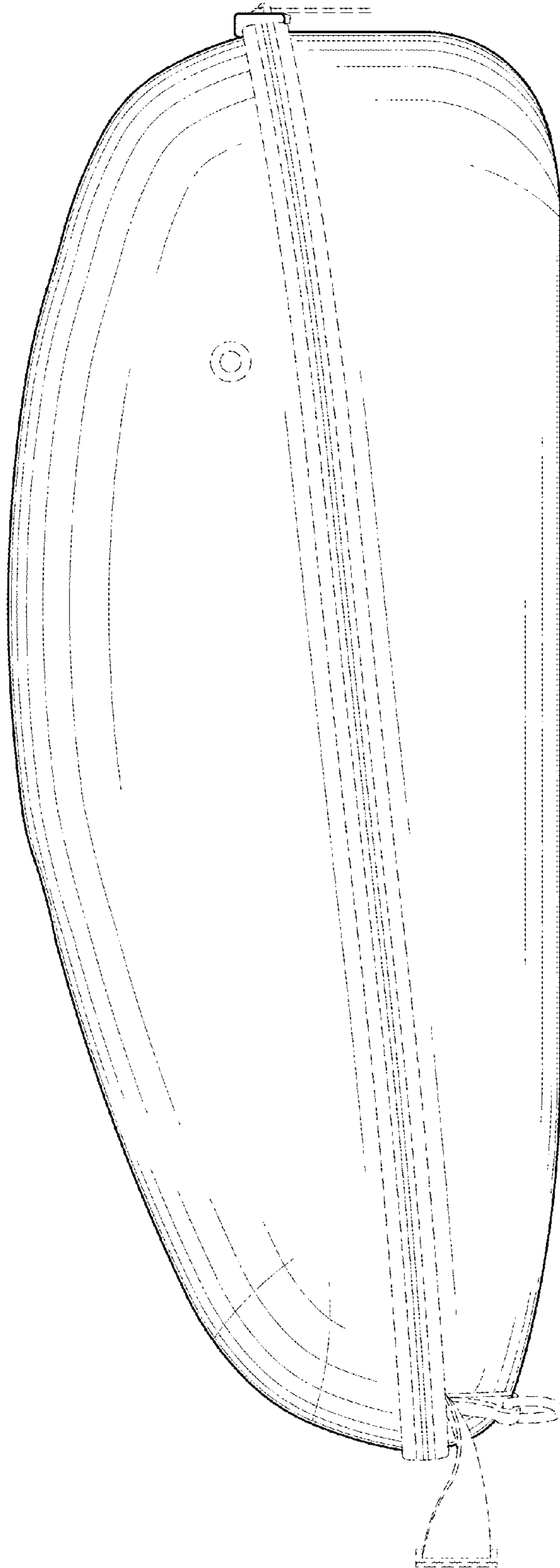

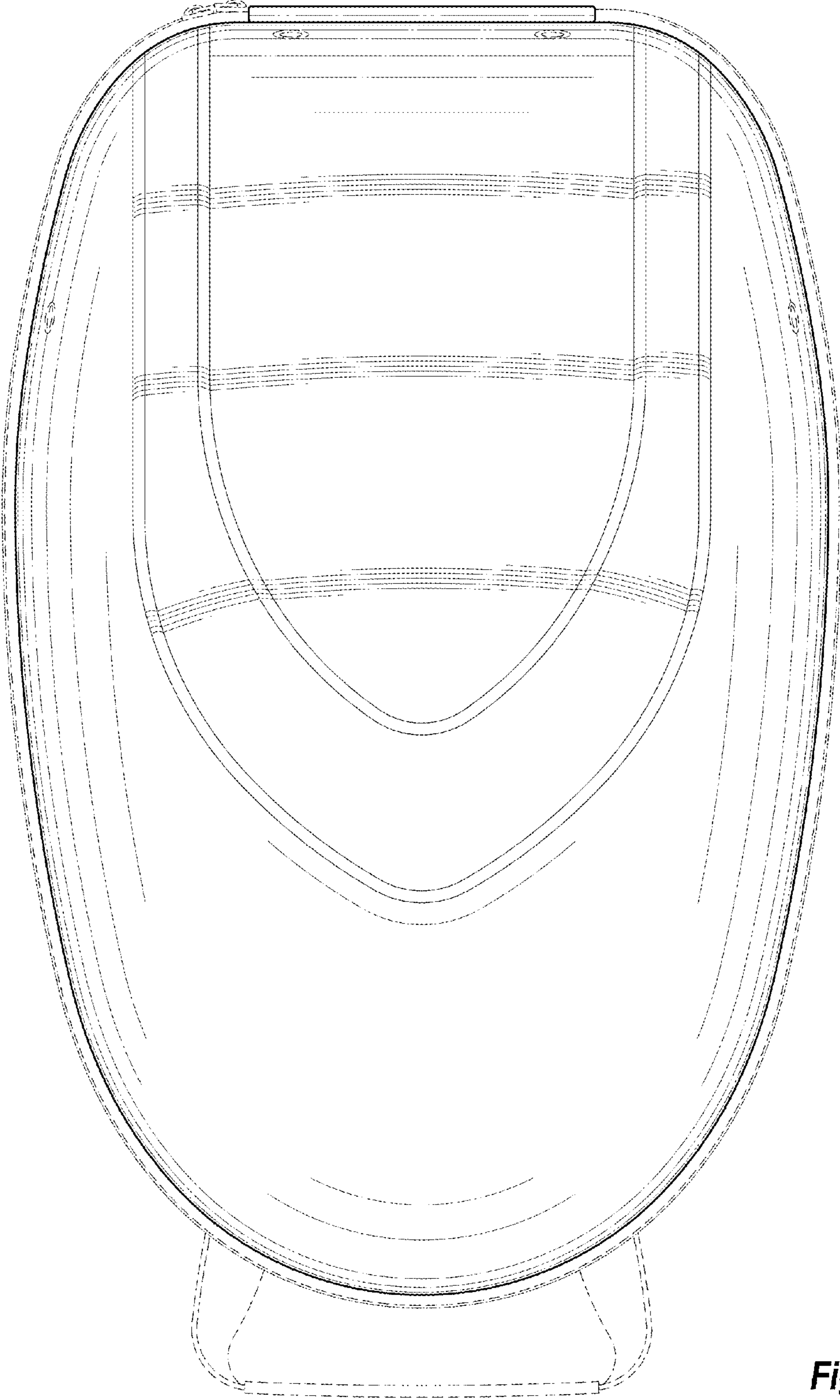
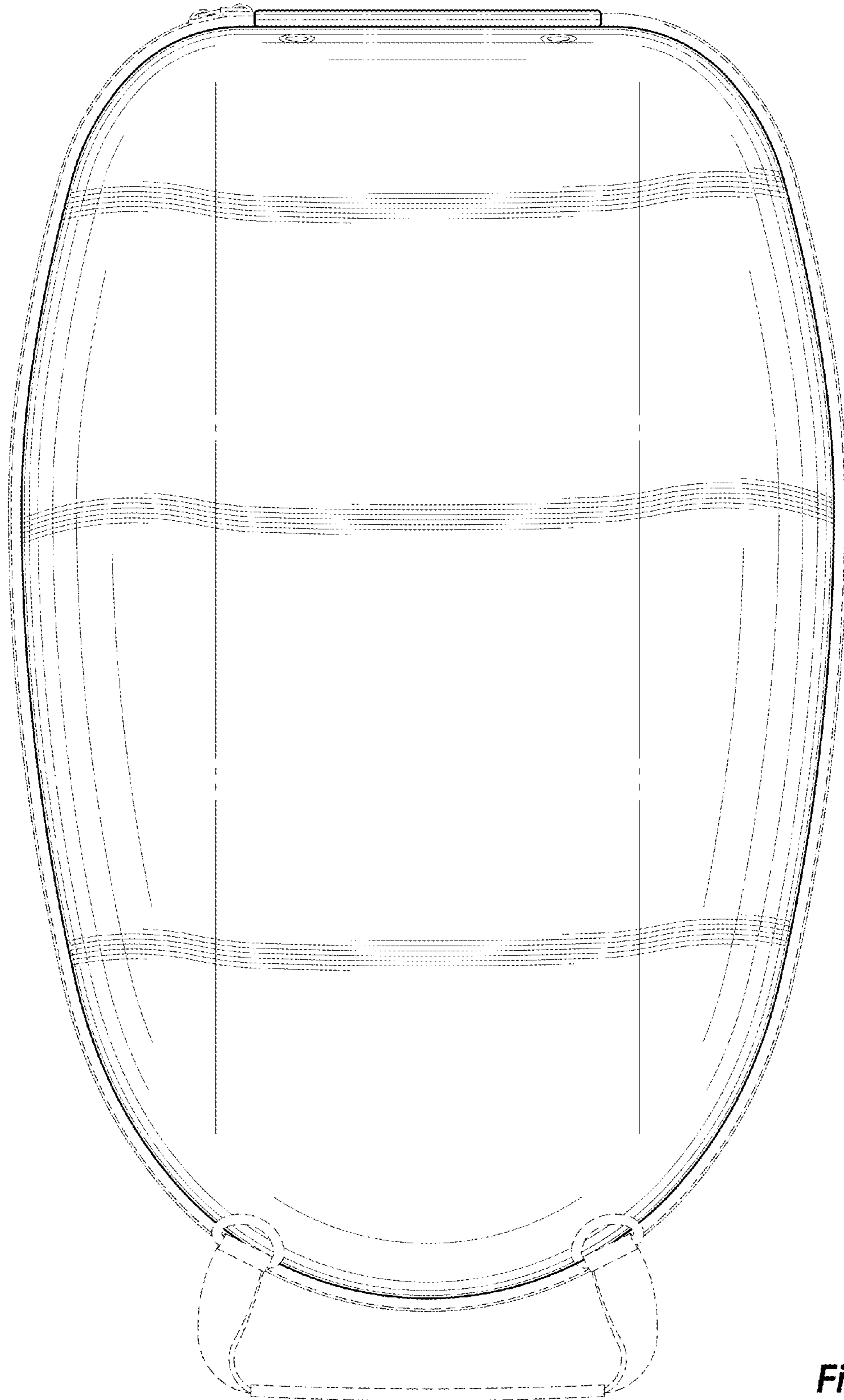

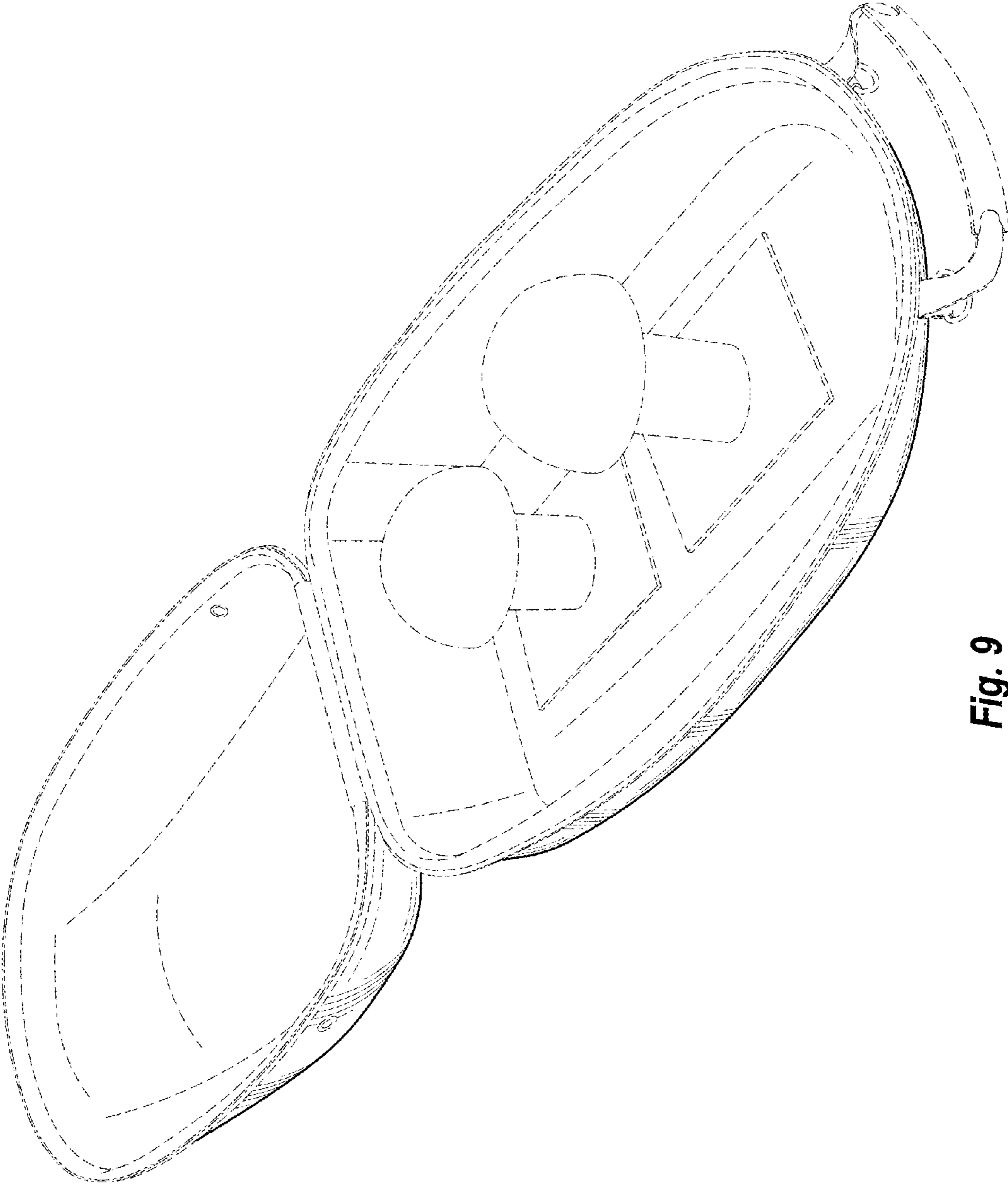
