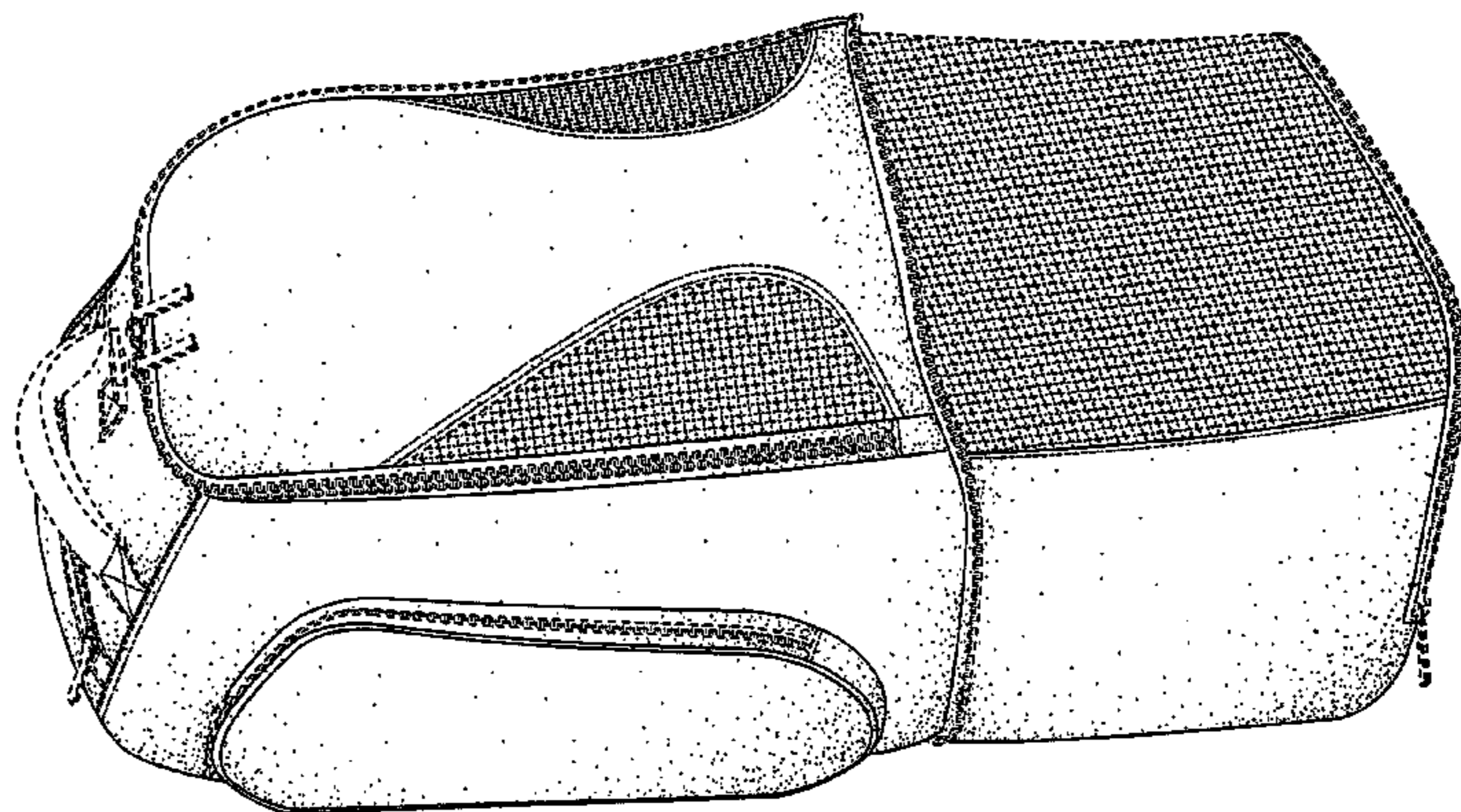
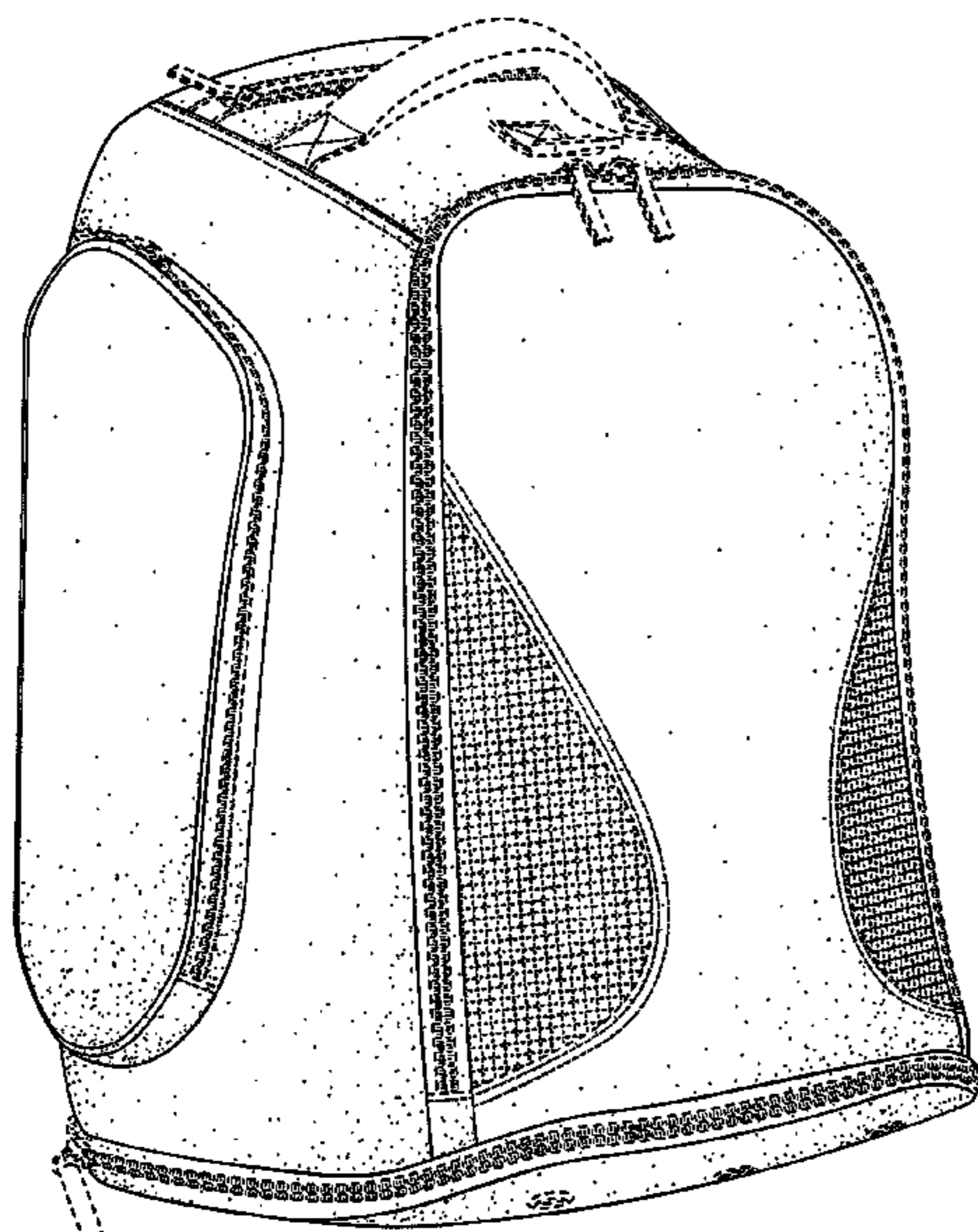
The ornamental design for a bag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the bag of the present invention showing my new design;

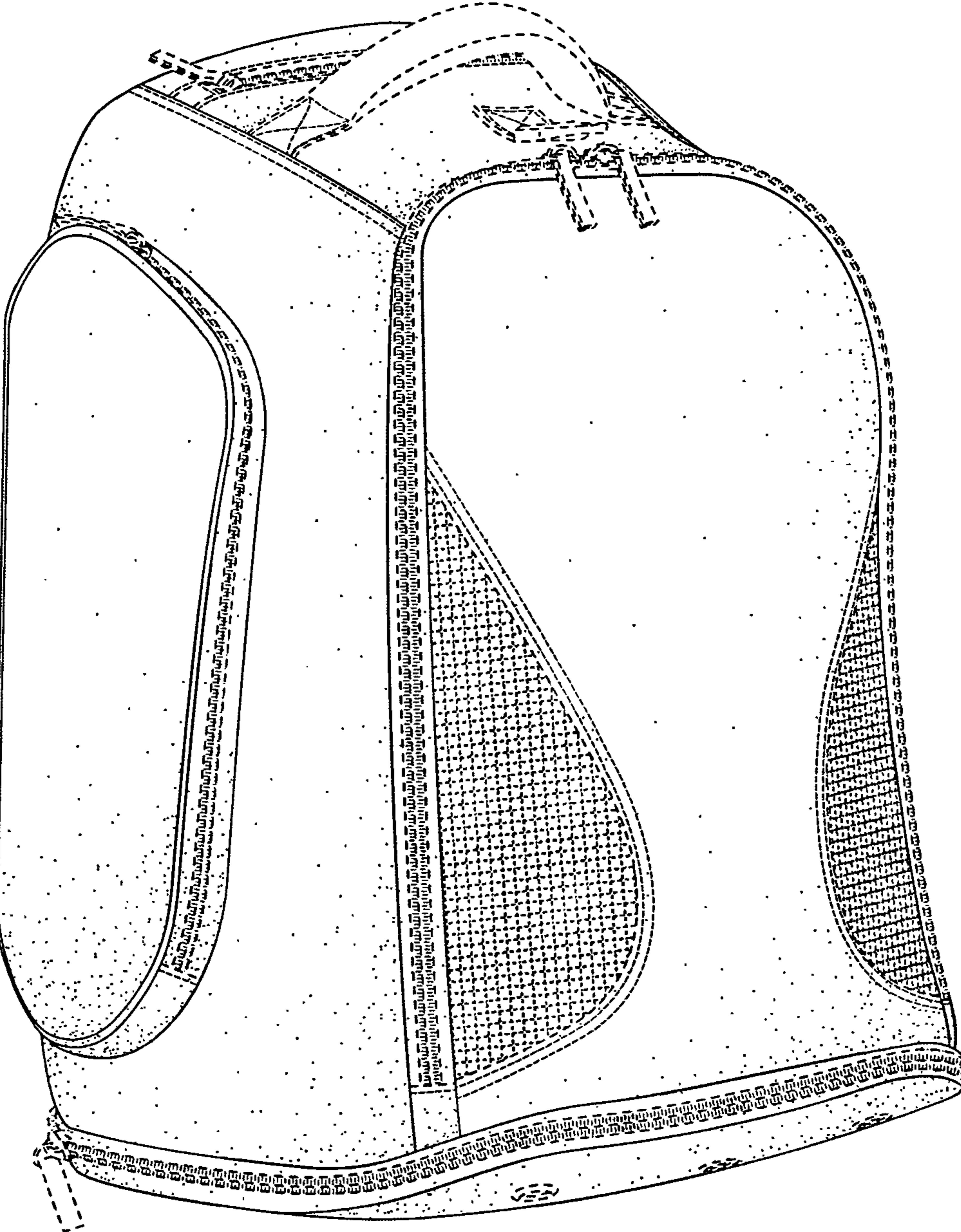

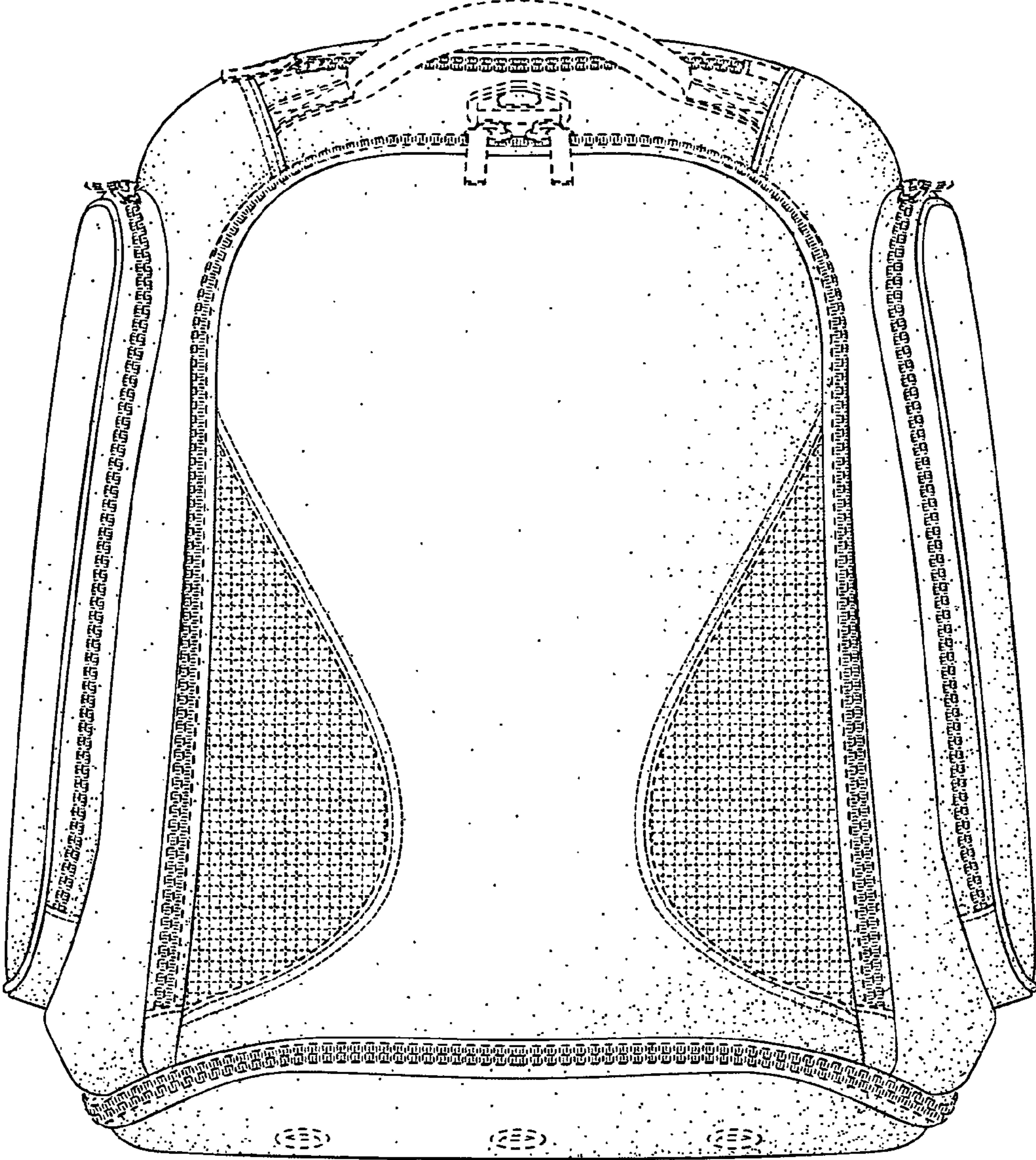

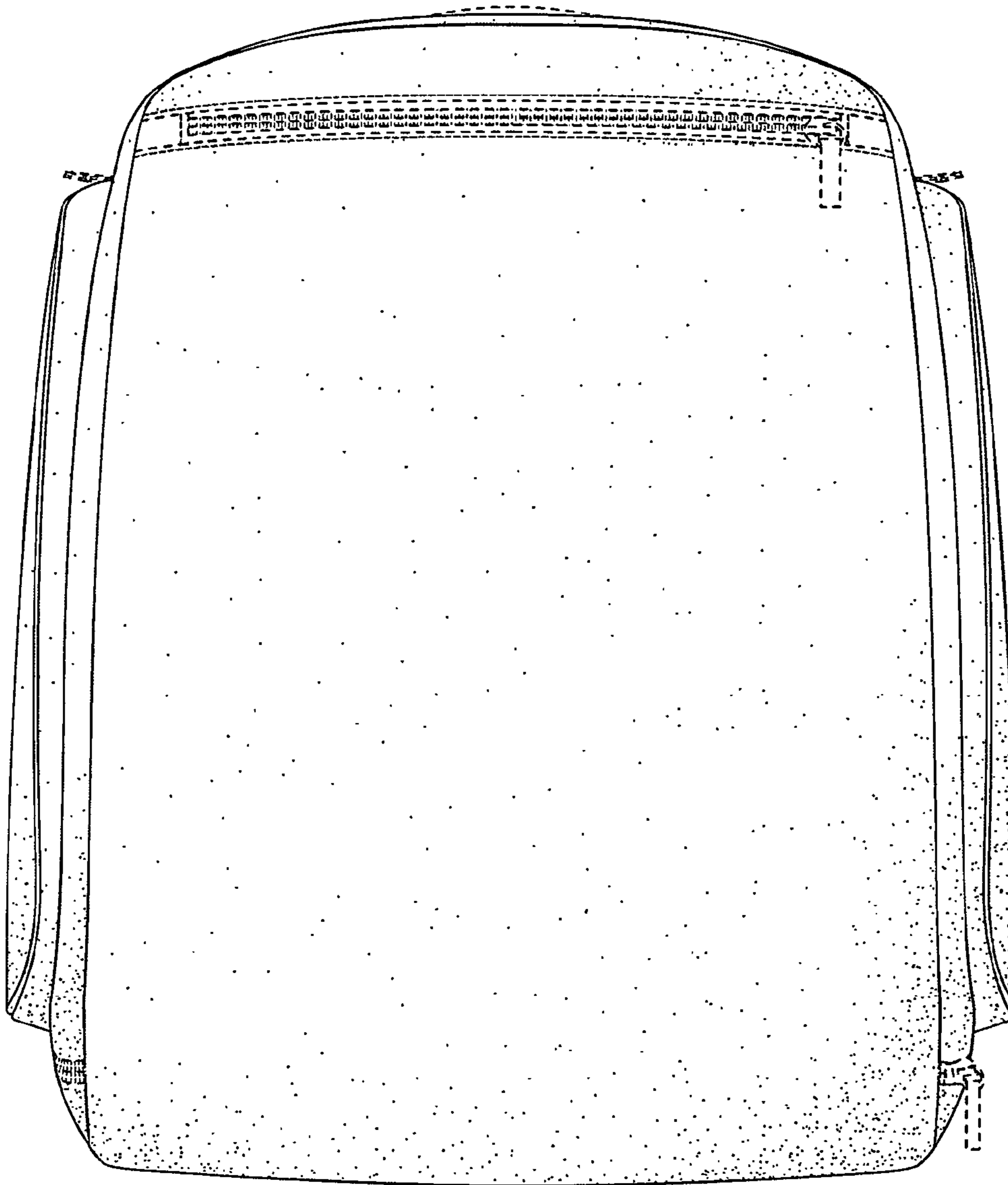

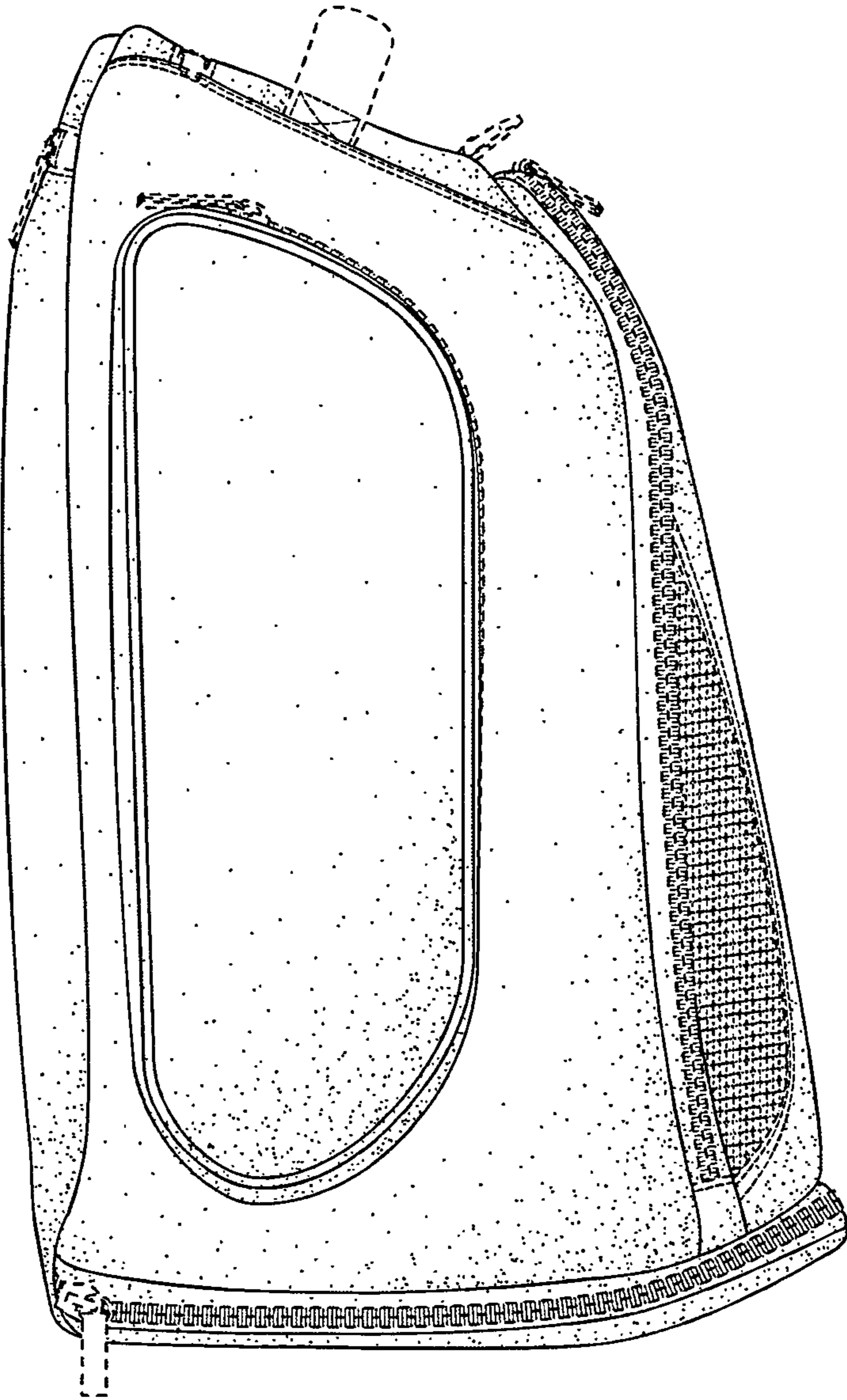

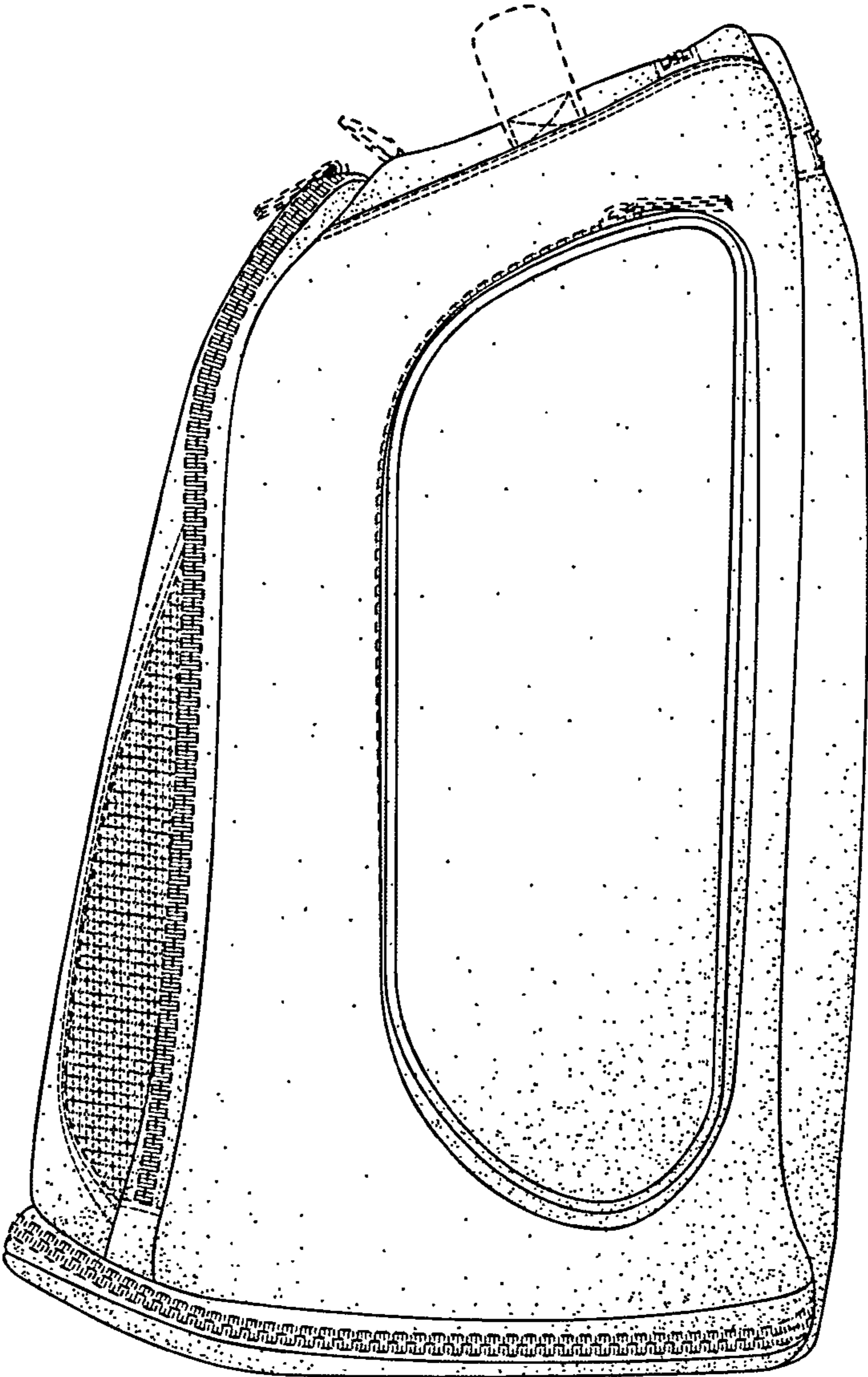

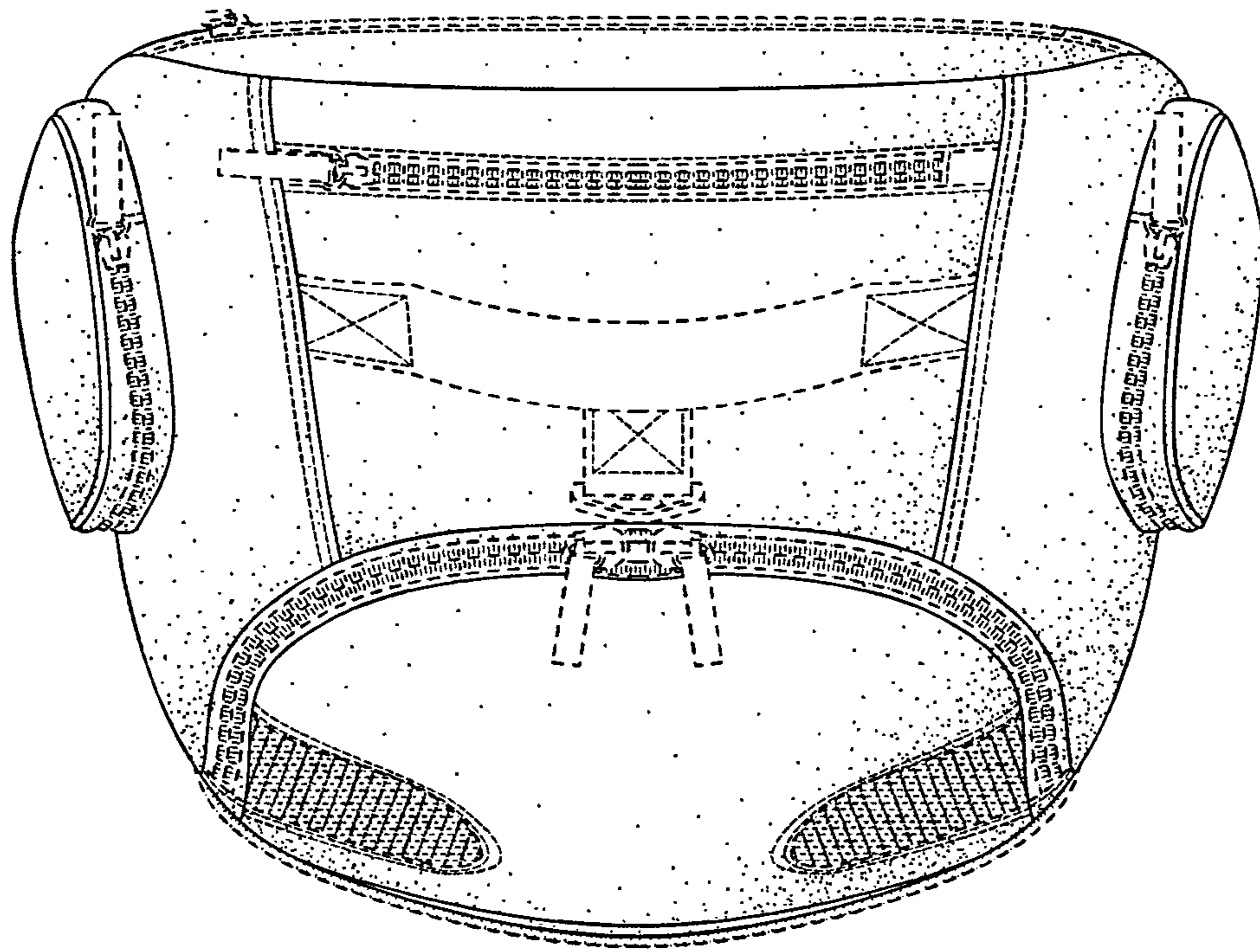

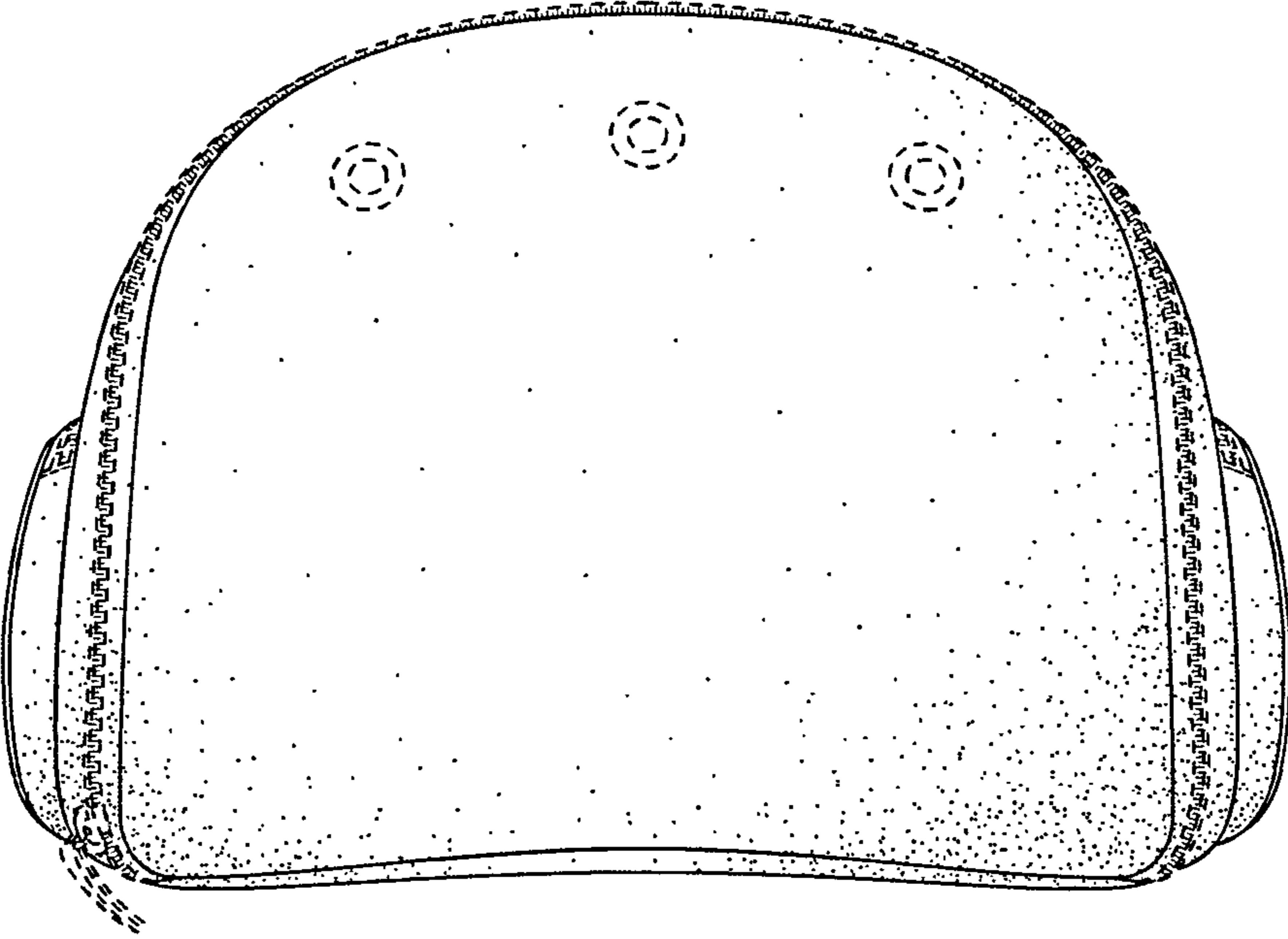

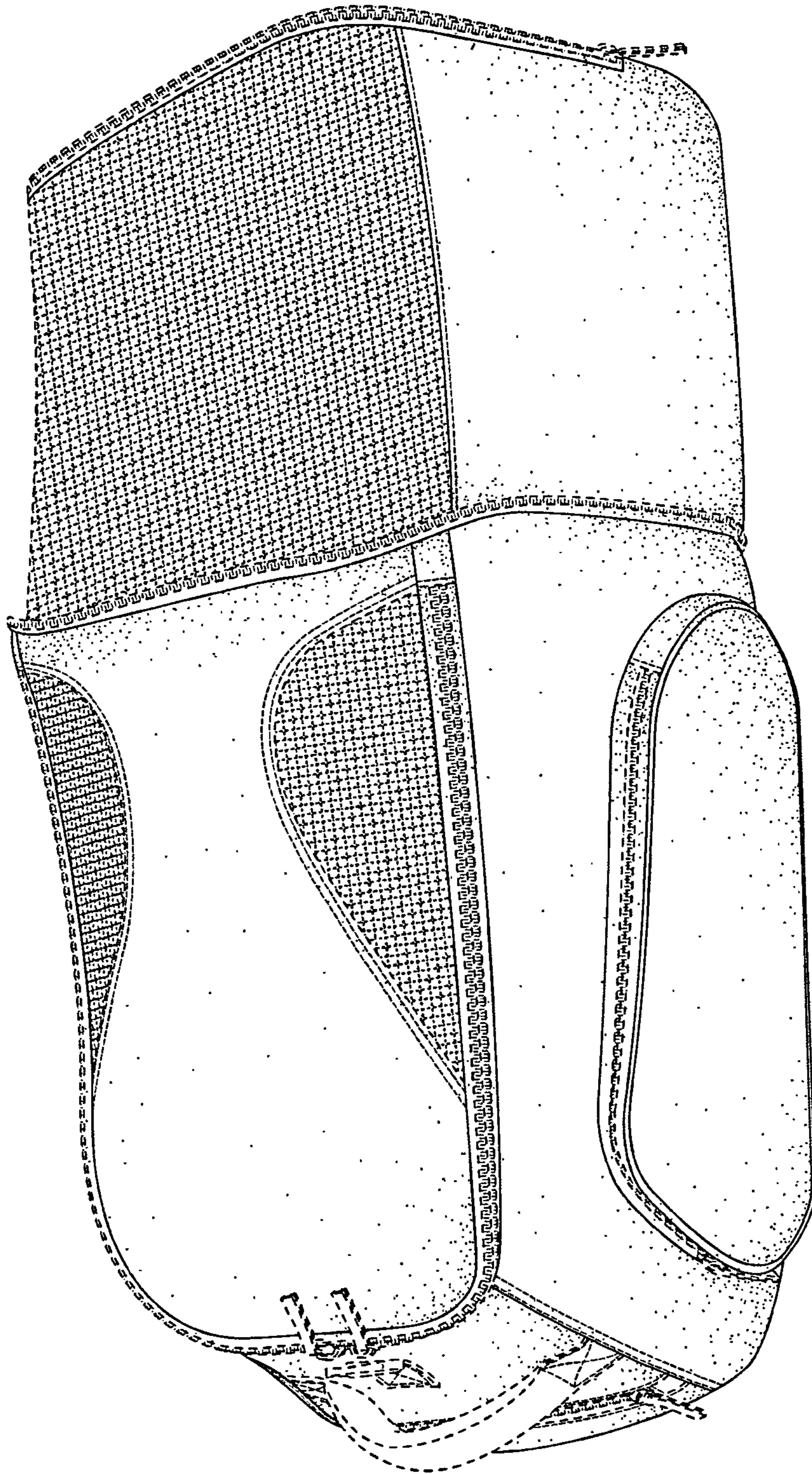

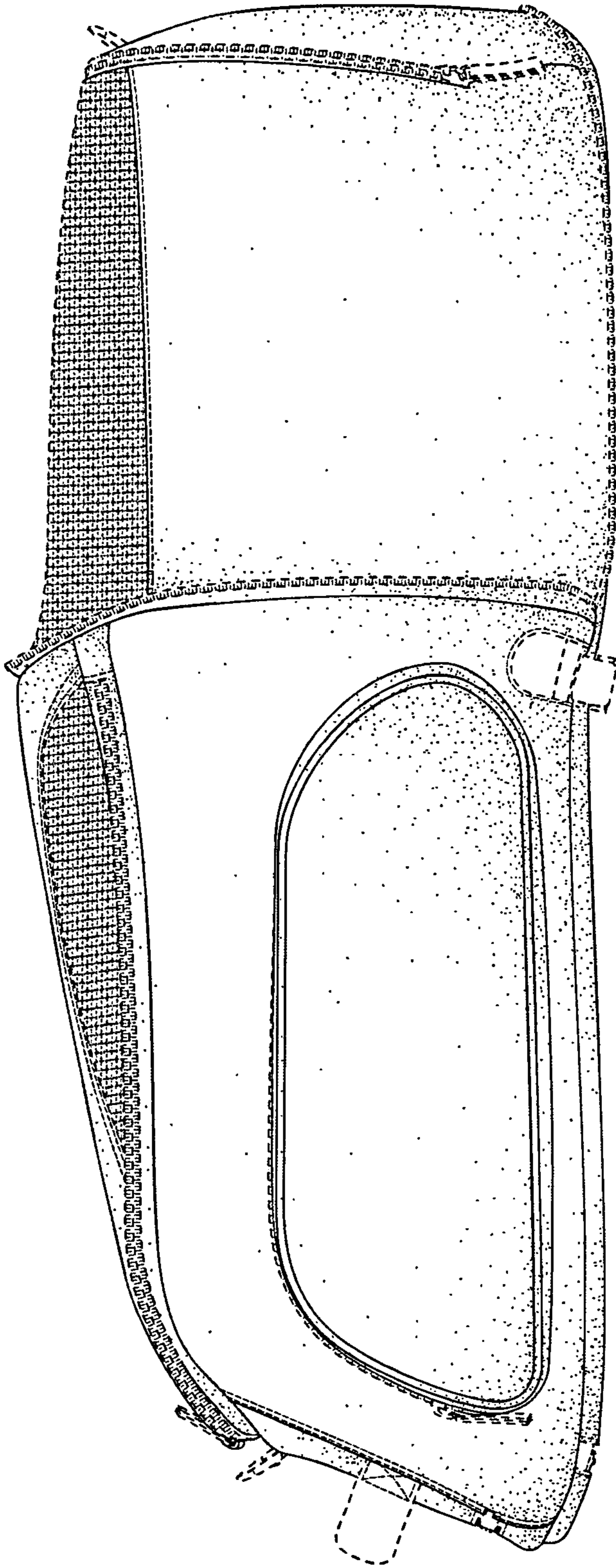

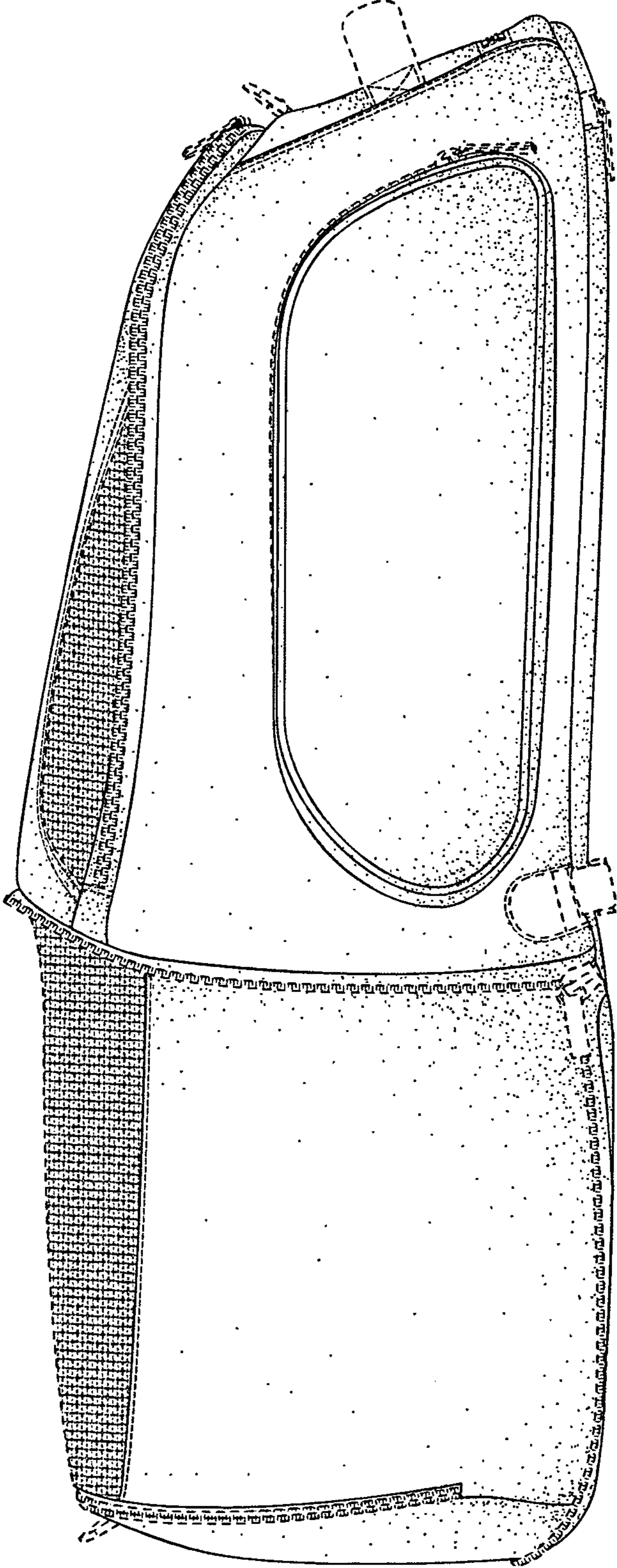

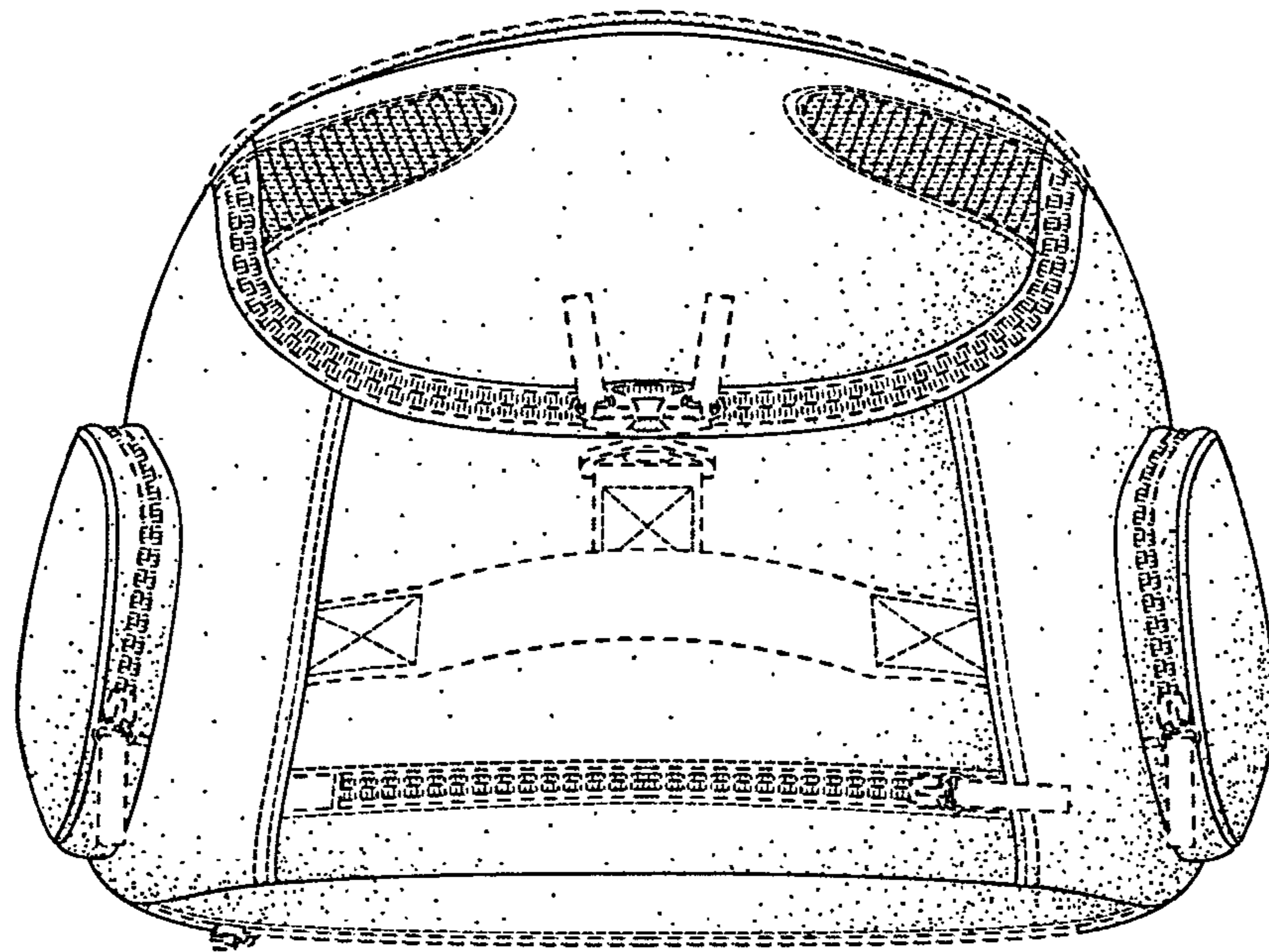

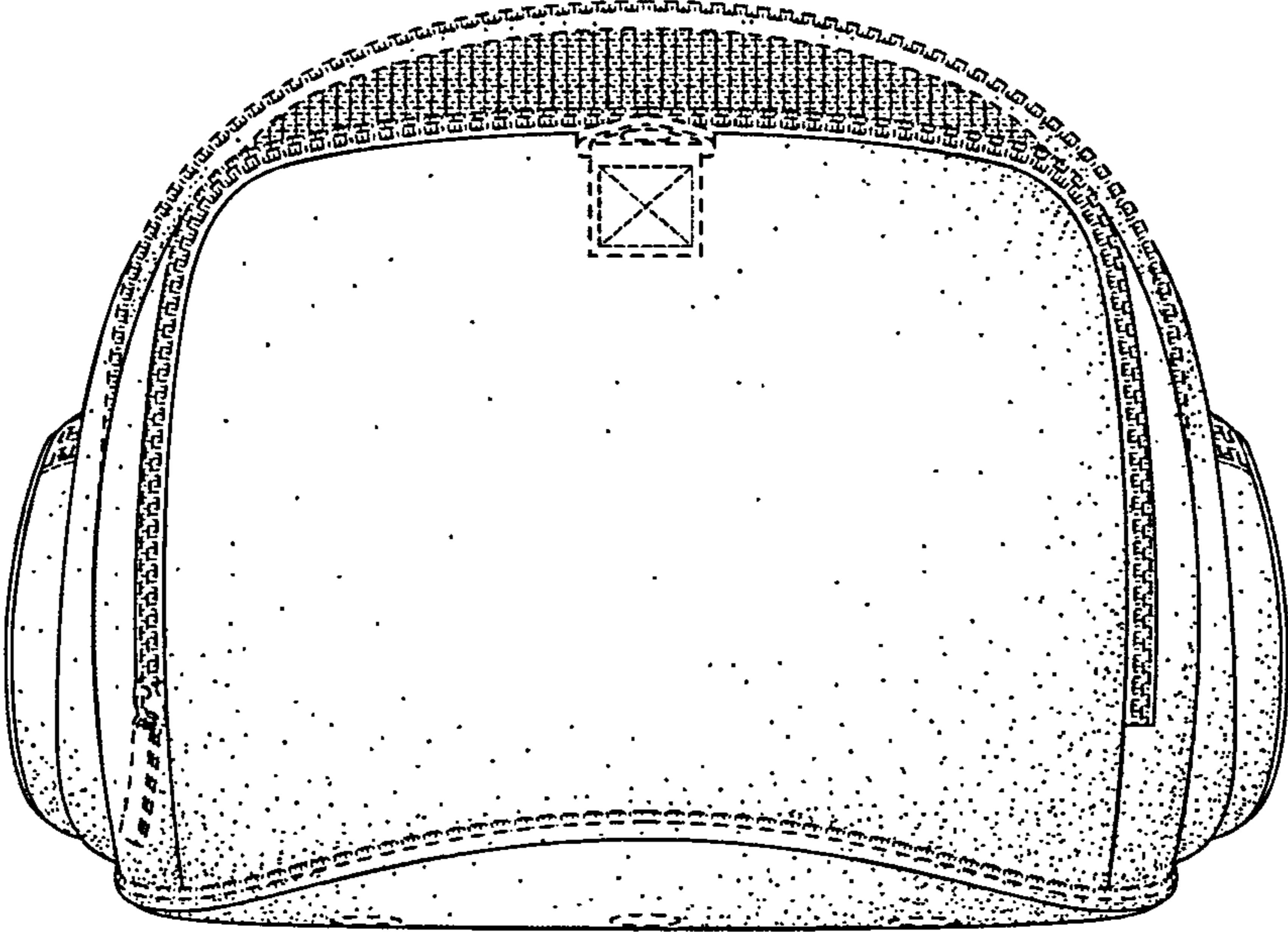

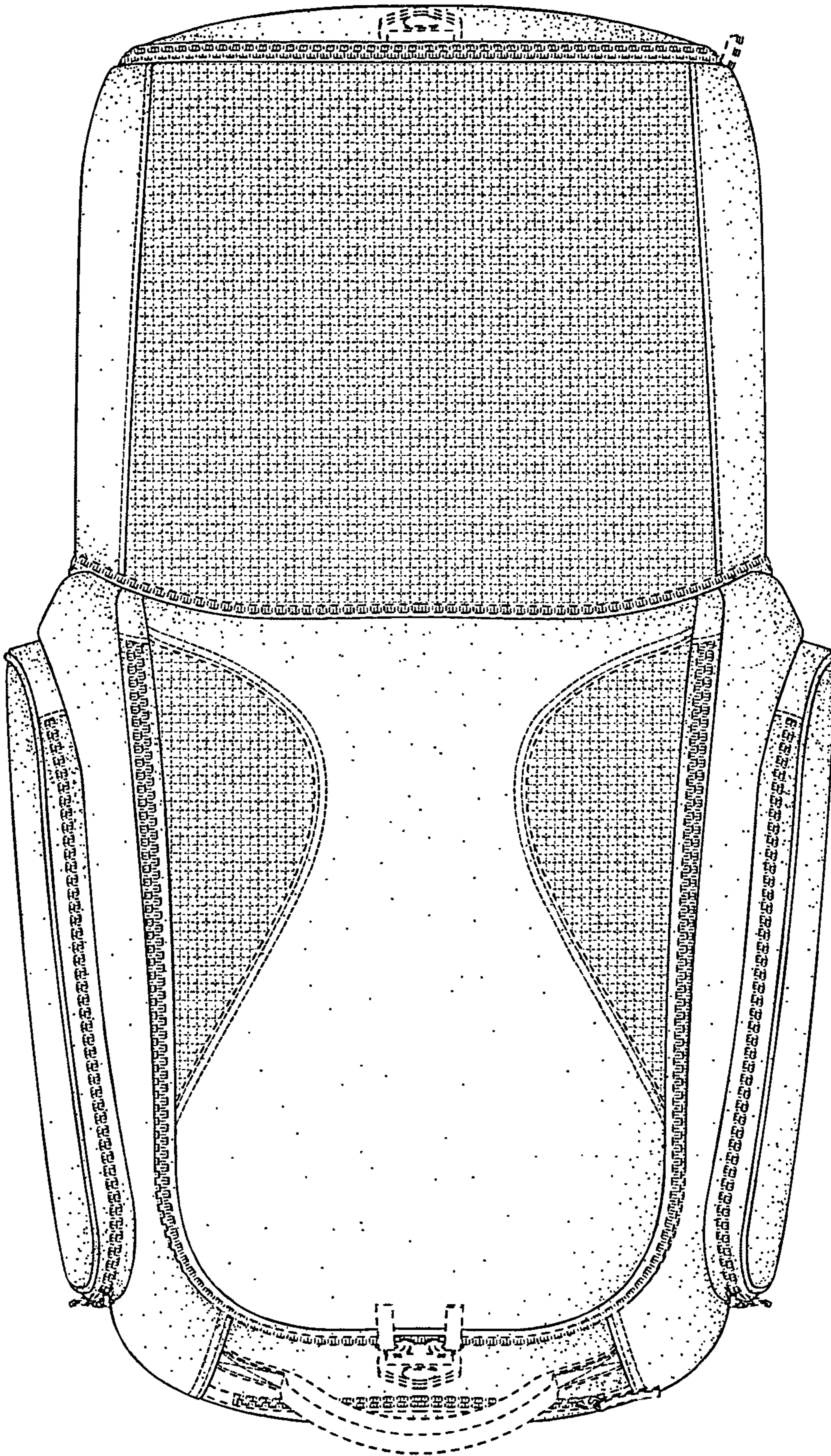

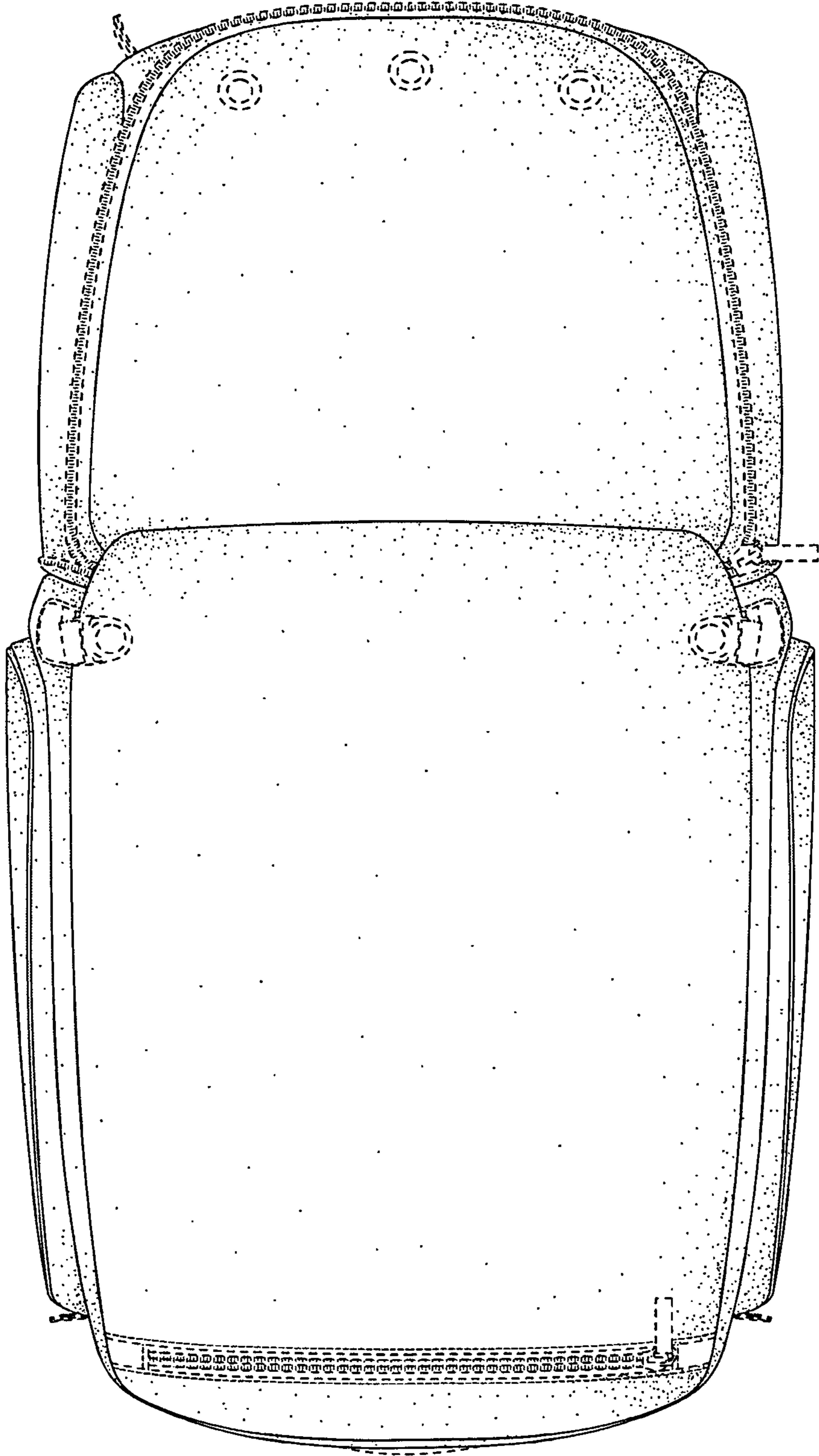
