FIG. 4 is a top side view of the bed, according to the embodiment;

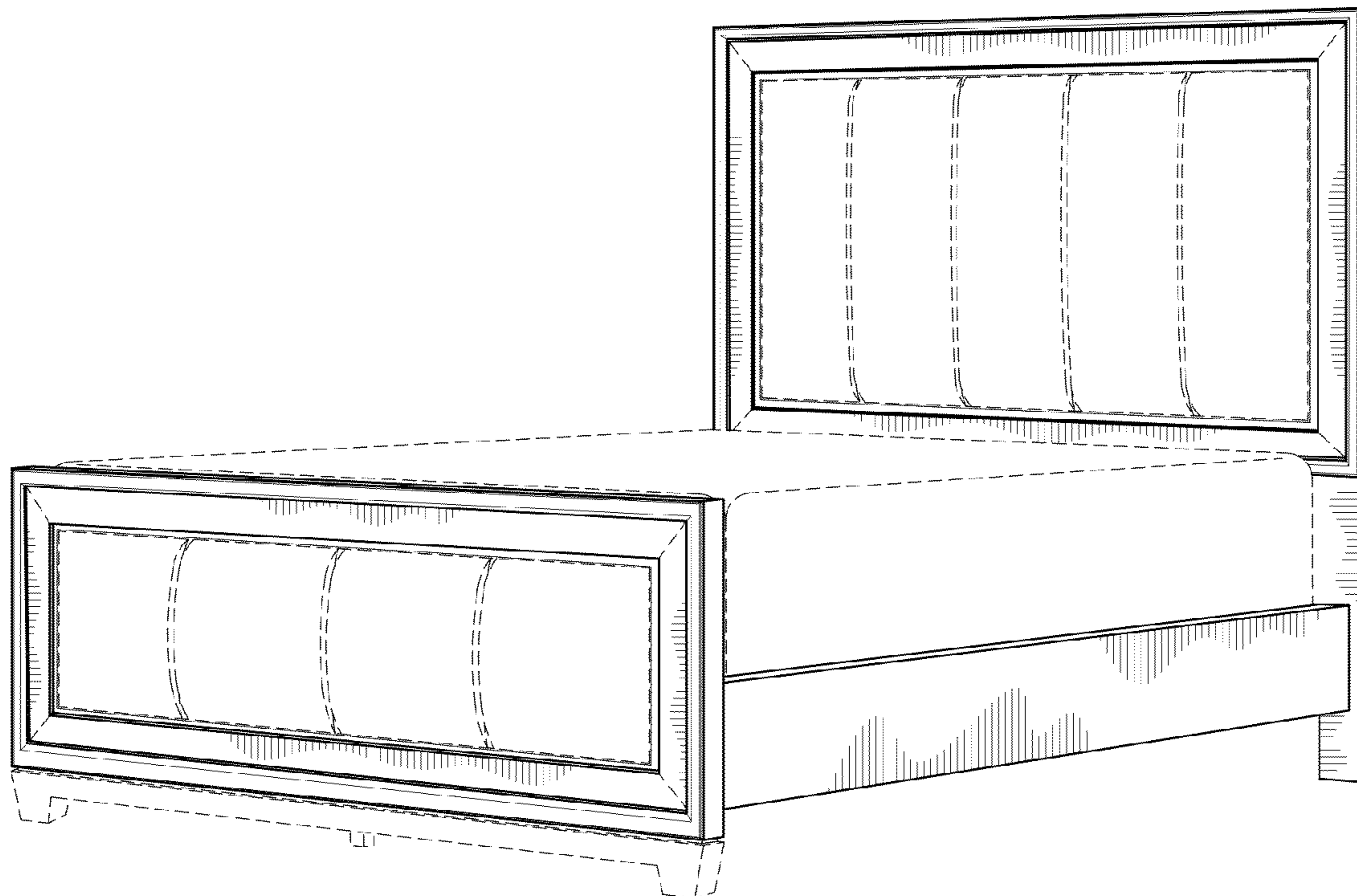
FIG. 5 is a right side view of the bed, according to the embodiment;

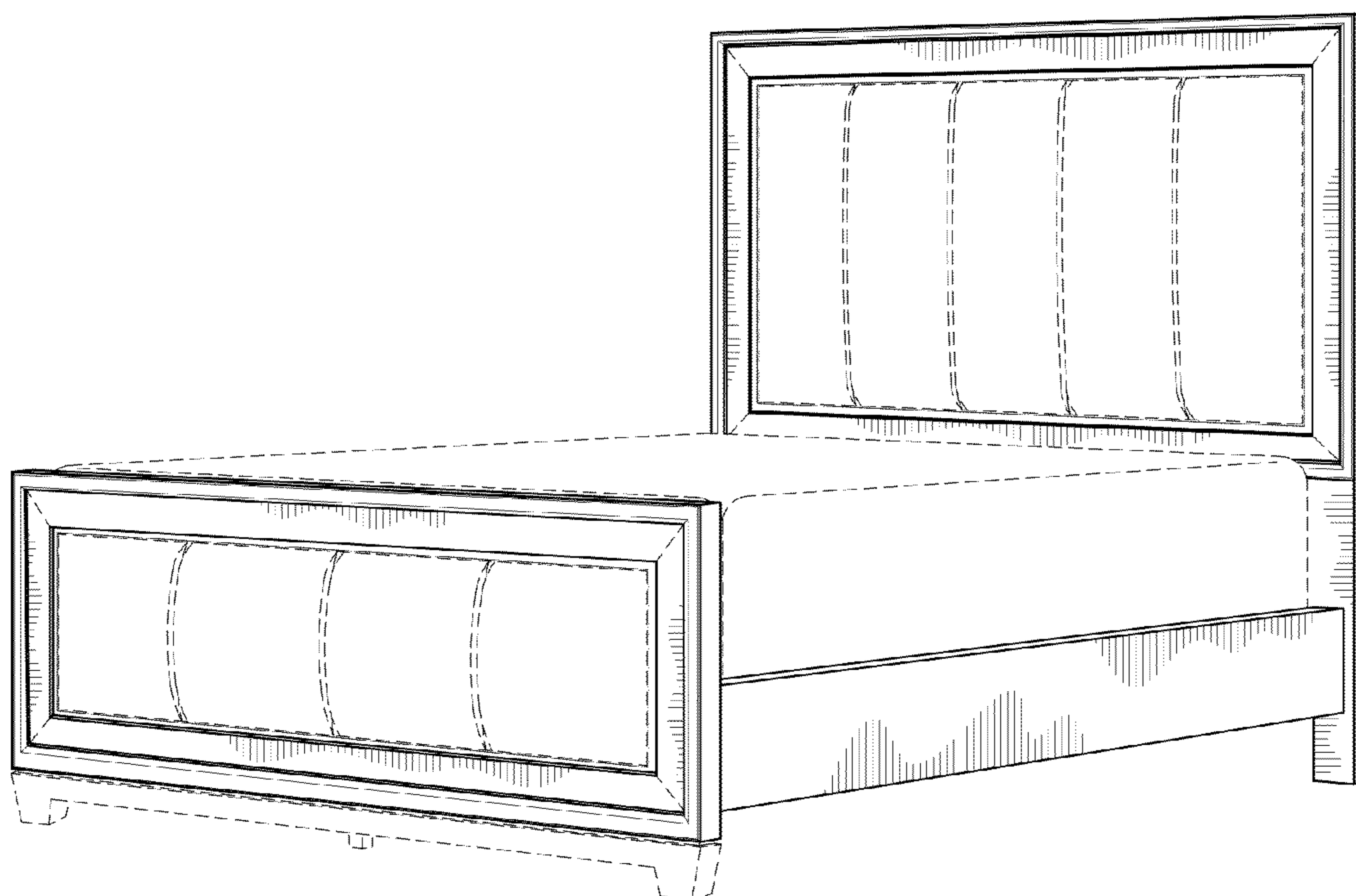

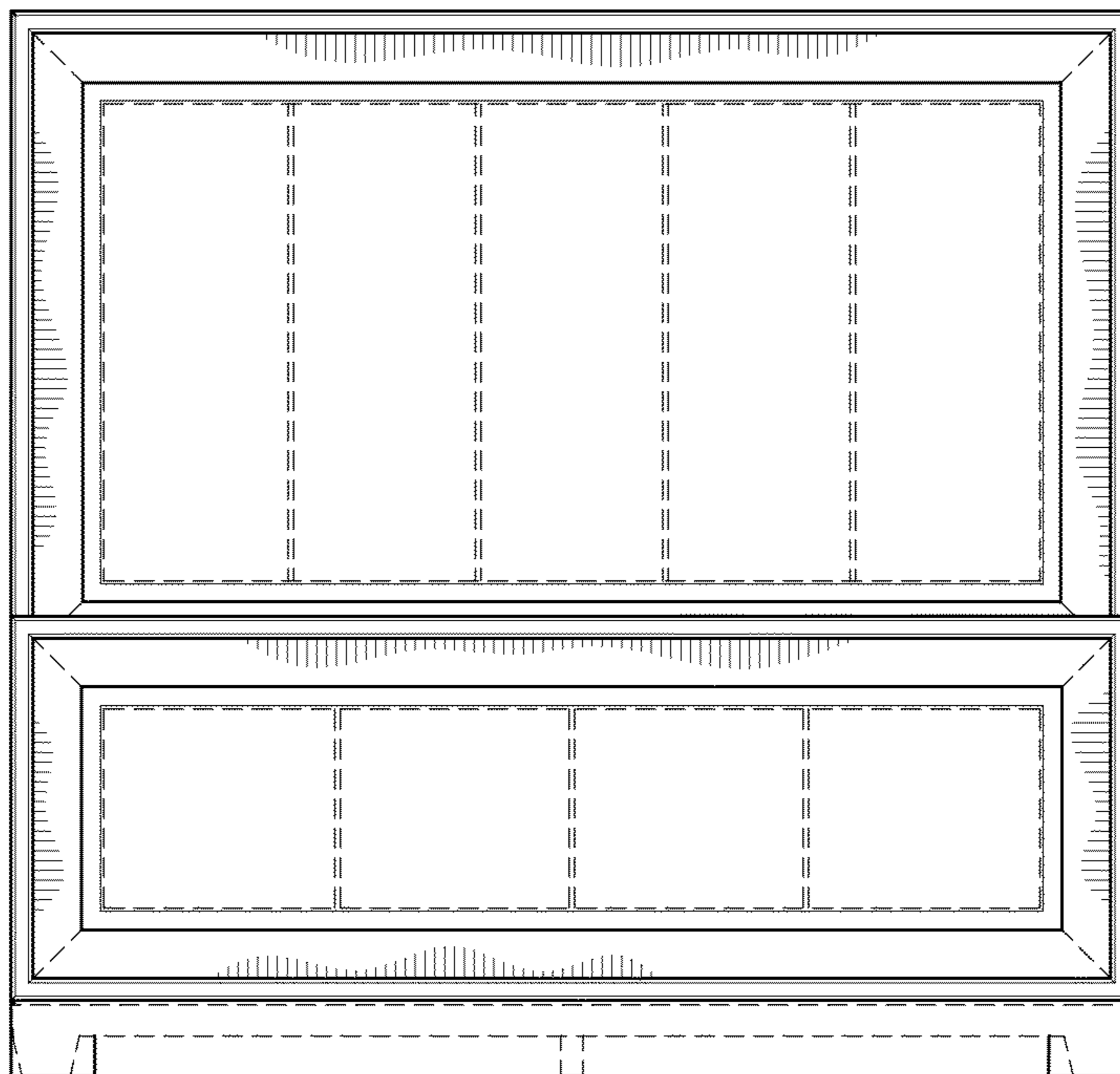

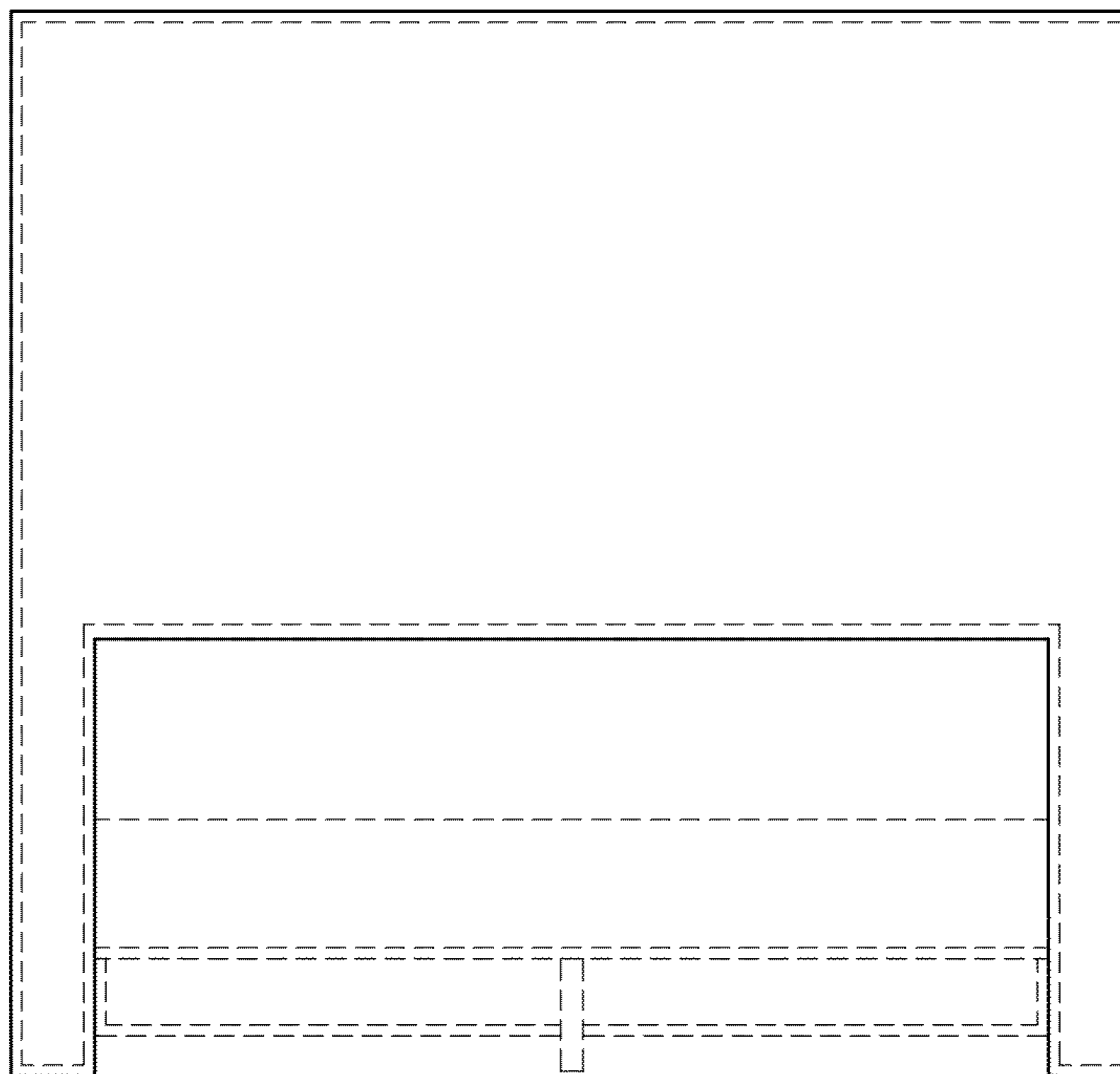

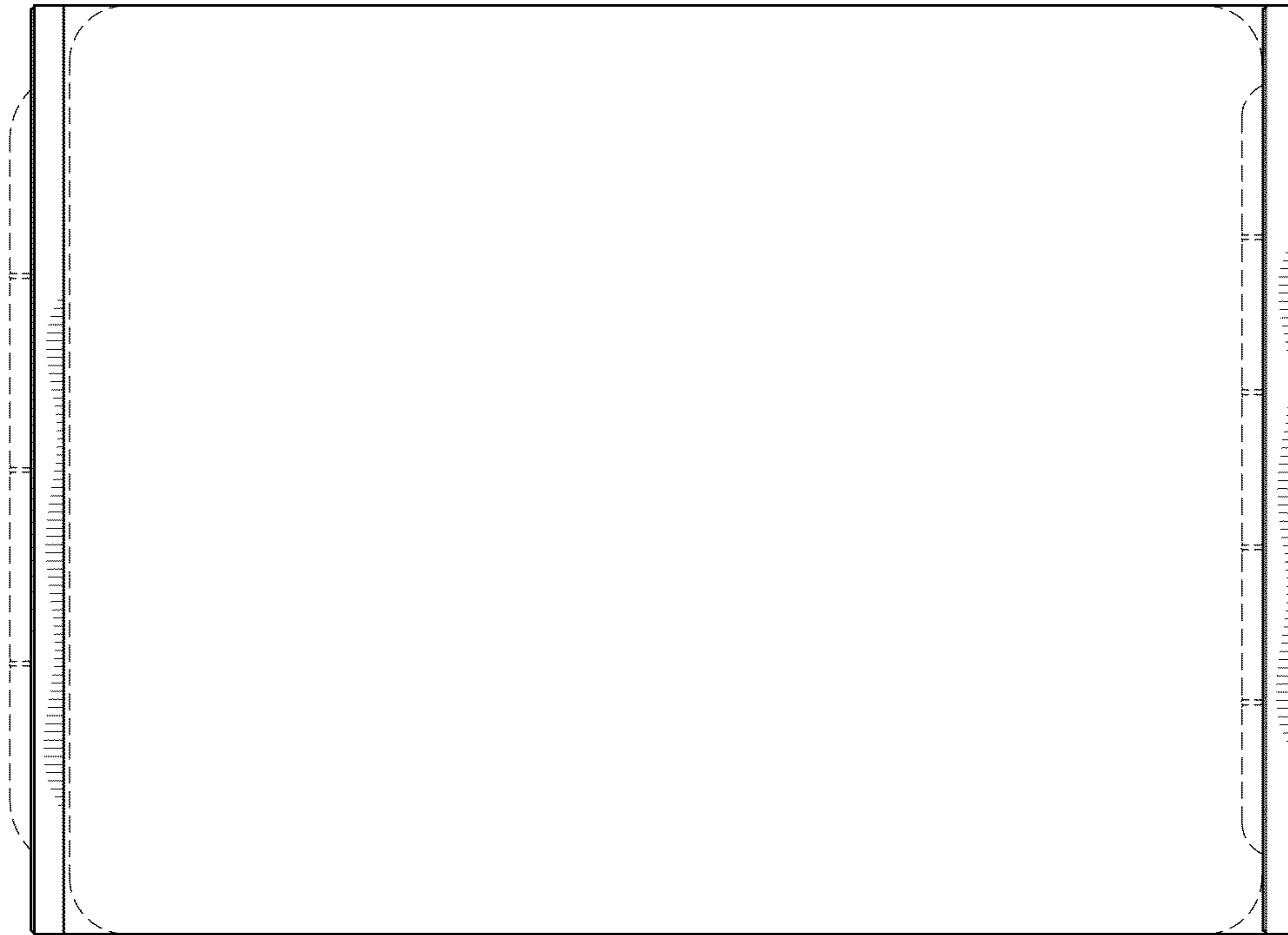

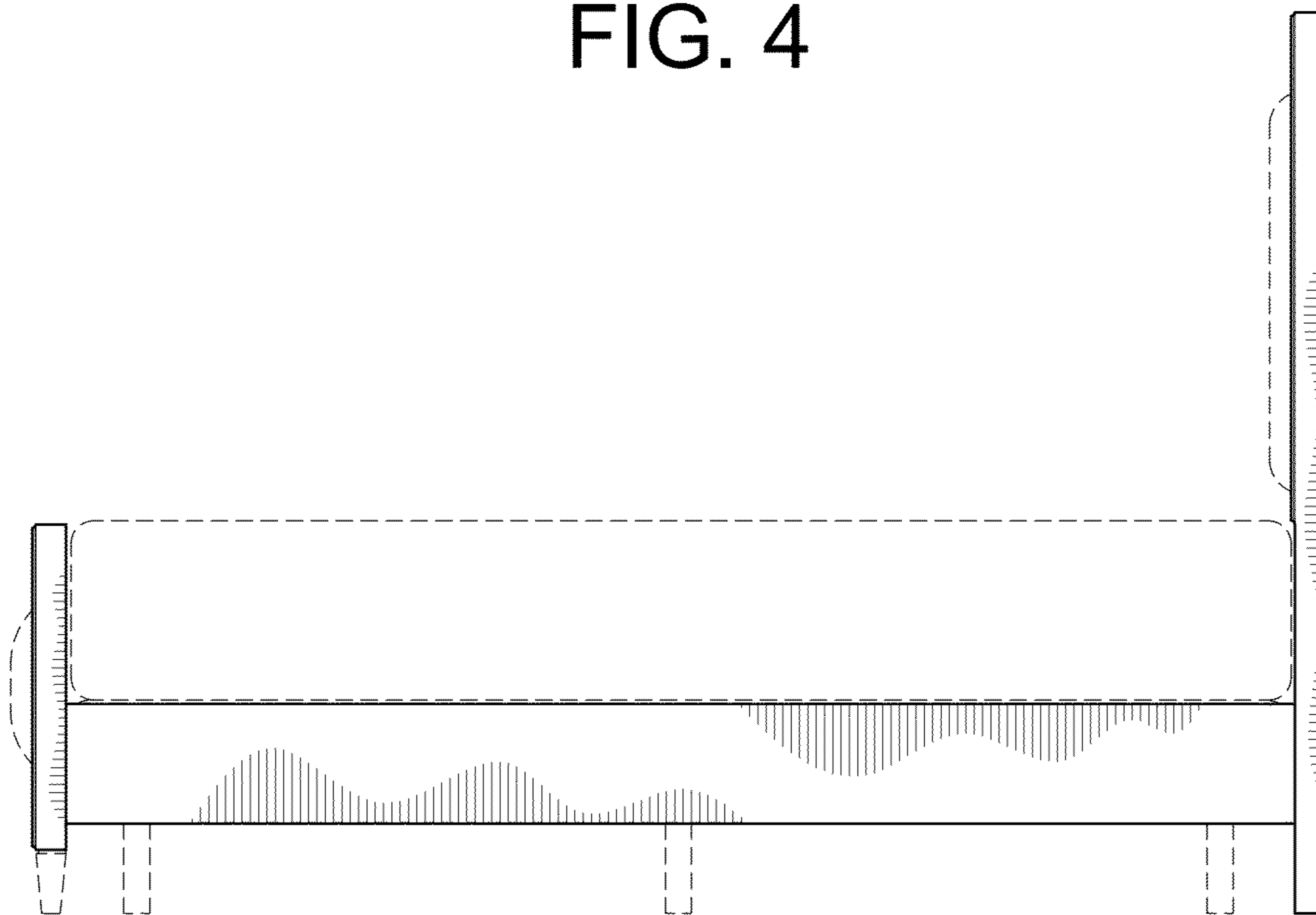

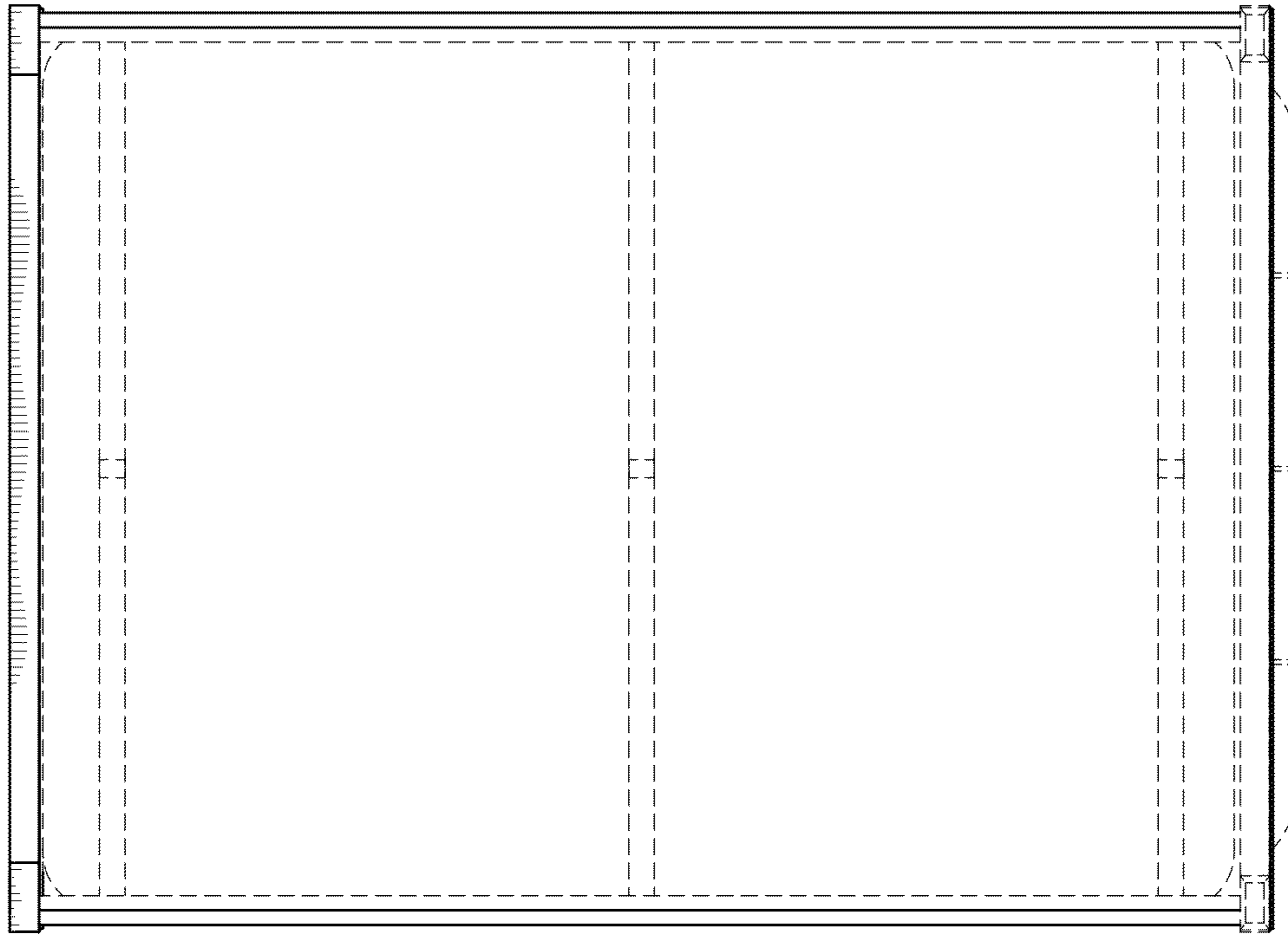

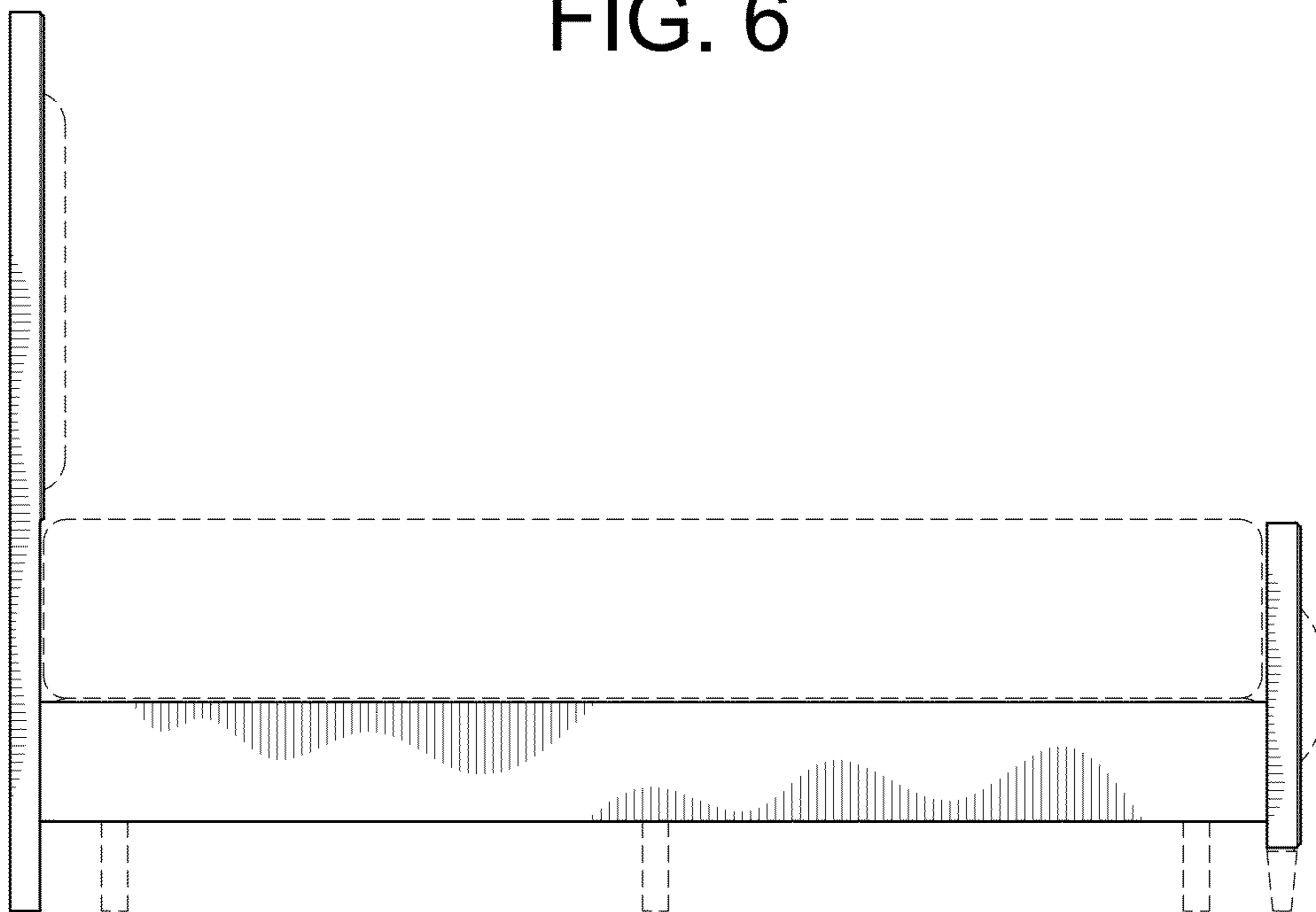
