DESCRIPTION

FIG. 5 is a front view of the table top shown in FIG. 1;

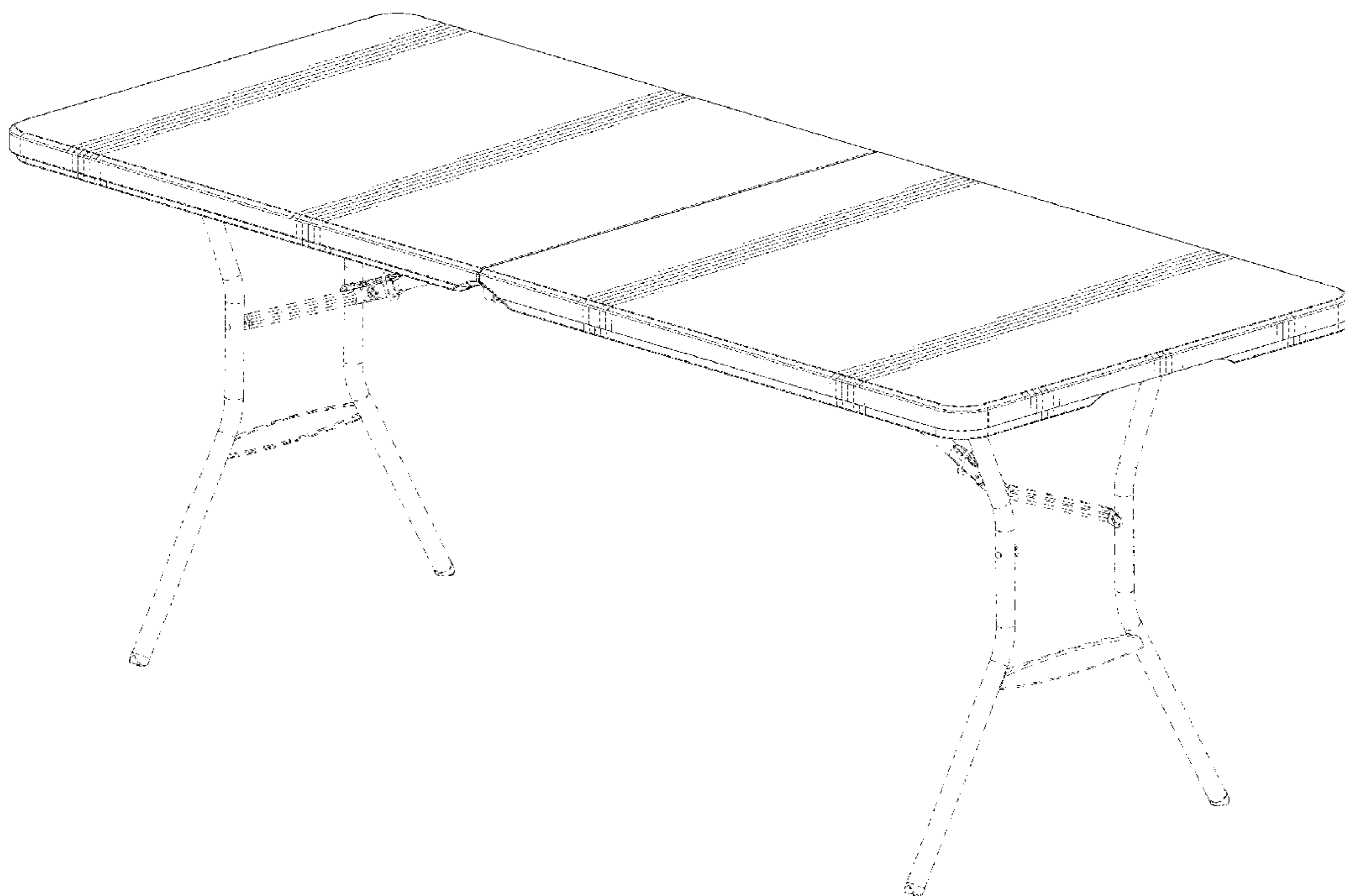
FIG. 6 is a bottom view of the table top shown in FIG. 1;

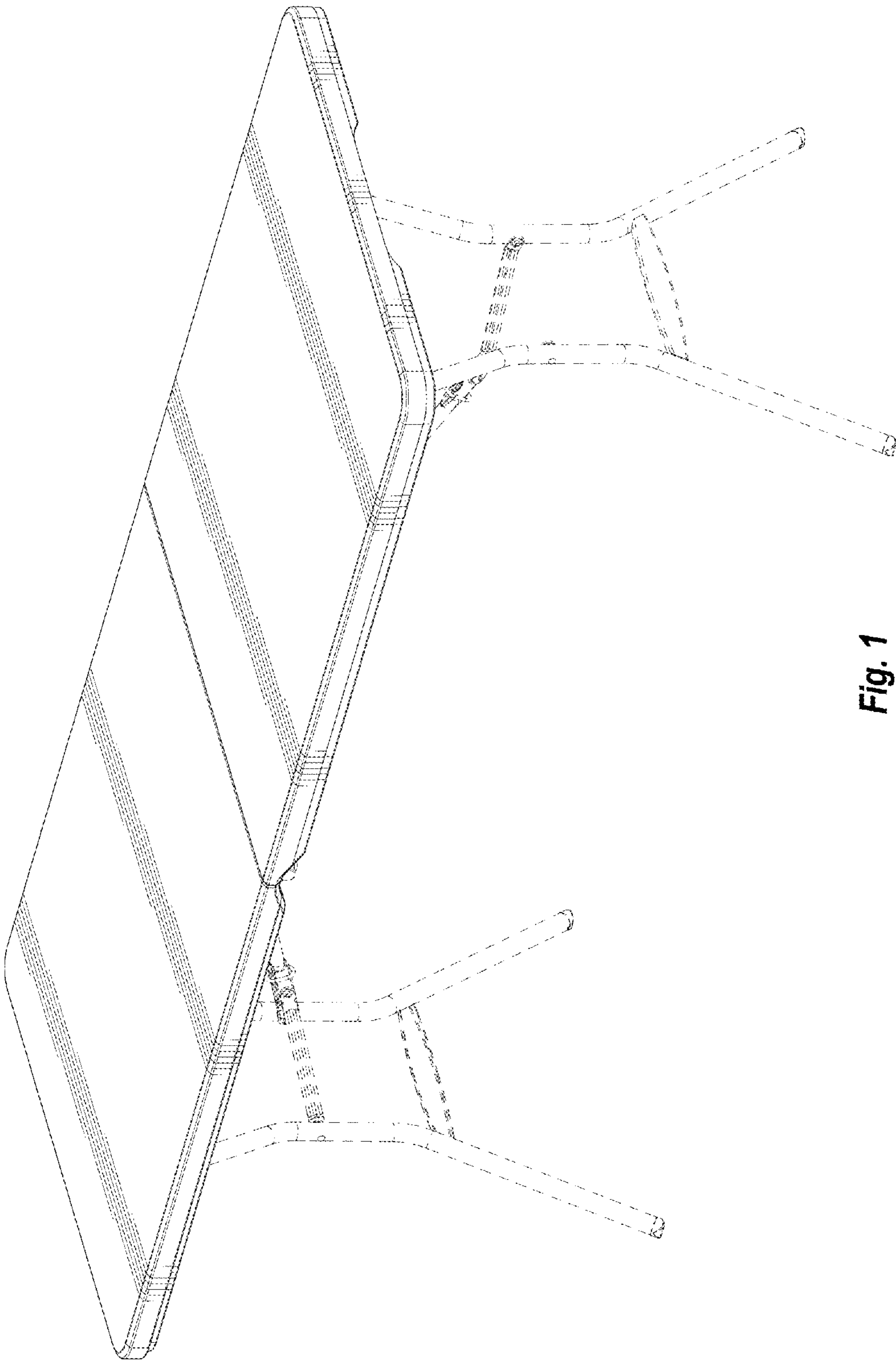

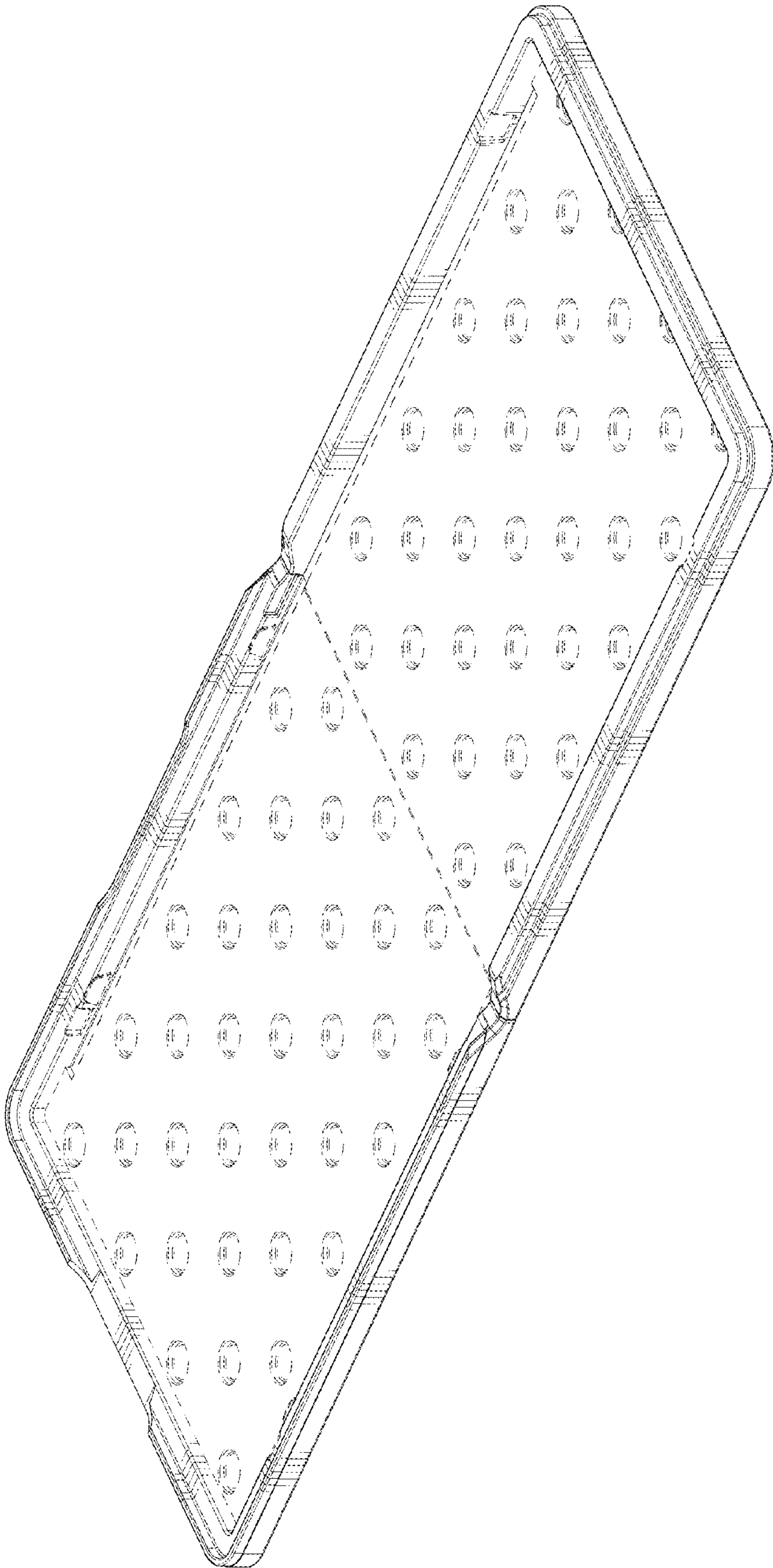

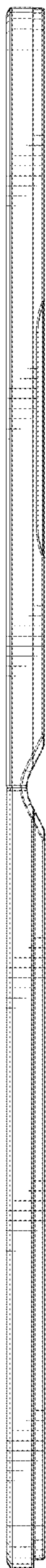

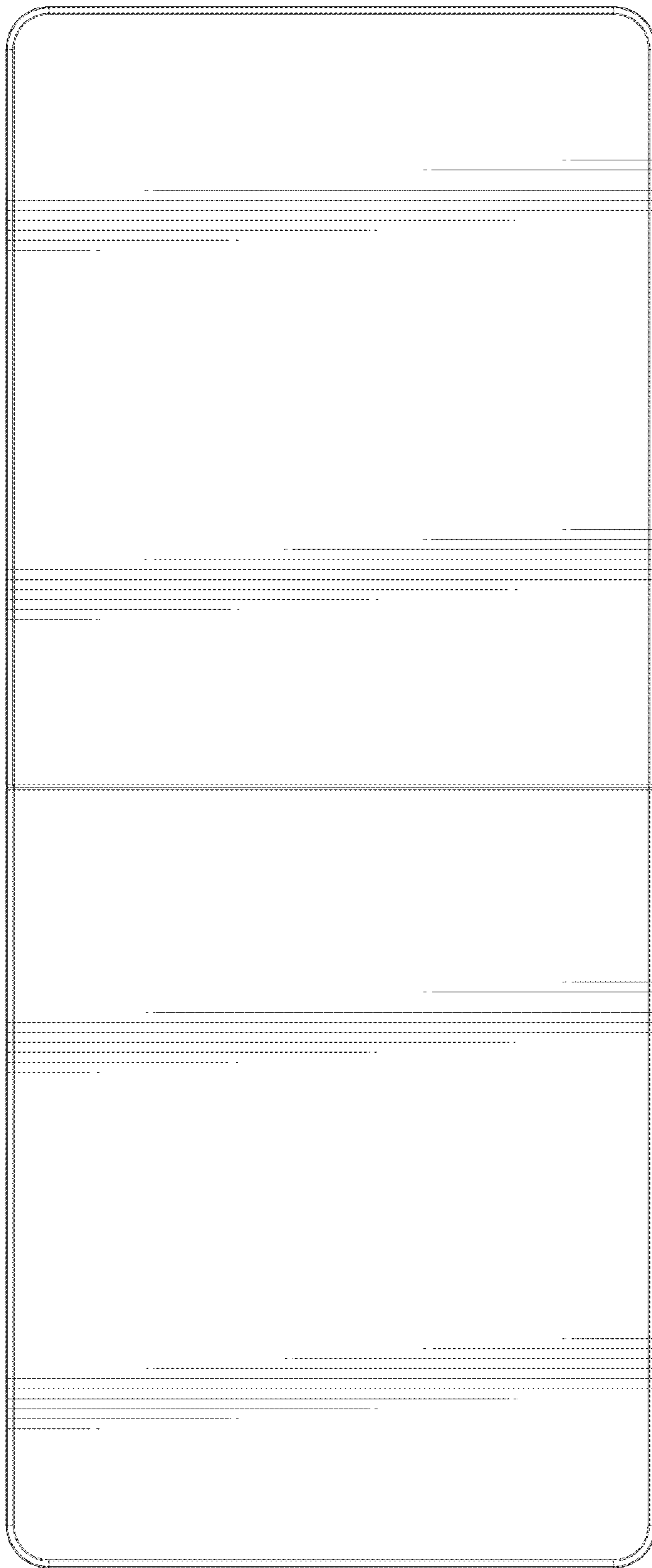

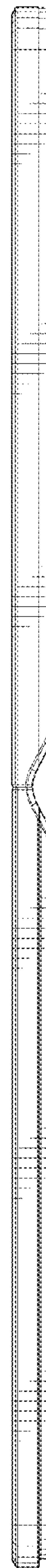

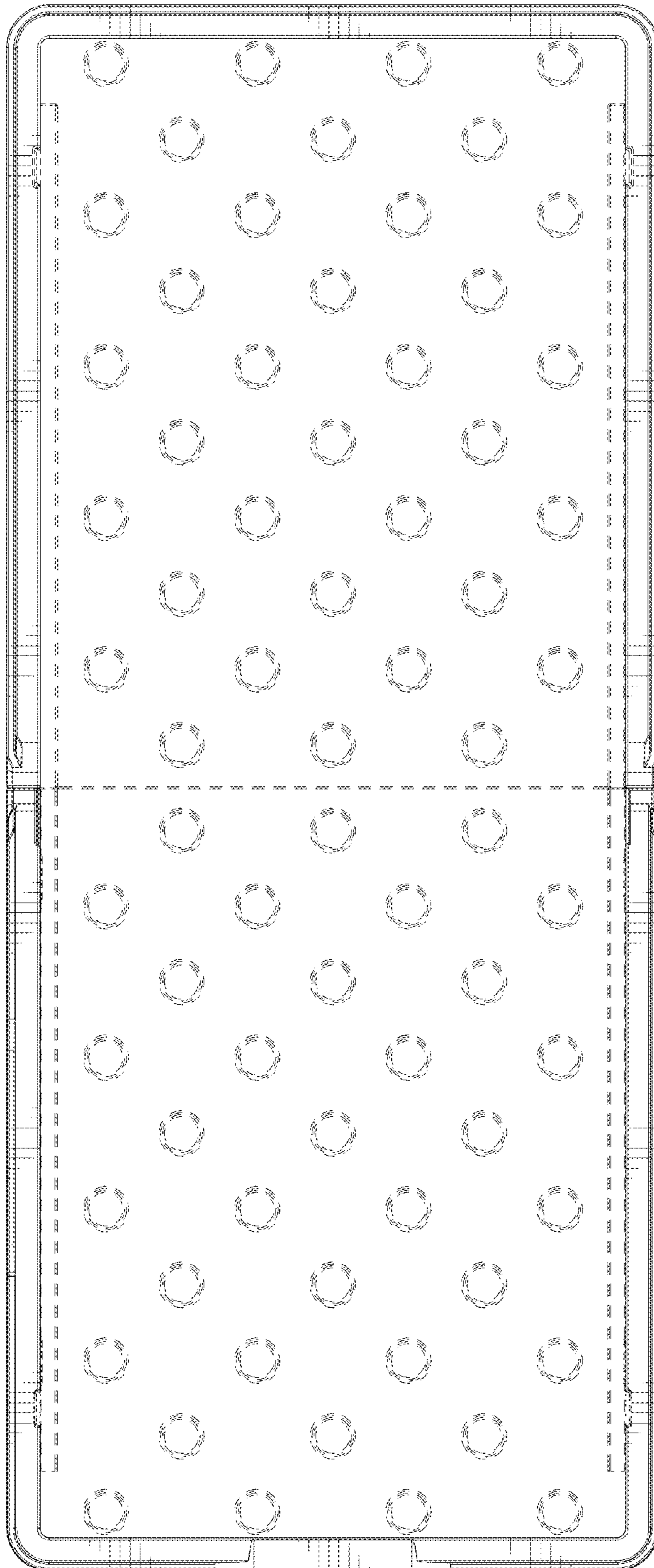

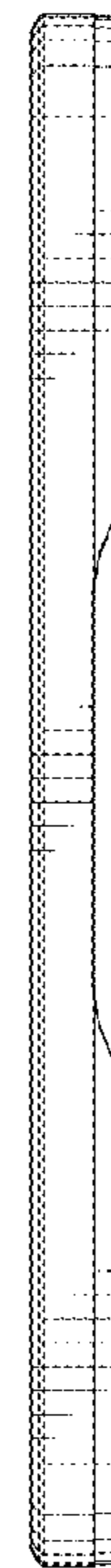

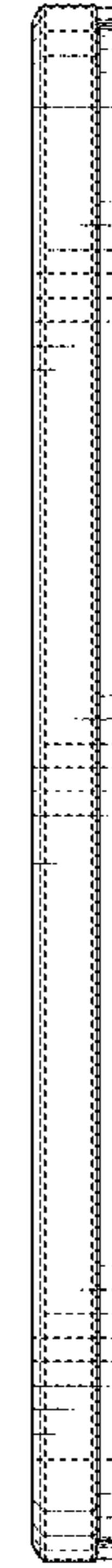
