The ornamental designs for a combined game coin and package, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the combined game coin and package of the present invention.

FIG. 2 is a rear view of the combined game coin and package of FIGS. 1 and 2.

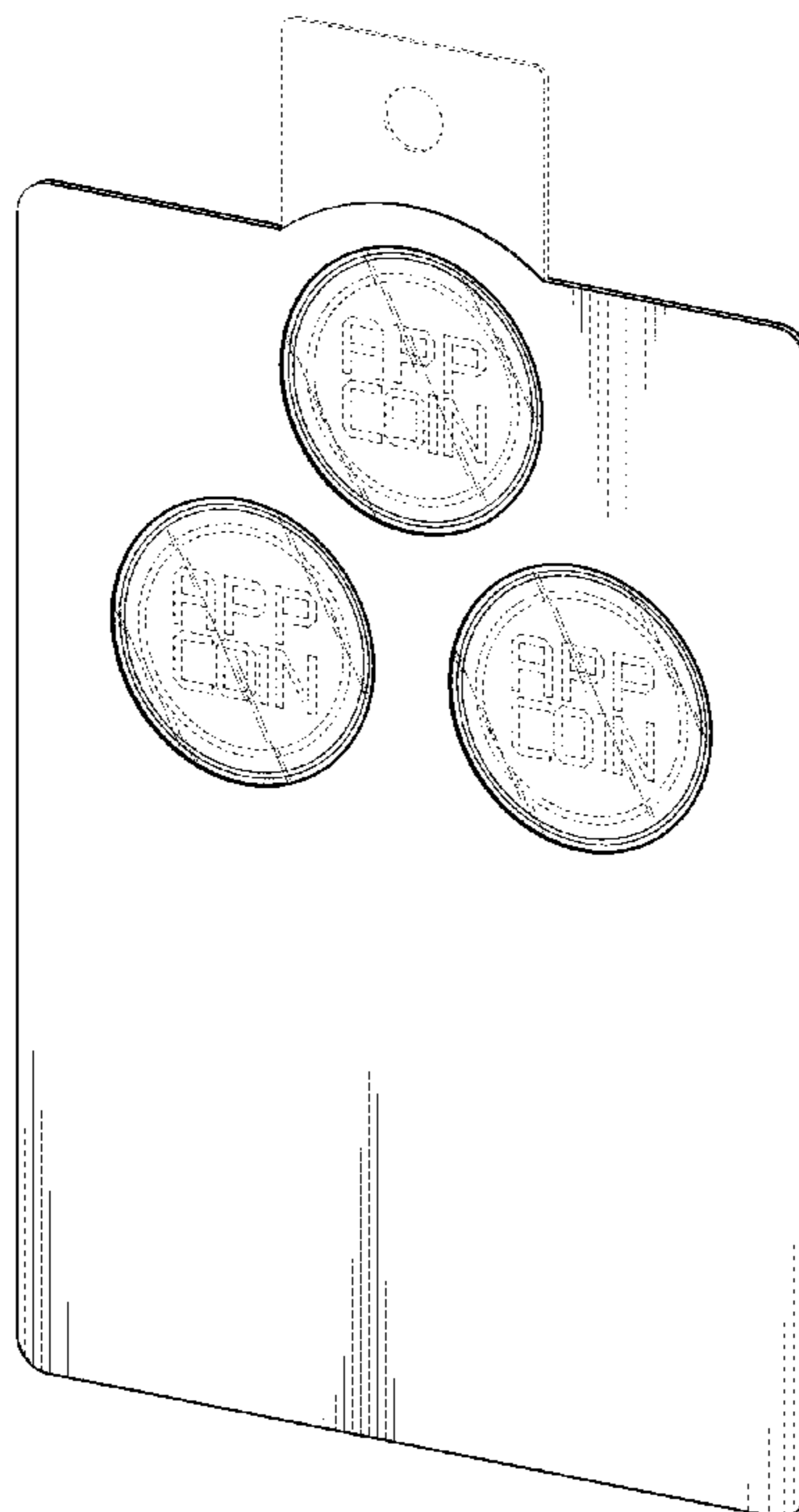
FIG. 3 is a right side view of the combined game coin and package of FIGS. 1 and 2, the left side view being identical thereto.

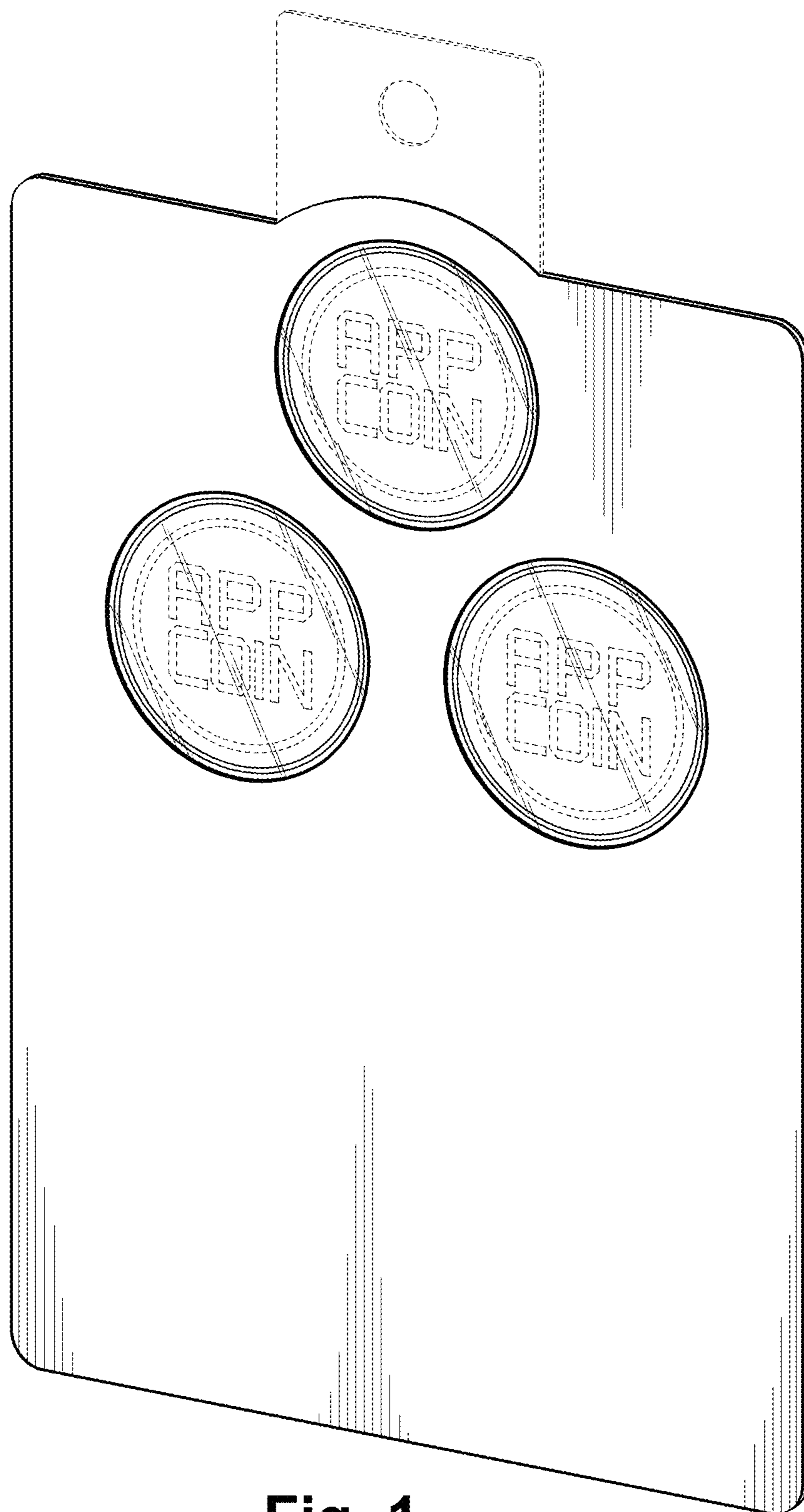

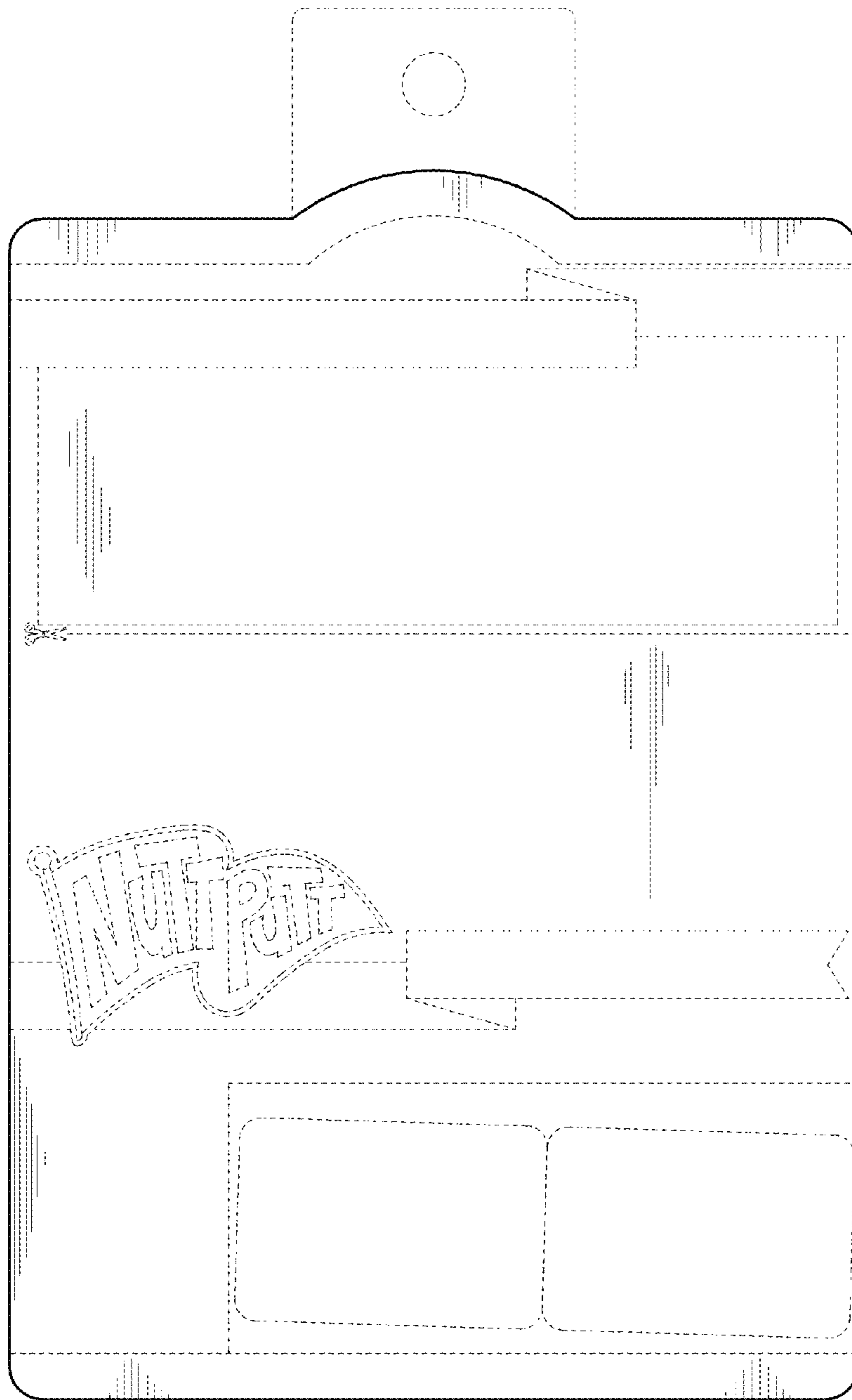

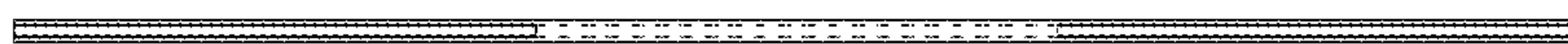
