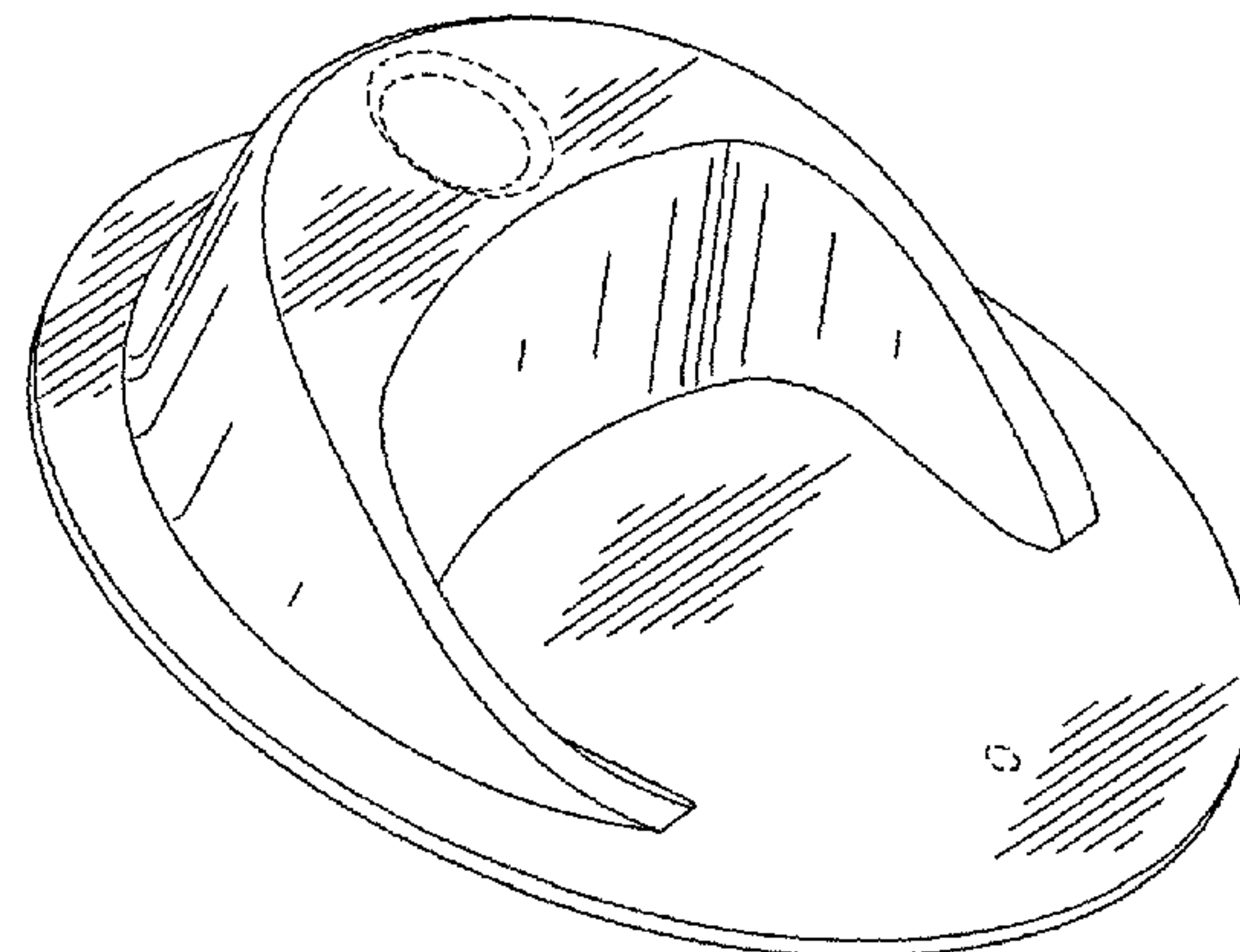
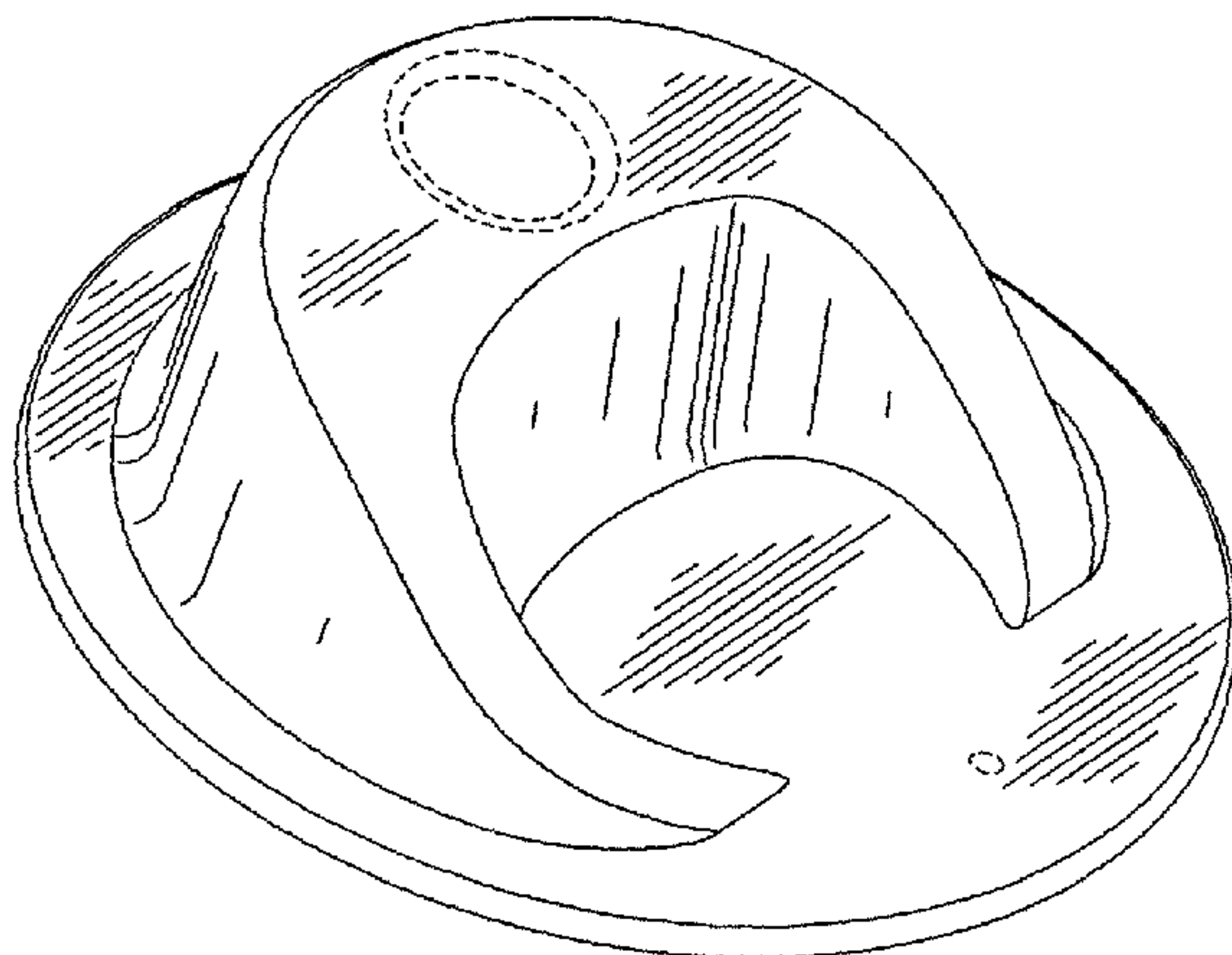
(57) **CLAIM**

The ornamental design for a jar lid, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left rear perspective view of a first embodiment of the jar lid;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a left side view thereof which is a mirror image of the right side view;  
FIG. 4 is a bottom plan view thereof;  
FIG. 5 is a rear view thereof;  
FIG. 6 is a front view thereof;  
FIG. 7 is a top left rear perspective view of a second embodiment of the jar lid  
FIG. 8 is a top plan view thereof;

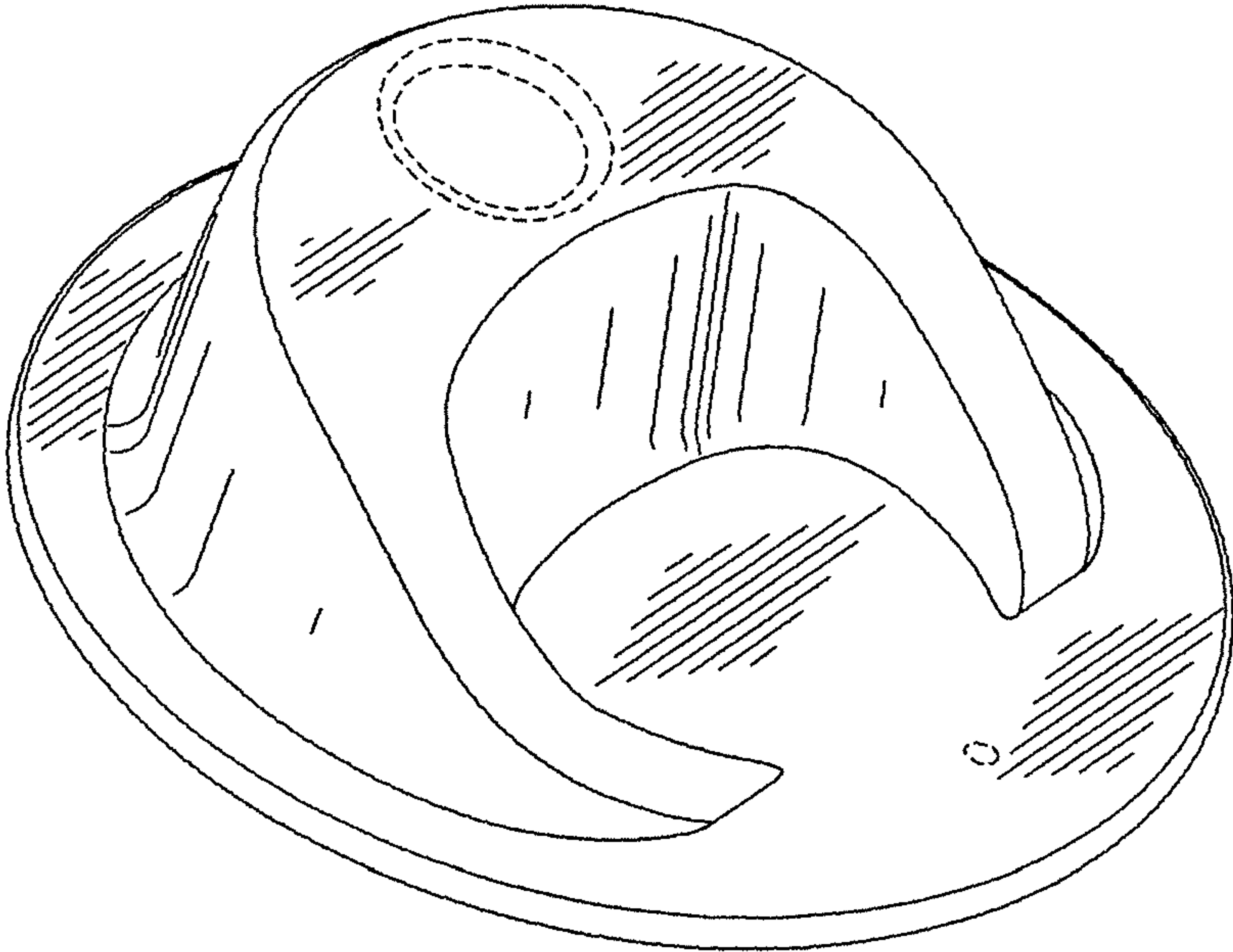

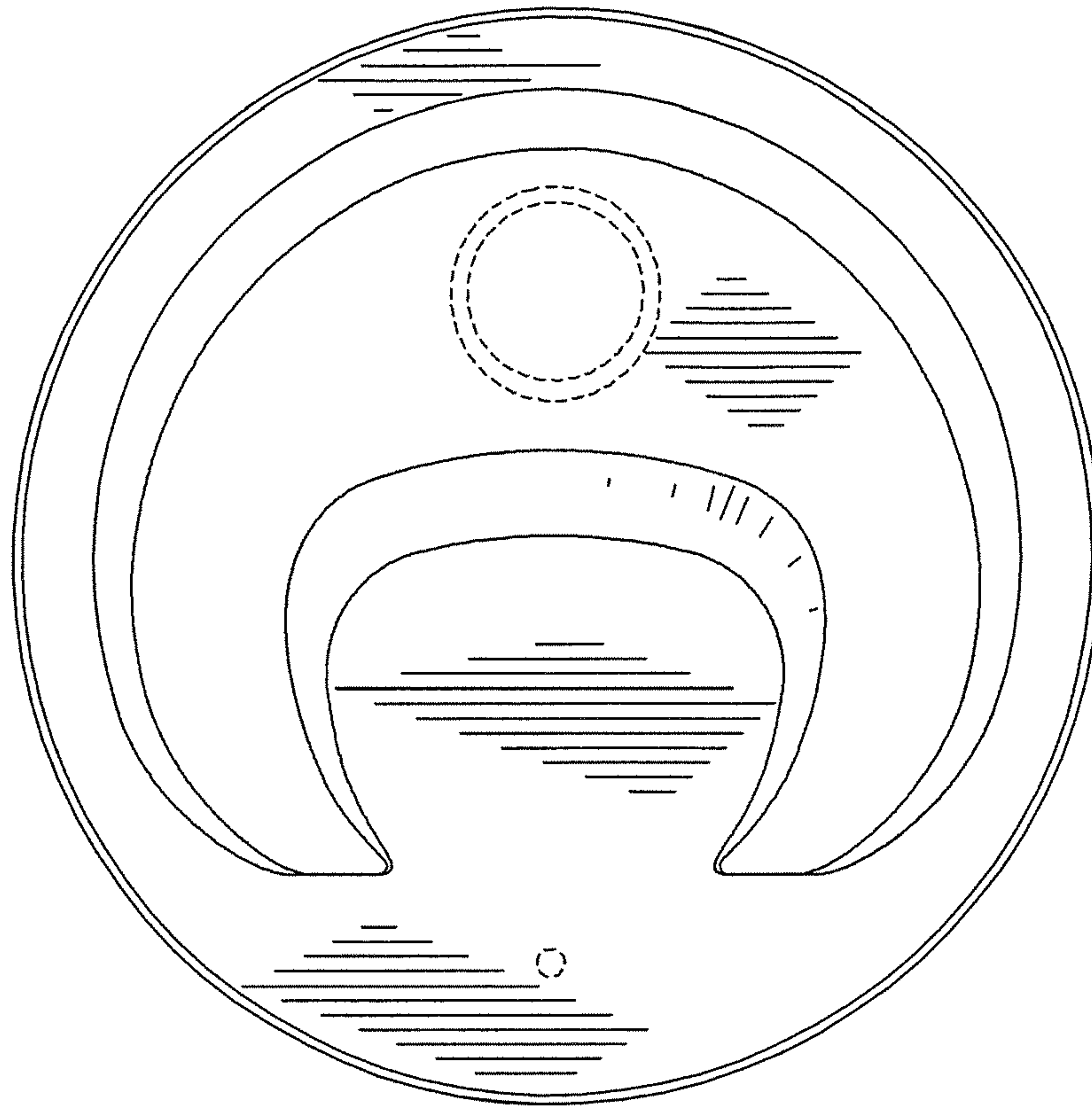

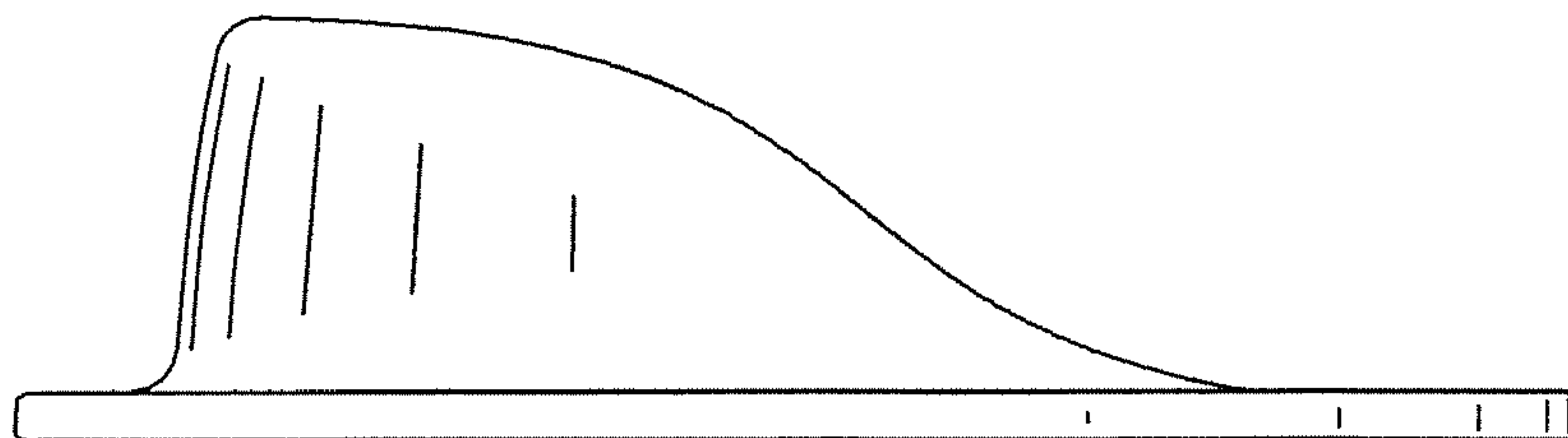

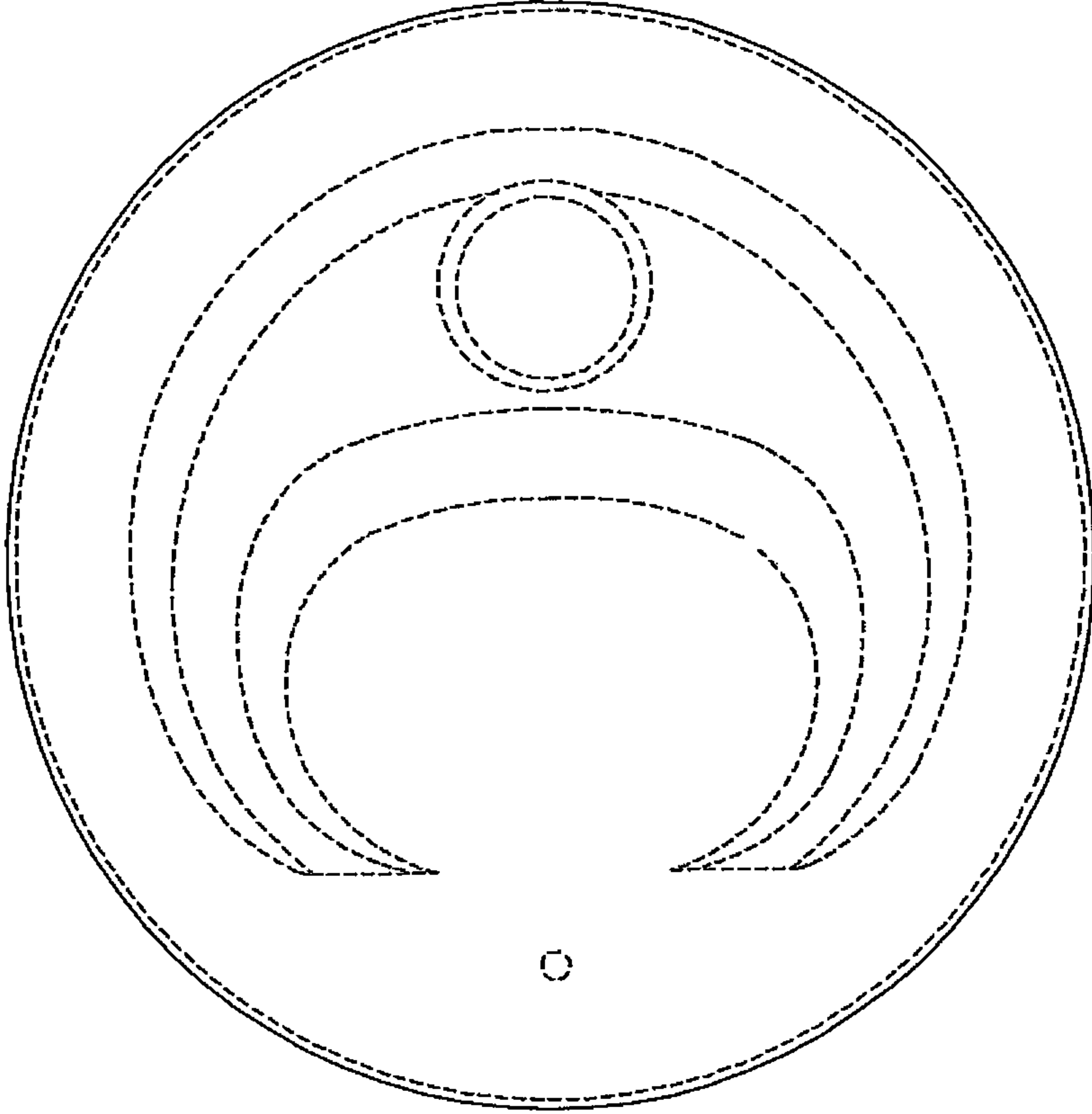

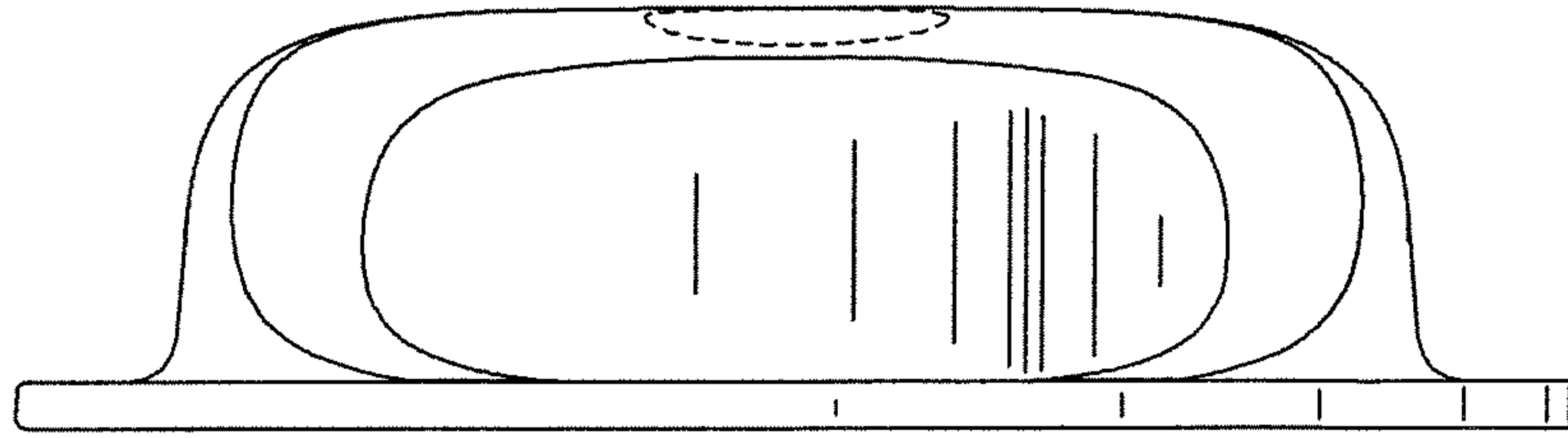

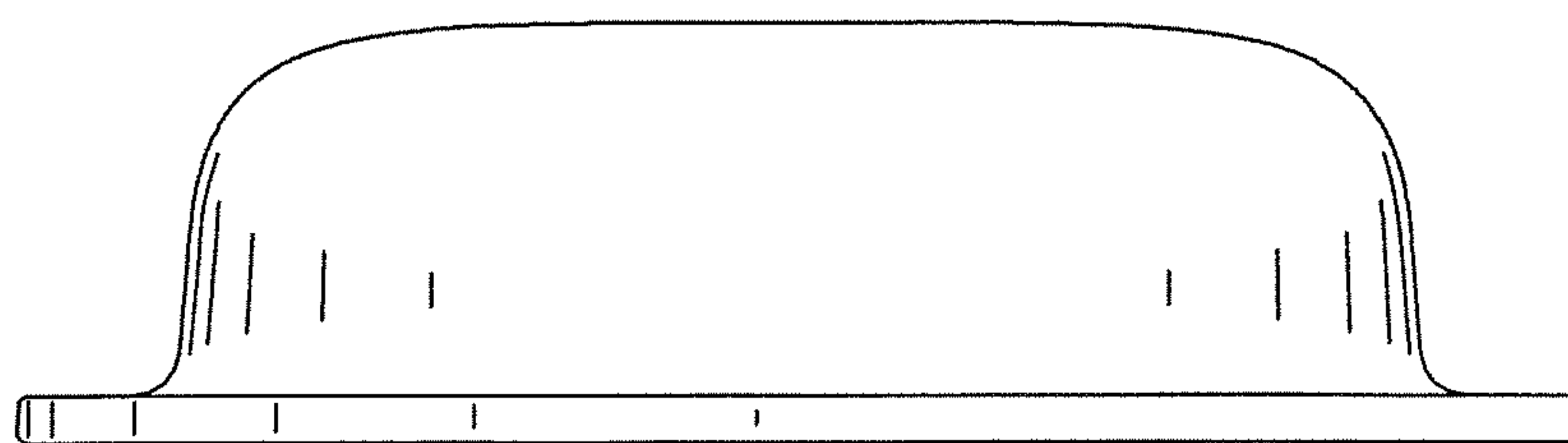

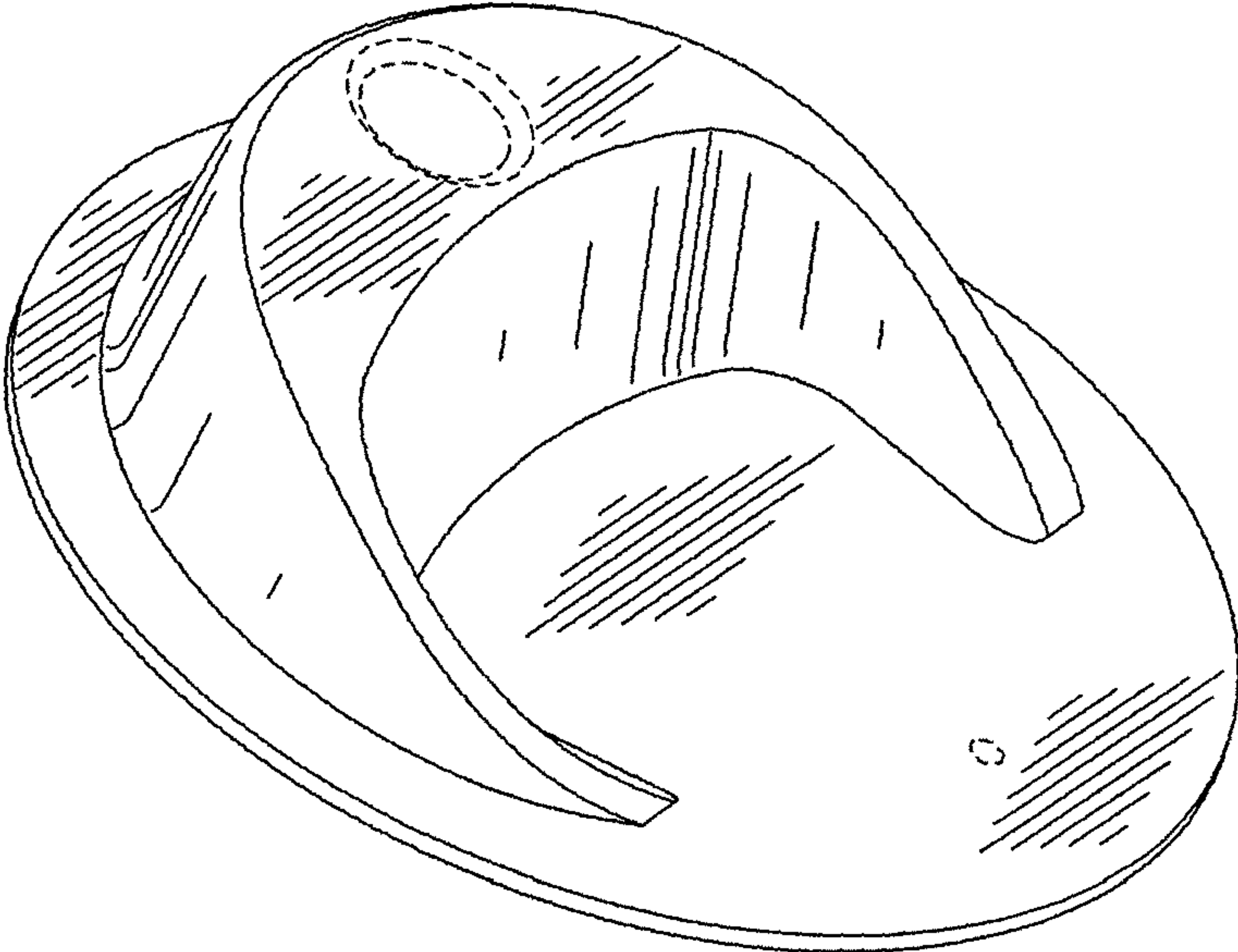

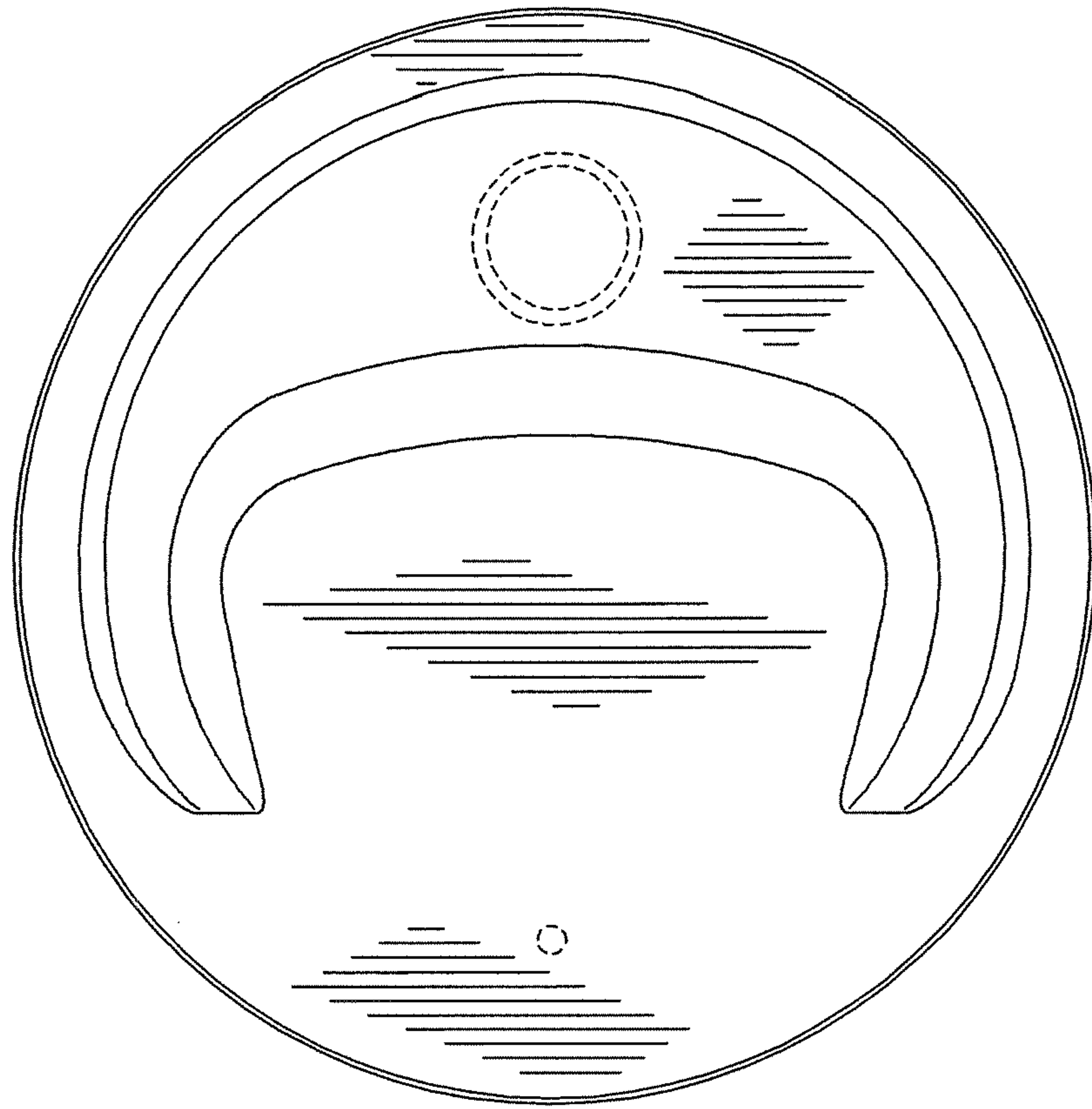

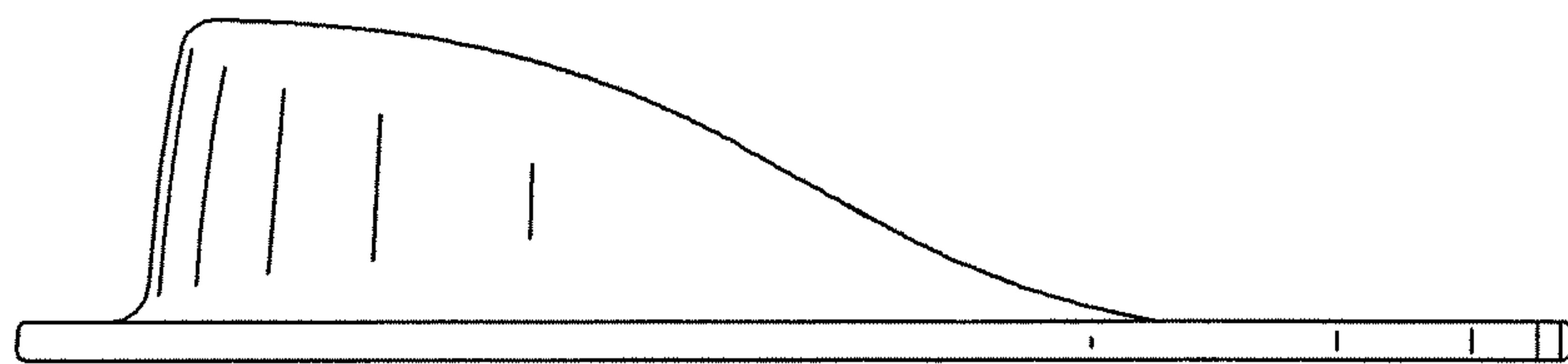

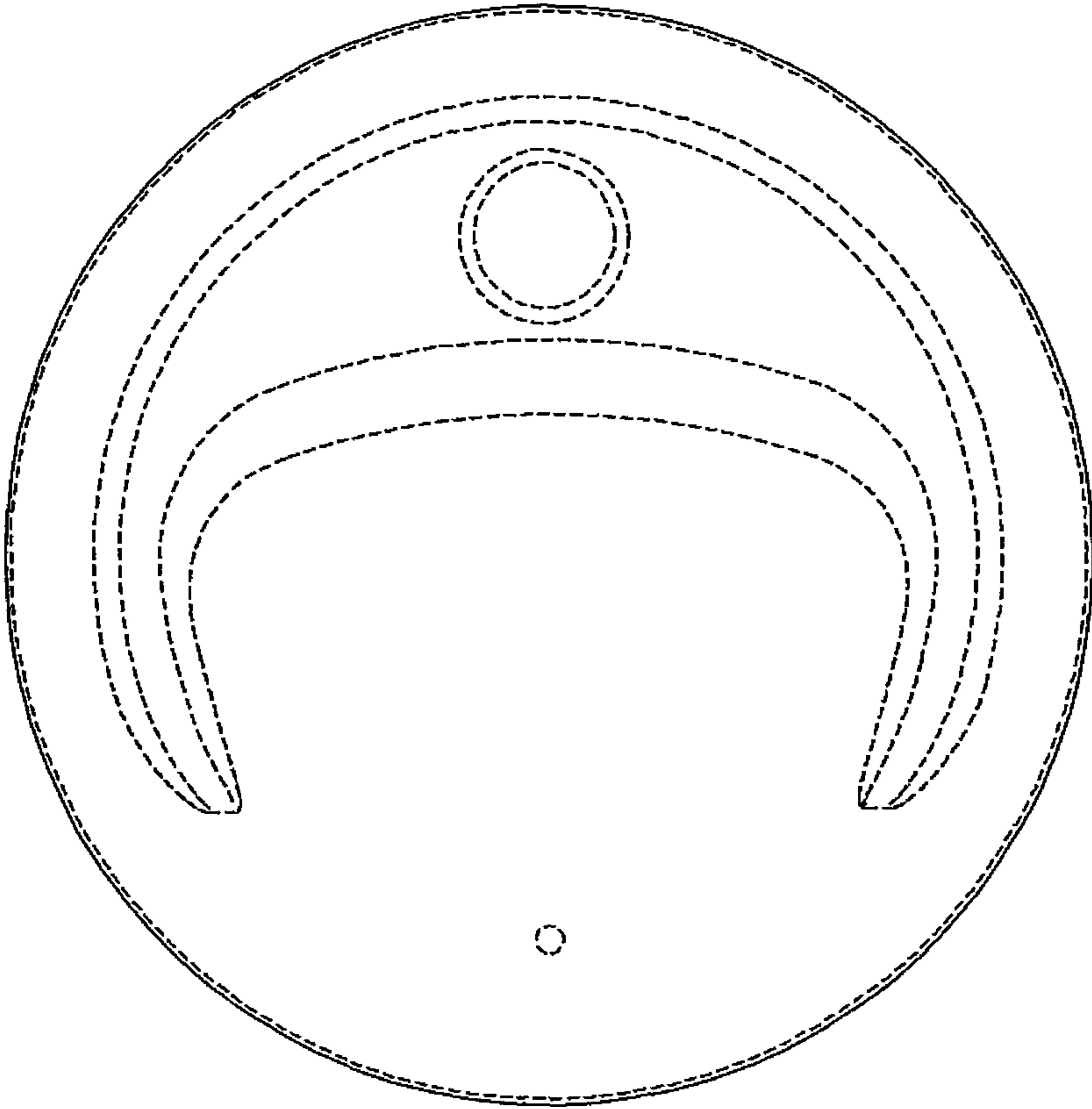

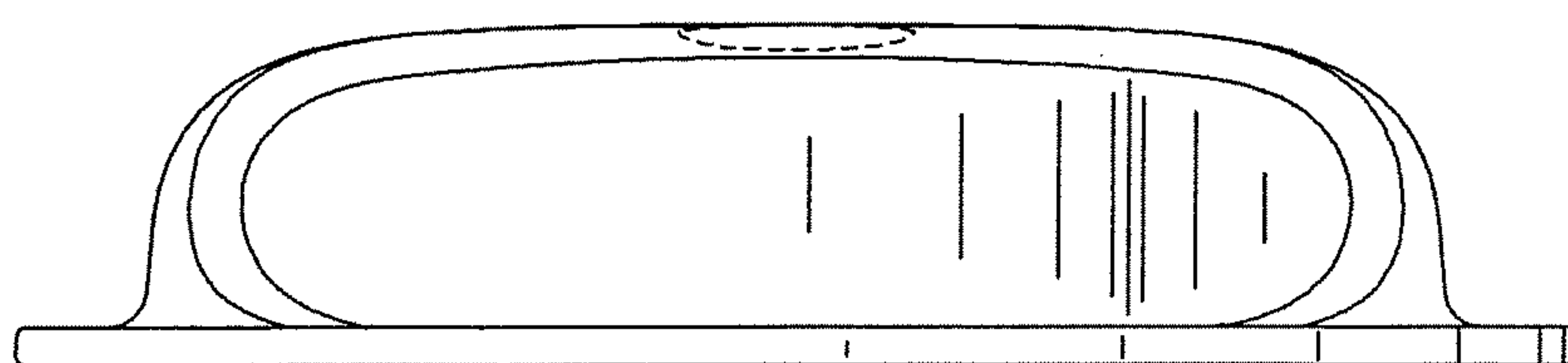

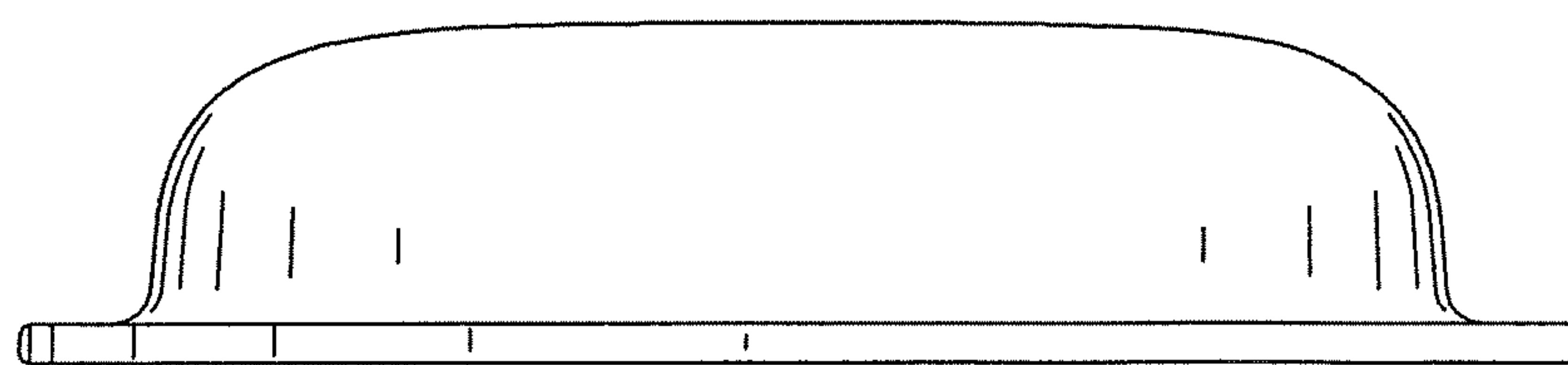
