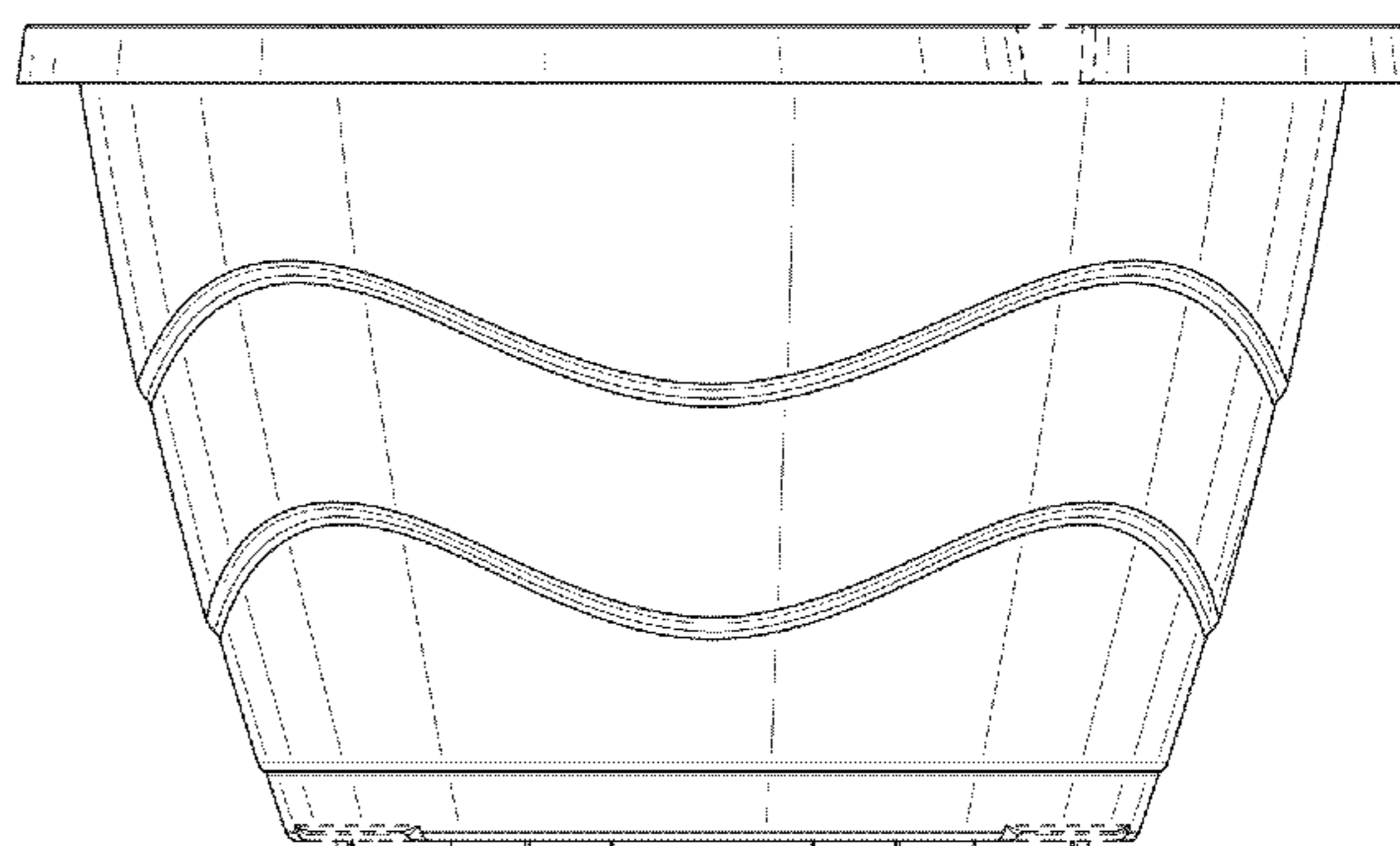
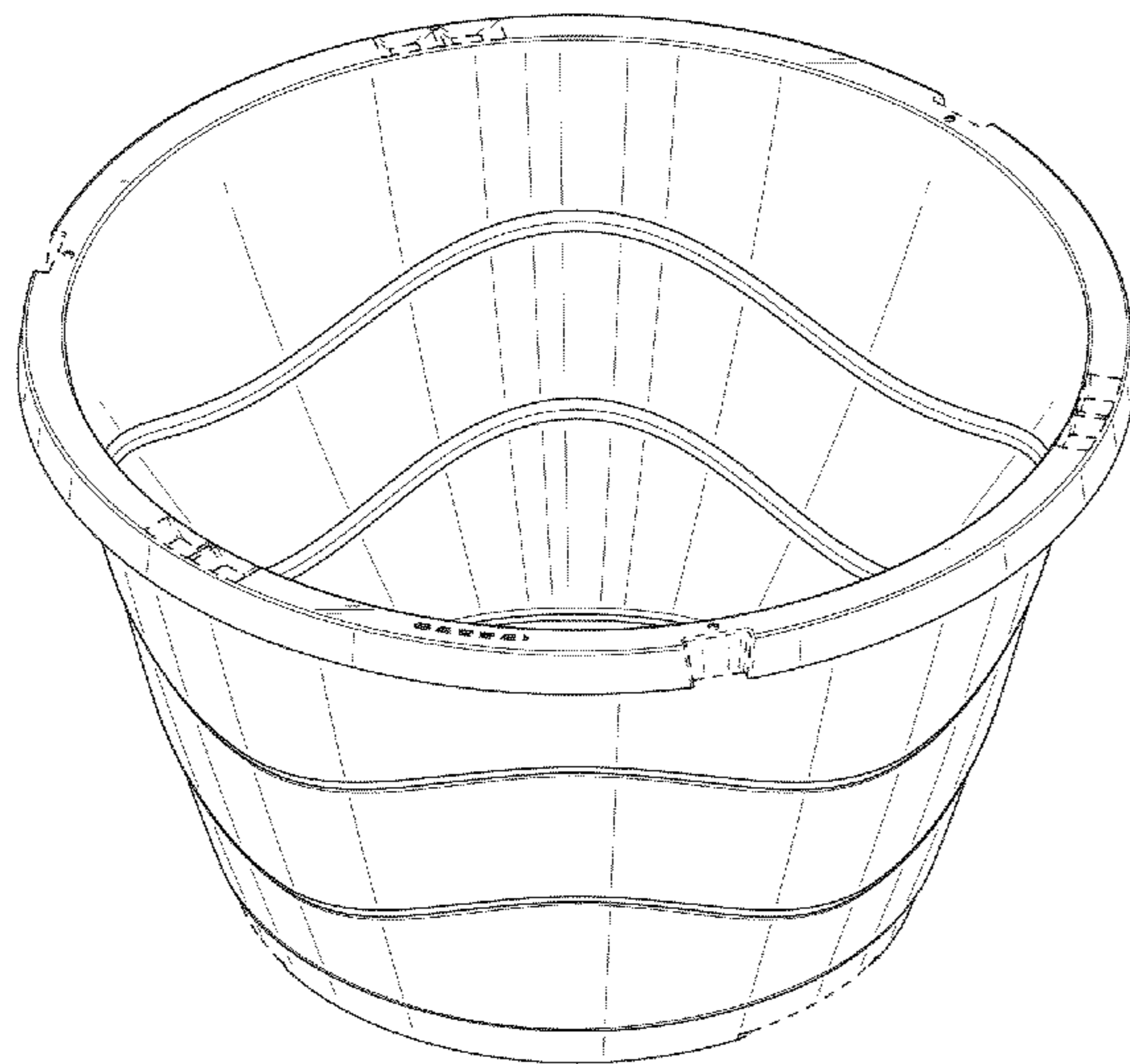
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a plant container showing our new design;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;

FIG. 5 is a back view thereof;
FIG. 6 is a top plan view thereof; and,

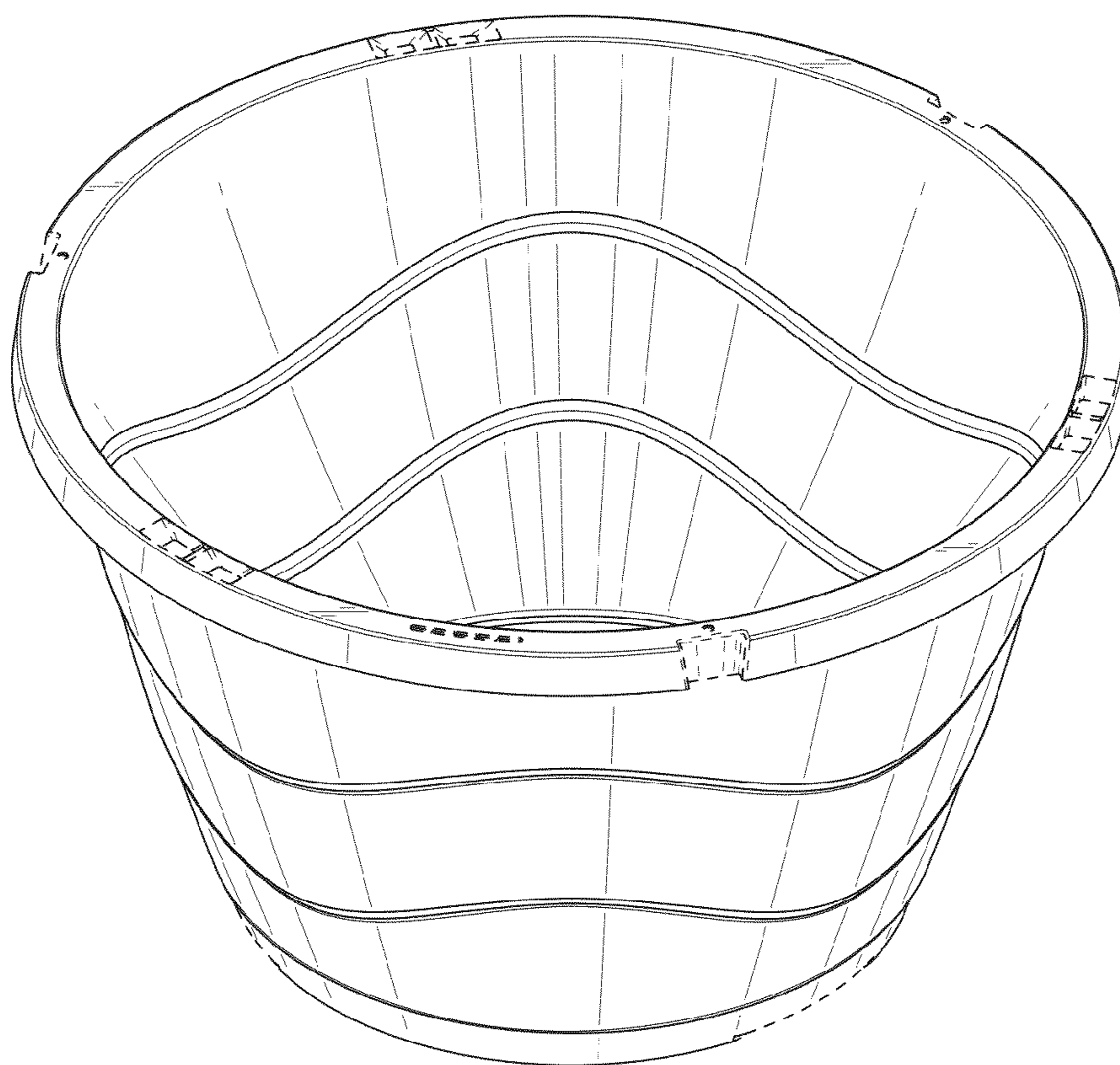

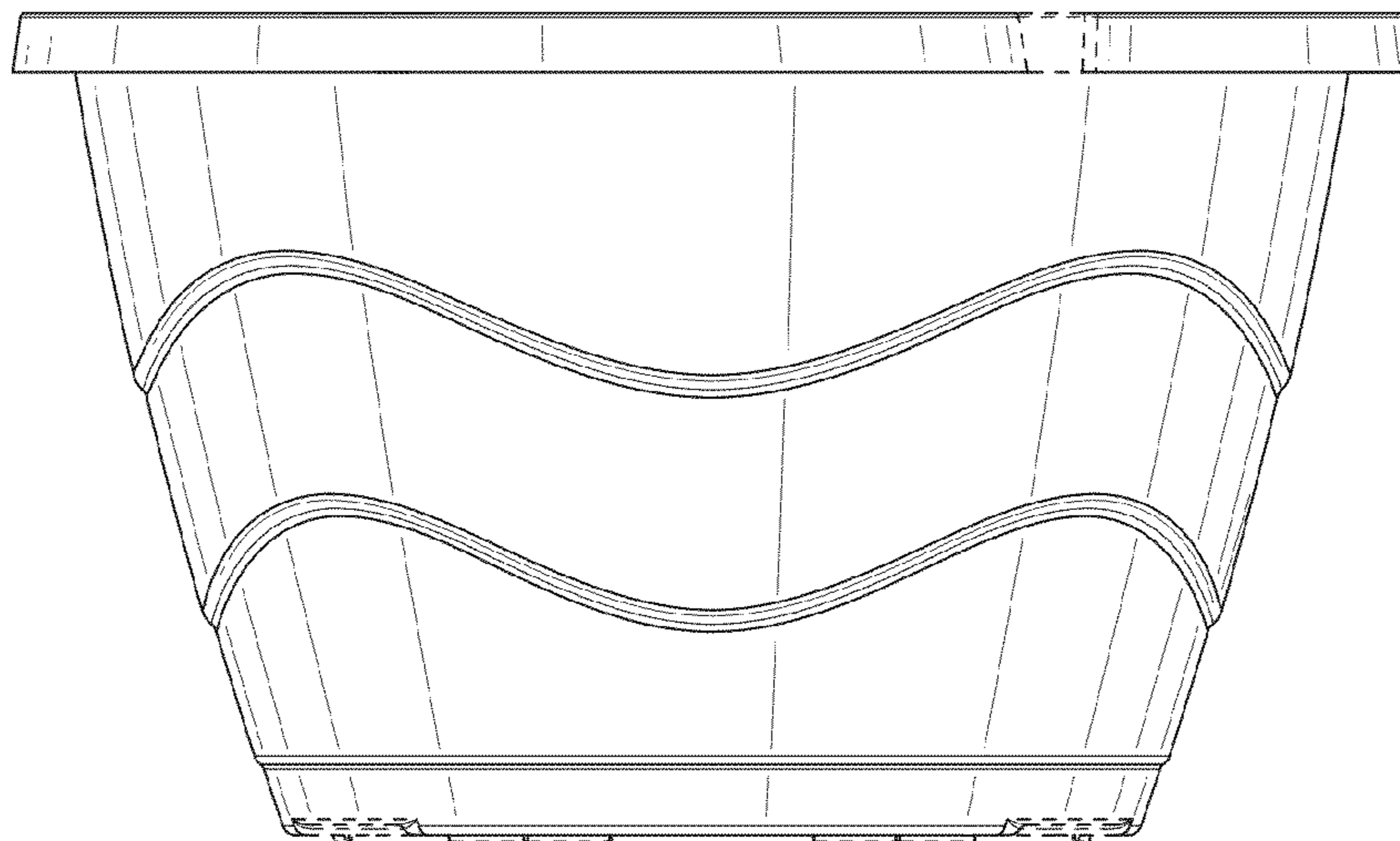

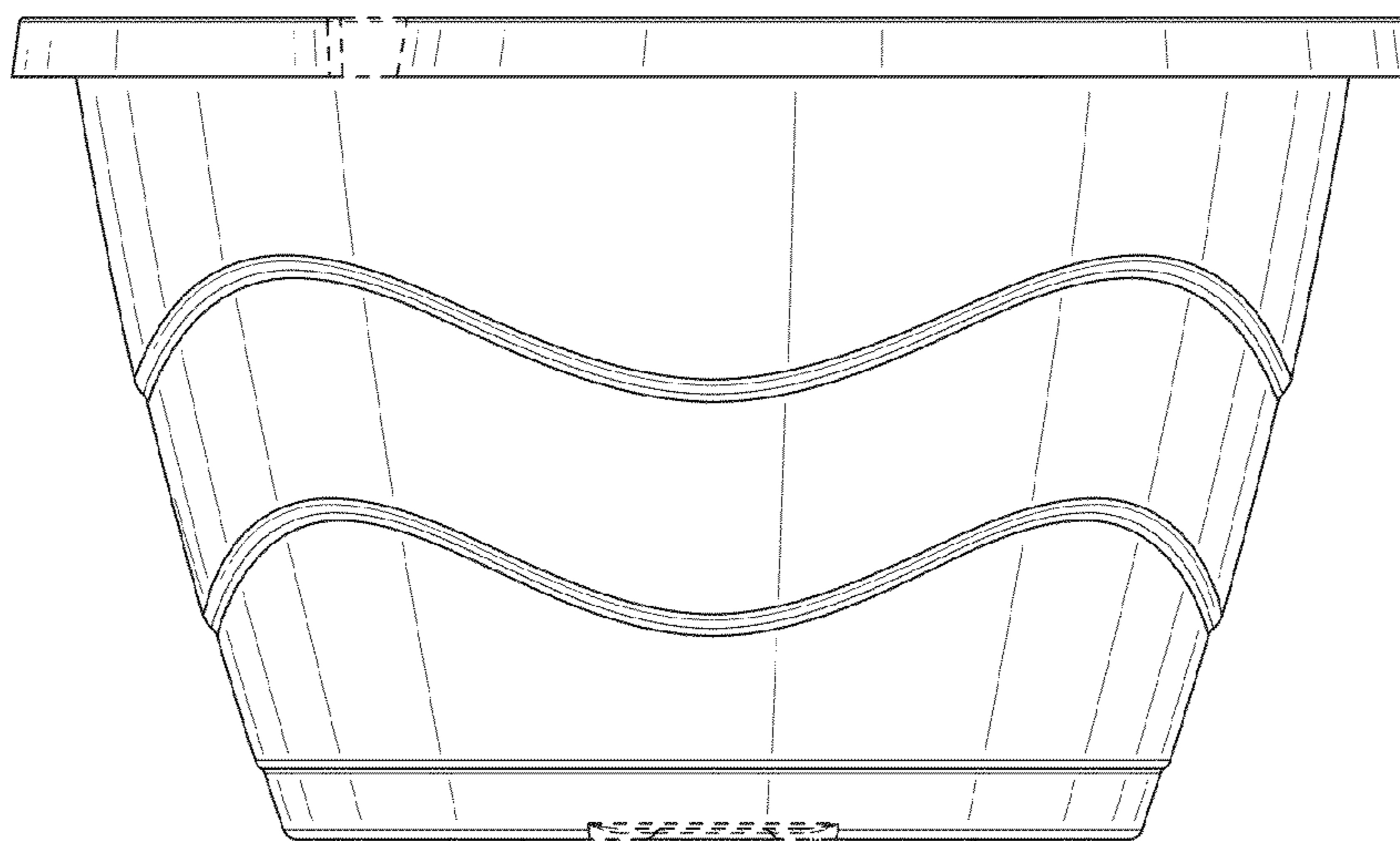

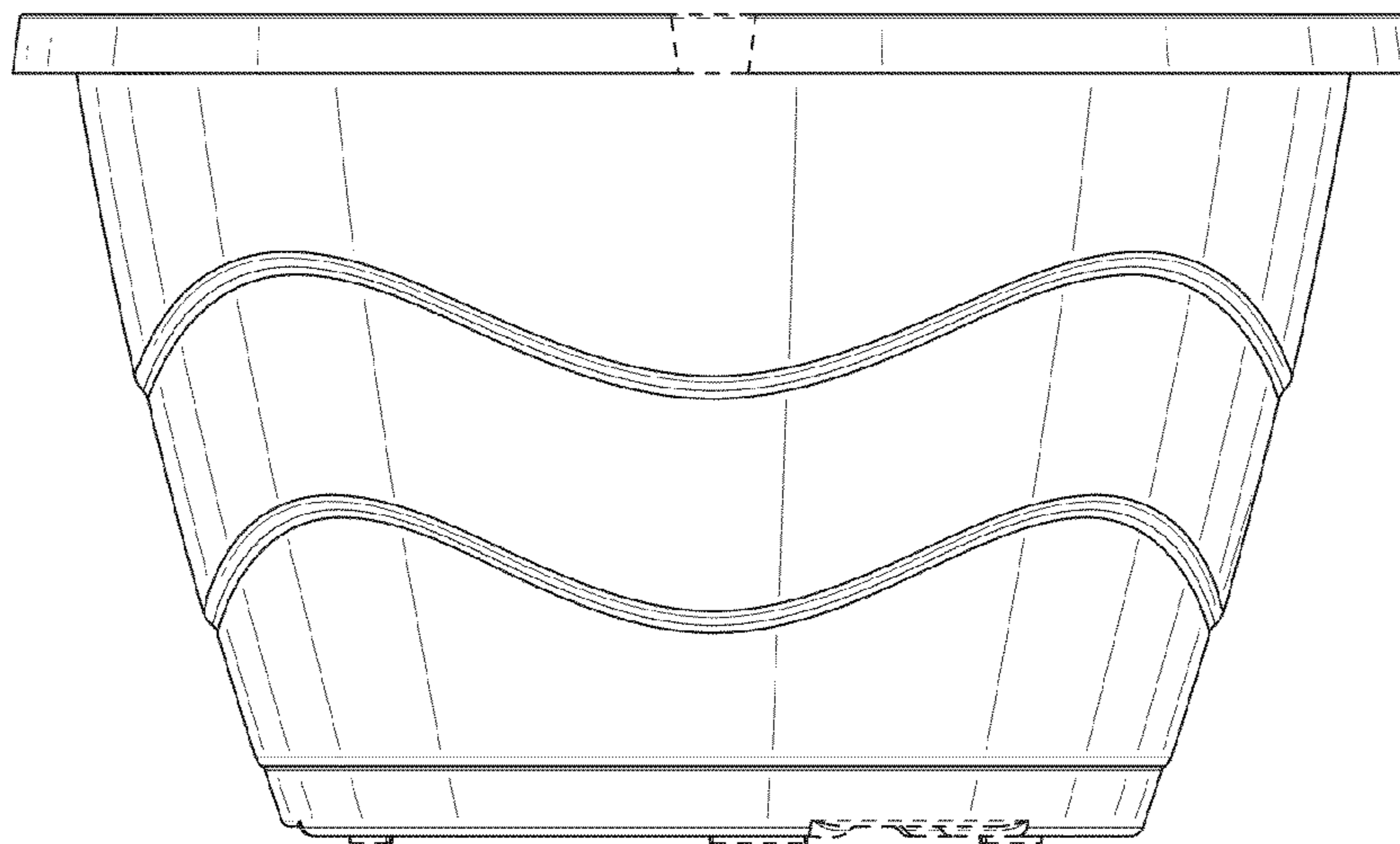

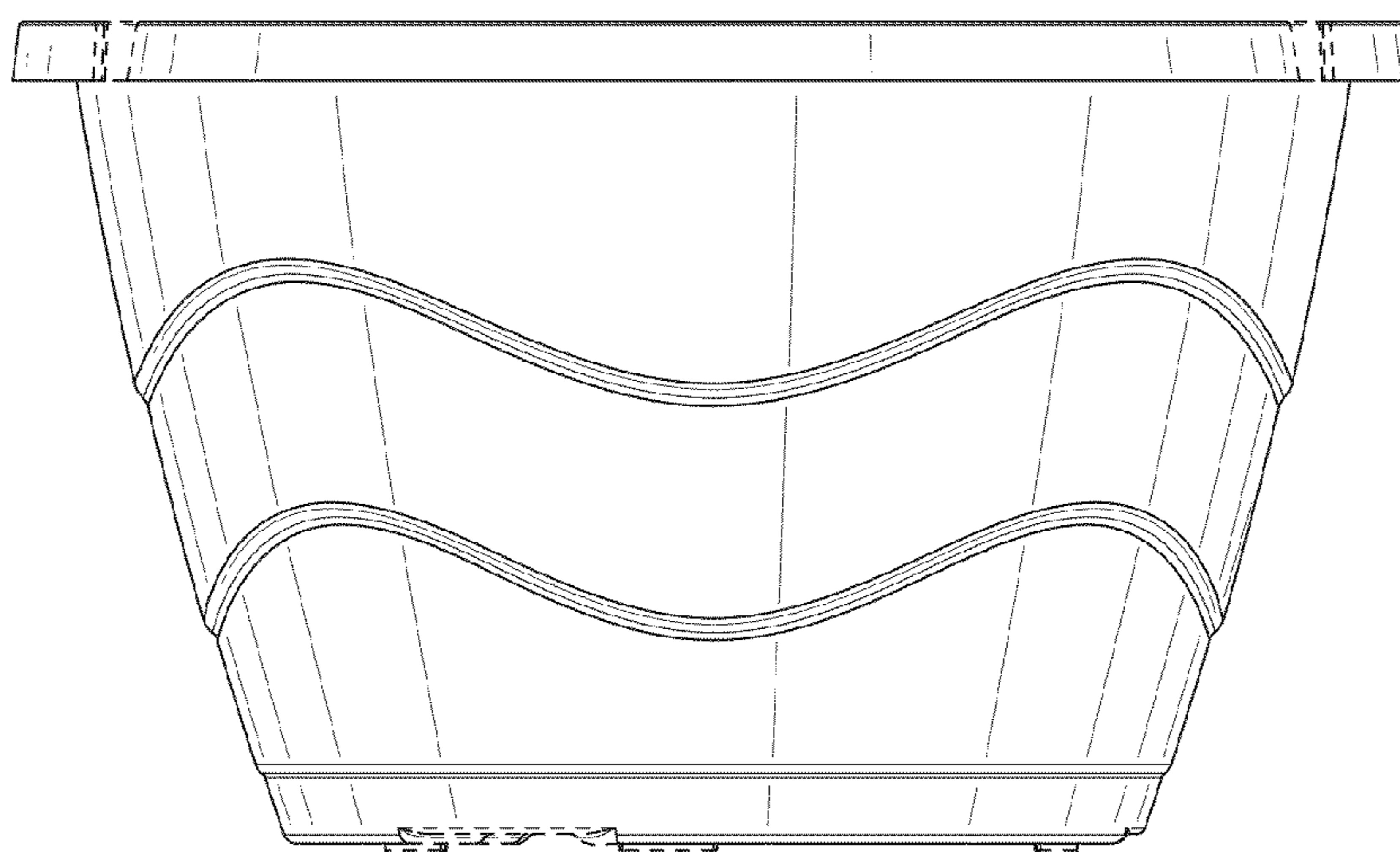

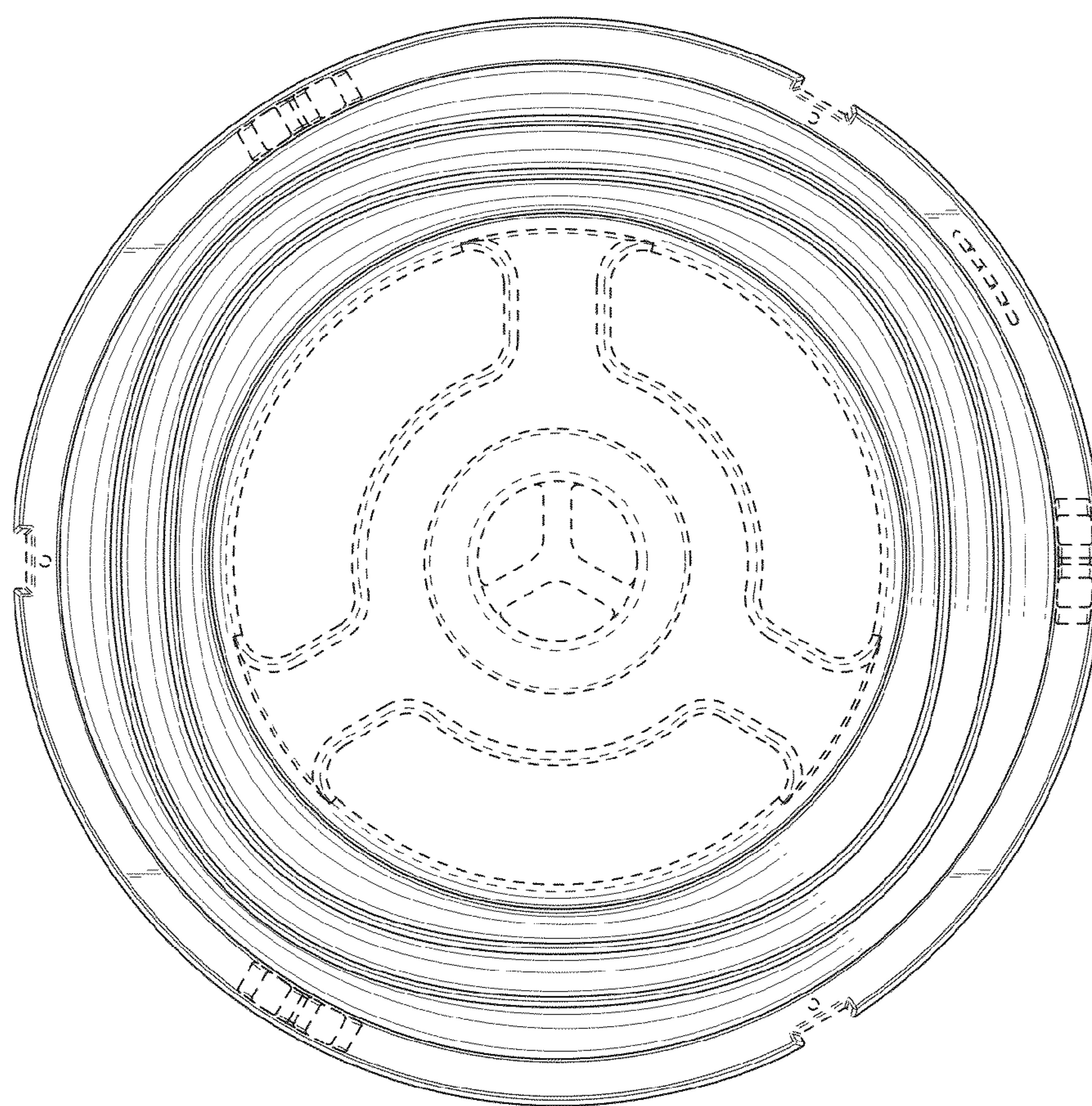

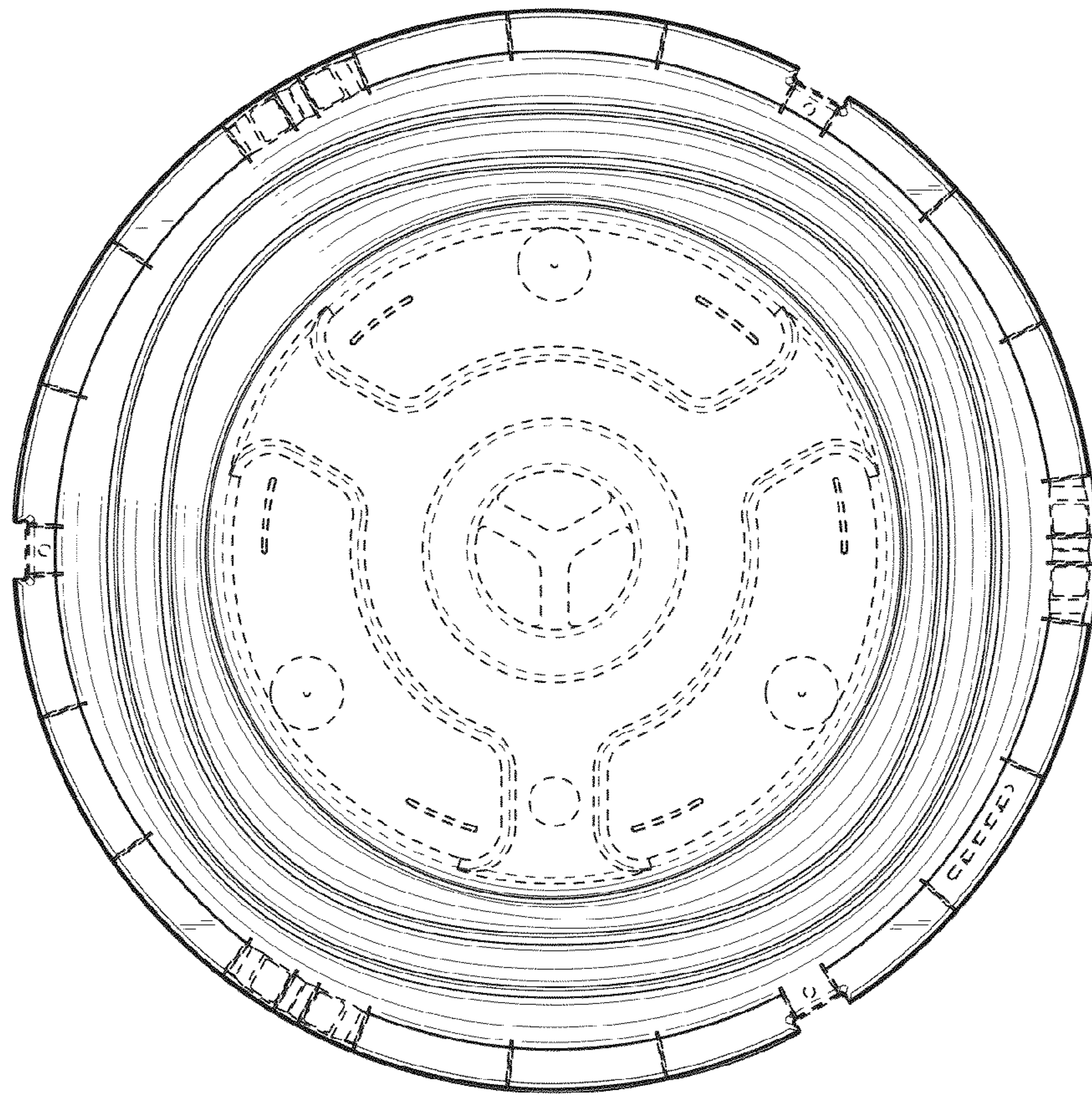
