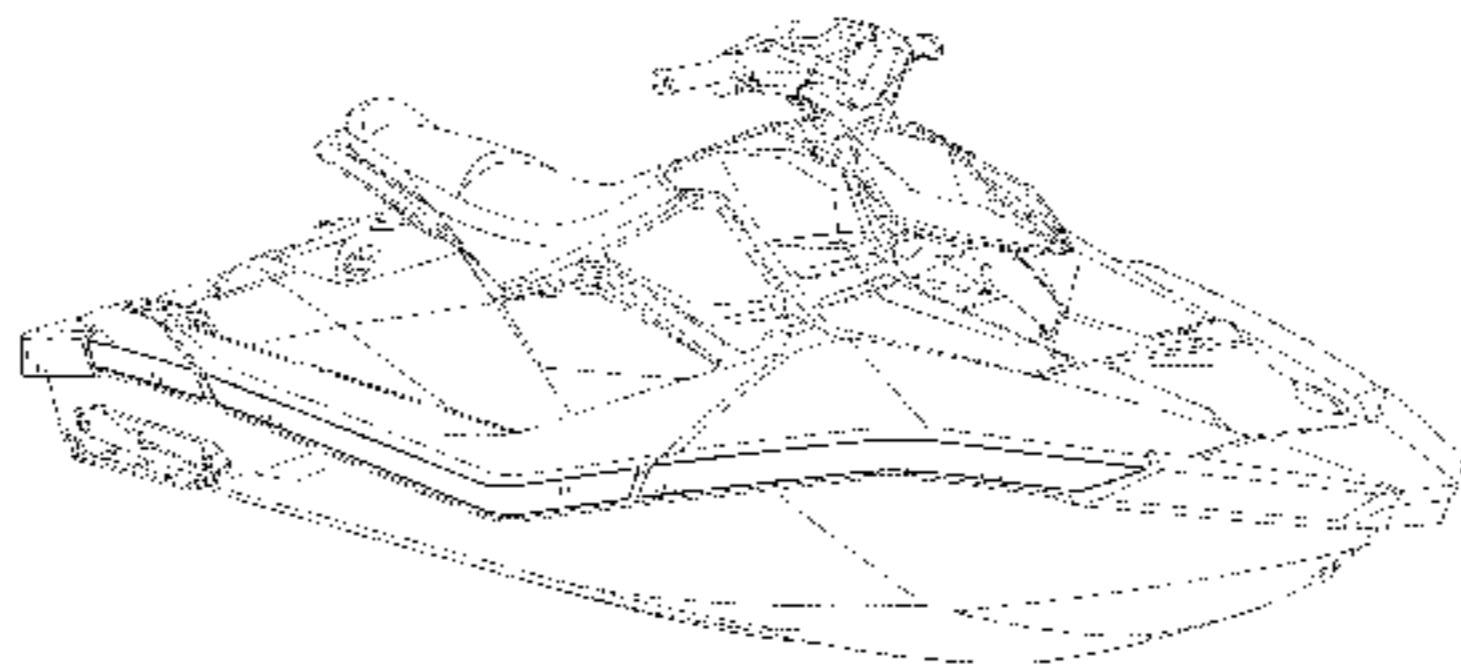
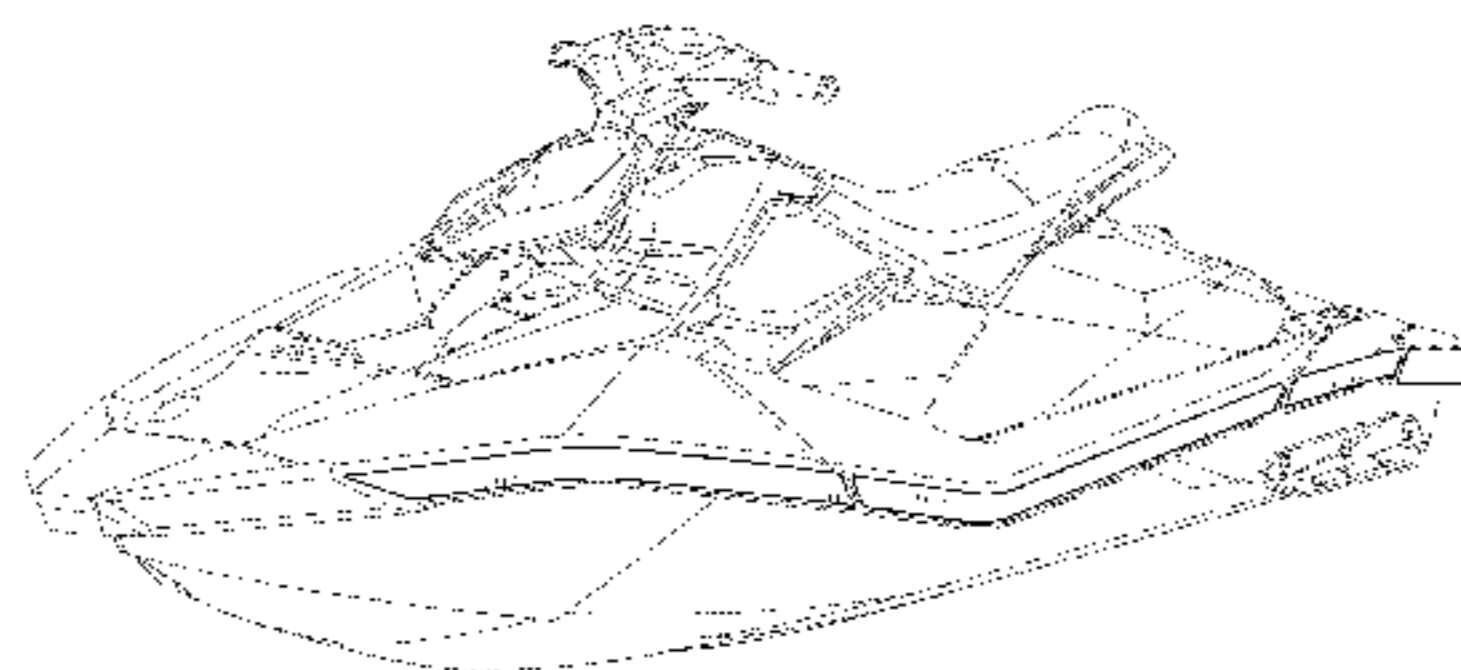
(57) **CLAIM**

The ornamental design for a personal watercraft exterior element, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side elevation view of the personal watercraft exterior element according to an embodiment of our design; FIG. 2 is a front elevation view of the personal watercraft exterior element of FIG. 1; FIG. 3 is a rear elevation view of the personal watercraft exterior element of FIG. 1; FIG. 4 is a top plan view of the personal watercraft exterior element of FIG. 1; FIG. 5 is a bottom plan view of the personal watercraft exterior element of FIG. 1; FIG. 6 is a perspective view taken from a front, left side of the personal watercraft exterior element of FIG. 1; FIG. 7 is a perspective view taken from a rear, left side of the personal watercraft exterior element of FIG. 1; FIG. 8 is a right side elevation view of the personal watercraft exterior element according to another embodiment of our design; FIG. 9 is a front elevation view of the personal watercraft exterior element of FIG. 8; FIG. 10 is a rear elevation view of the personal watercraft exterior element of FIG. 8; FIG. 11 is a top plan view of the personal watercraft exterior element of FIG. 8; FIG. 12 is a bottom plan view of the personal watercraft exterior element of FIG. 8; FIG. 13 is a perspective view taken from a front, right side of the personal watercraft exterior element of FIG. 8; and, FIG. 14 is a perspective view taken from a rear, right side of the personal watercraft exterior element of FIG. 8. Throughout the Figures, where shown, (i) the dashed lines showing additional structure of the personal watercraft exterior element and a personal watercraft having the personal watercraft exterior element thereon are for illustrative purposes only and form no part of the claimed design; (ii) the unshaded surfaces form no part of the claimed design; and (iii) the dotted/dashed lines illustrate unclaimed boundaries of surfaces claimed as part of the design.

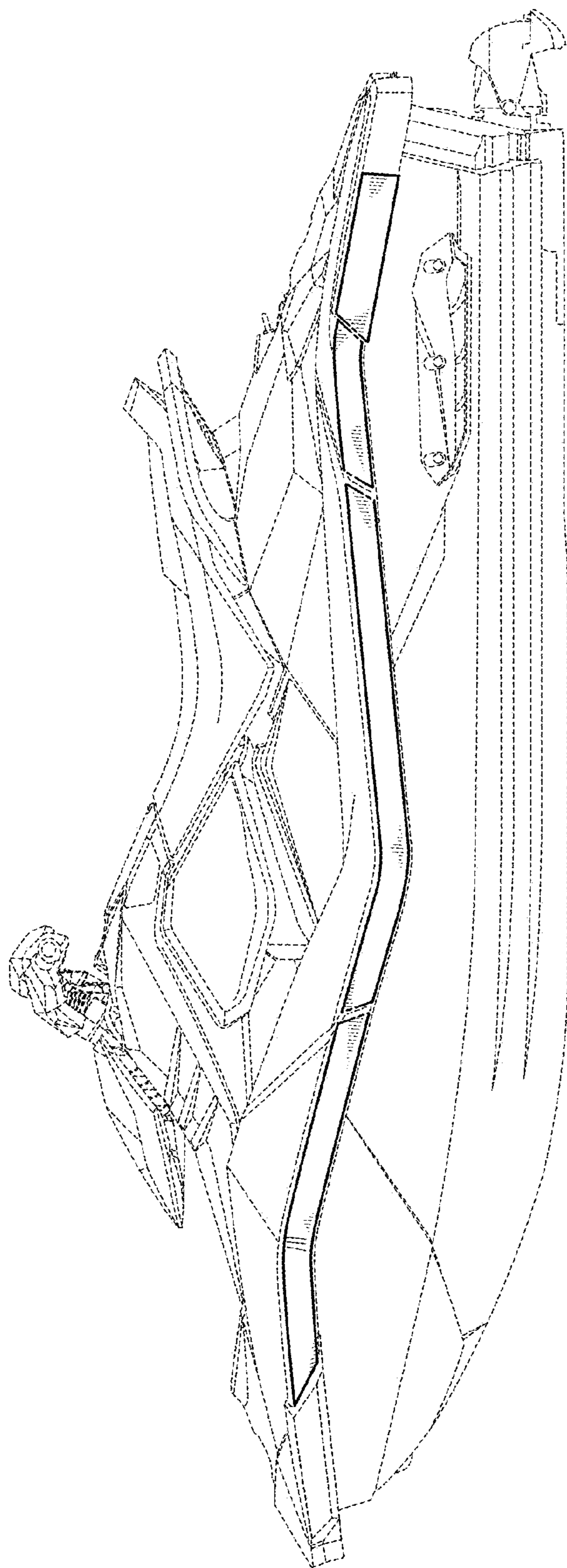

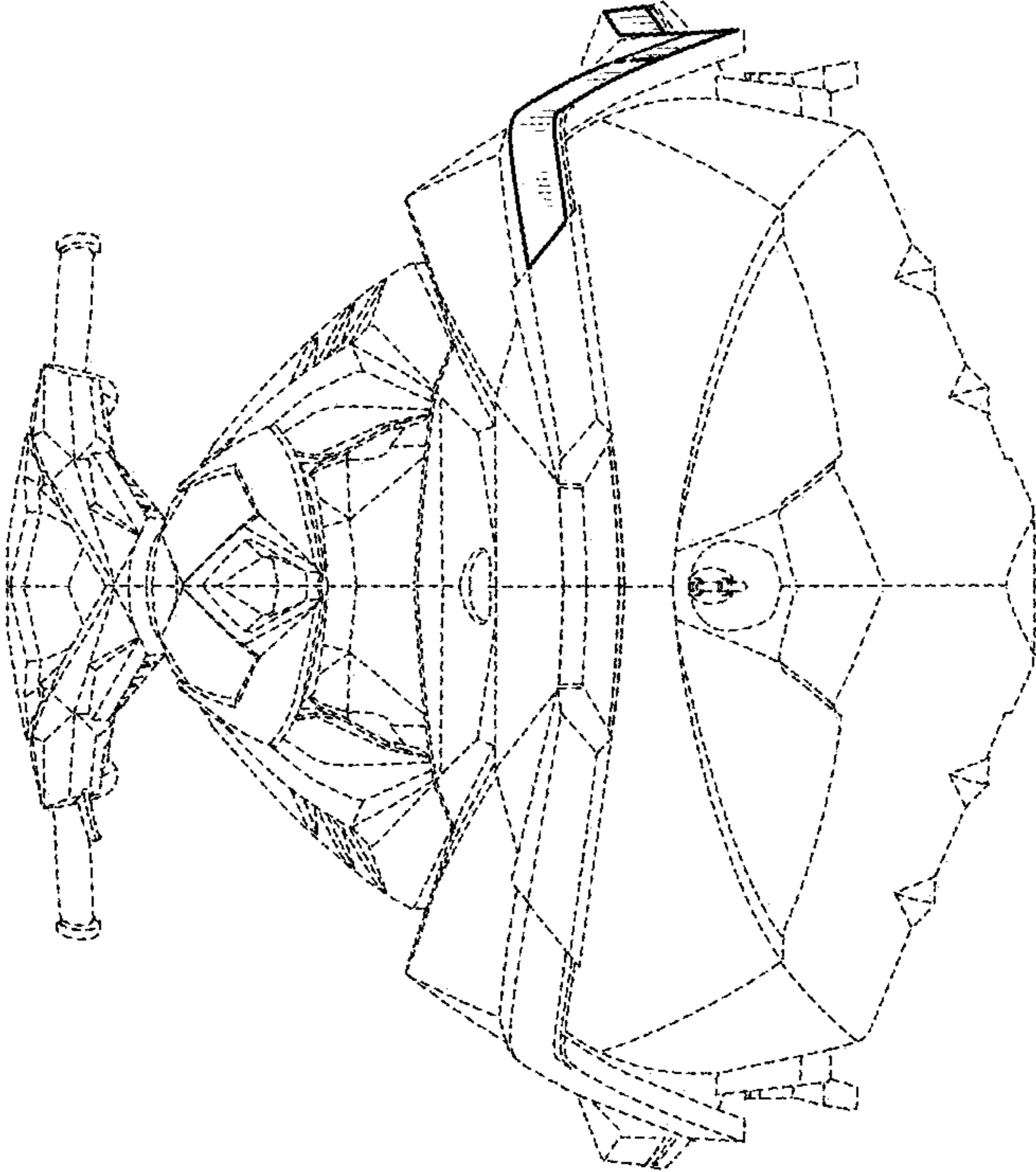

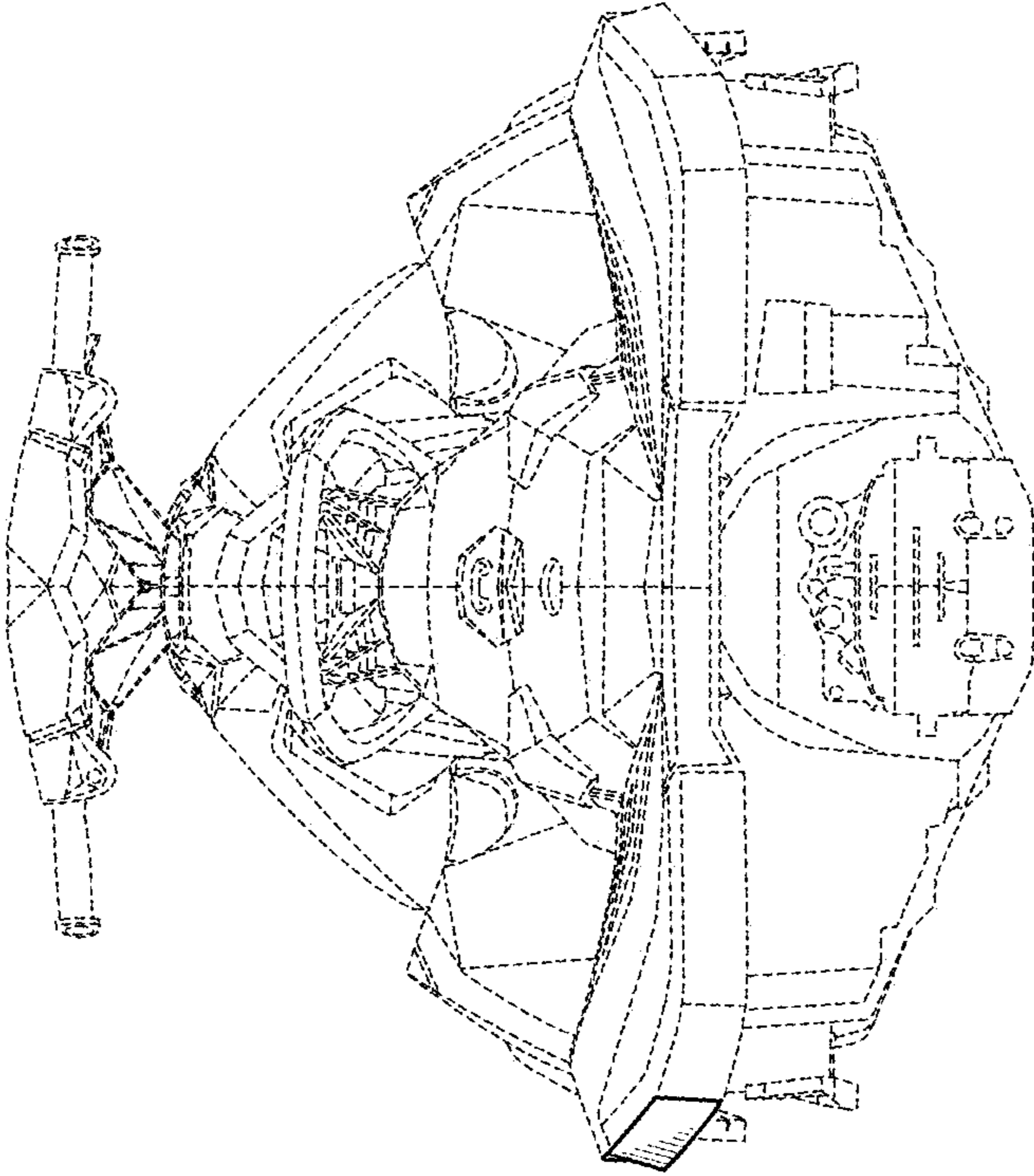

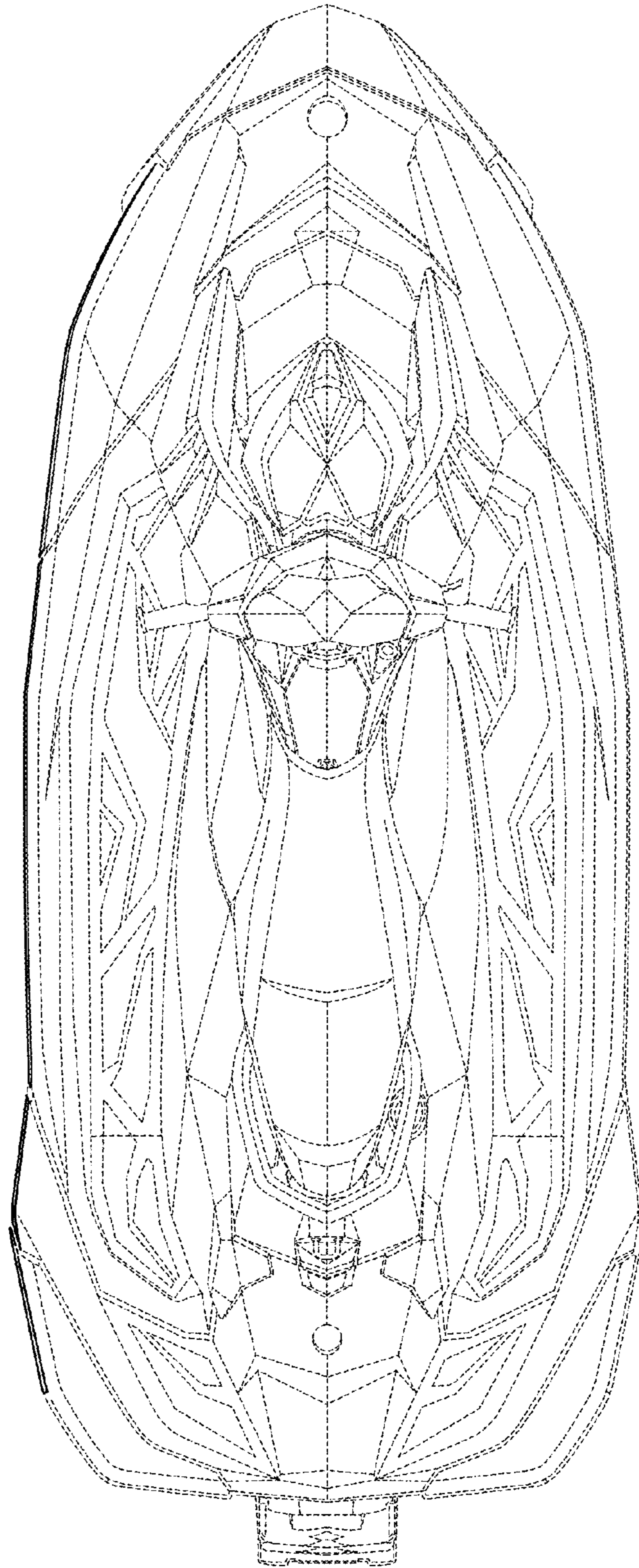

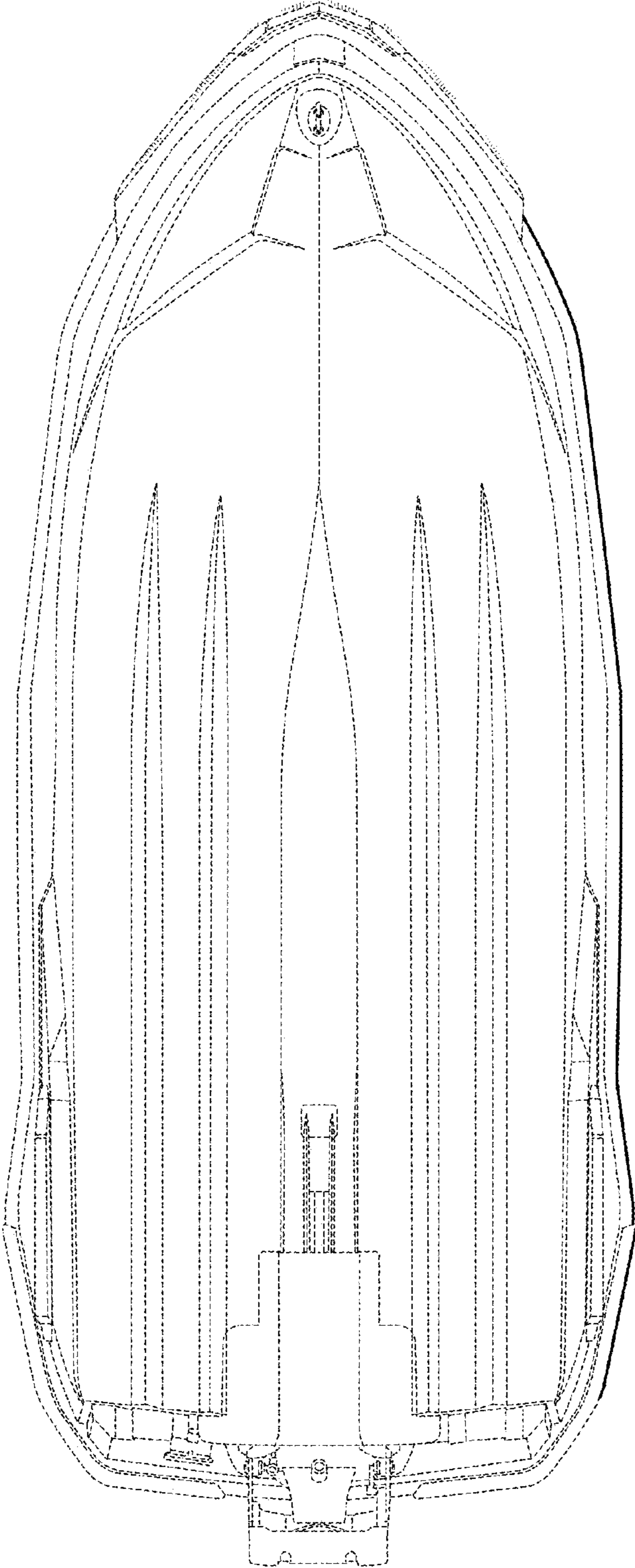

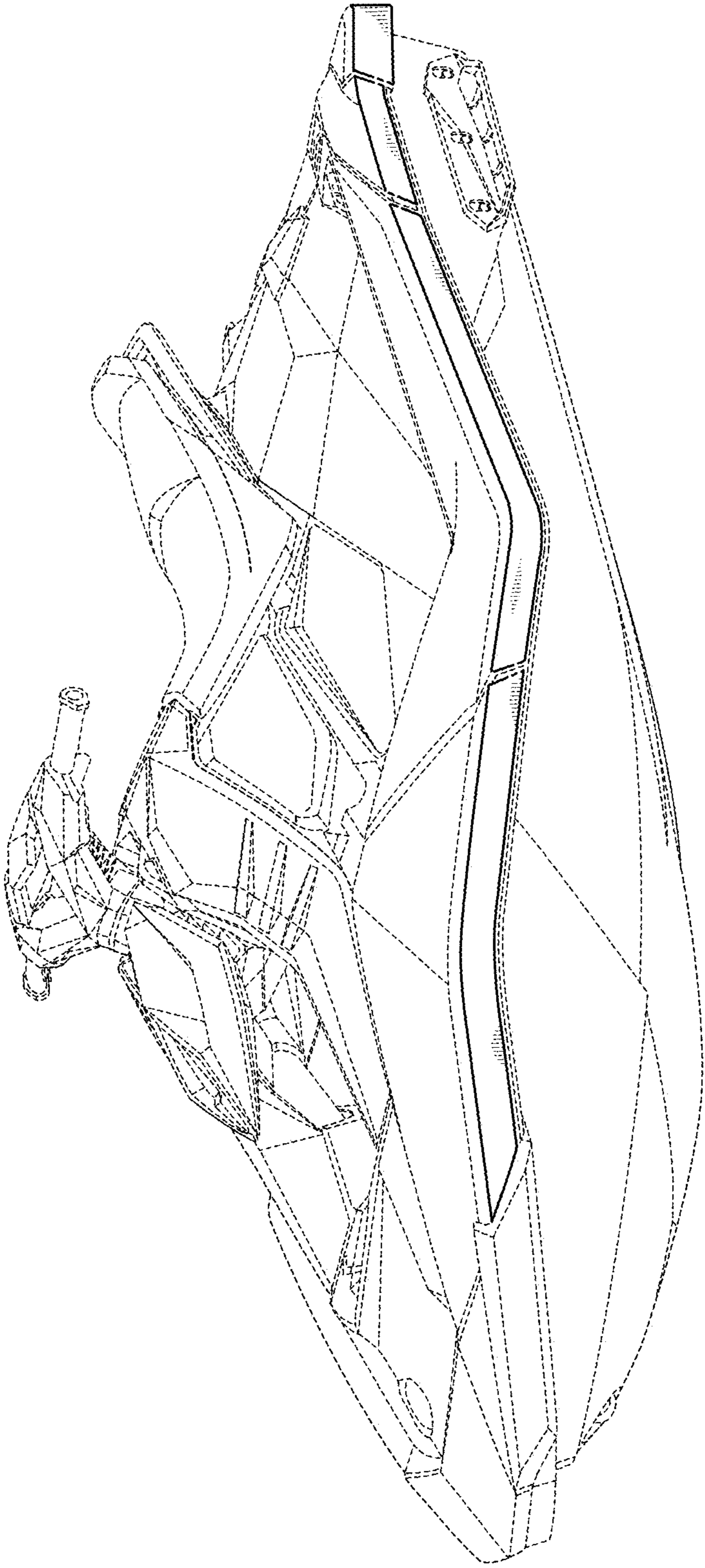

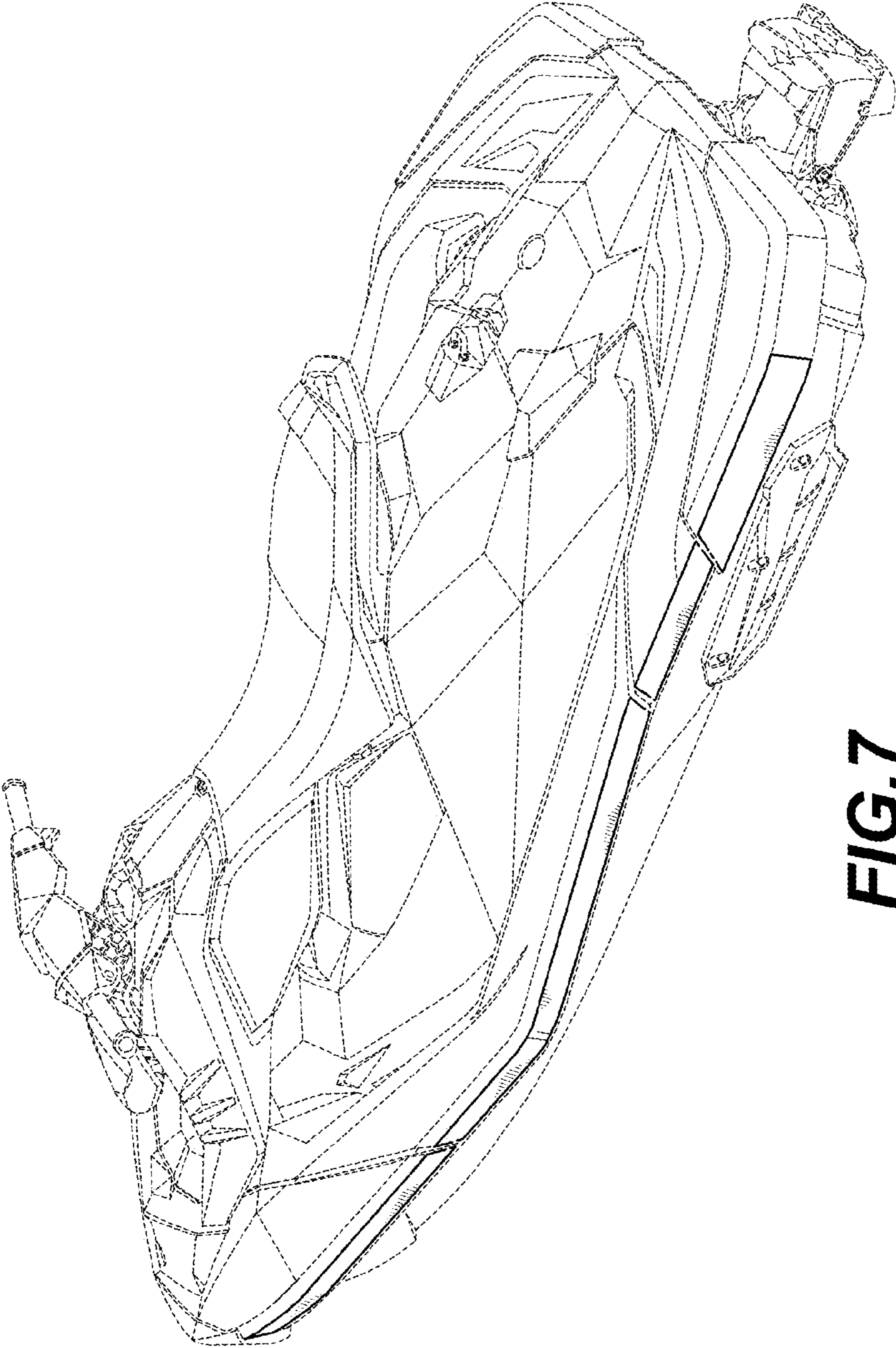

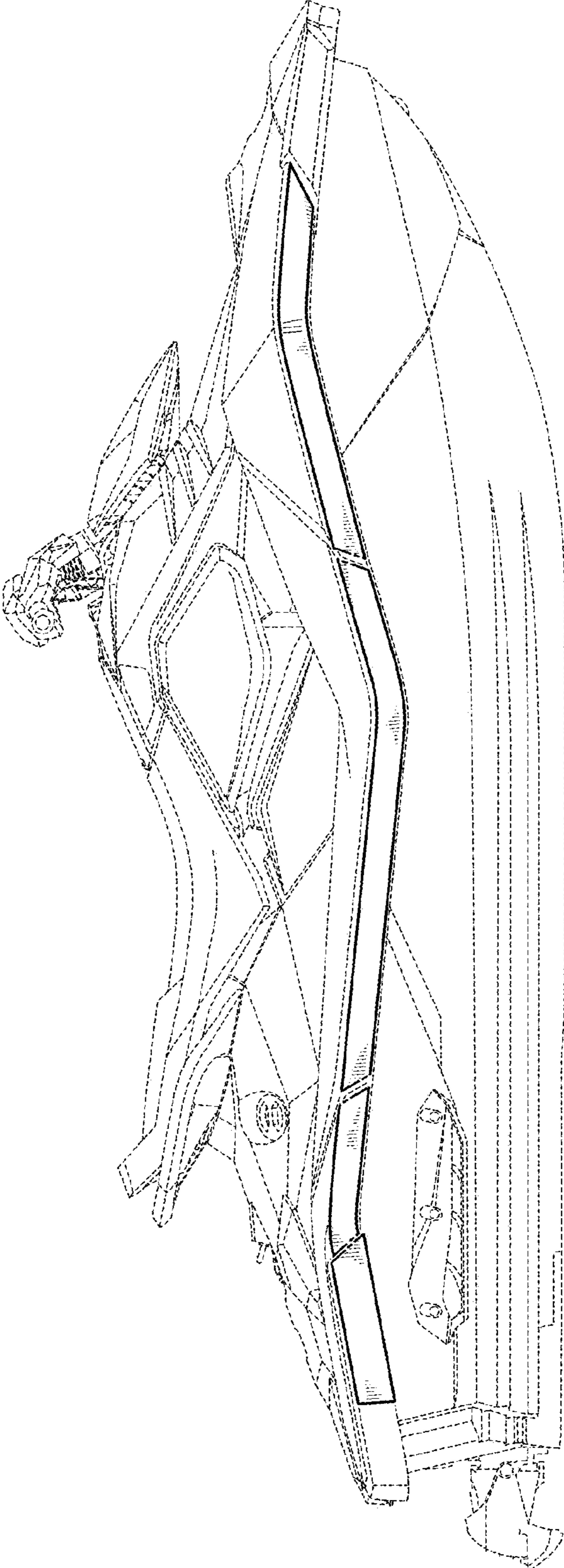

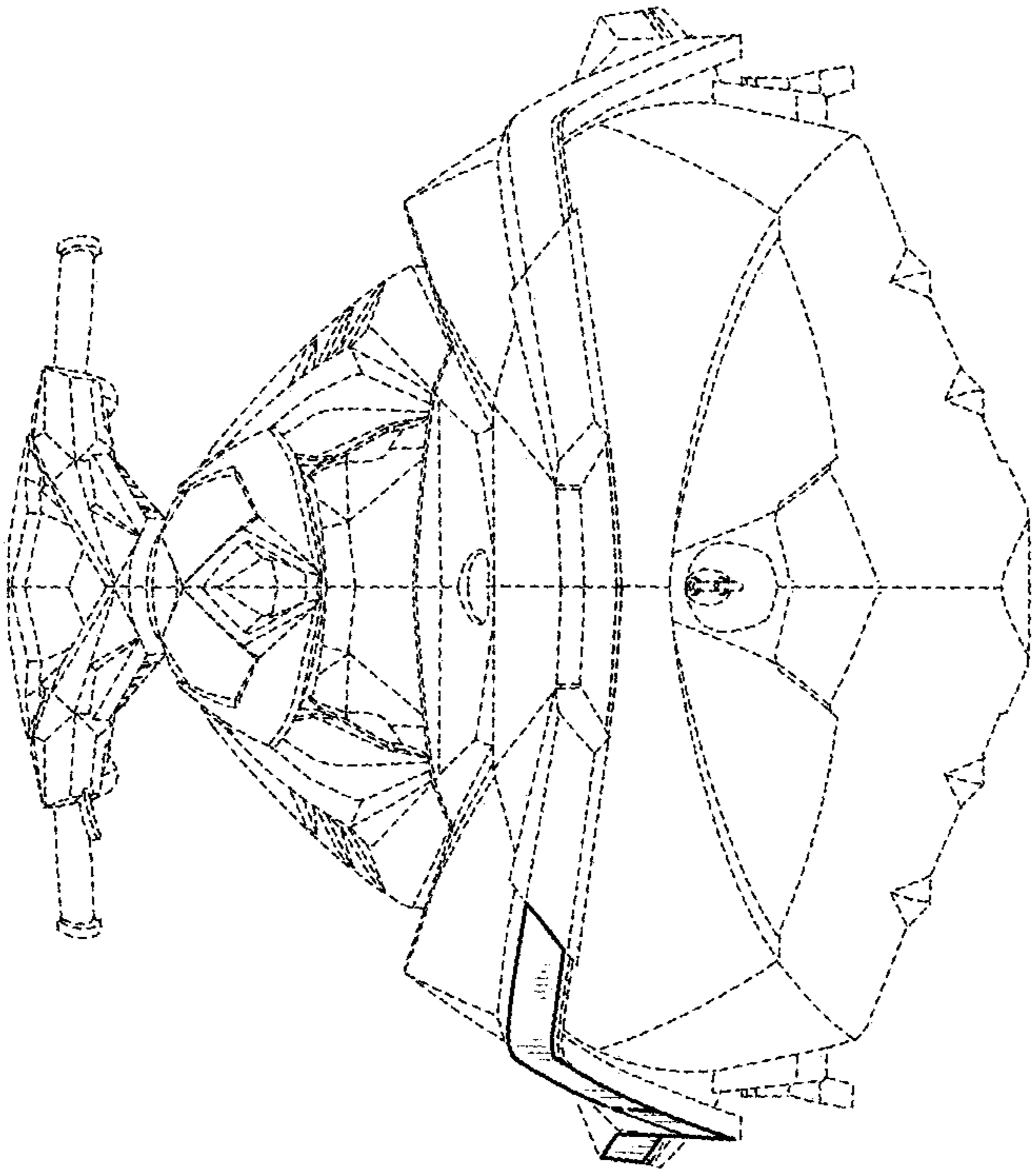




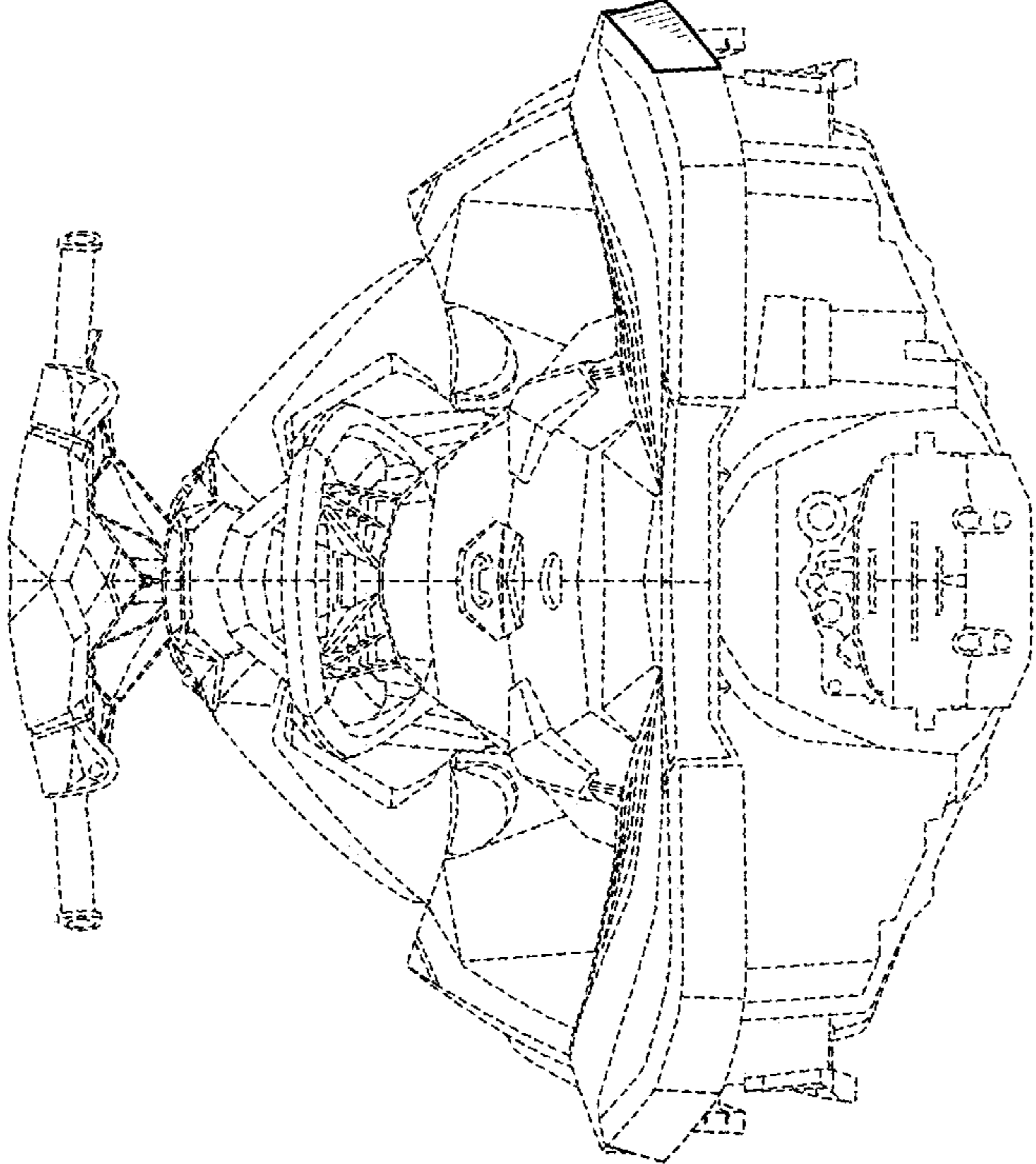

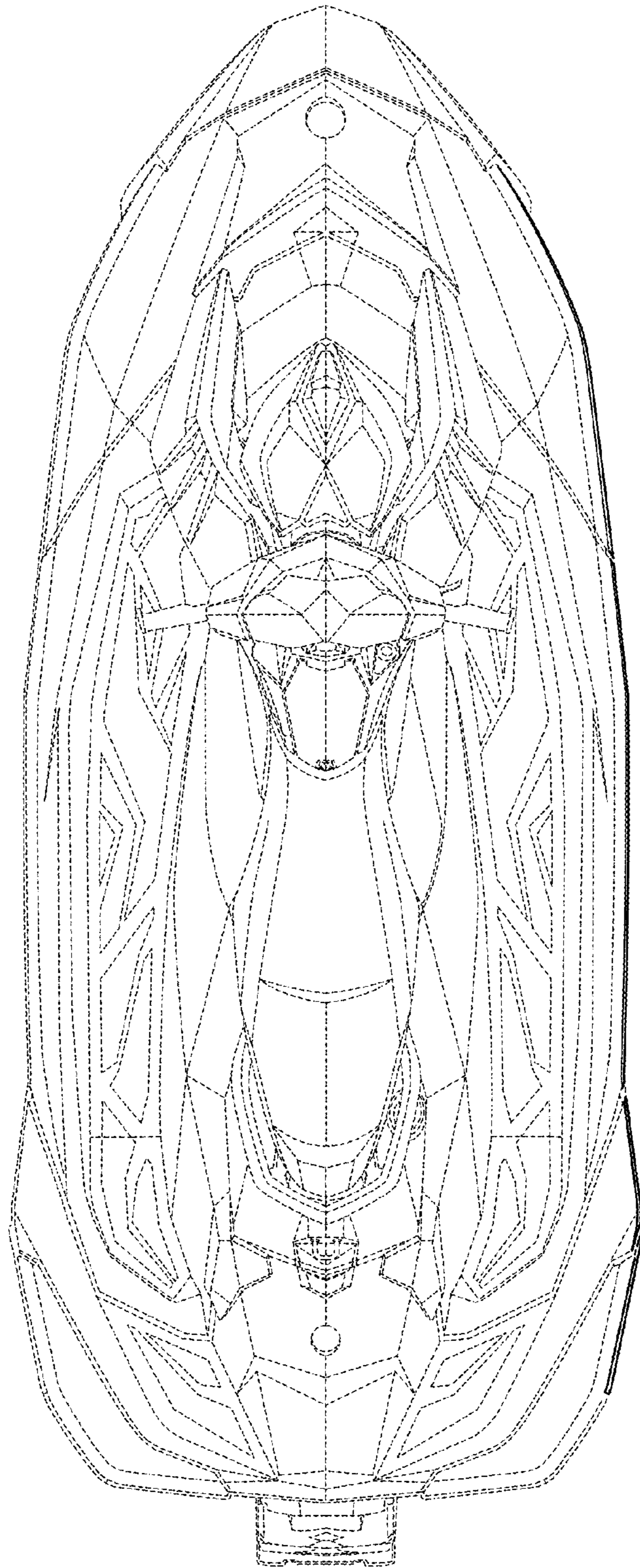

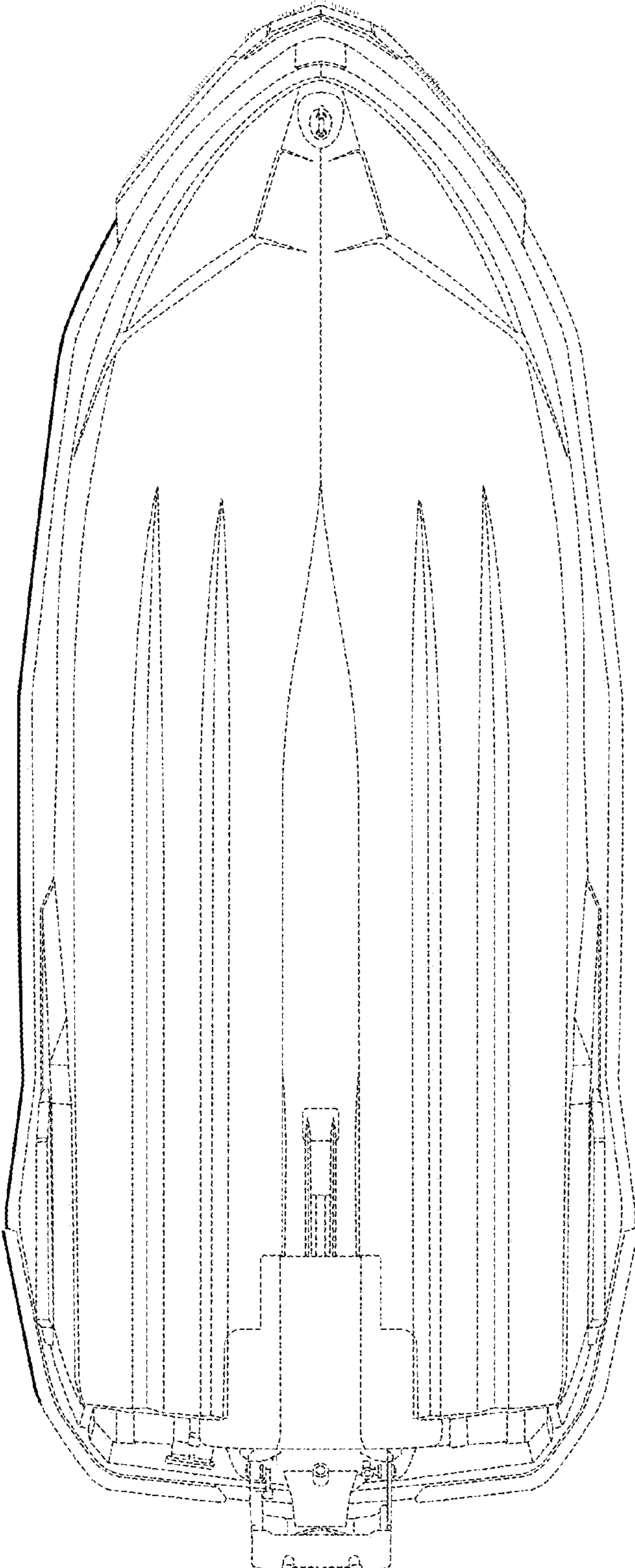

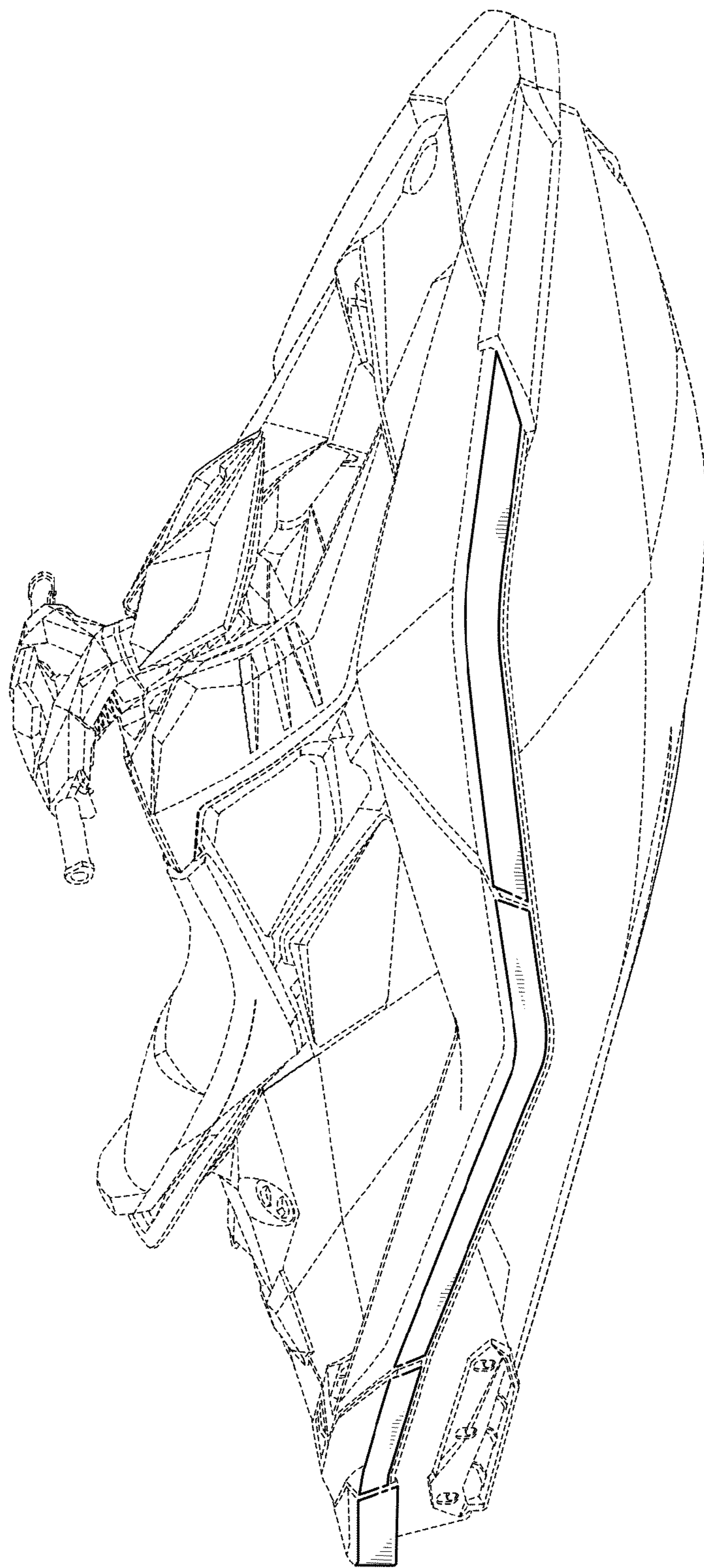

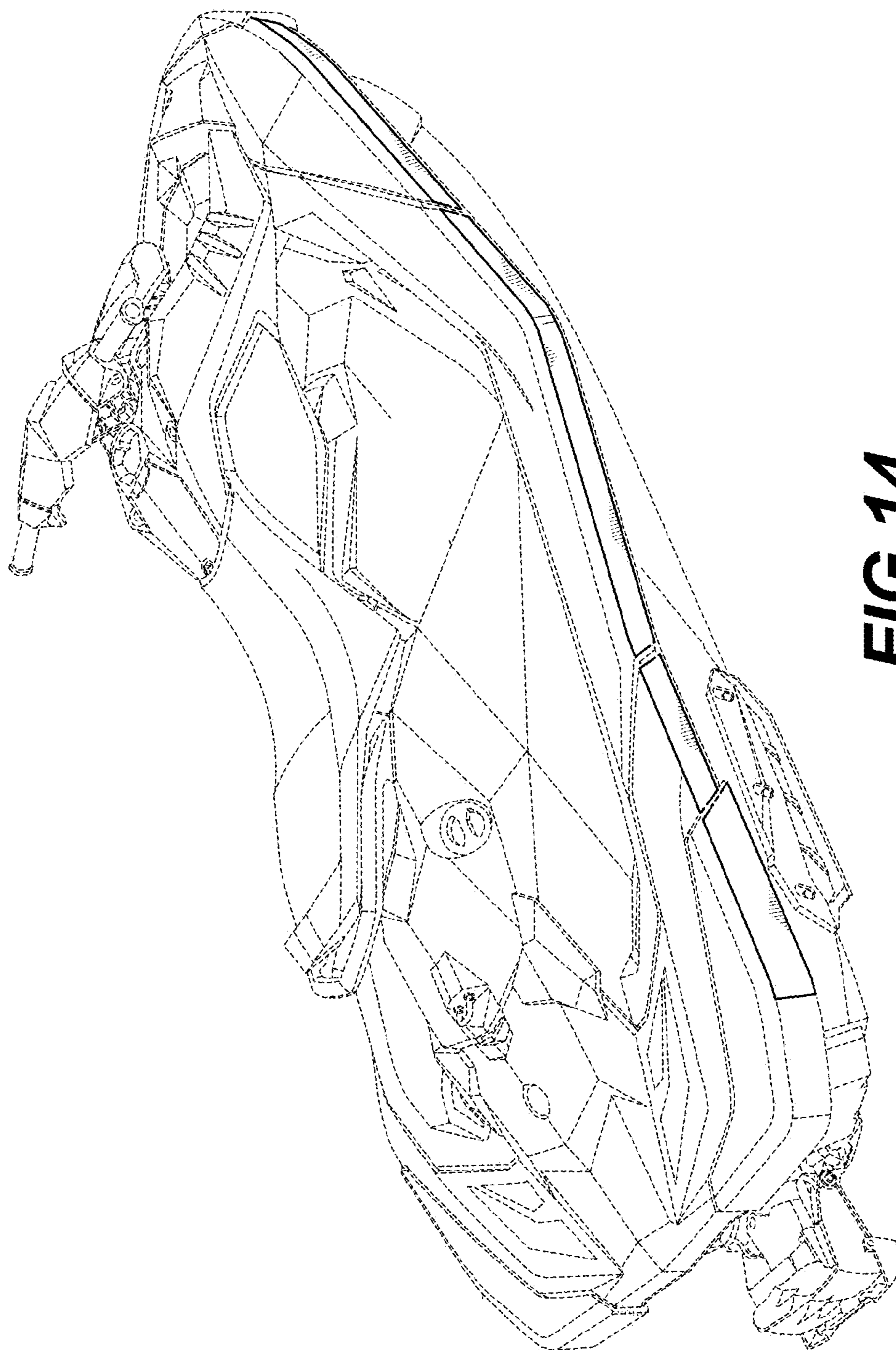
