DESCRIPTION

FIG. 1 is a top, front and right side perspective view of a first embodiment of a portable speaker, embodying my new design;

FIG. 12 is a top, front and right side perspective view of a third embodiment thereof;

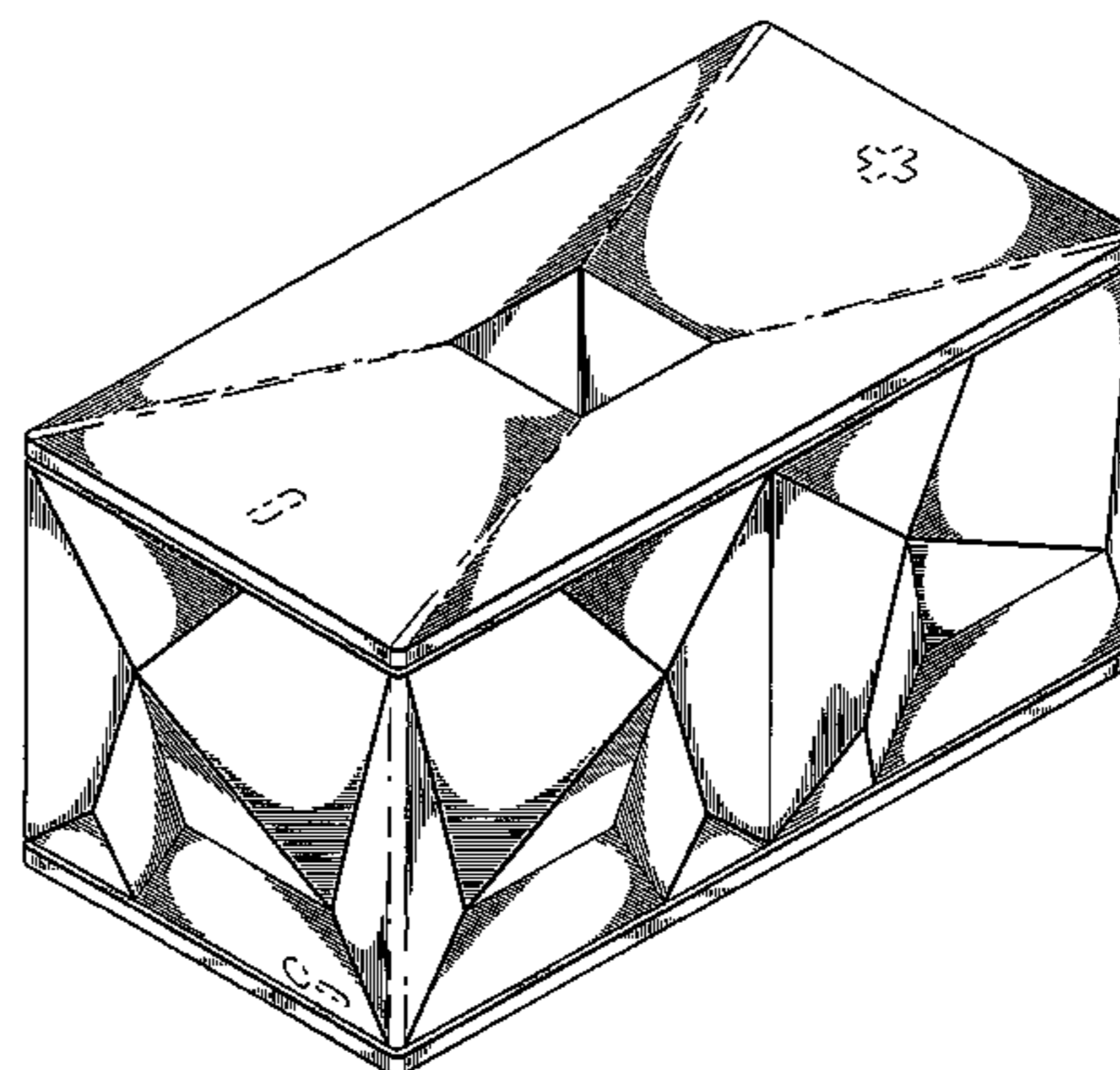
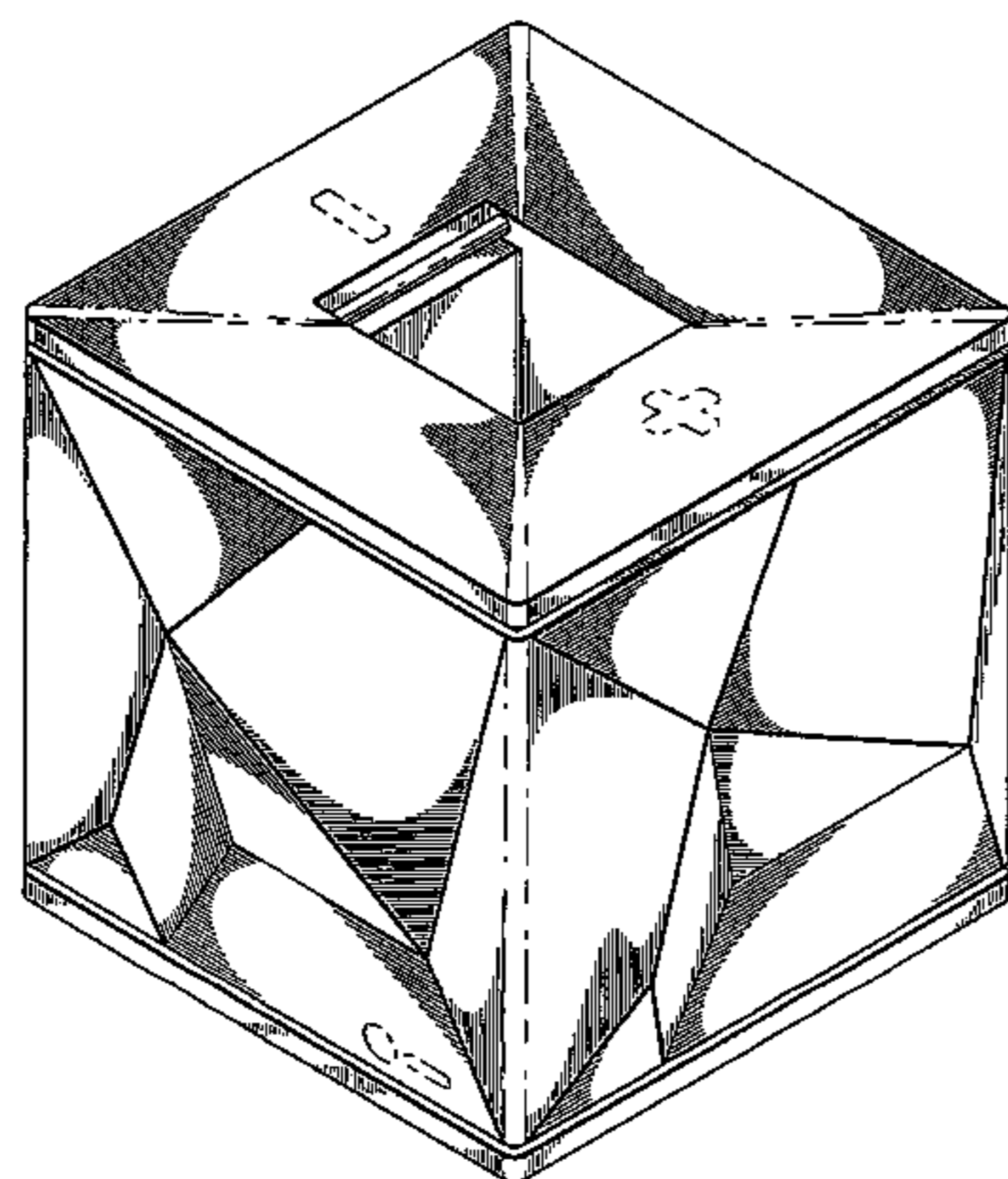
FIG. 13 is a top plan view;

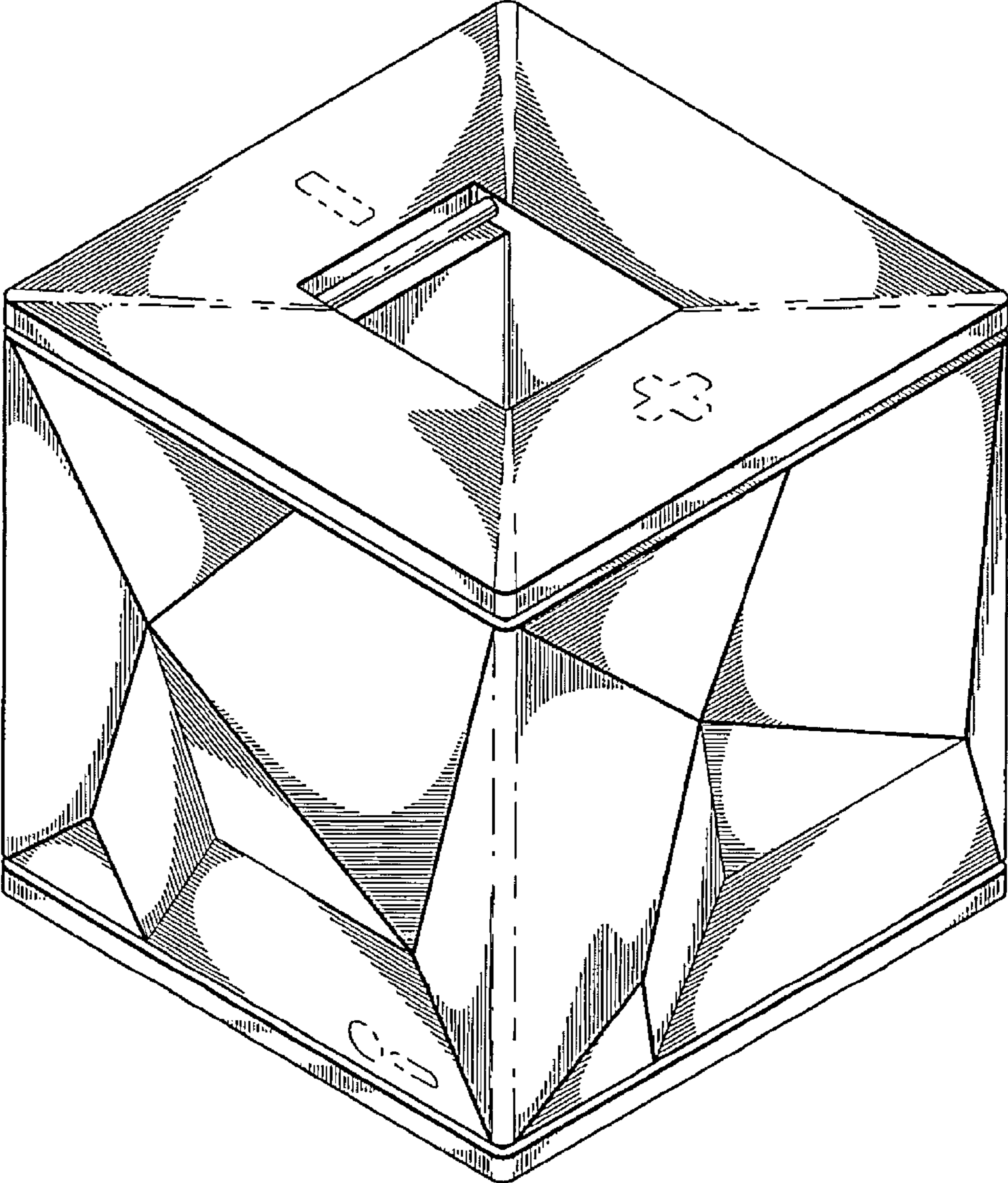

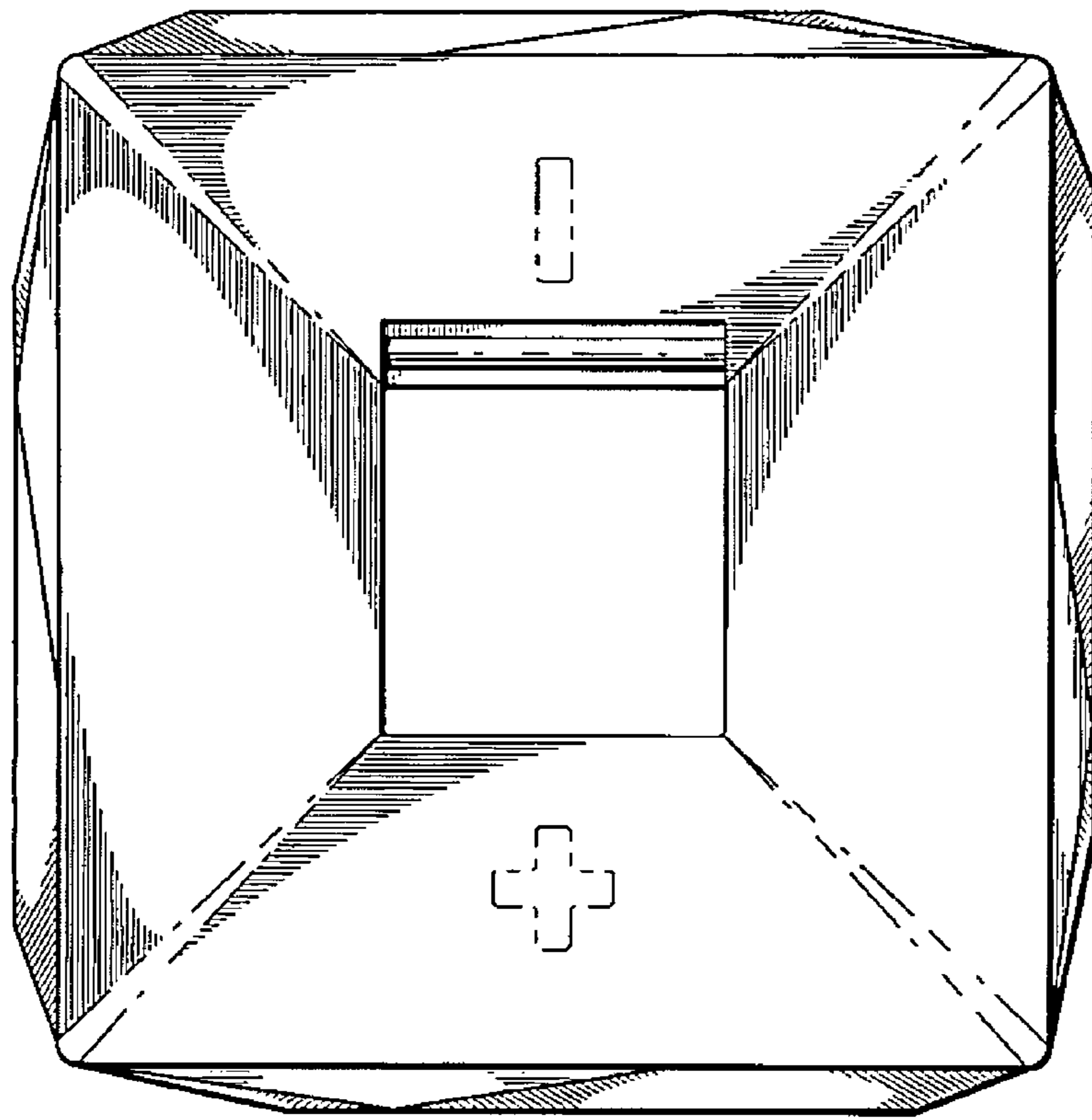

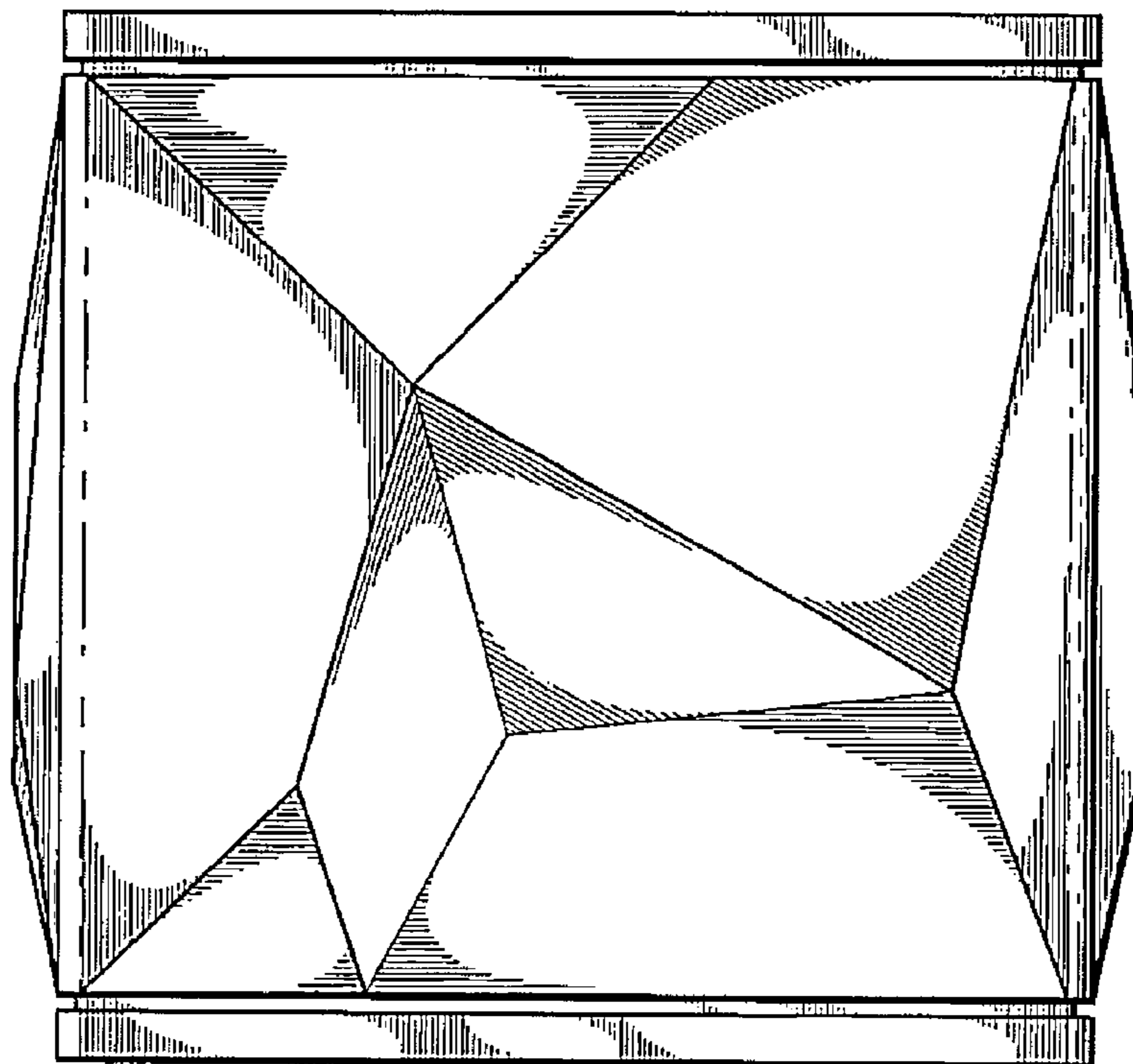

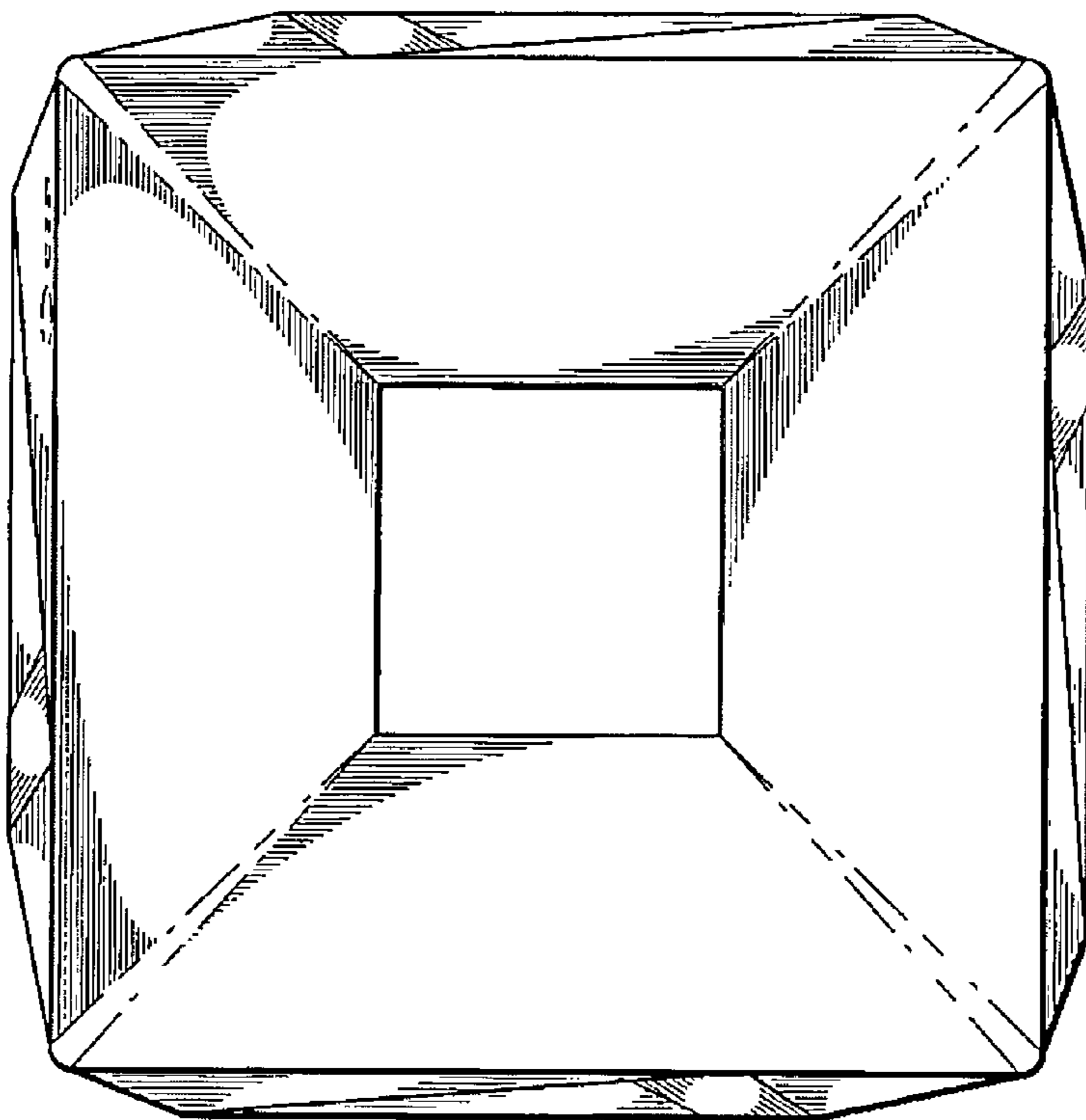
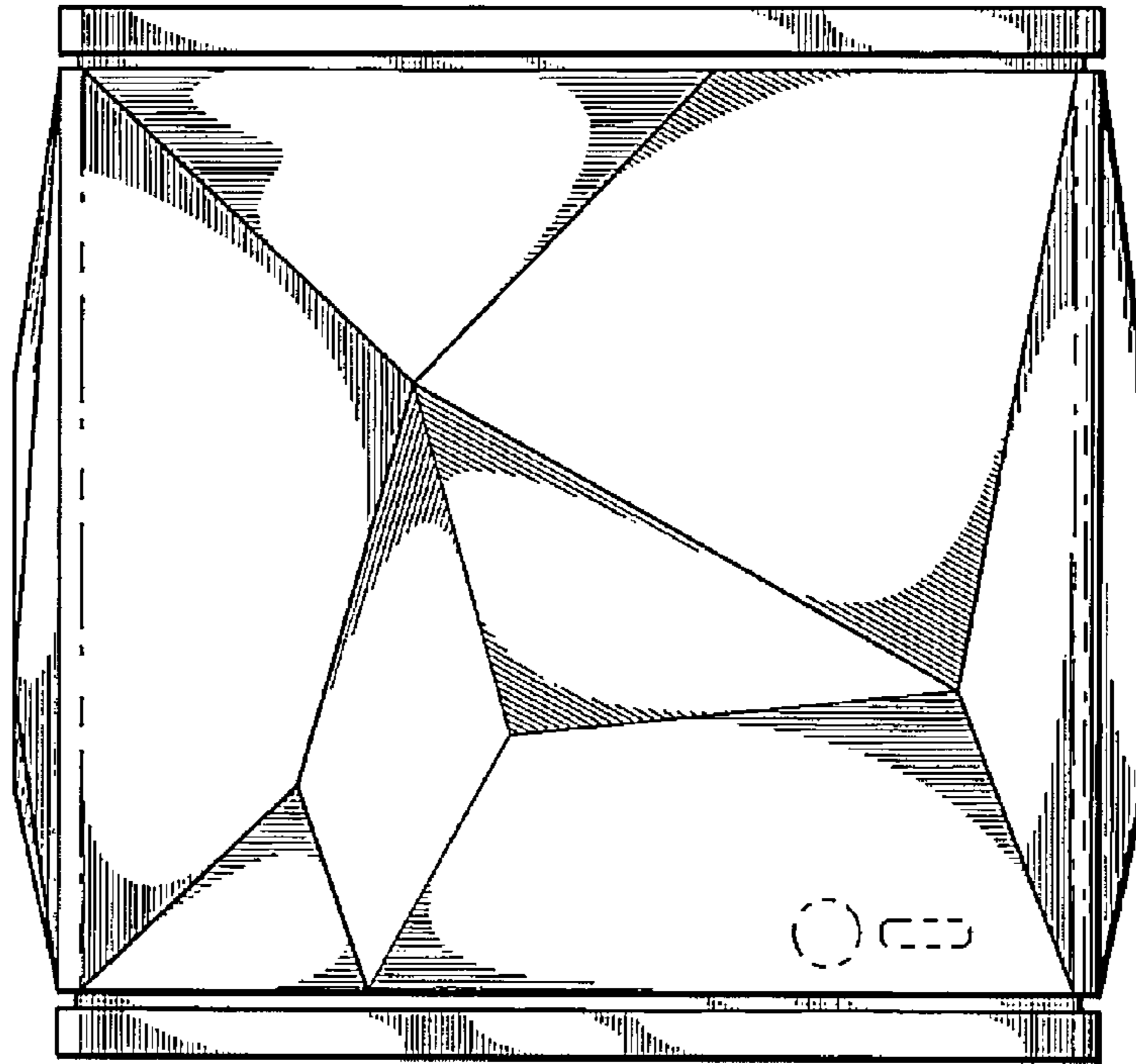

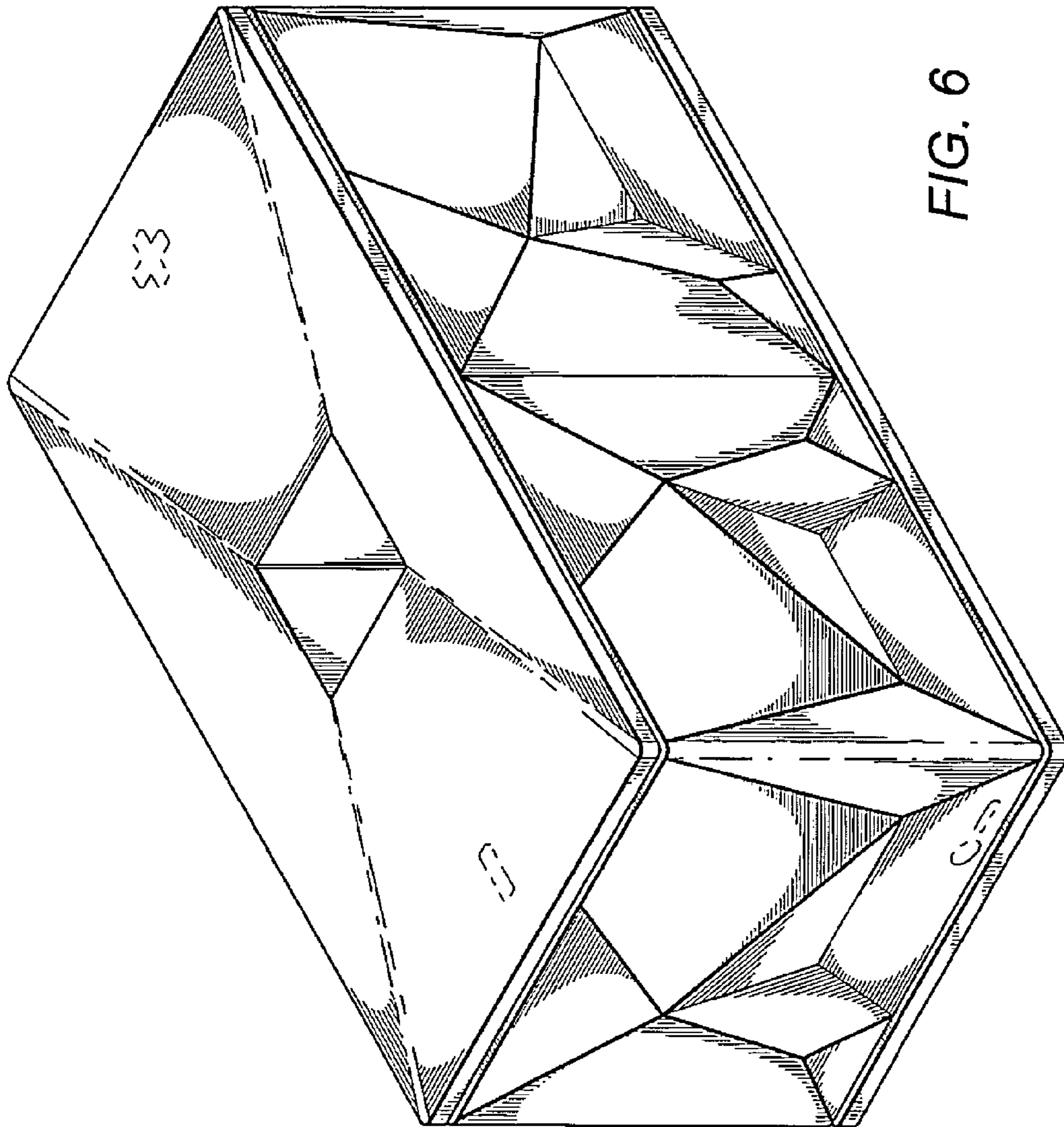

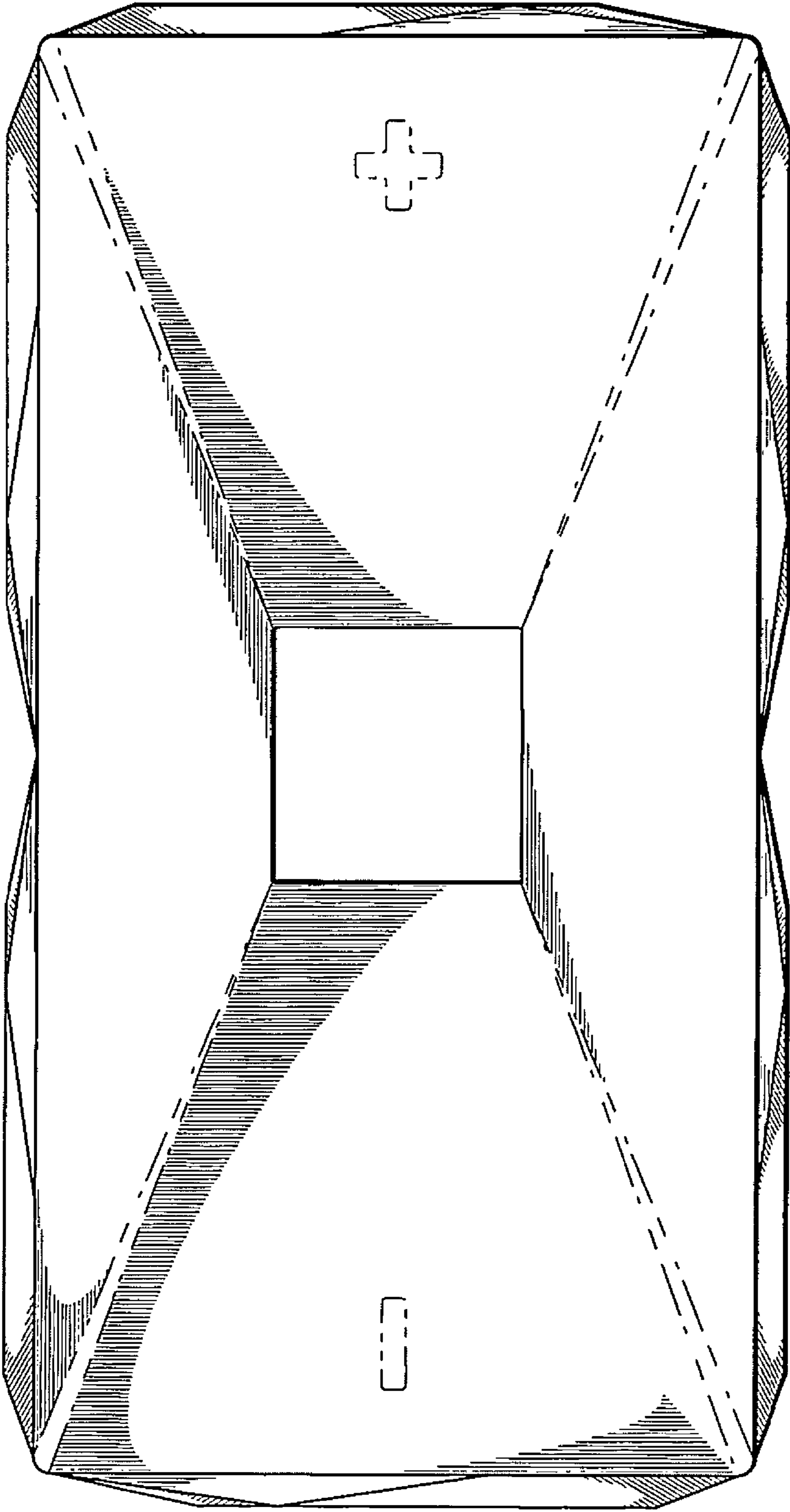

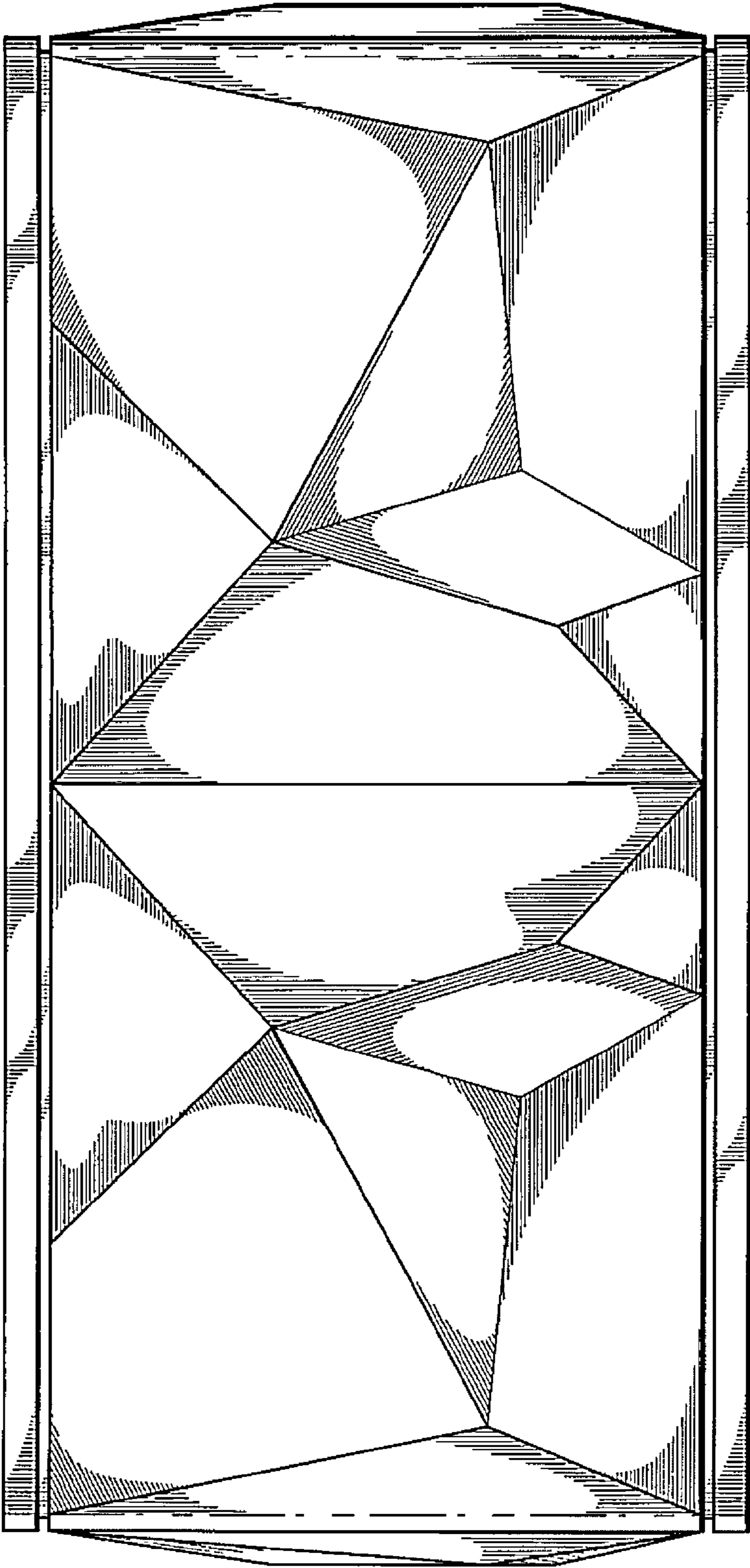

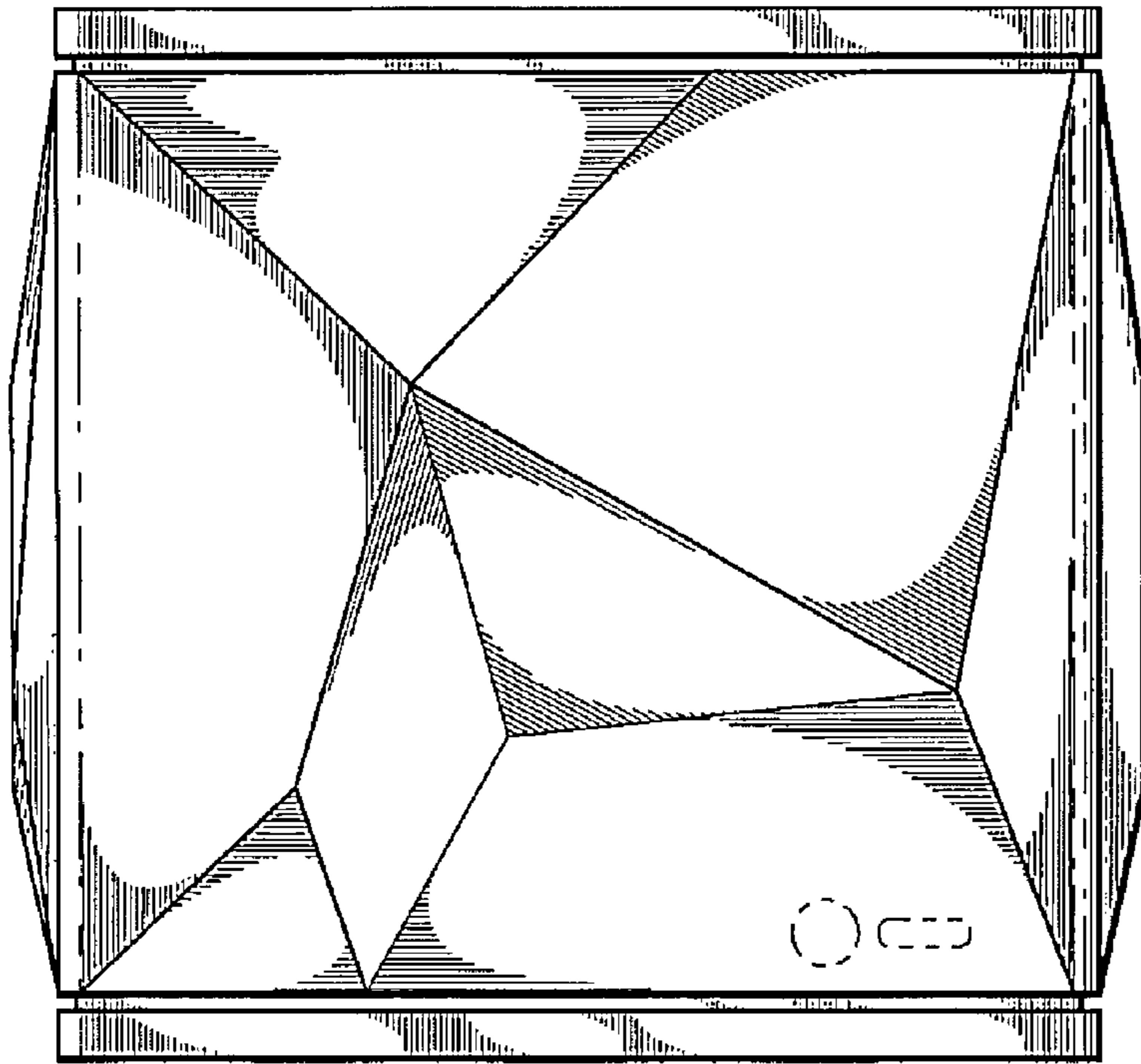
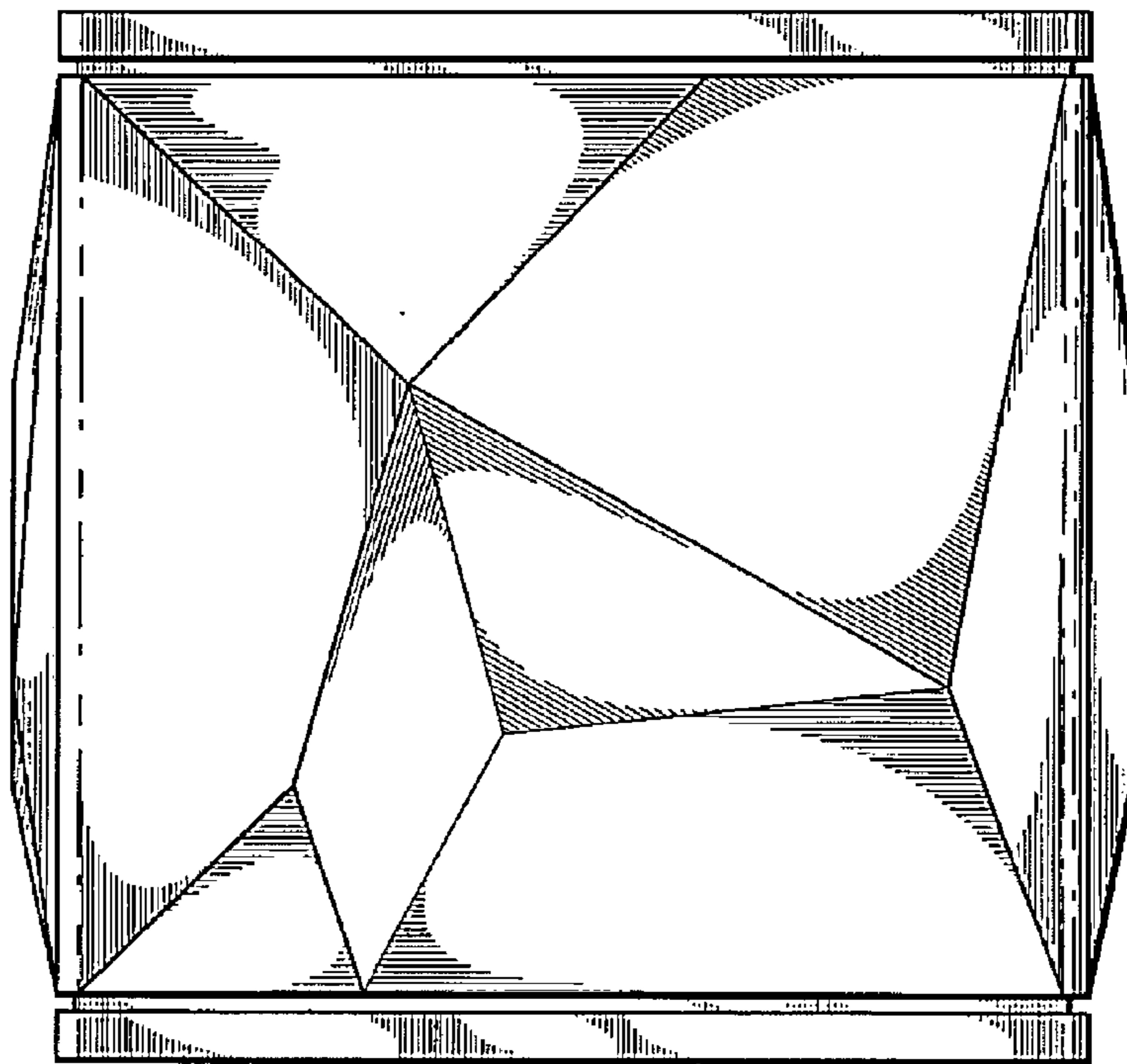

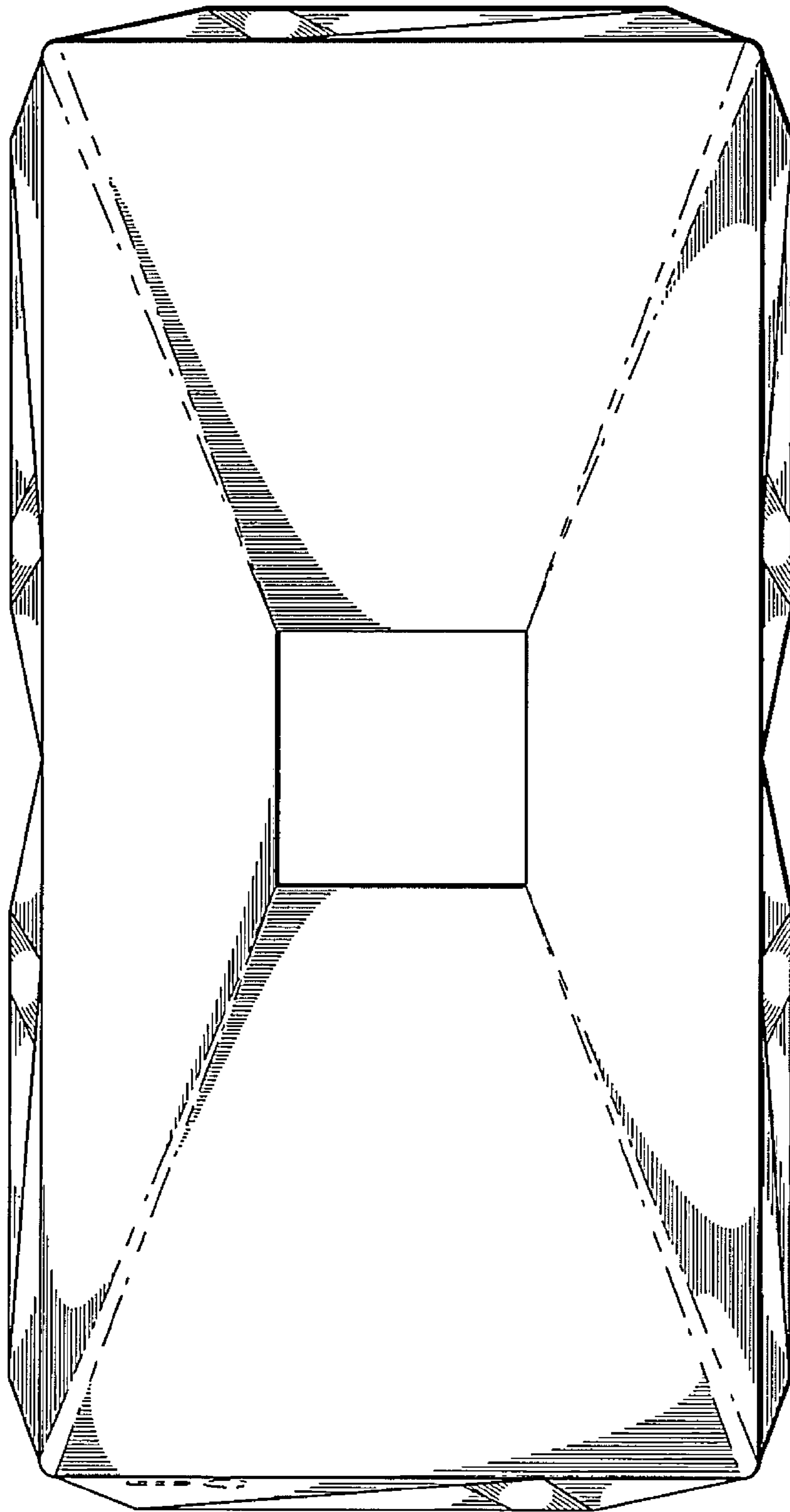

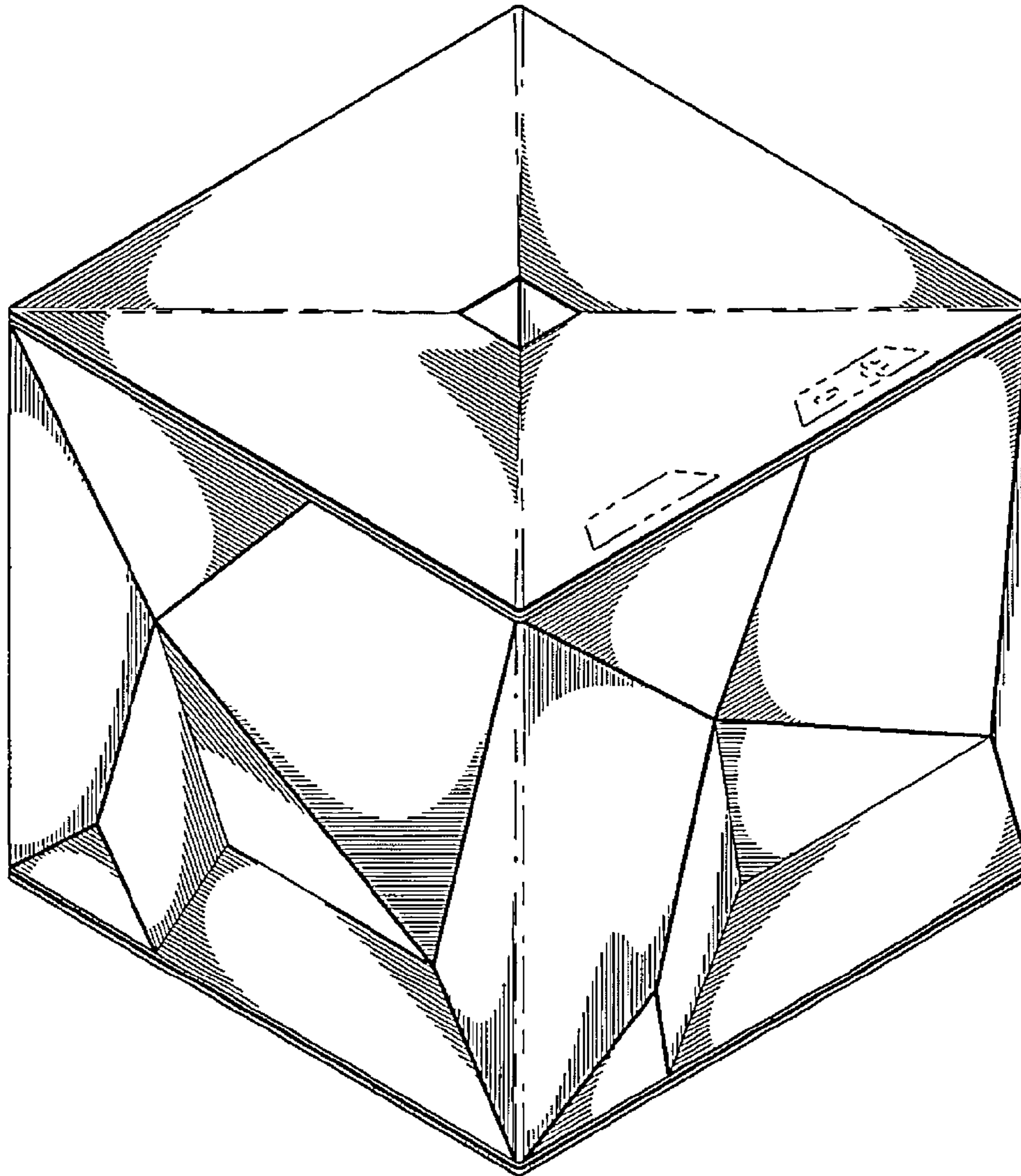

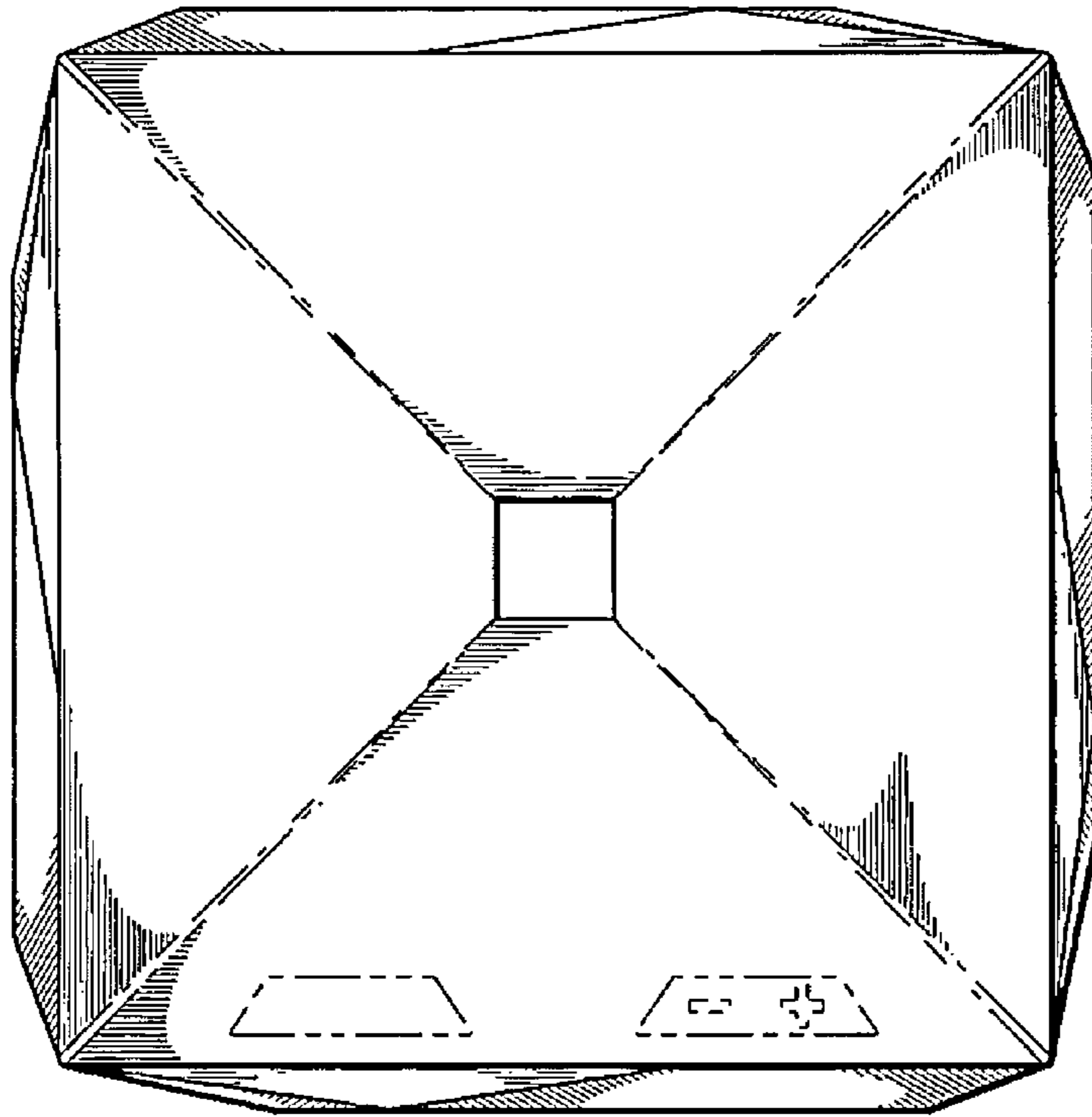
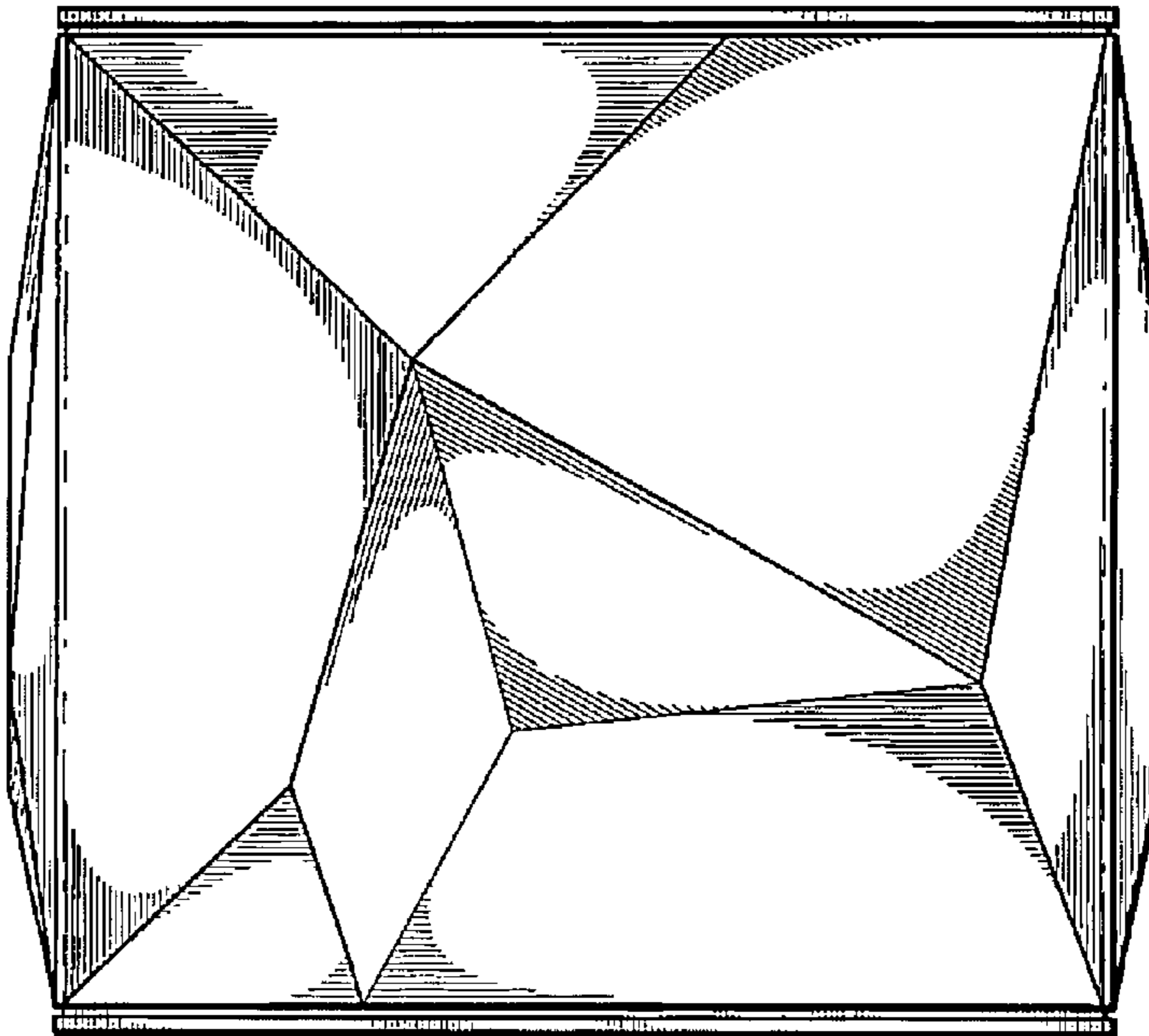

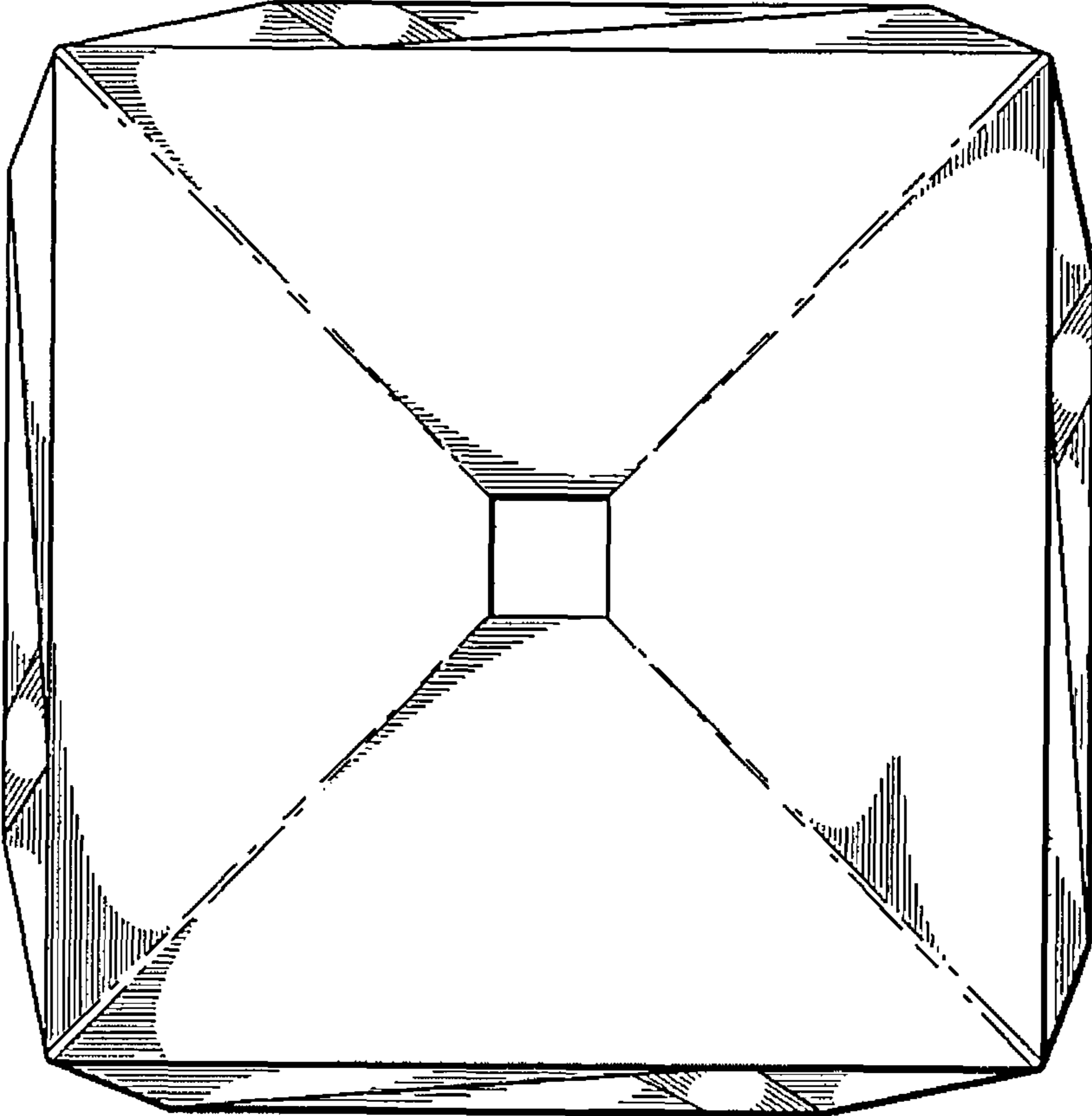
