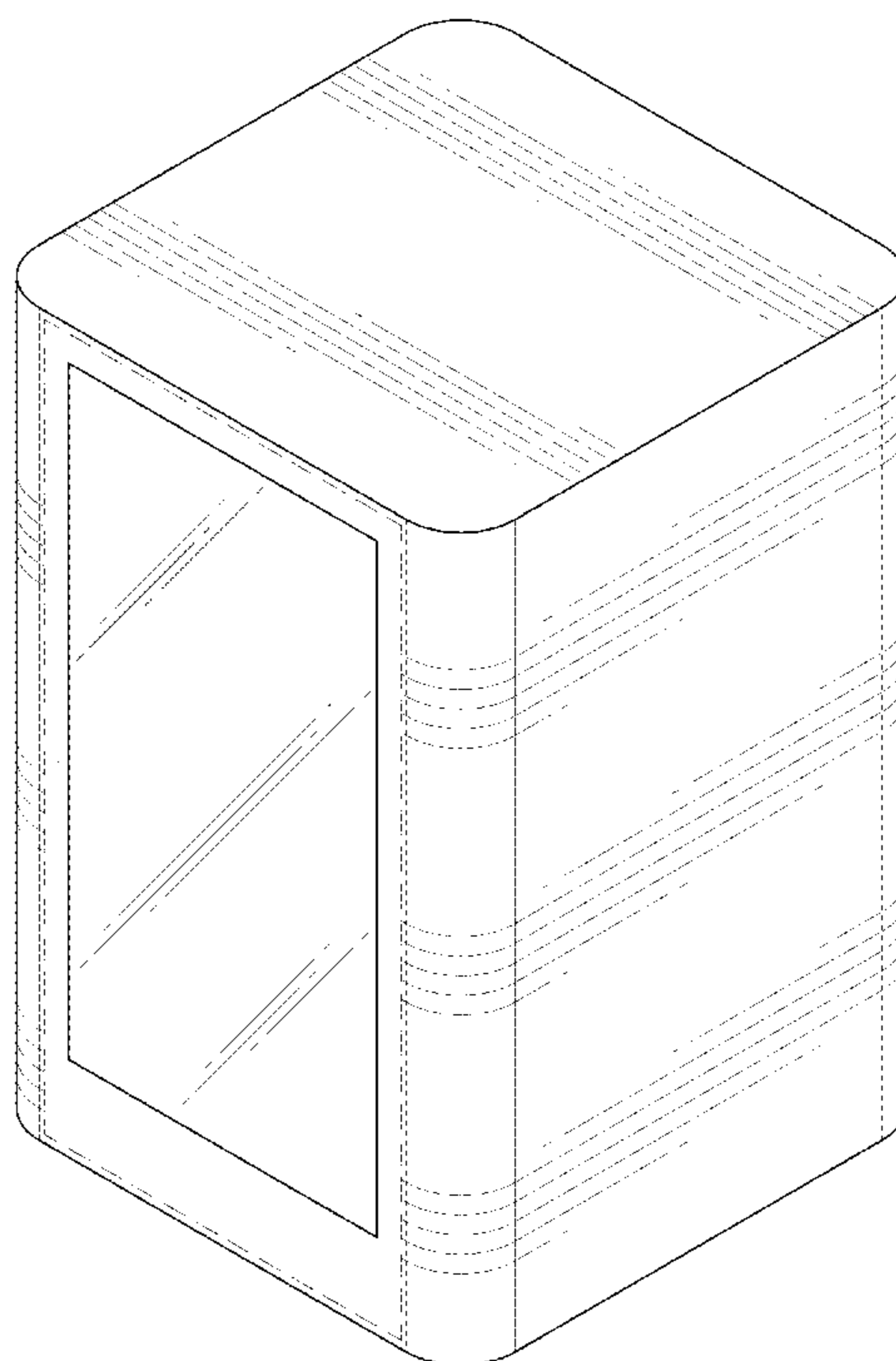
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, front, side perspective view of a home data center;
FIG. 2 is a bottom, back, side perspective view of the home data center shown in FIG. 1;
FIG. 3 is a front view of the home data center shown in FIG. 1;
FIG. 4 is a back view of the home data center shown in FIG. 1;

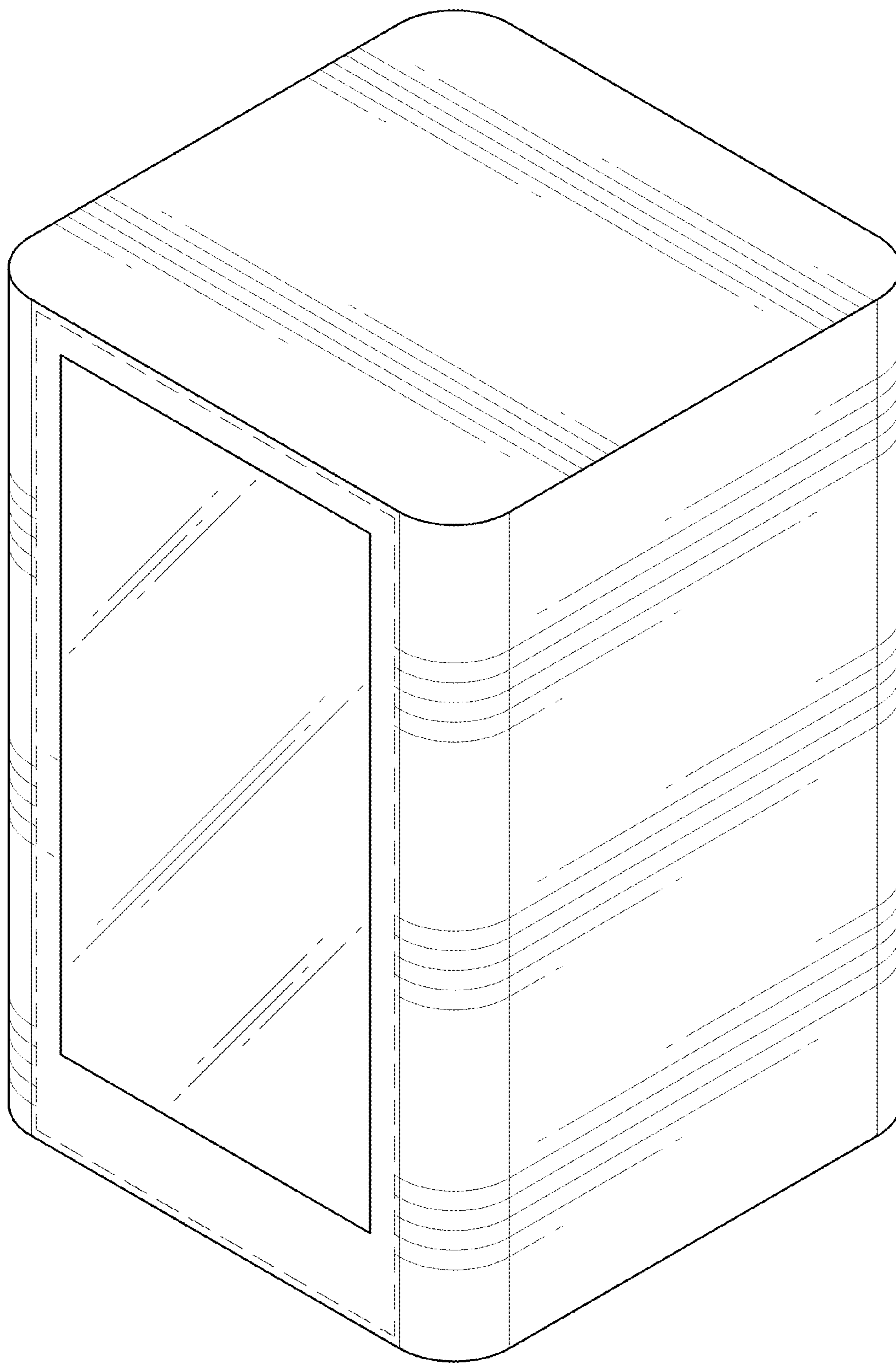

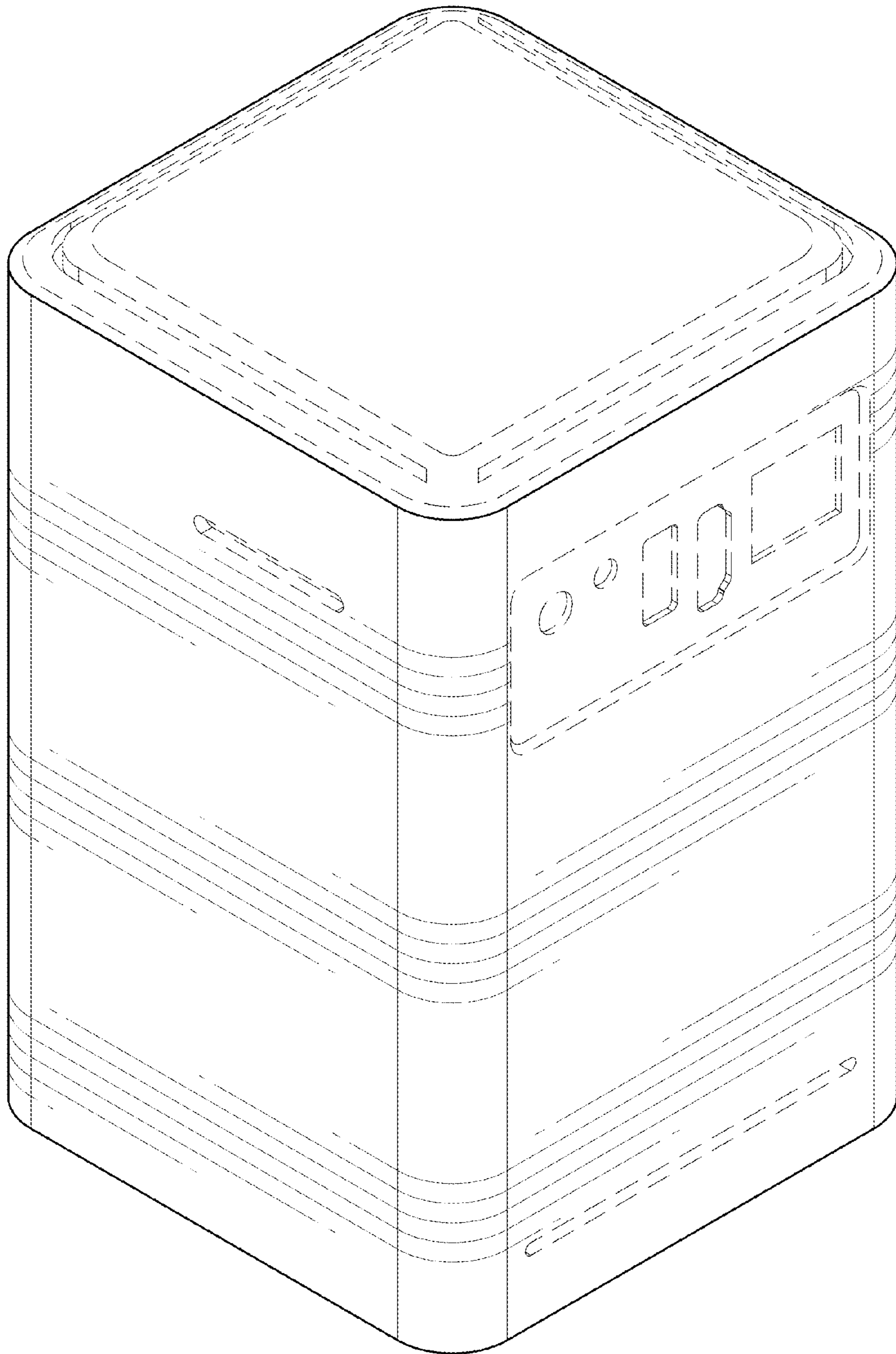

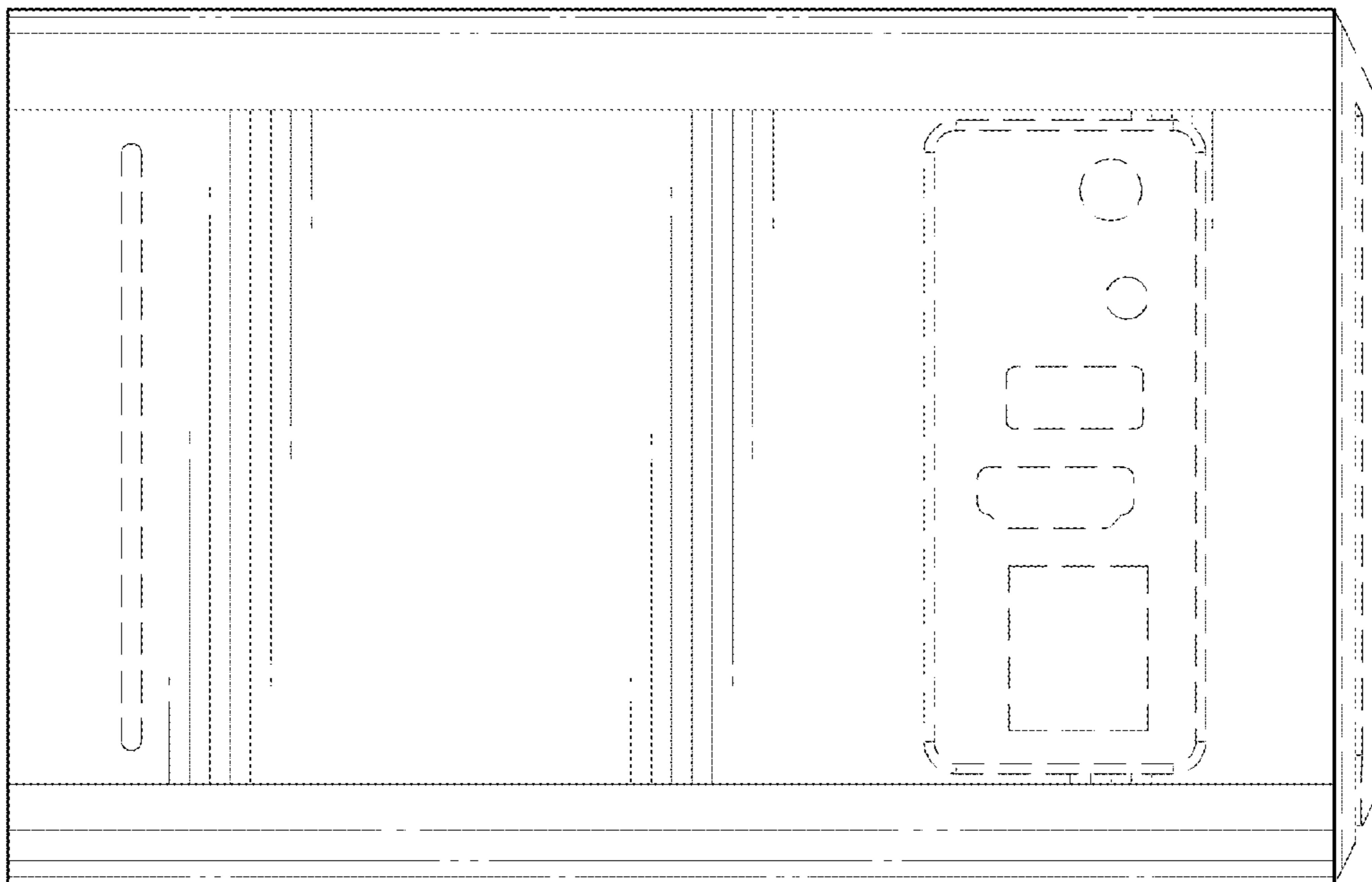

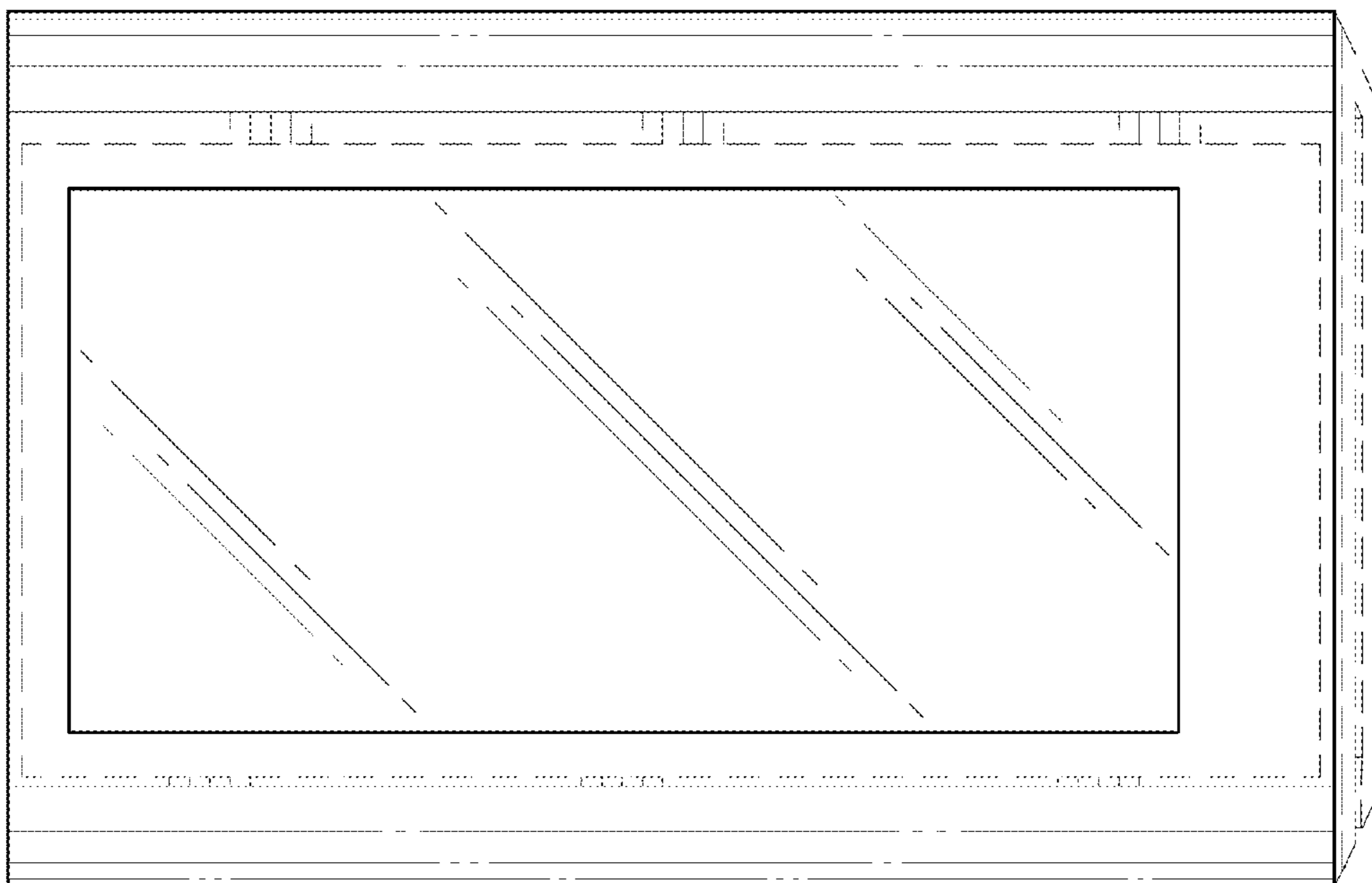

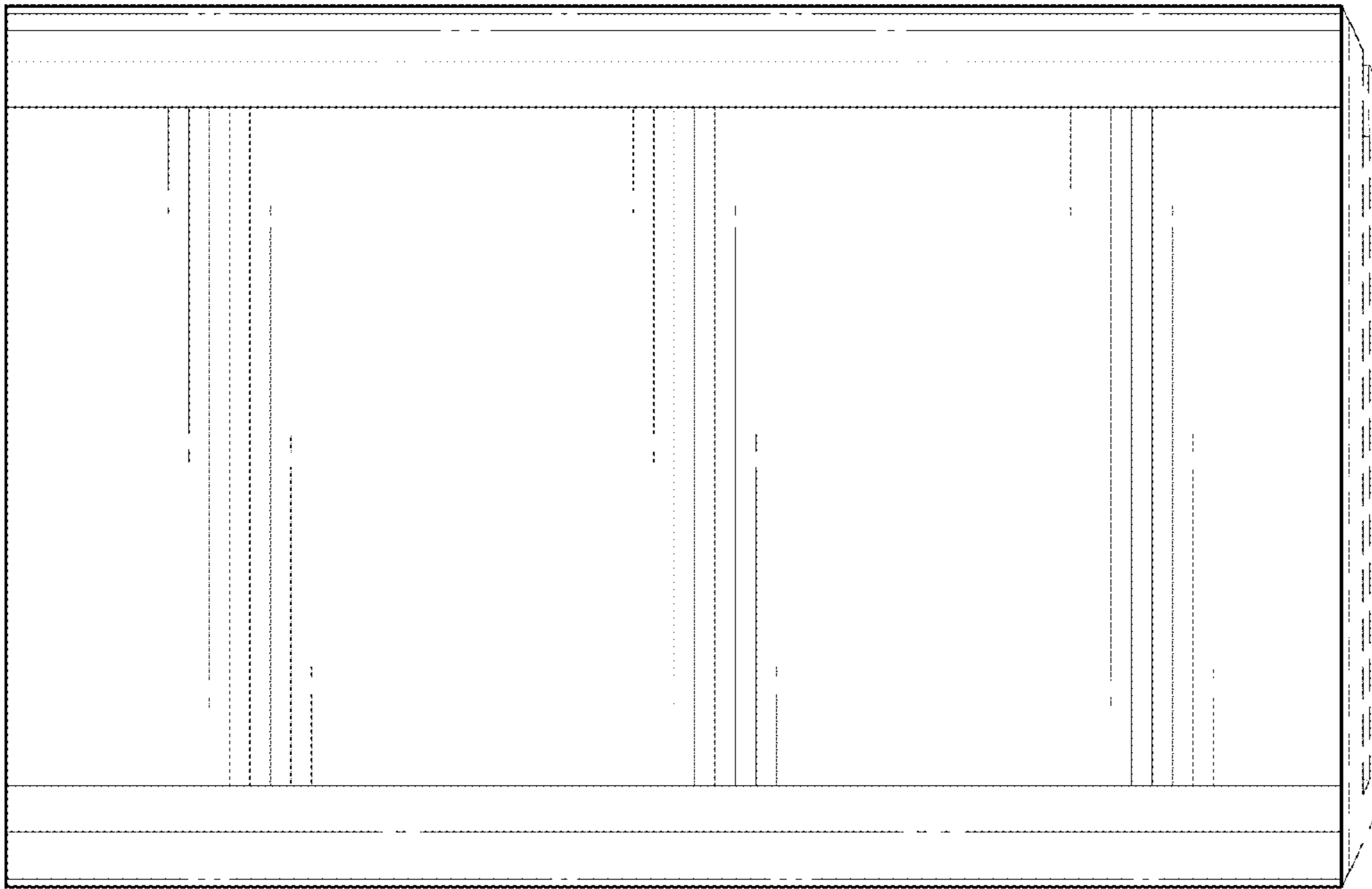

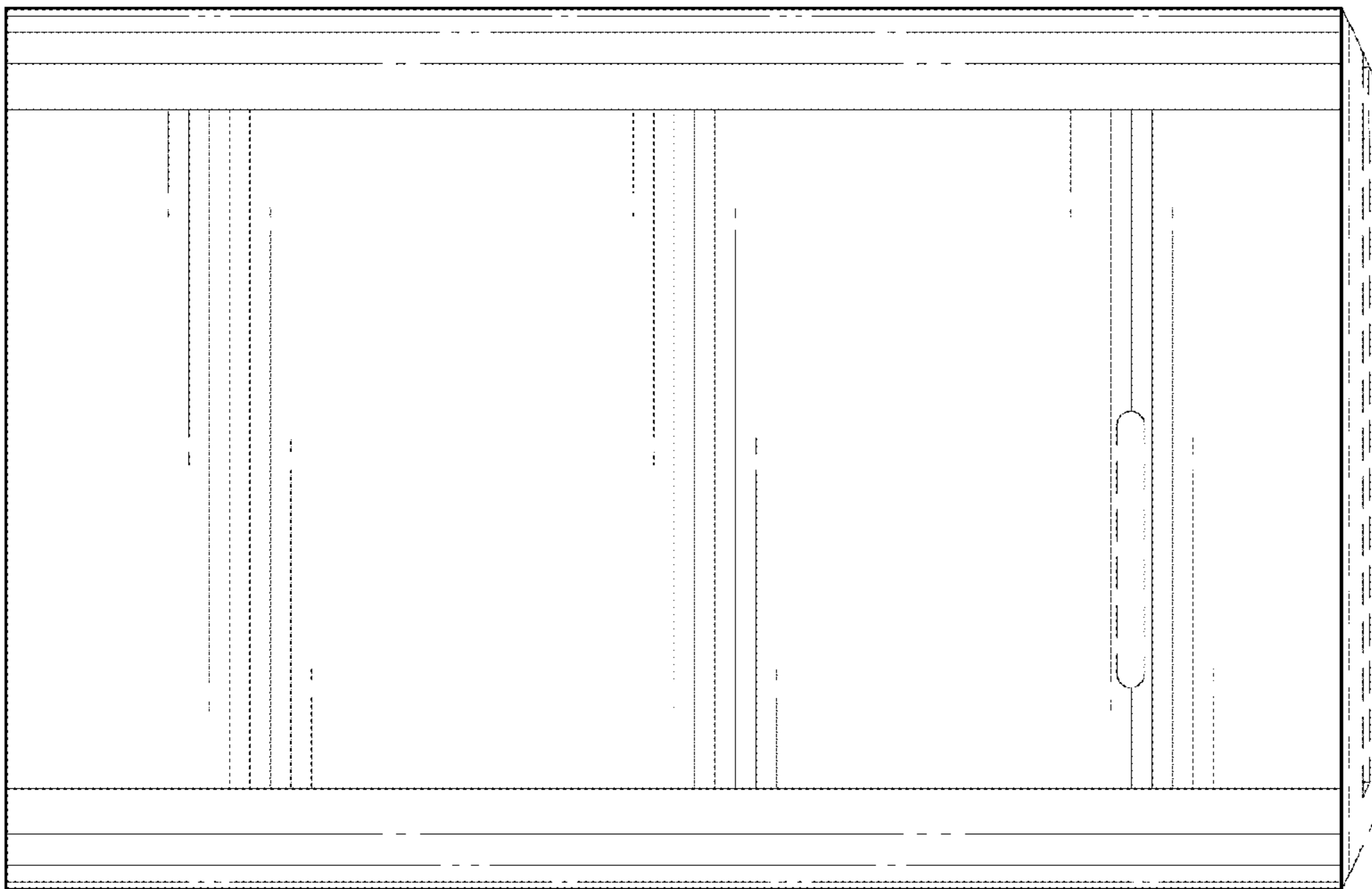

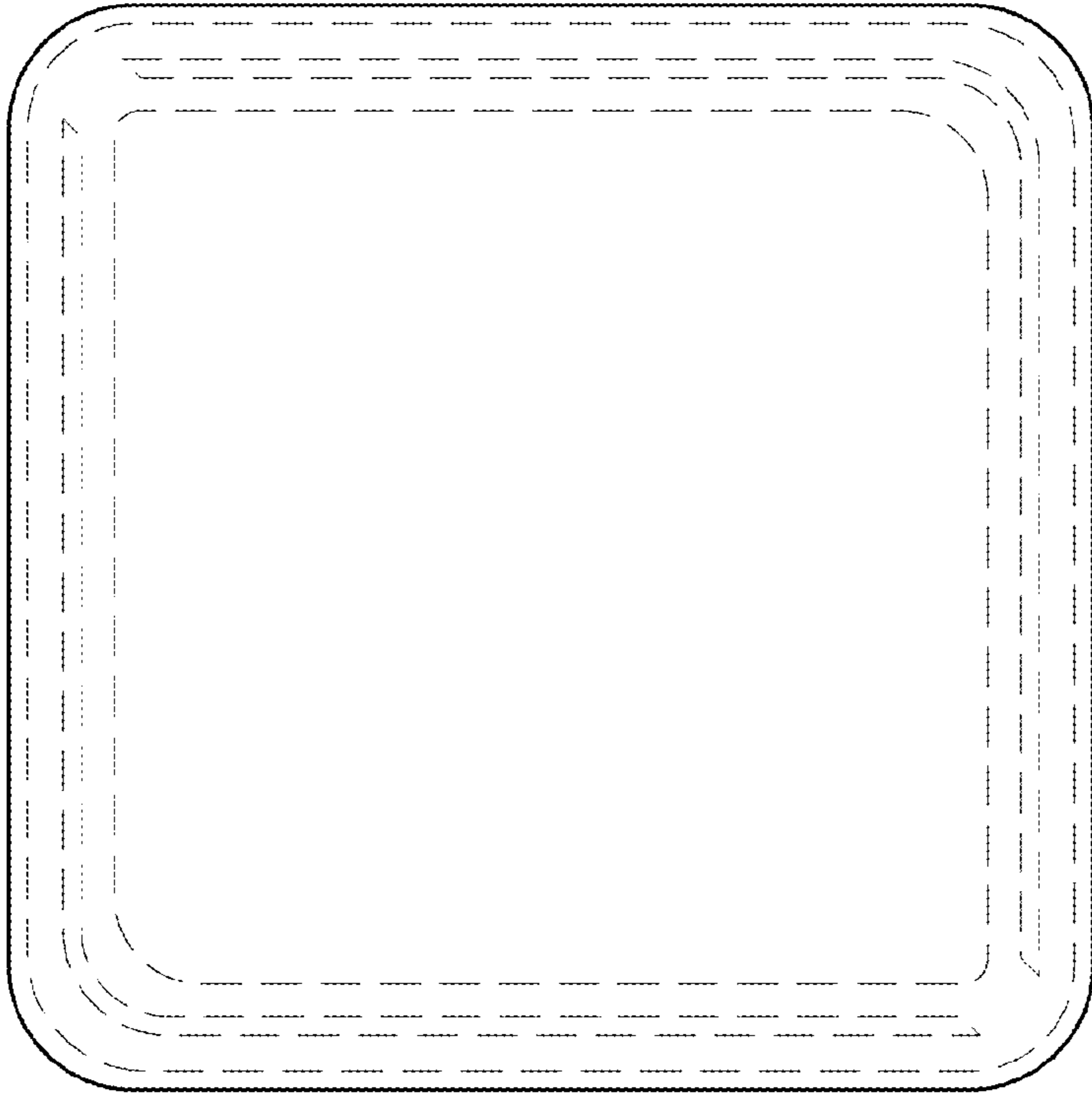

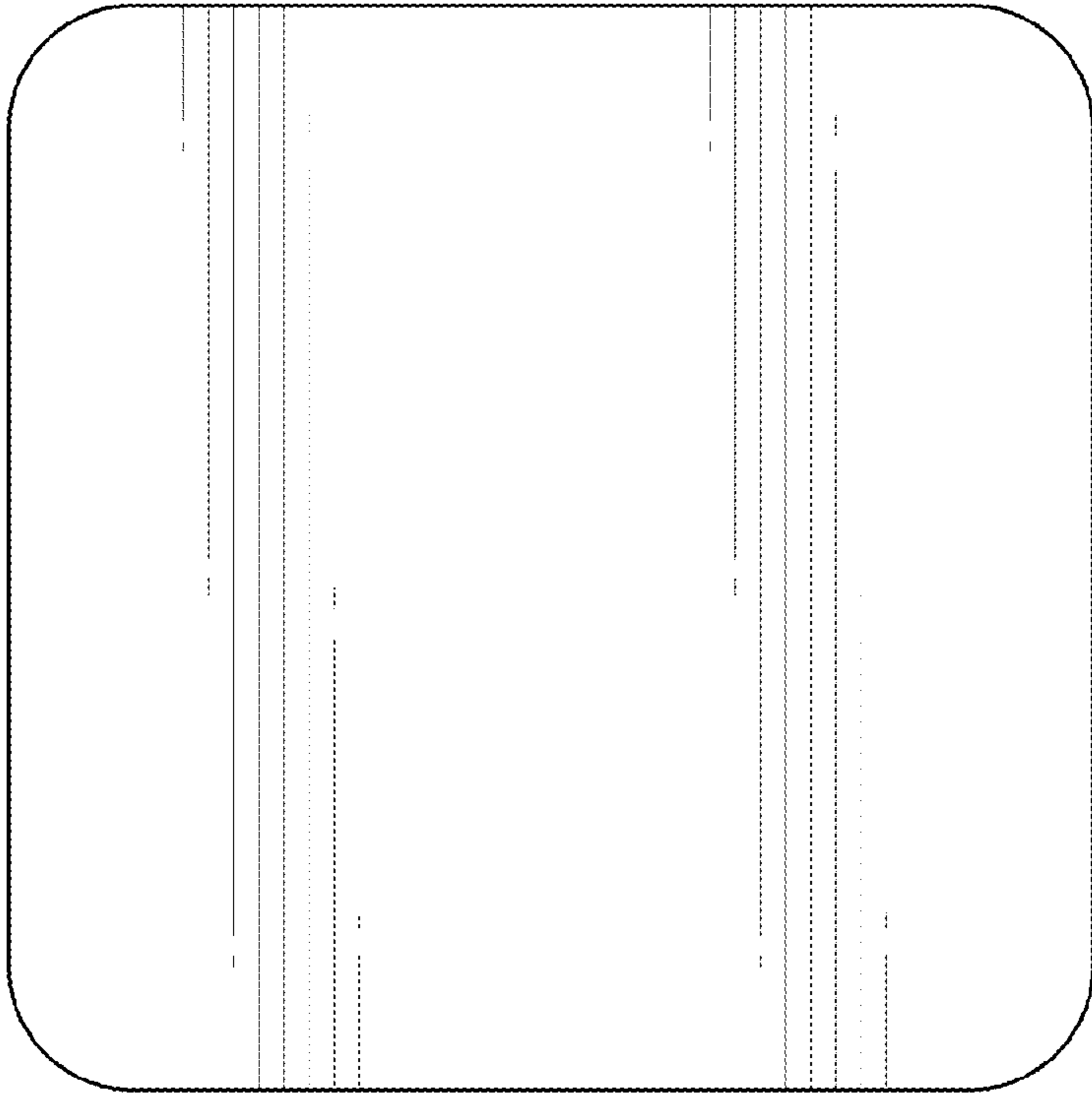
