The ornamental design for a notebook computer, as shown and described.

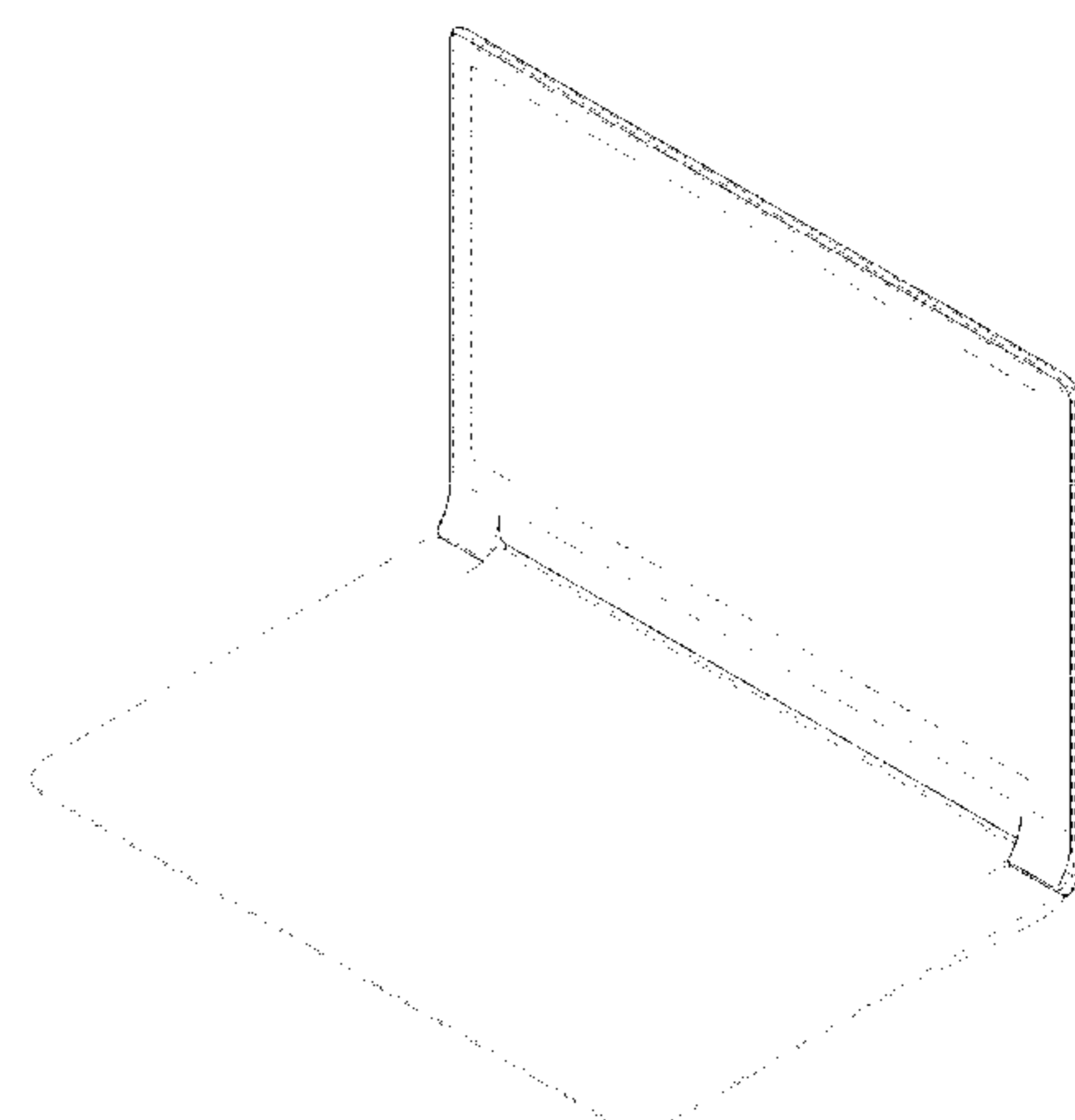
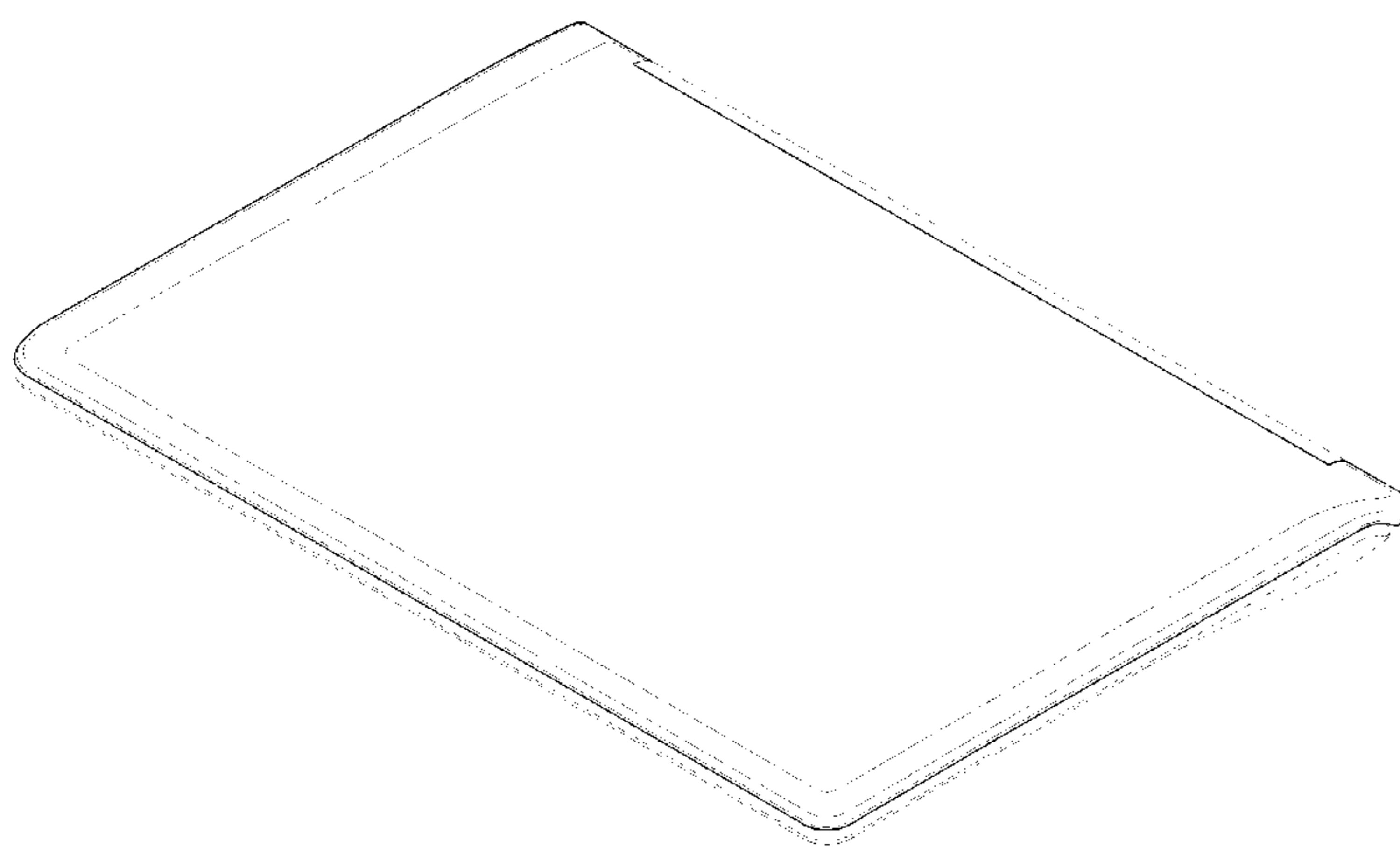
**DESCRIPTION**

FIG. 8 is the front perspective view thereof in use environment.

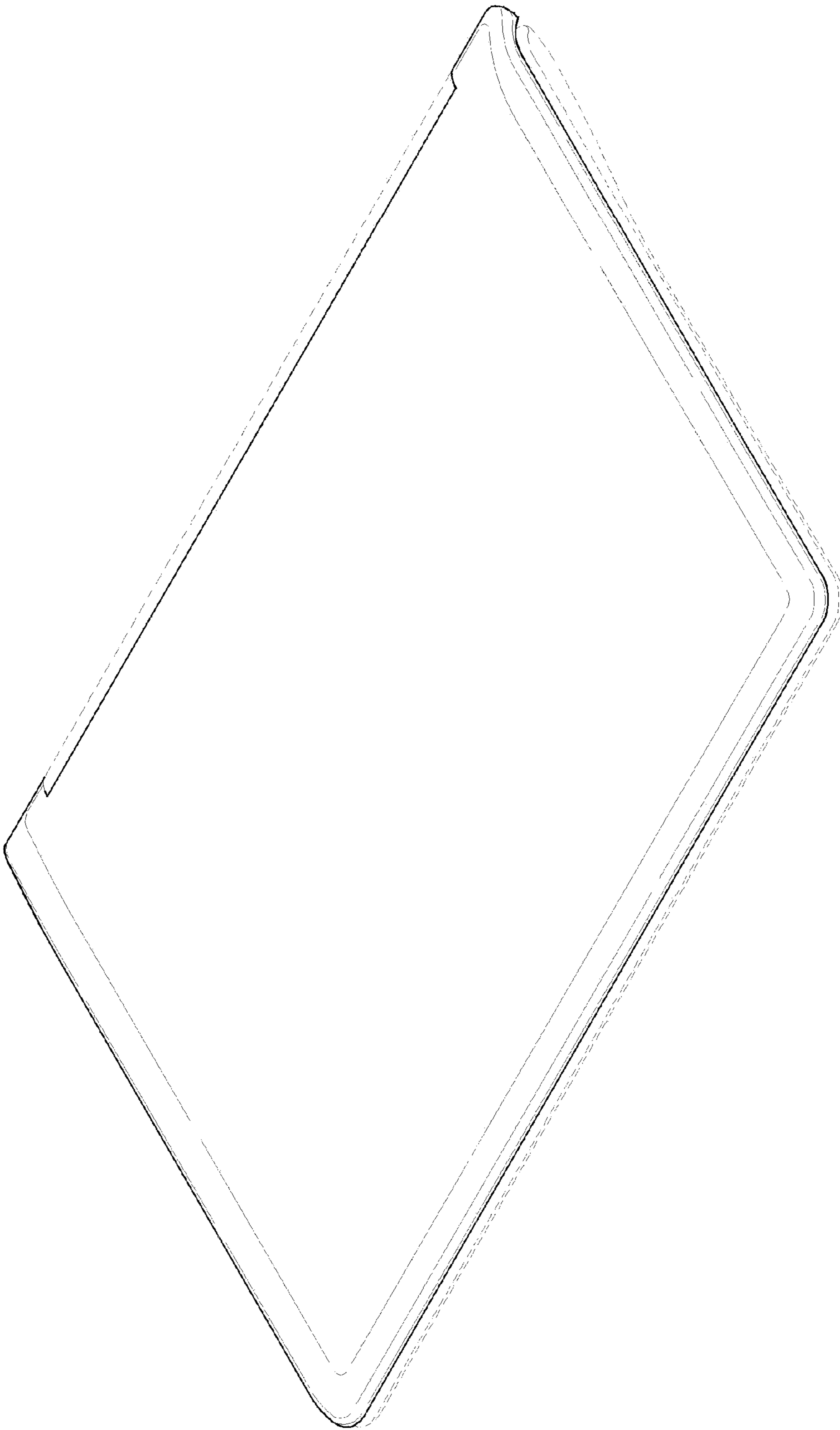
The broken lines are for environmental purposes only and form no part of the claimed design.

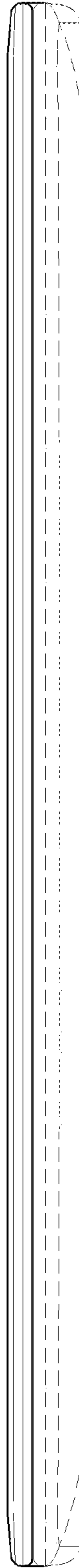
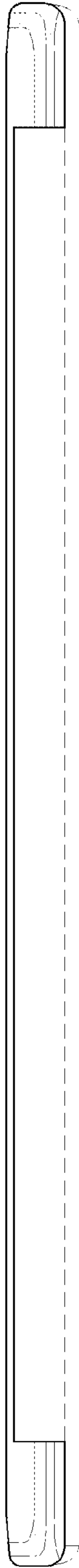

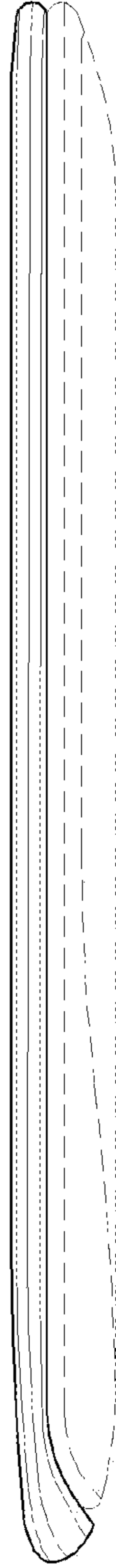

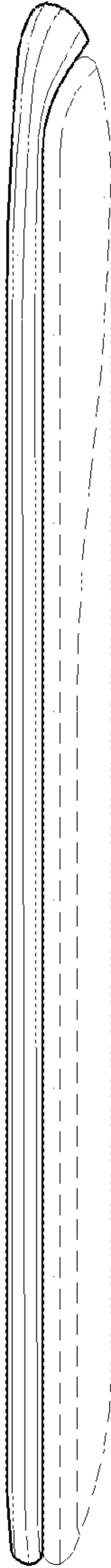

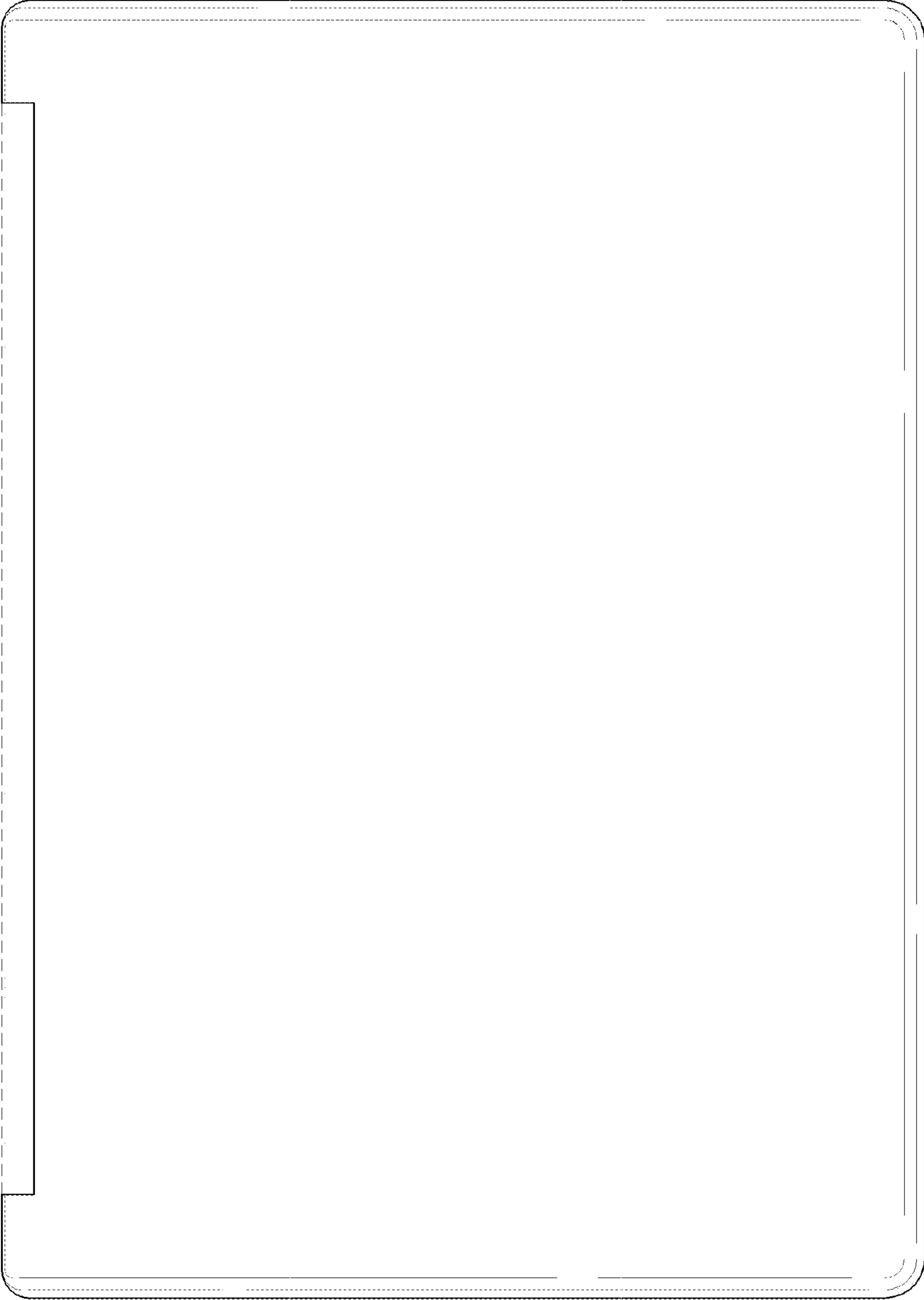
