(57) **CLAIM**

We claim the ornamental design for a display screen for a digital camera with an animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first image of a display screen for a digital camera with an animated graphical user interface showing our new design;

FIG. 3 is a front view of a third image thereof;

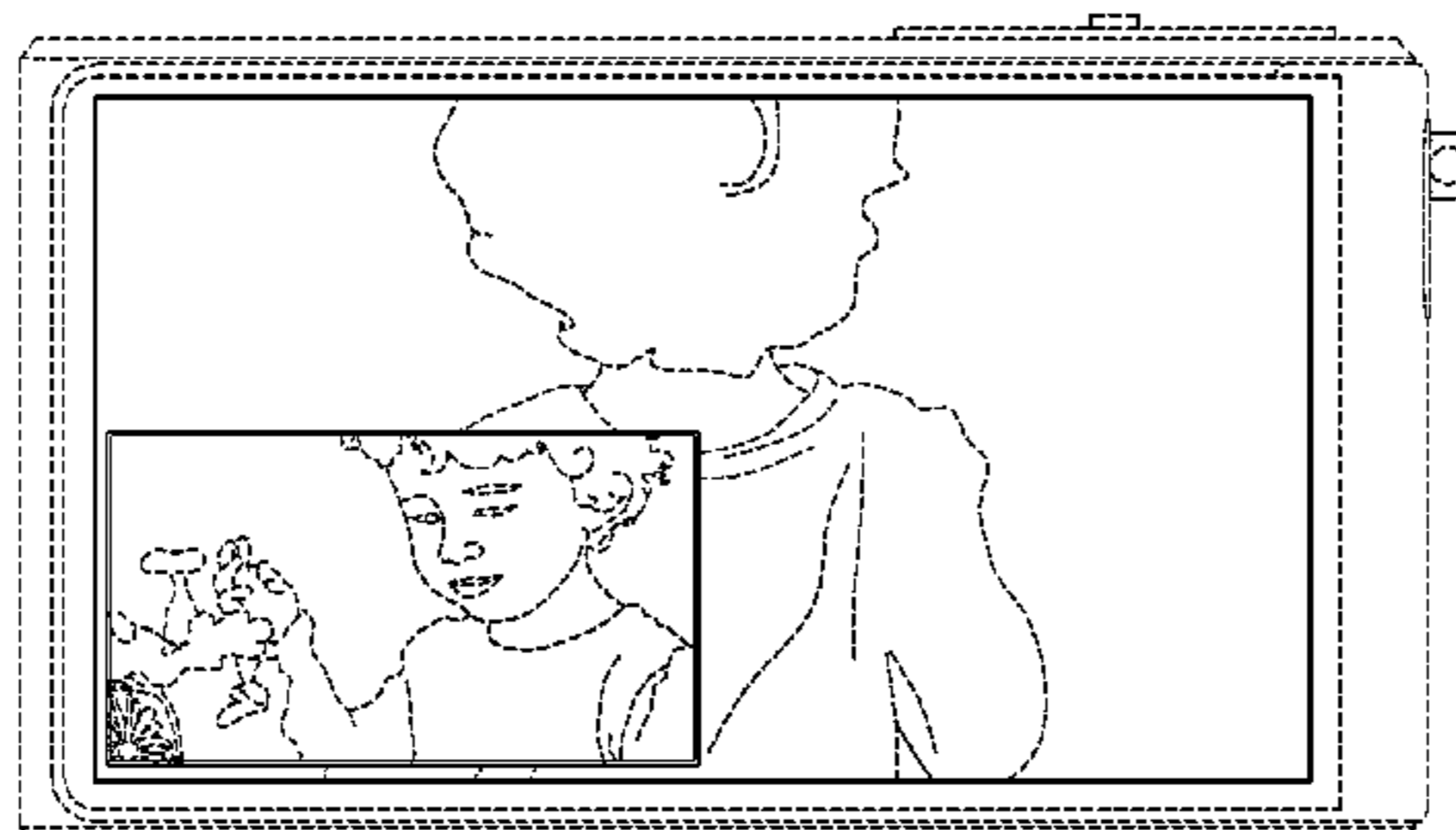
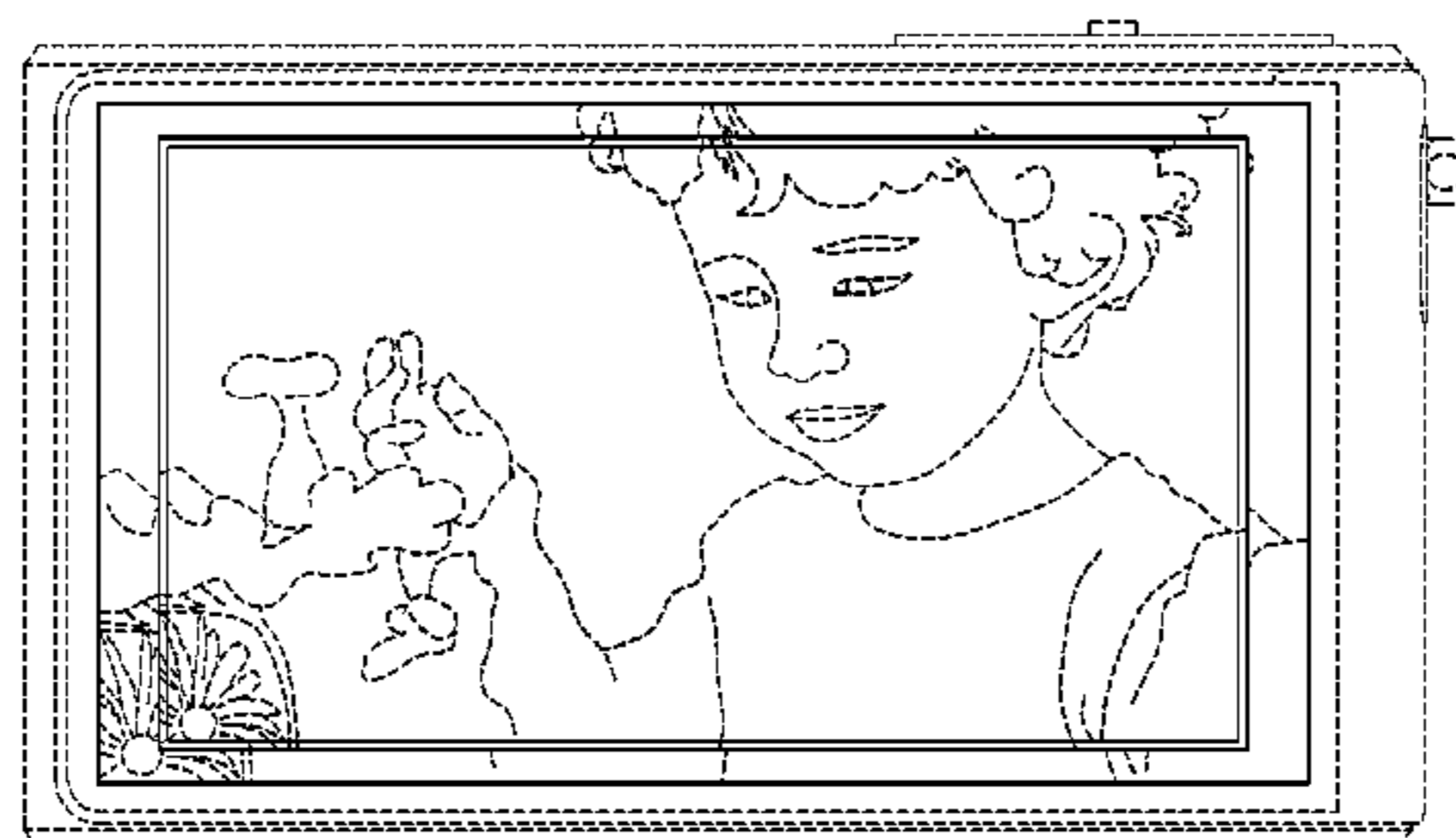
FIG. 4 is a front view of a fourth image thereof; and,

FIG. 5 is a front view of a fifth image thereof.

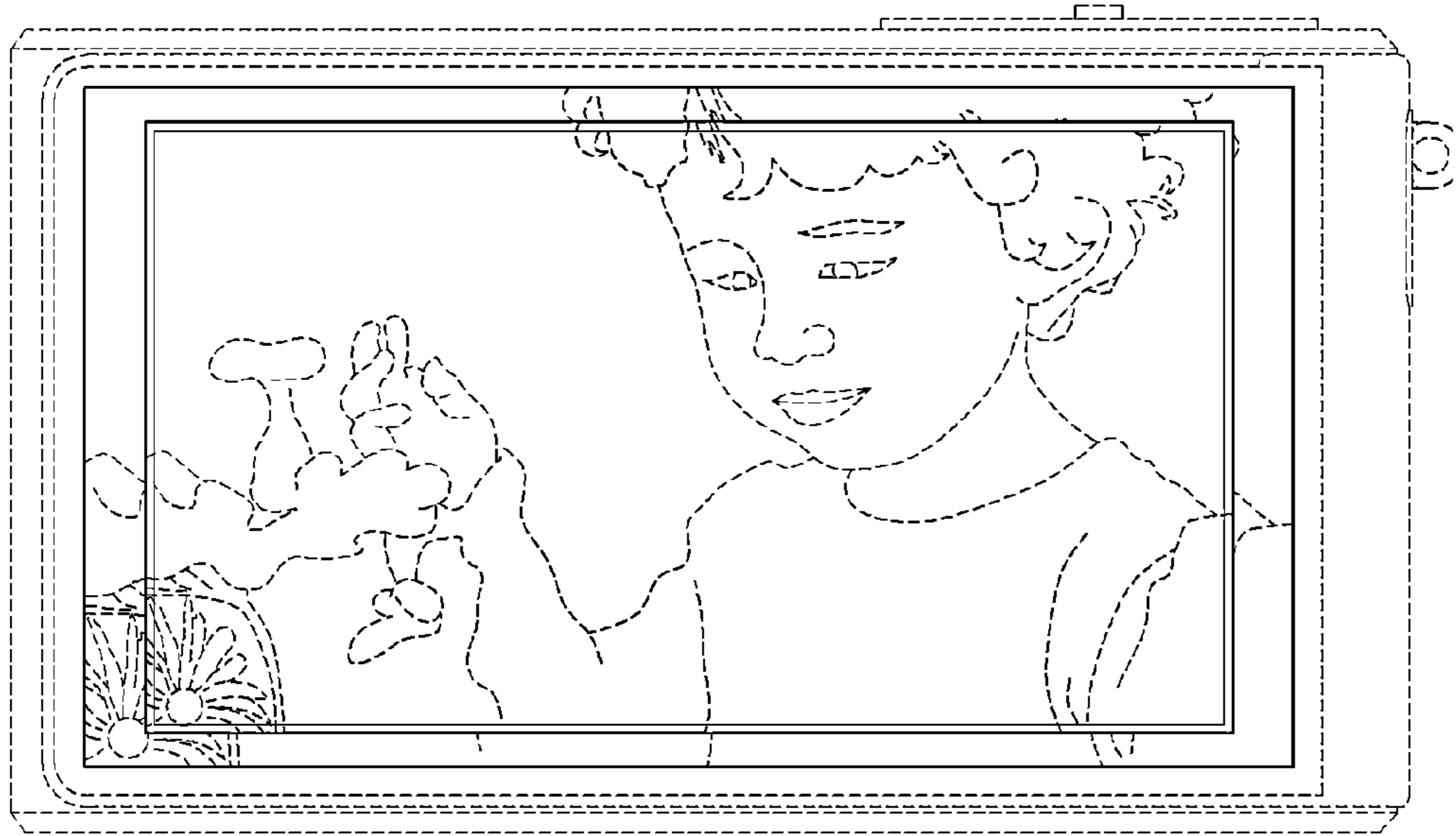

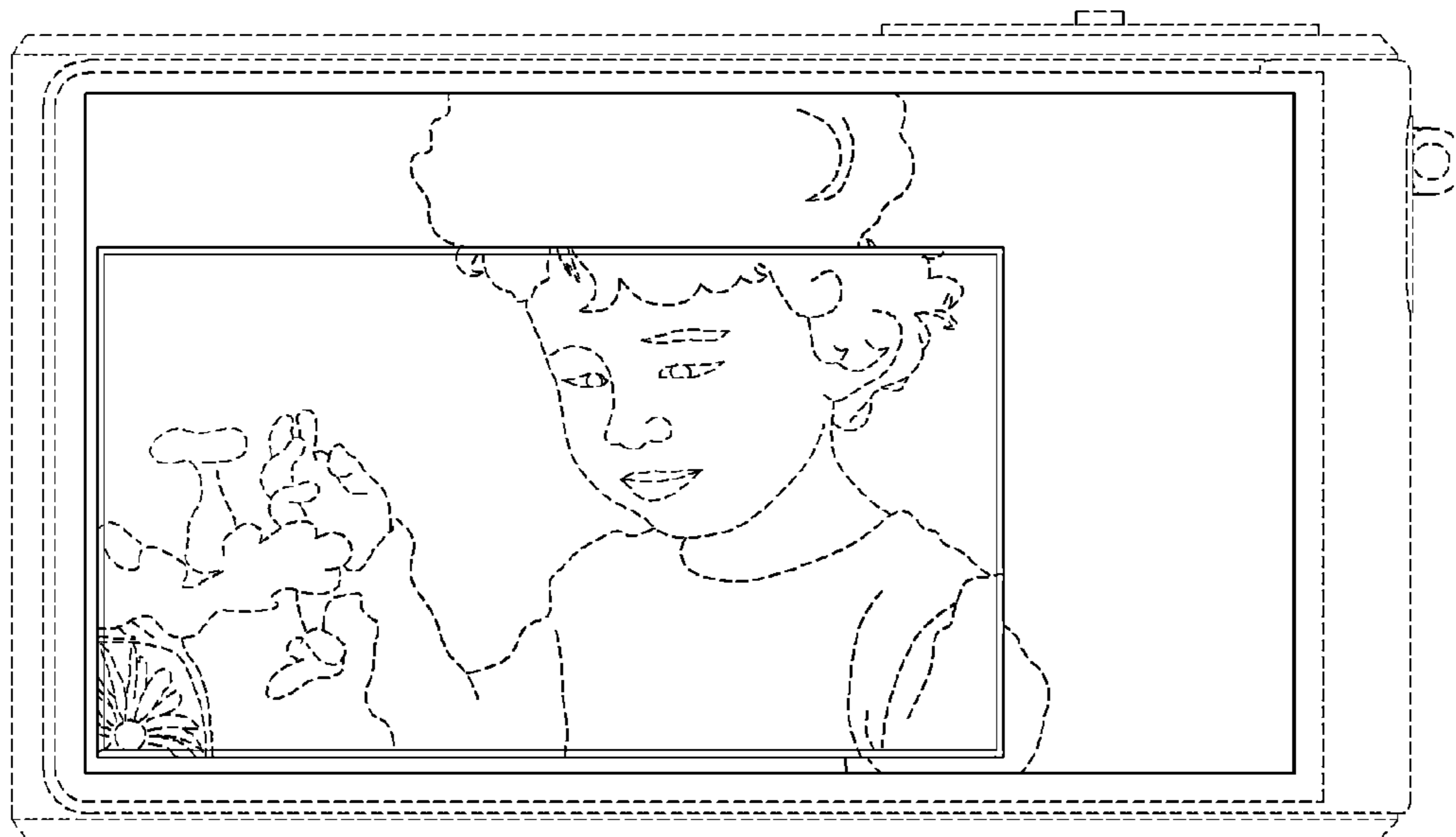

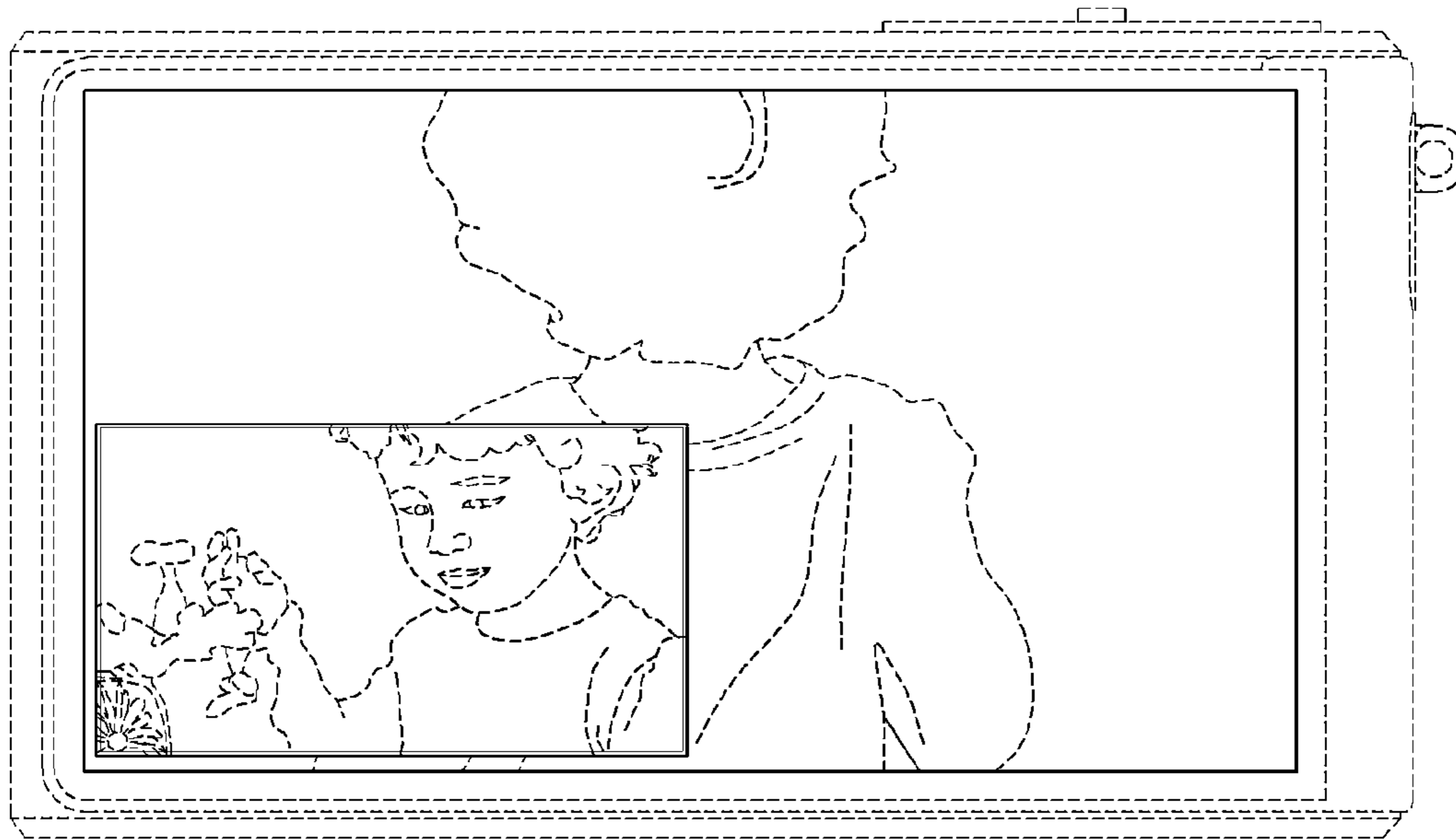
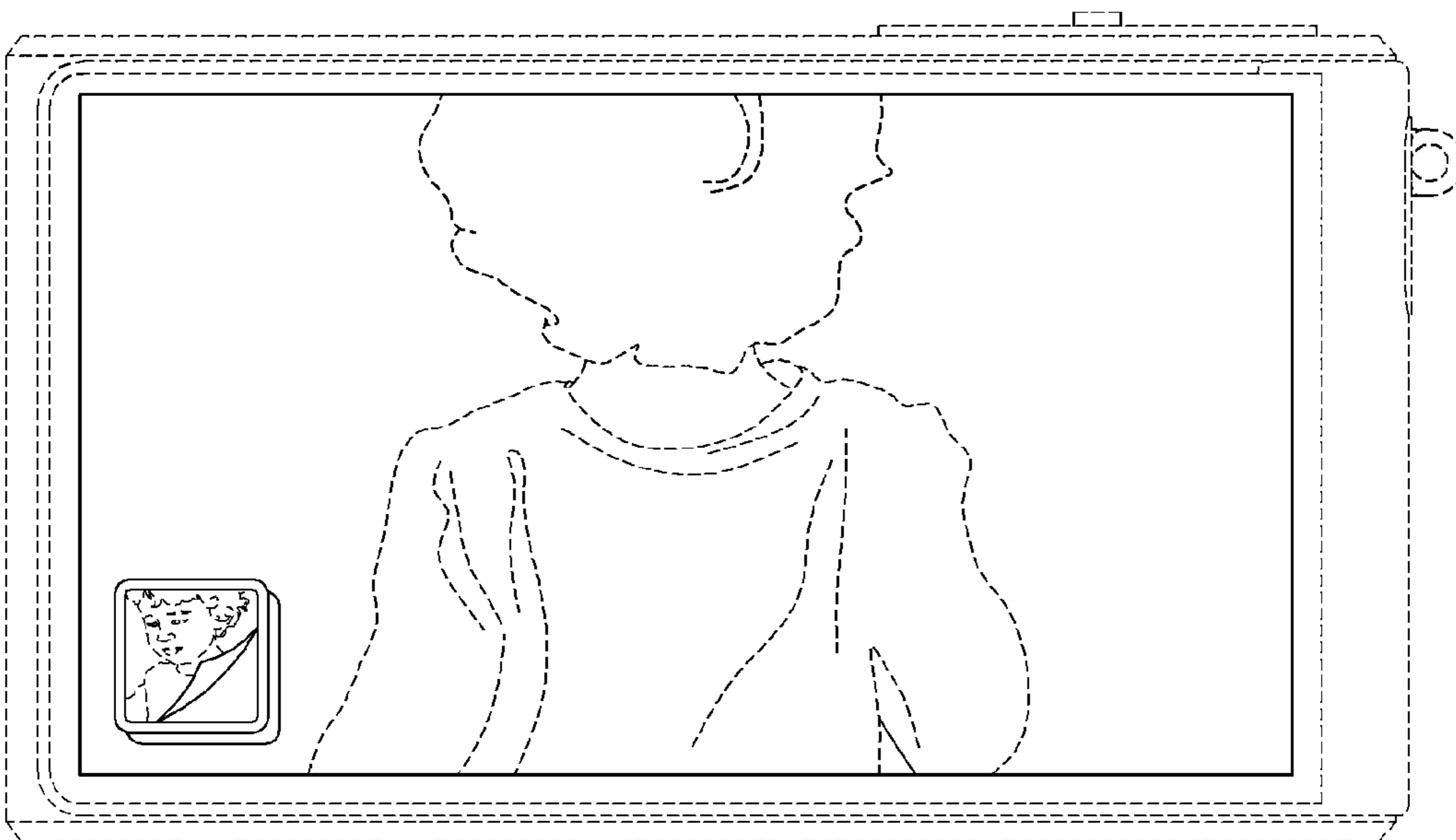
