The ornamental design for a refrigerator, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a refrigerator showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top plan view thereof where the bottom plan view is a mirror image; and,
FIG. 7 is a cross-sectional view taken along line 7-7 of FIG. 2. The broken lines shown in the drawings represent unclaimed portions of the refrigerator and form no part of the claimed design.

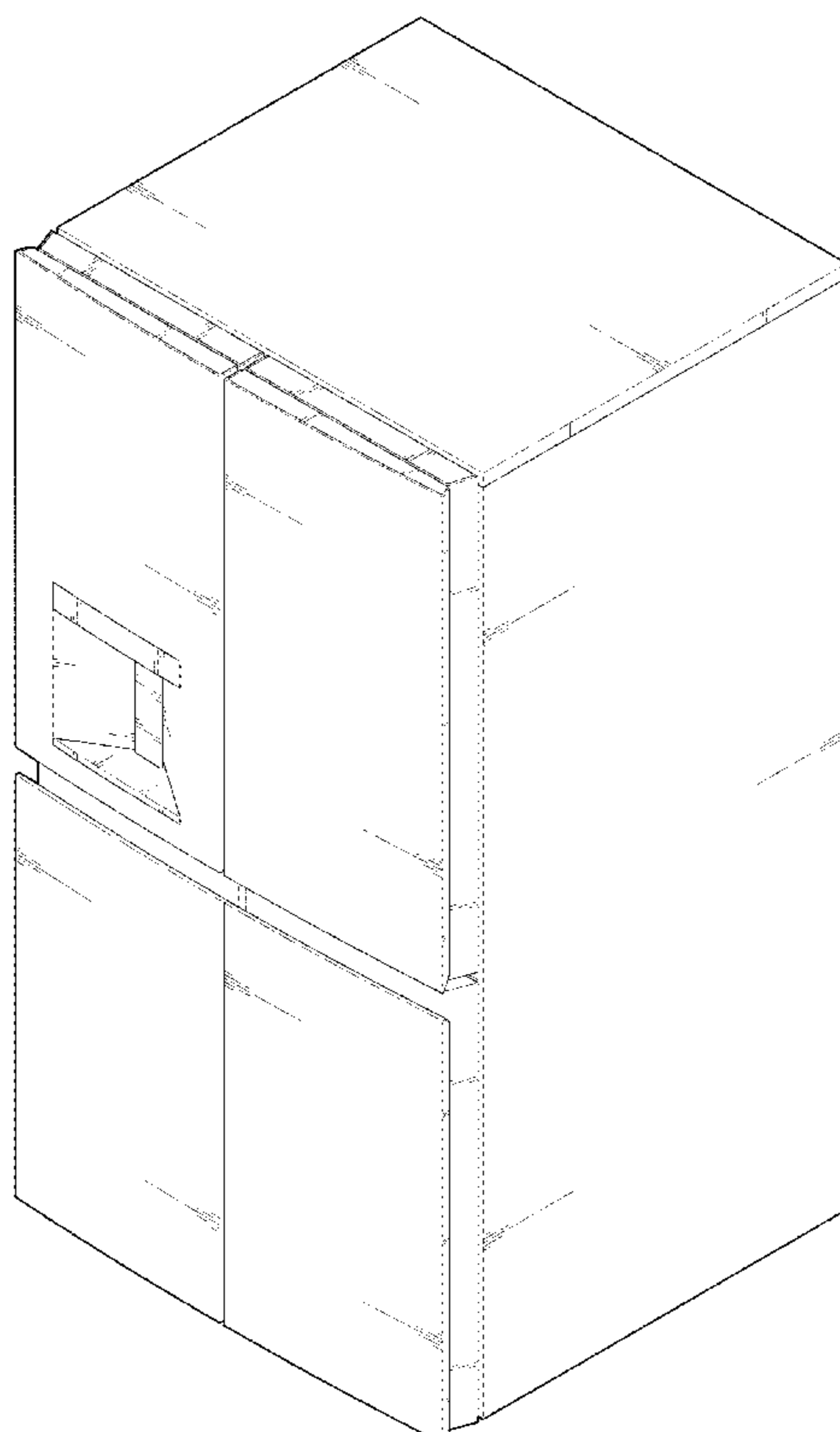

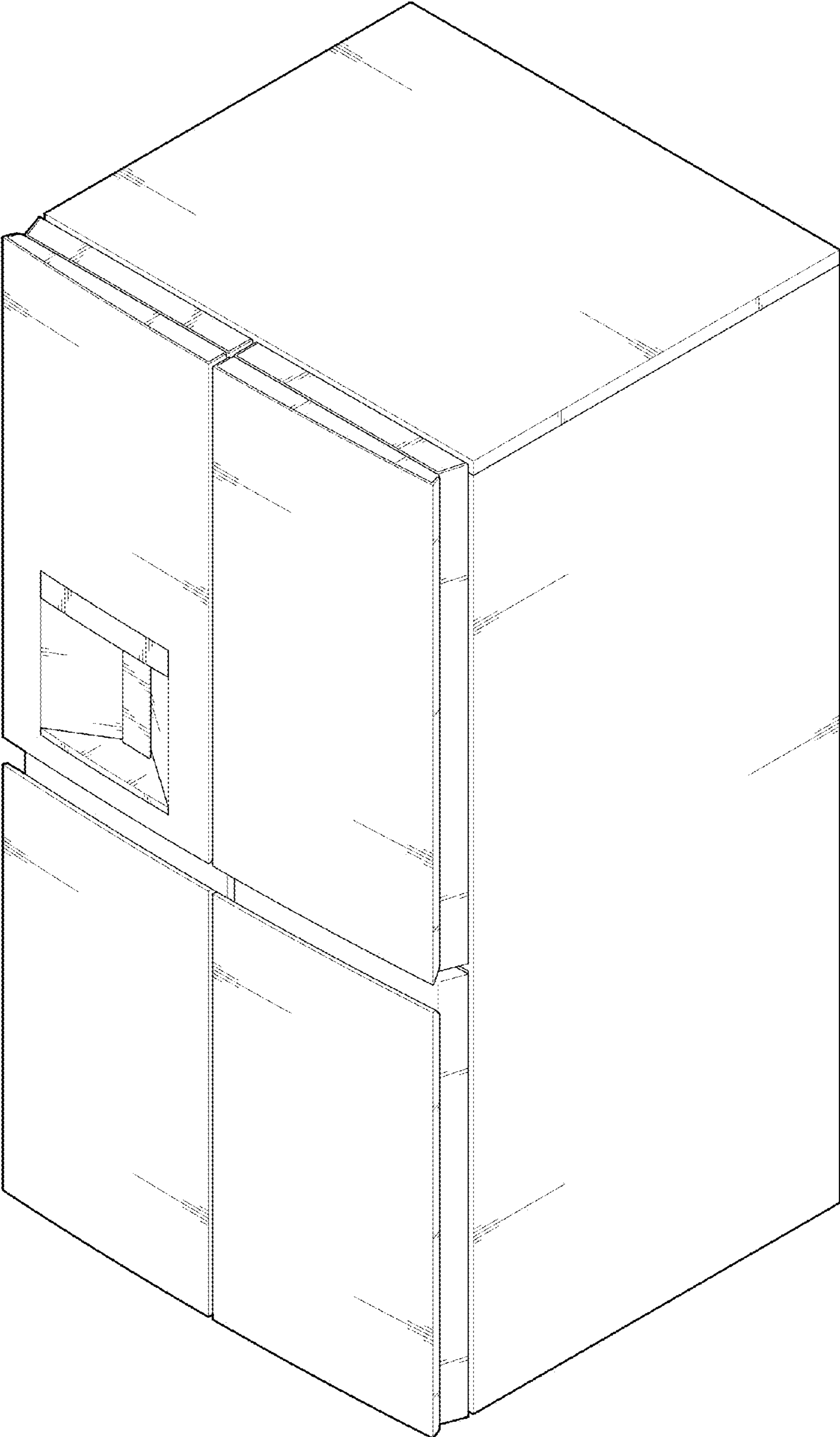

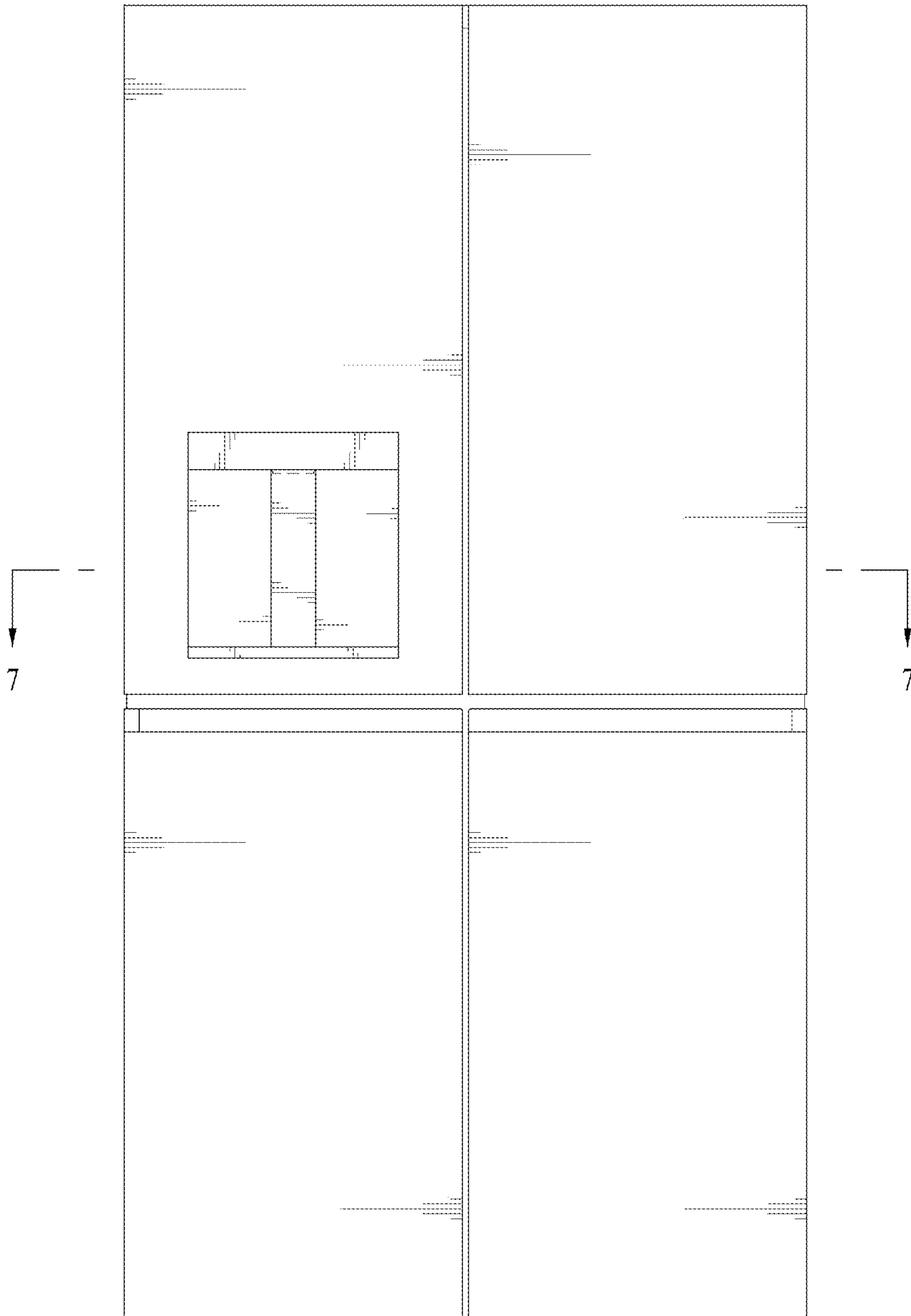

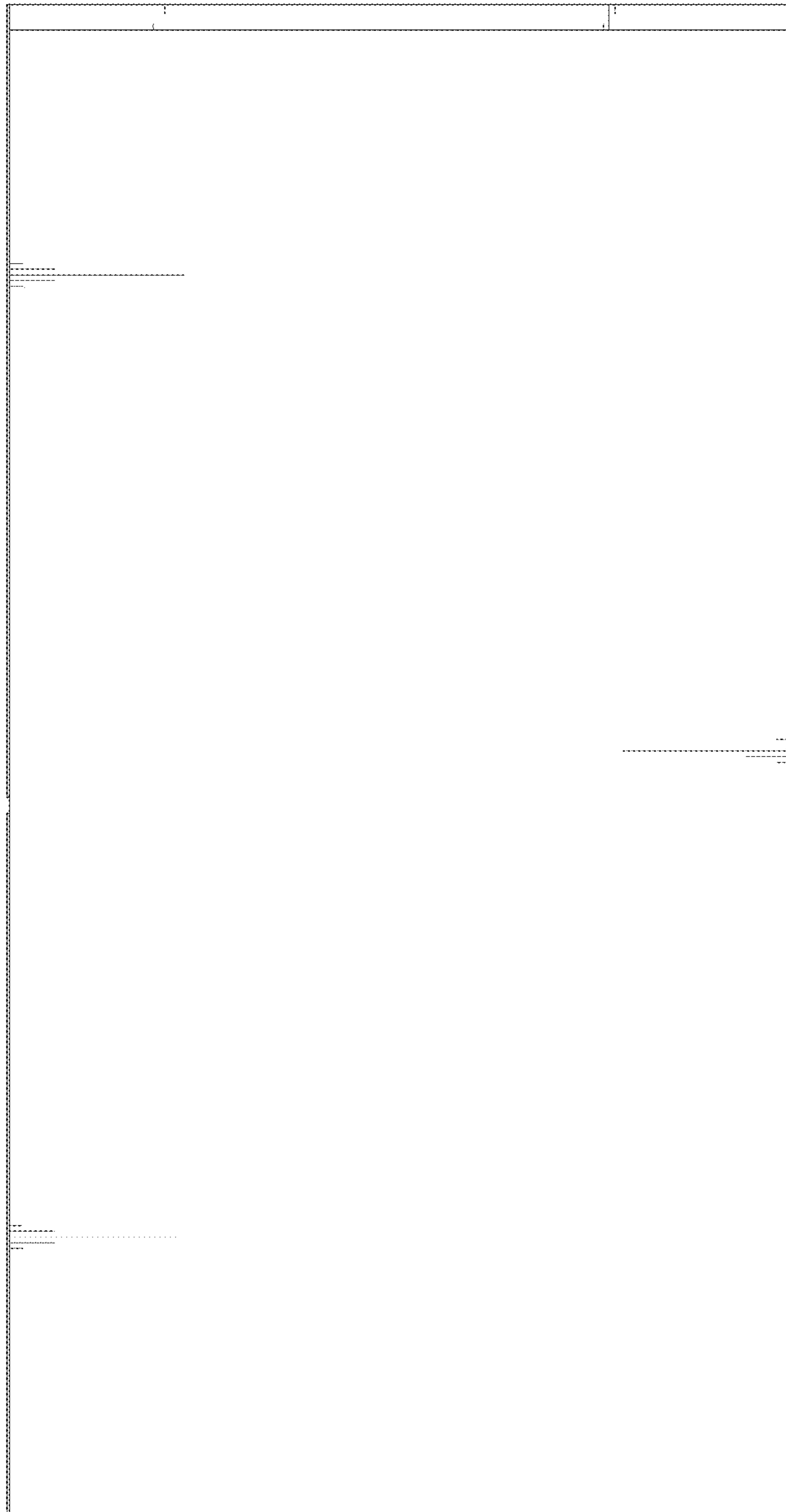

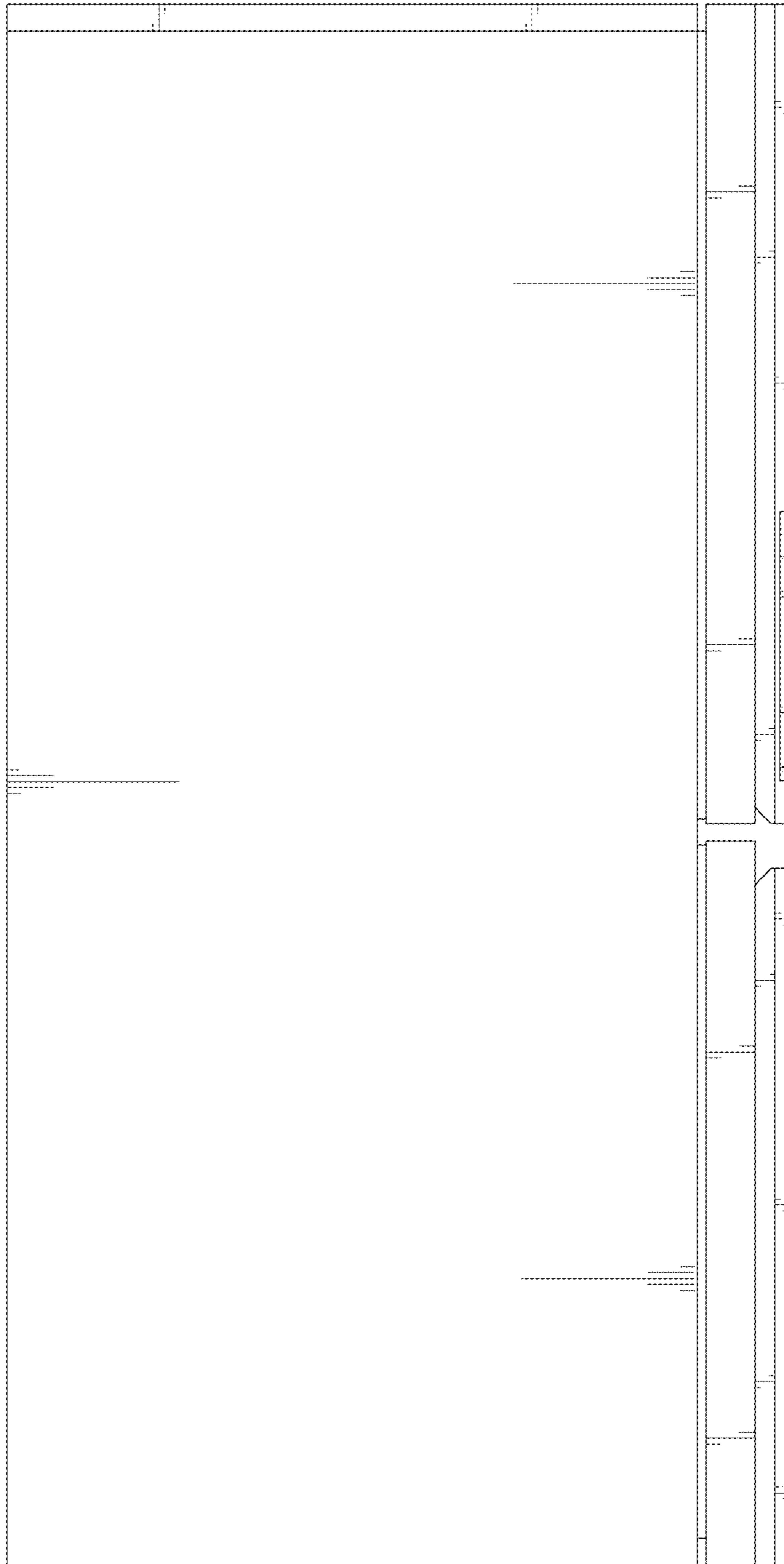

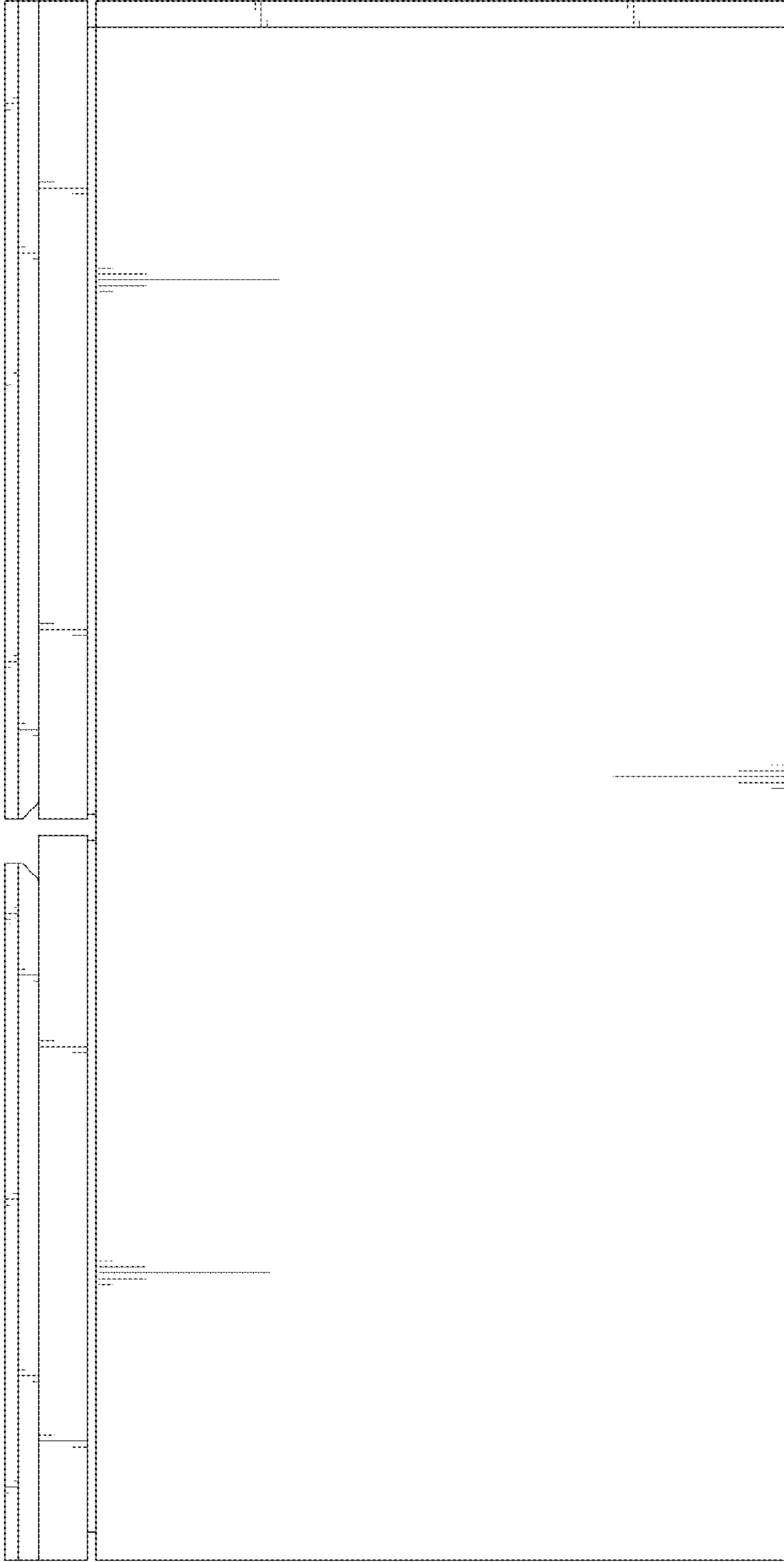

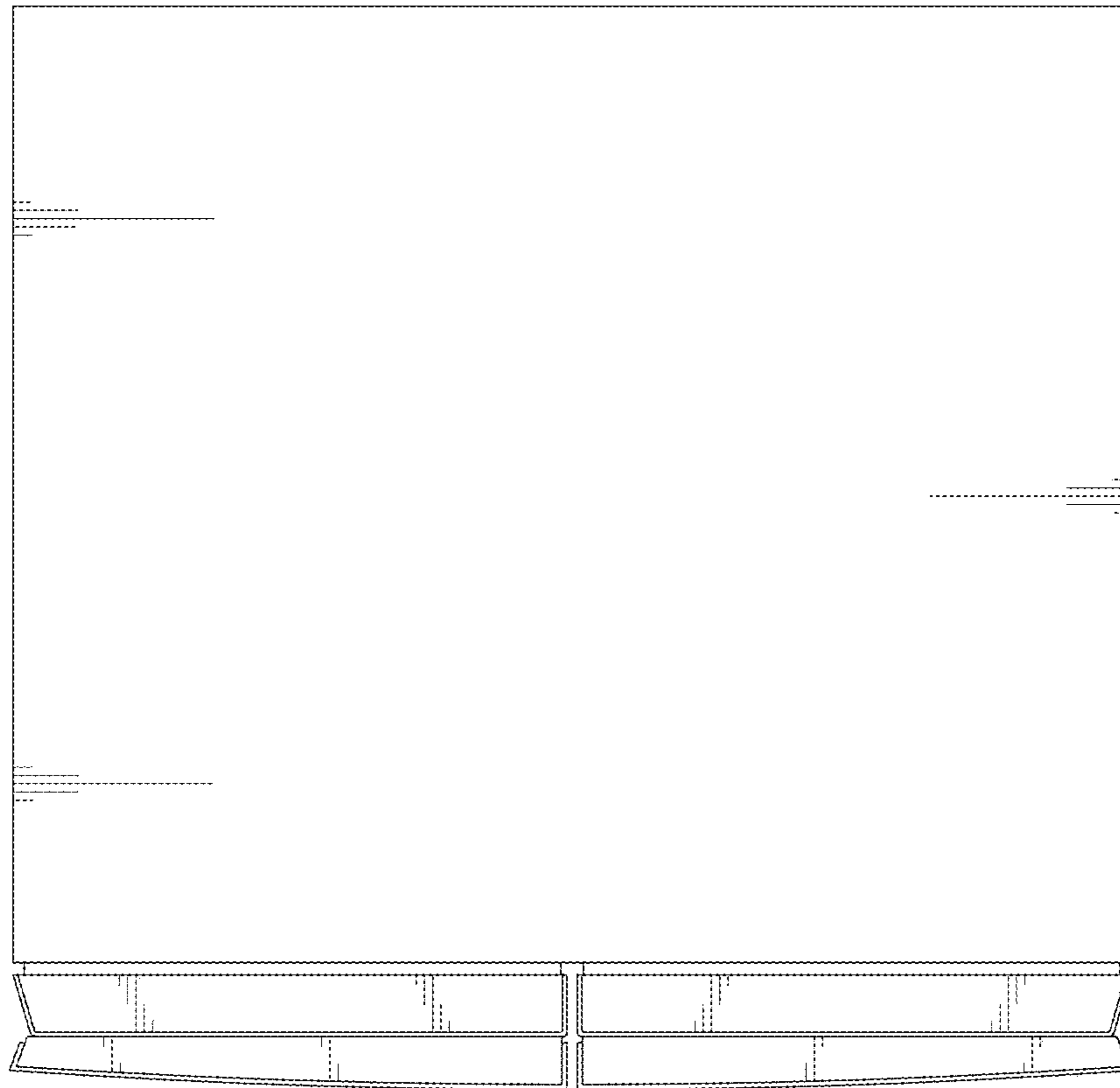
