DESCRIPTION

FIG. 1 is a front elevational view of printing paper showing
my new design;

FIG. 12 is an enlarged partial view thereof taken along a 7-7

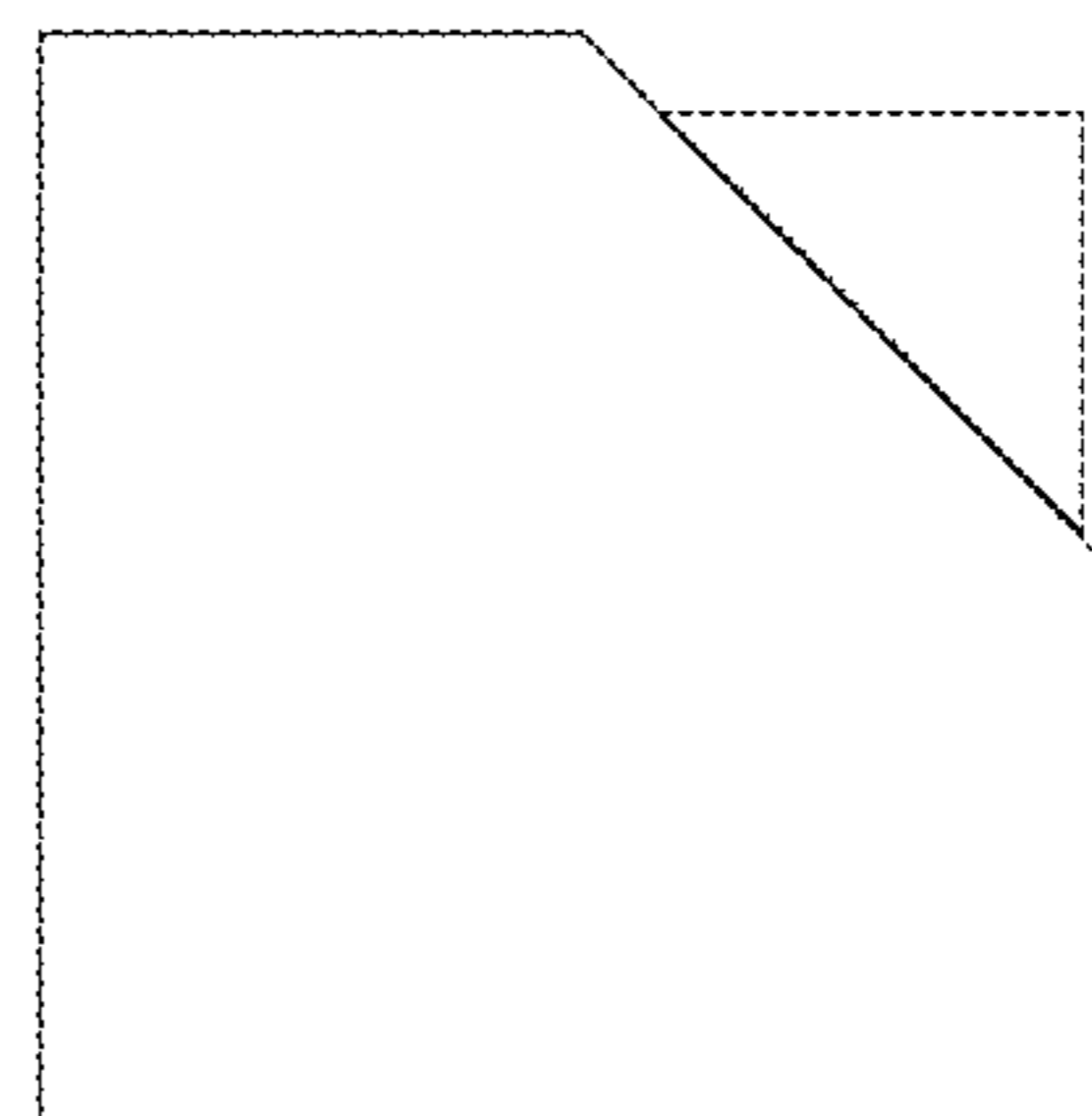
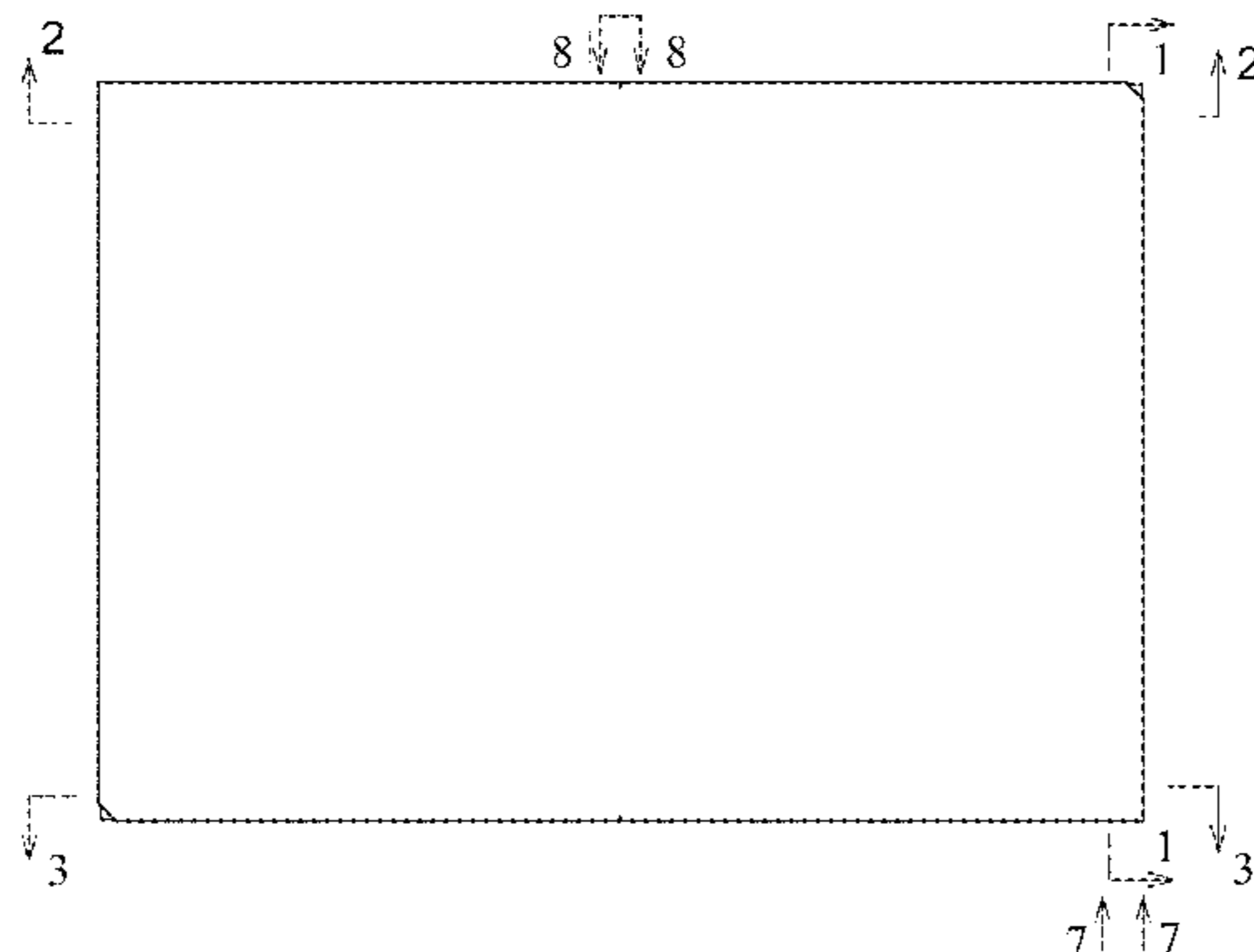

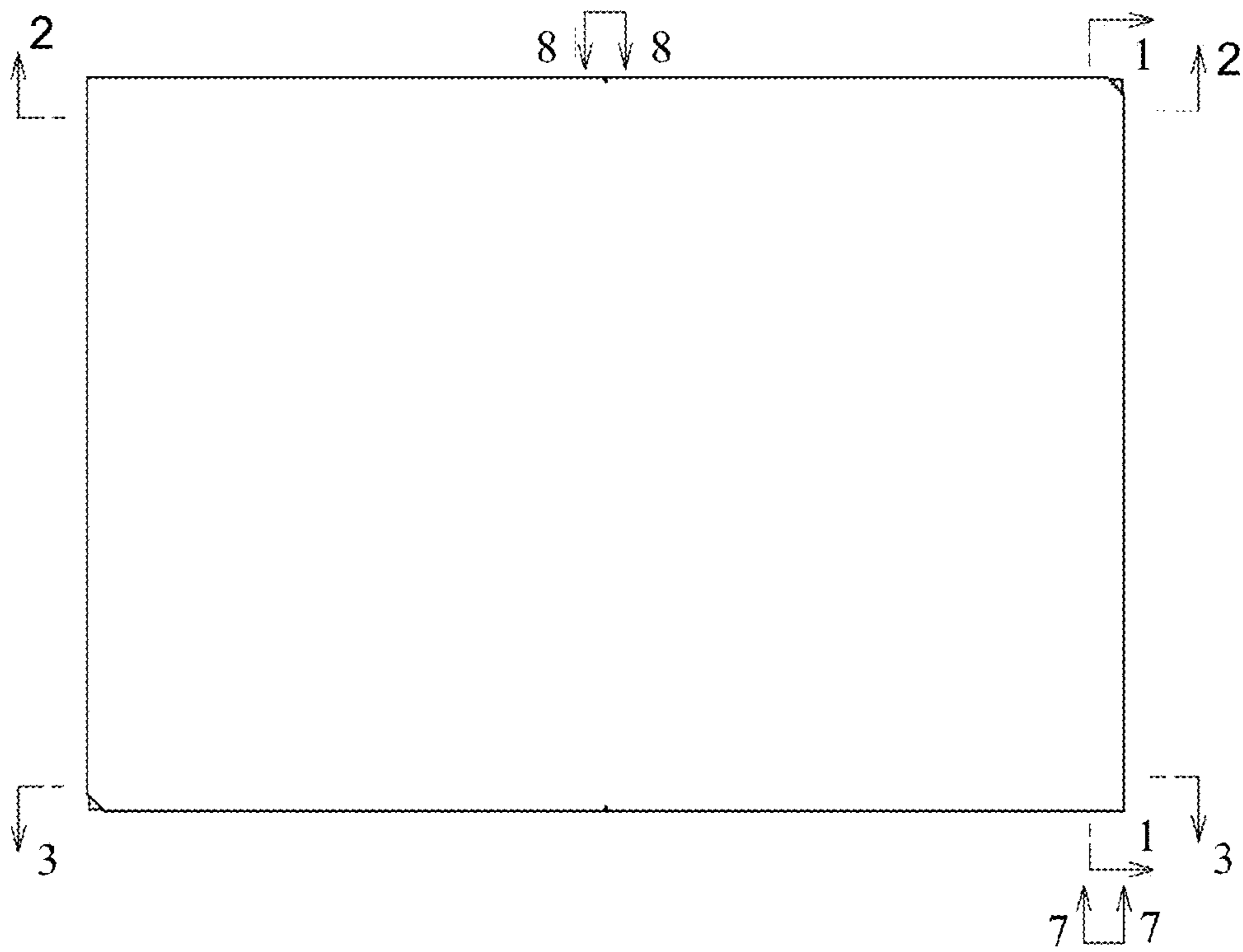

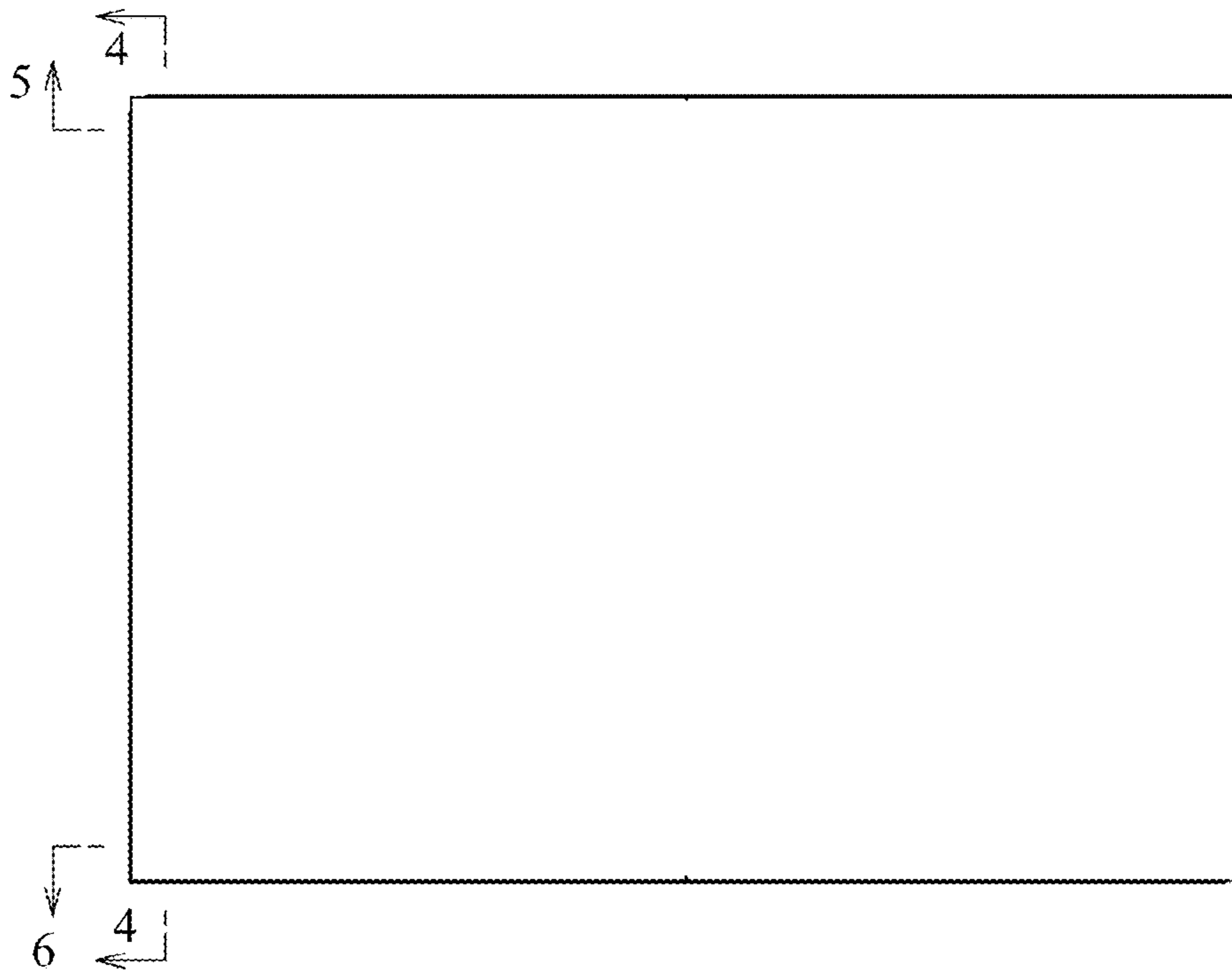

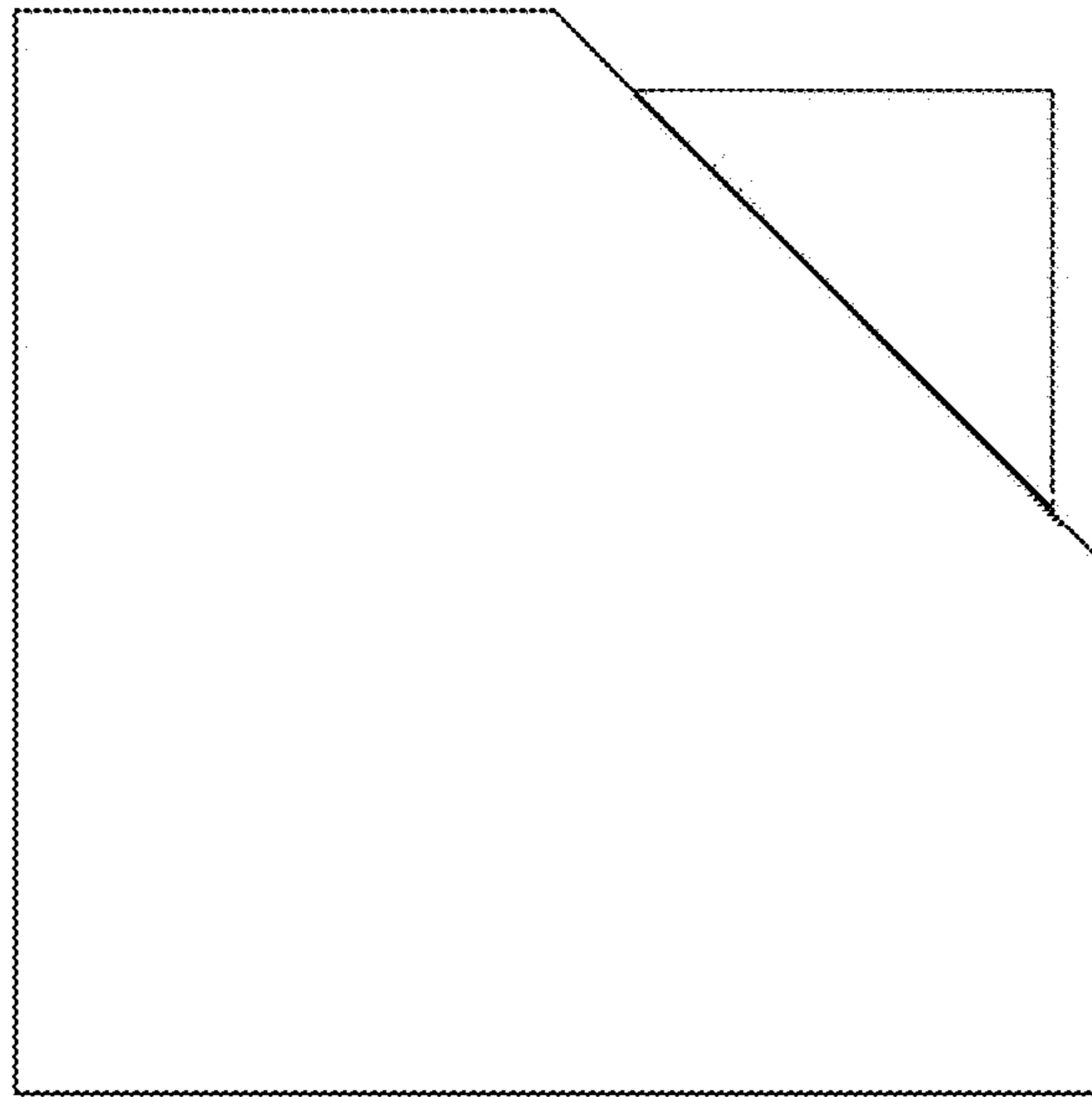

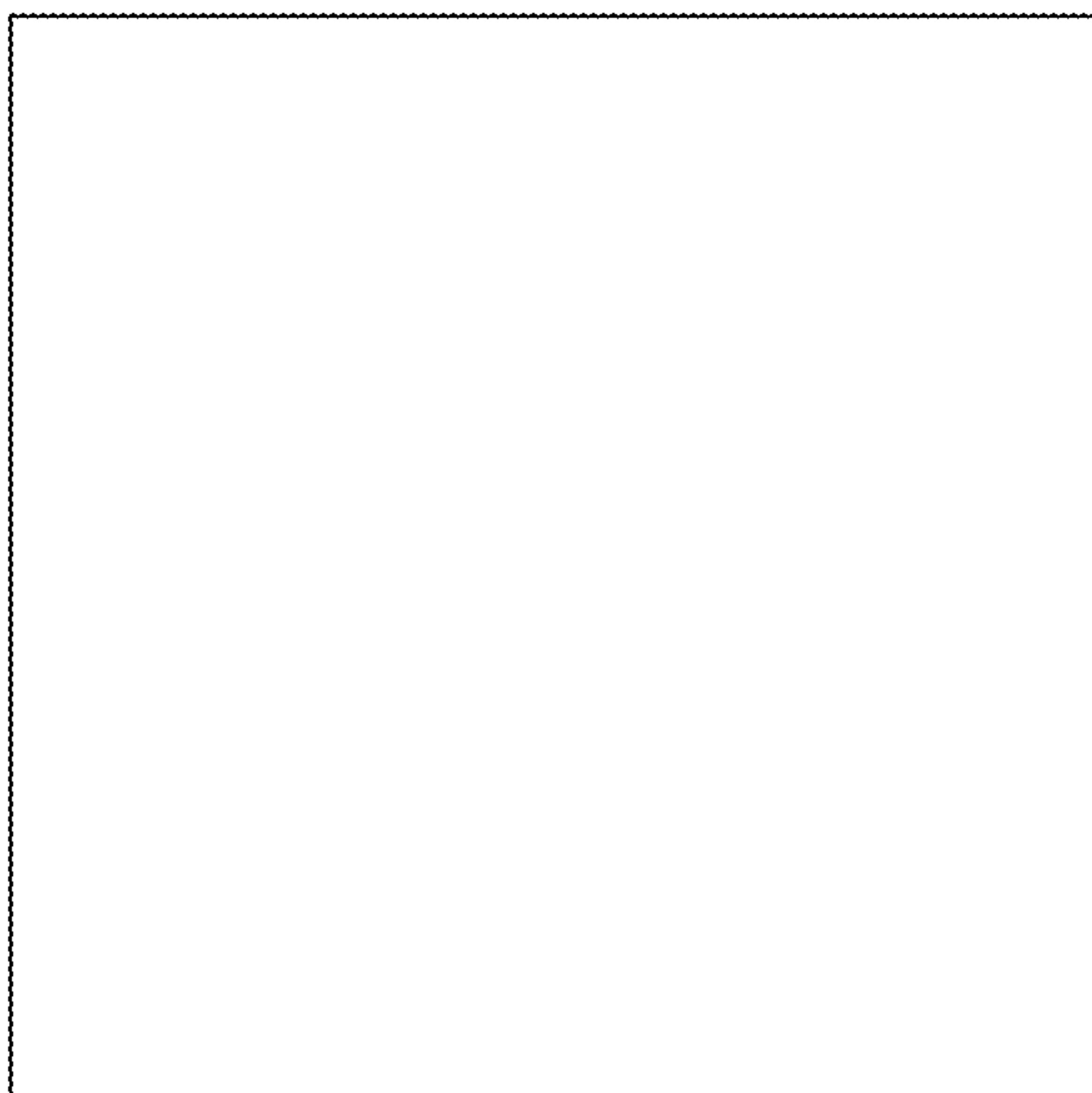

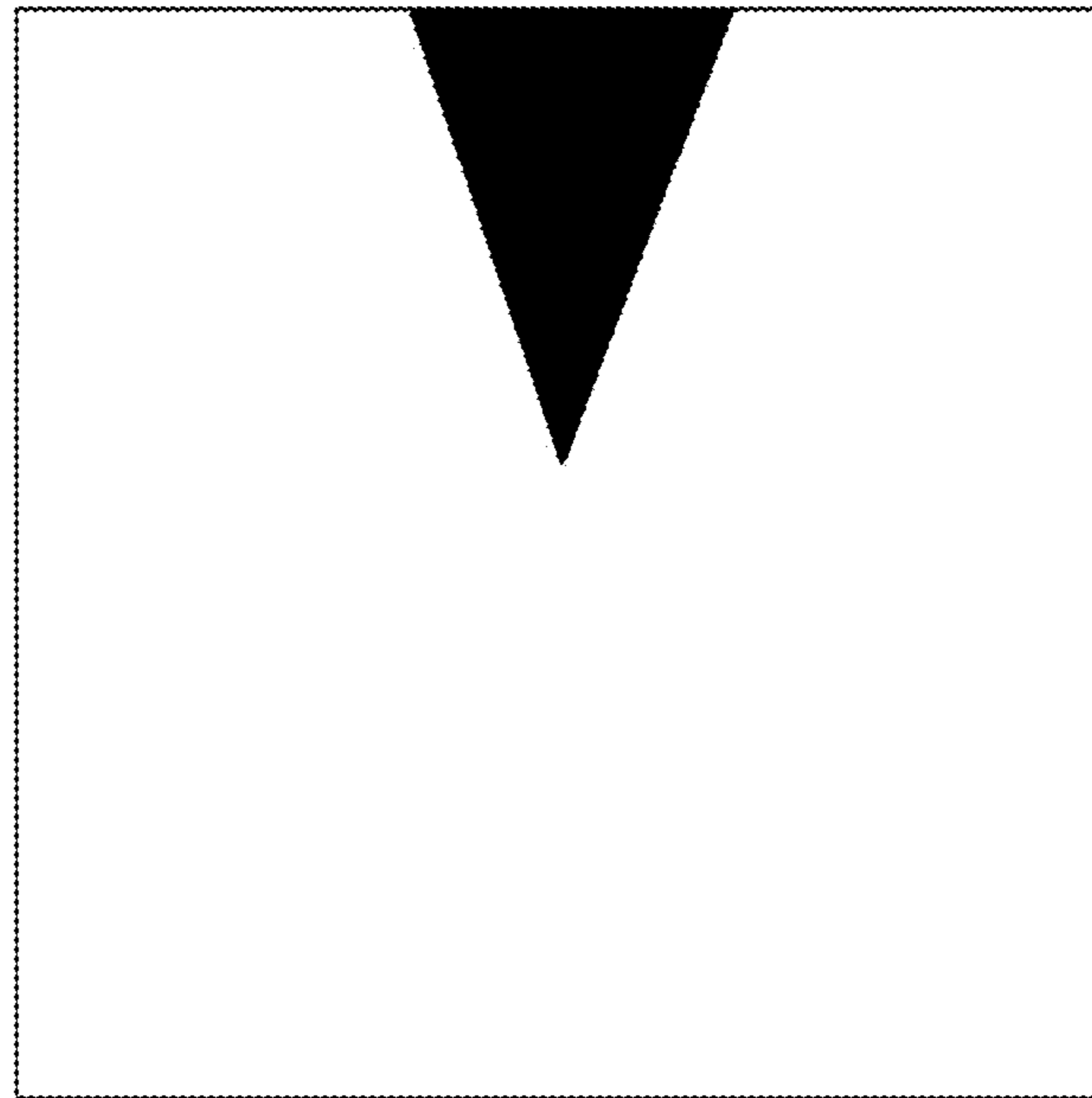

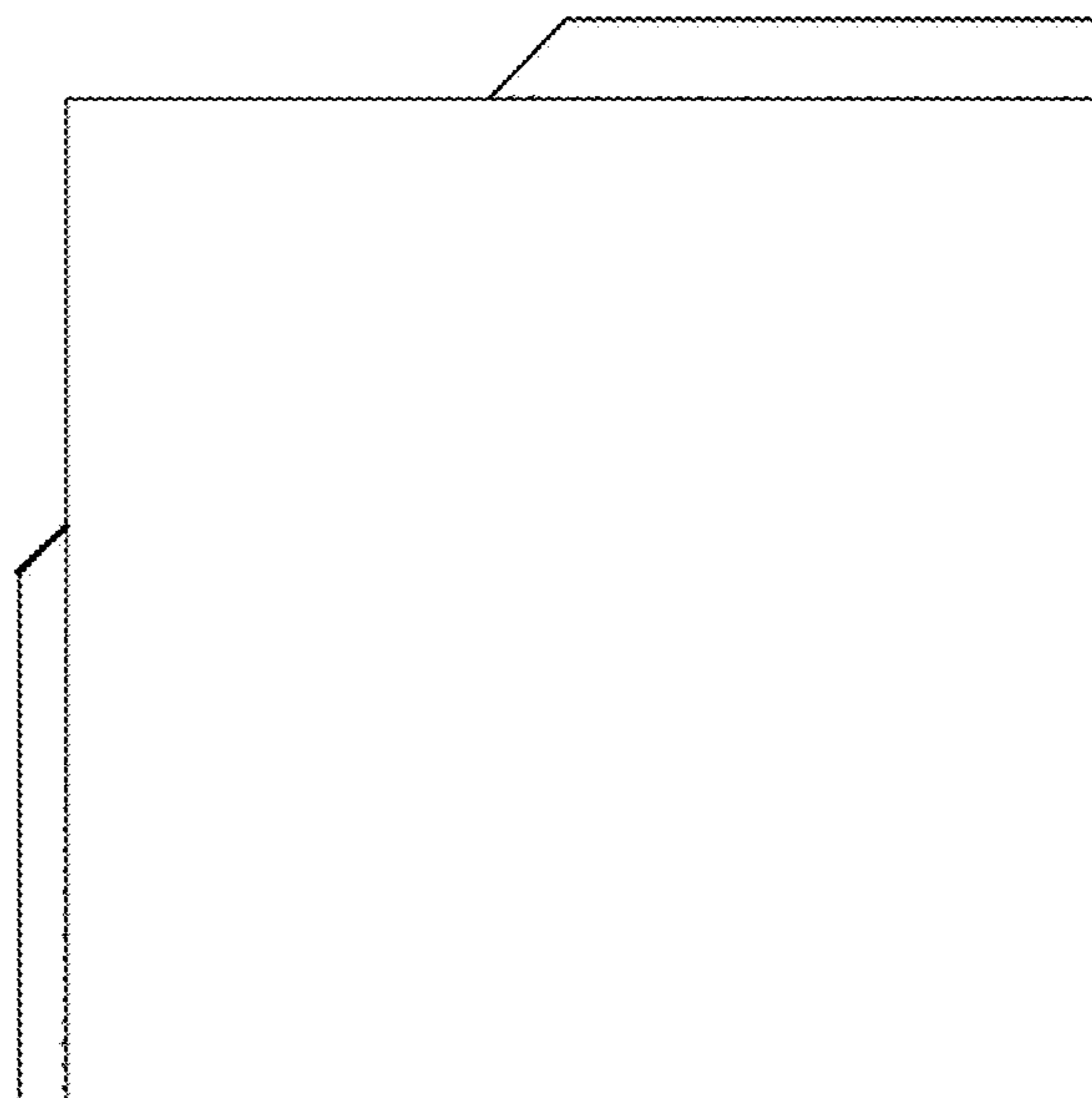

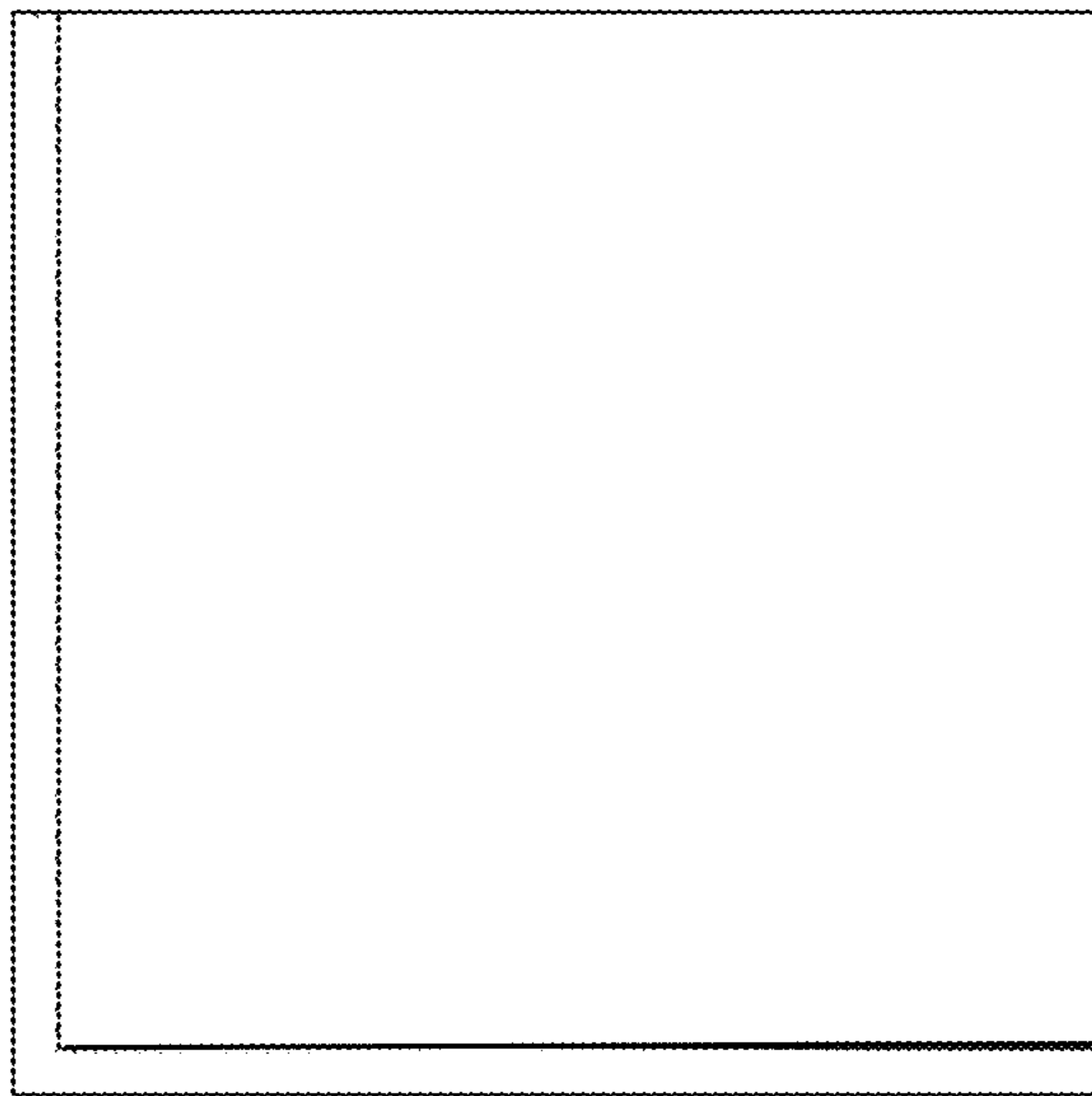
