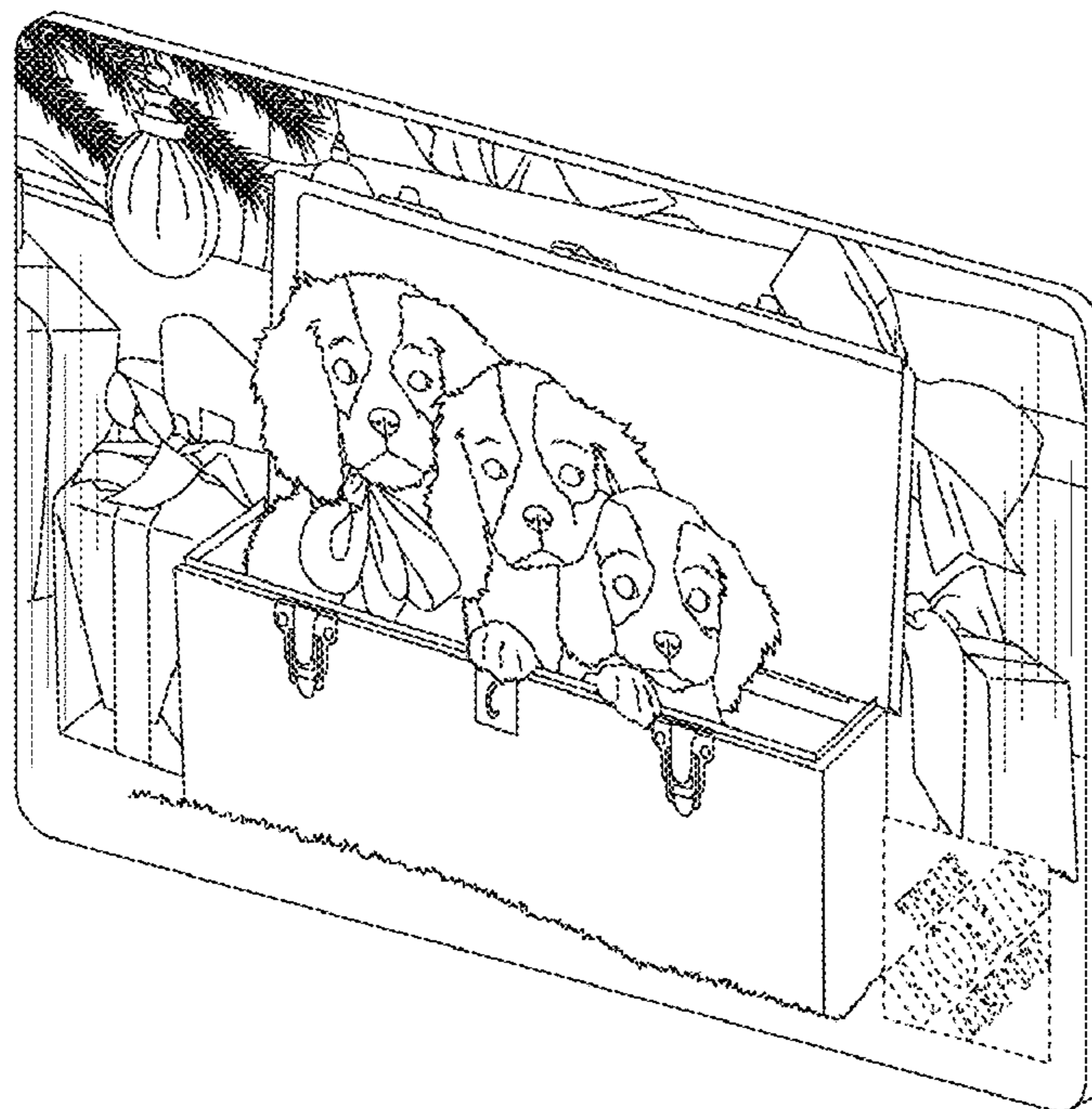
The ornamental design for a financial transaction card, as shown and described.

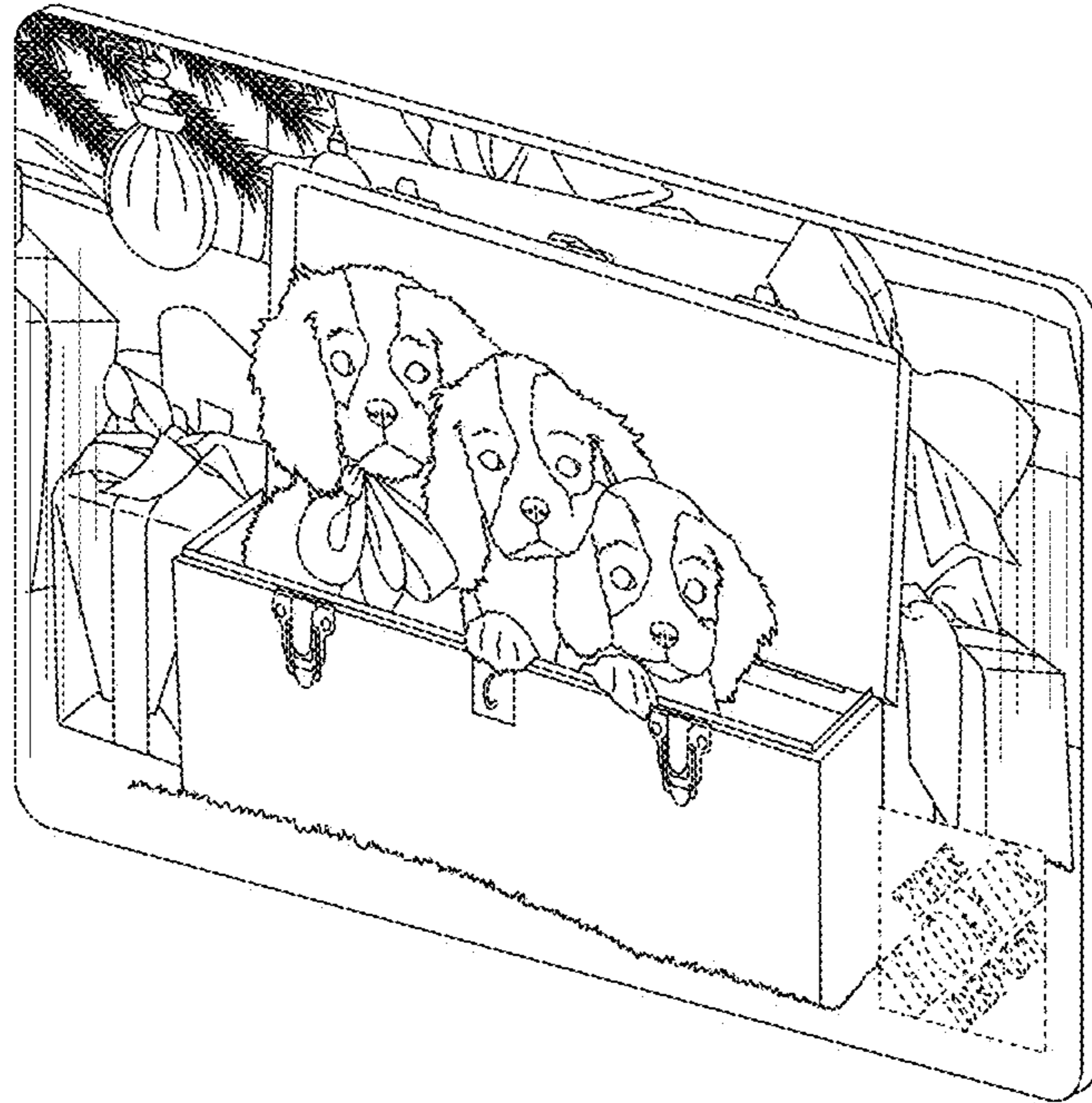

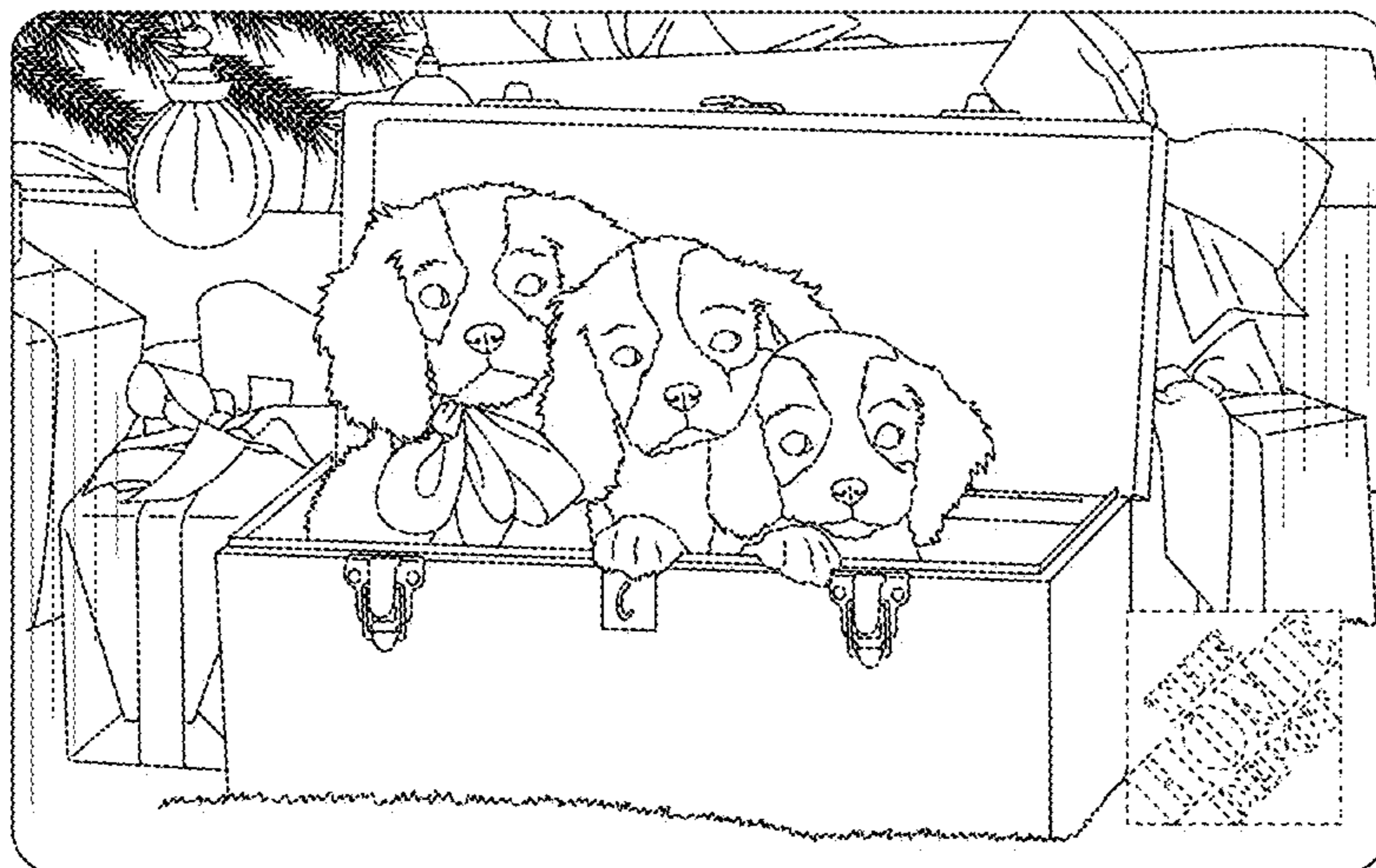
