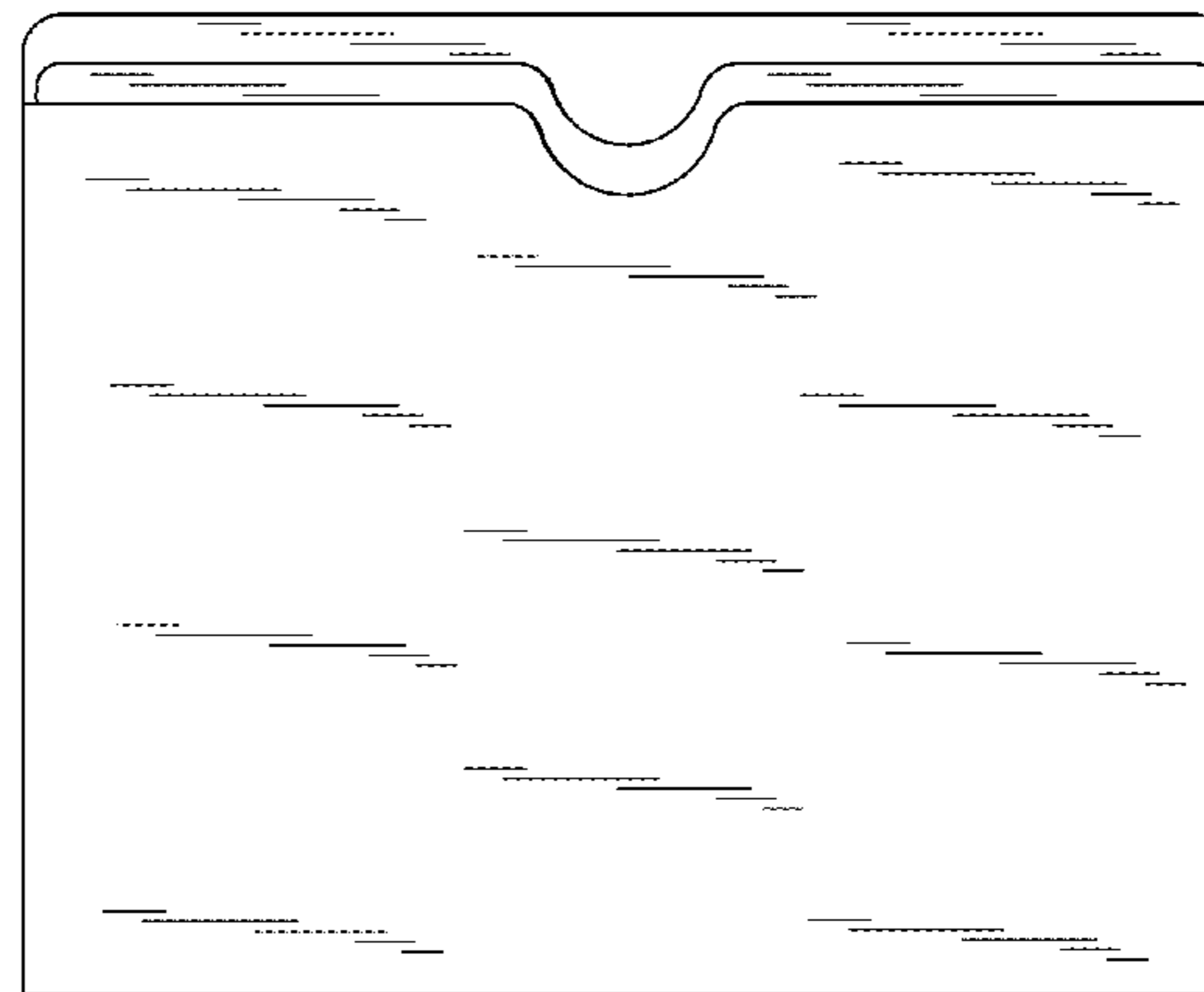
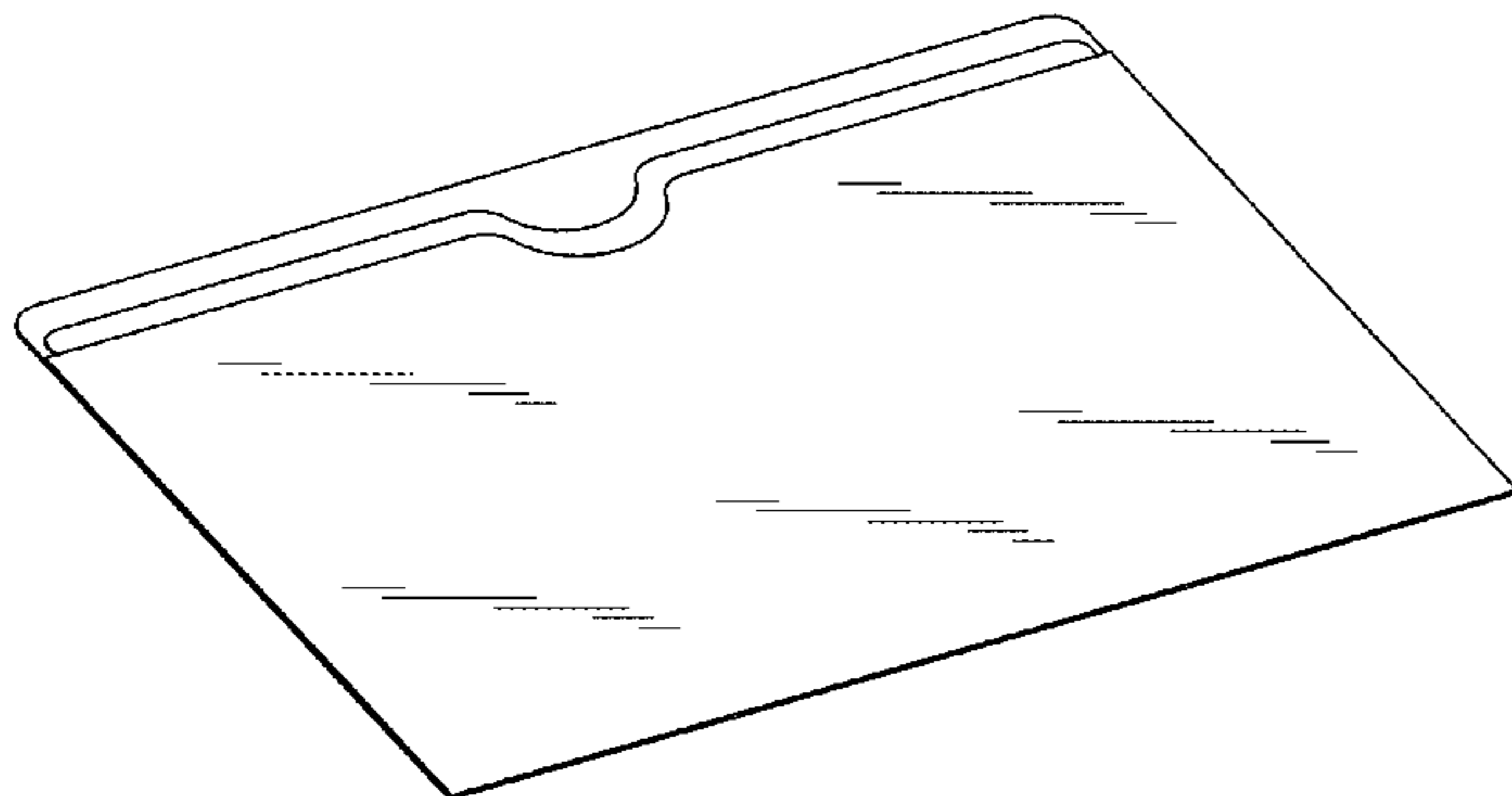
(57) **CLAIM**

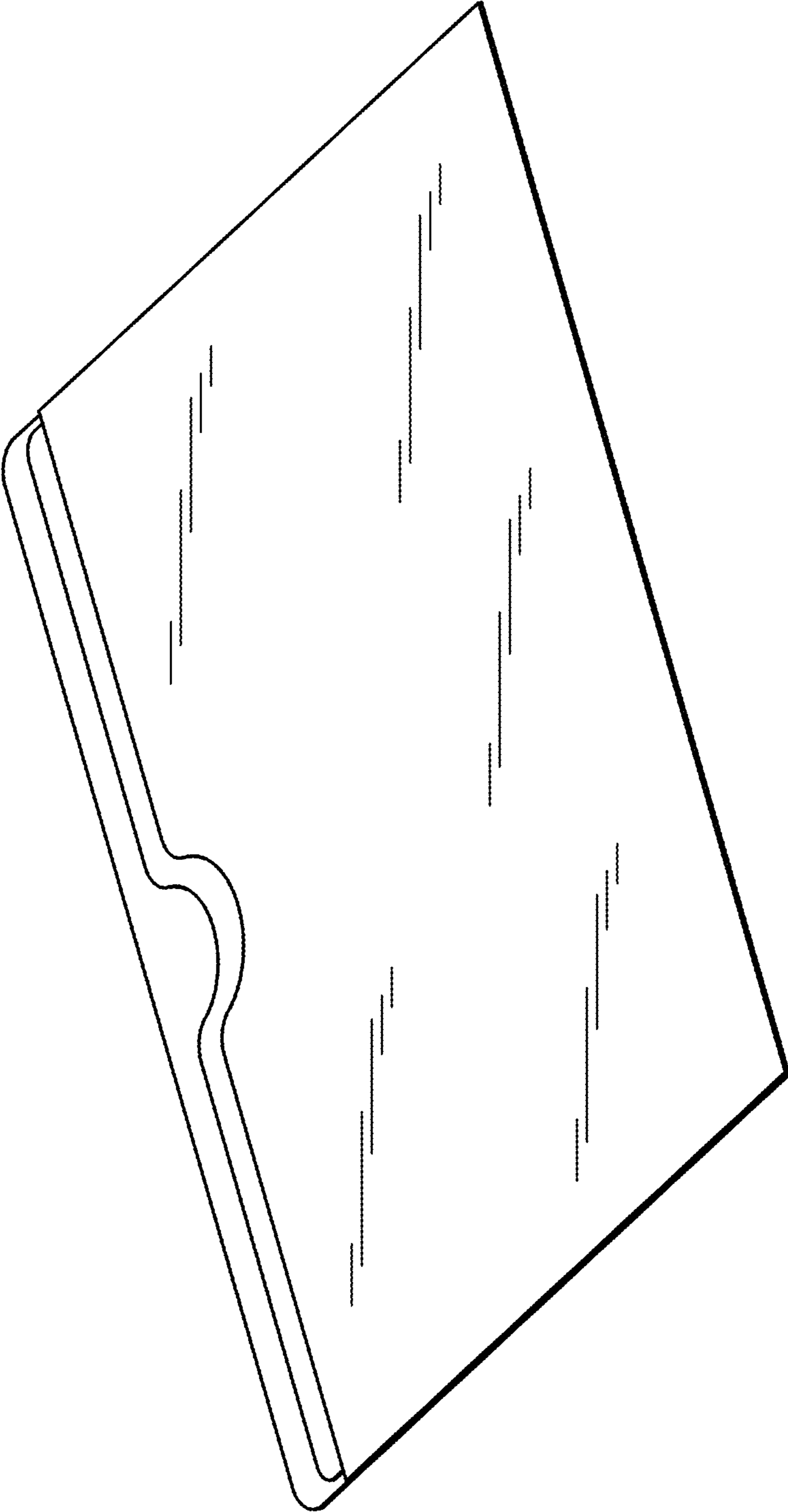

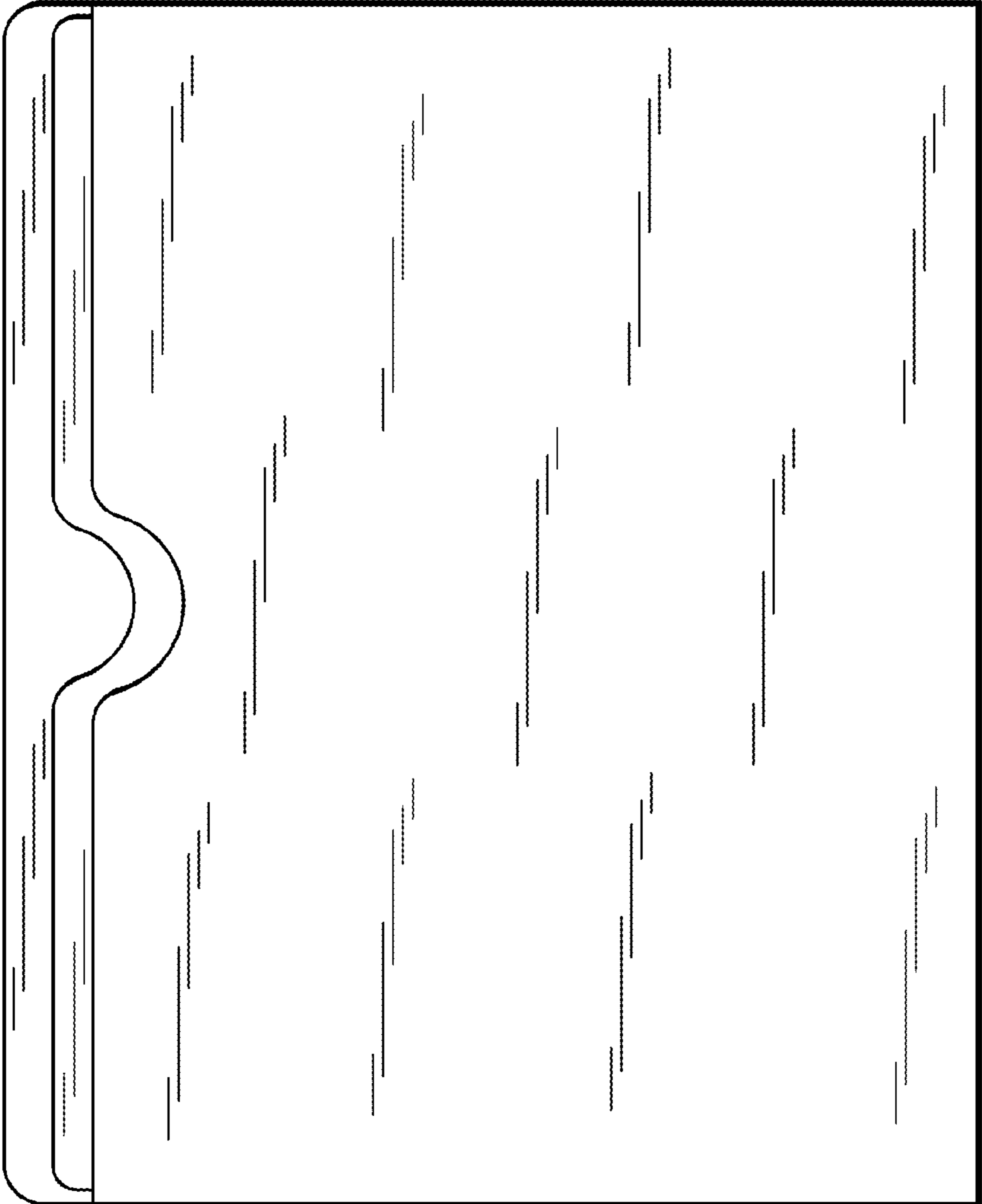

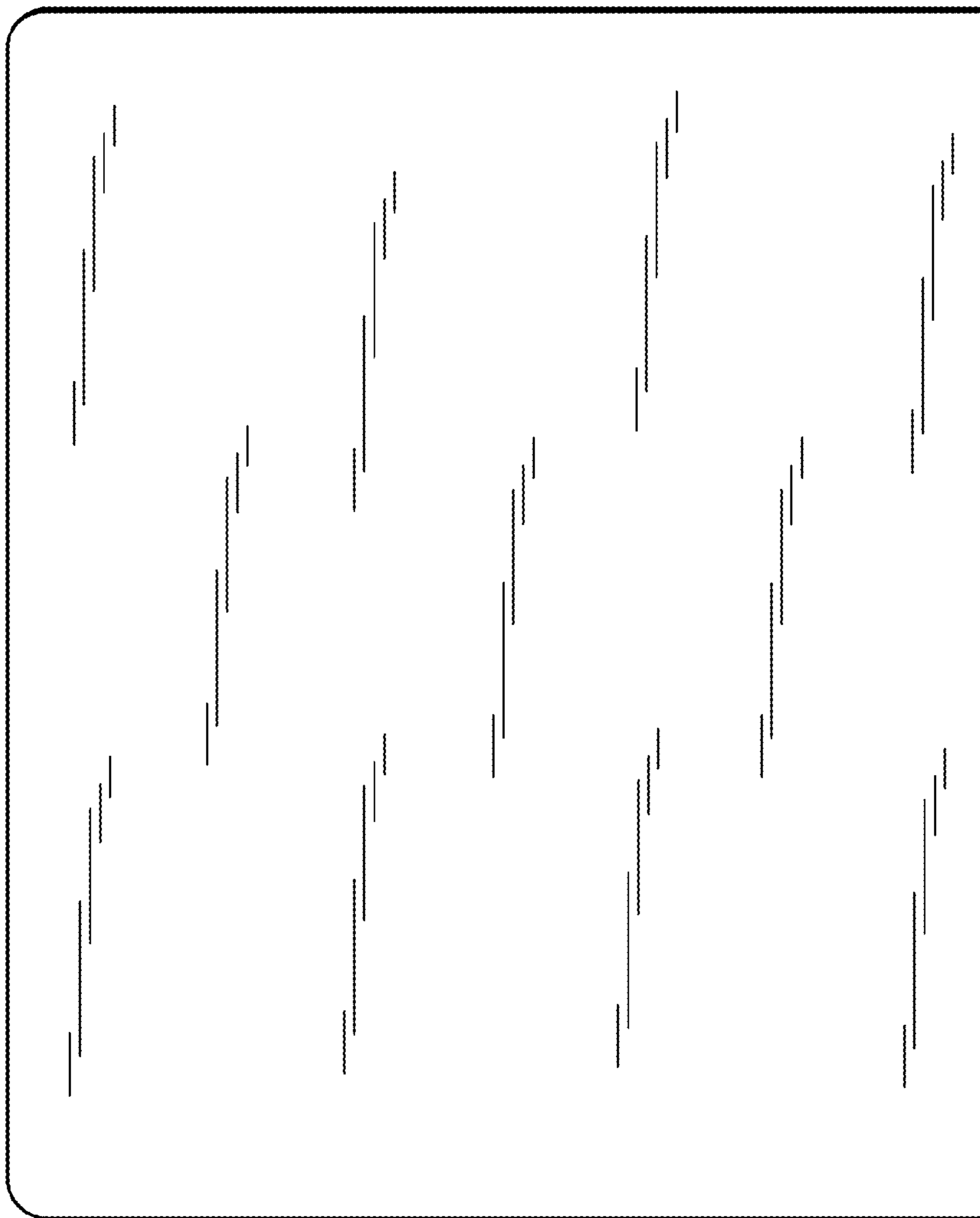

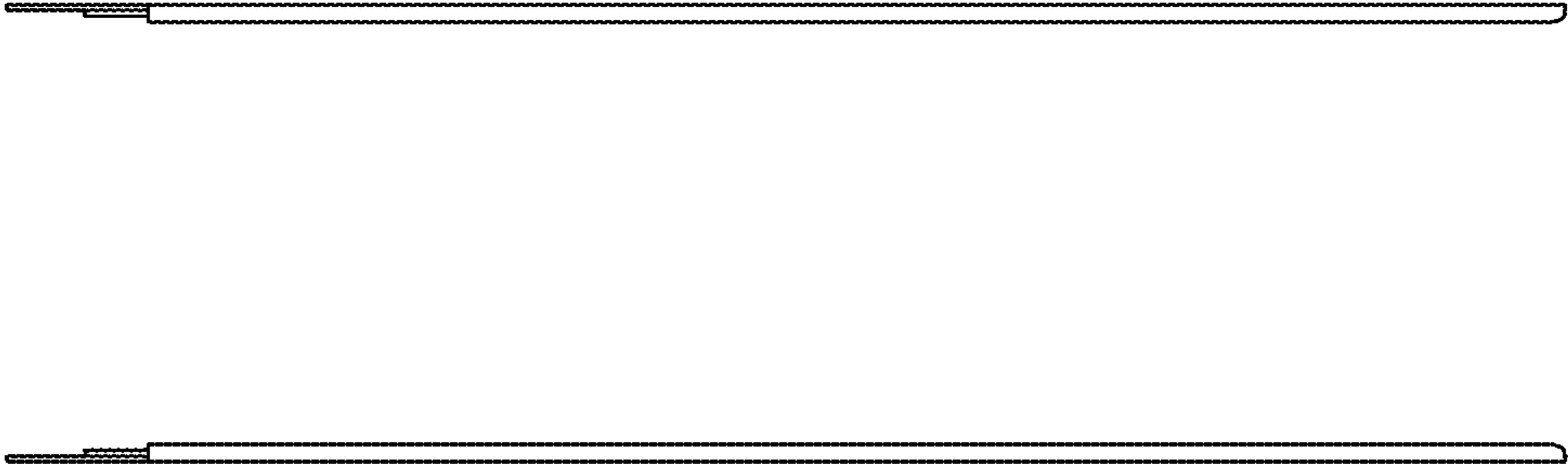

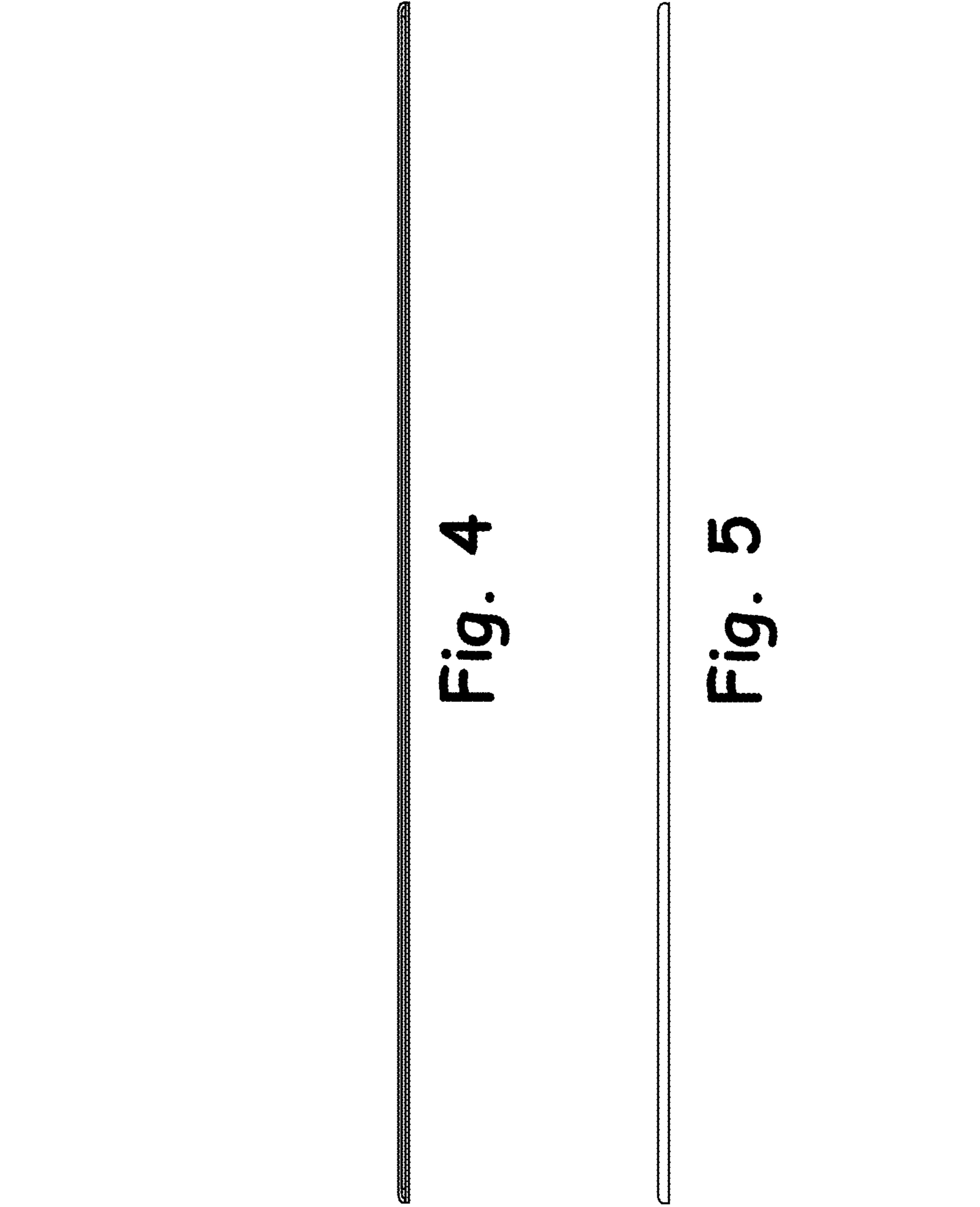

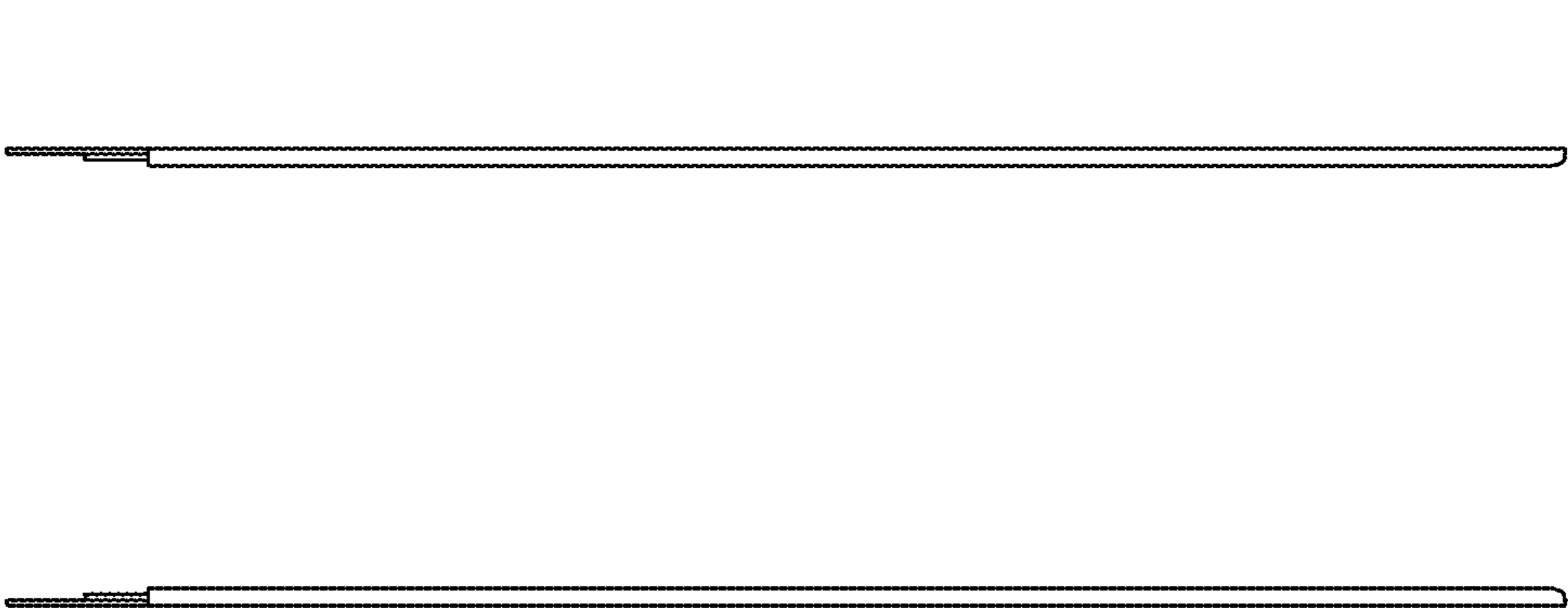


Fig. 6 Fig. 7
