**DESCRIPTION**

FIG. 1 shows a front view of a pinch valve showing our new design;

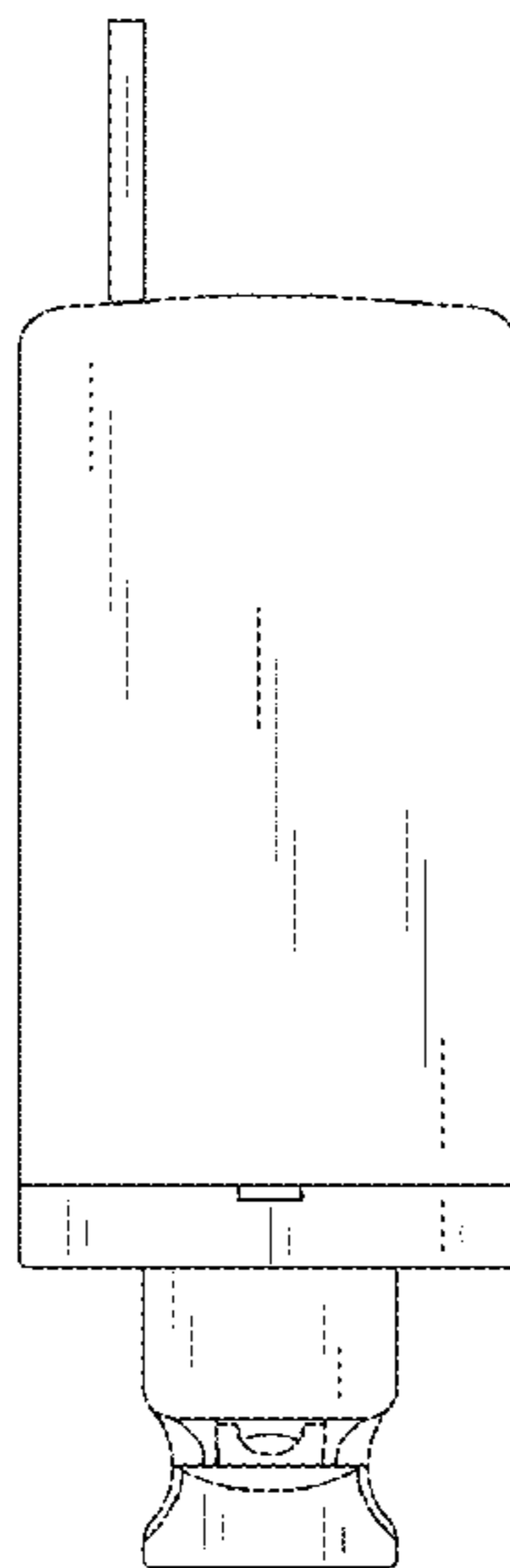

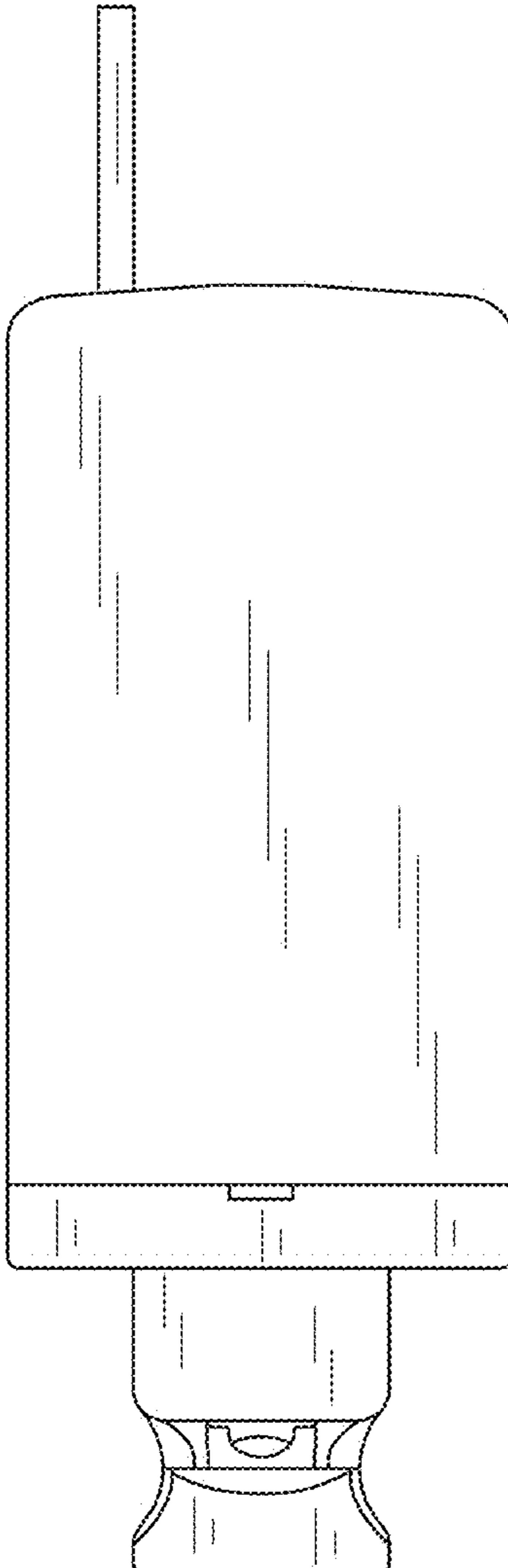

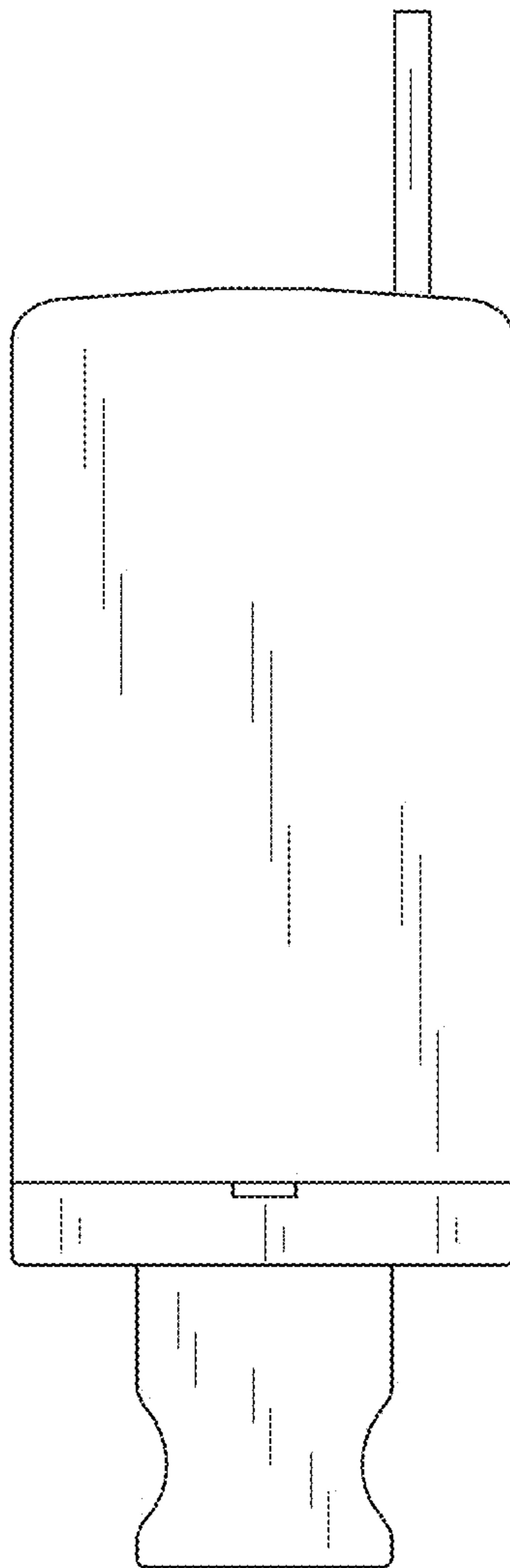

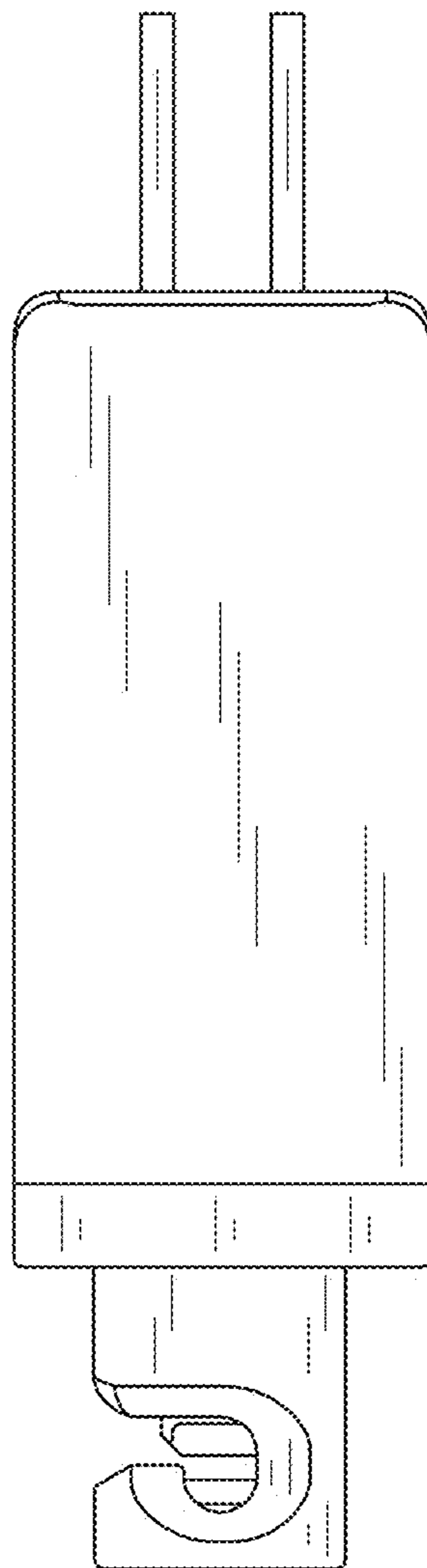

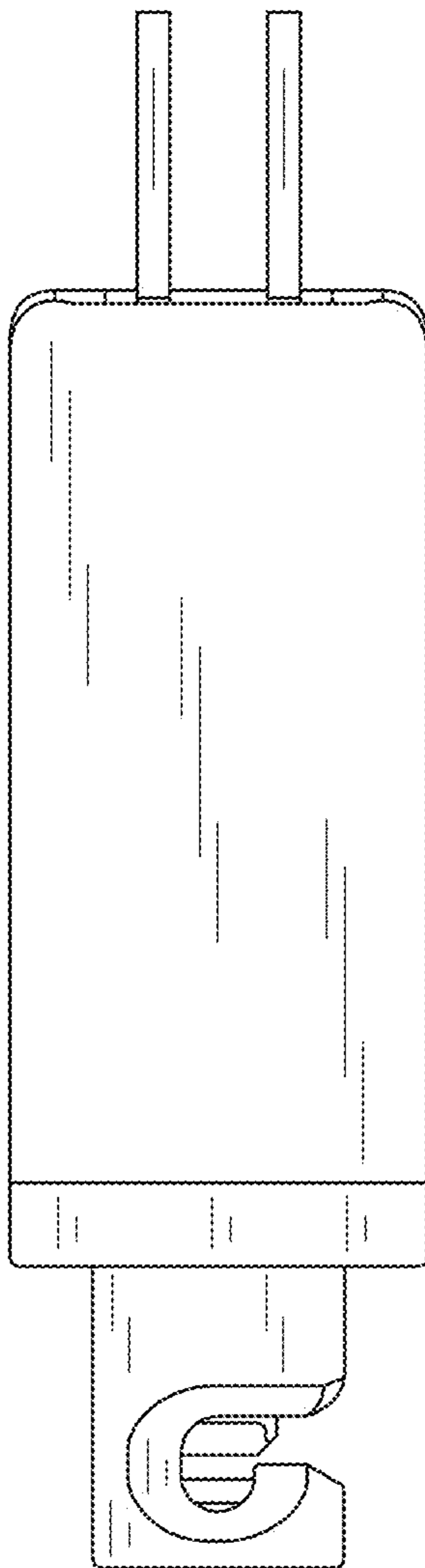

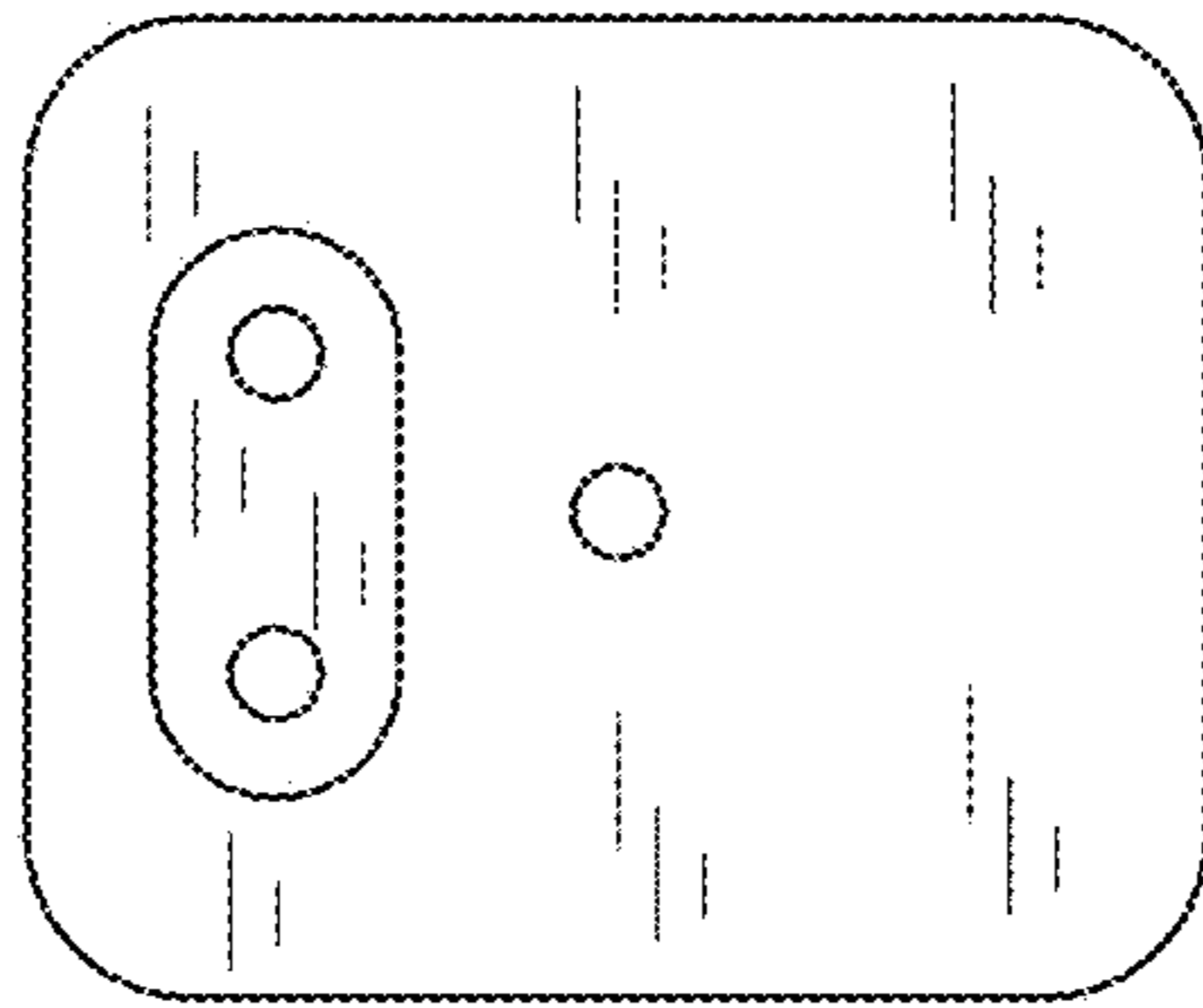

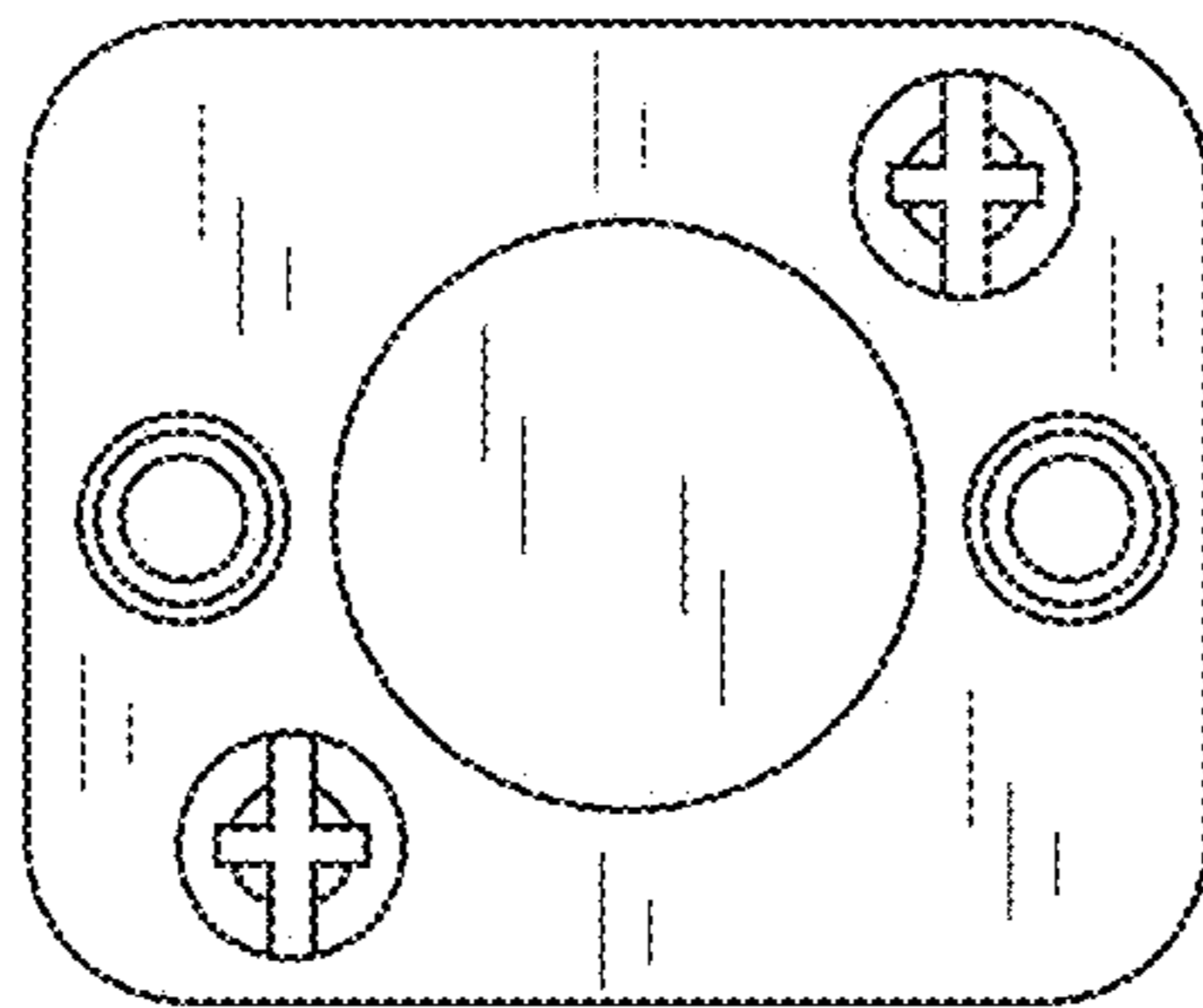

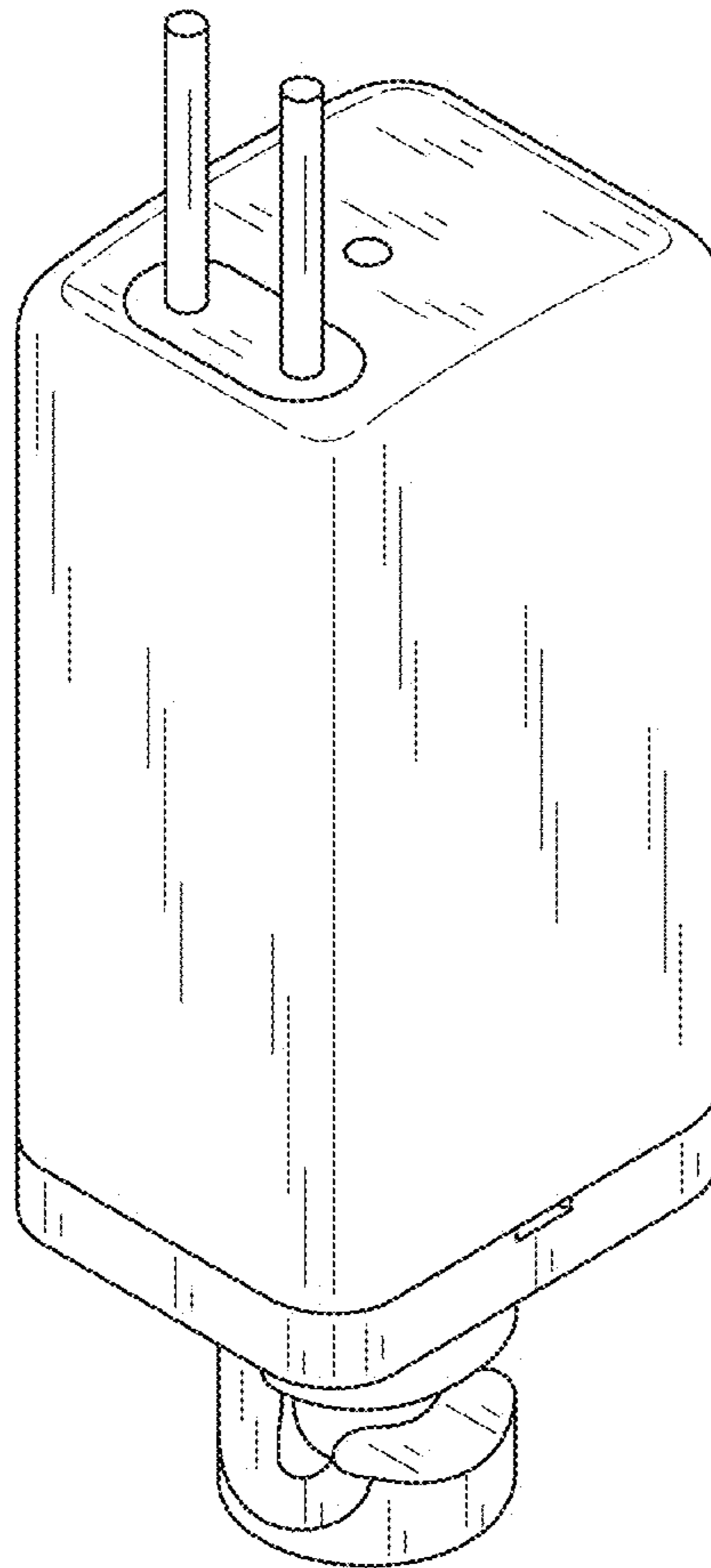
