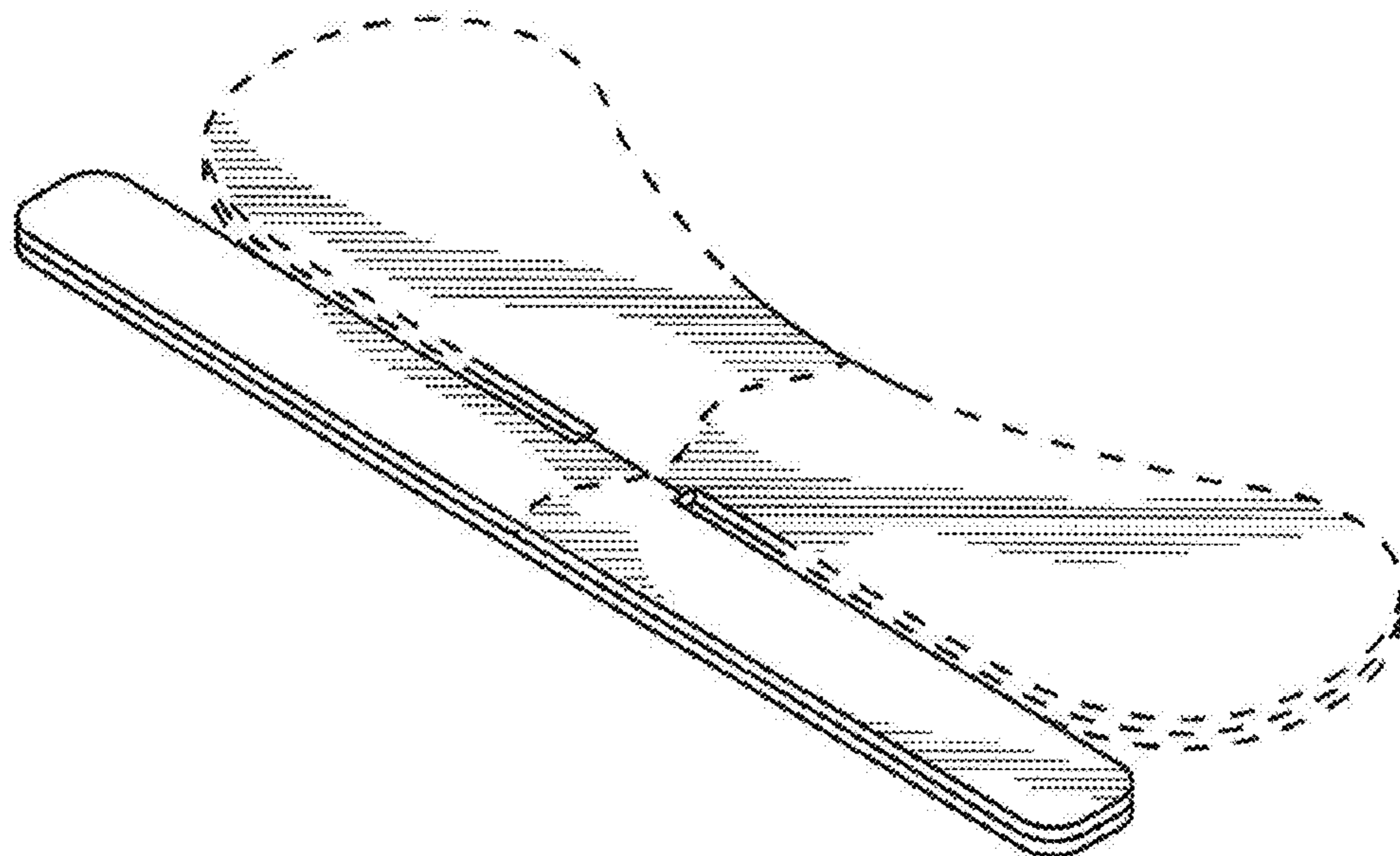

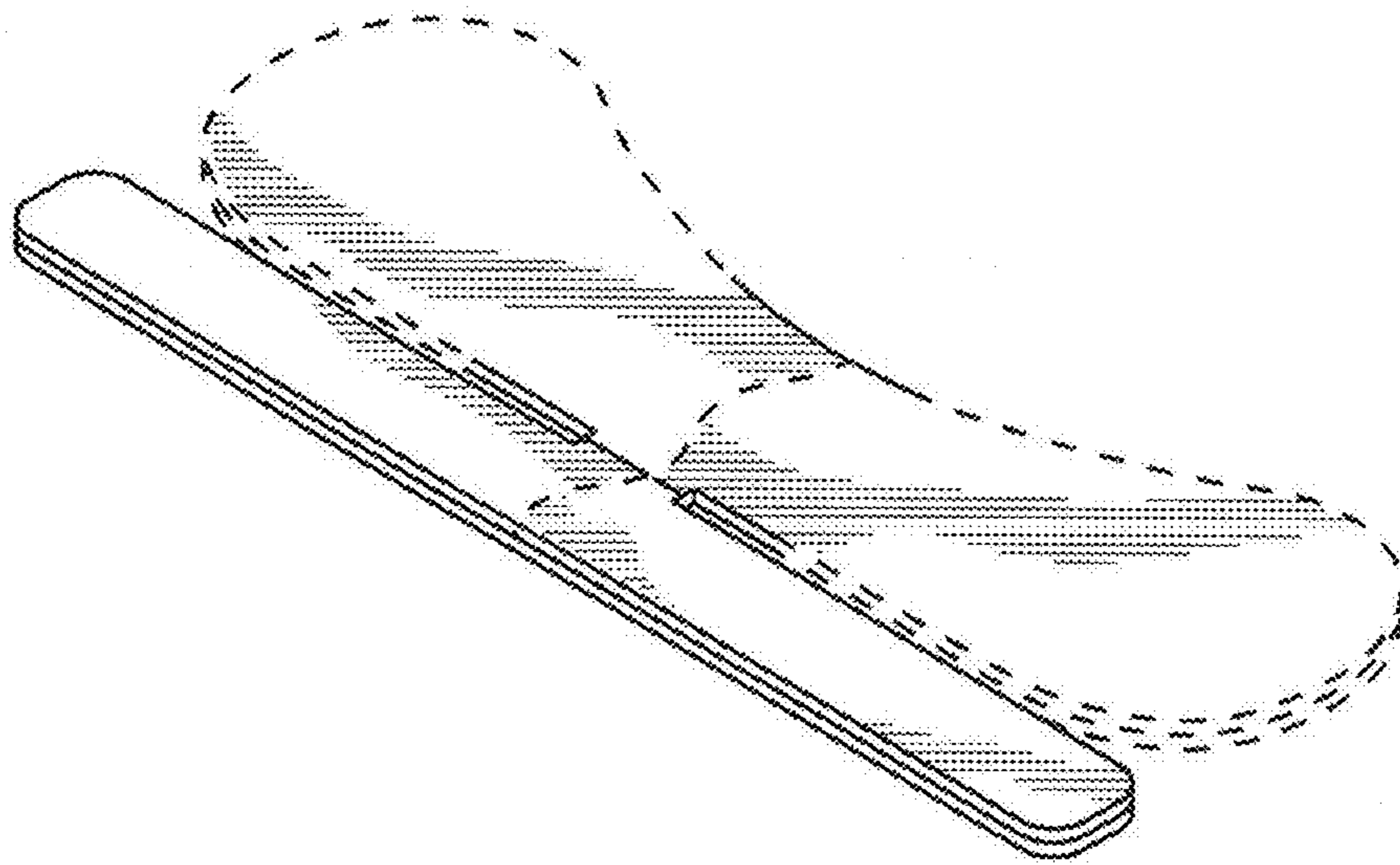
The ornamental design for a nasal tube securement device, as shown and described.

**DESCRIPTION**

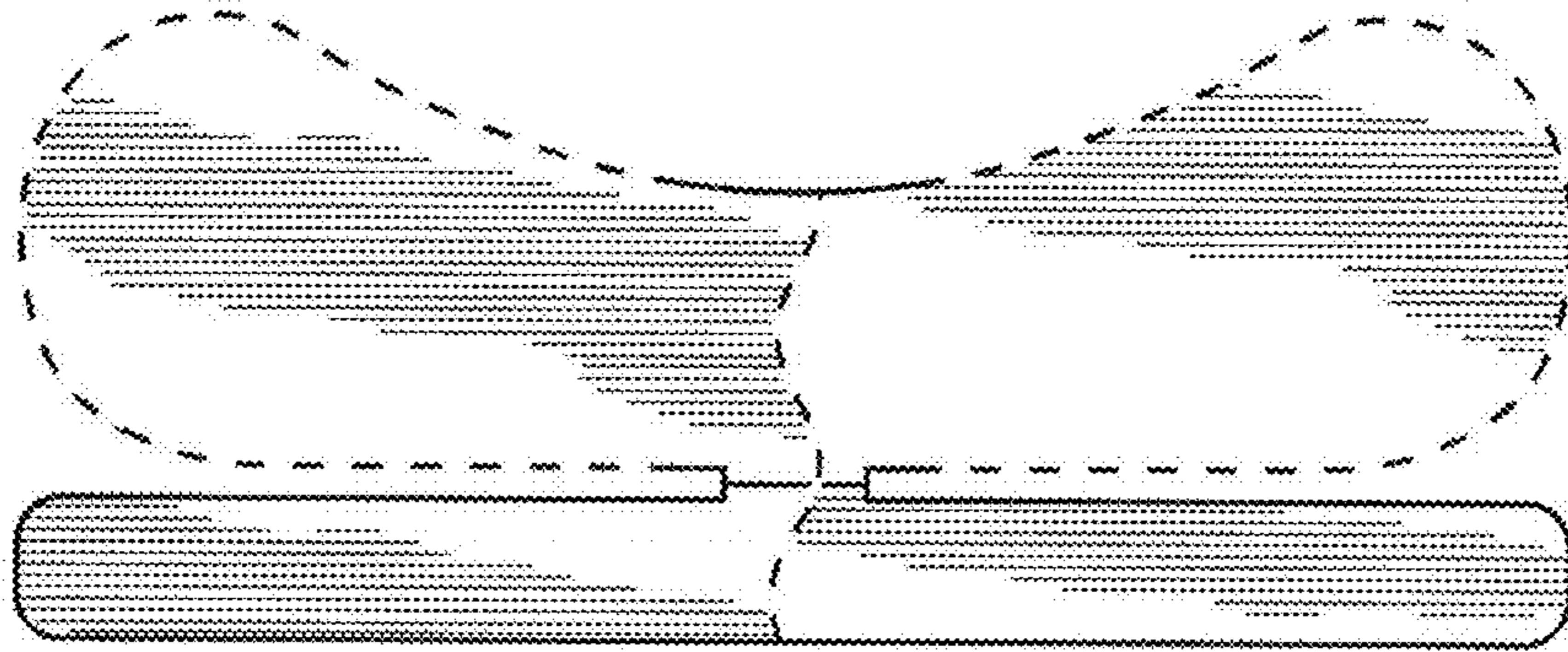
FIG. 1 is a bottom perspective view of an embodiment of the nasal tube securement device;

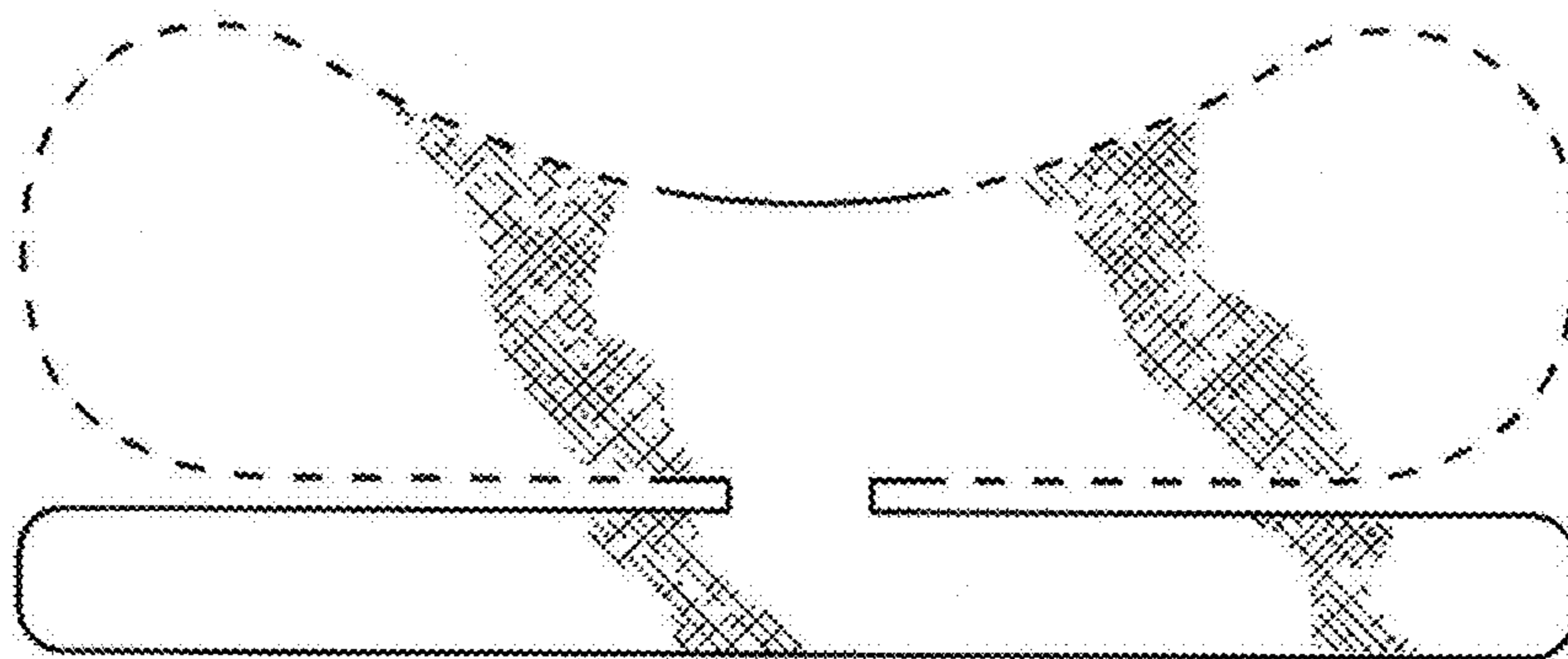

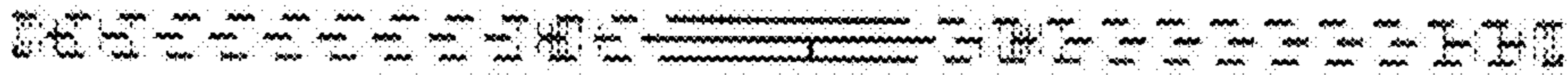

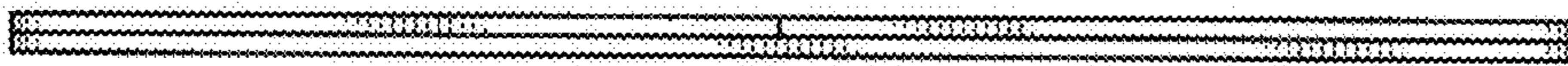
