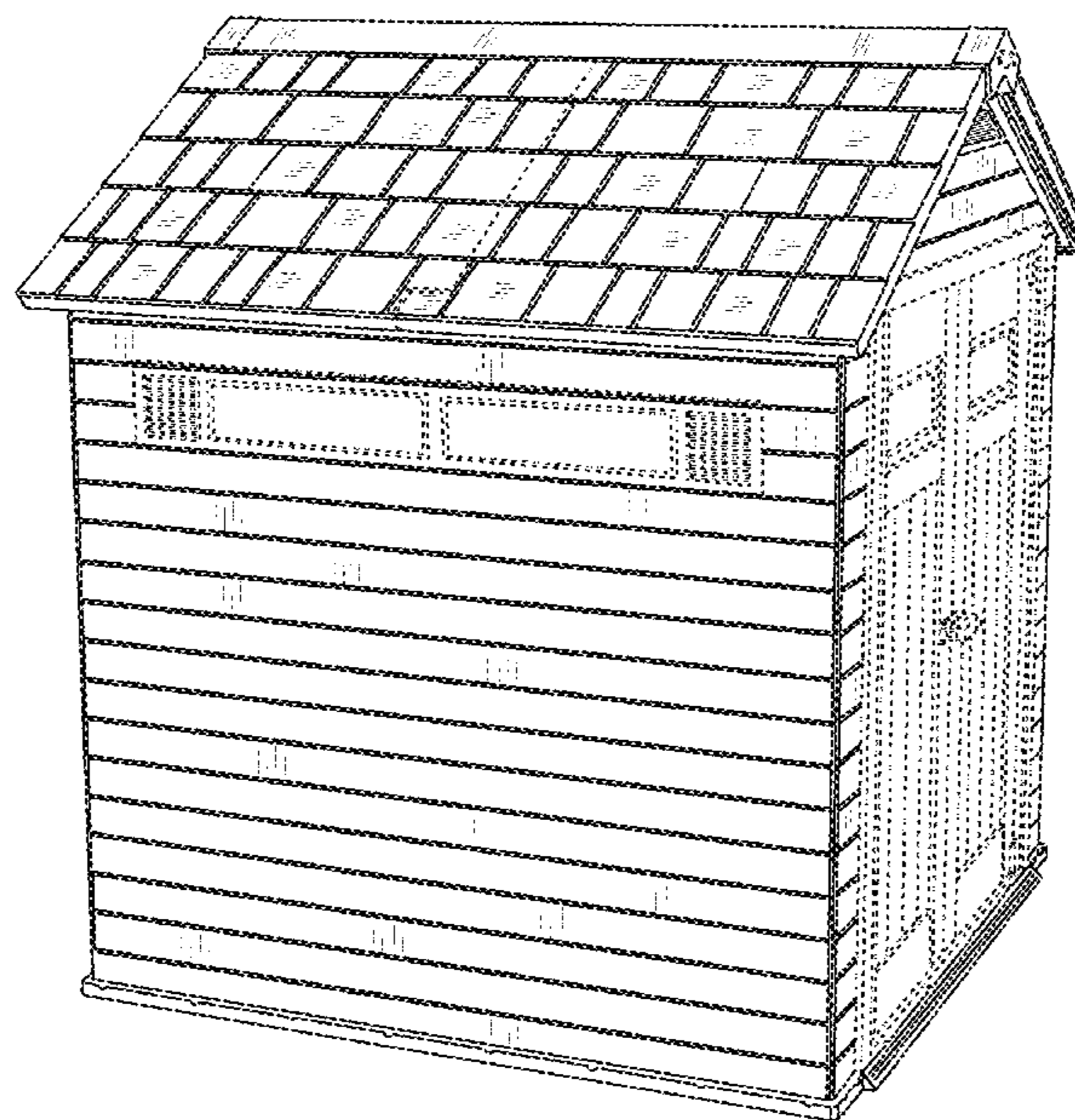

The ornamental design for a shed and shed roof, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a new design for a shed;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof,
FIG. 4 is a right-side elevational view thereof,
FIG. 5 is a left-side elevational view thereof; and,
FIG. 6 is a top planar view thereof.
The broken lines shown in FIGS. 1-6 illustrate portions of the shed and shed roof that form no part of the claimed design.

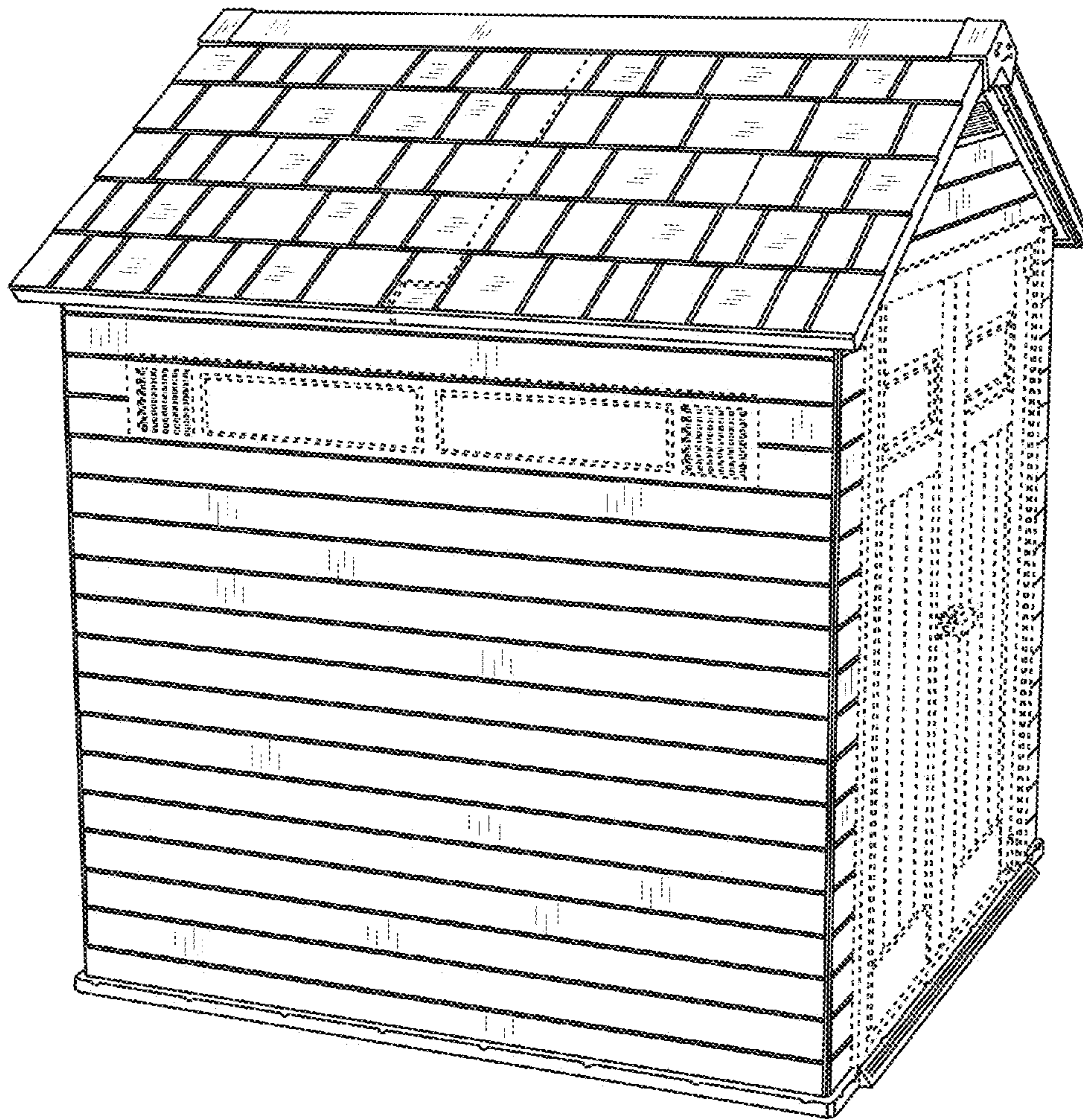

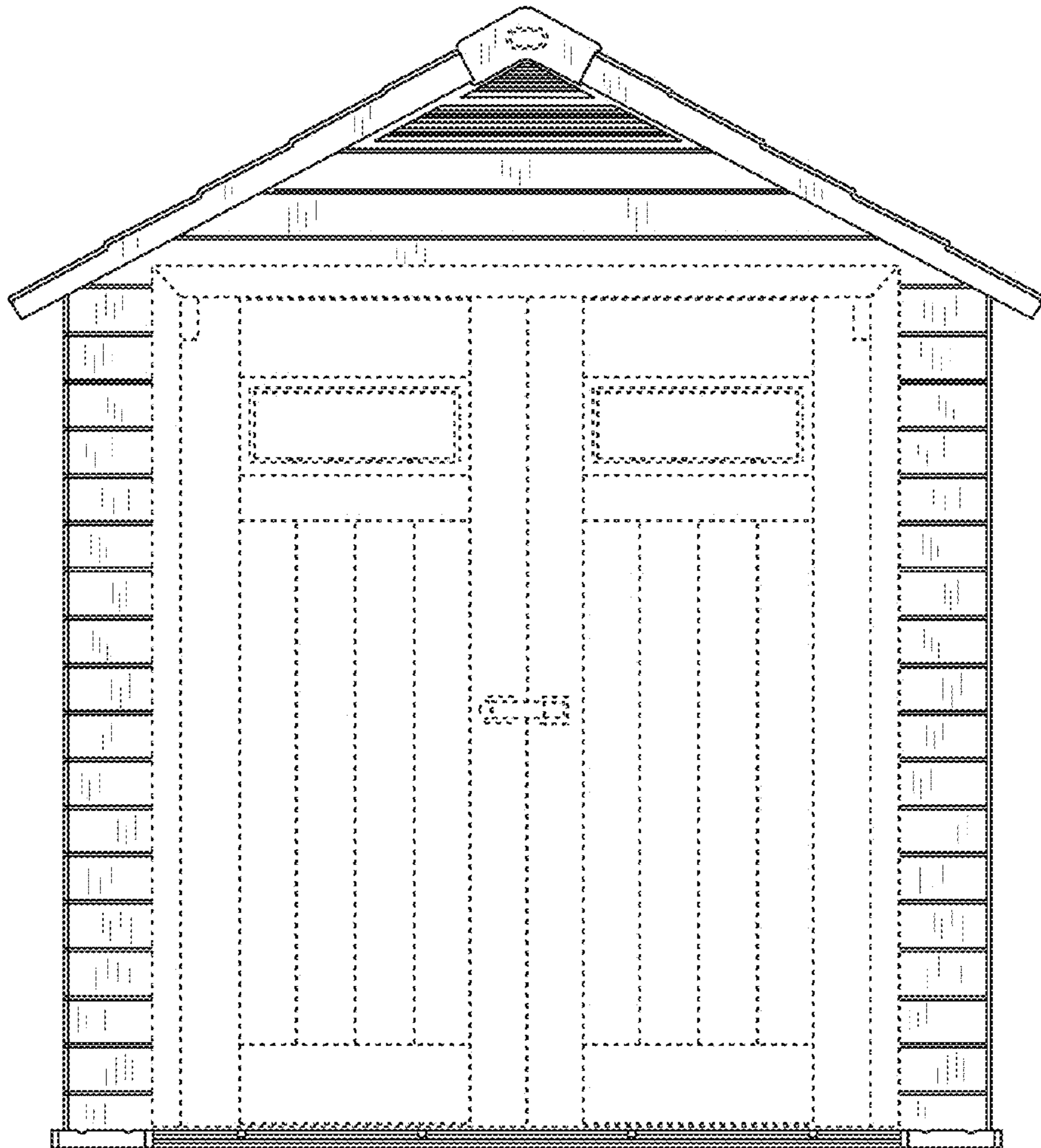

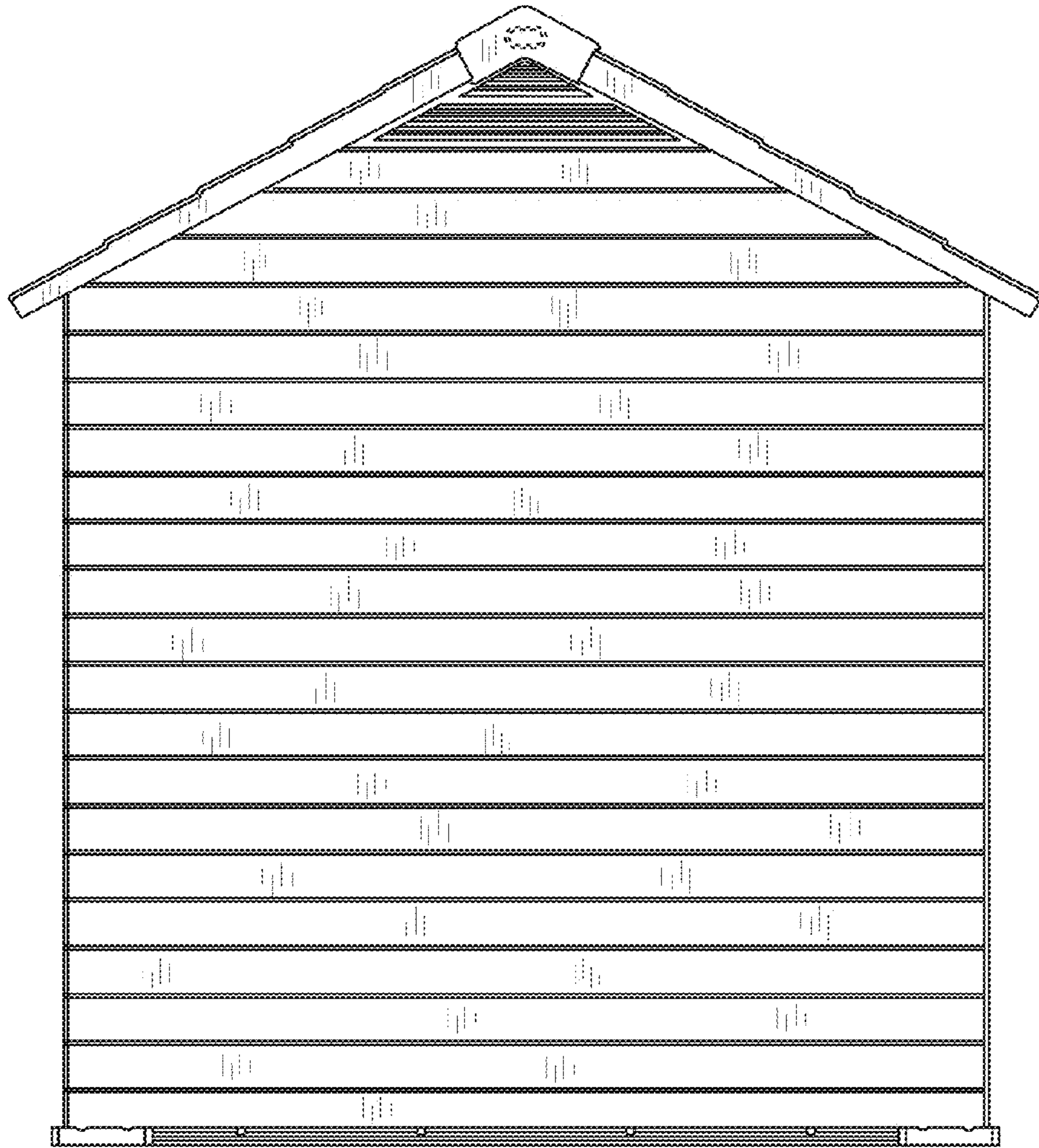

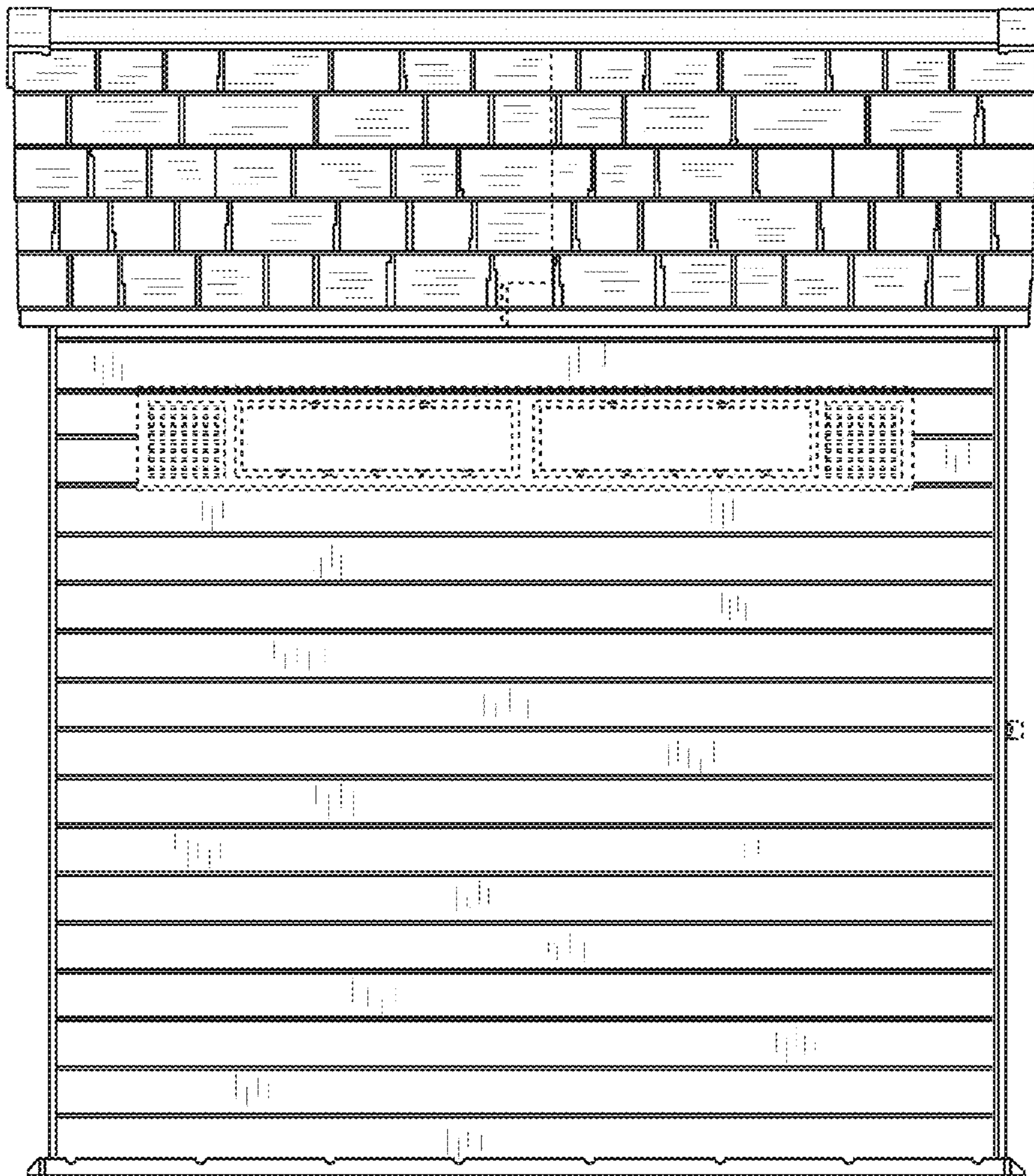

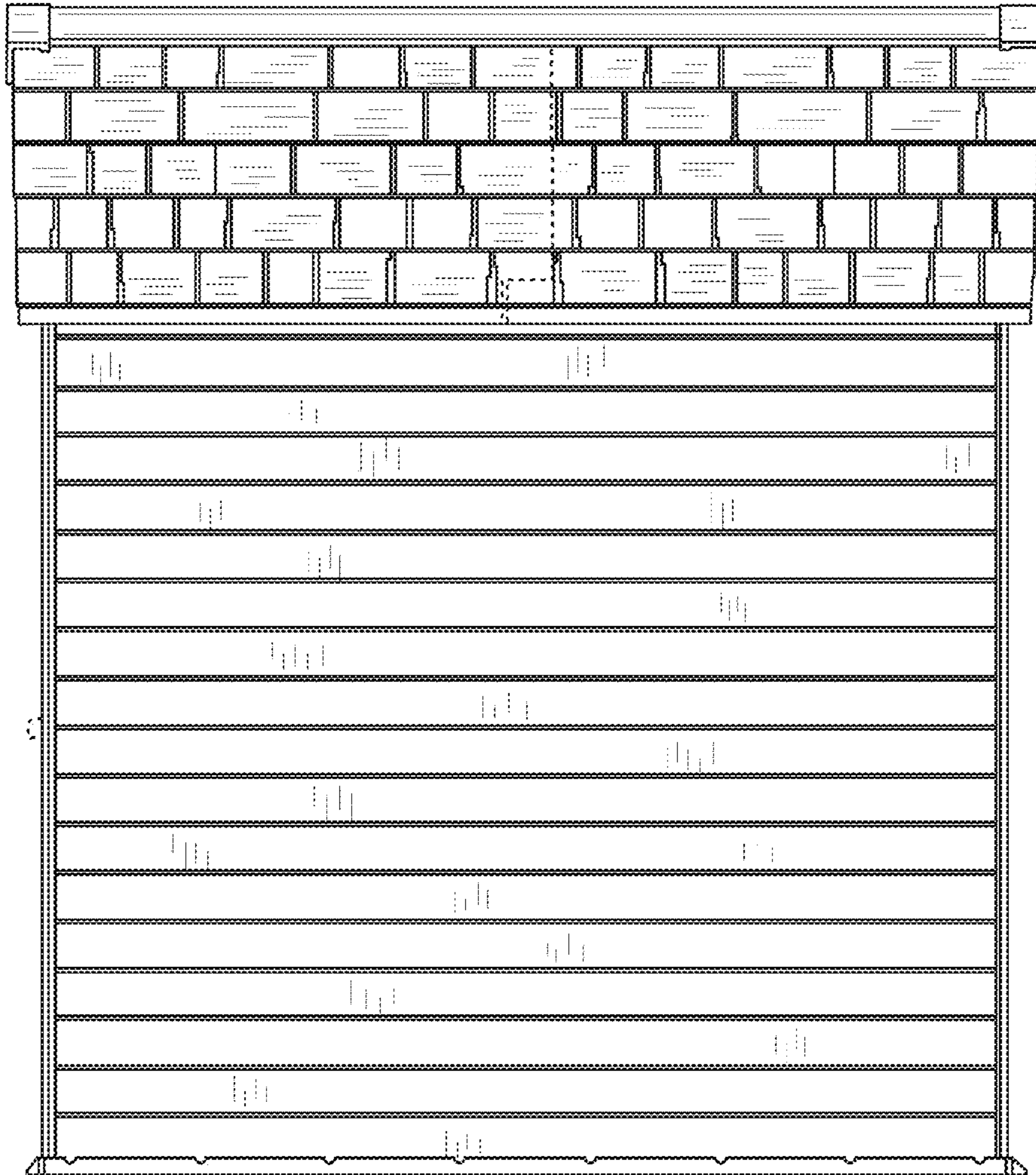

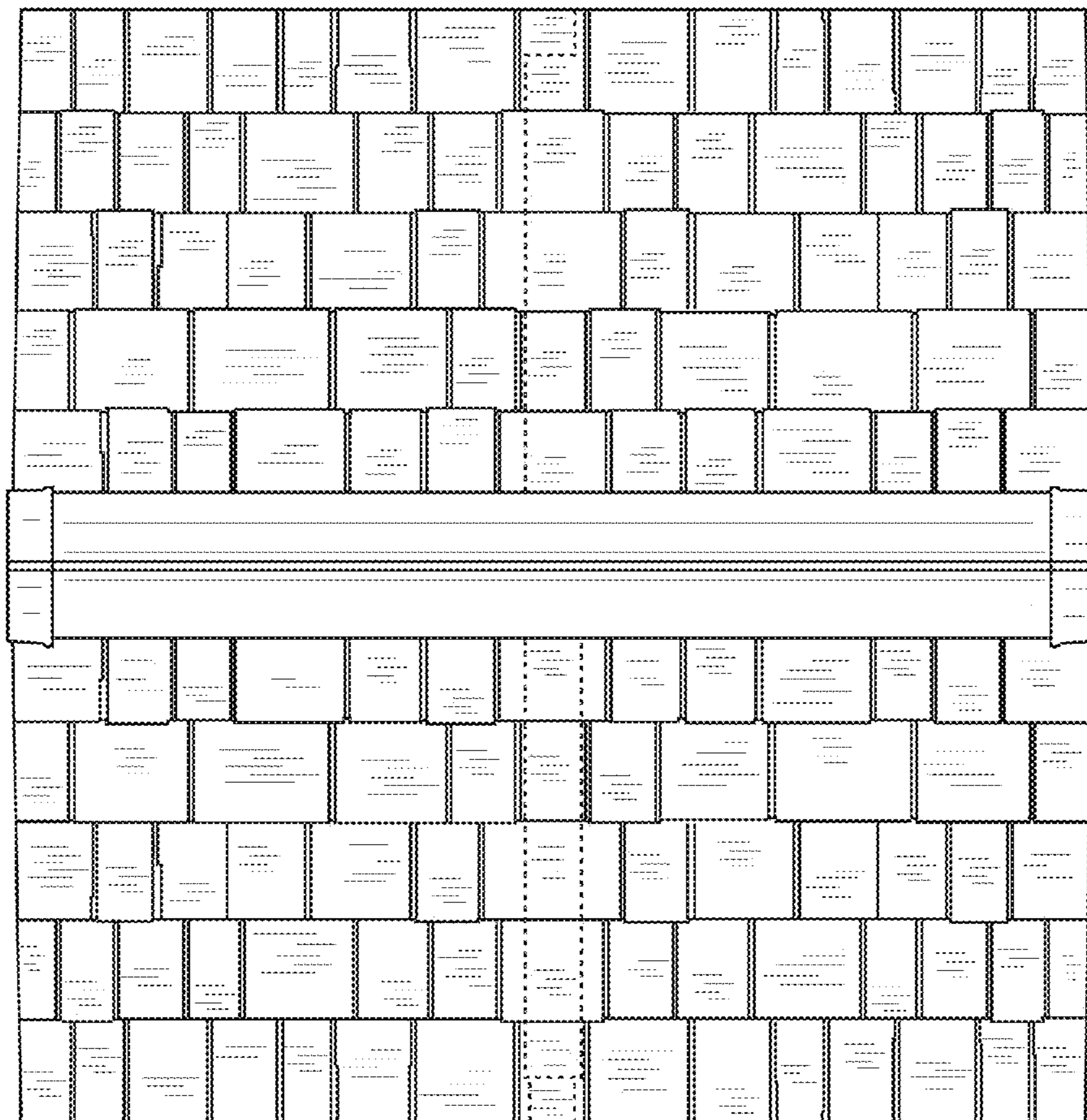
