(57) **CLAIM**

The ornamental design for a combined fence and gate, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view showing my new design for a combined fence and gate.

FIG. 2 is a side perspective view thereof.

FIG. 3 is a close up perspective view of the yard fence of the combined fence and gate on the left hand side of FIG. 1.

FIG. 4 is a top plan view thereof.

FIG. 5 is a front view thereof.

FIG. 6 is a left side elevation view thereof, and the right side elevation is the mirror image.

FIG. 7 is a bottom view thereof.

FIG. 8 is a top plan view of the yard gate of the combined fence and gate shown in FIG. 1.

FIG. 9 is a front elevation view thereof; the rear view is the mirror image.

FIG. 10 is a left side elevation view thereof, and the right side elevation is the mirror image.

FIG. 11 is a bottom view thereof.

FIG. 12 is a top plane view of a segment of a fence on top of a wall of the combined fence and gate as shown in FIG. 1.

FIG. 13 is a front elevation view thereof; the rear view is the mirror image.

FIG. 14 is a left side elevation view thereof, and the right side elevation is the mirror image.

FIG. 15 is a top plan view of a segment of a fence on top of a wall of the combined fence and gate as shown in FIG. 1.

FIG. 16 is a front elevation view thereof, the rear view is the mirror image.

FIG. 17 is a left side elevation view thereof, and the right side elevation is the mirror image.

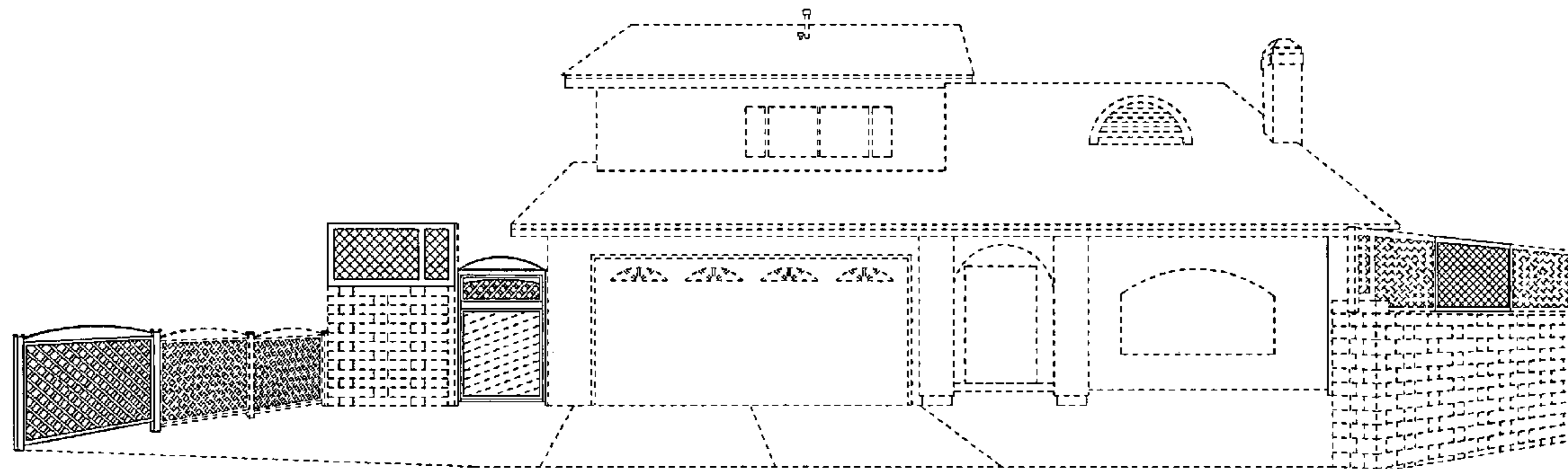
FIG. 18 is a top plan view of a portion of a fence on top of a wall of the combined fence and gate as shown in FIG. 2.

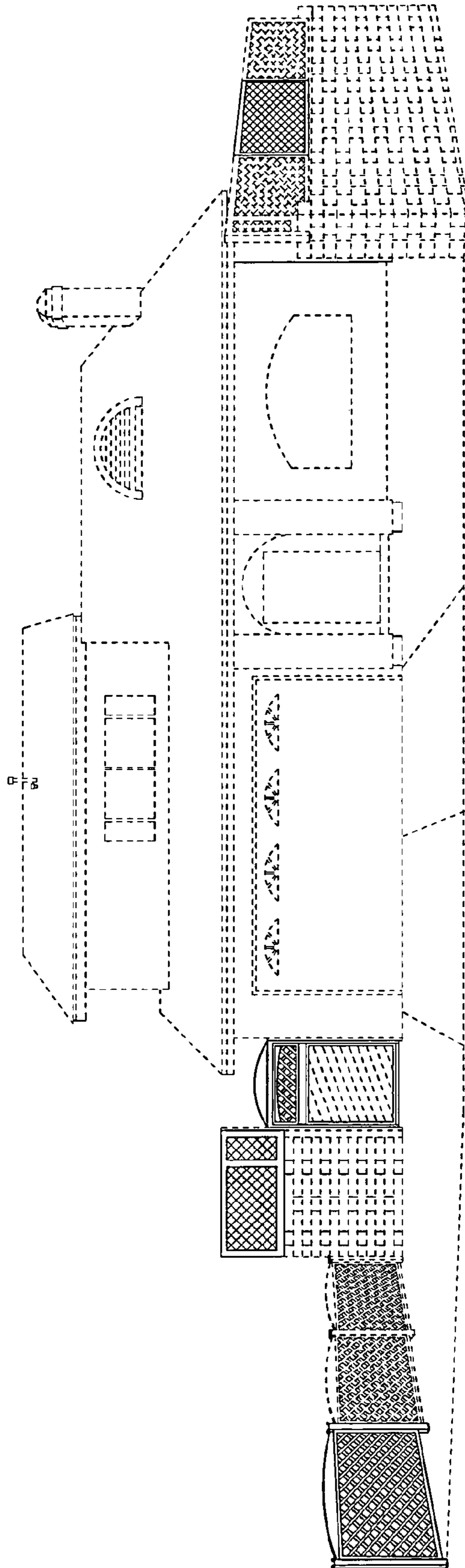

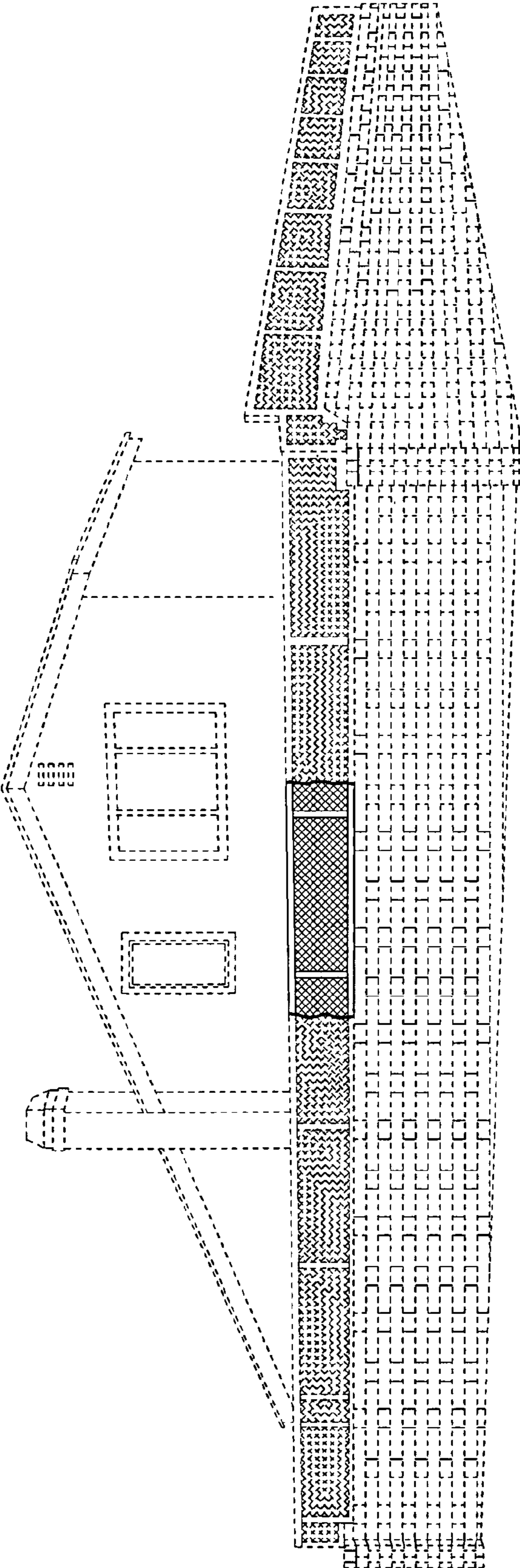

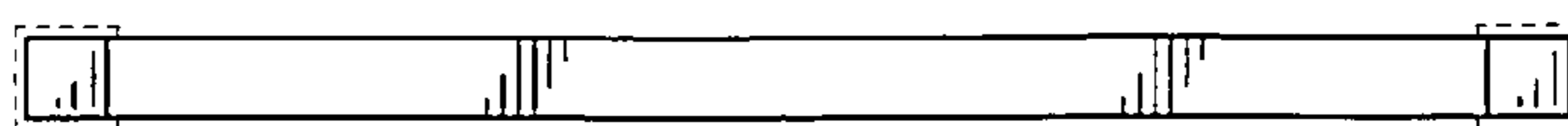
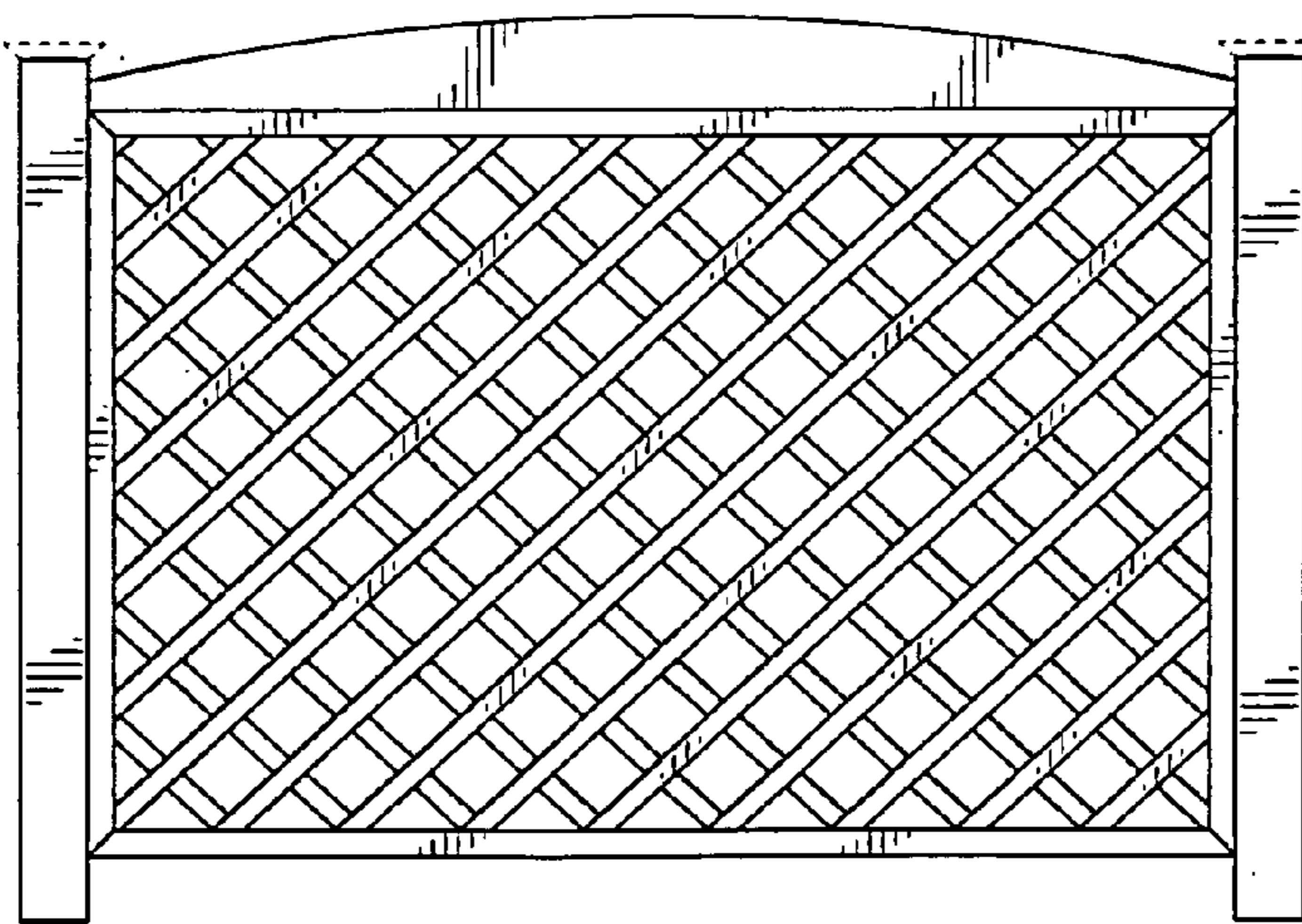
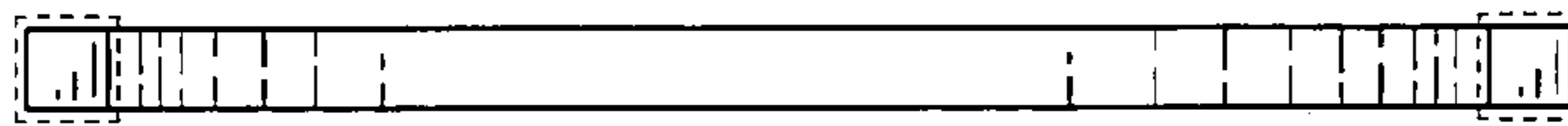
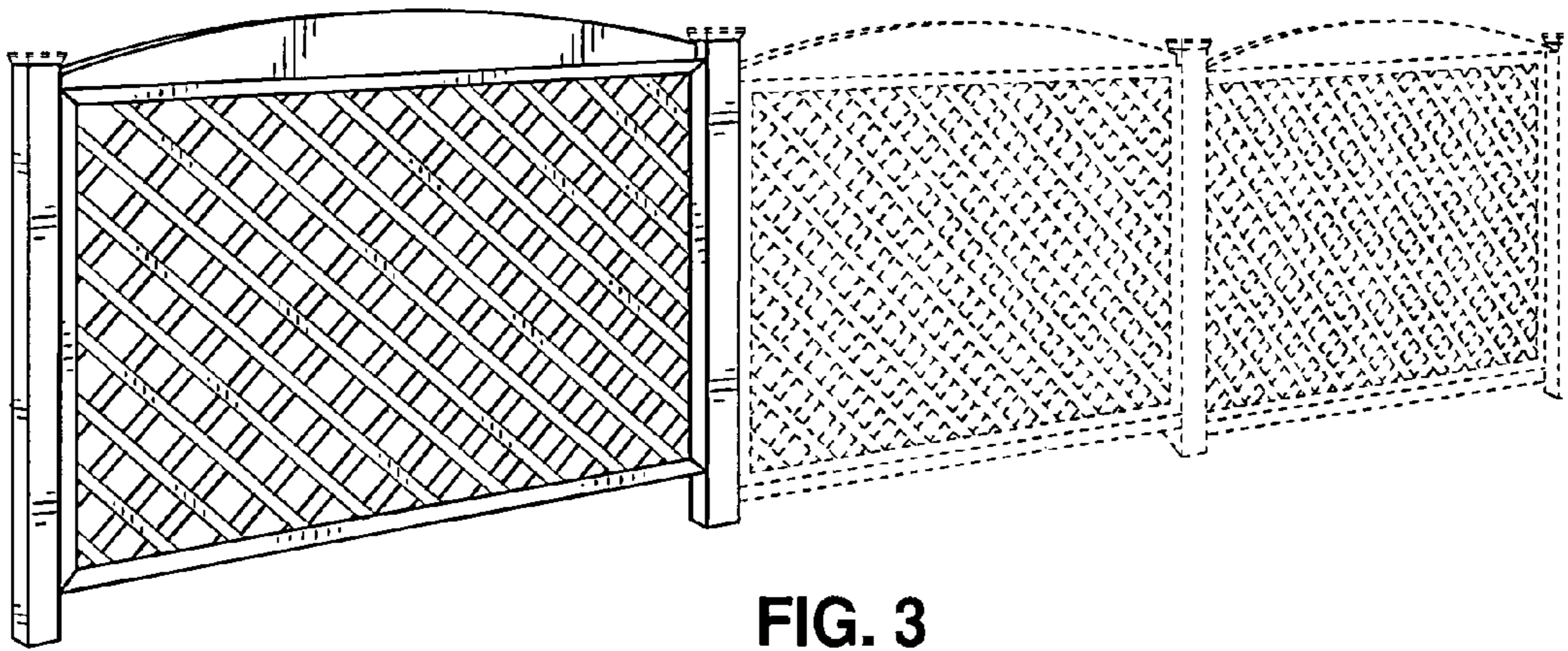

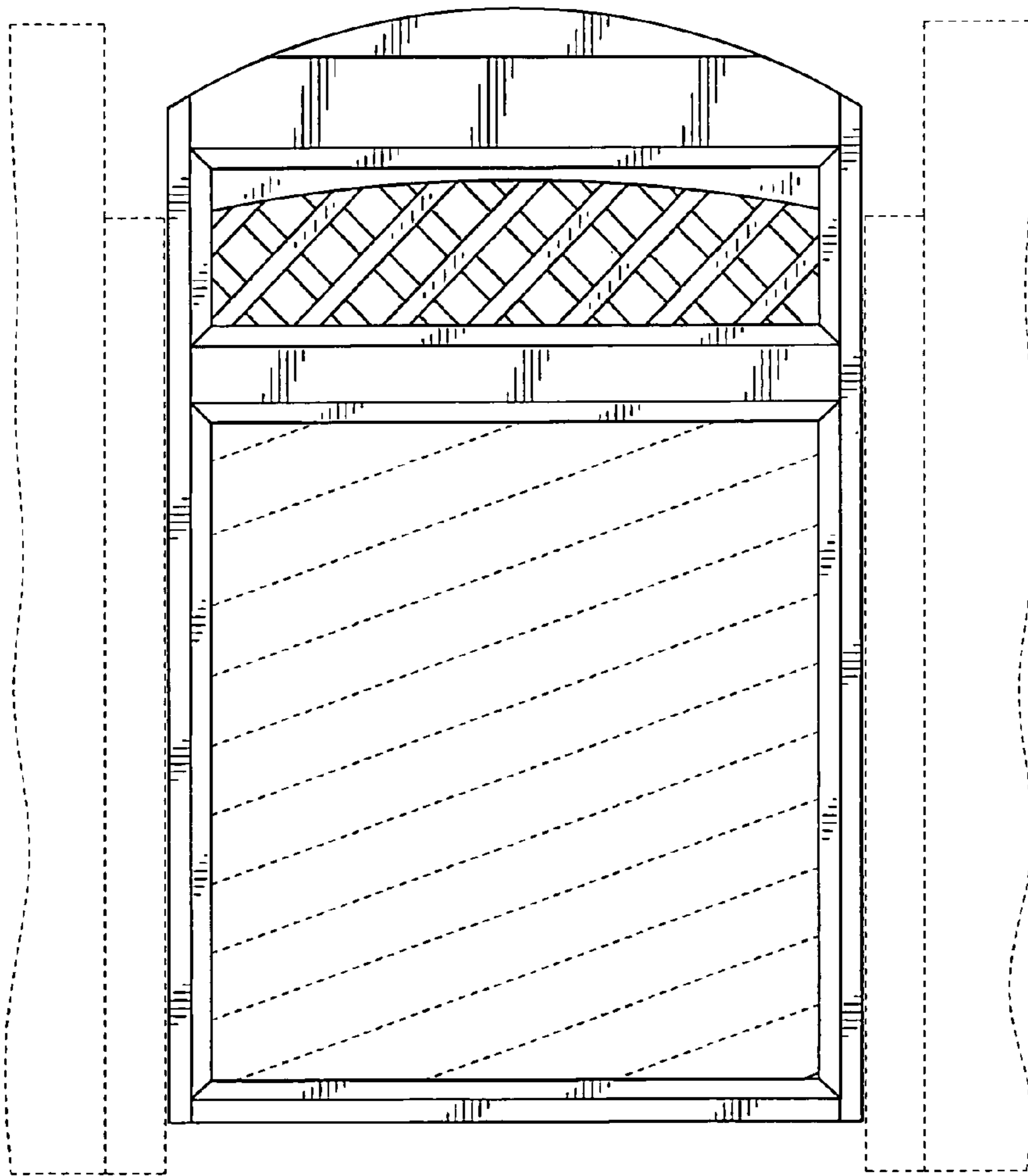

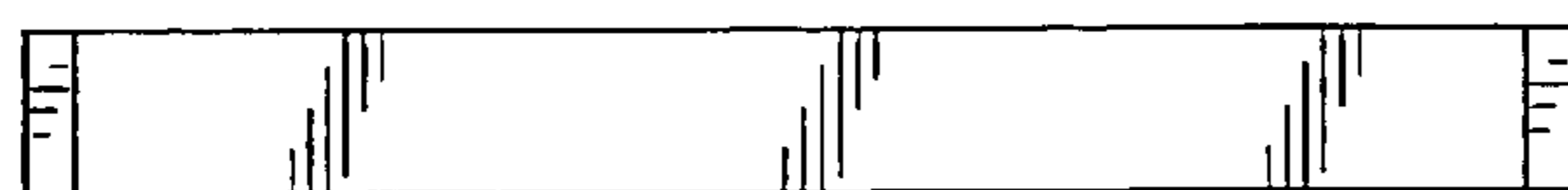

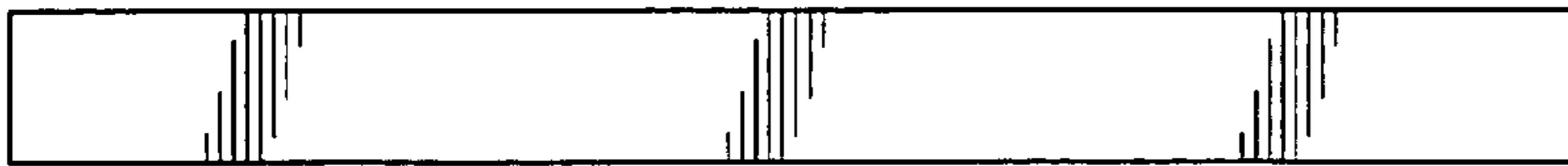

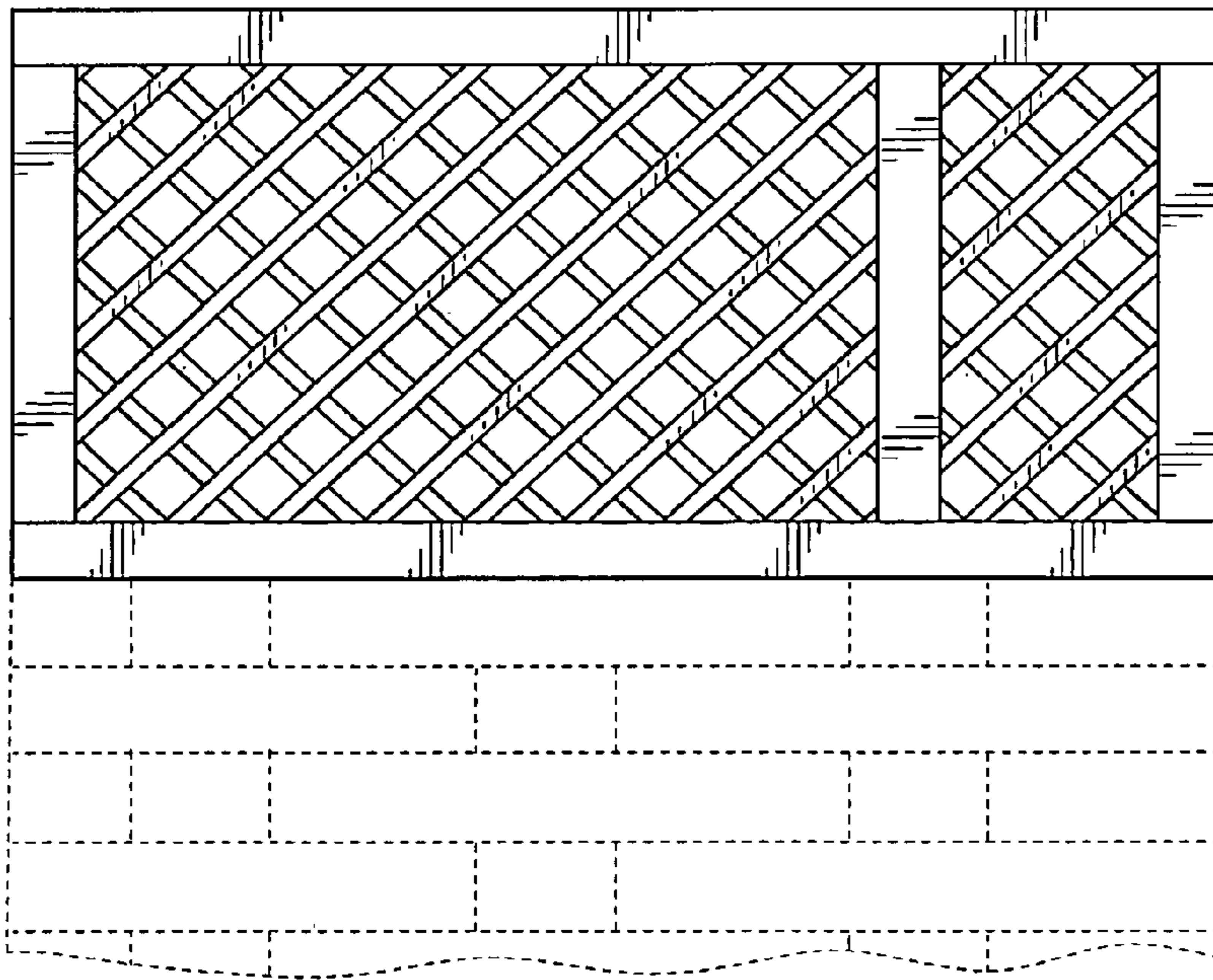

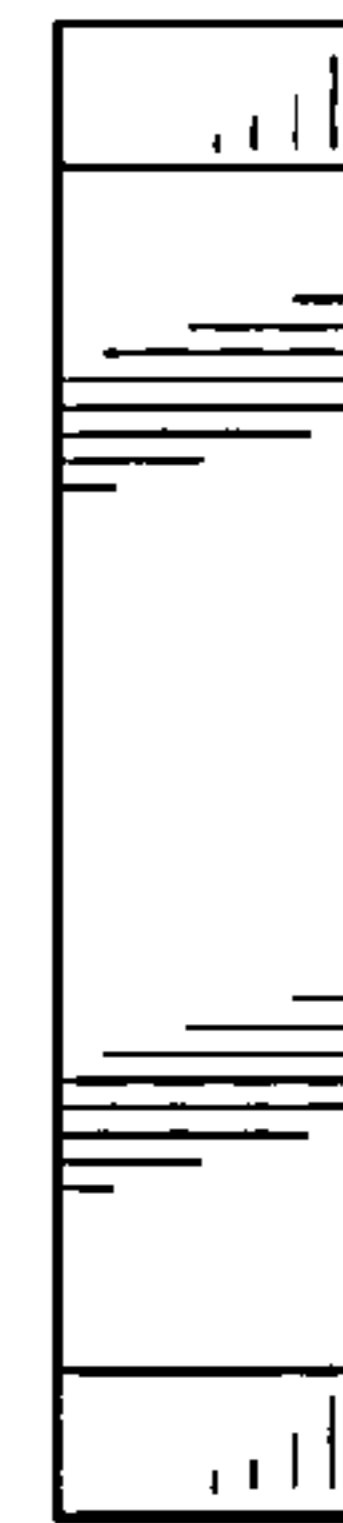

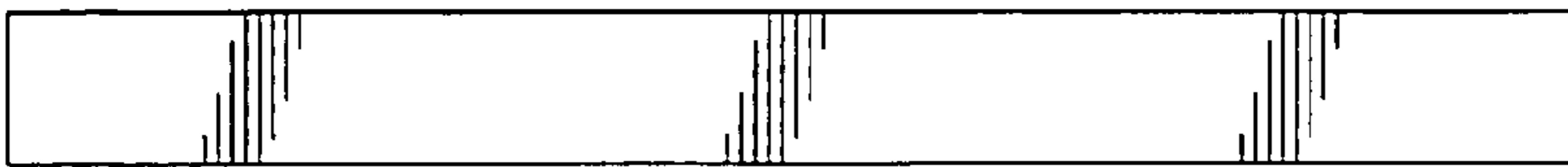

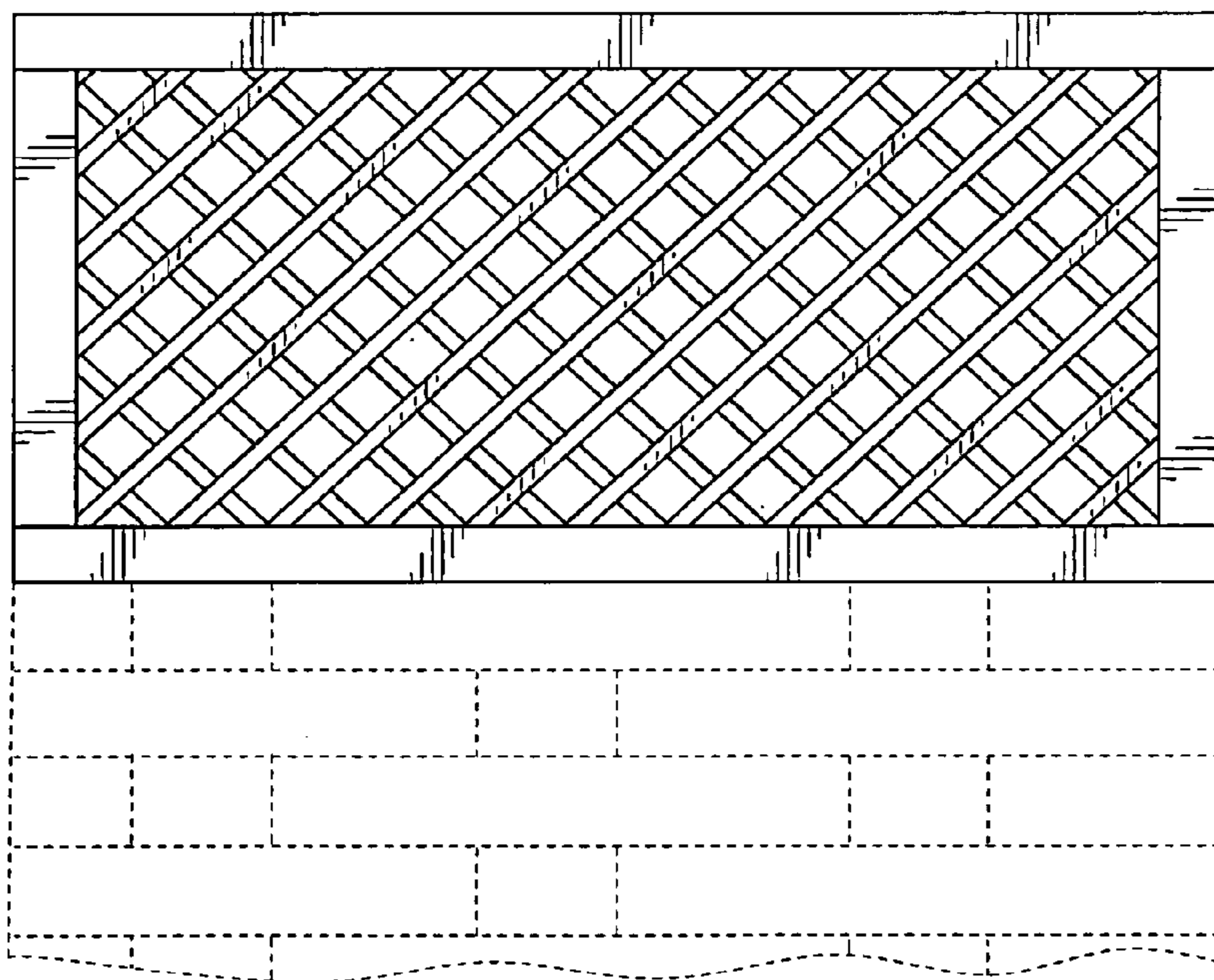

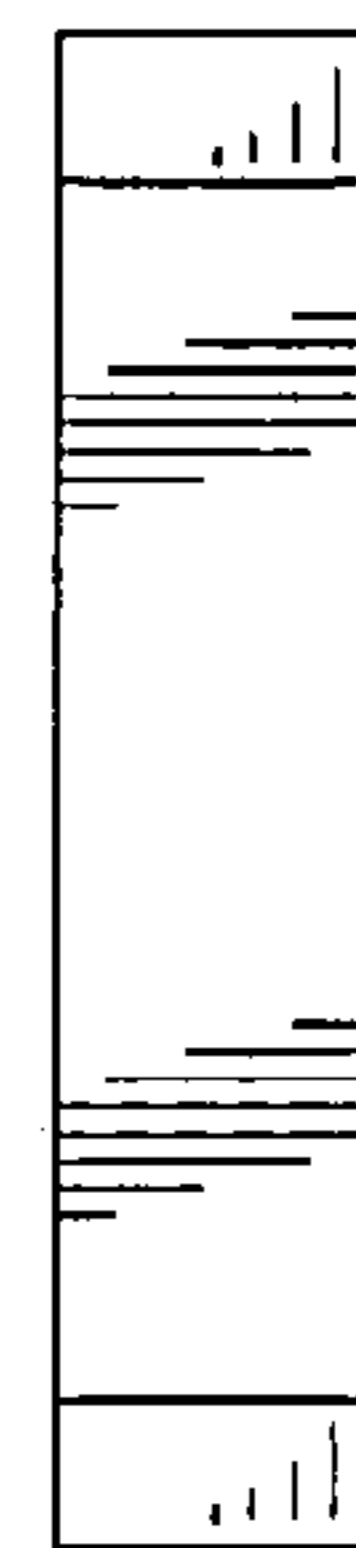

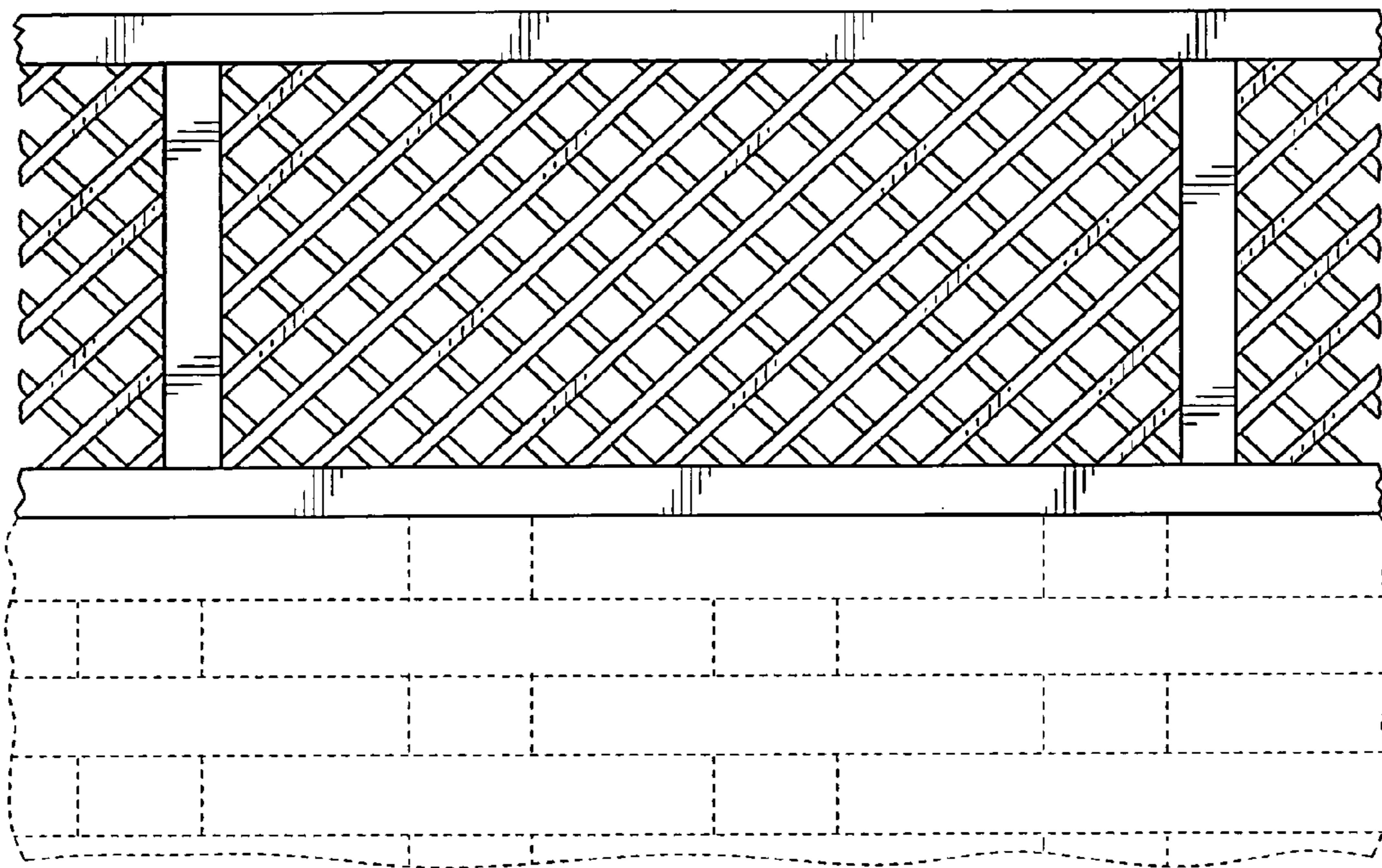

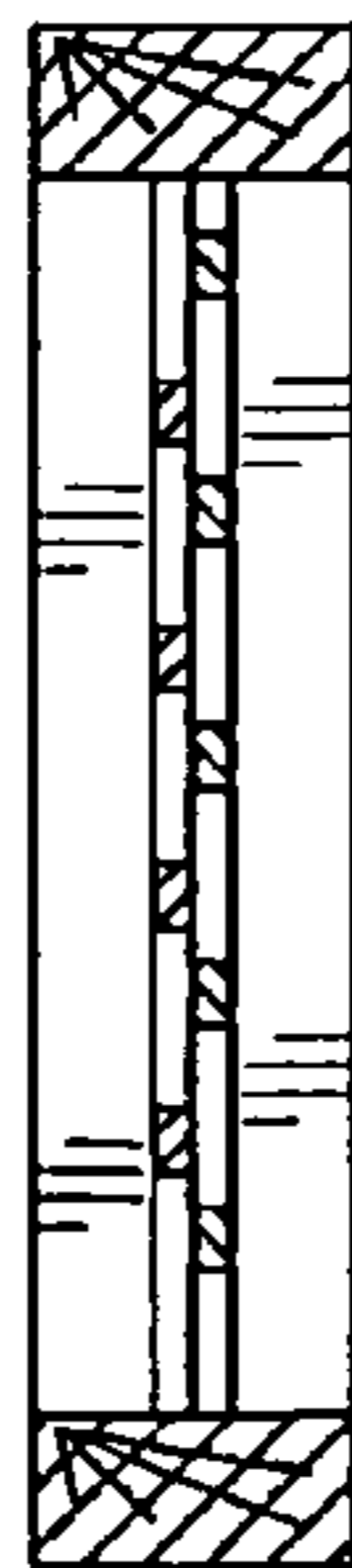
