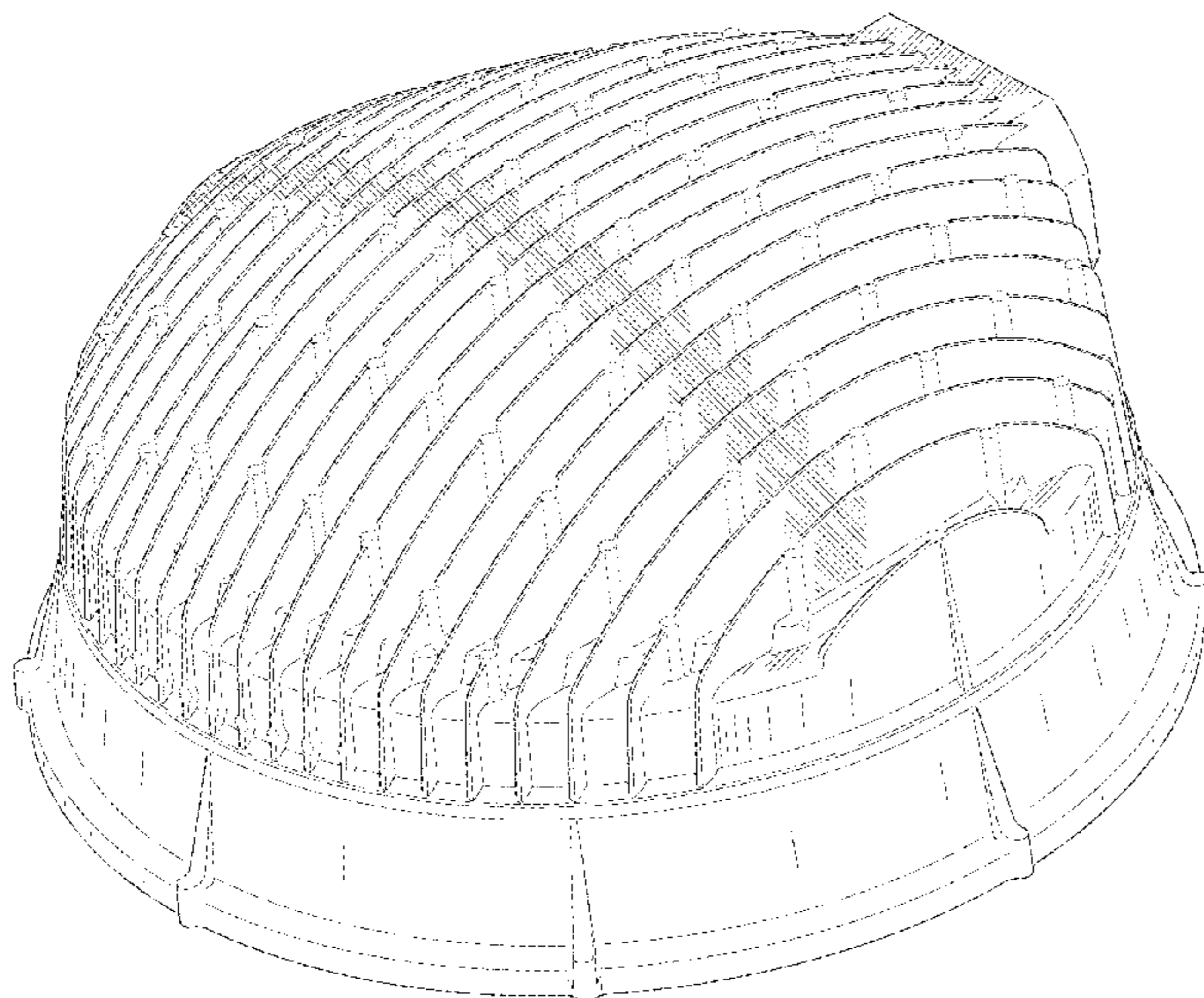
(57) **CLAIM**  
The ornamental design for a domed floodlight fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a domed floodlight fixture showing the present invention;  
FIG. 2 is a front elevation of FIG. 1;  
FIG. 3 is a back elevation of FIG. 1;  
FIG. 4 is a top plan view of FIG. 1;  
FIG. 5 is a bottom plan view of FIG. 1;  
FIG. 6 is a right side elevation of FIG. 1; and,  
FIG. 7 is a left side elevation of FIG. 1.  
The broken lines in the drawings illustrate portions of the domed floodlight fixture that form no part of the claimed design.

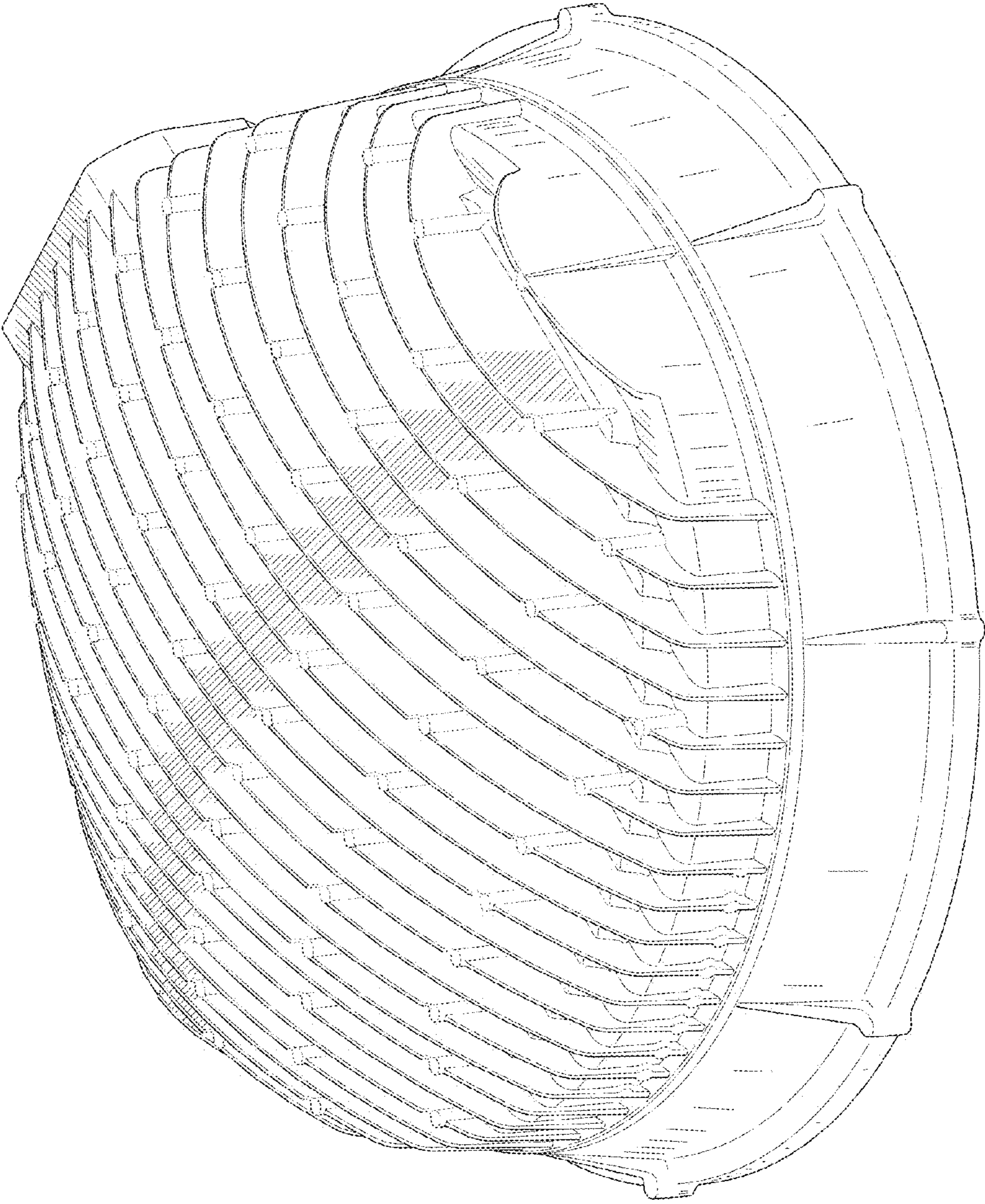

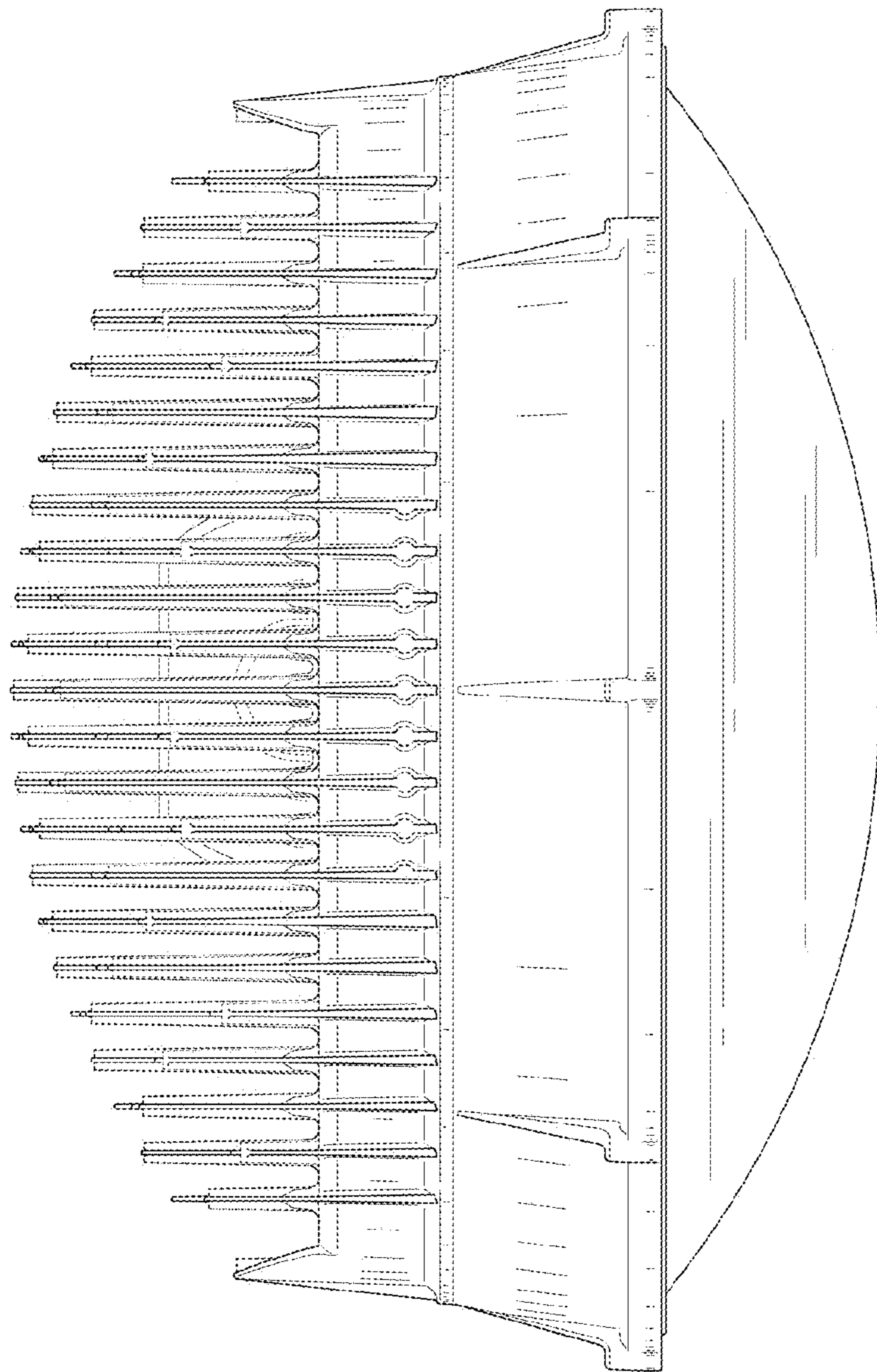

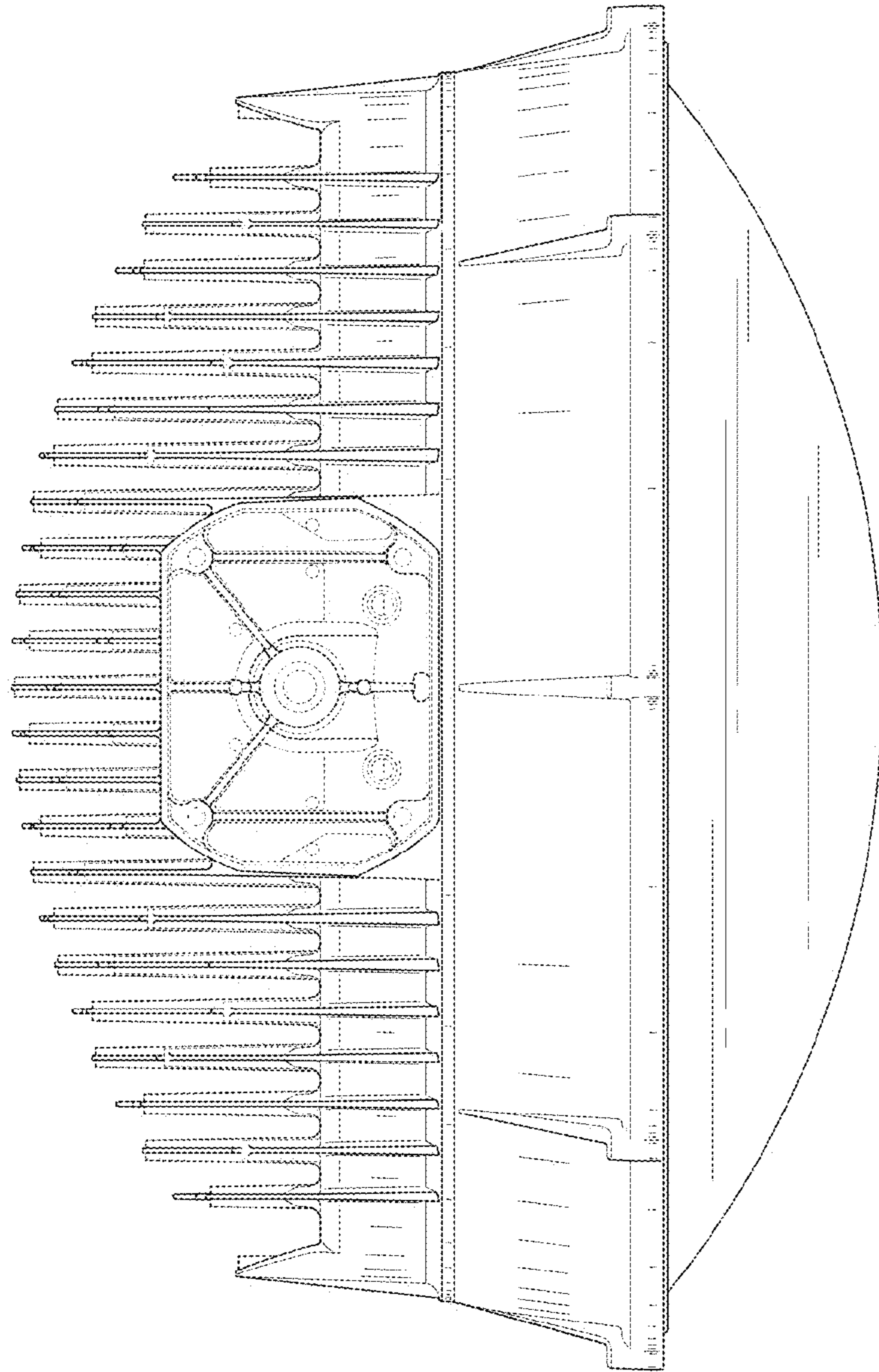

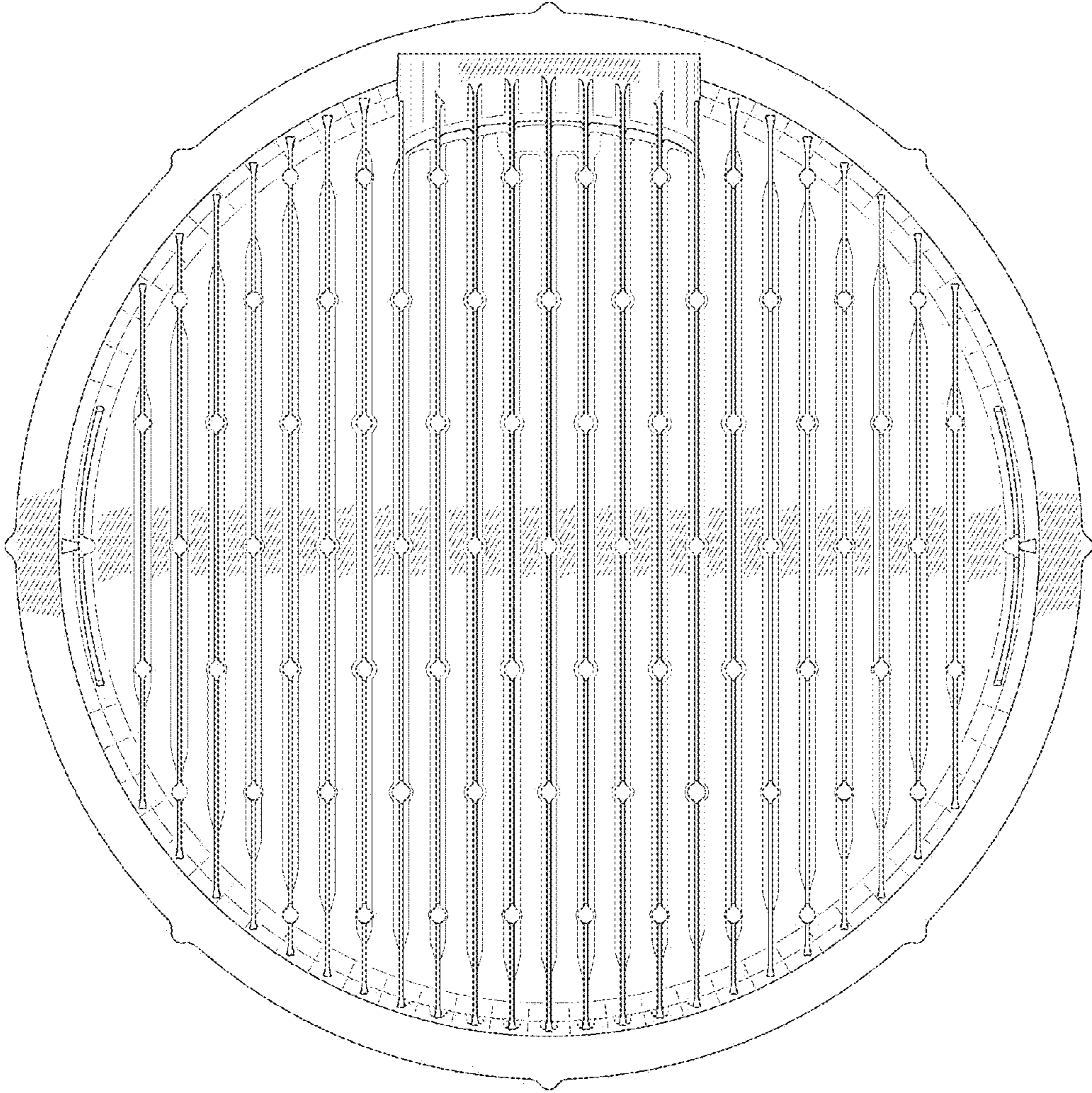

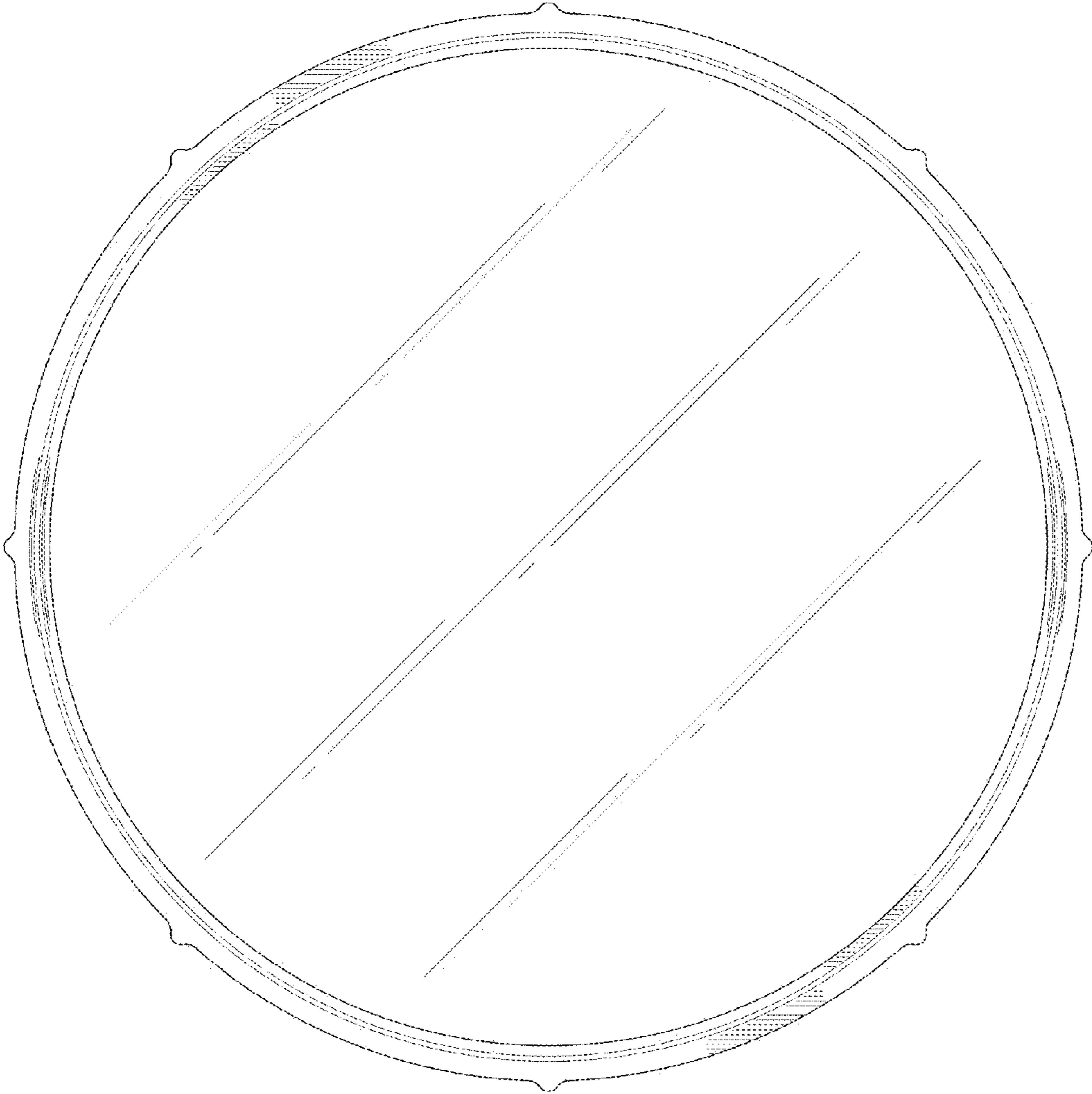

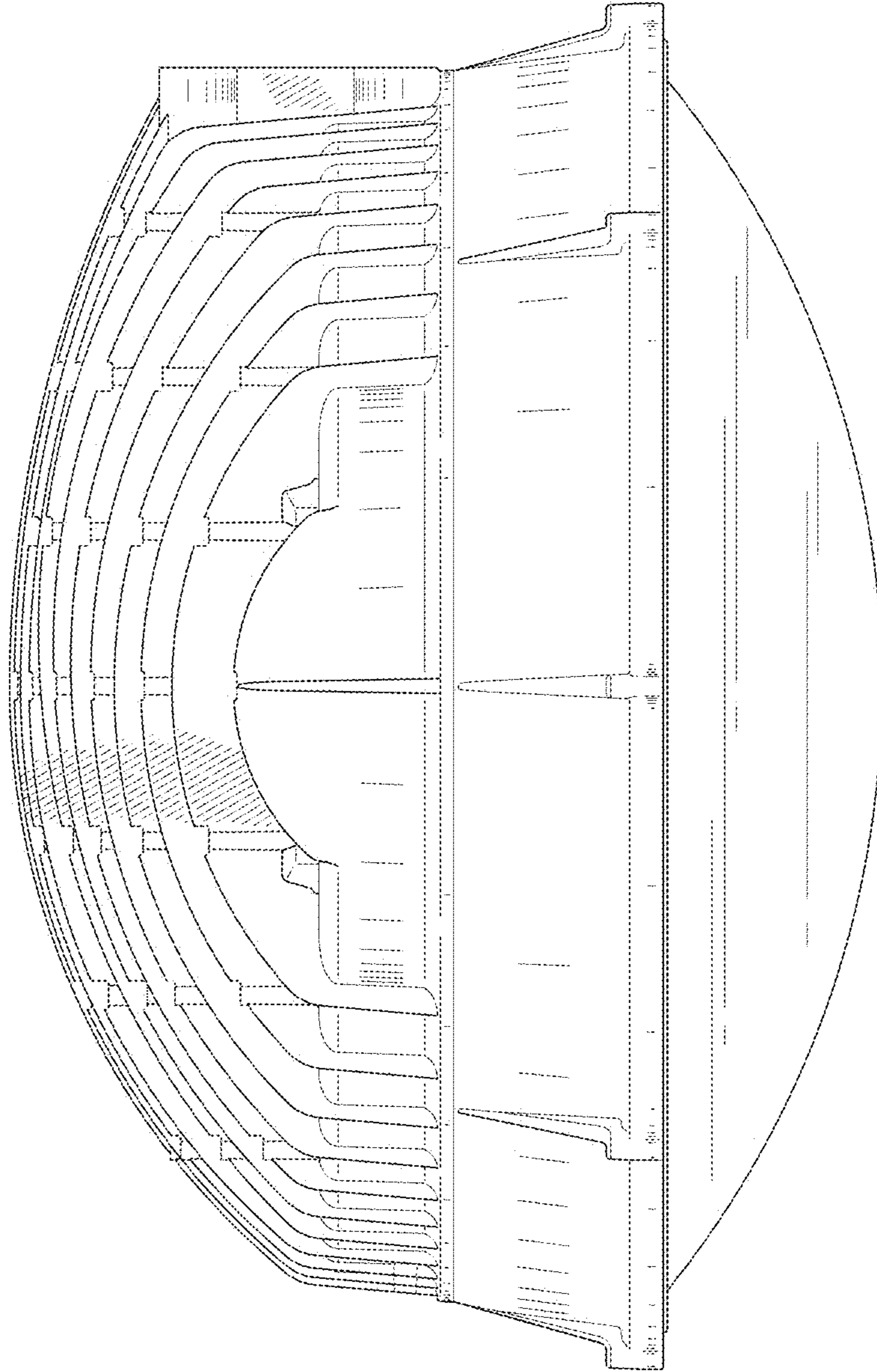

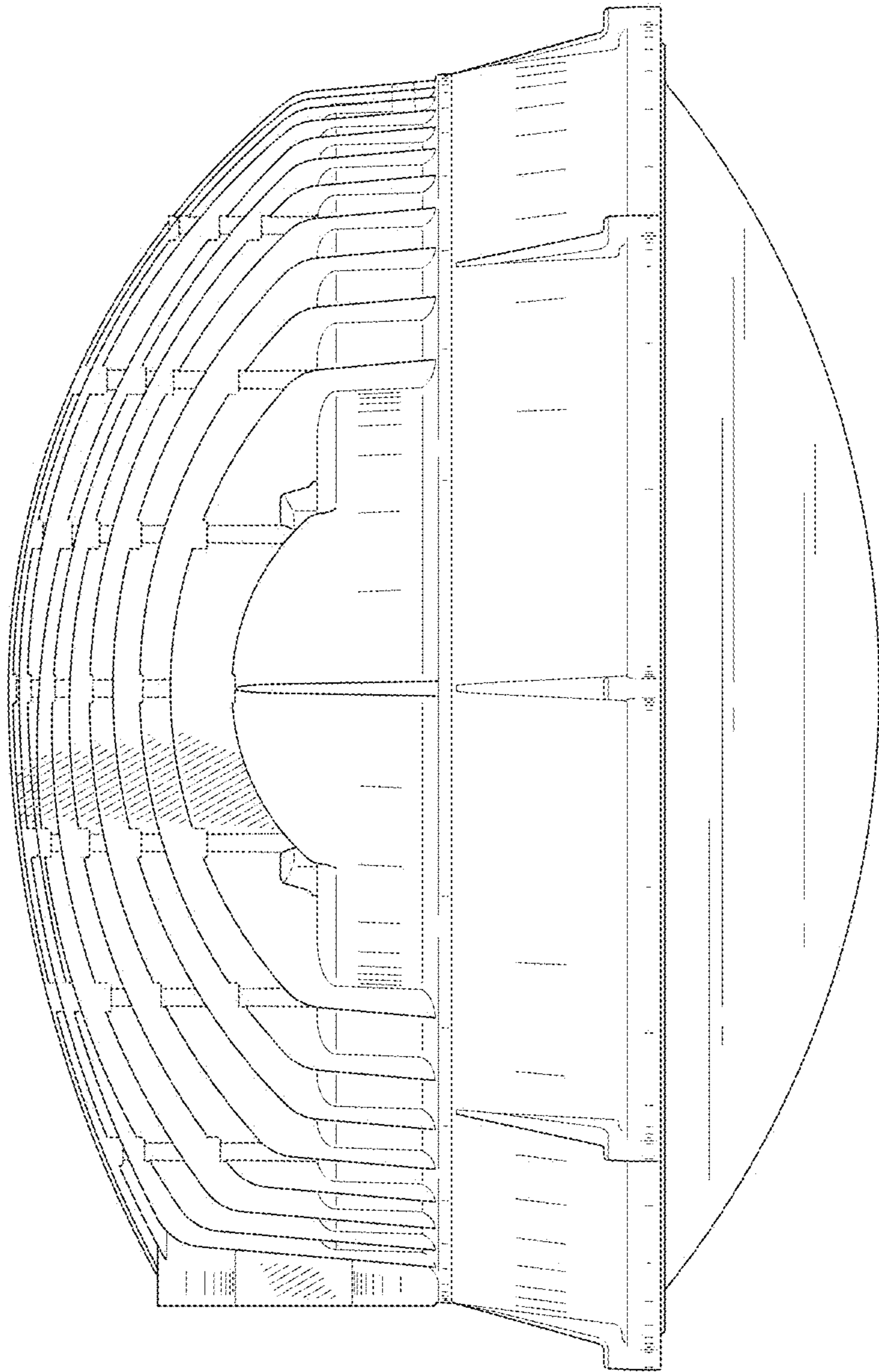
