The broken lines are for environmental purposes only and form no part of the claimed design.

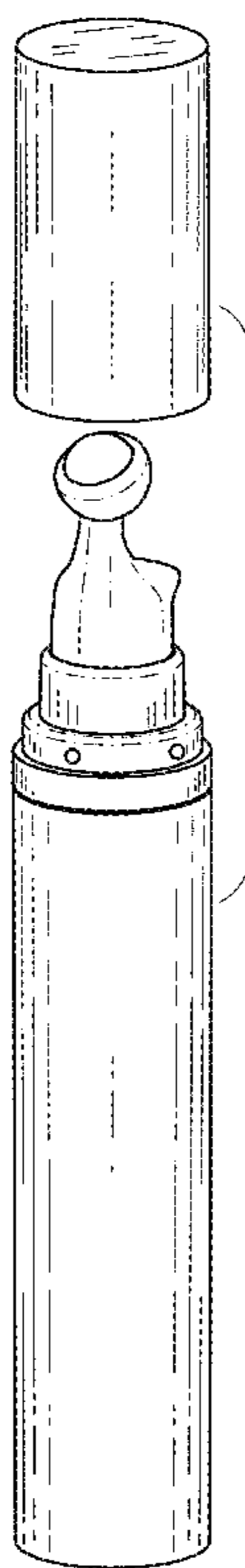

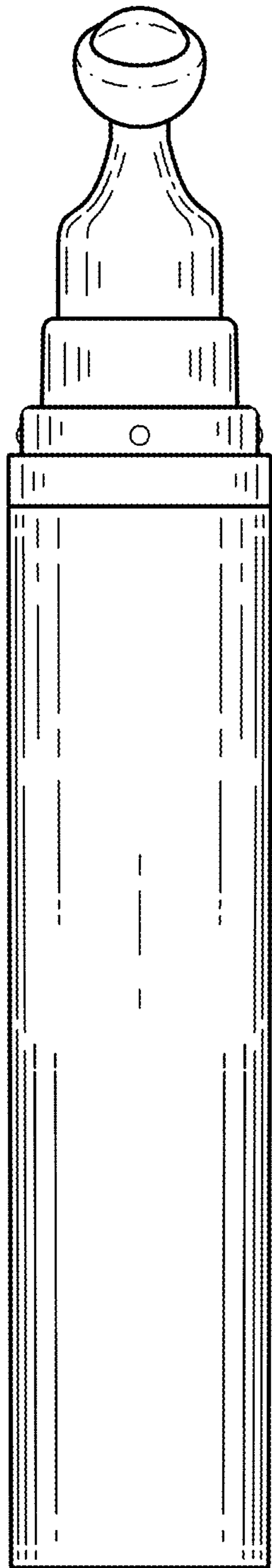

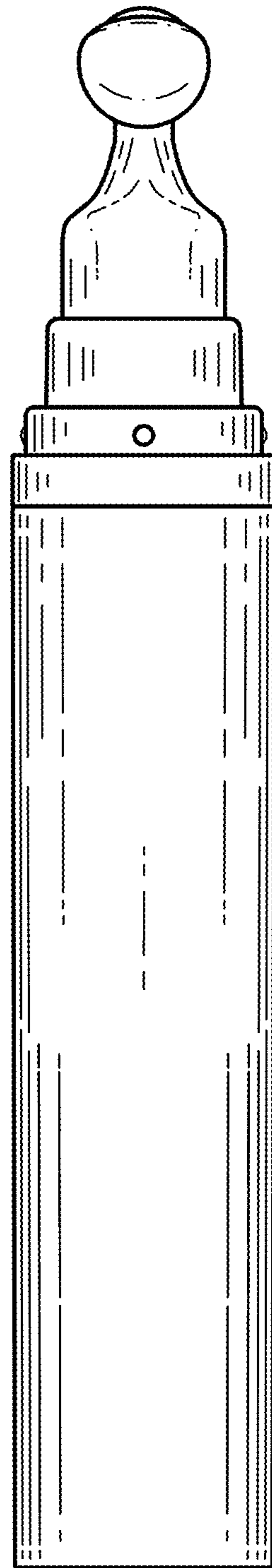

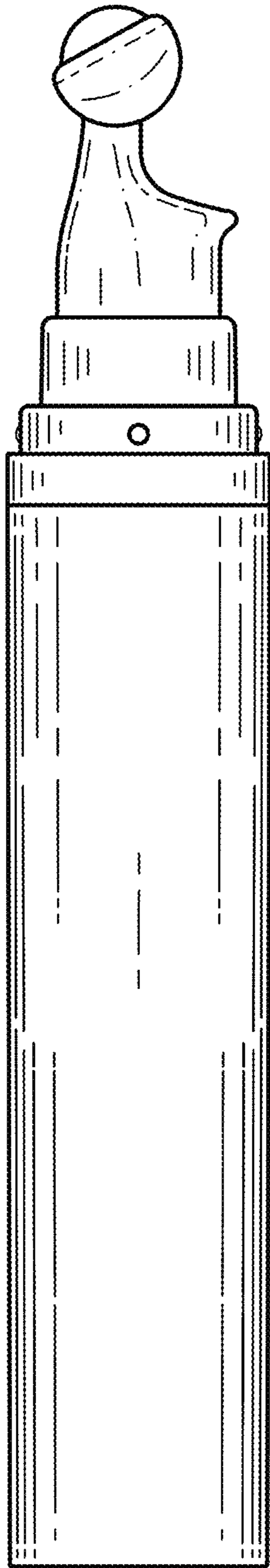

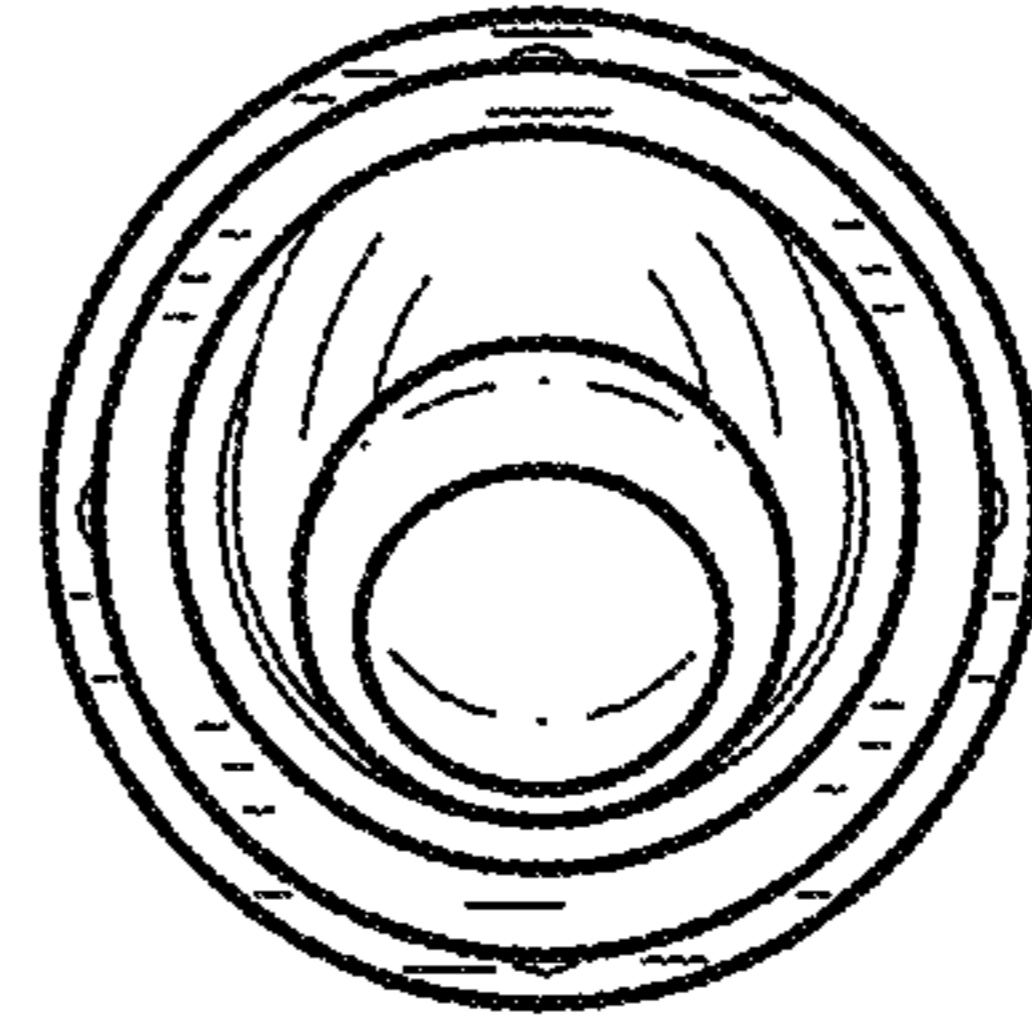

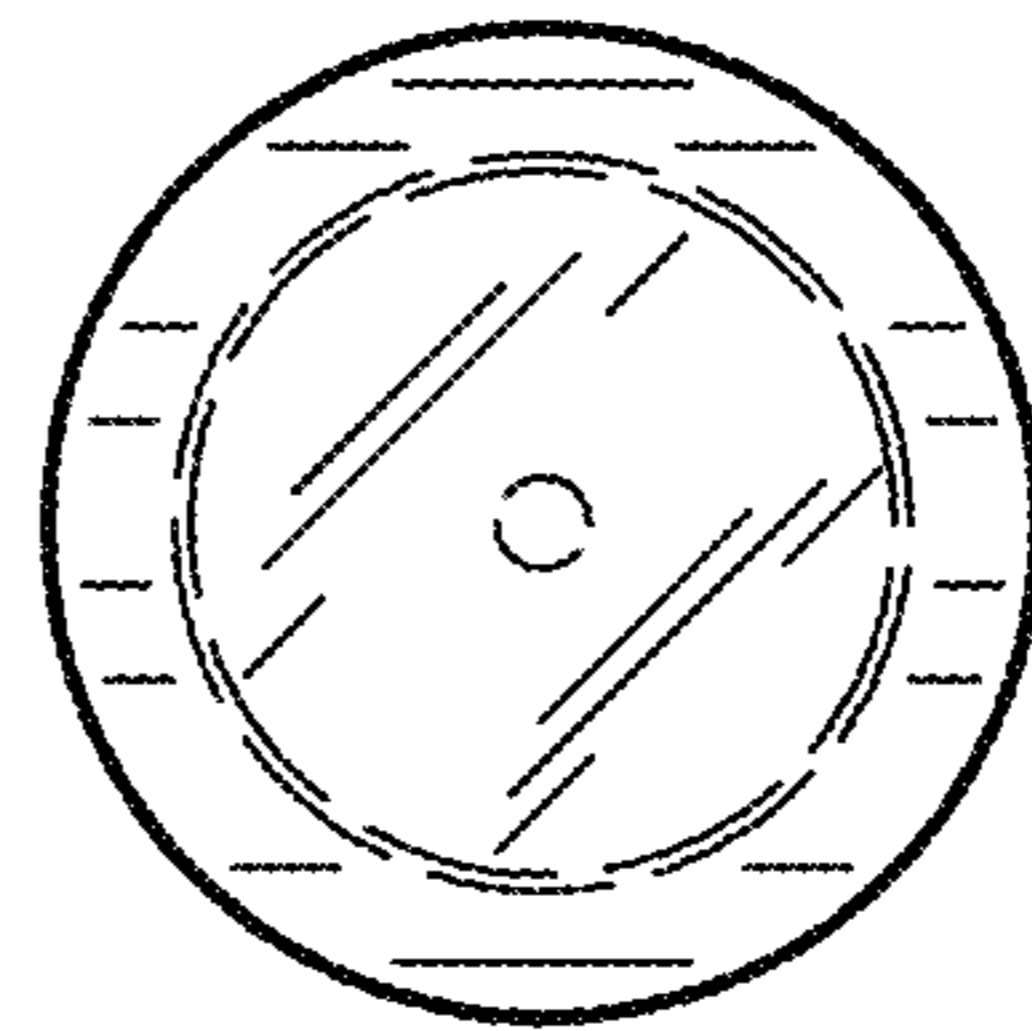

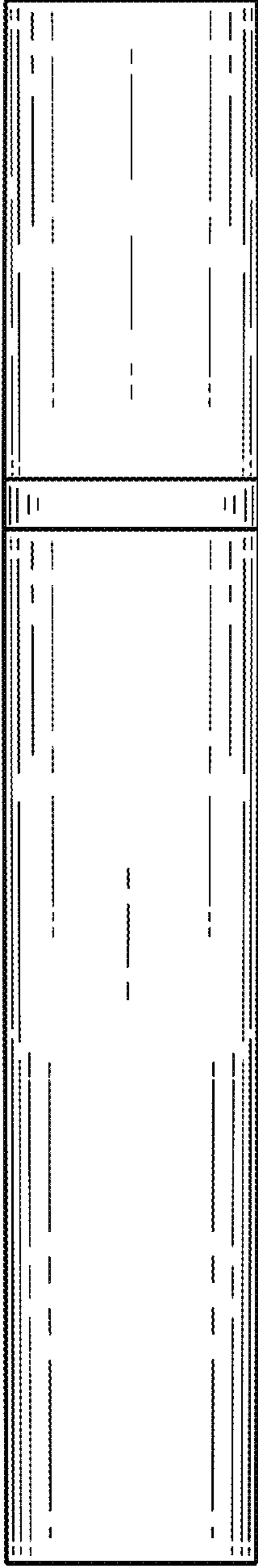

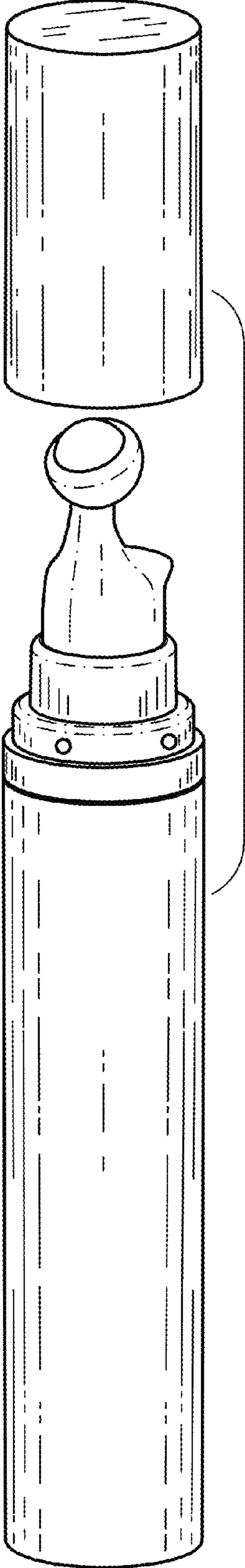
