(57) **CLAIM**

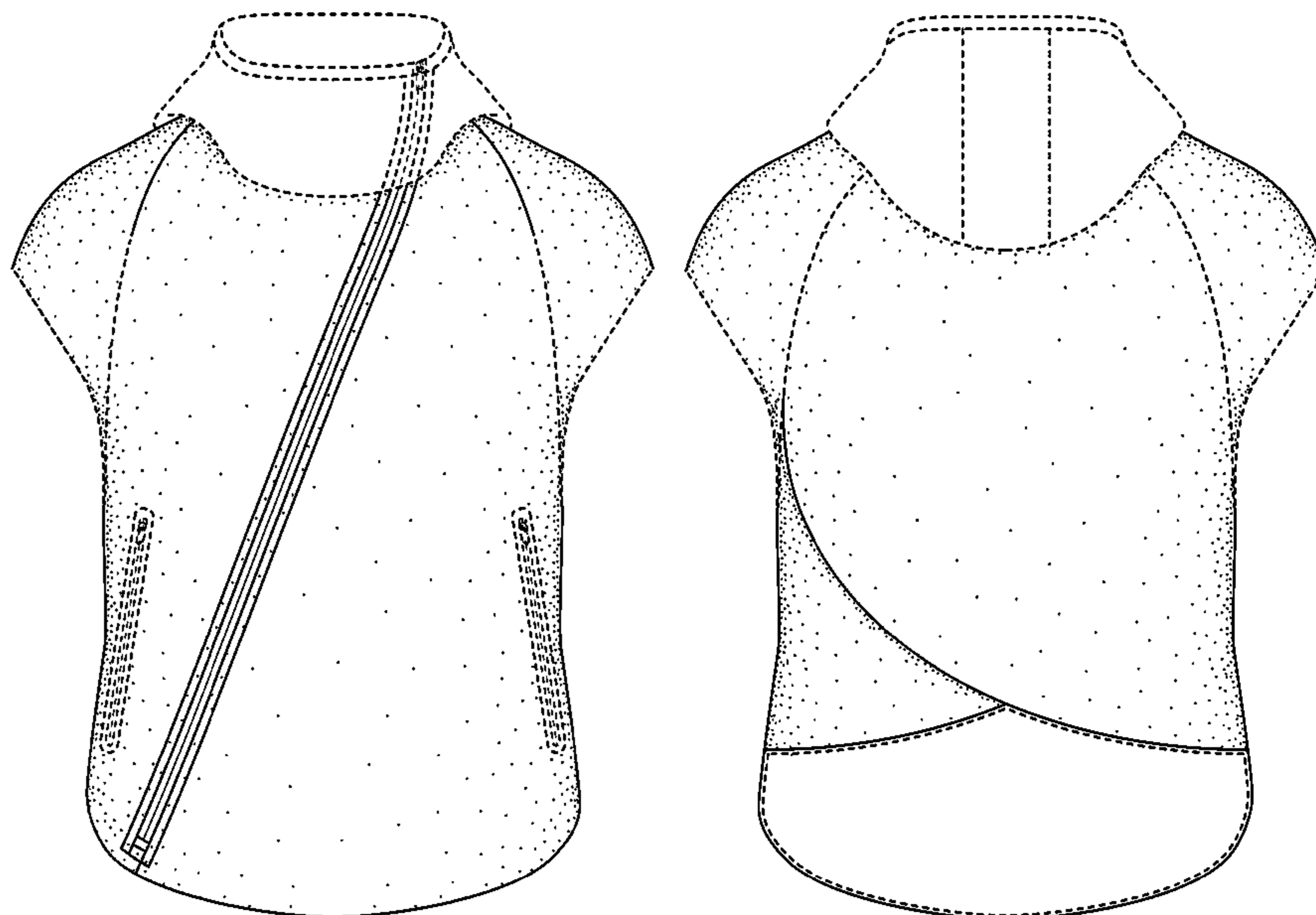
The ornamental design for a hooded garment, as shown and described.

DESCRIPTION

FIG. 1 is a left perspective front view of a hooded garment showing my new design in an in-use configuration; FIG. 2 is right perspective front view thereof; FIG. 3 is a front view thereof; FIG. 4 is a back side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; and, FIG. 7 is a top view thereof.

The broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The broken lines within the shaded area for are for environmental purposes only and form no part of the claimed design. 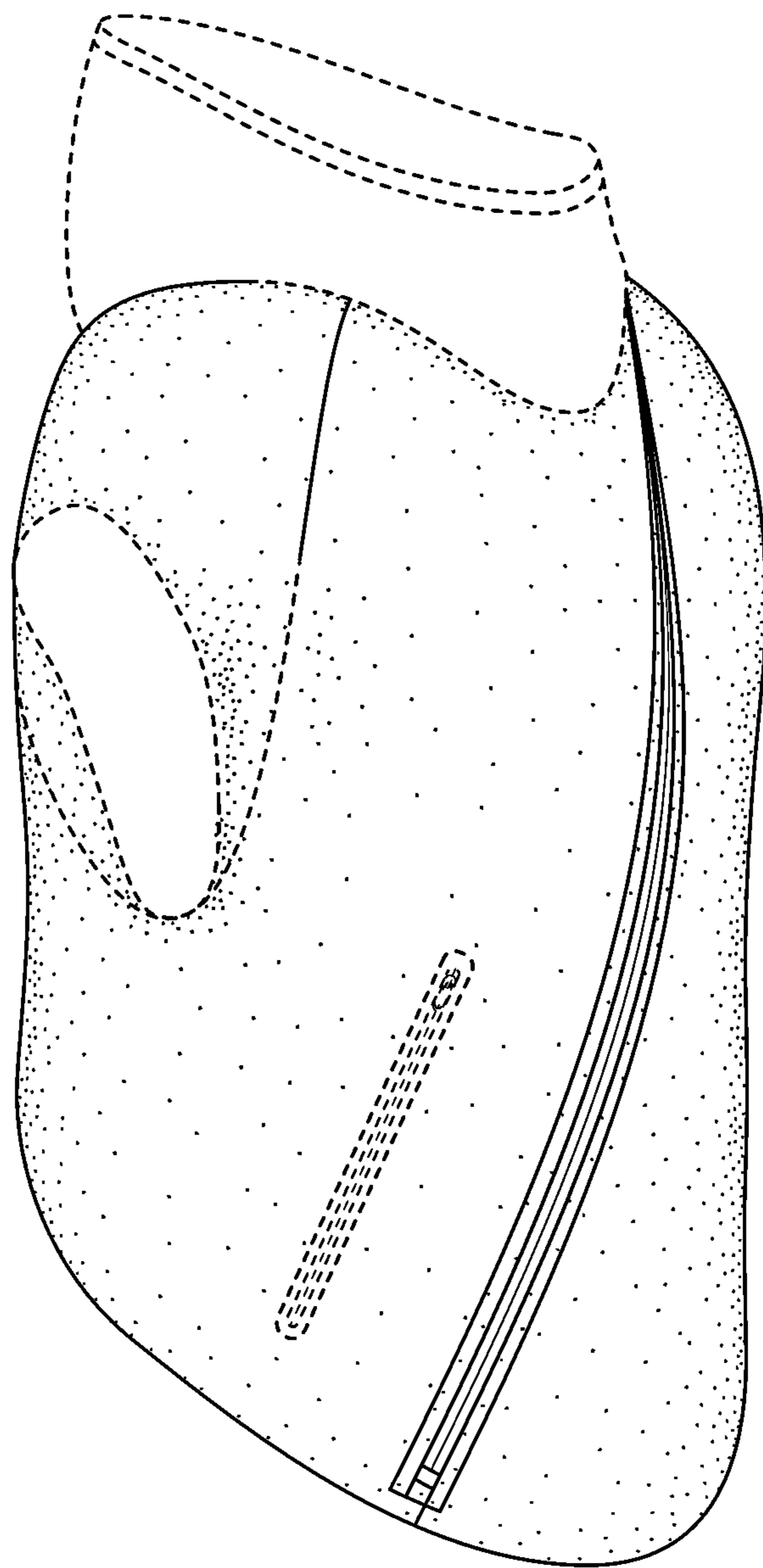

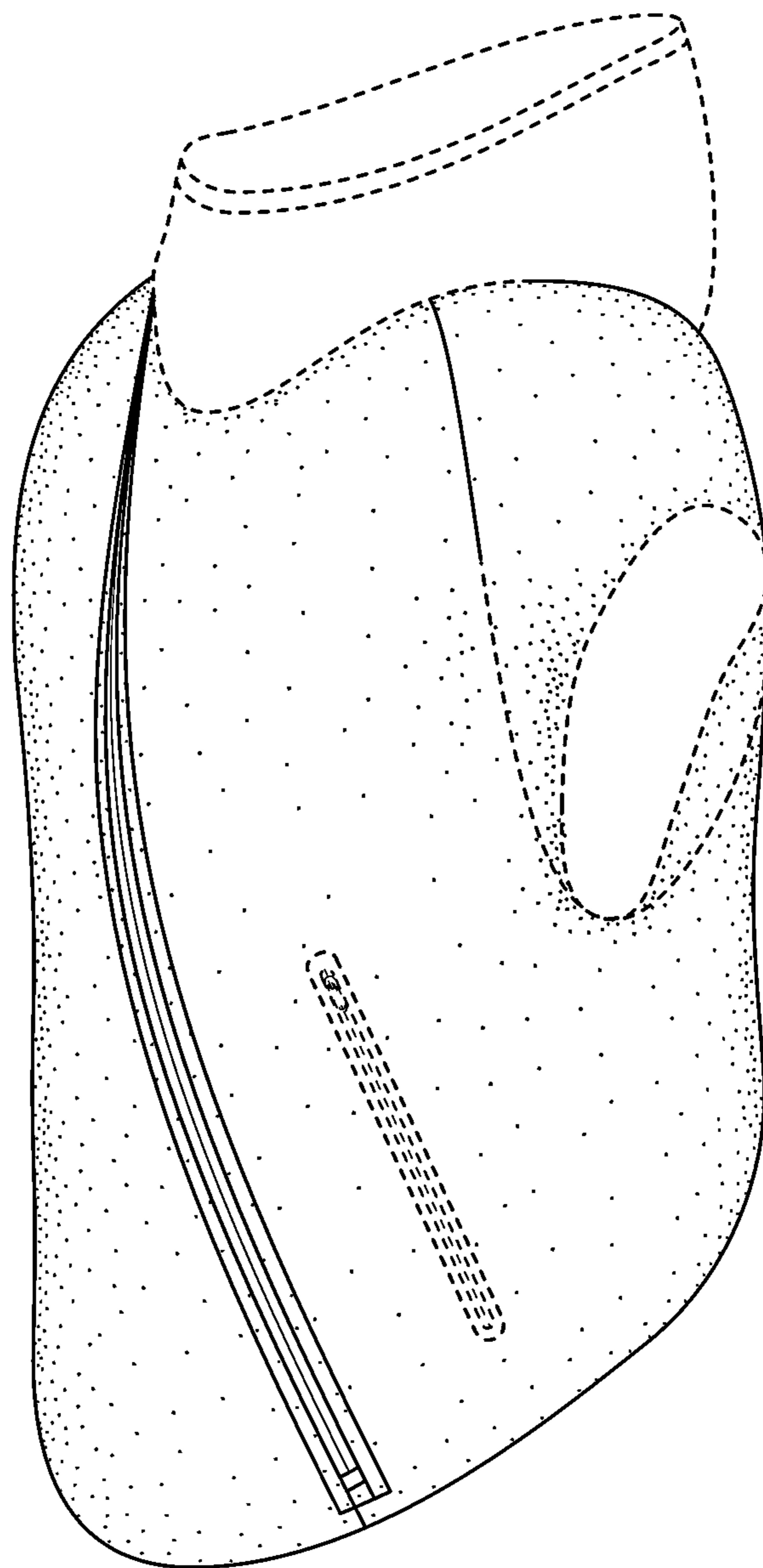

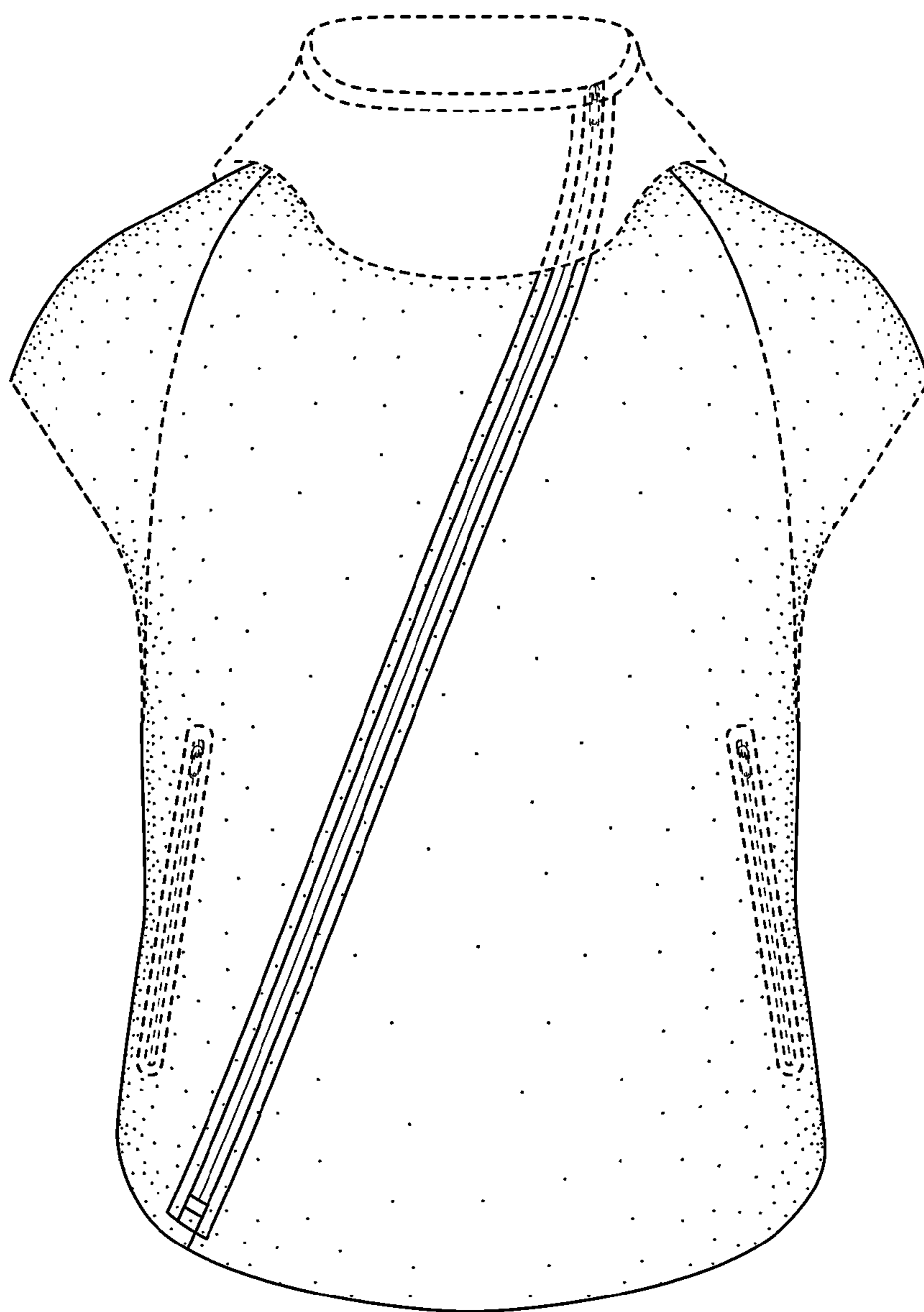

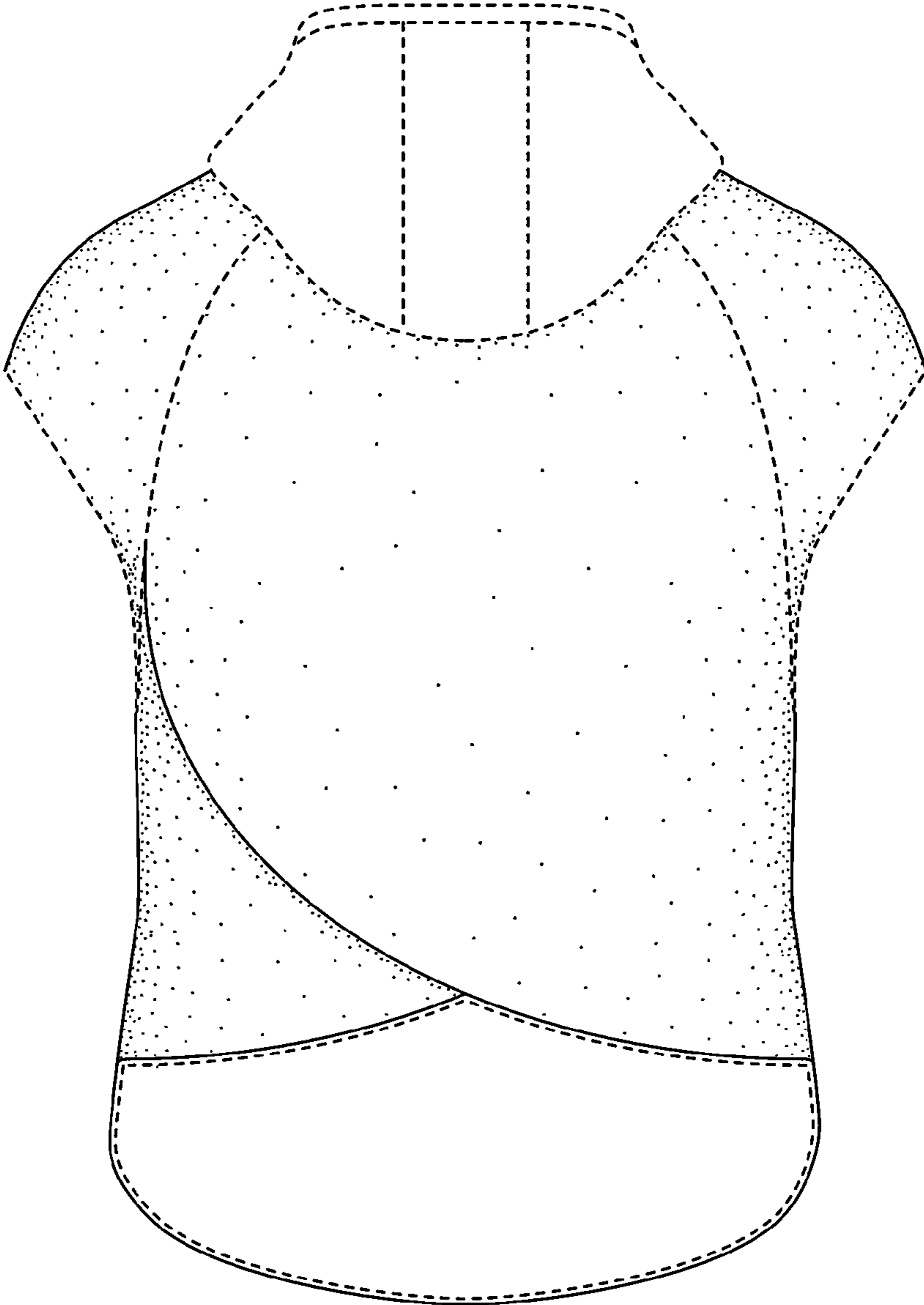

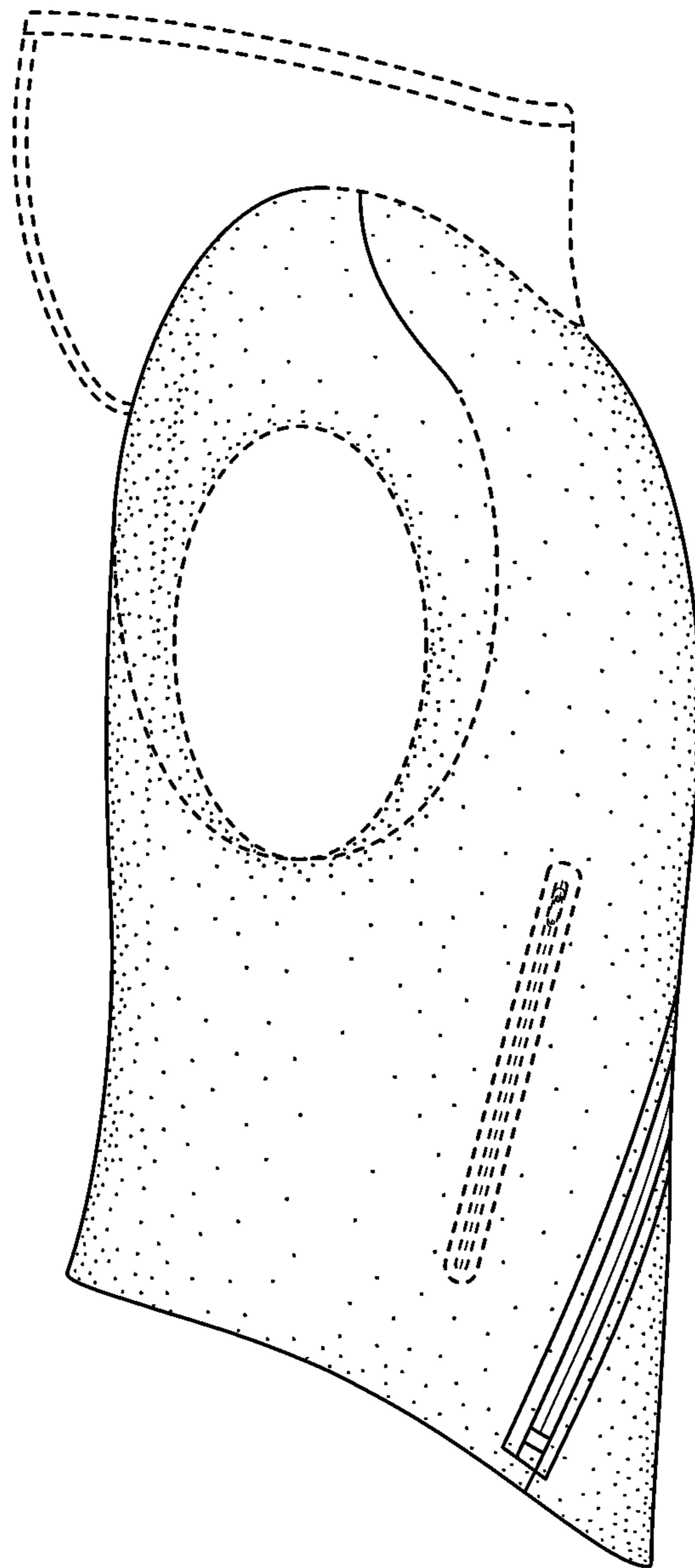

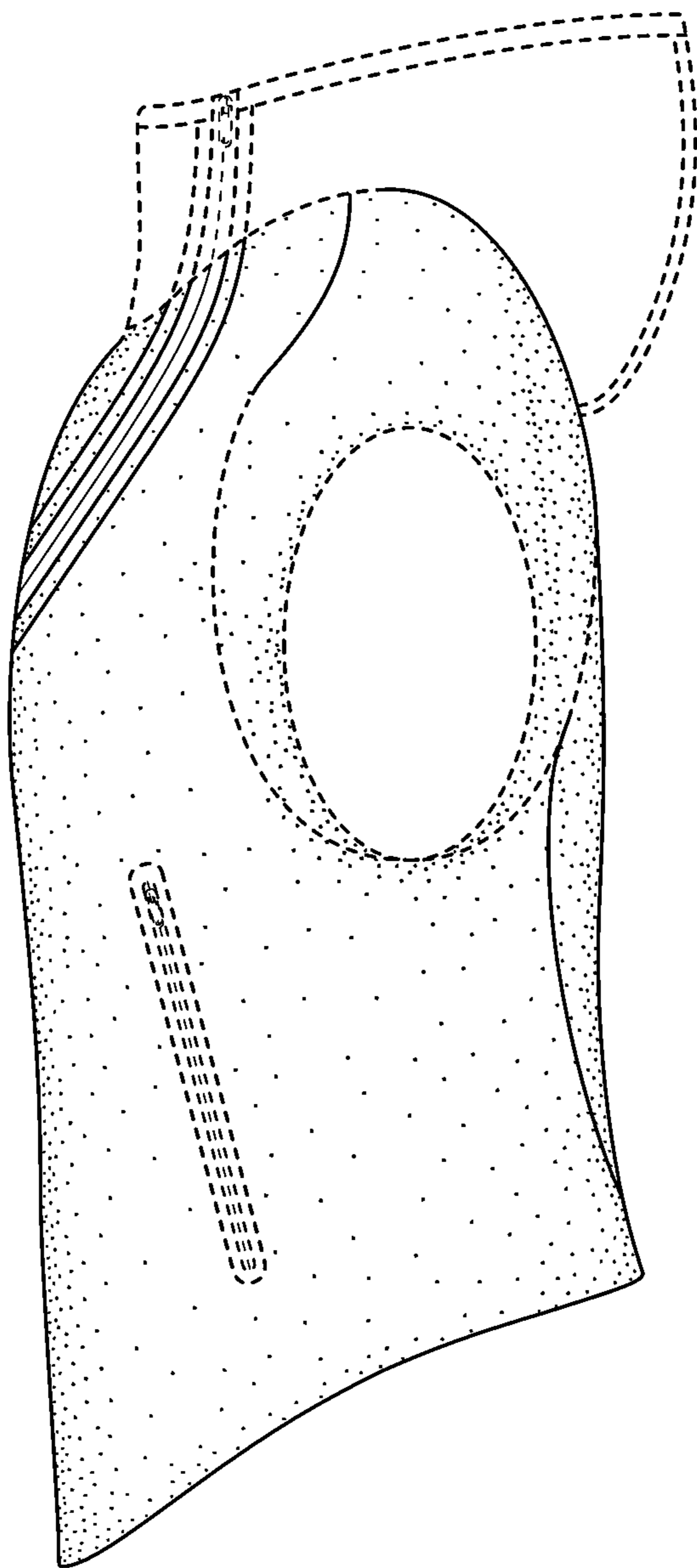

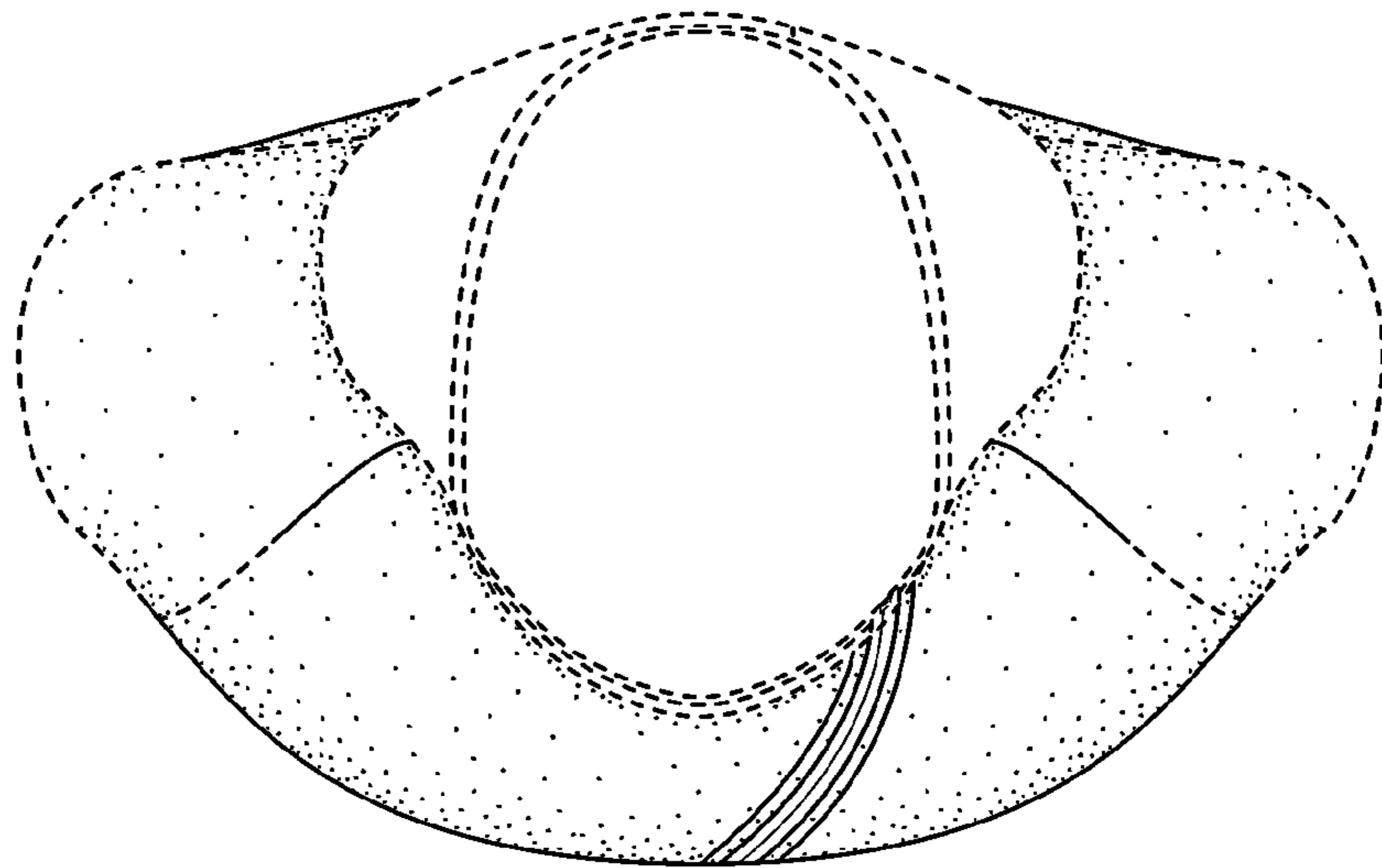
