The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing the new design.

FIG. 2 is a plan view of the shoe outsole of FIG. 1.

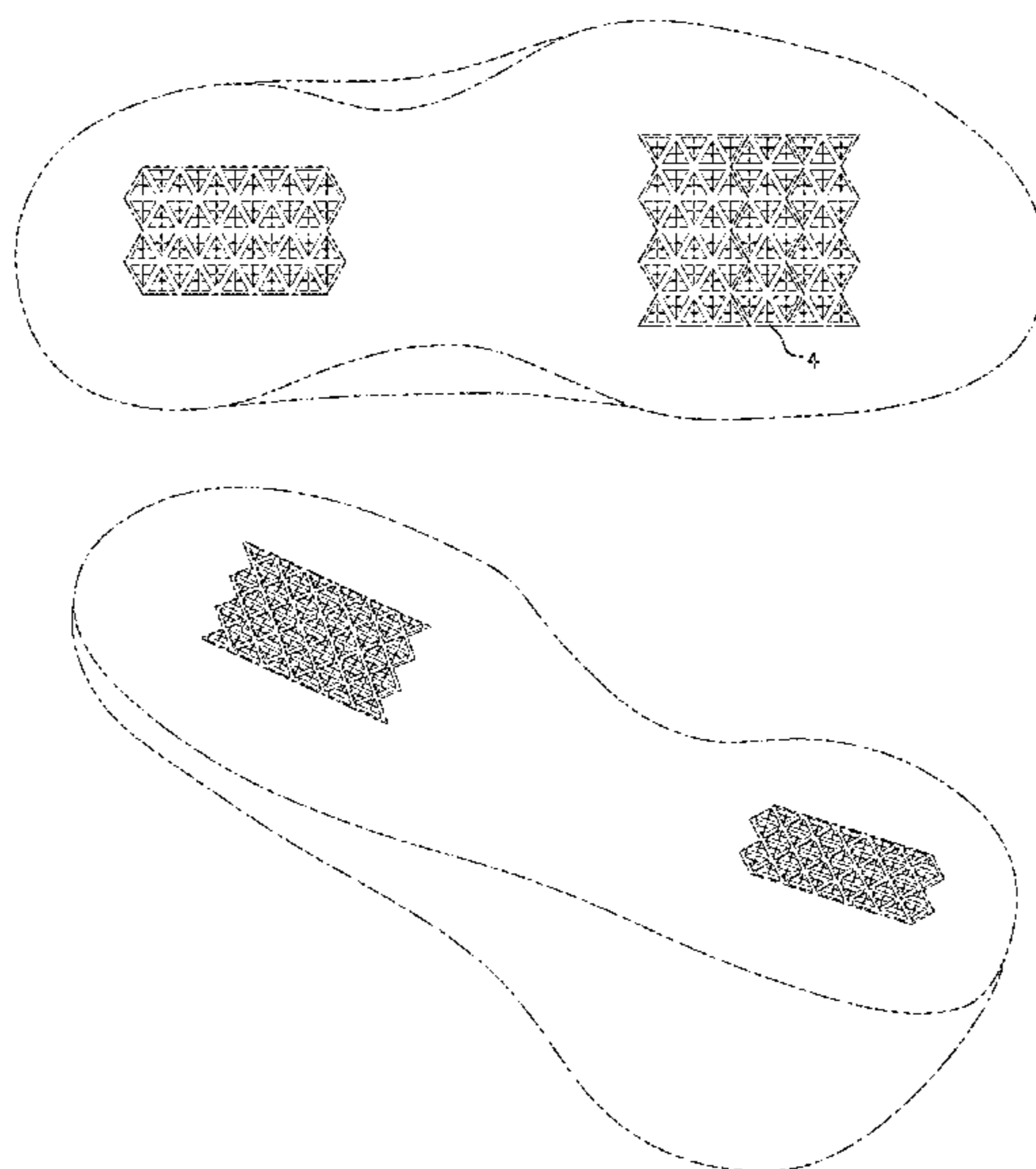
FIG. 3 is a rear perspective view of the shoe outsole of FIG. 1.

FIG. 4 is an enlarged, partial view of encircled area 4 in FIG. 2; and,

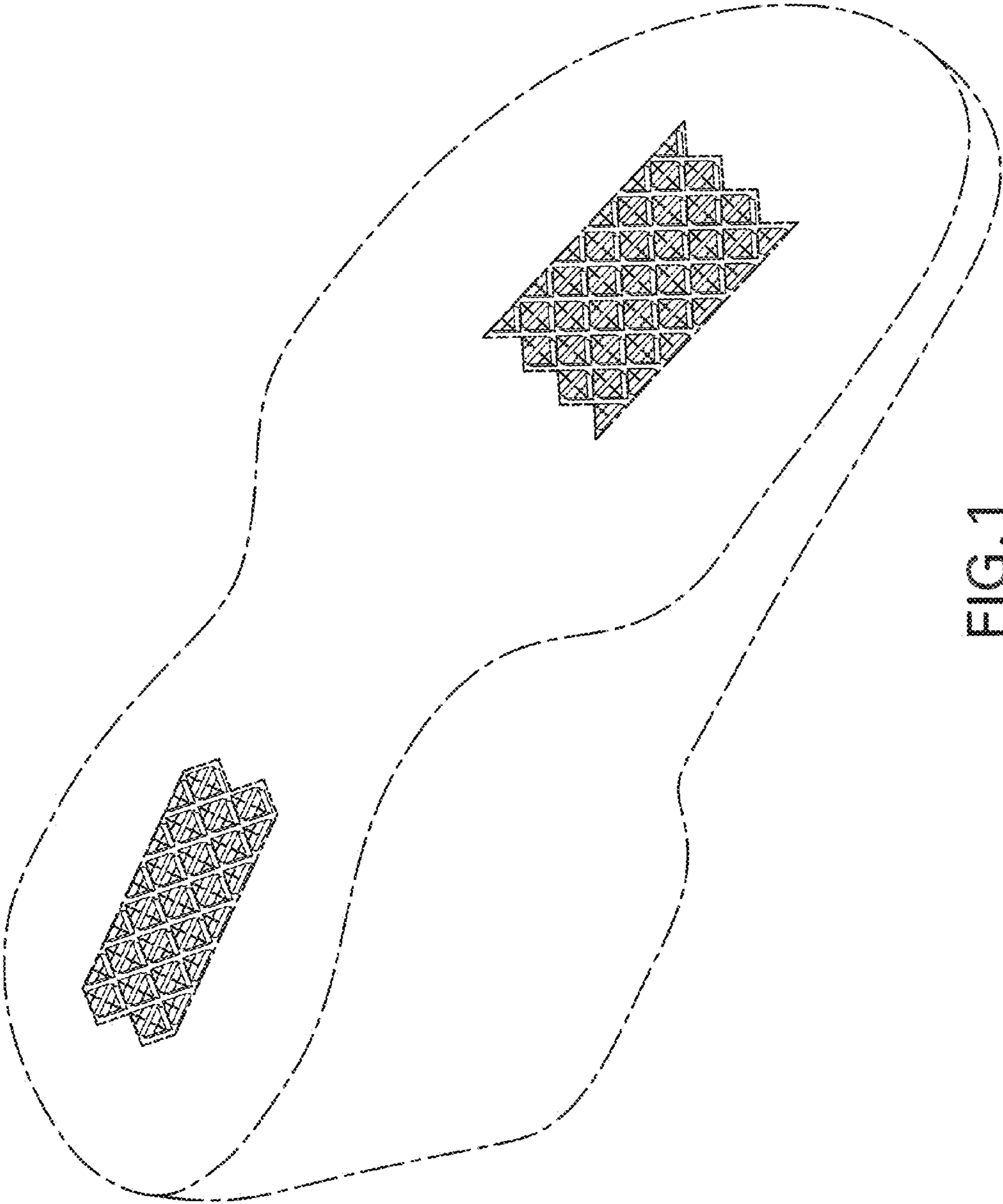

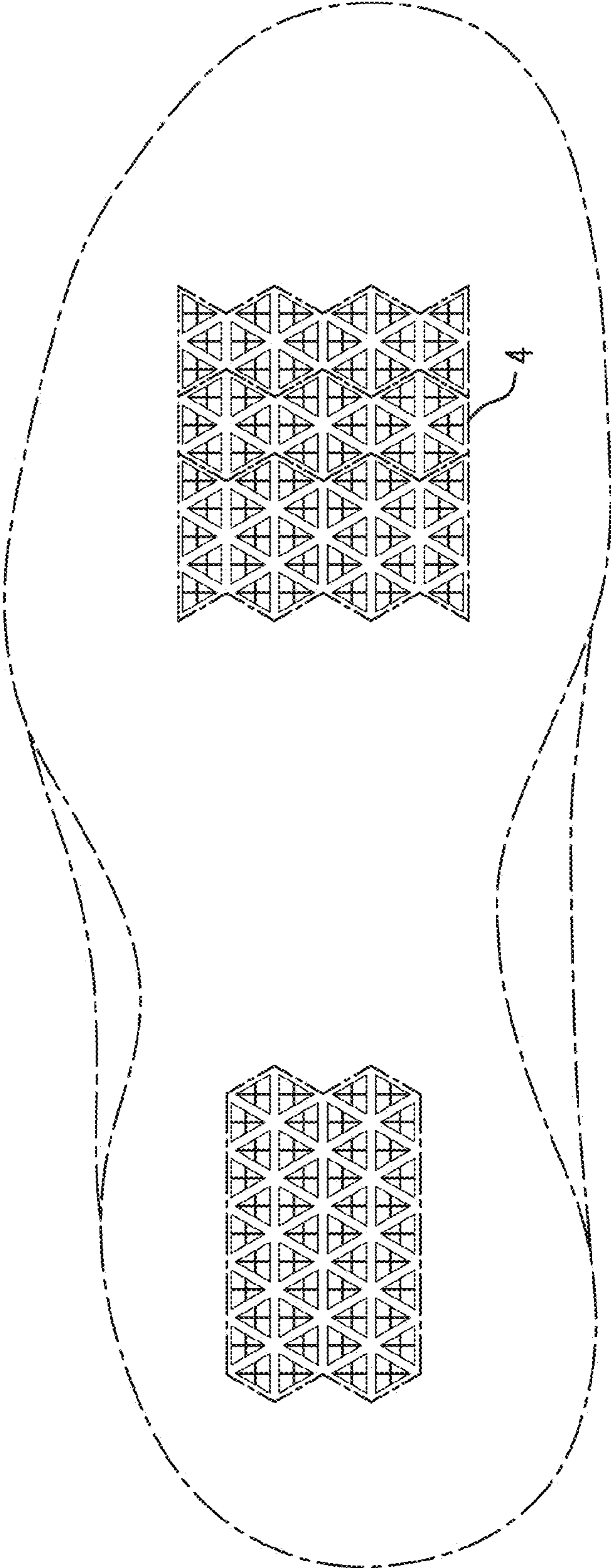

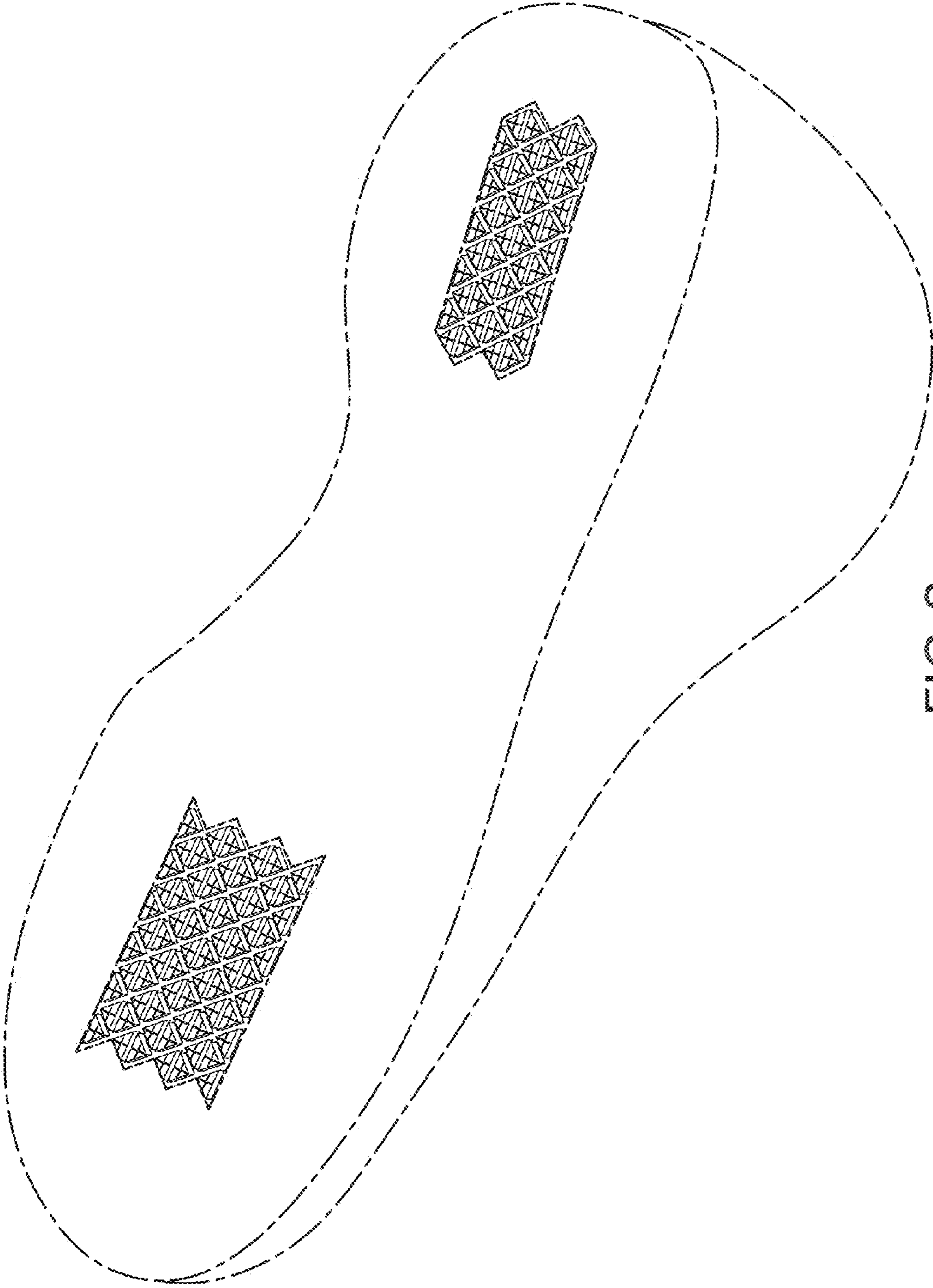

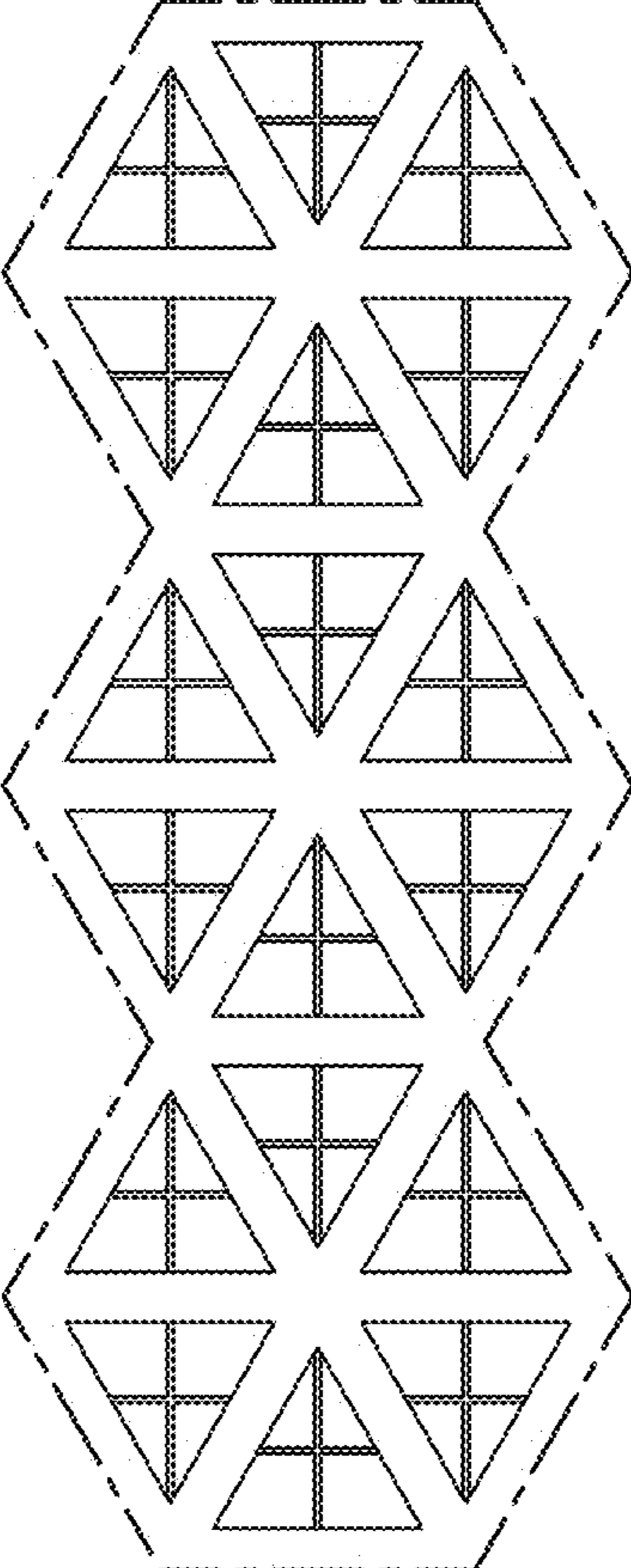

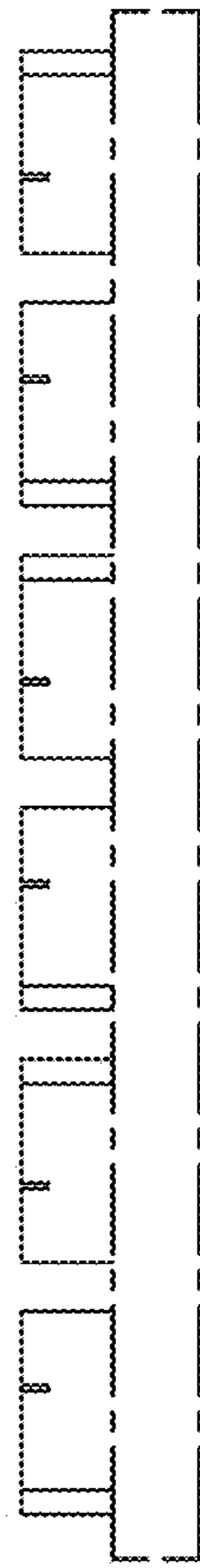
