The ornamental design for golf boots, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a right golf boot of a pair of golf boots showing my new design;

 FIG. 3 is a right-side elevational view of the right golf boot shown in FIG. 1;  
 FIG. 4 is a top plan view of the right golf boot shown in FIG. 1;  
 FIG. 5 is a bottom plan view of the right golf boot shown in FIG. 1;  
 FIG. 6 is a front elevational view of the right golf boot shown in FIG. 1;  
 FIG. 7 is a rear elevational view of the right golf boot shown in FIG. 1;

FIG. 8 is a perspective view of a left golf boot of a pair of golf boots showing my new design;  
 FIG. 9 is a right-side elevational view of the left golf boot shown in FIG. 8;  
 FIG. 10 is a left-side elevational view of the left golf boot shown in FIG. 8;  
 FIG. 11 is a top plan view of the left golf boot shown in FIG. 8;

 FIG. 20 is a front elevational view of the right golf boot shown in FIG. 15;  
 FIG. 21 is a rear elevational view of the right golf boot shown in FIG. 15;  
 FIG. 22 is an alternative perspective view, showing the left golf boot of the pair of golf boots in a different configuration than from that shown in FIG. 8;  
 FIG. 23 is a right-side elevational view of the left golf boot shown in FIG. 22;  
 FIG. 24 is a left-side elevational view of the left golf boot shown in FIG. 22;  
 FIG. 24 is a top plan view of the left golf boot shown in FIG. 22;  
 FIG. 26 is a bottom plan view of the left golf boot shown in FIG. 22;  
 FIG. 27 is a front elevational view of the left golf boot shown in FIG. 22; and,  
 FIG. 28 is a rear elevational view of the left golf boot shown in FIG. 22.

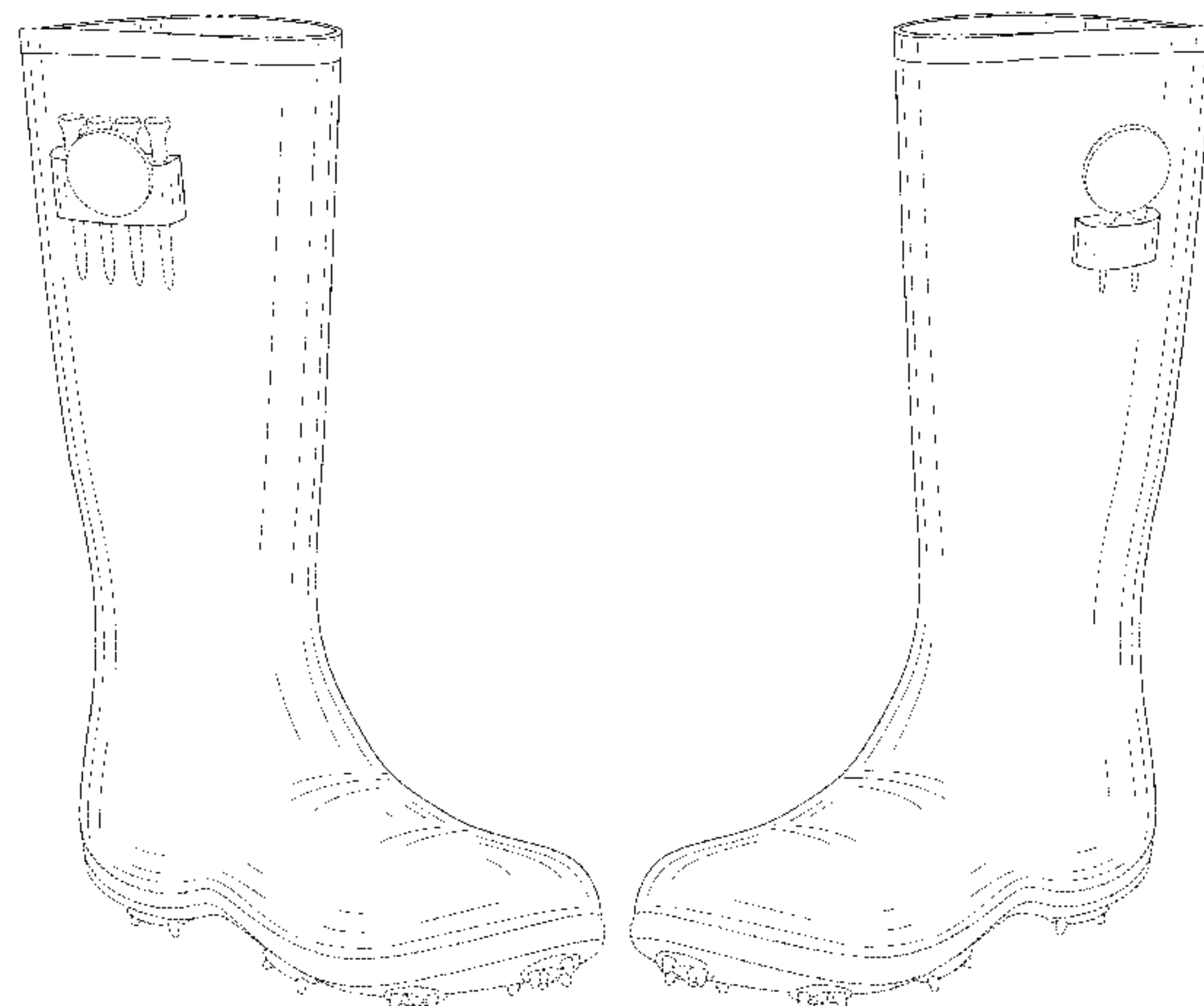

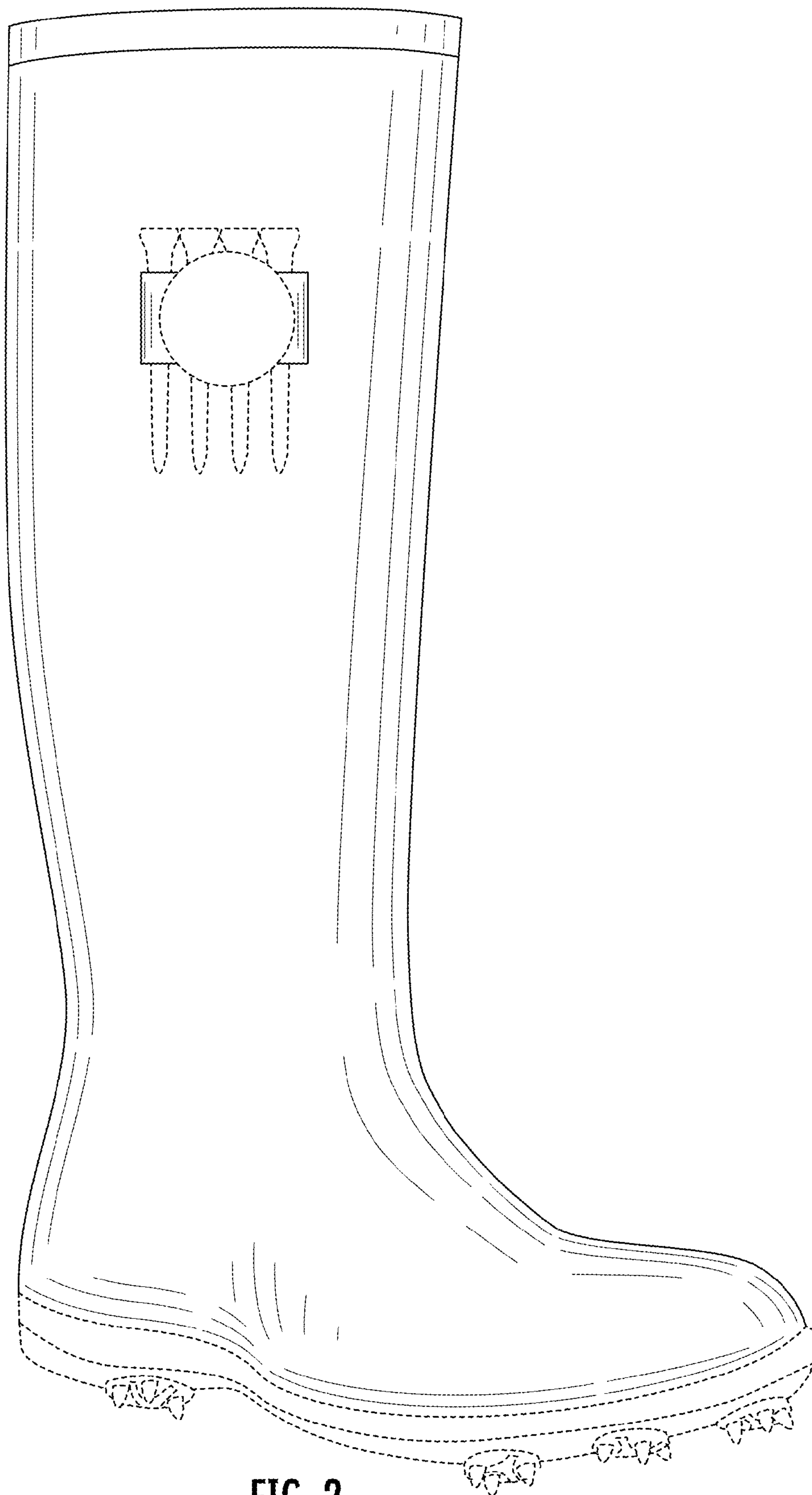

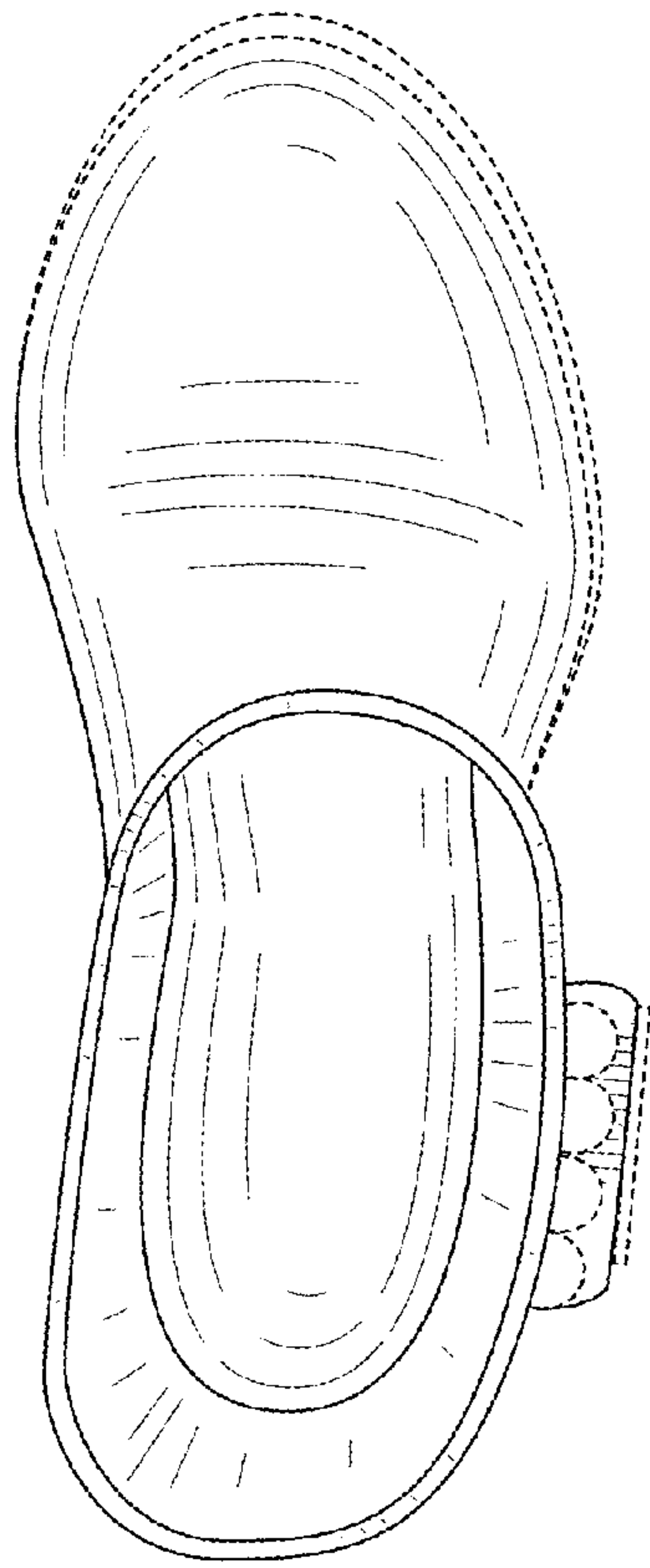

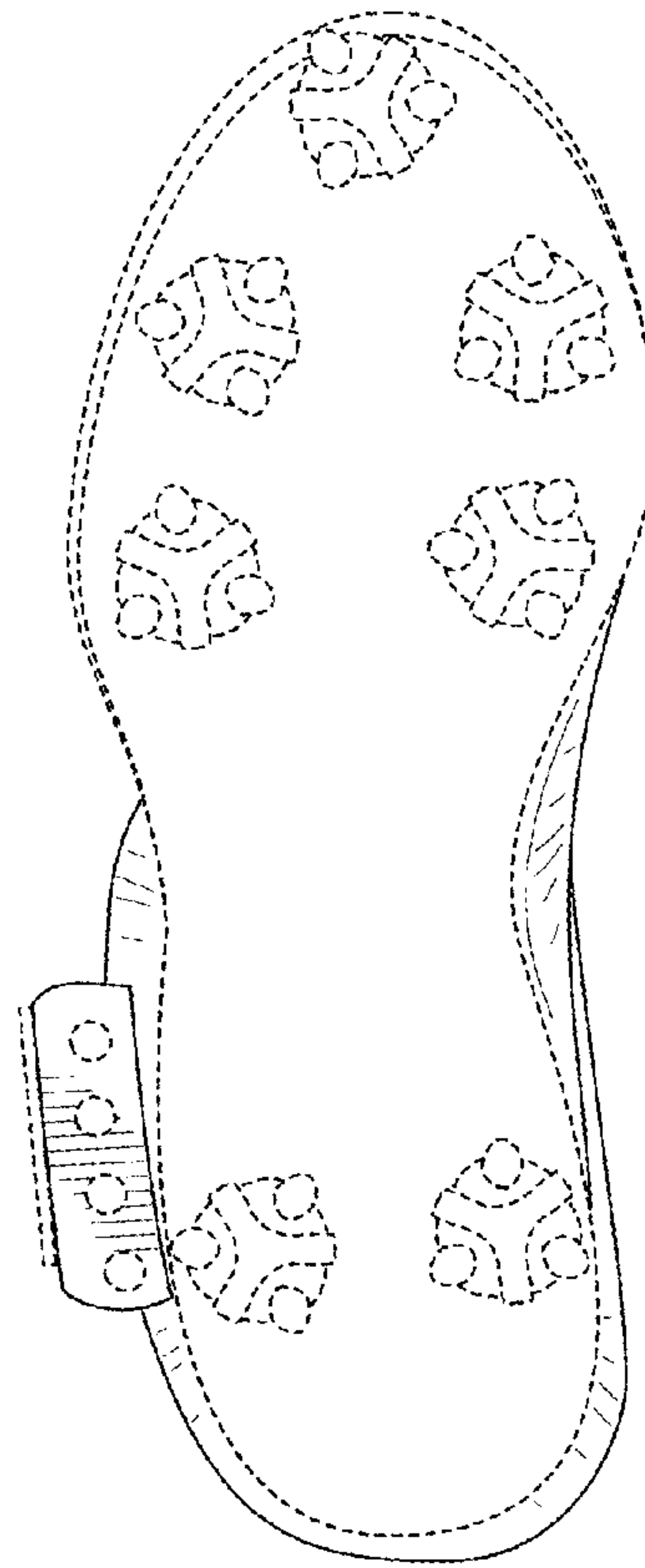

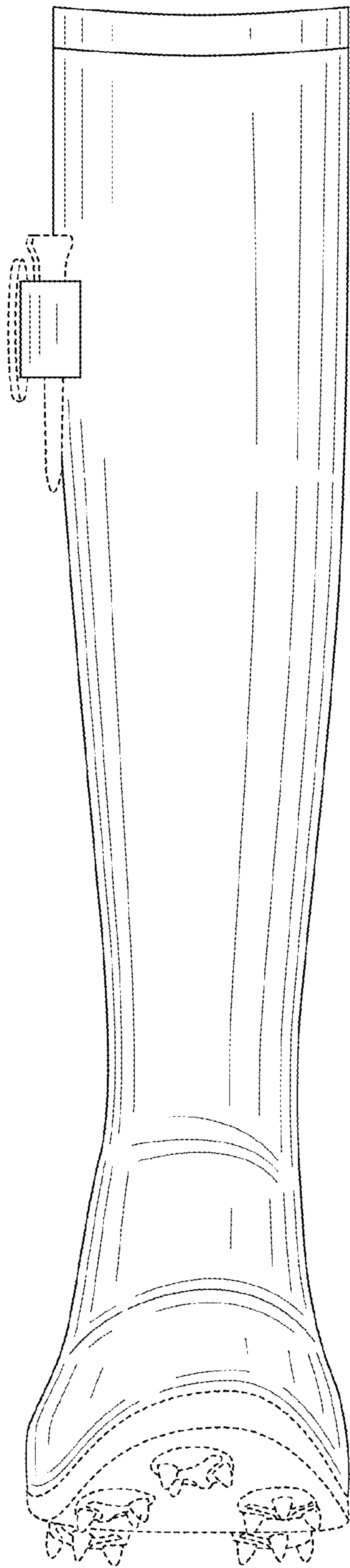

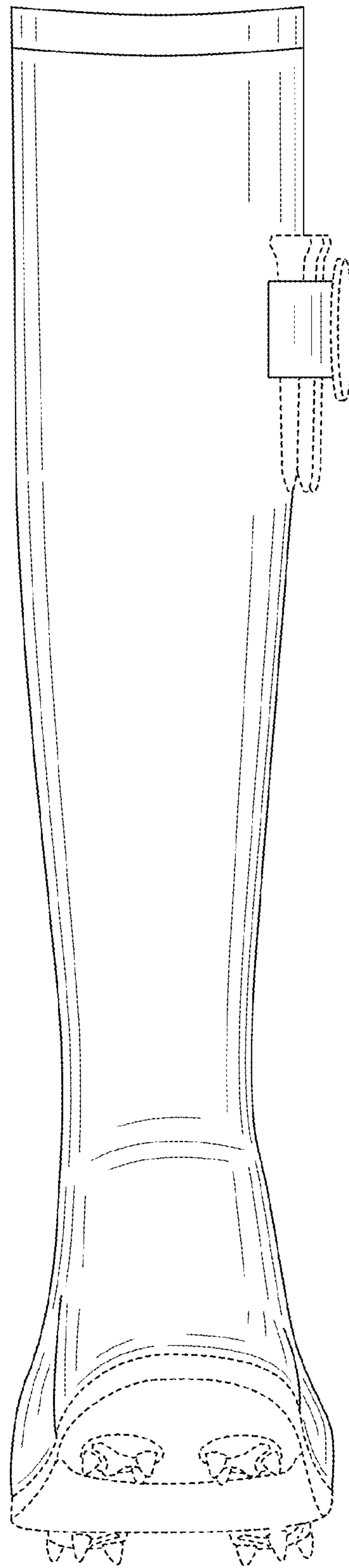

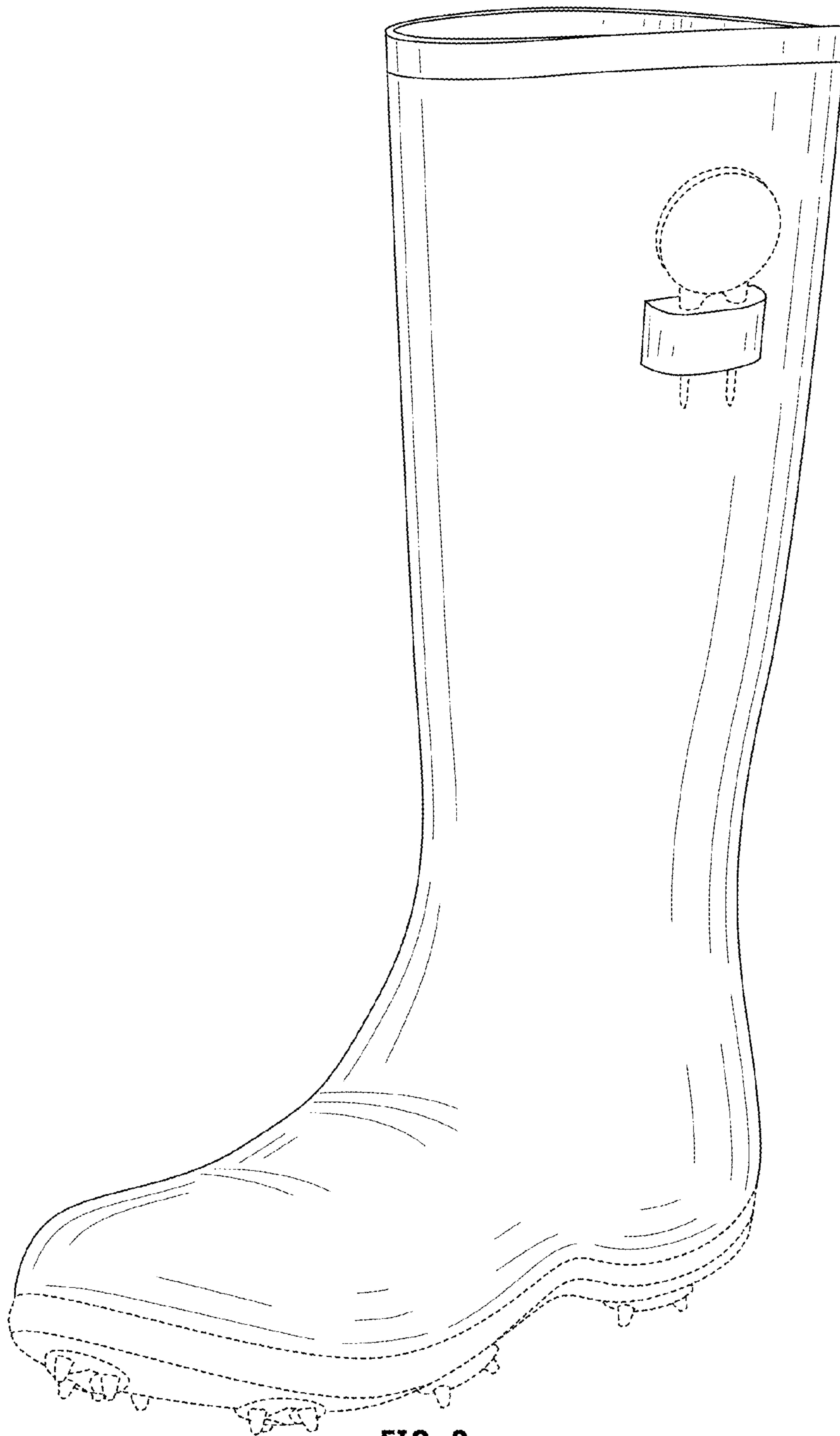

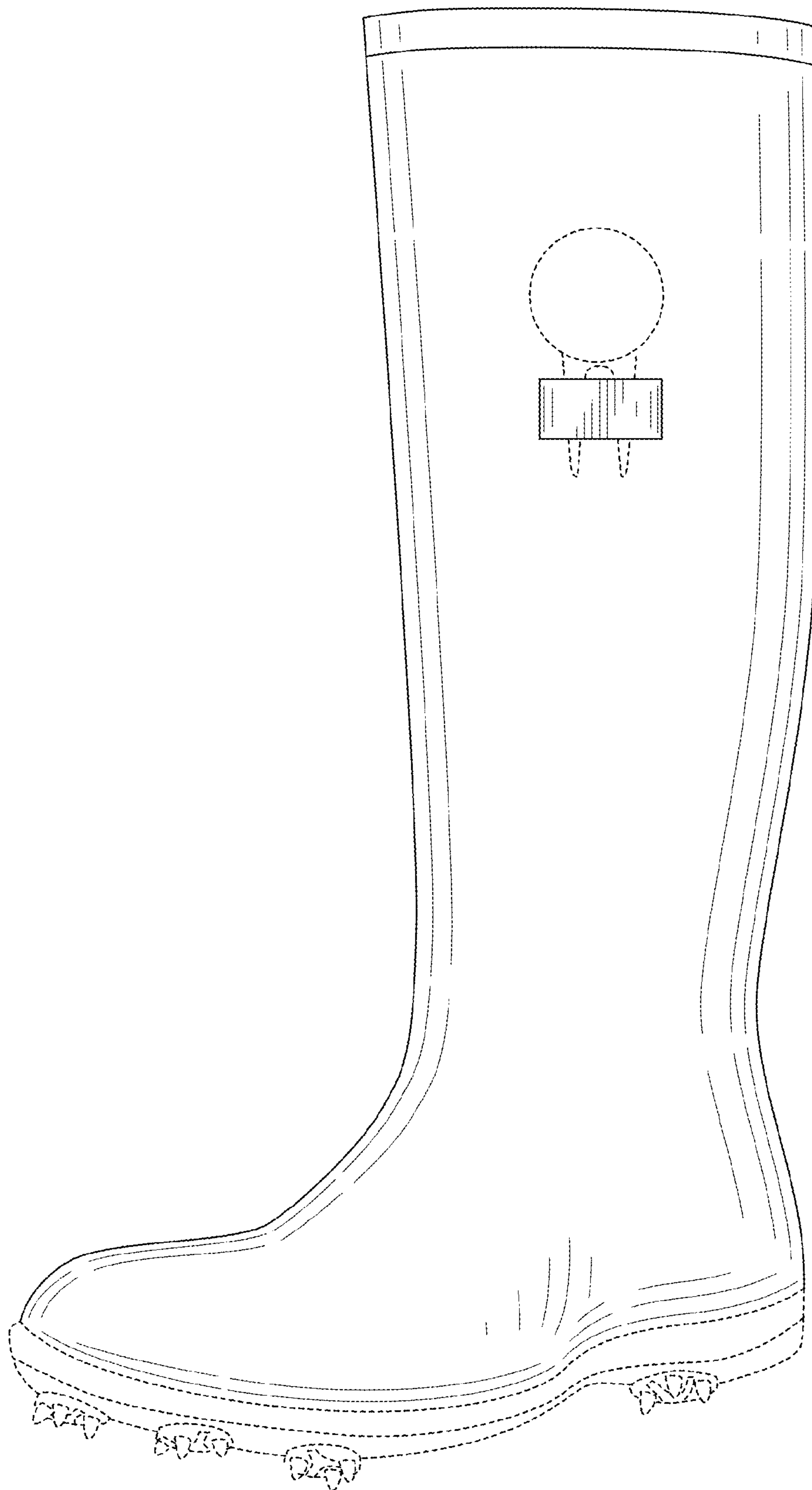

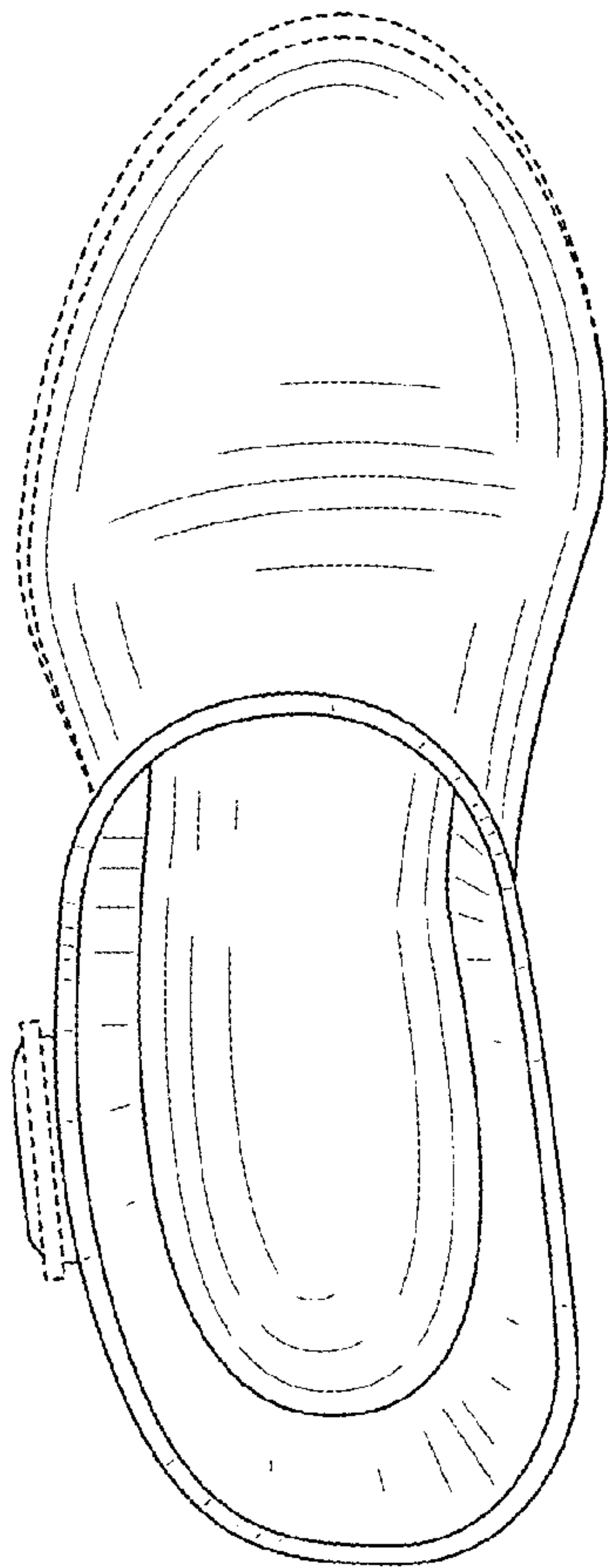

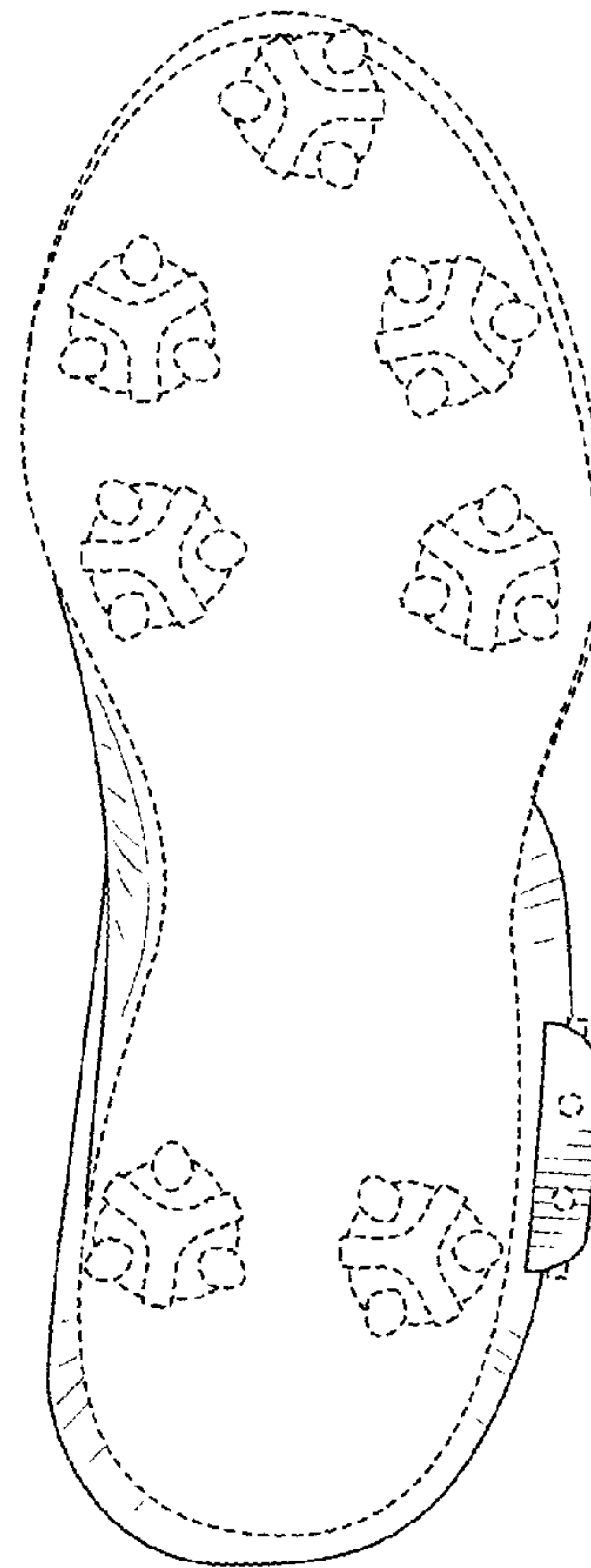

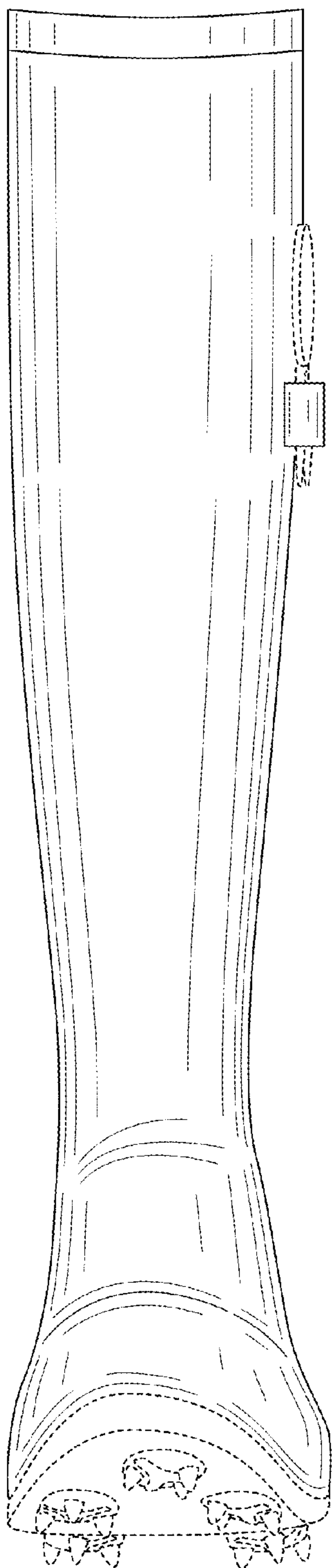

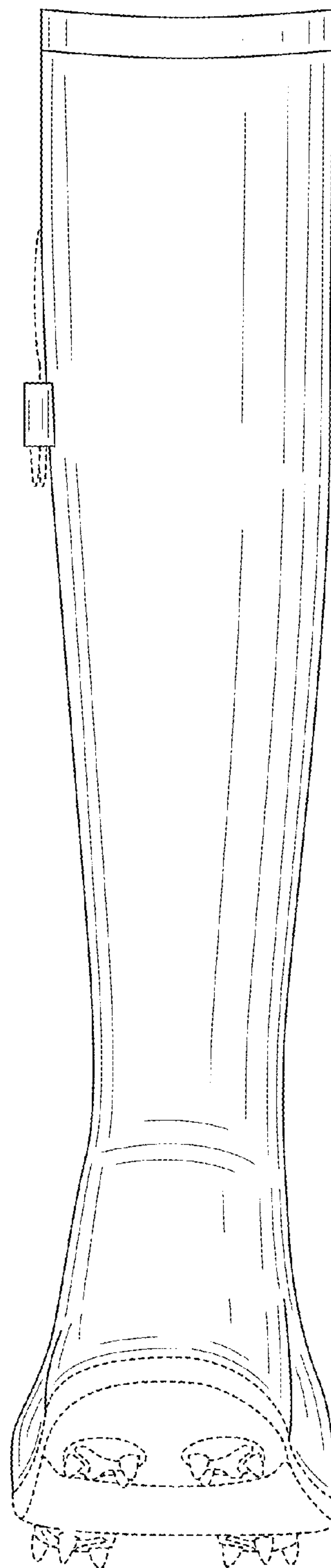

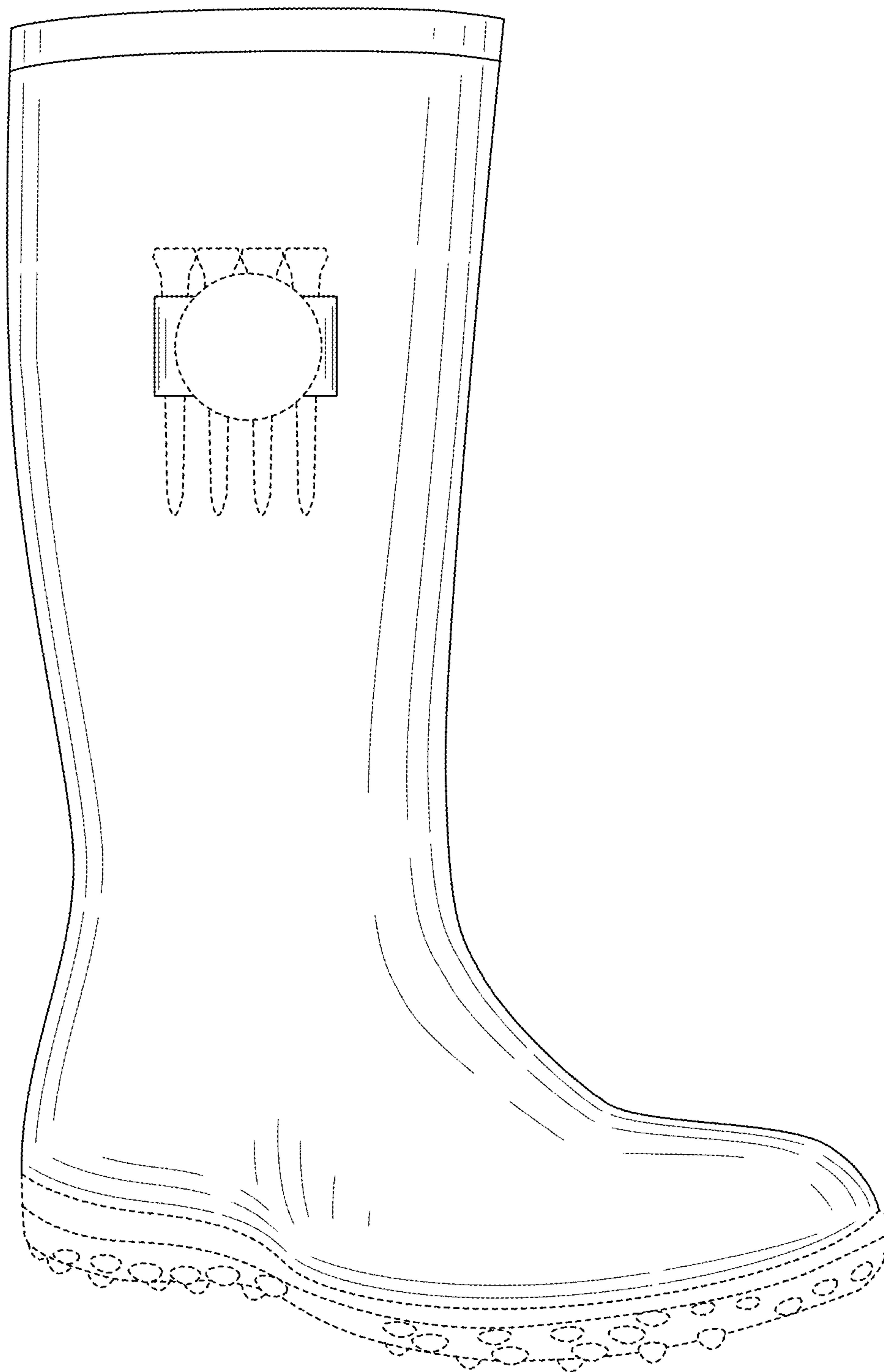

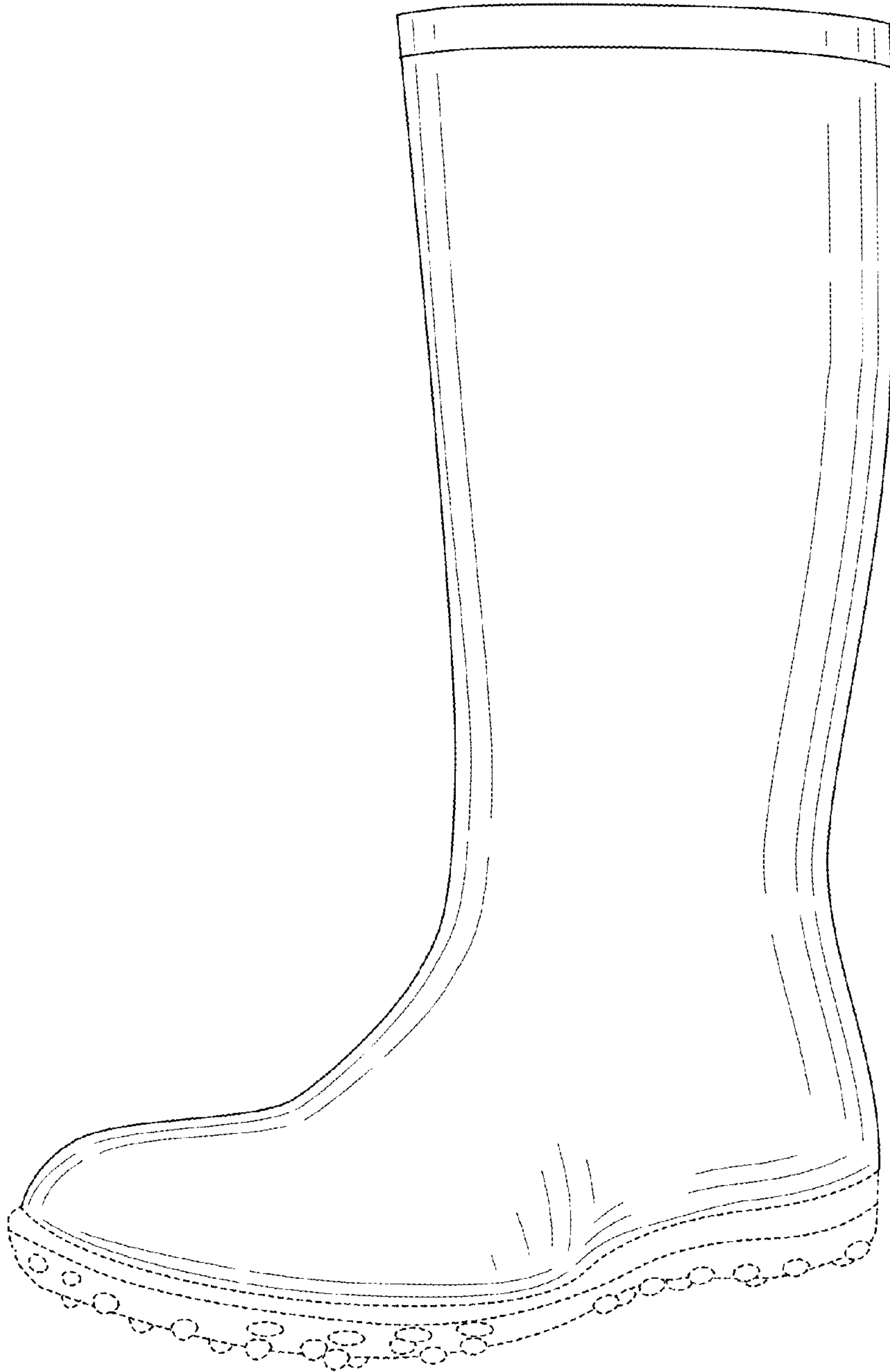

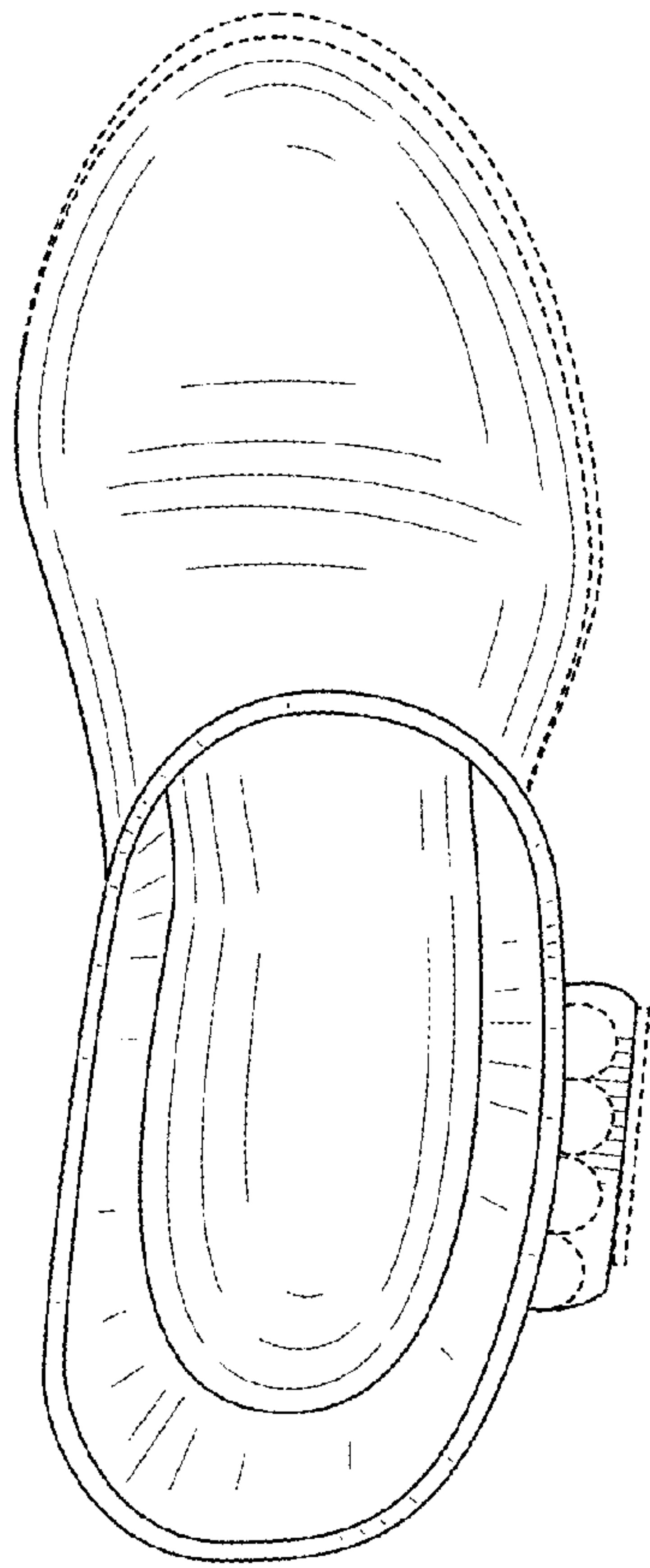

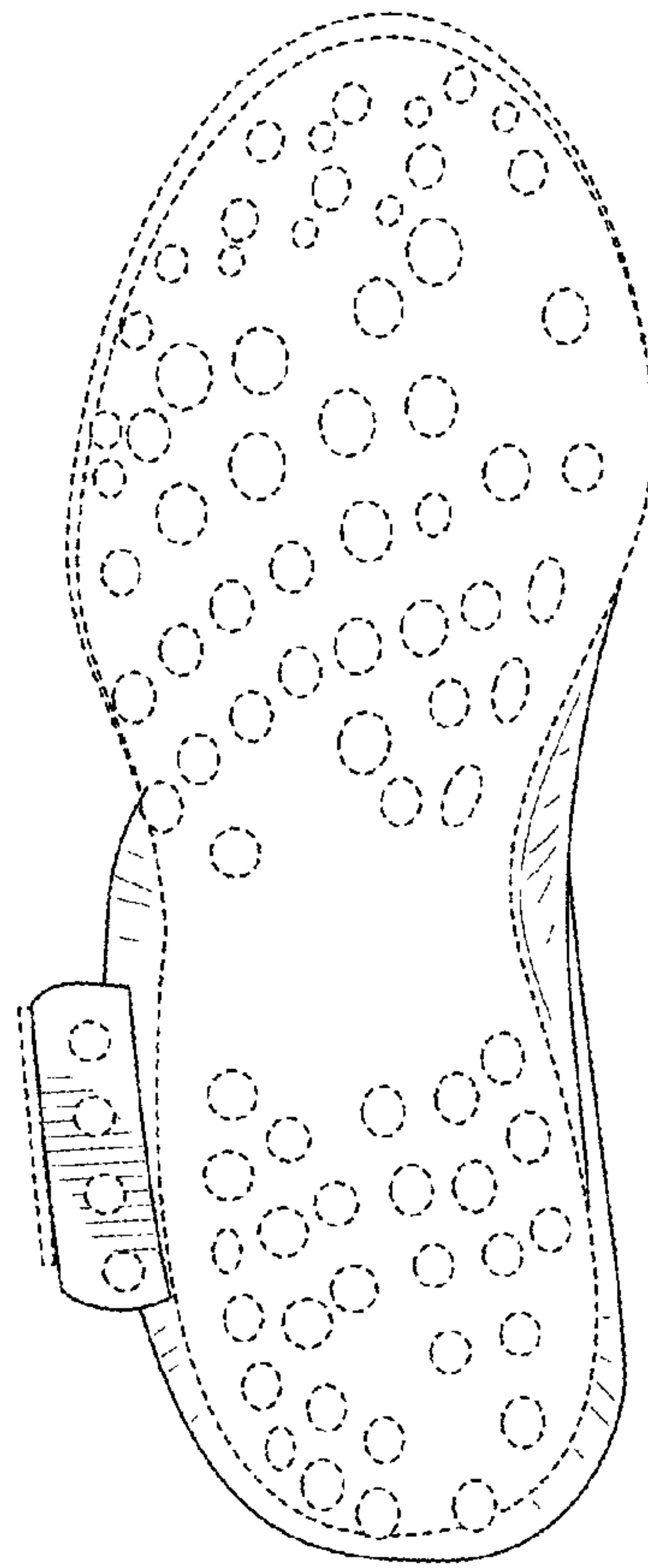

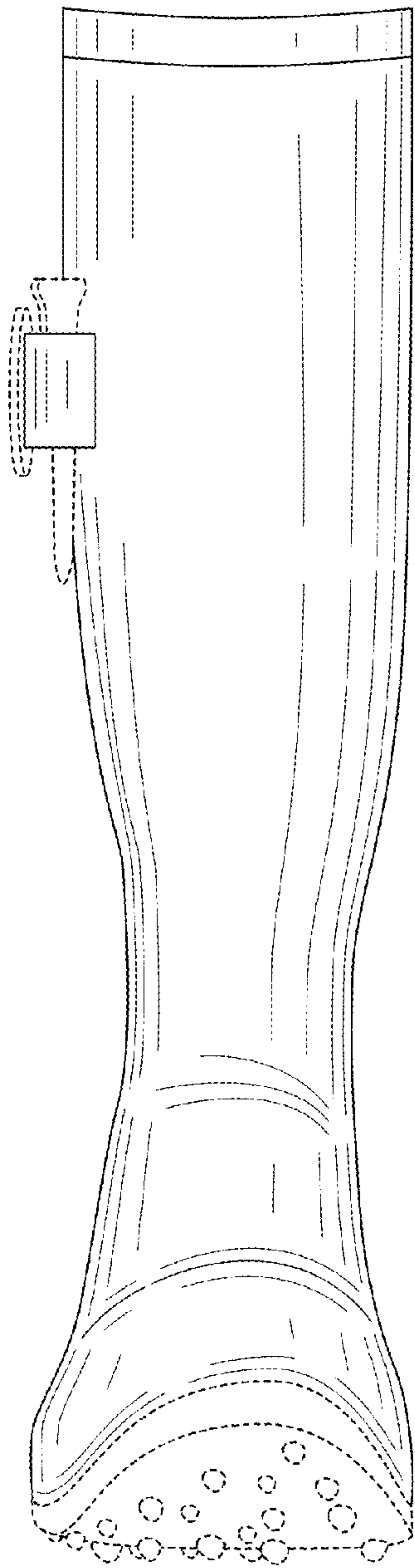

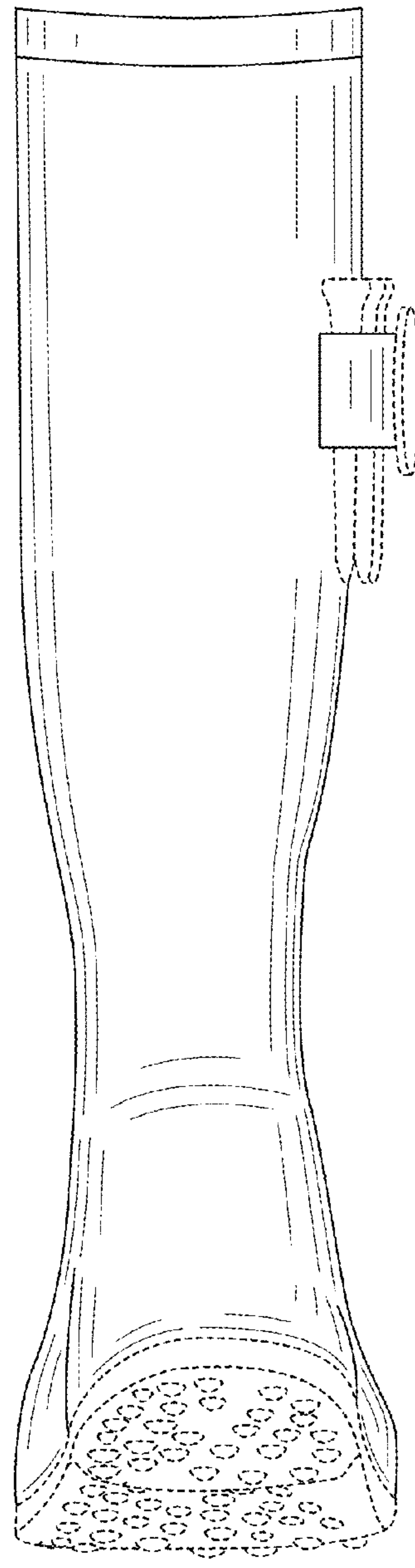

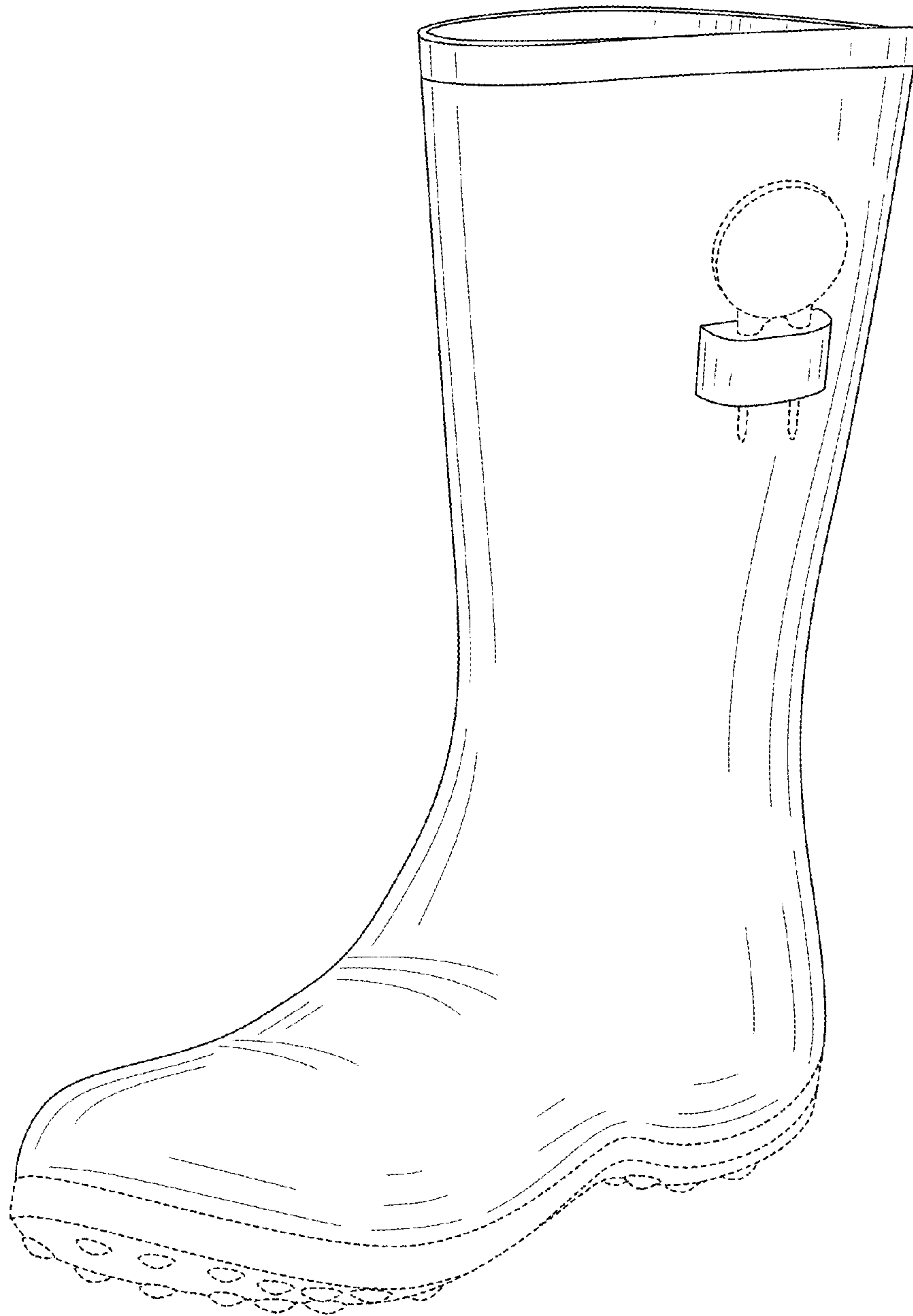

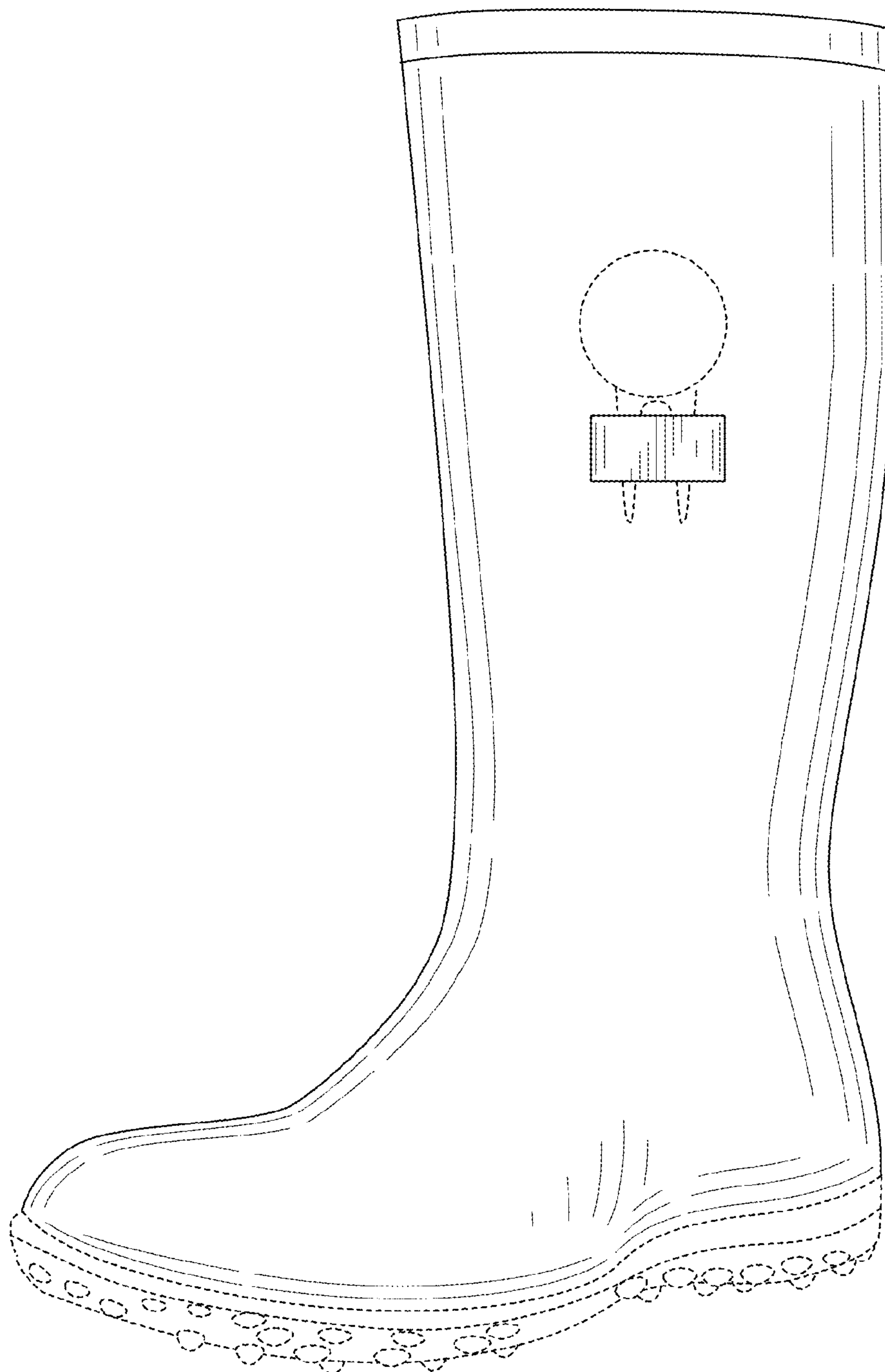

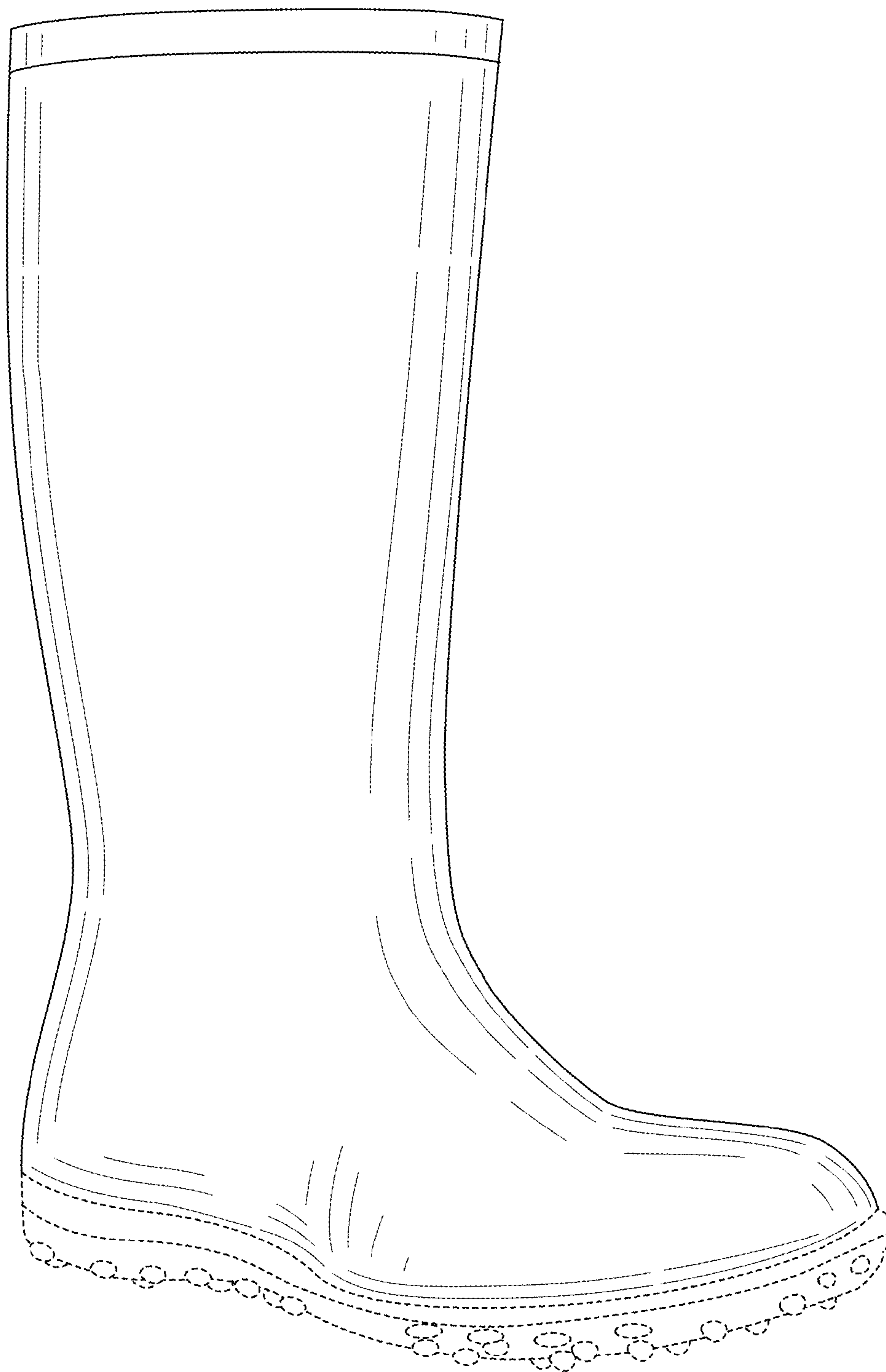

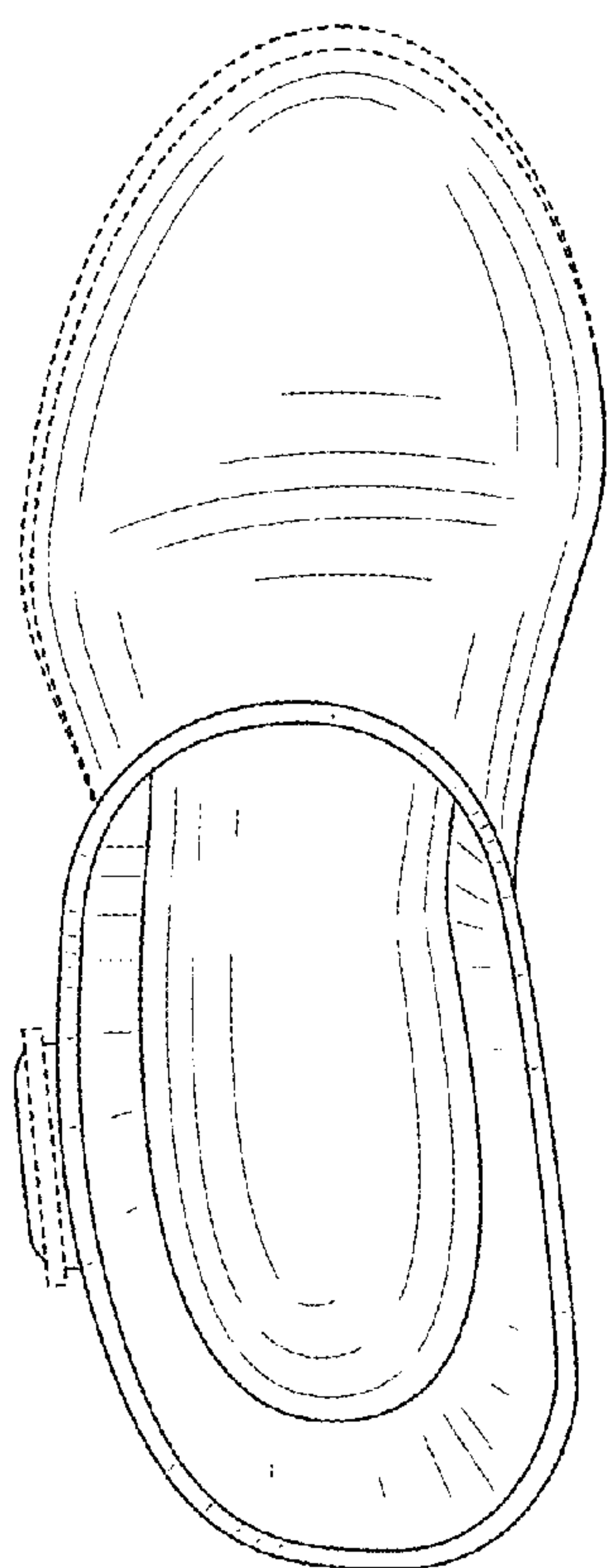

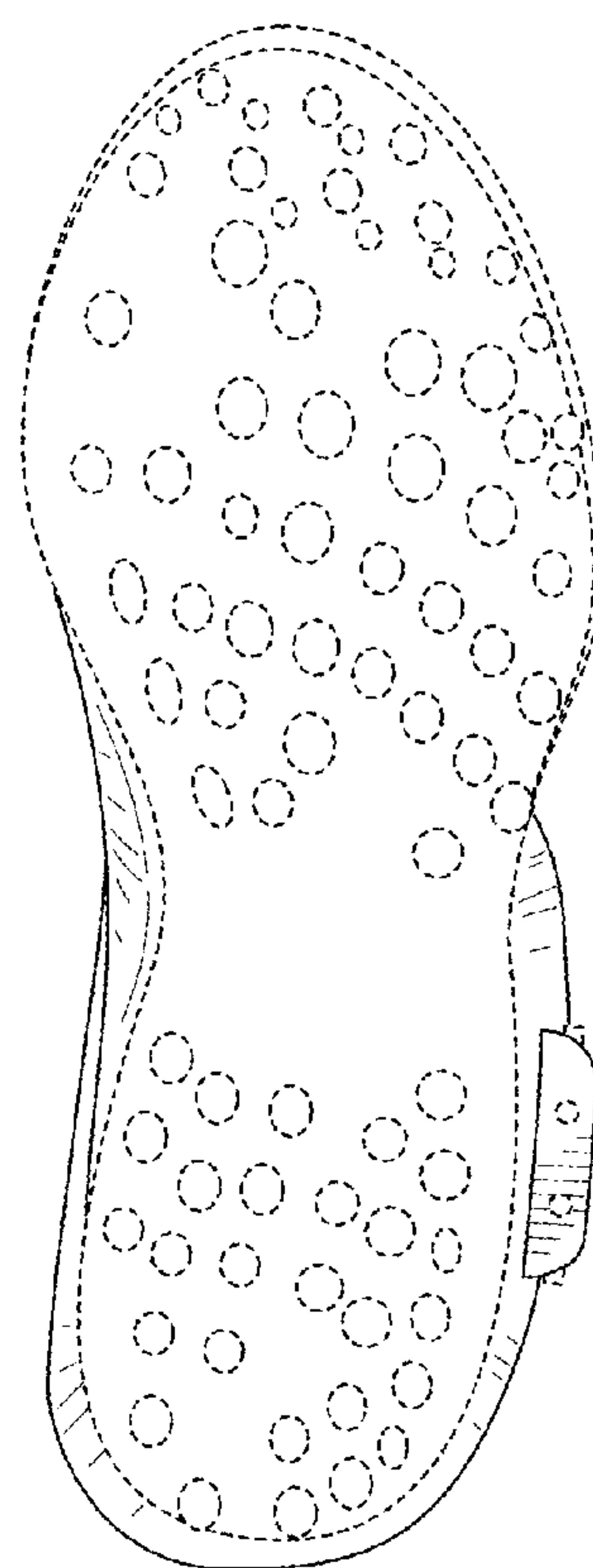

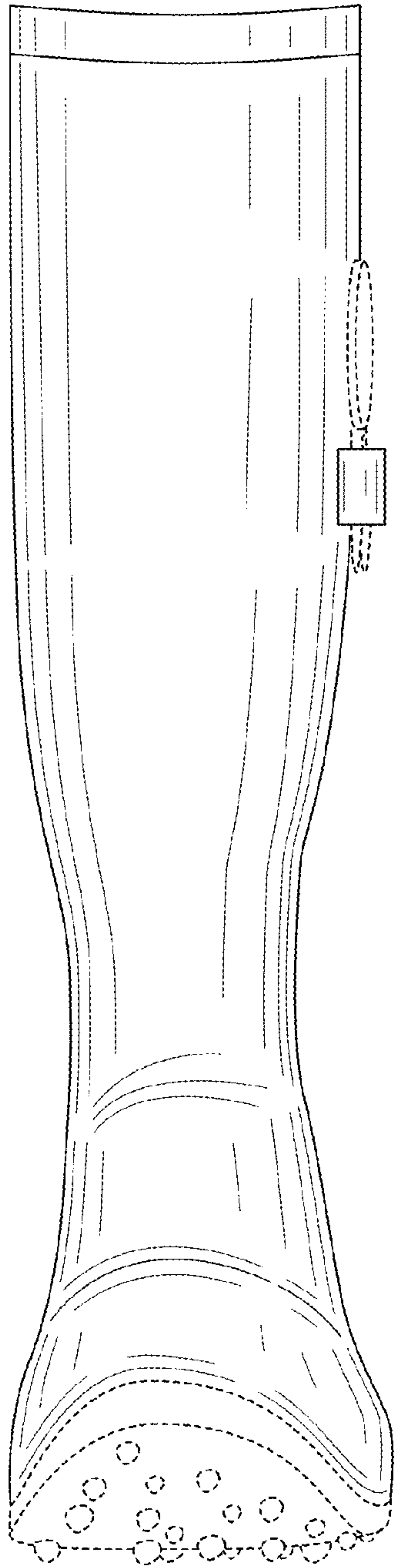

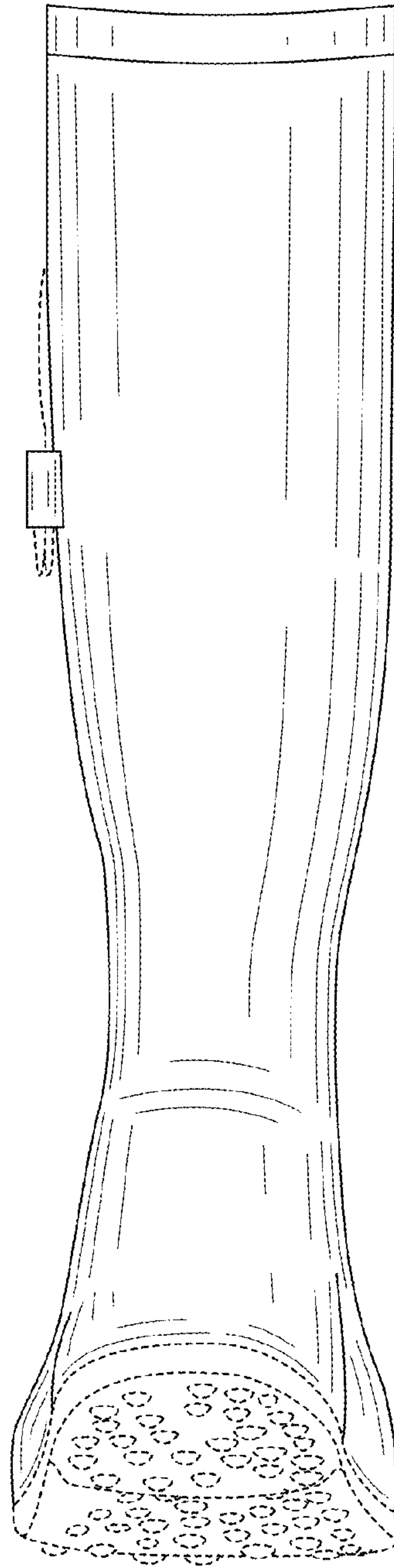
