The ornamental design for a fabric bag housing a medical device, as shown.

**DESCRIPTION**

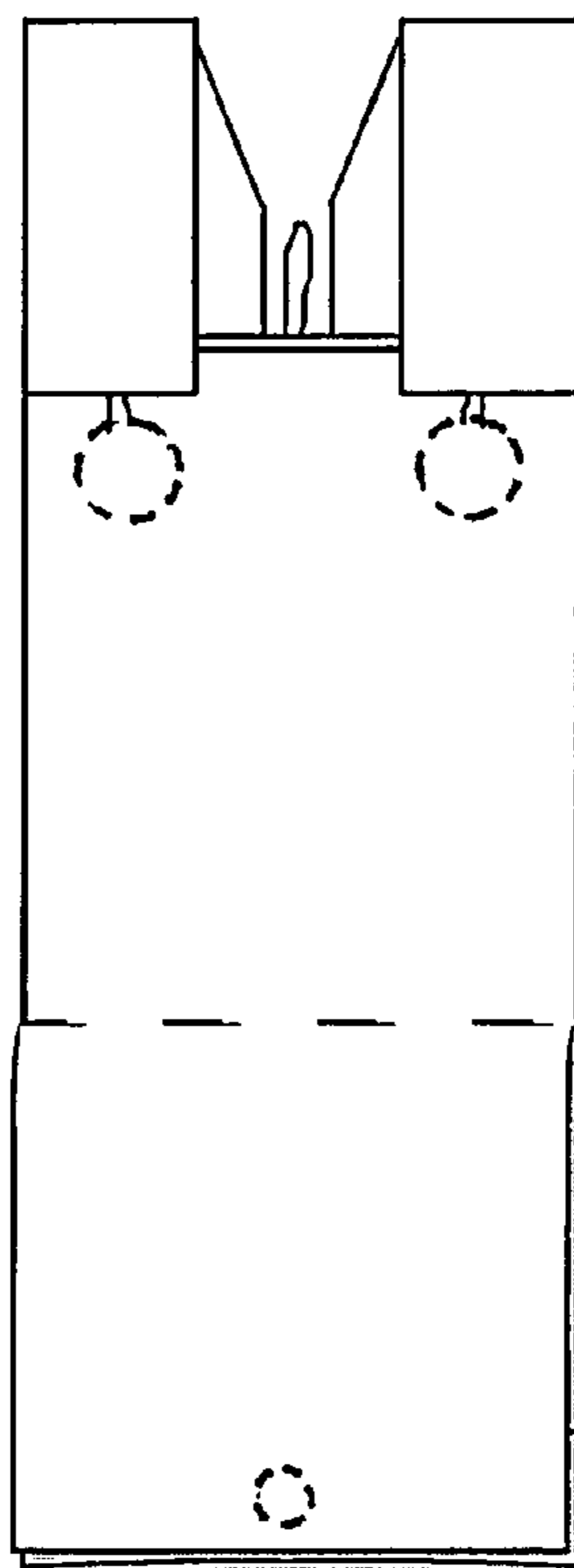
FIG. 1—Front view of the fabric bag housing a medical device with its straps and flaps down.

FIG. 2—Front view with the fabric bag's straps and flaps up, revealing a window made of netting; and,

FIG. 3—Rear view of the fabric bag housing a medical device.

The broken lines depicting buttons in the drawing figures is for illustrative purposes only and forms no part of the design. The design is a thin and flat fabric bag housing a medical device; therefore only the front and rear views are shown.

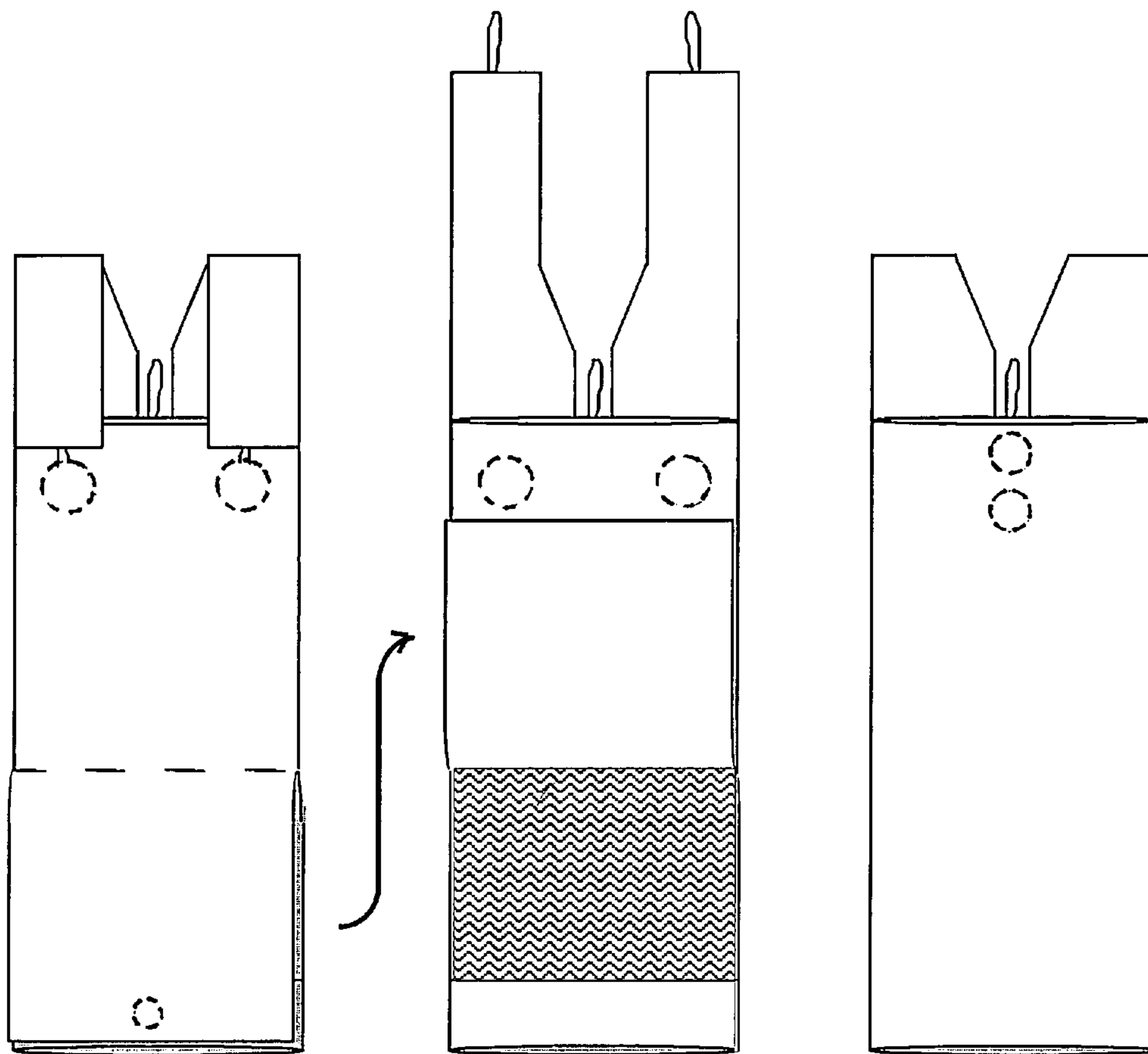
