The broken lines show portions of the key fob which form no part of the claimed design.

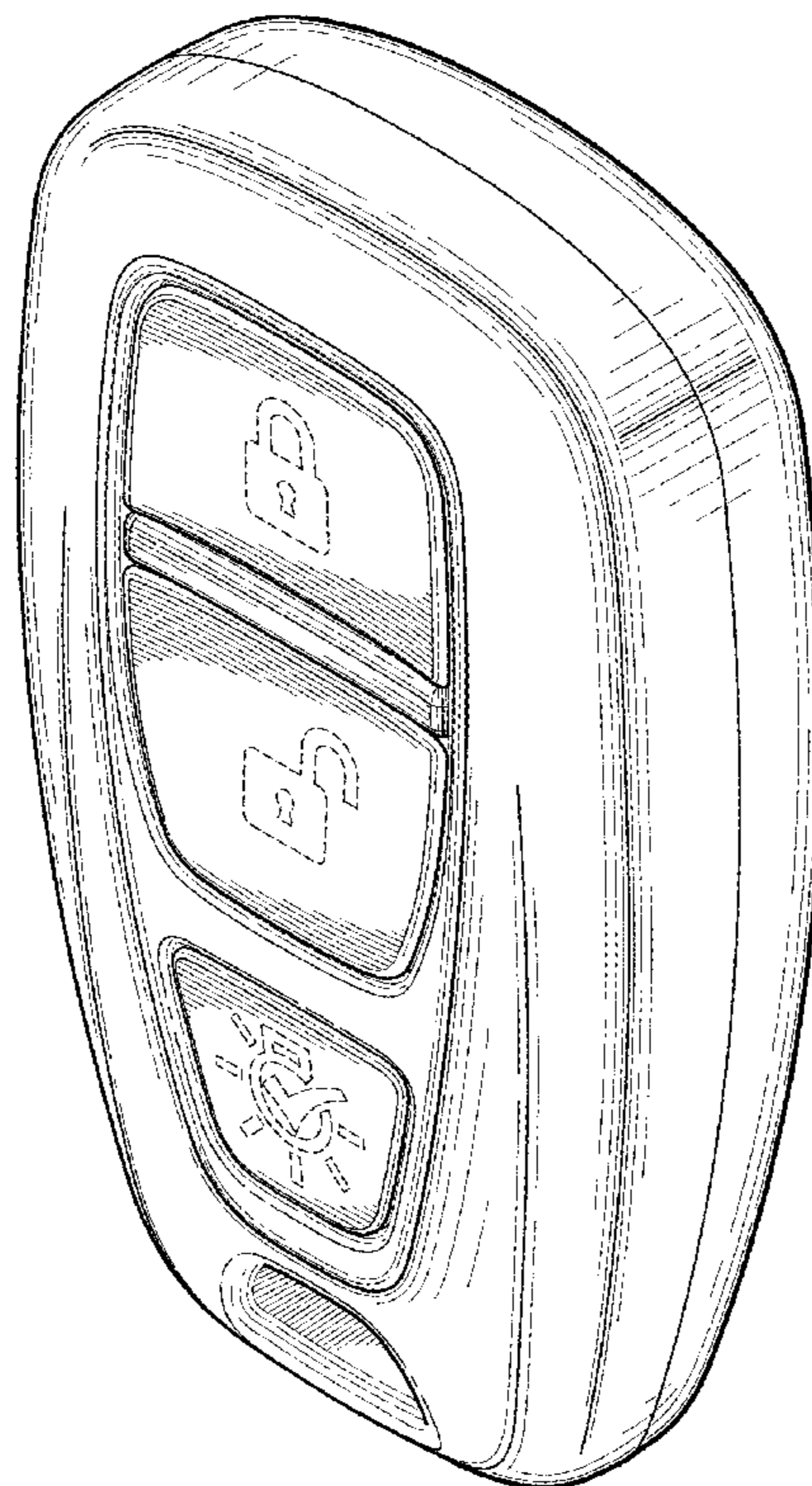

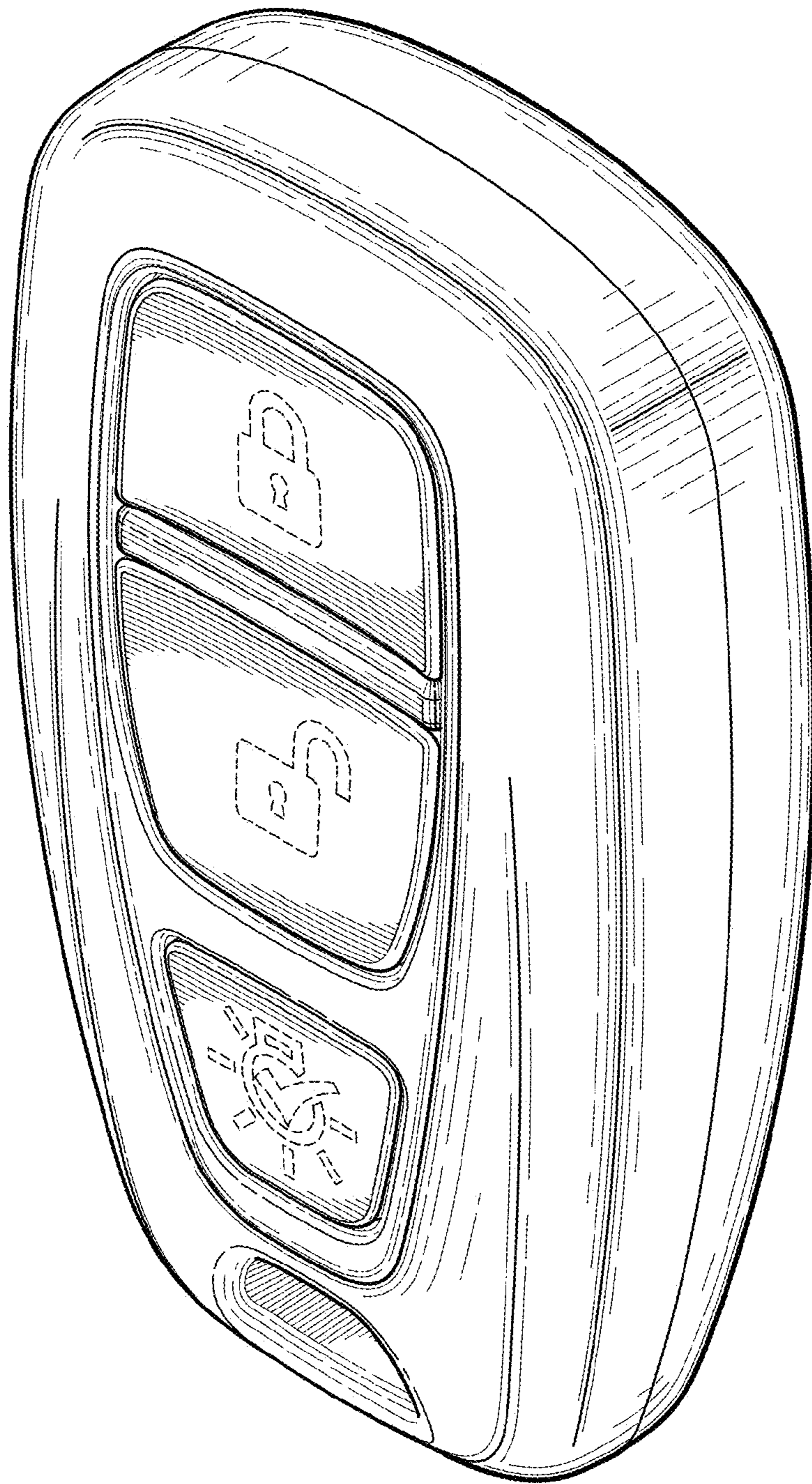

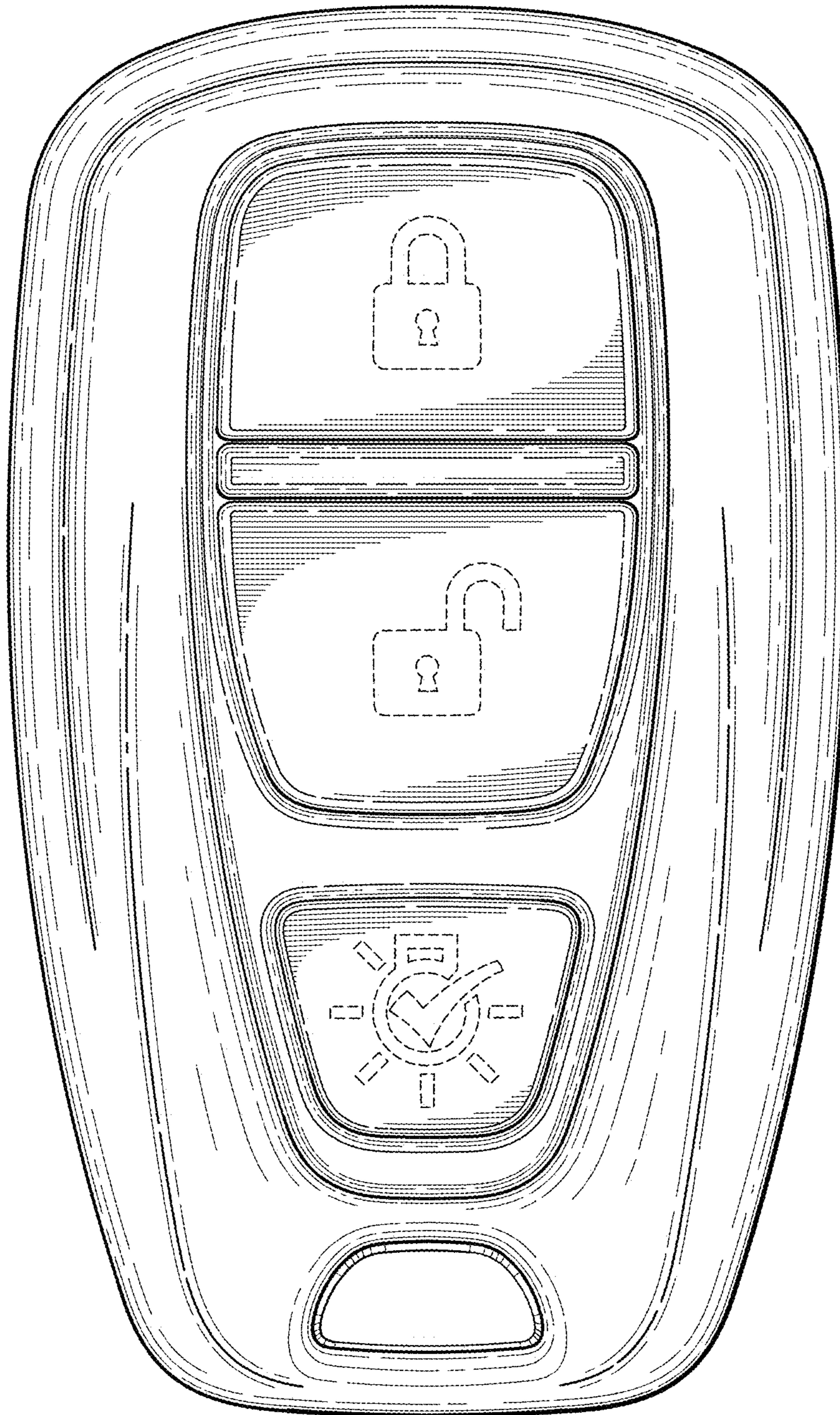

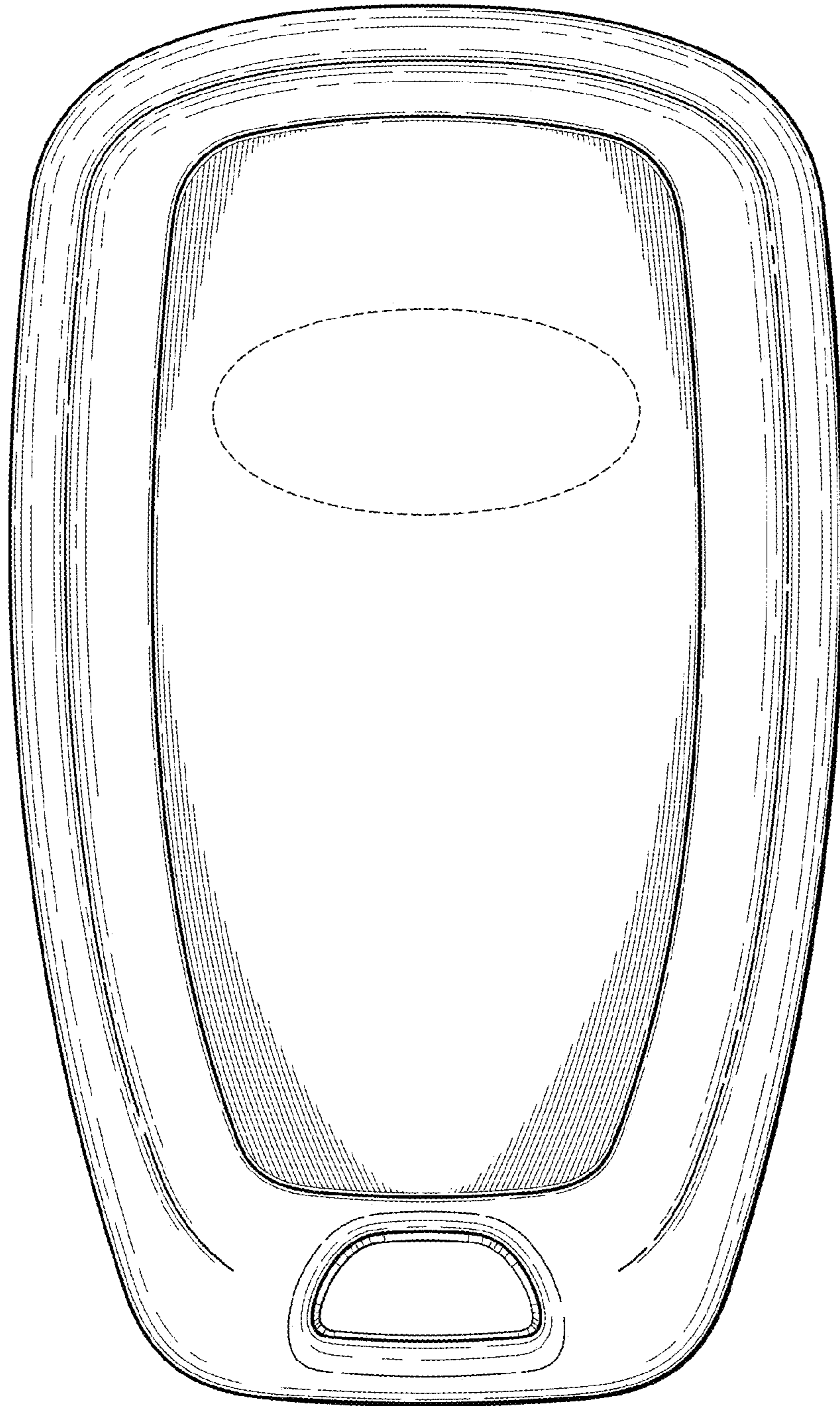

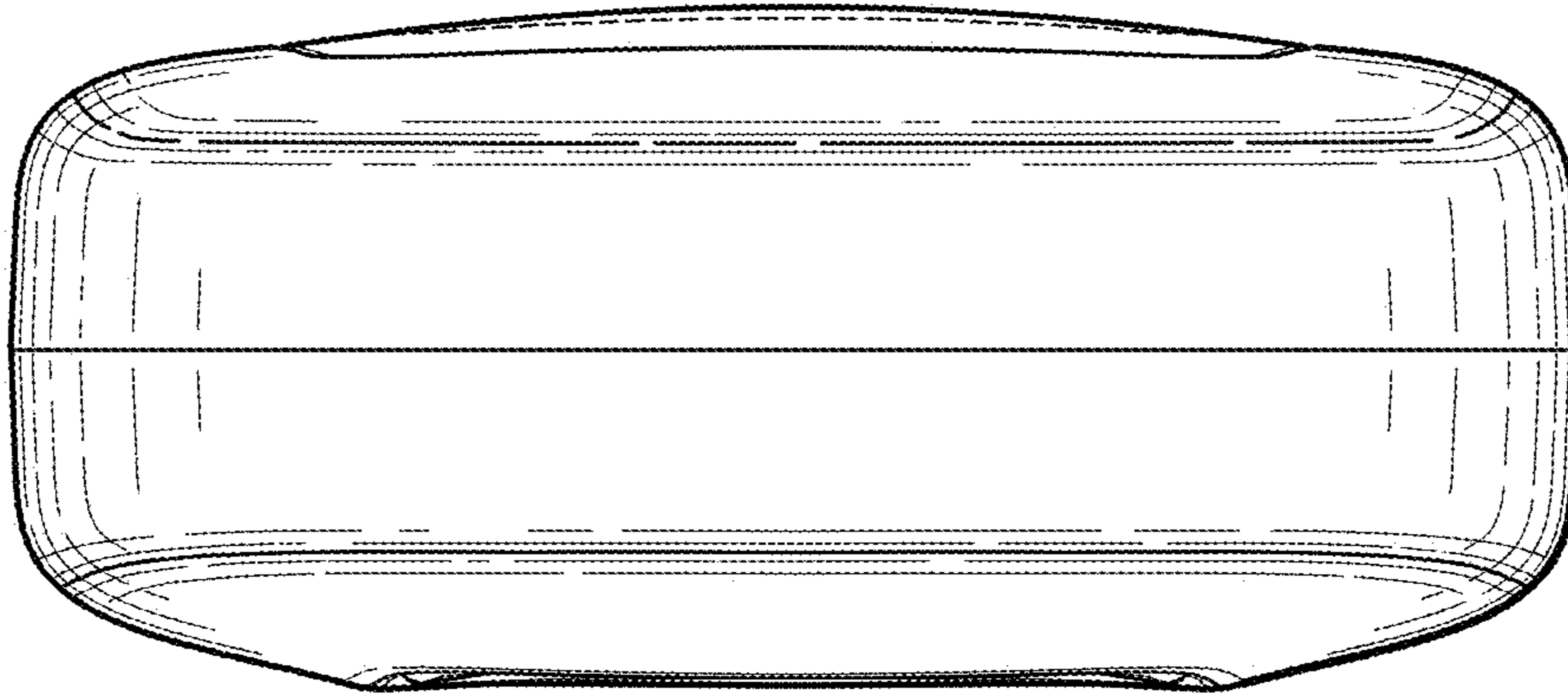

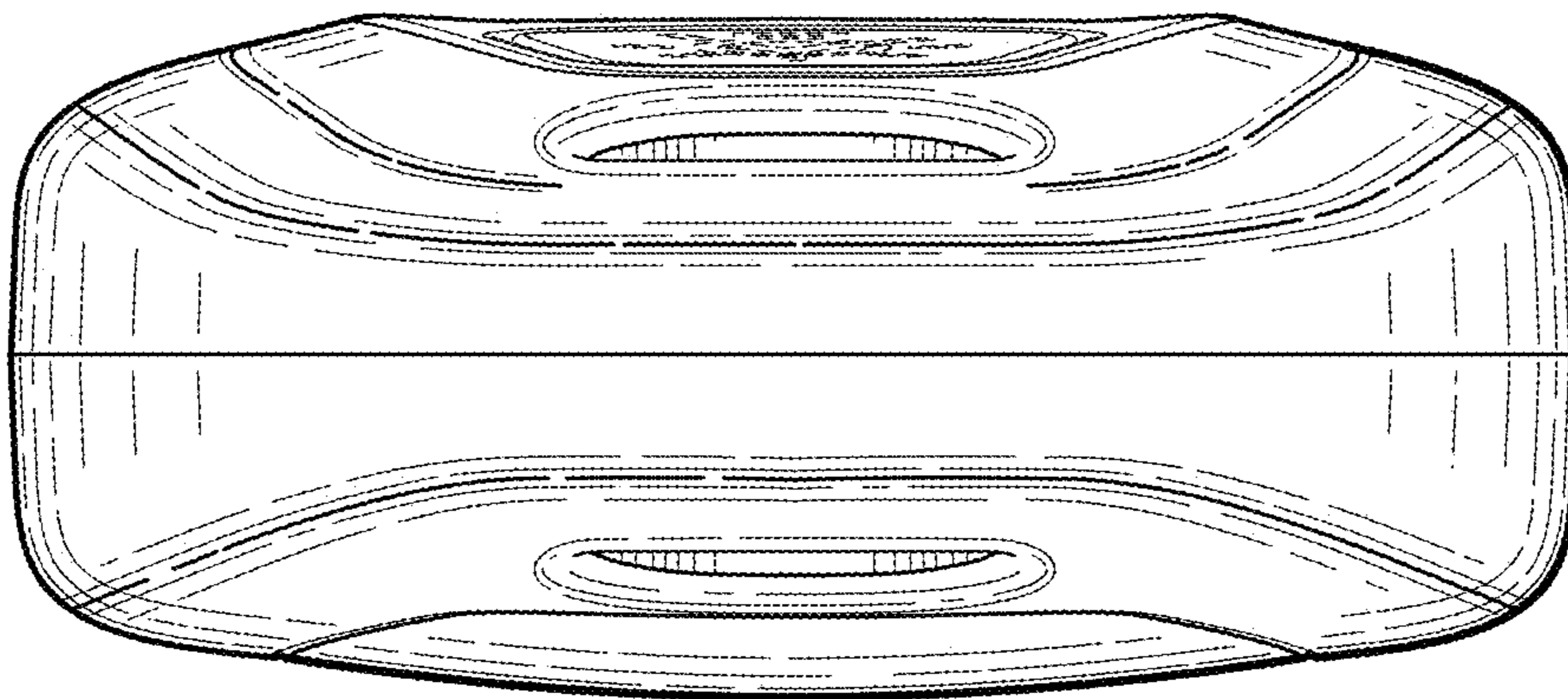

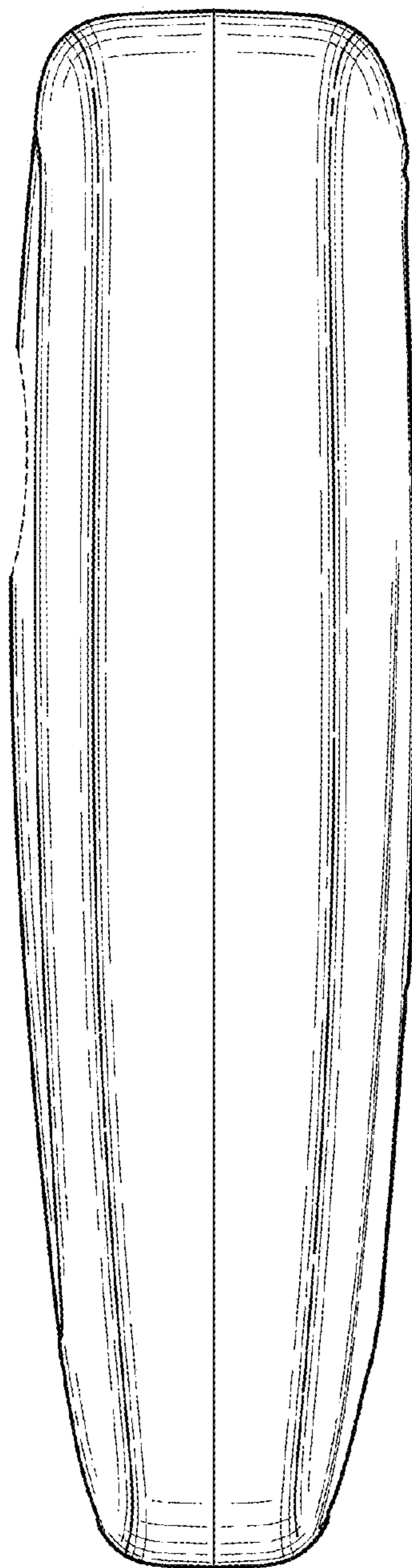

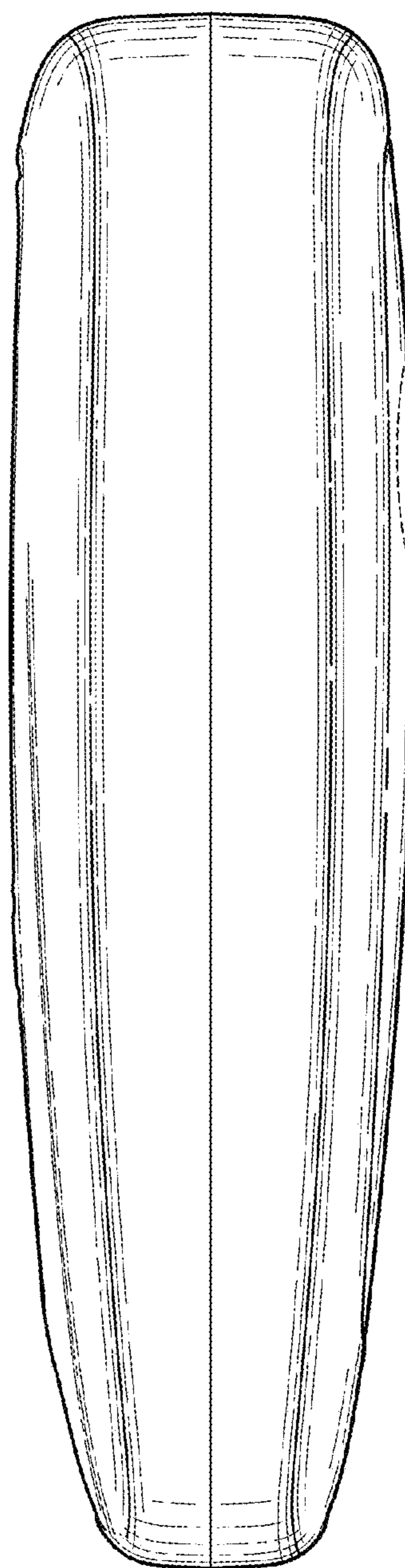

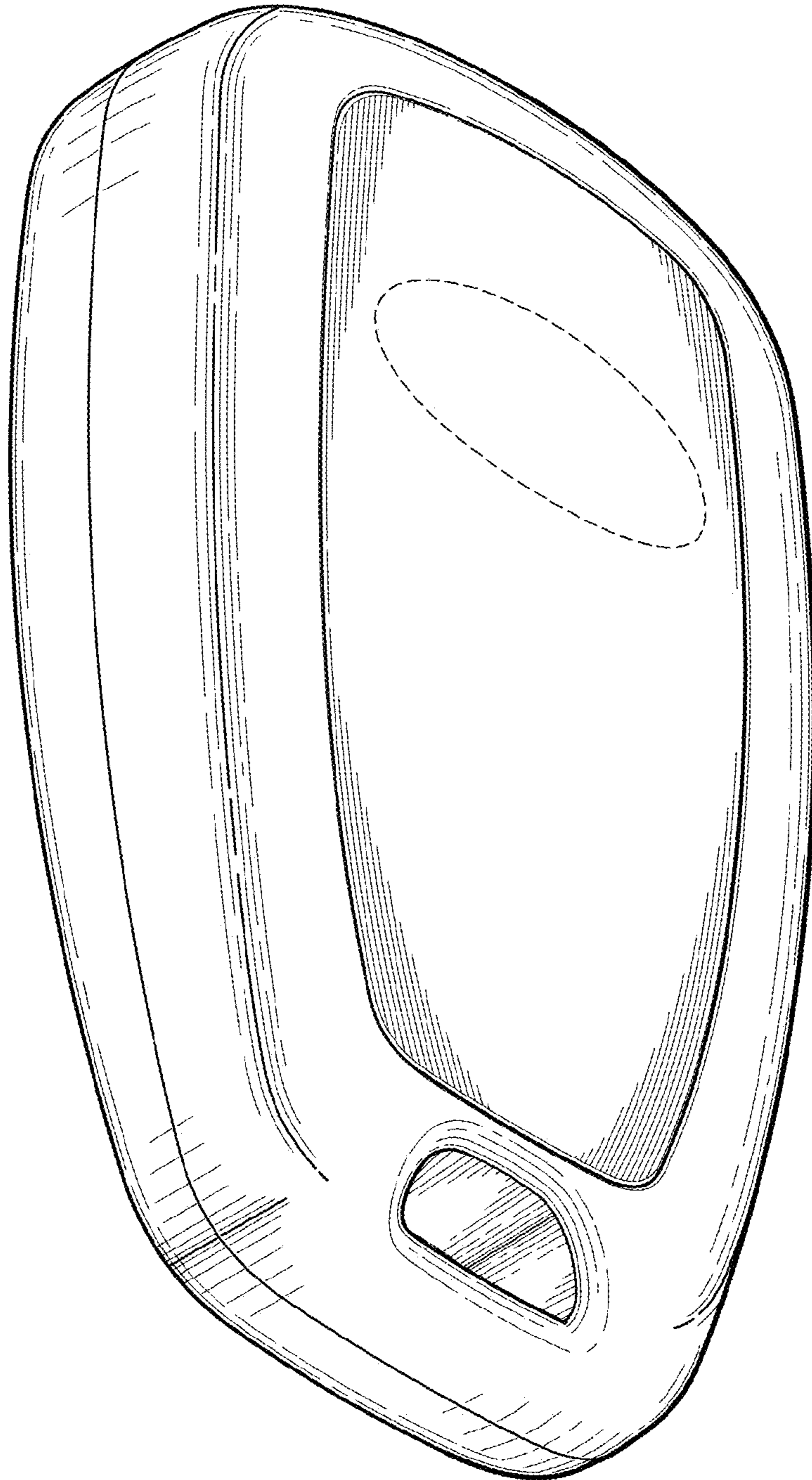

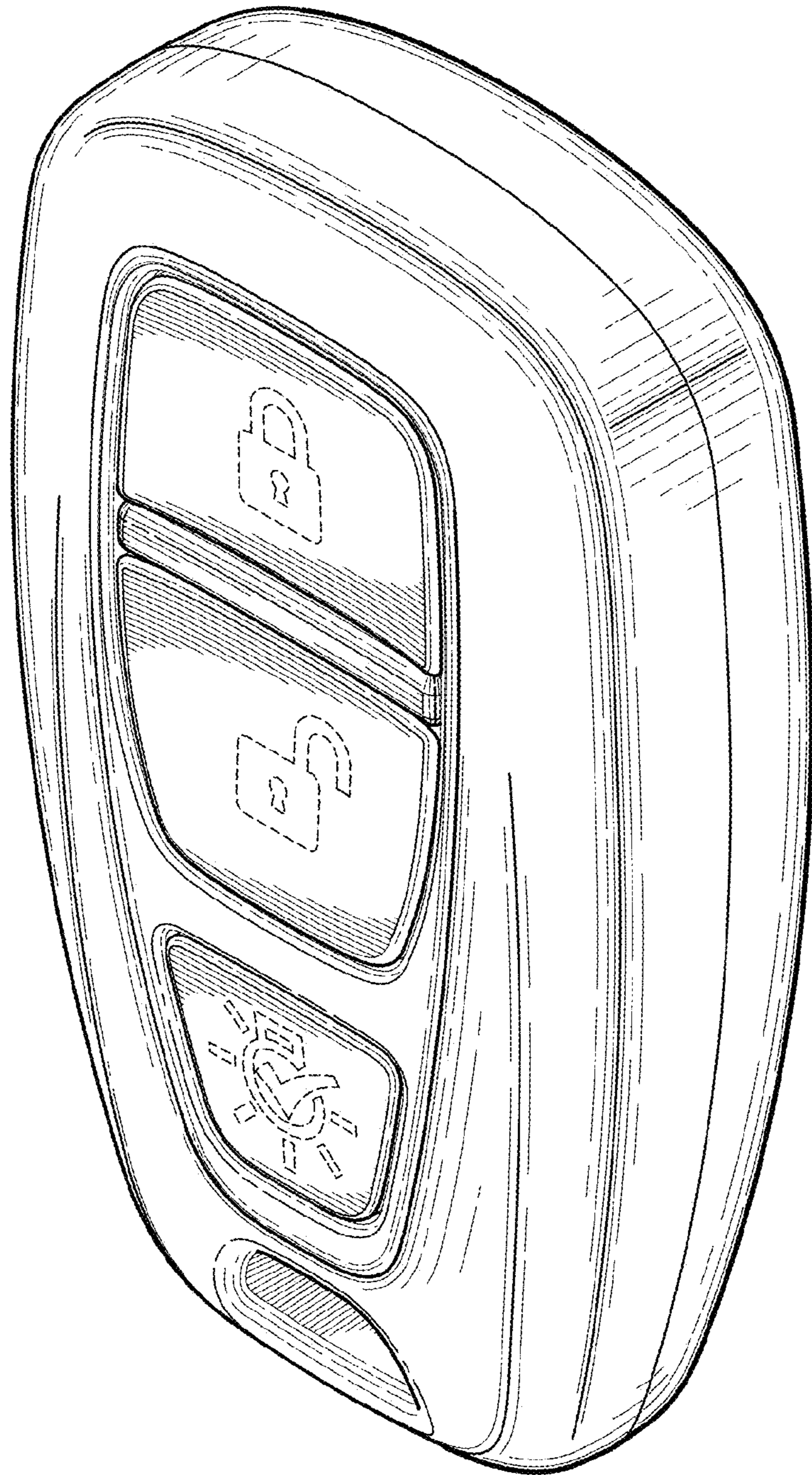

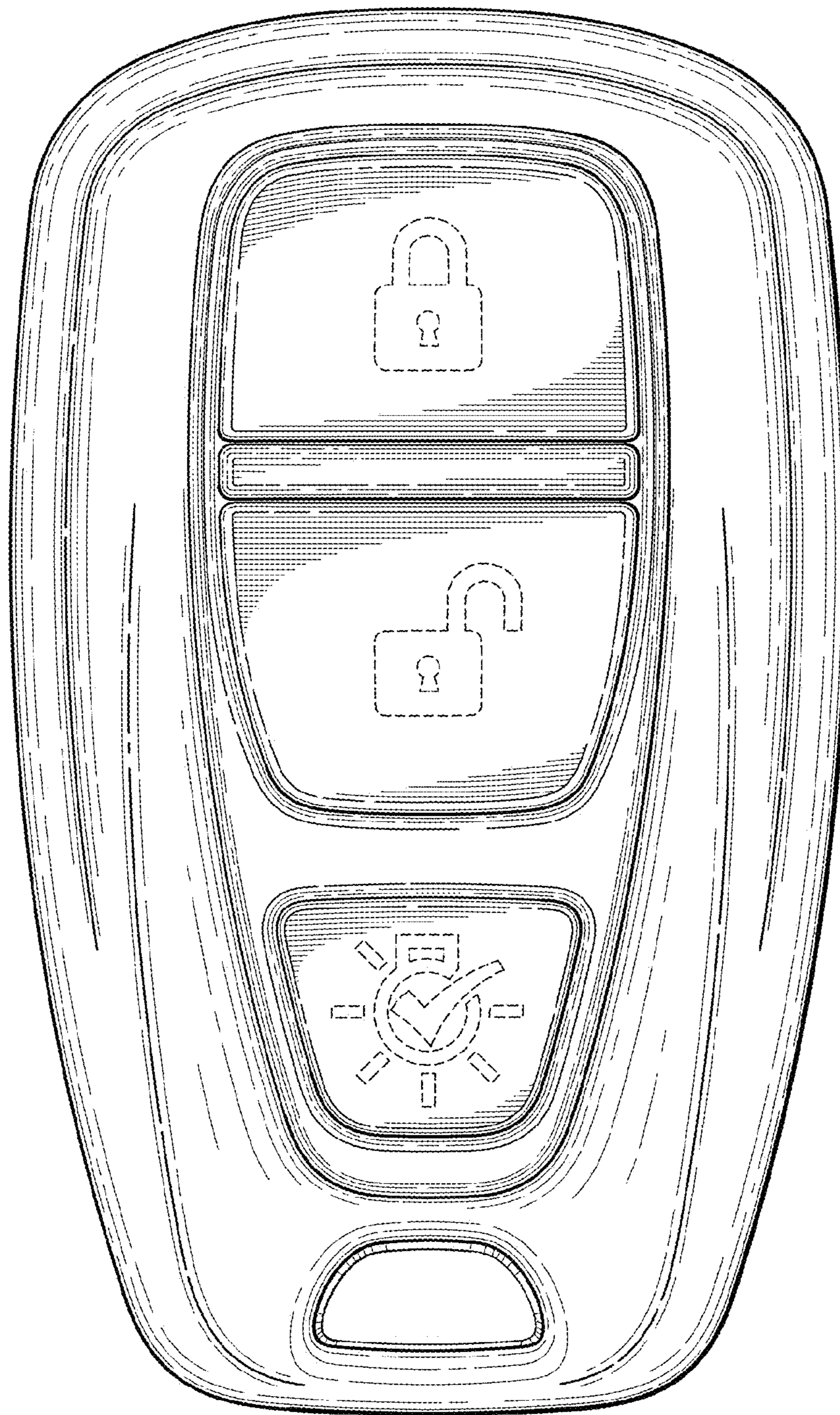

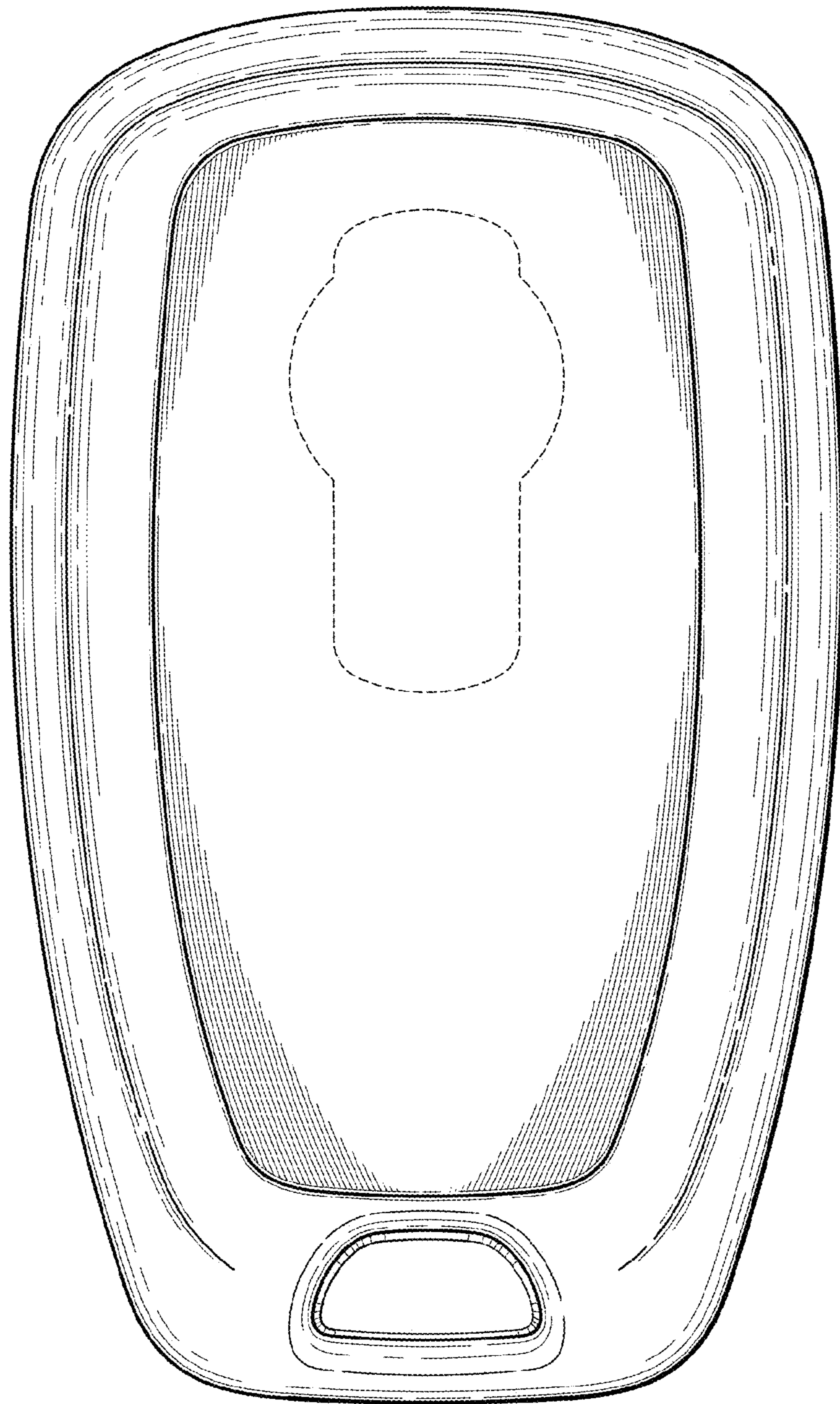

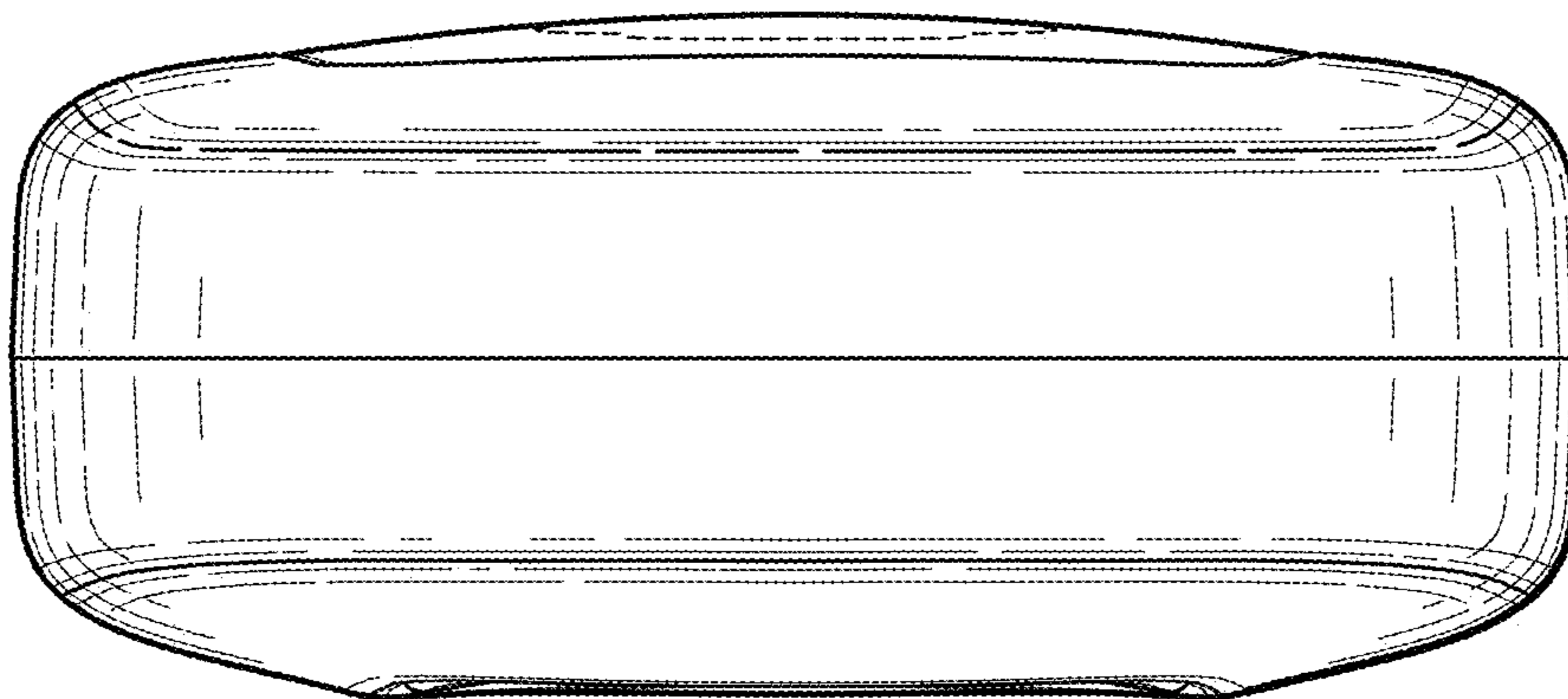

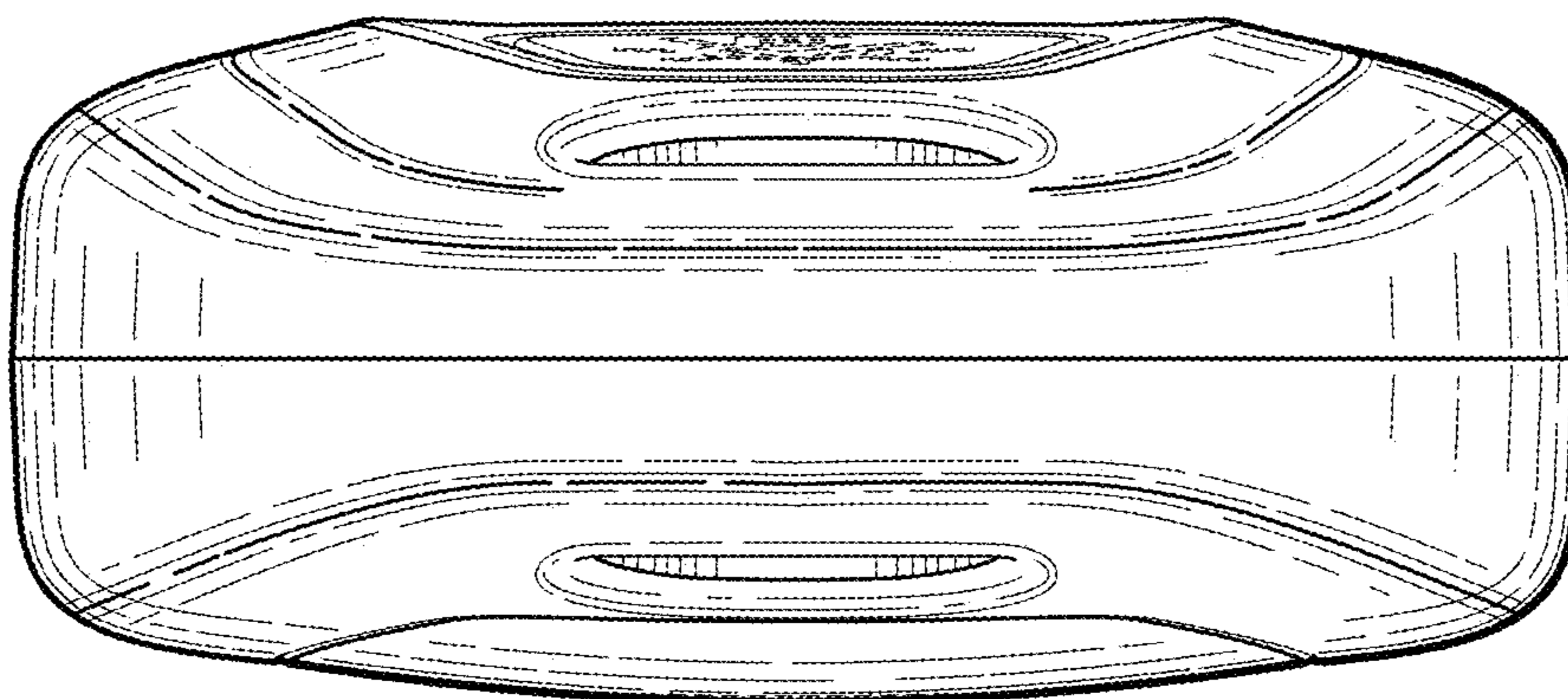

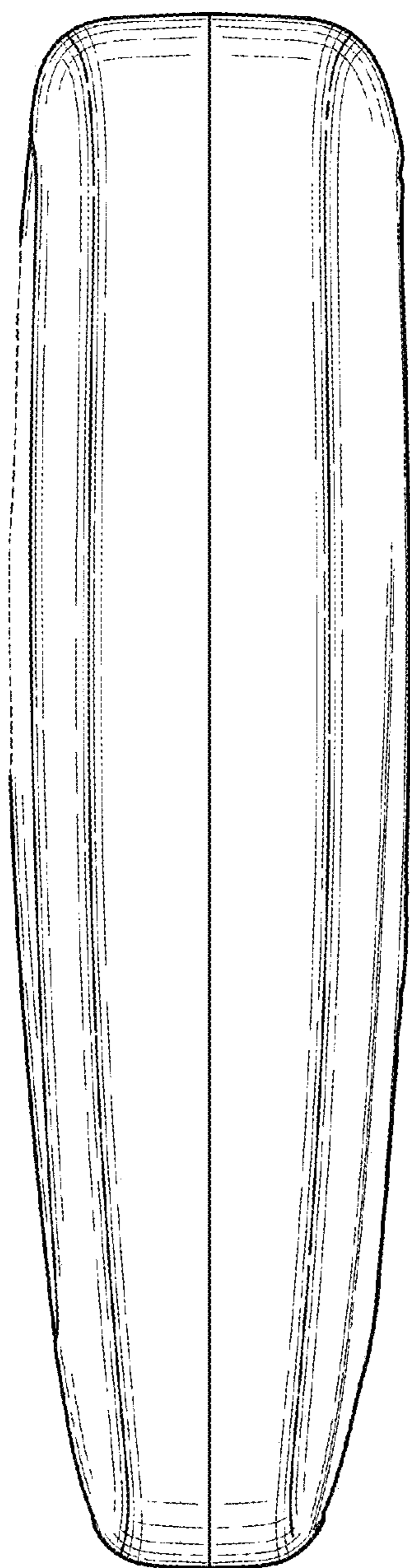

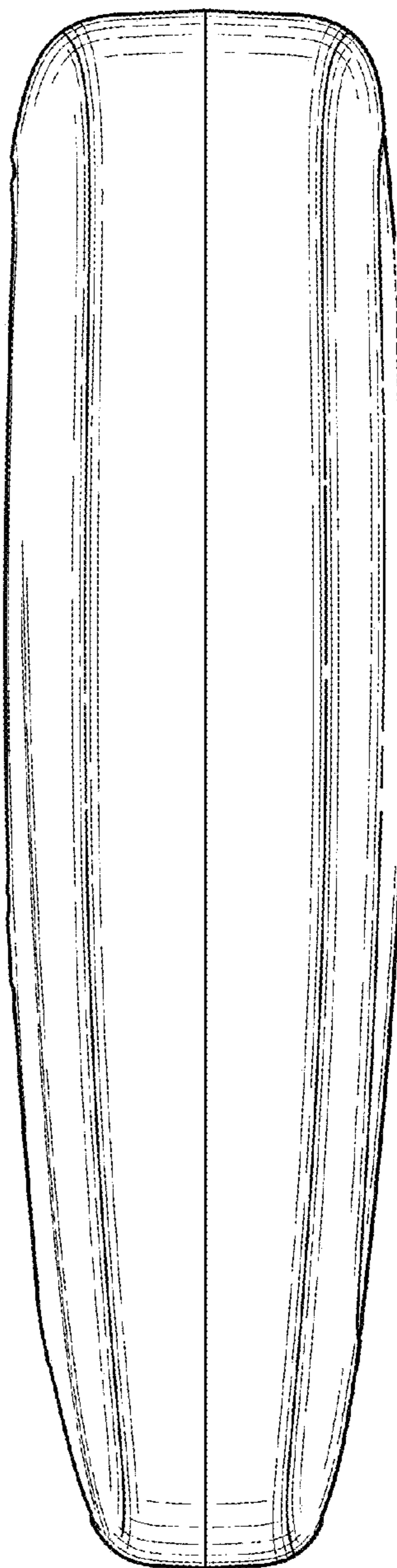

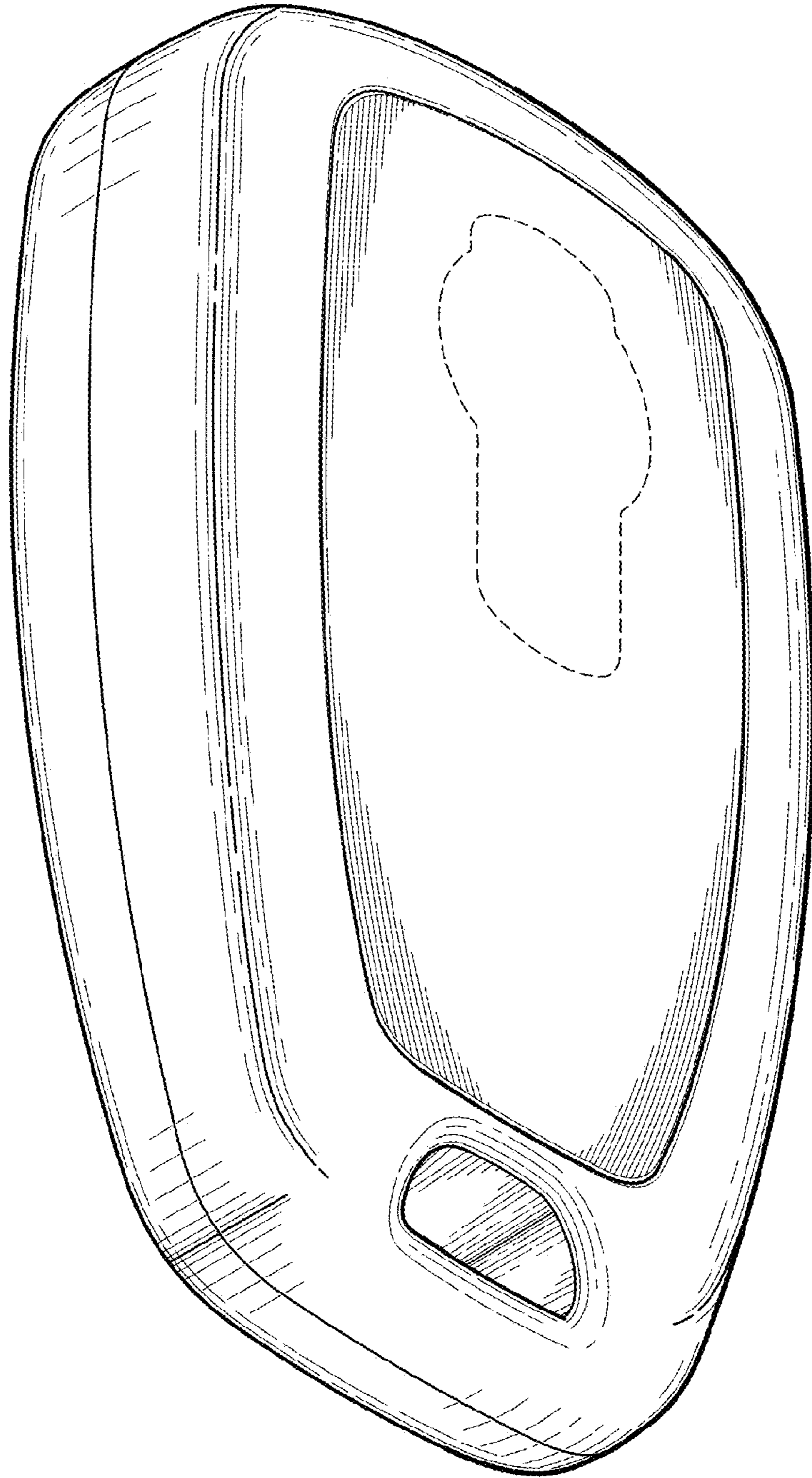
