DESCRIPTION

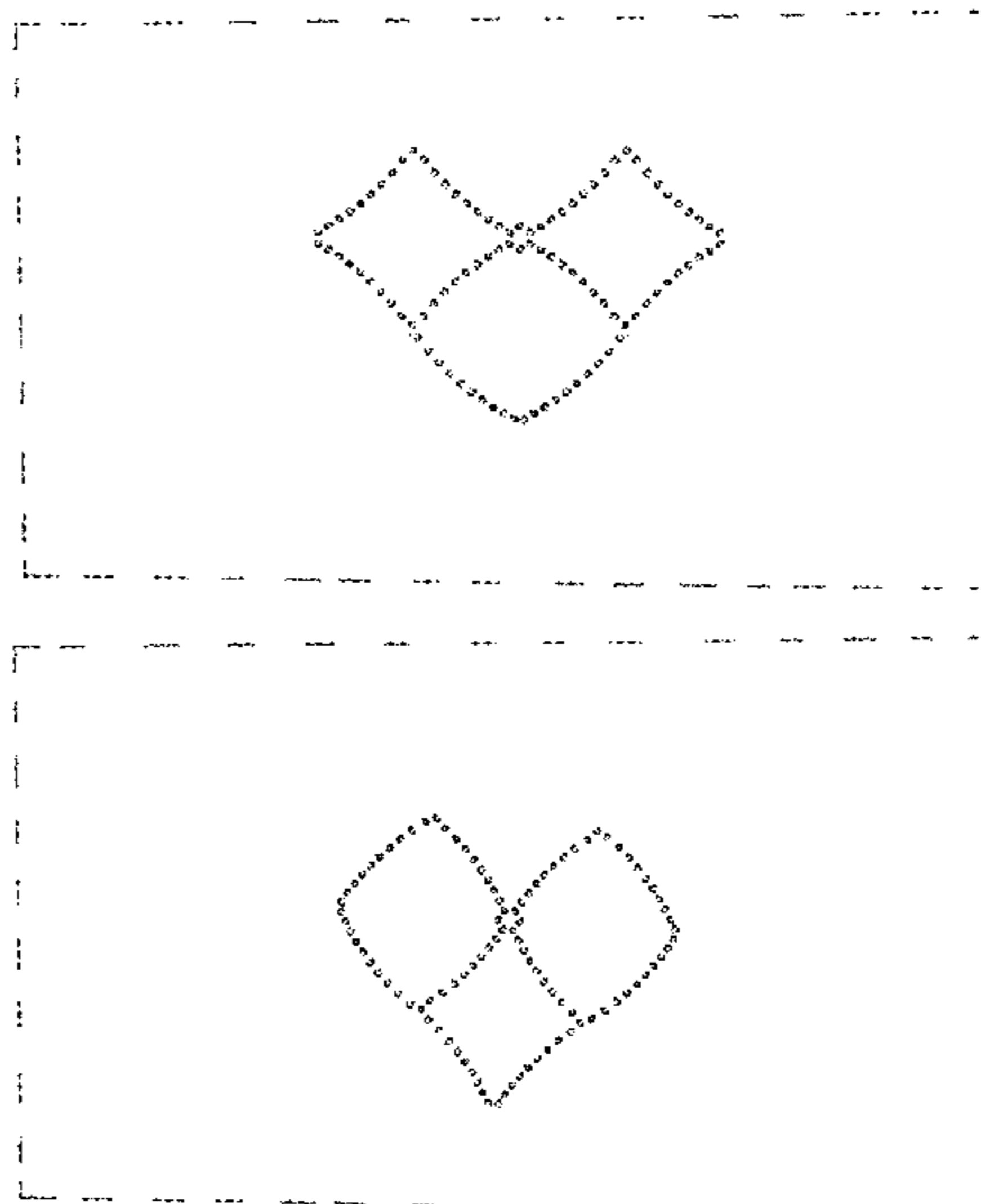
FIG. 1 is a front view of a first embodiment of a sheet having a pattern;

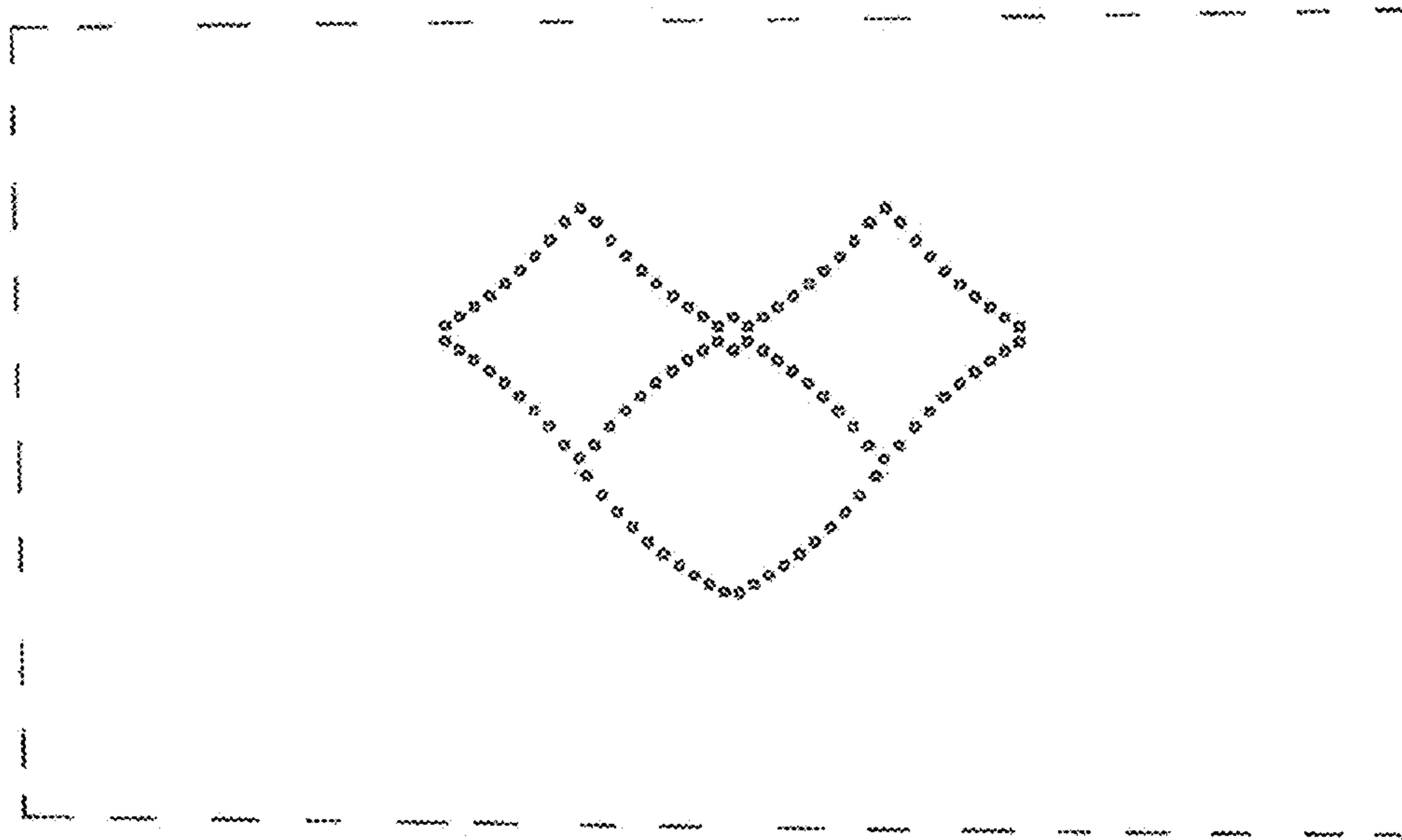

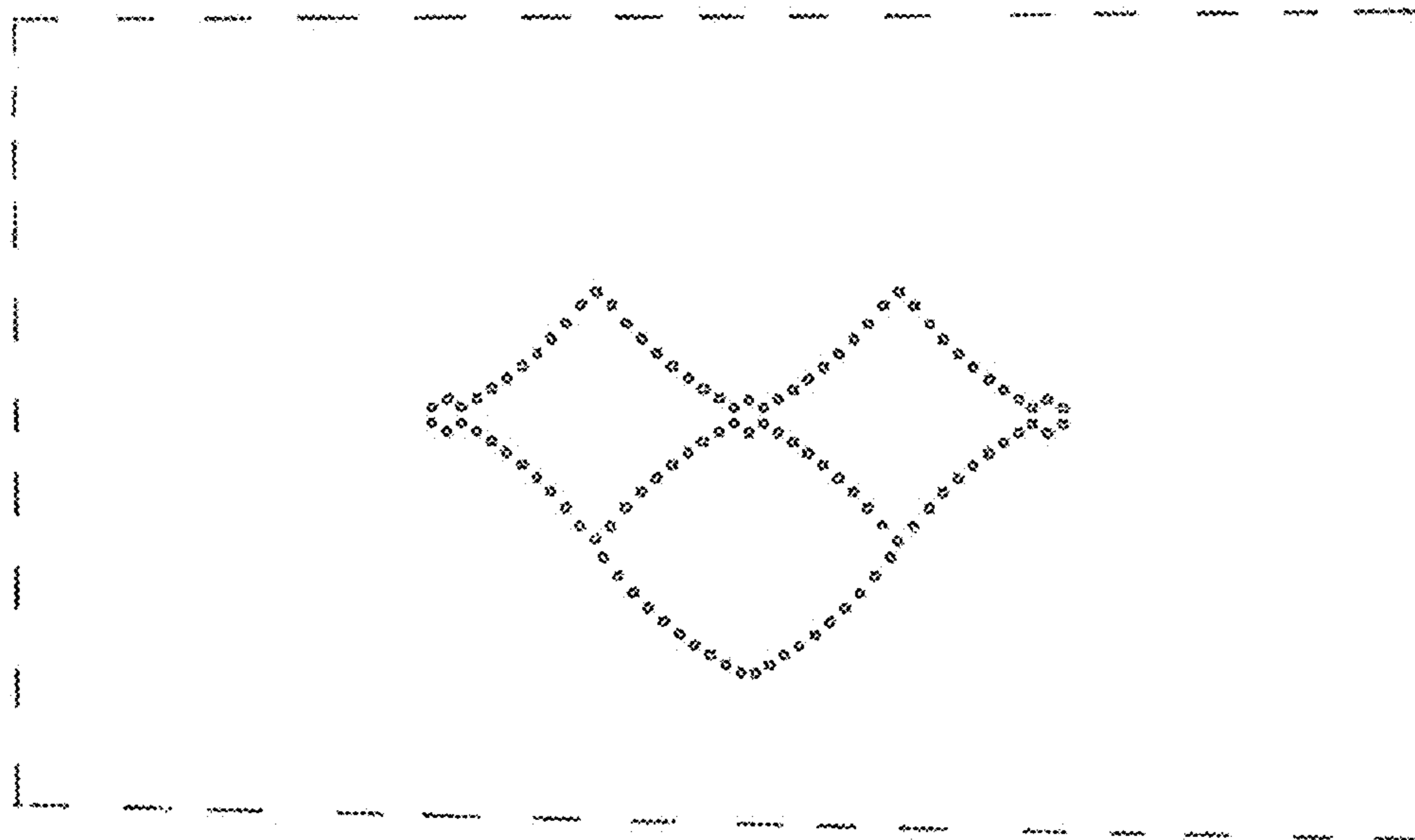

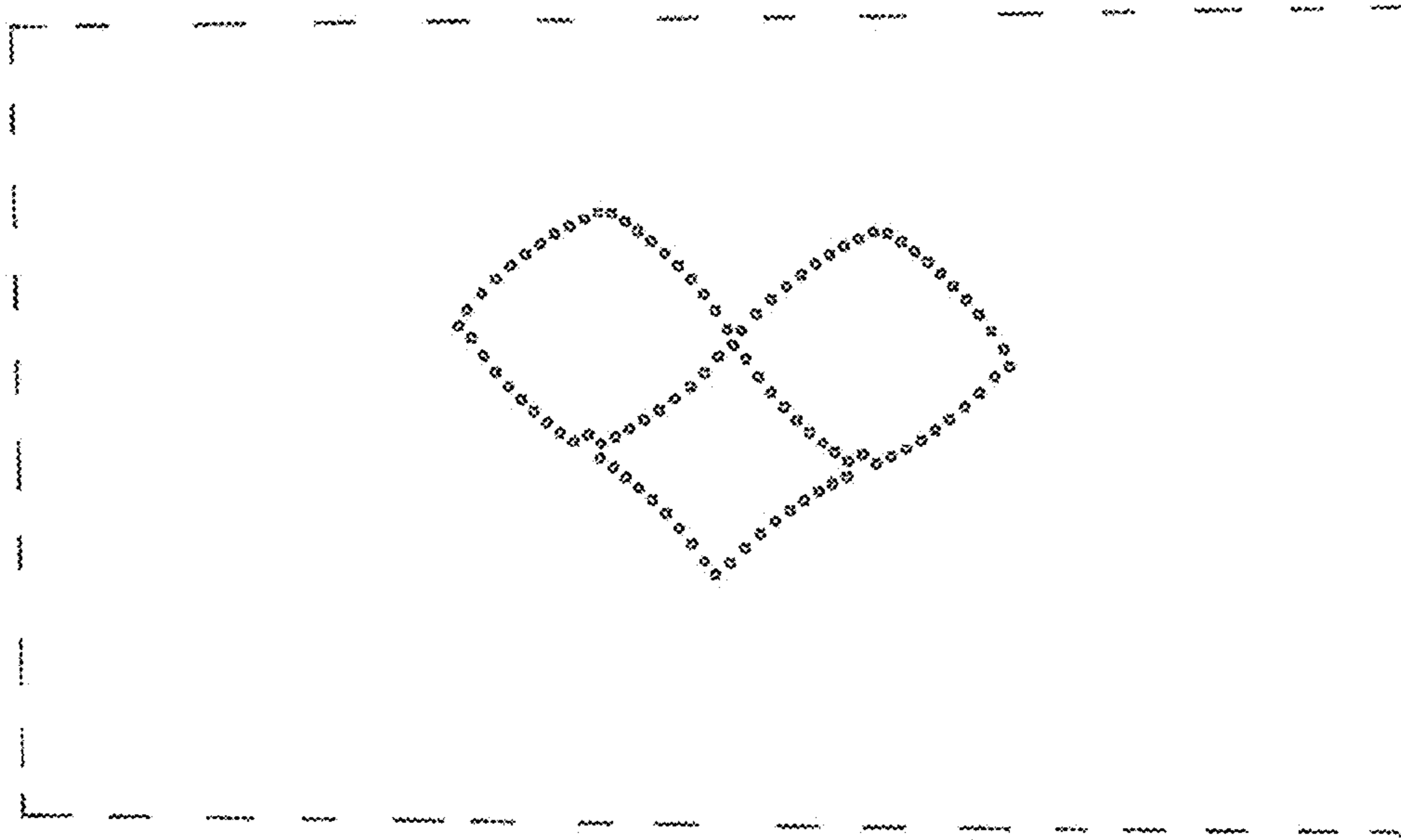

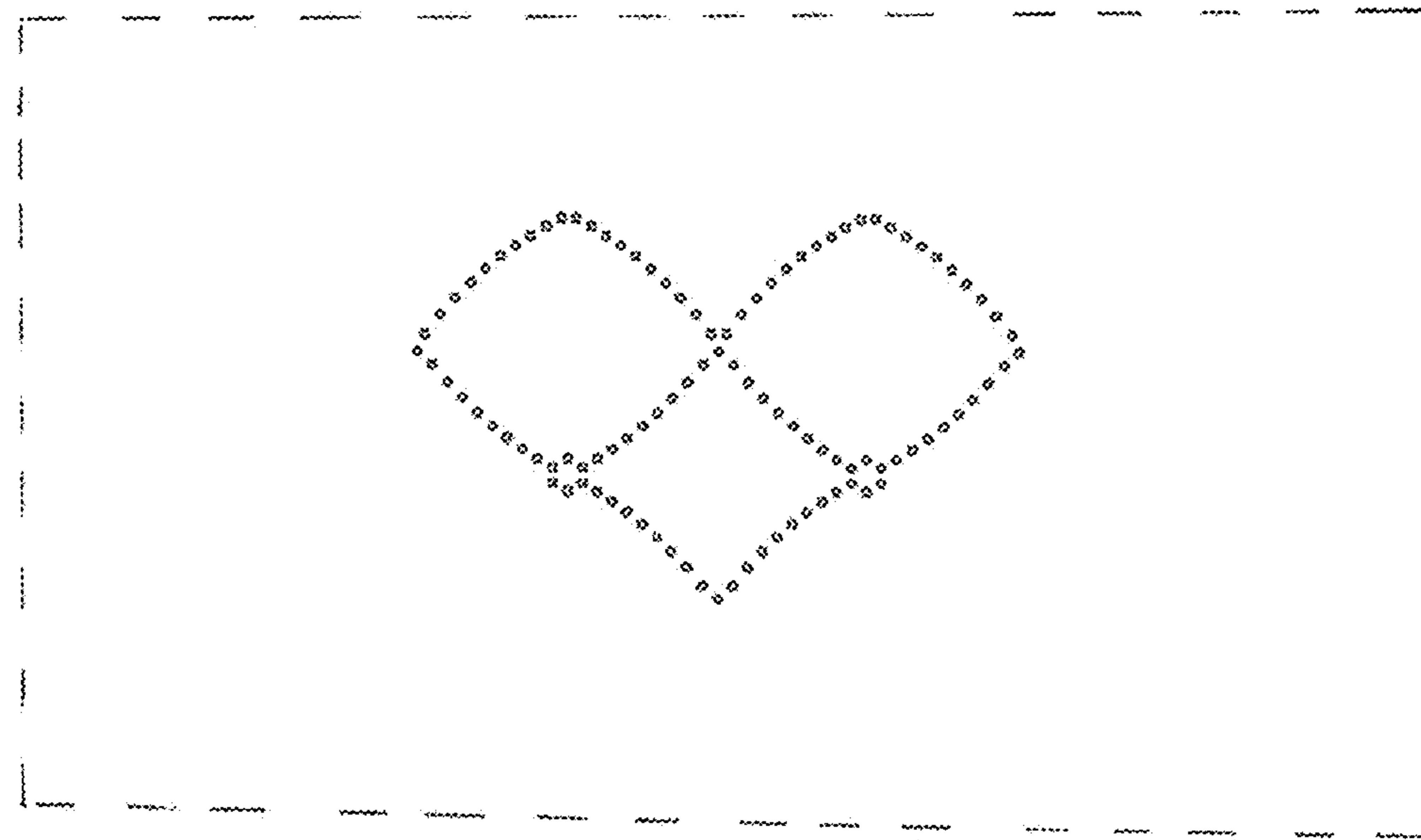

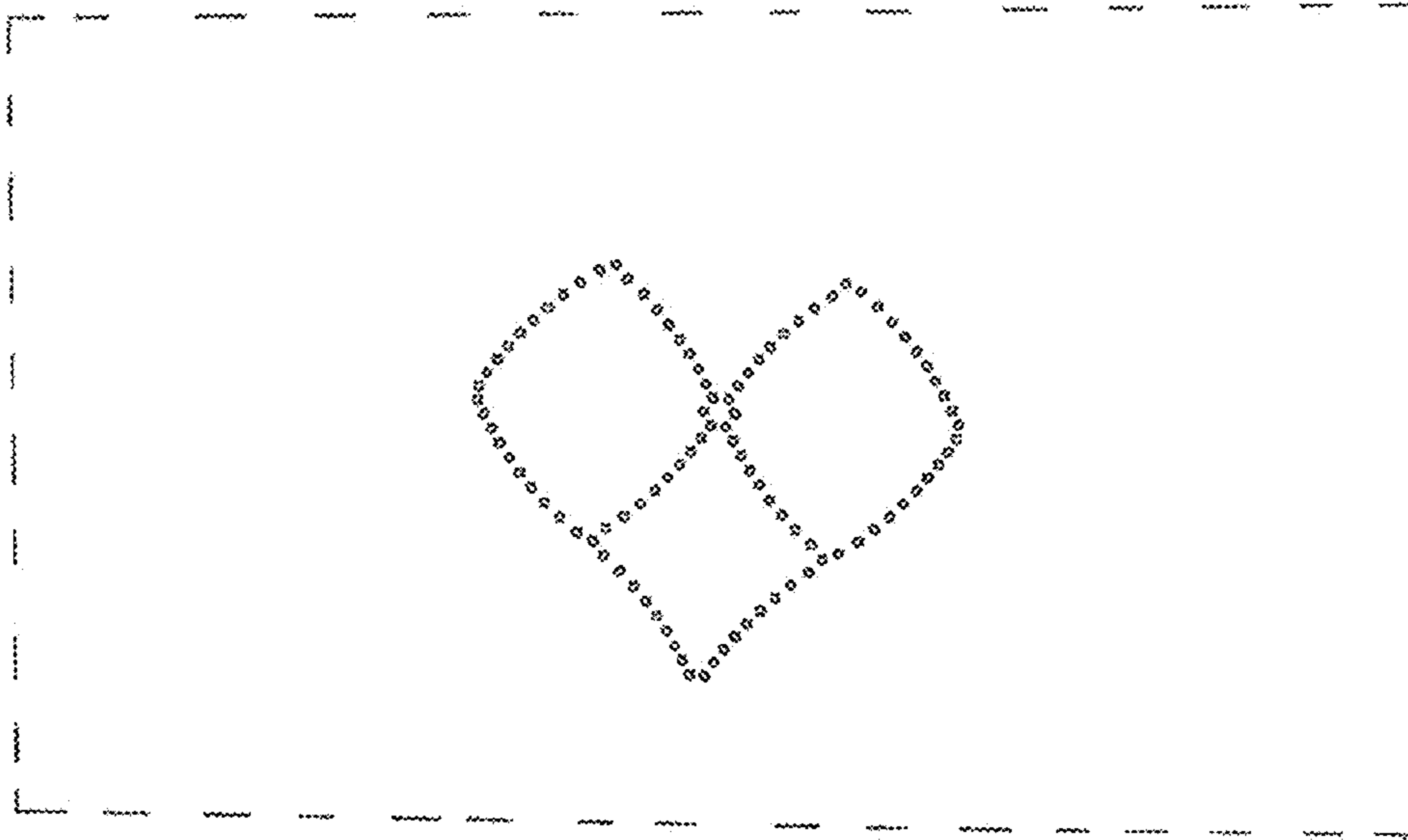

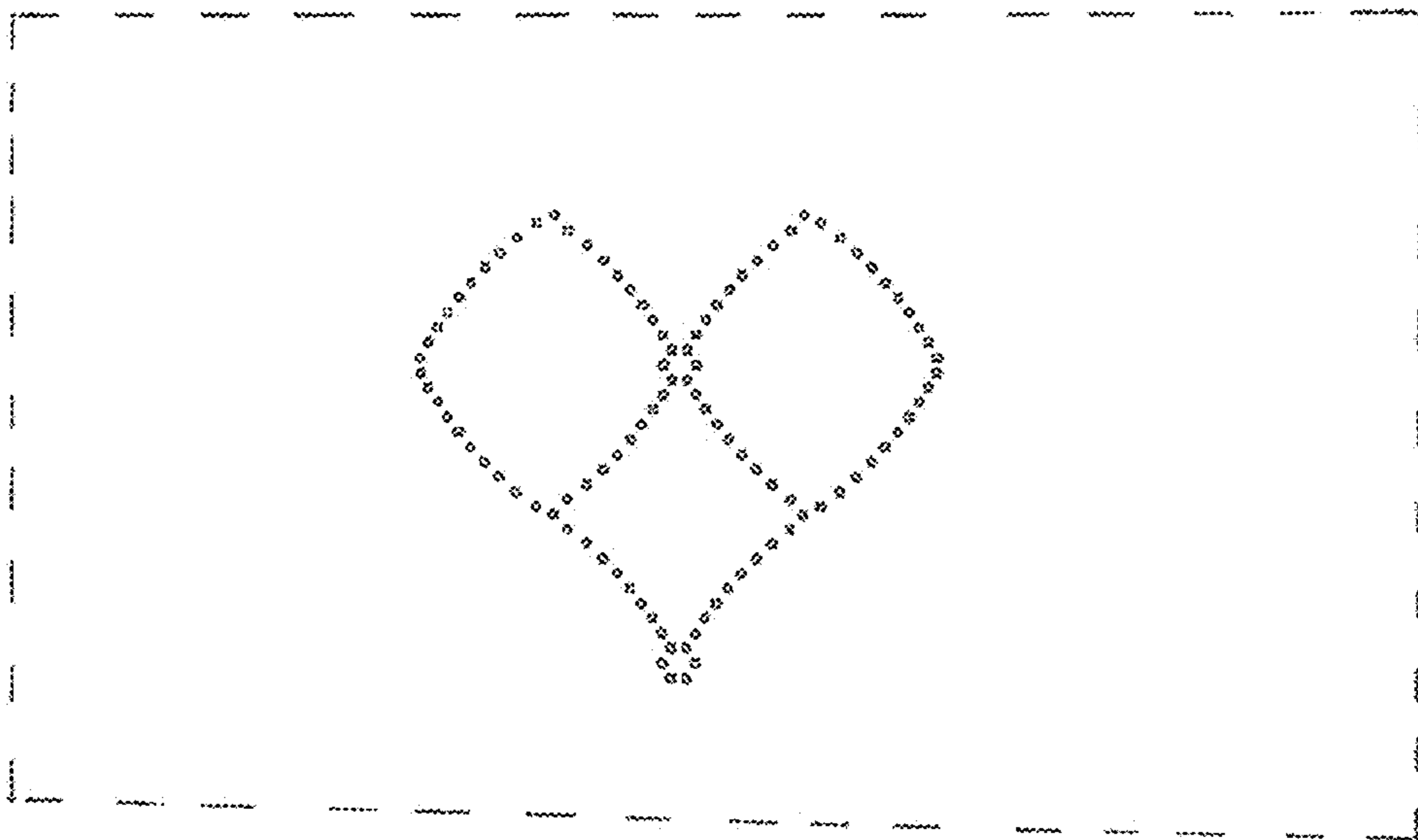
