FIG. 11 is a side elevational view of the container in an open position; and,

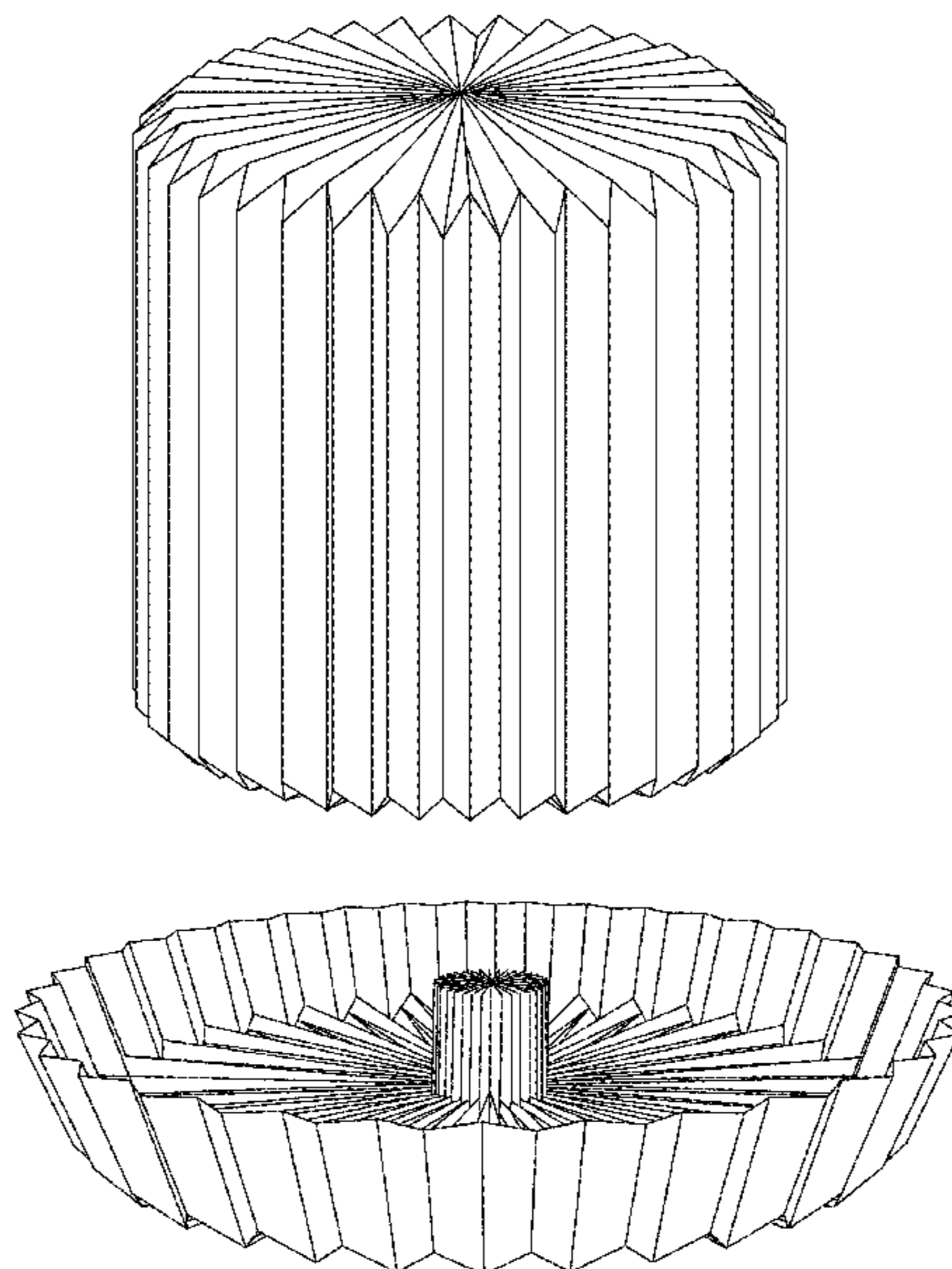
FIG. 12 is a perspective view of the container in an open position.

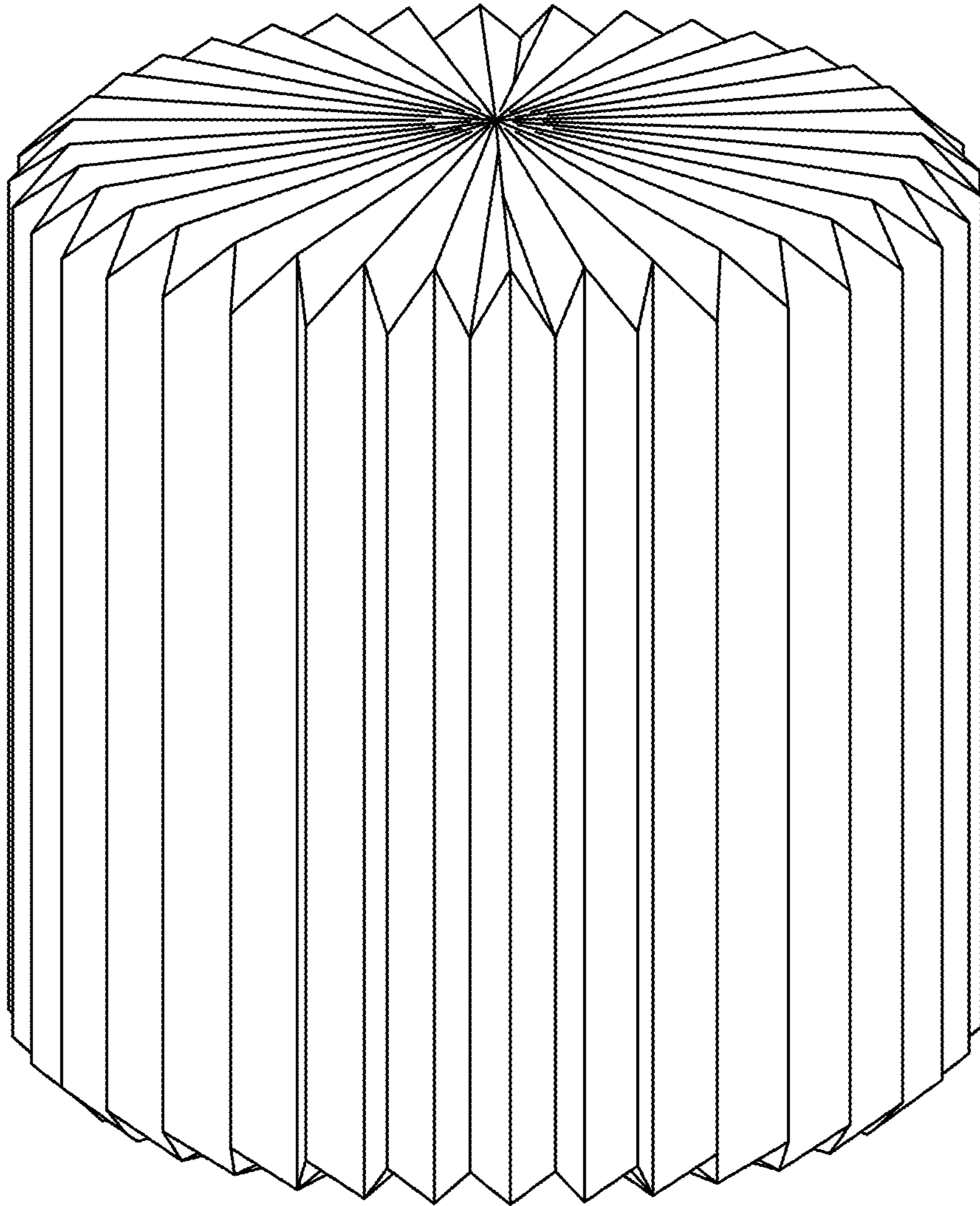

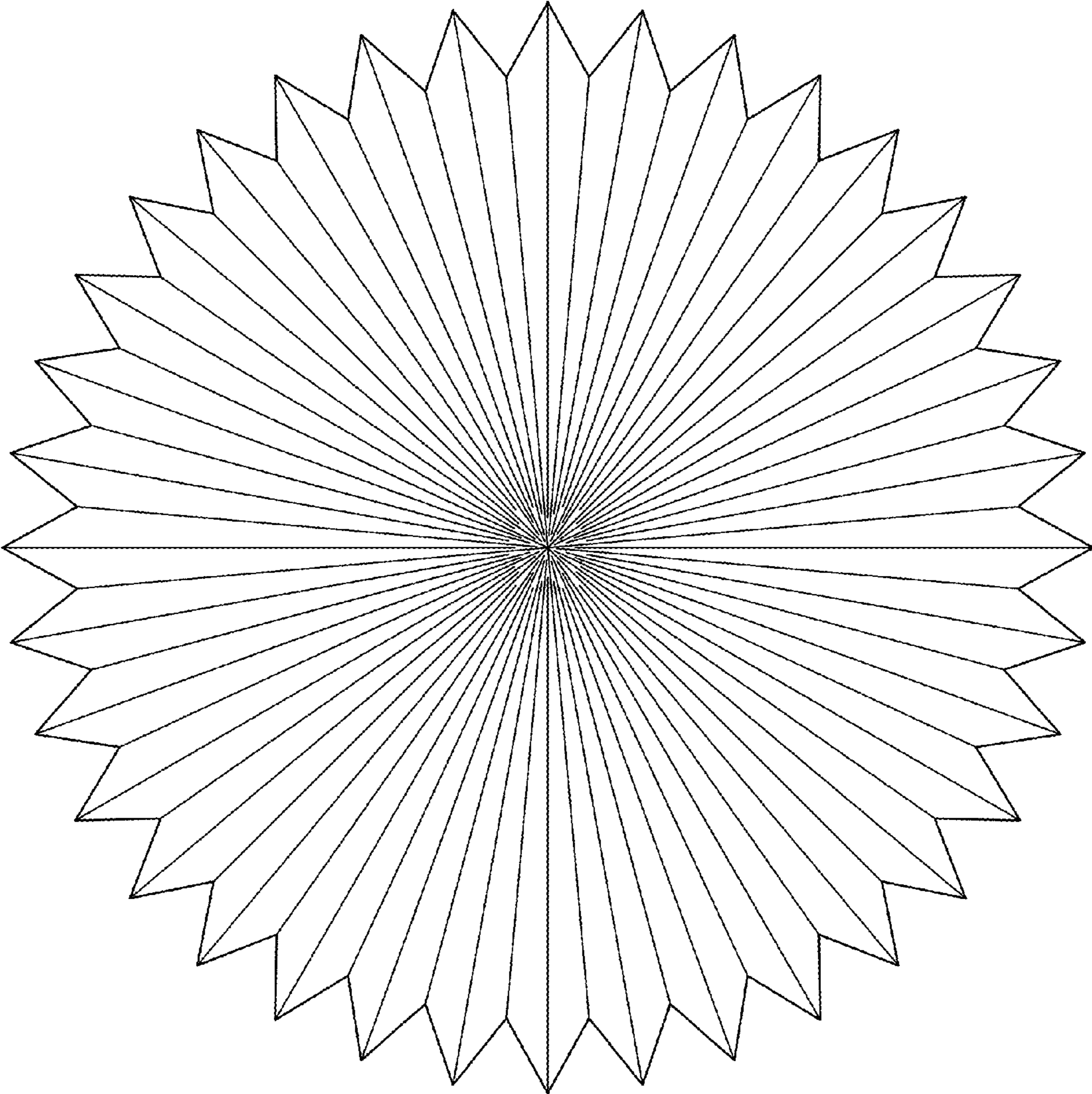

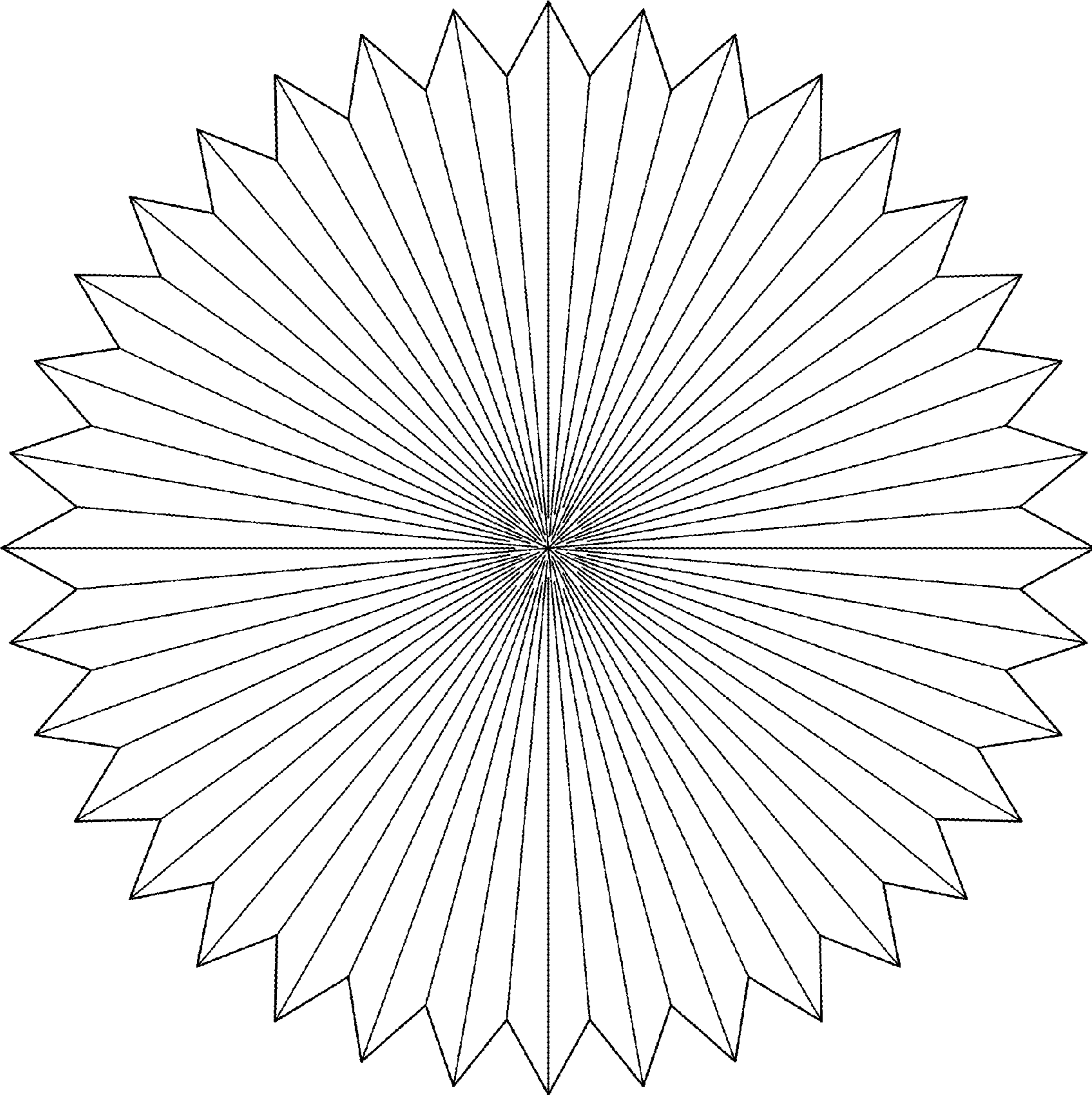

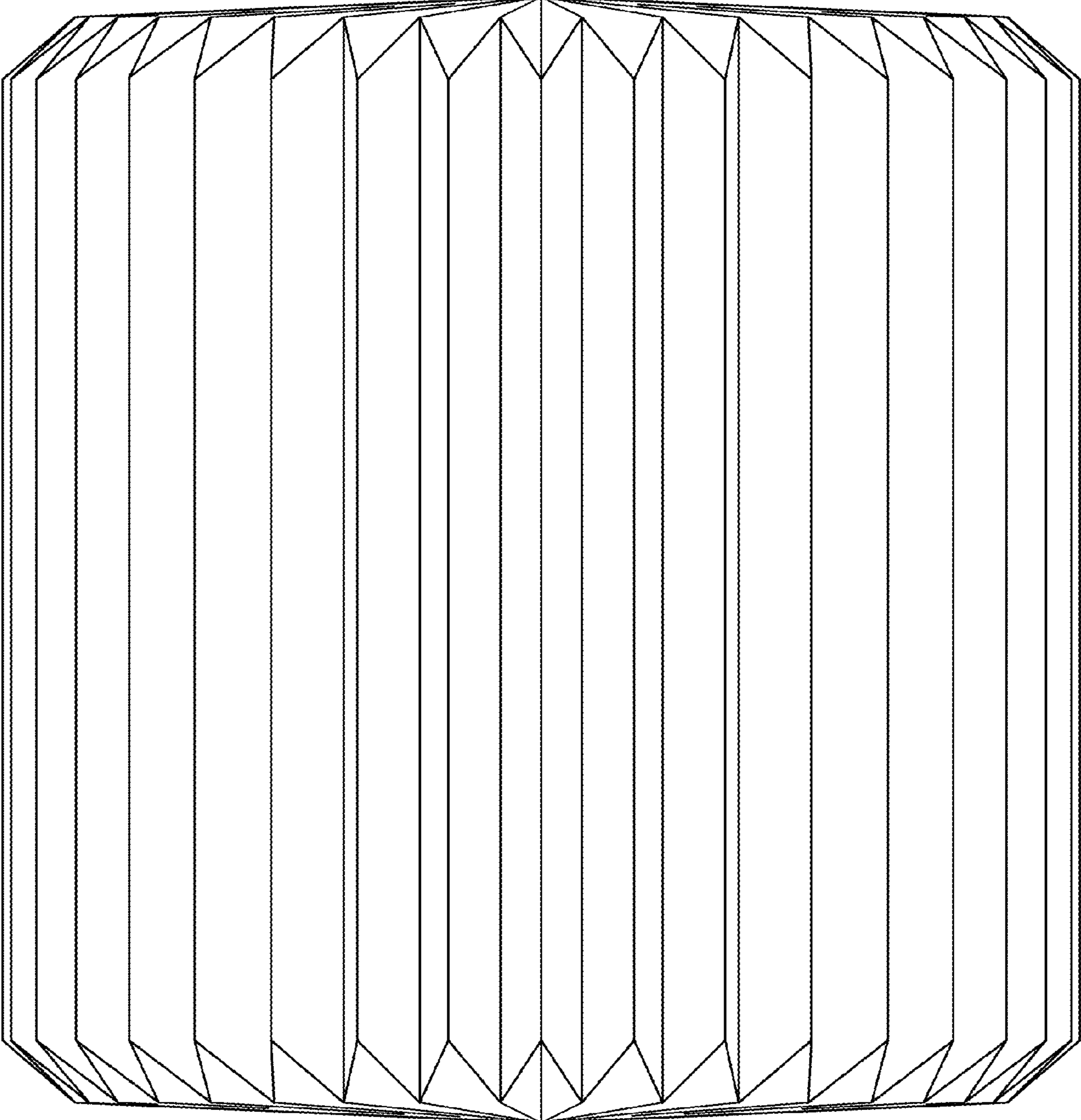

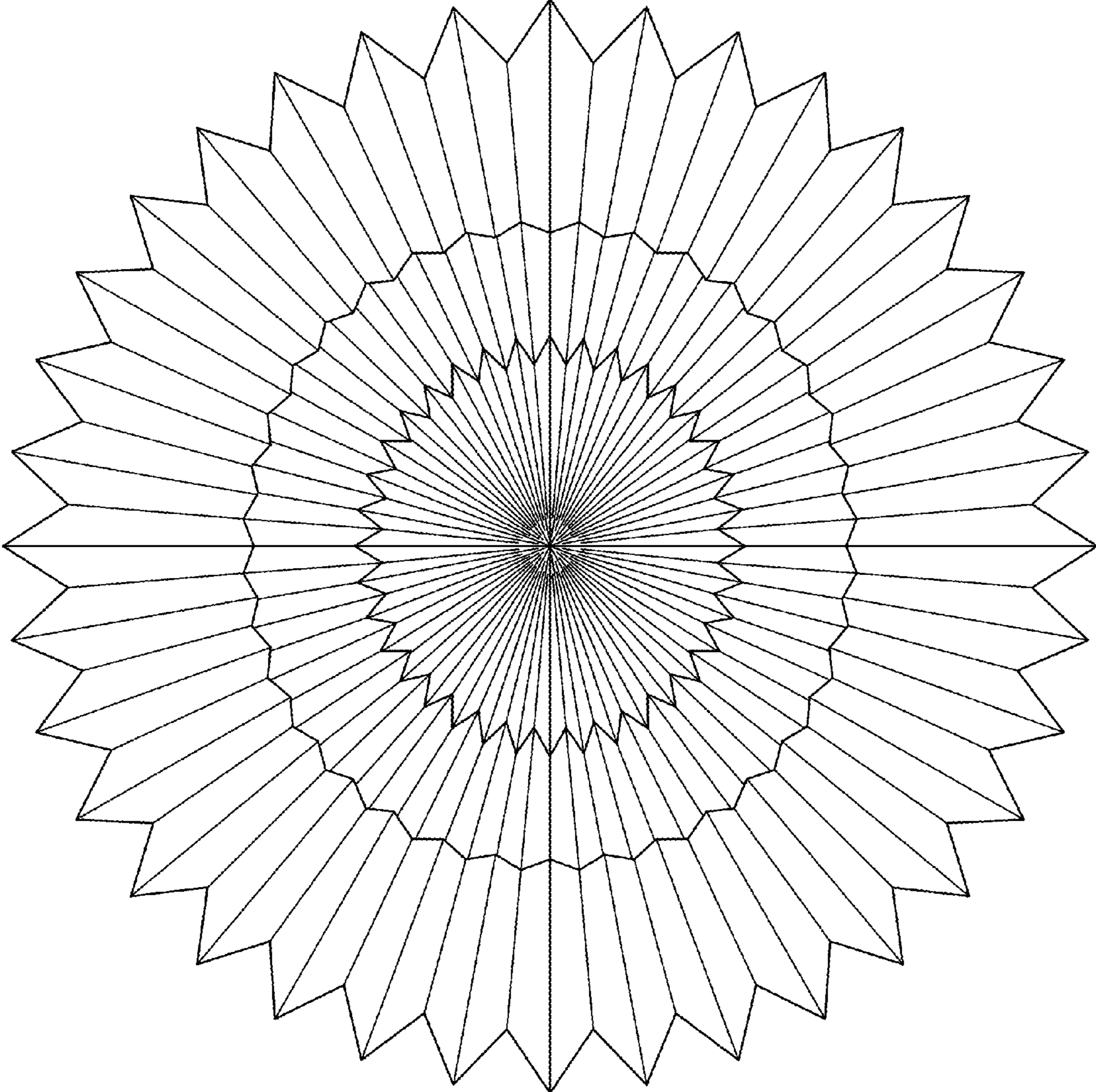

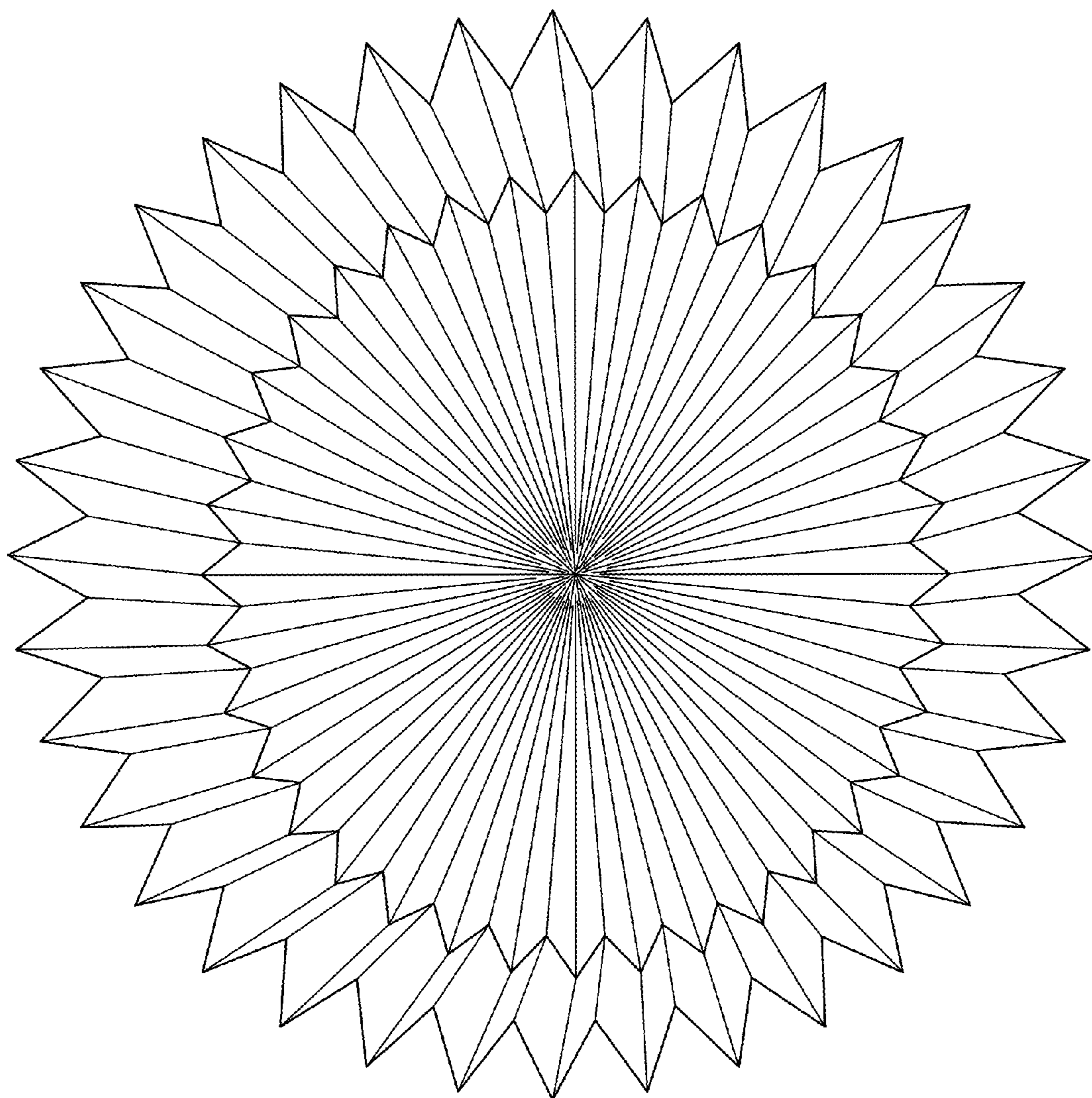

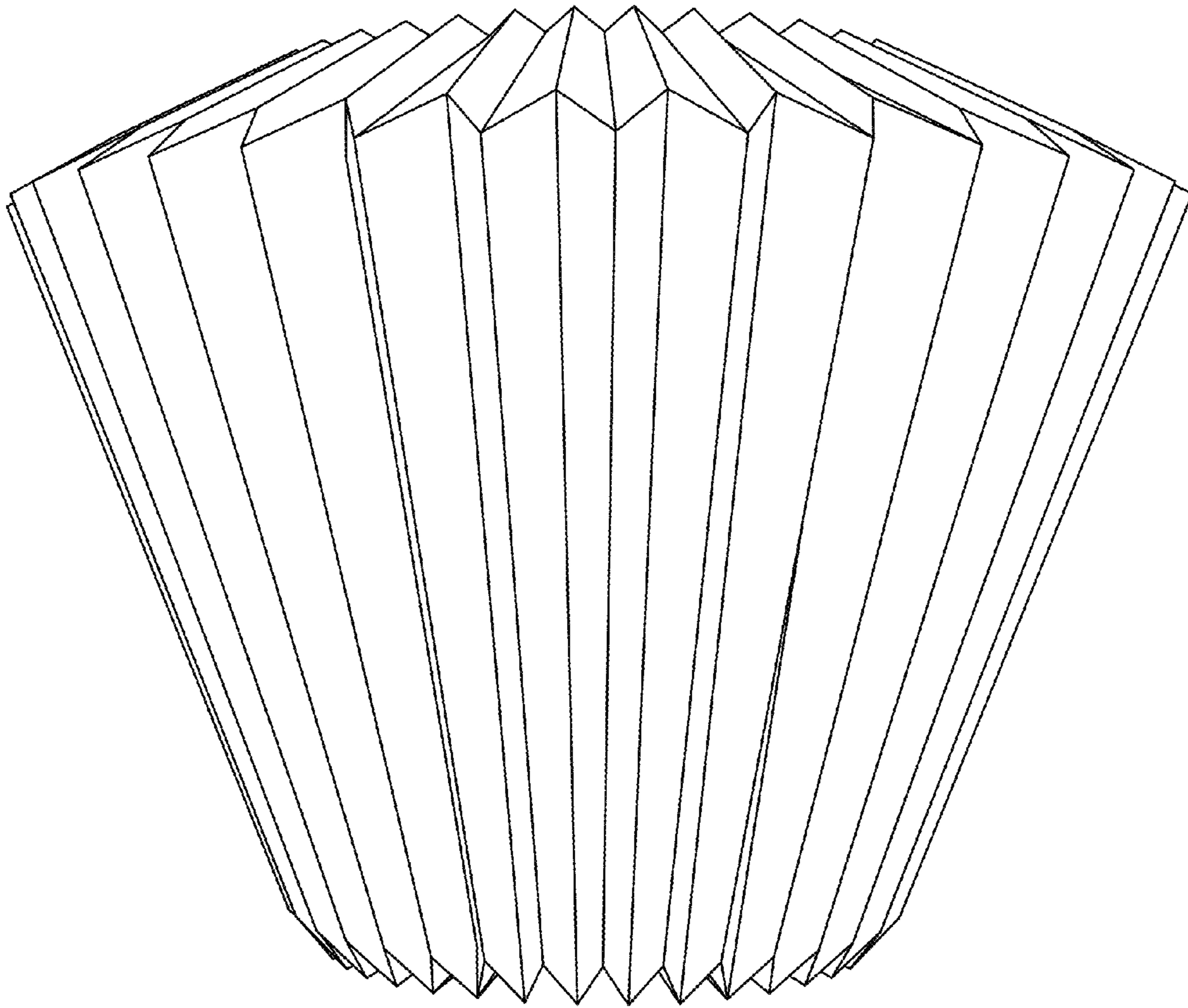

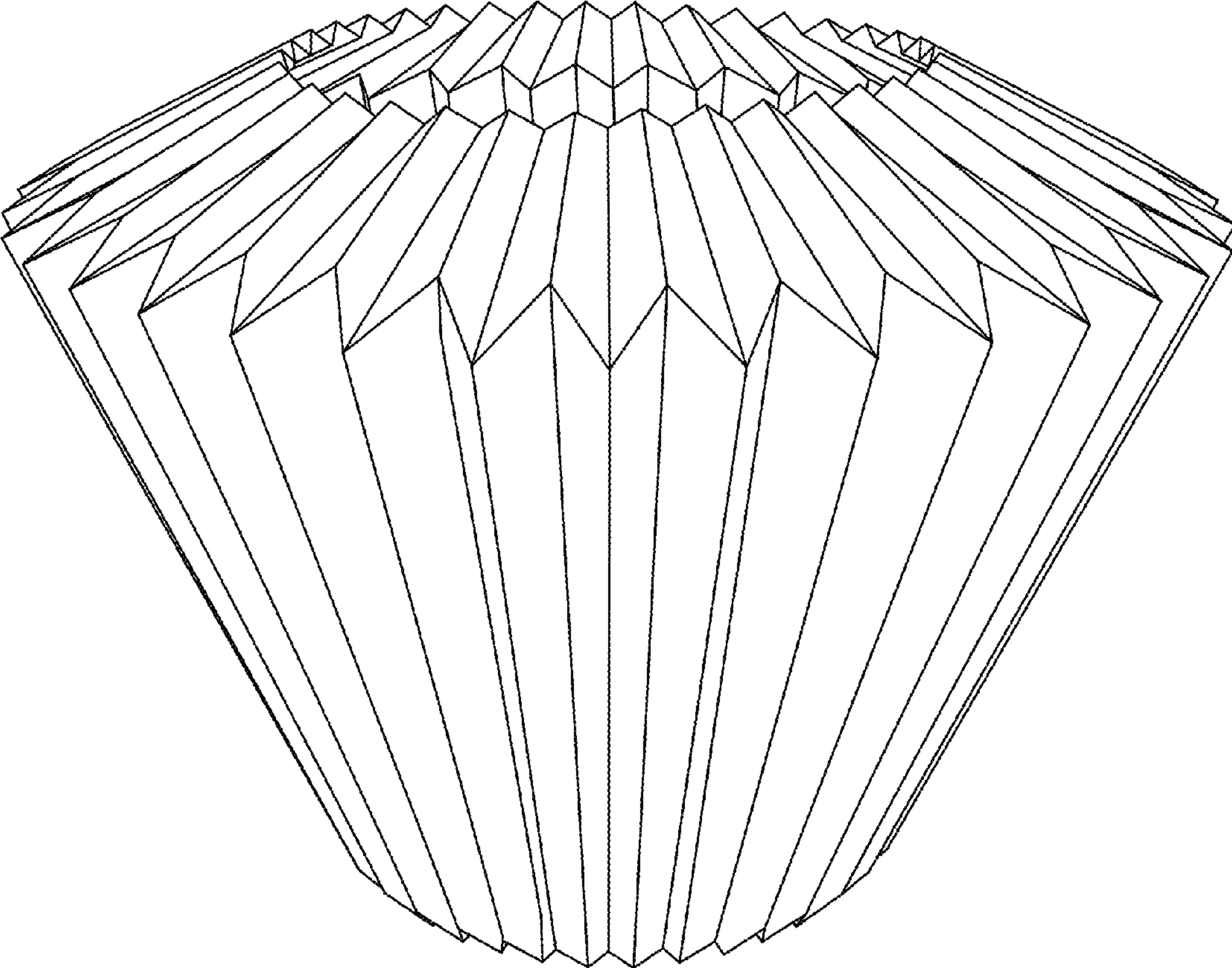

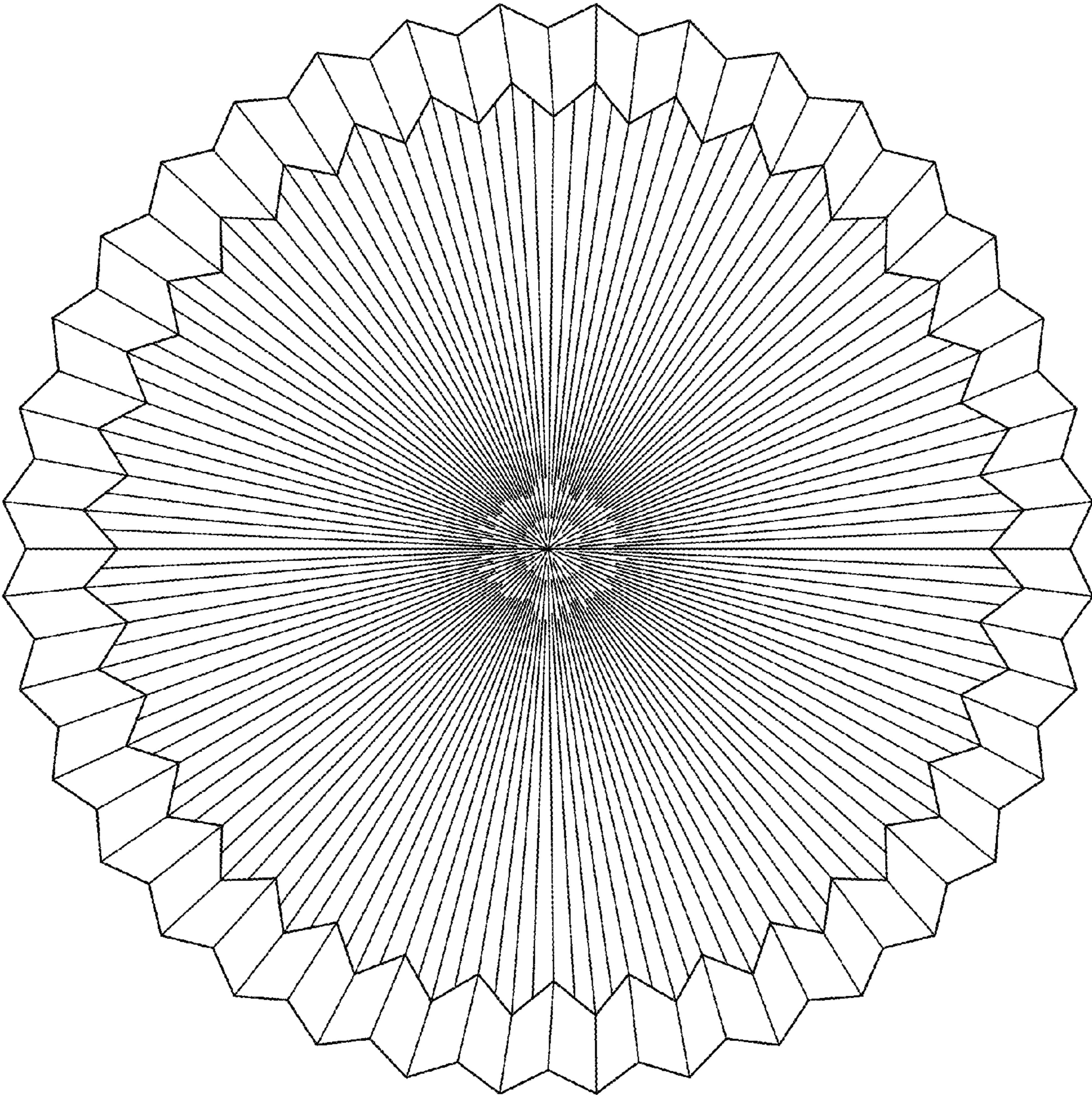

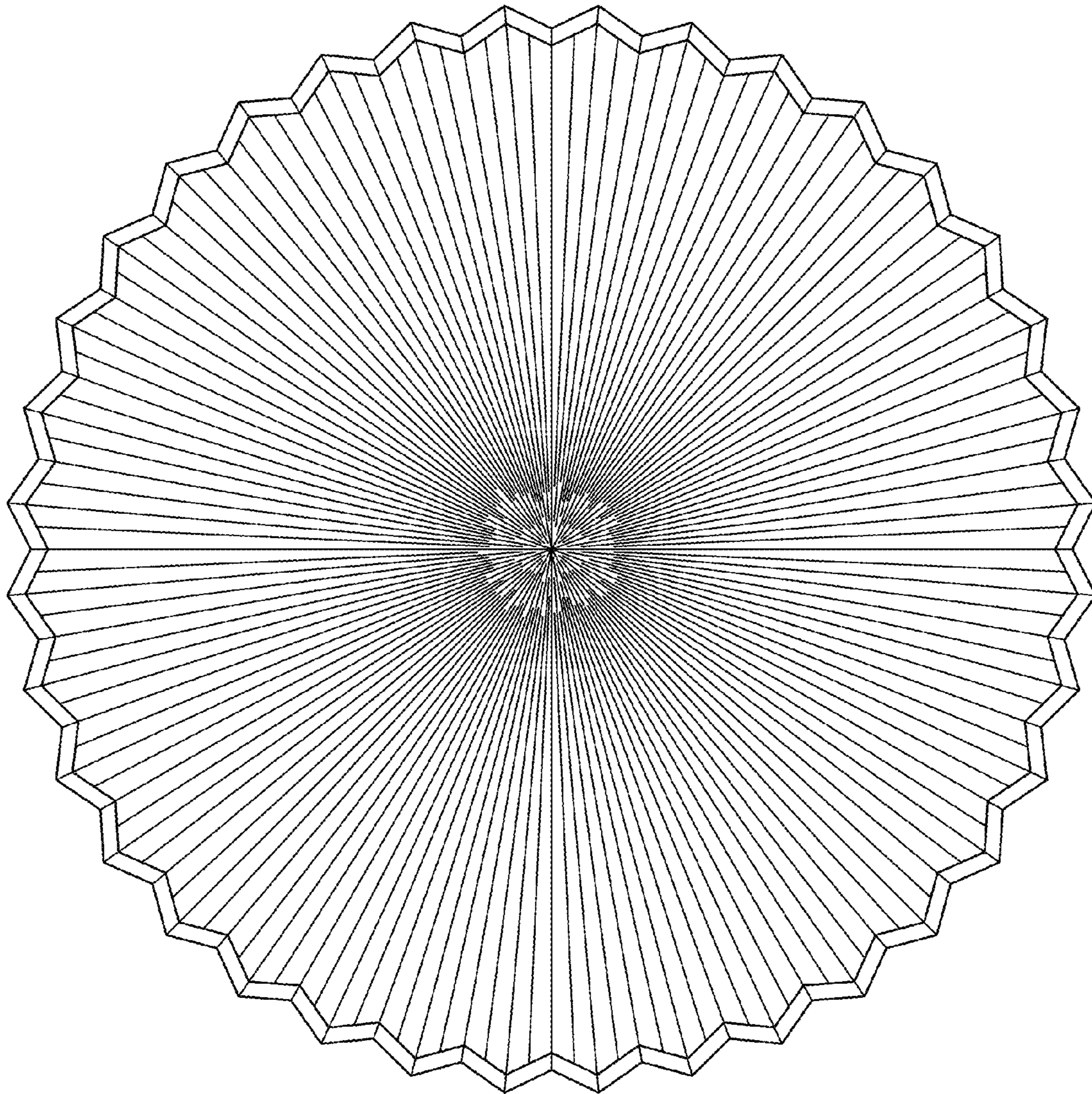

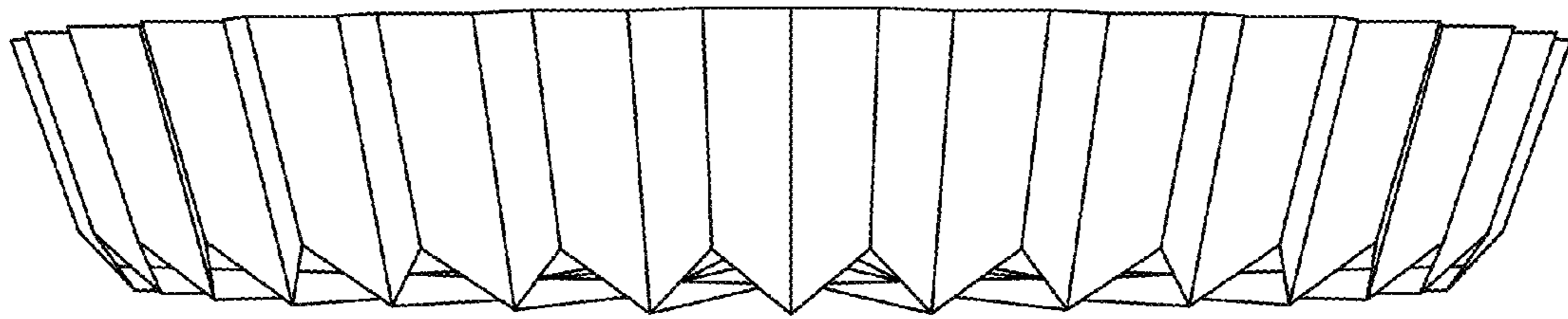

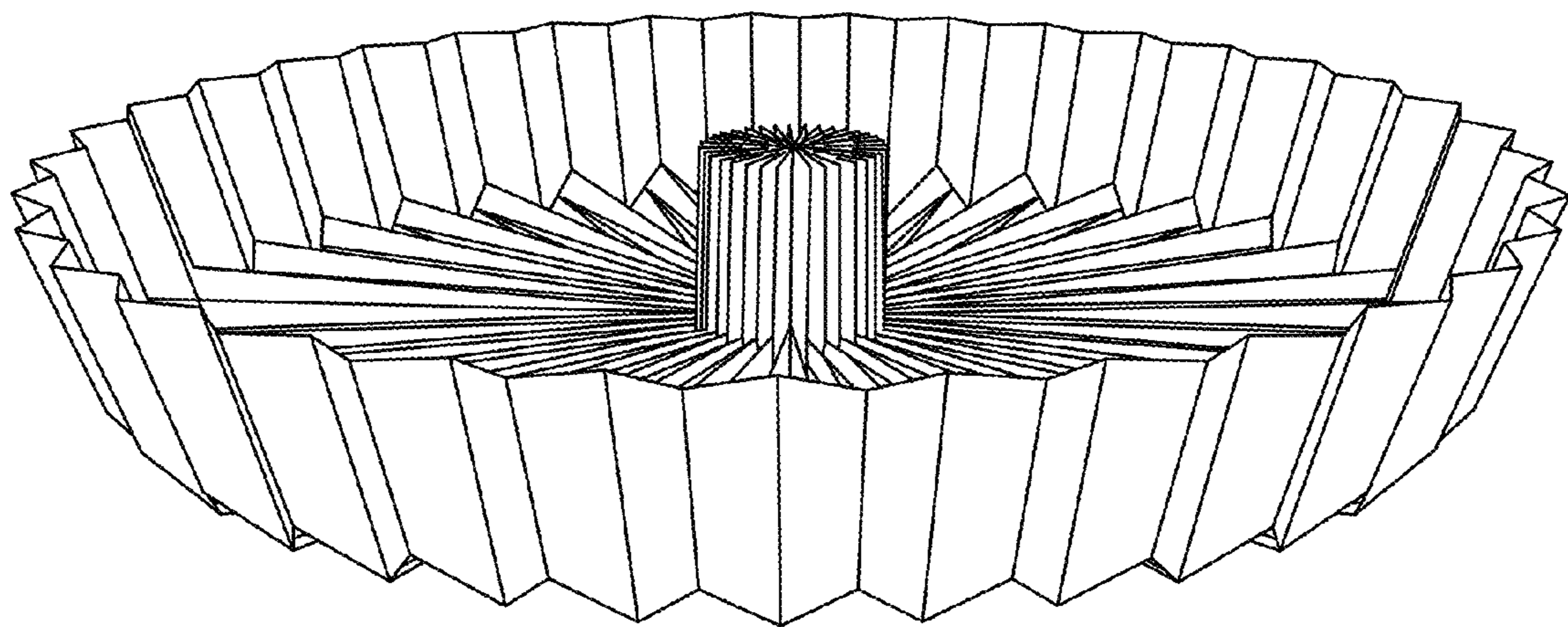
