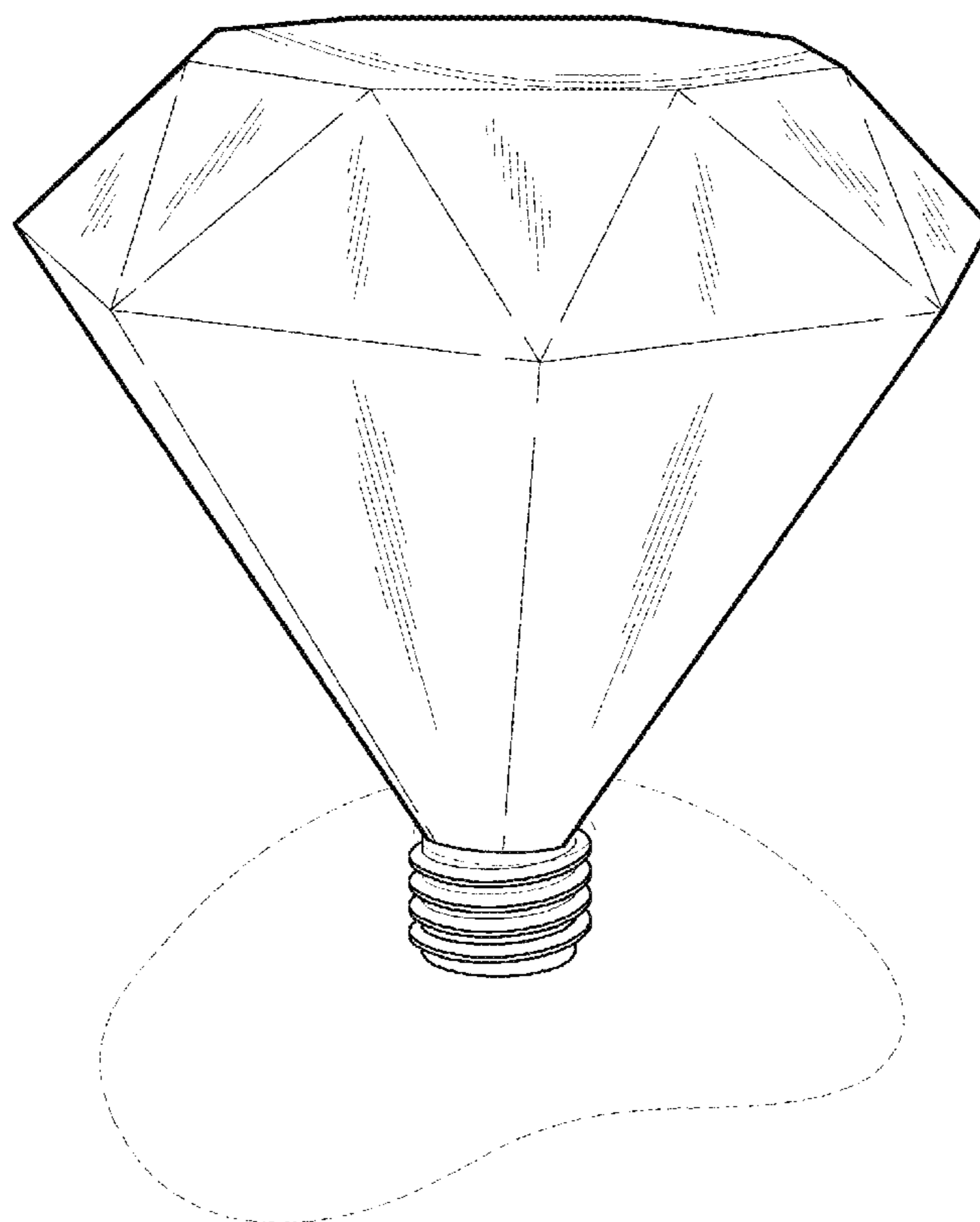

The ornamental design for a diamond shaped bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a diamond shaped bottle in accordance with the present invention;
FIG. 2 is a side view of the diamond shaped bottle of FIG. 1;
FIG. 3 is a top view of the diamond shaped bottle of FIG. 1; and,
FIG. 4 is a bottom view of the diamond shaped bottle of FIG. 1.

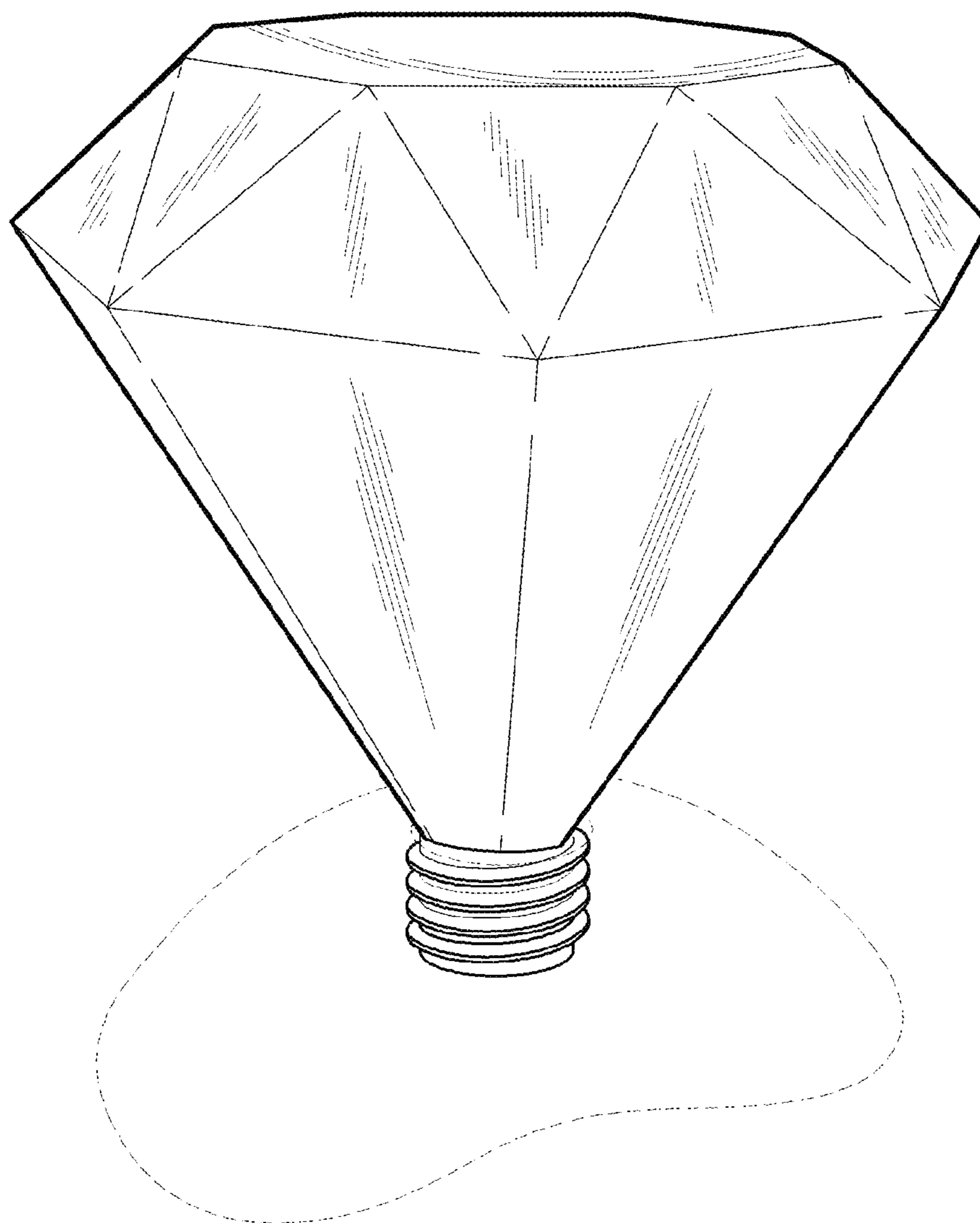

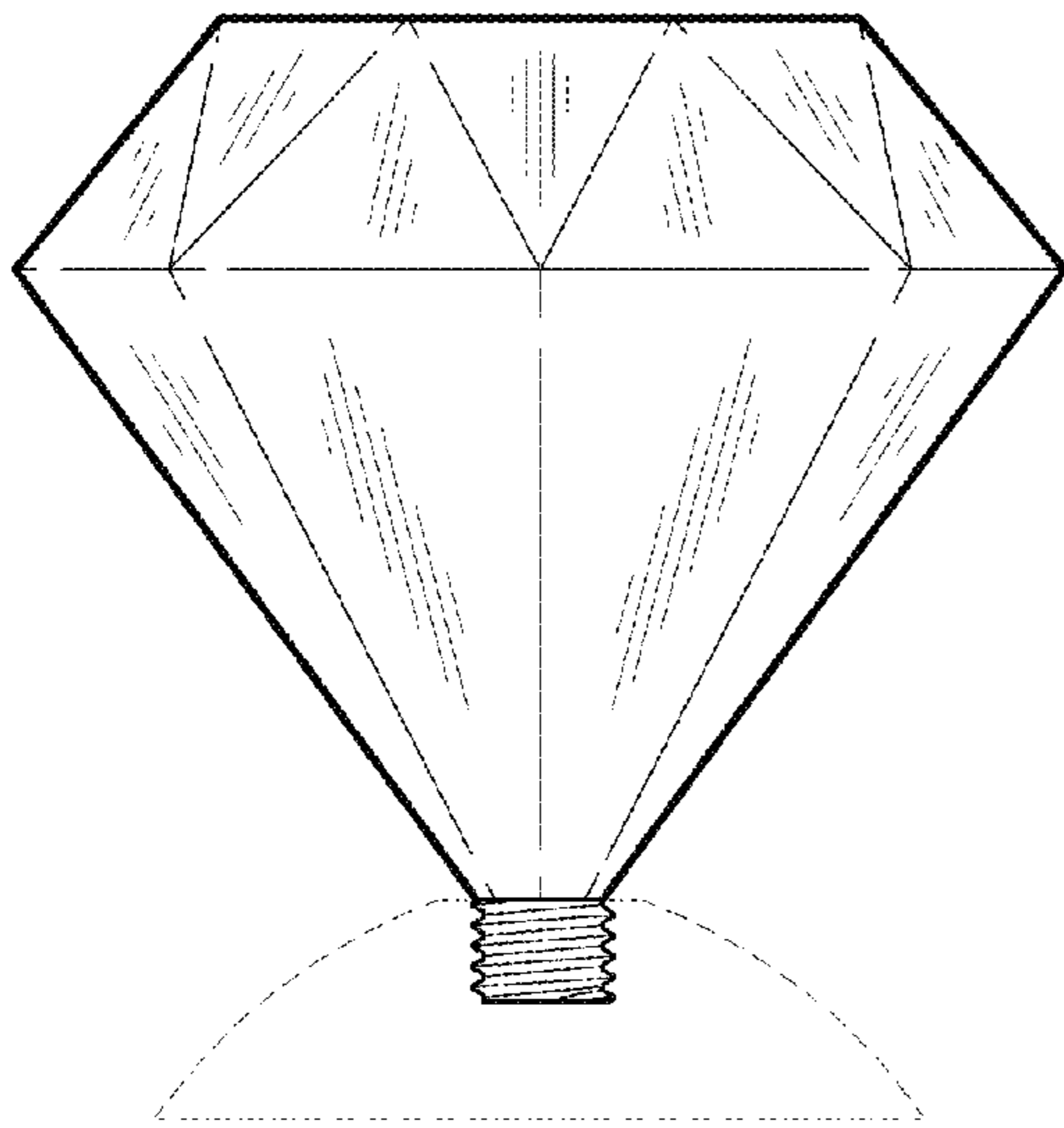

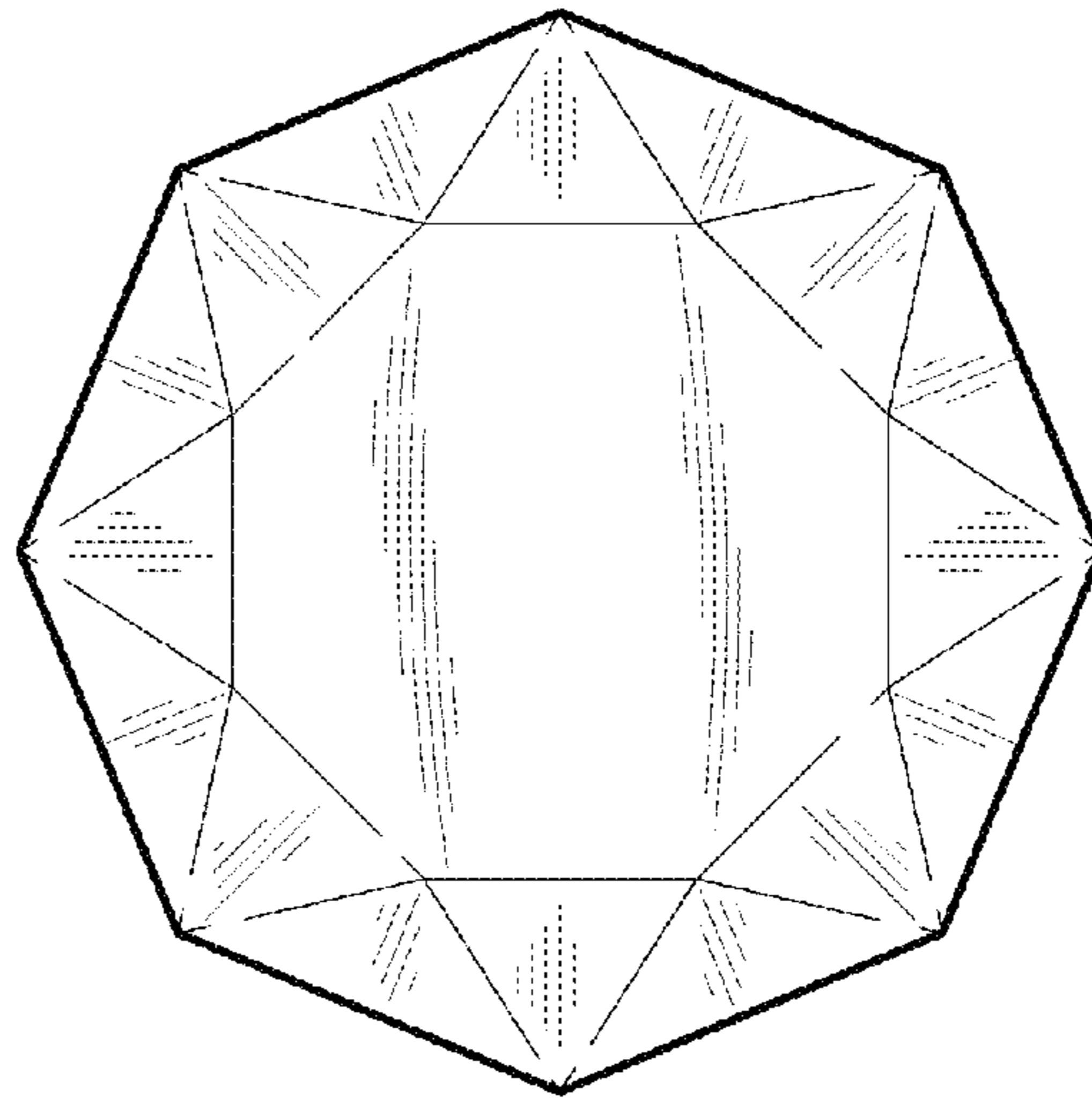

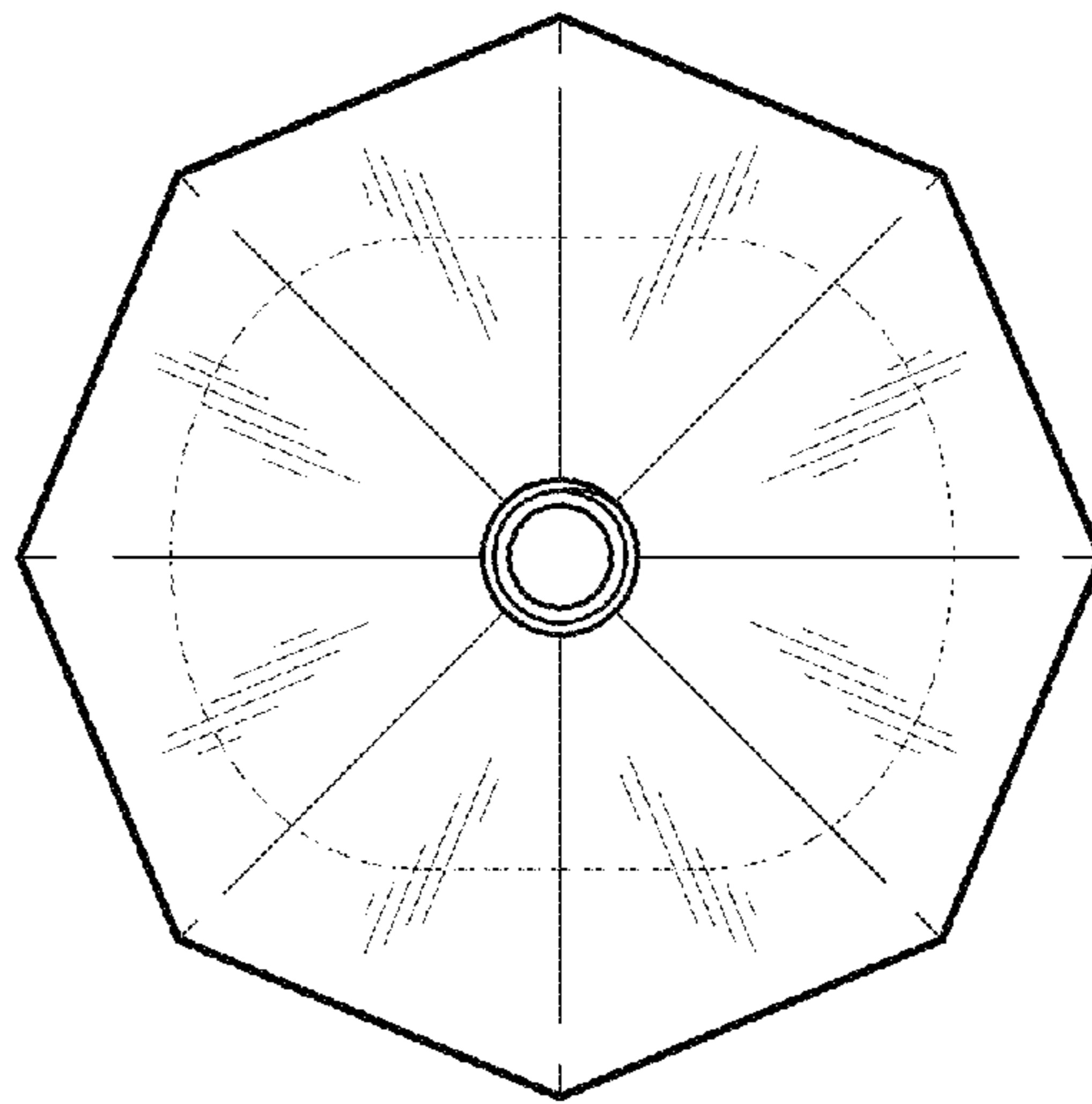
