DESCRIPTION

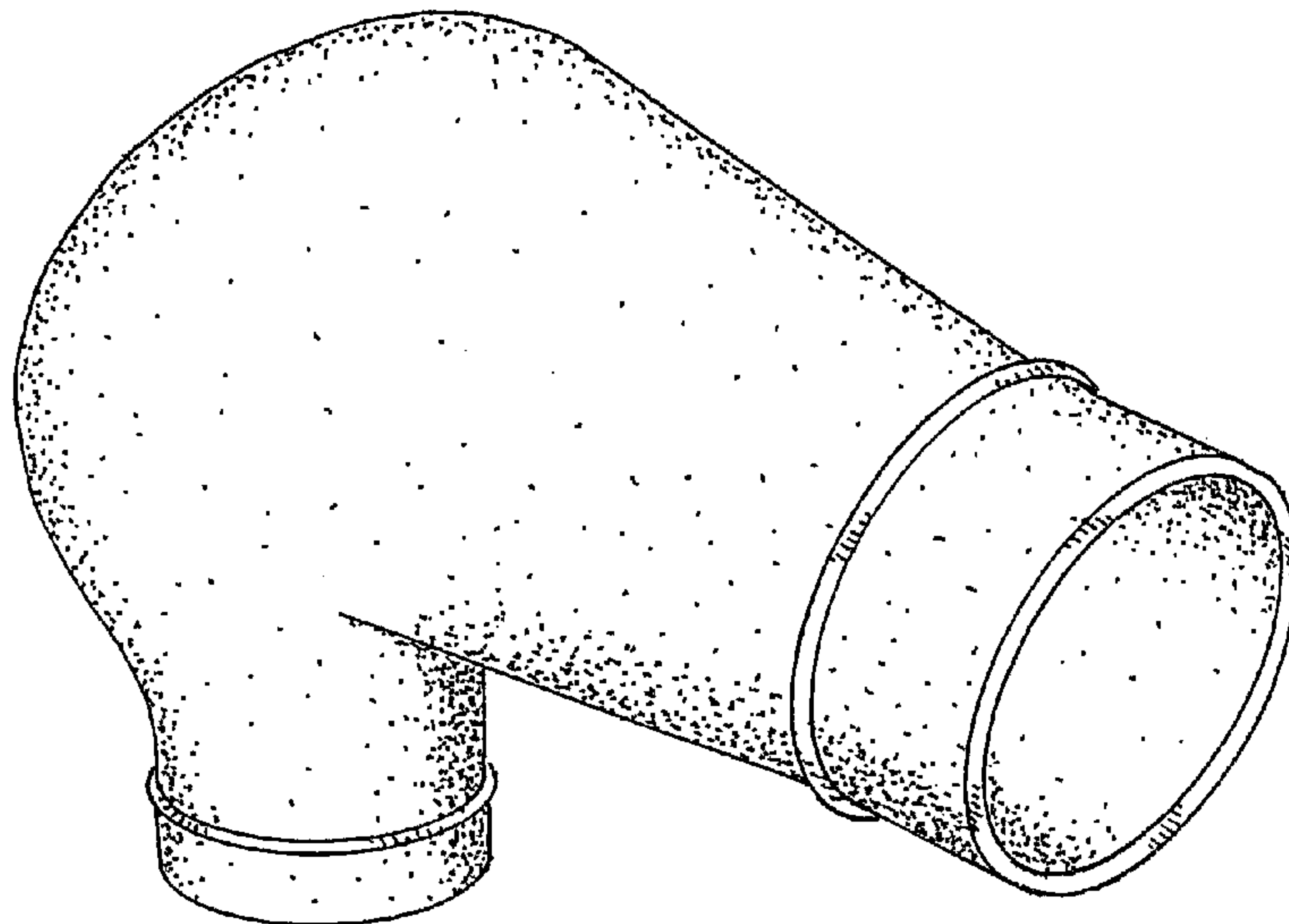
FIG. 1 is a perspective view of an air filter elbow showing our design;

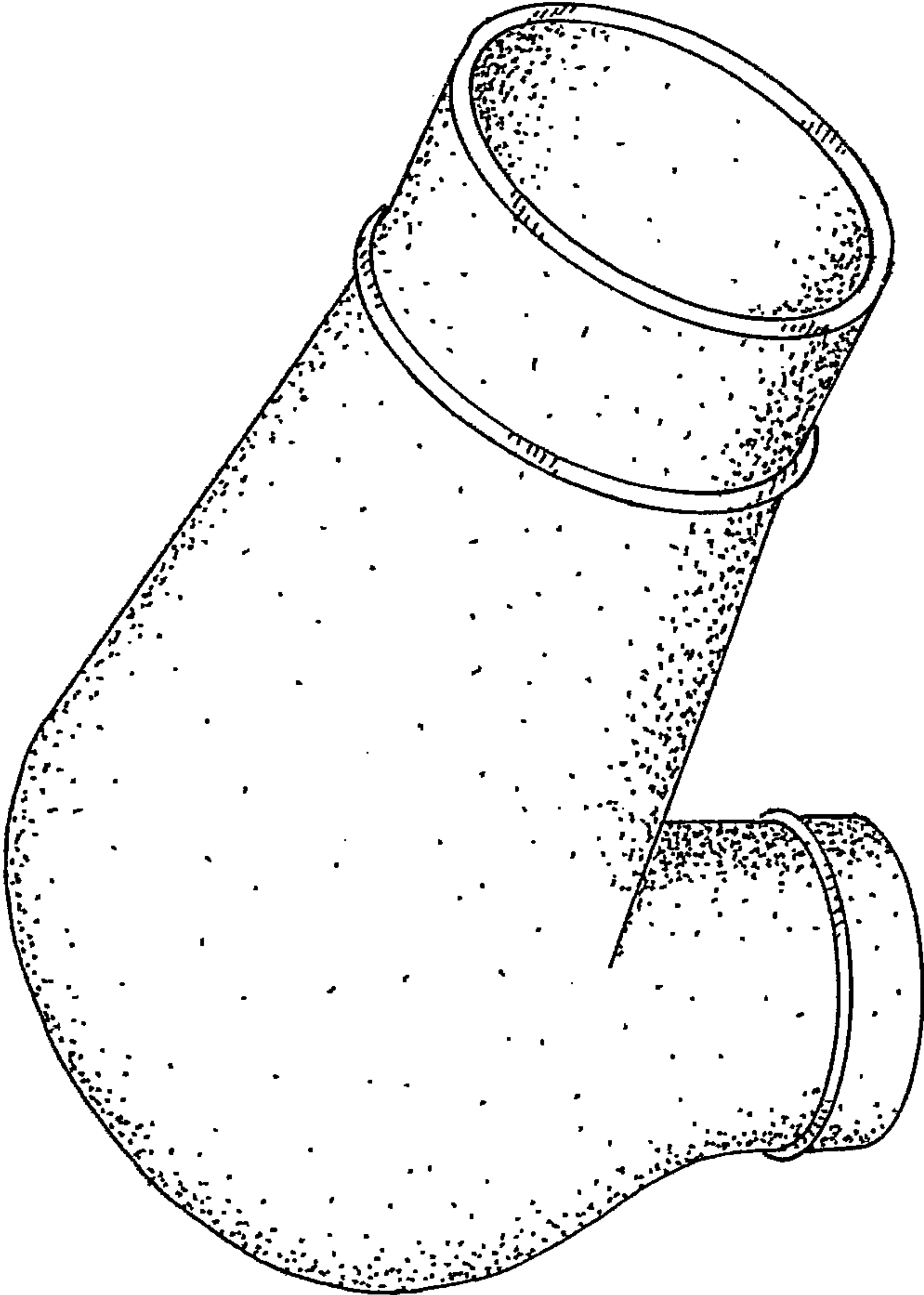

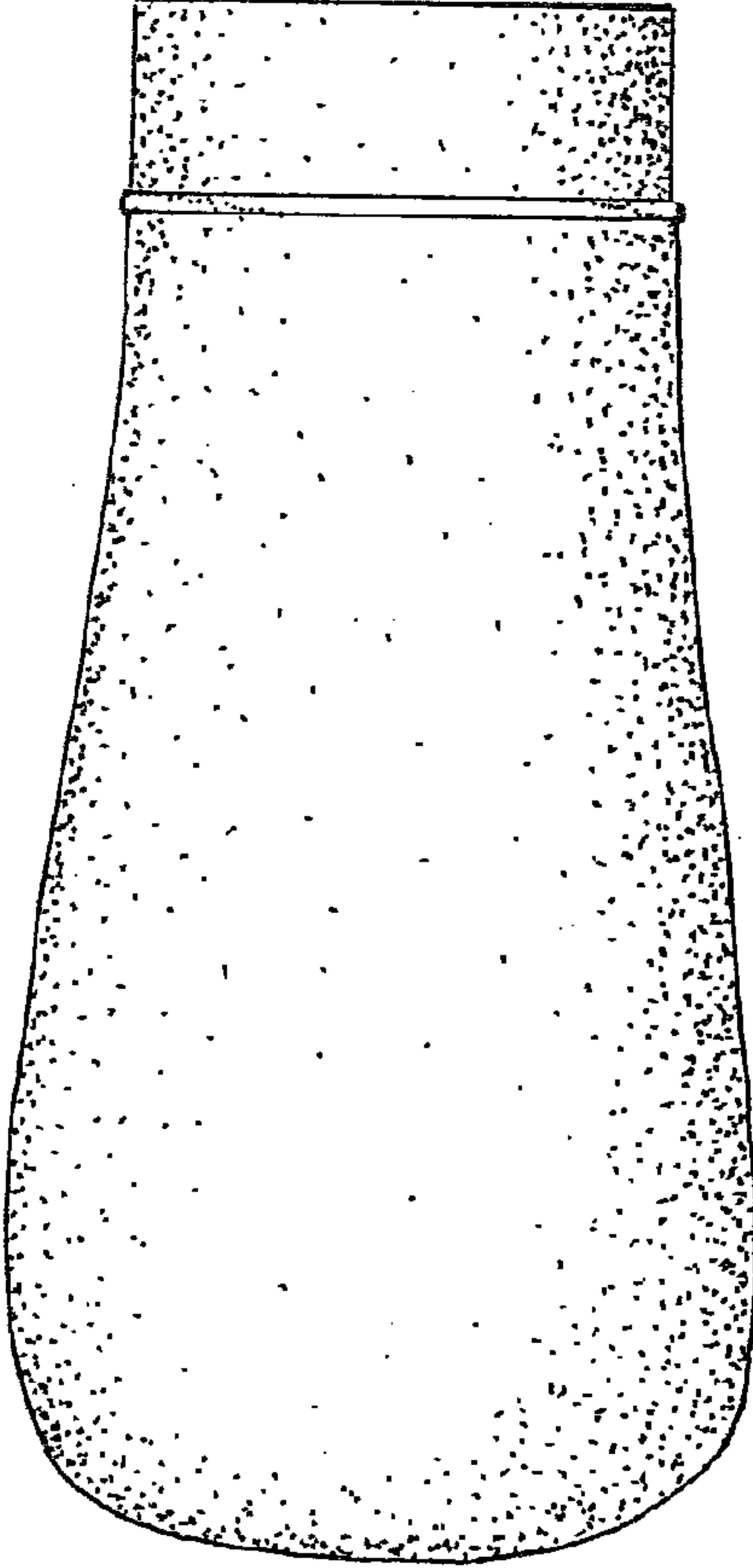

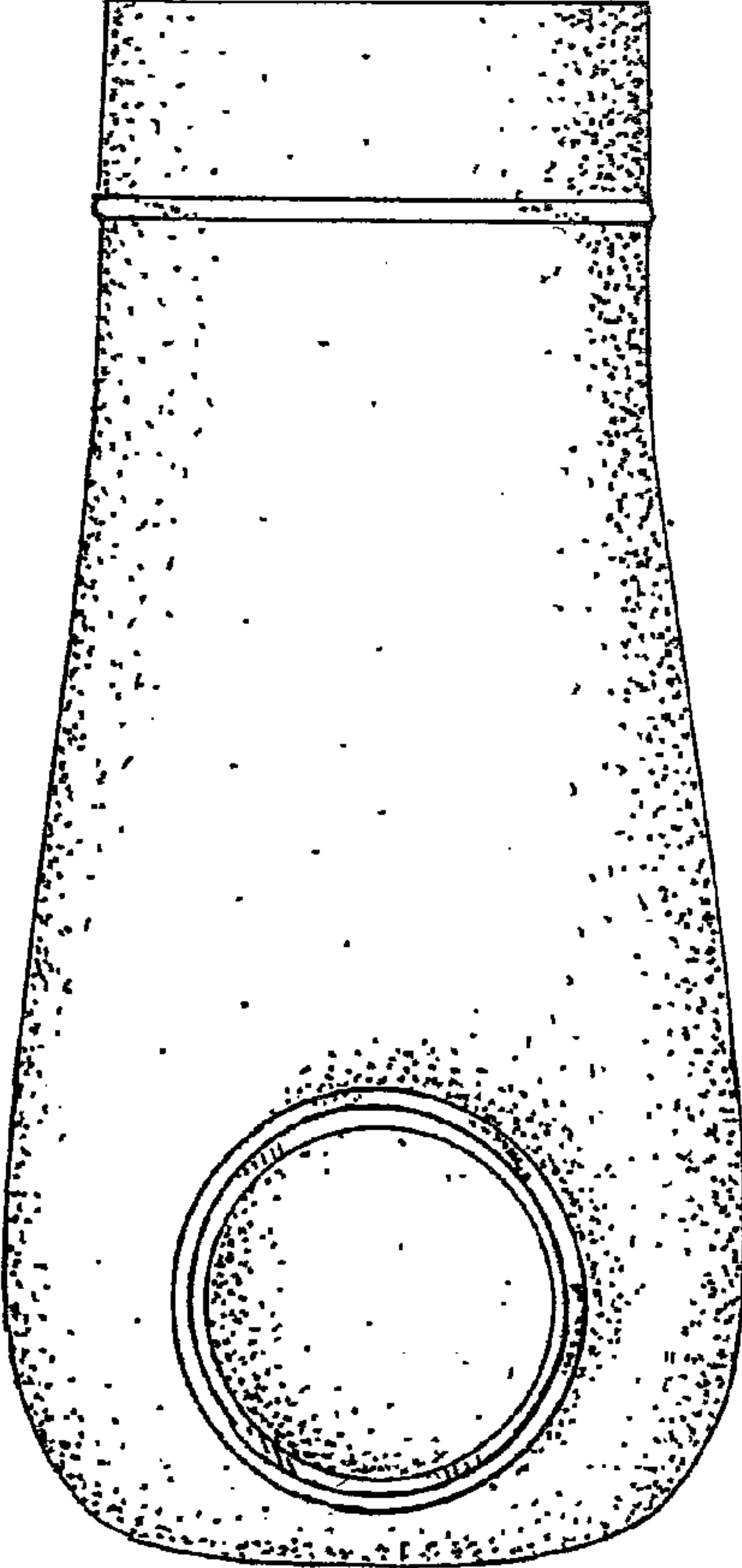

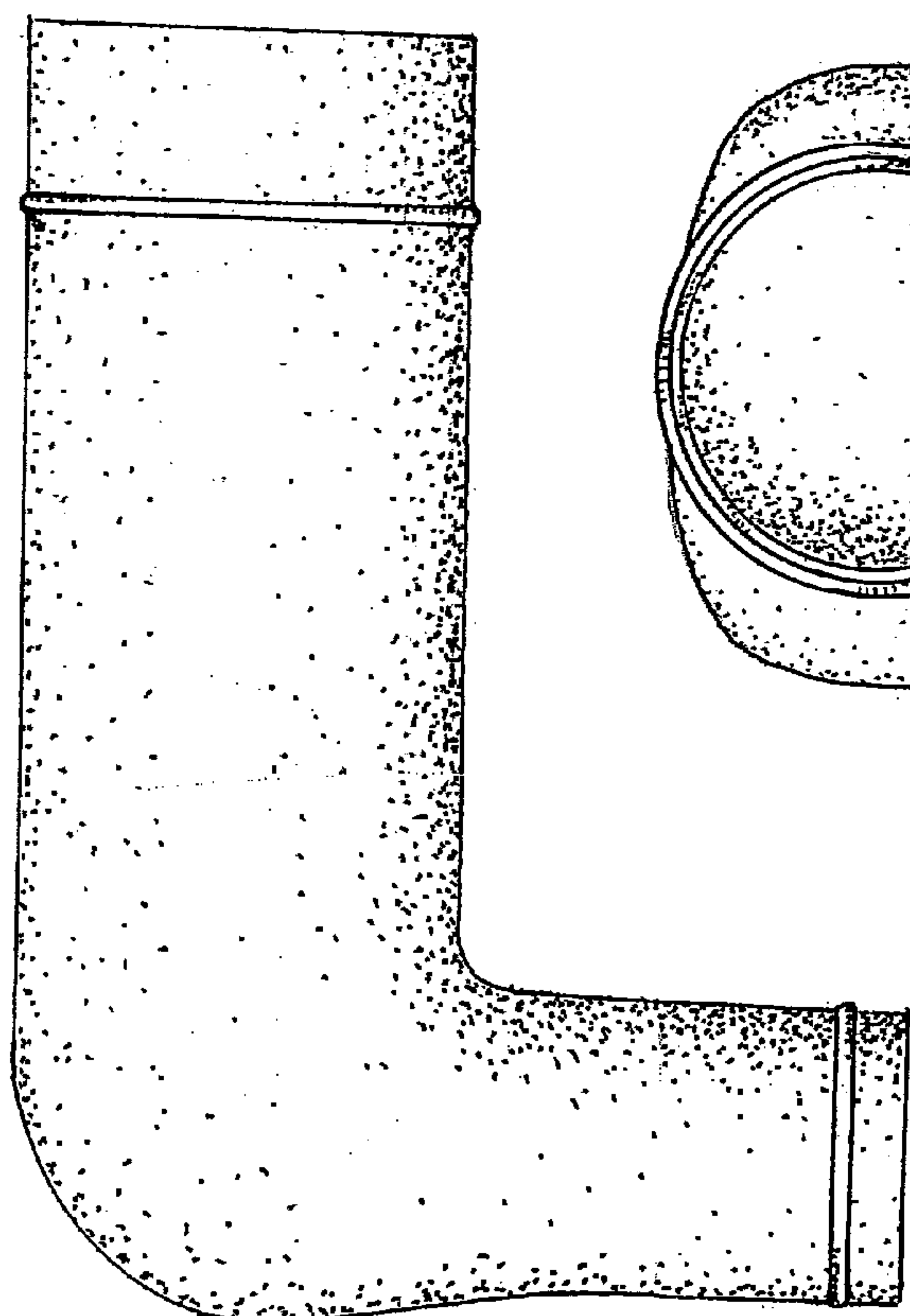

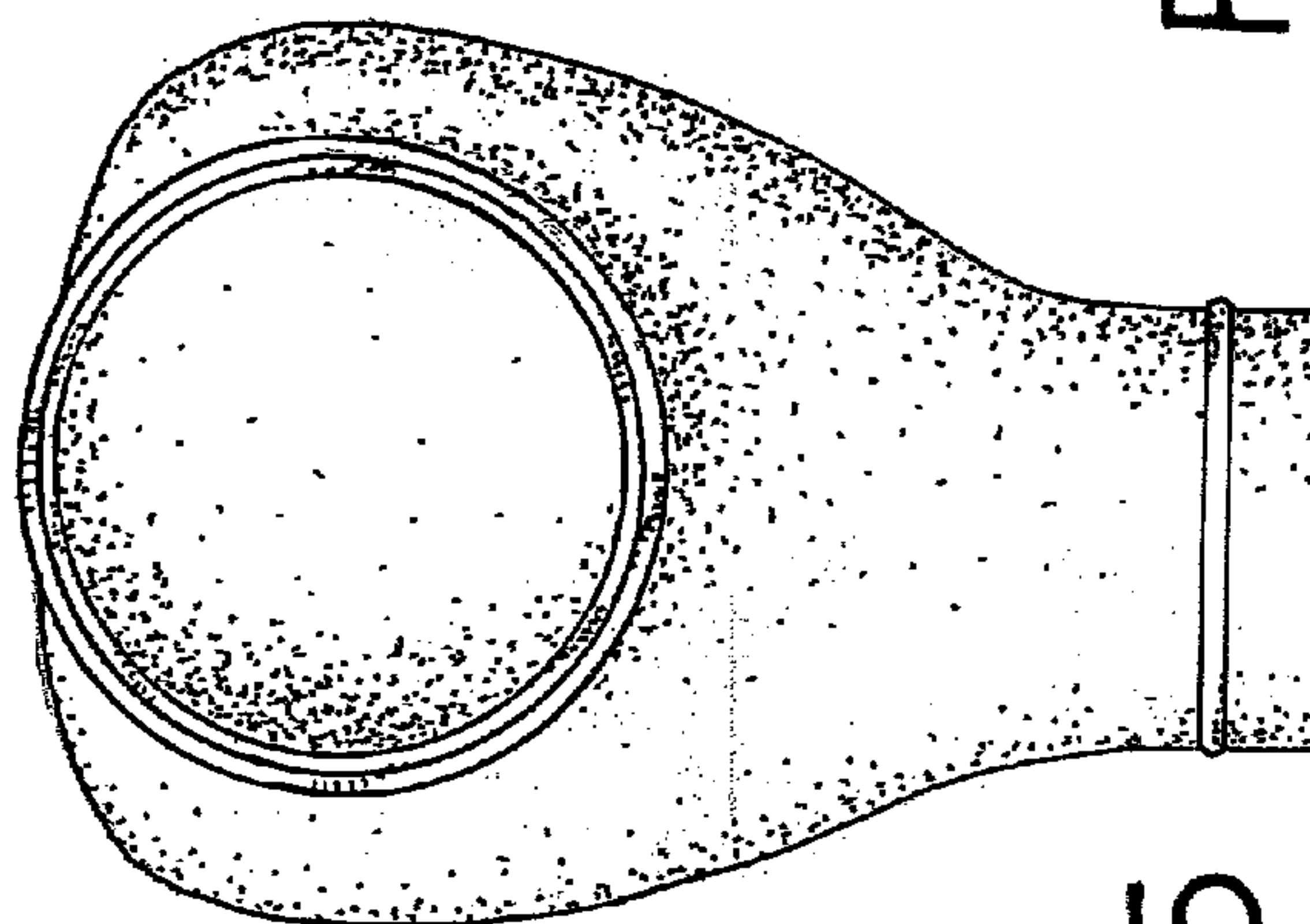

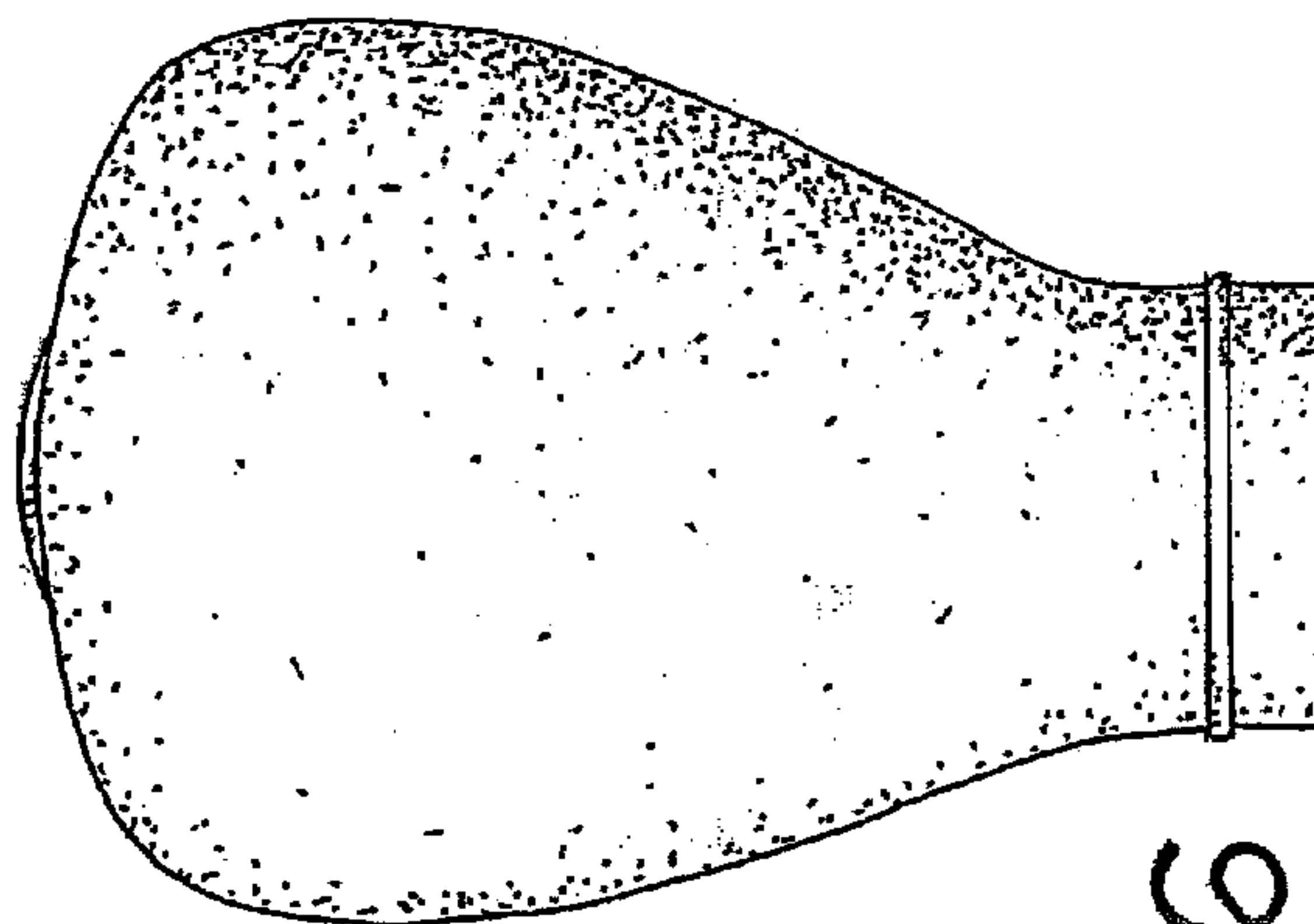
