elongated slots of FIG. 1.

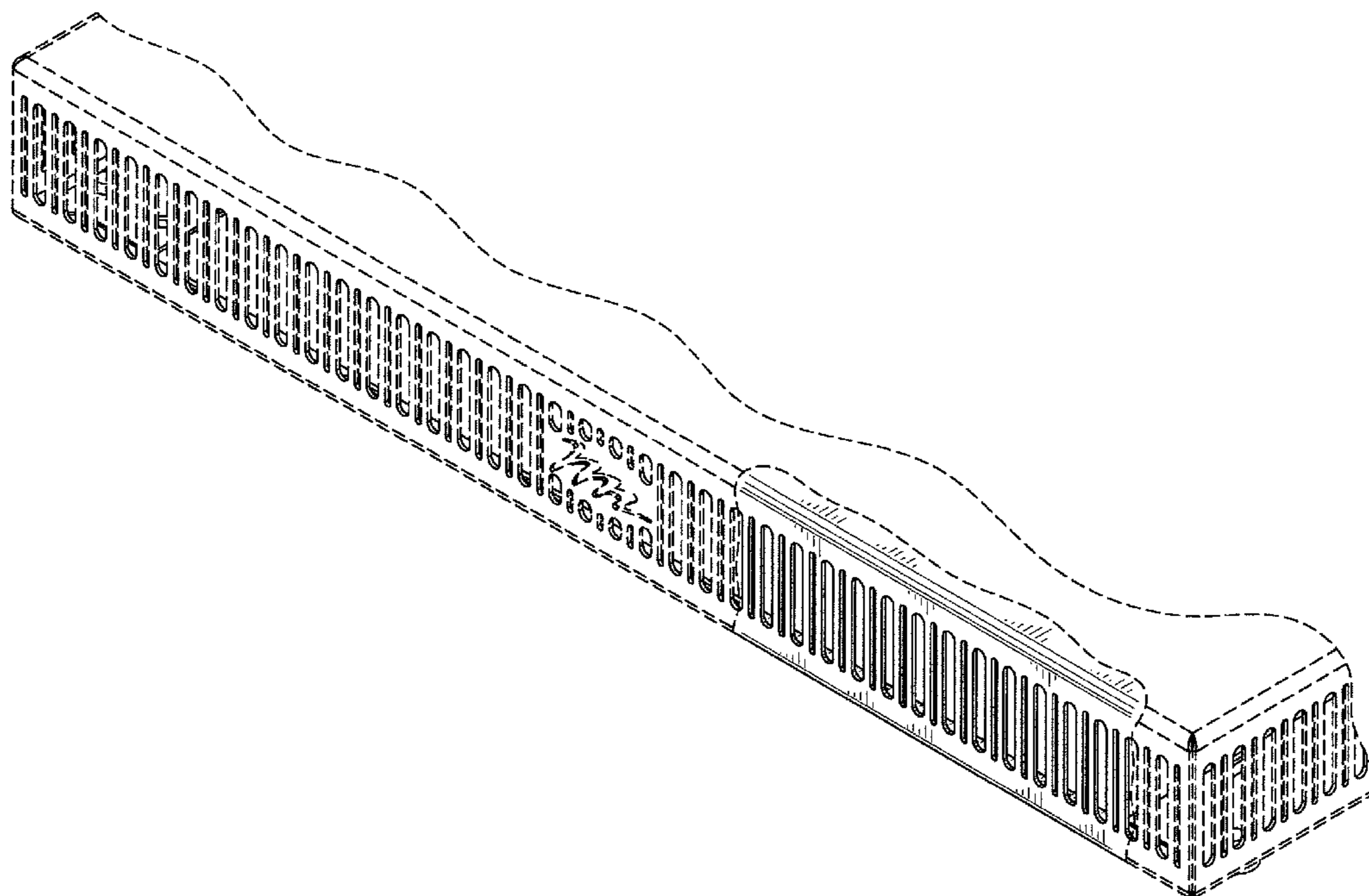

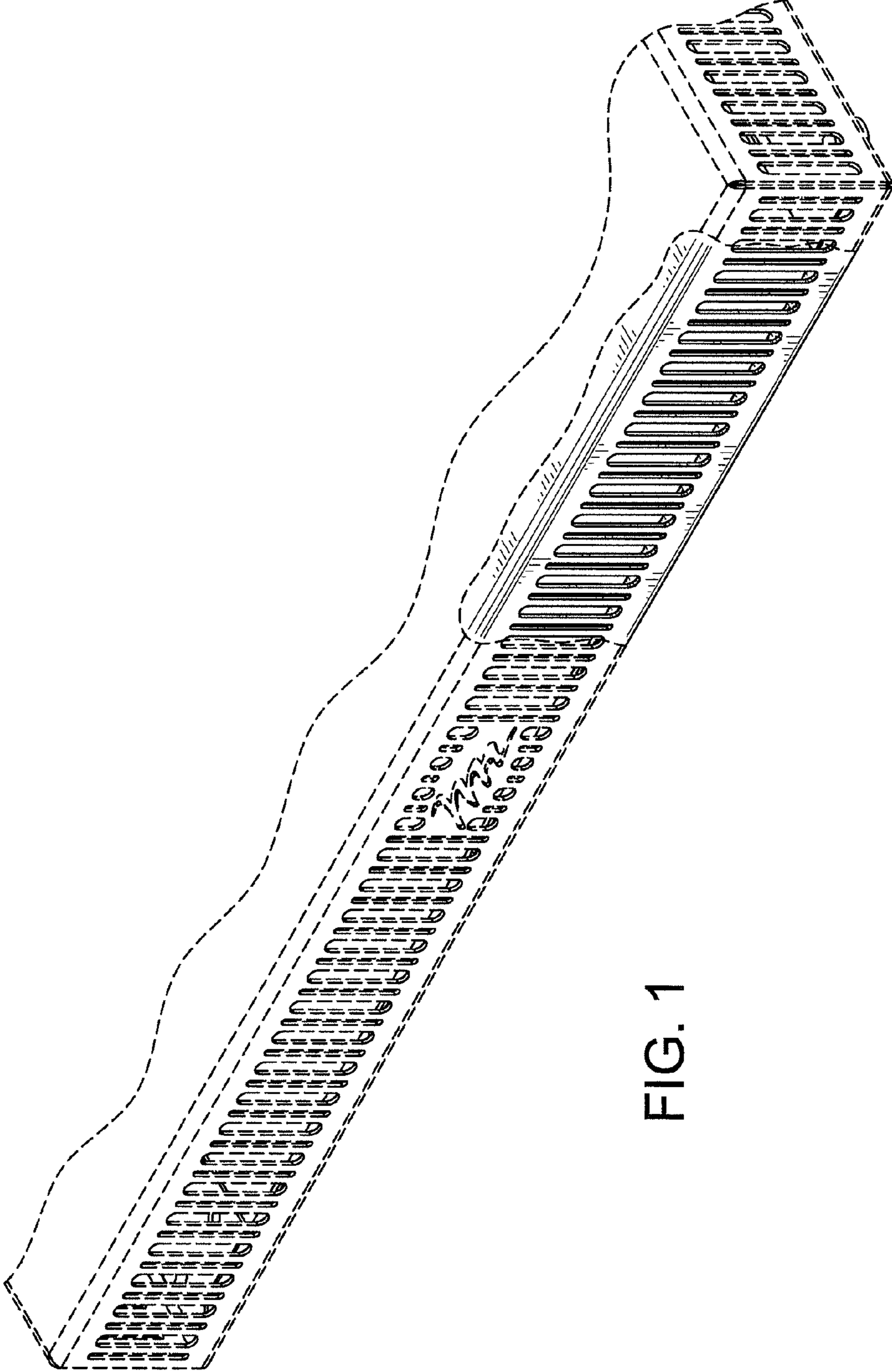

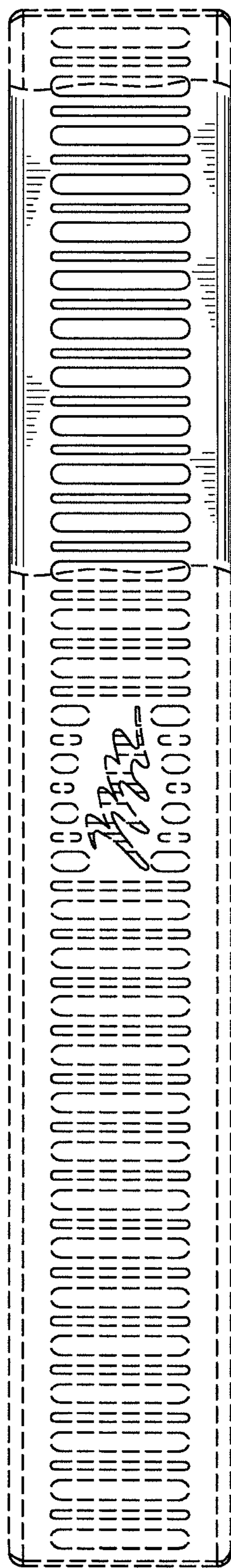

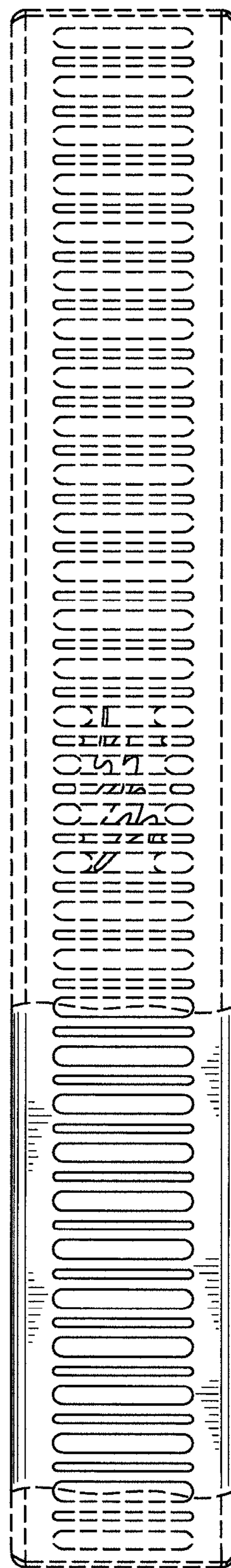

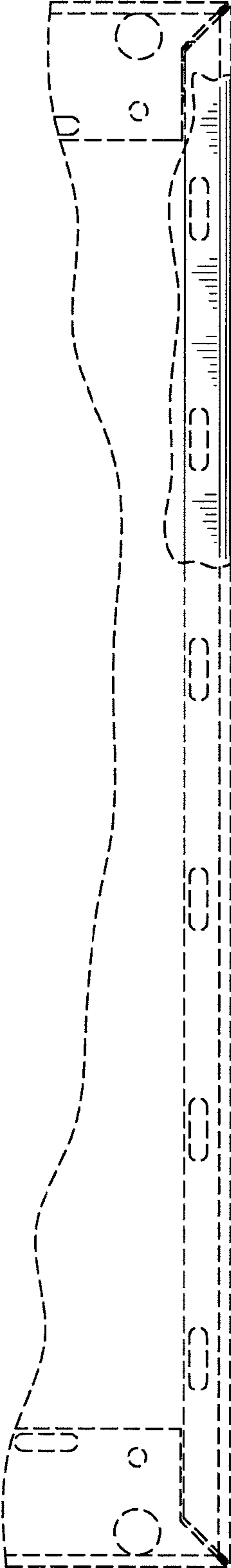

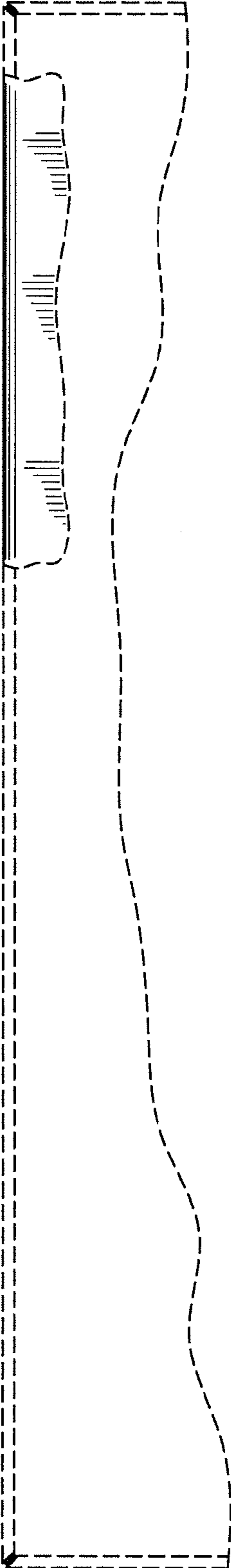

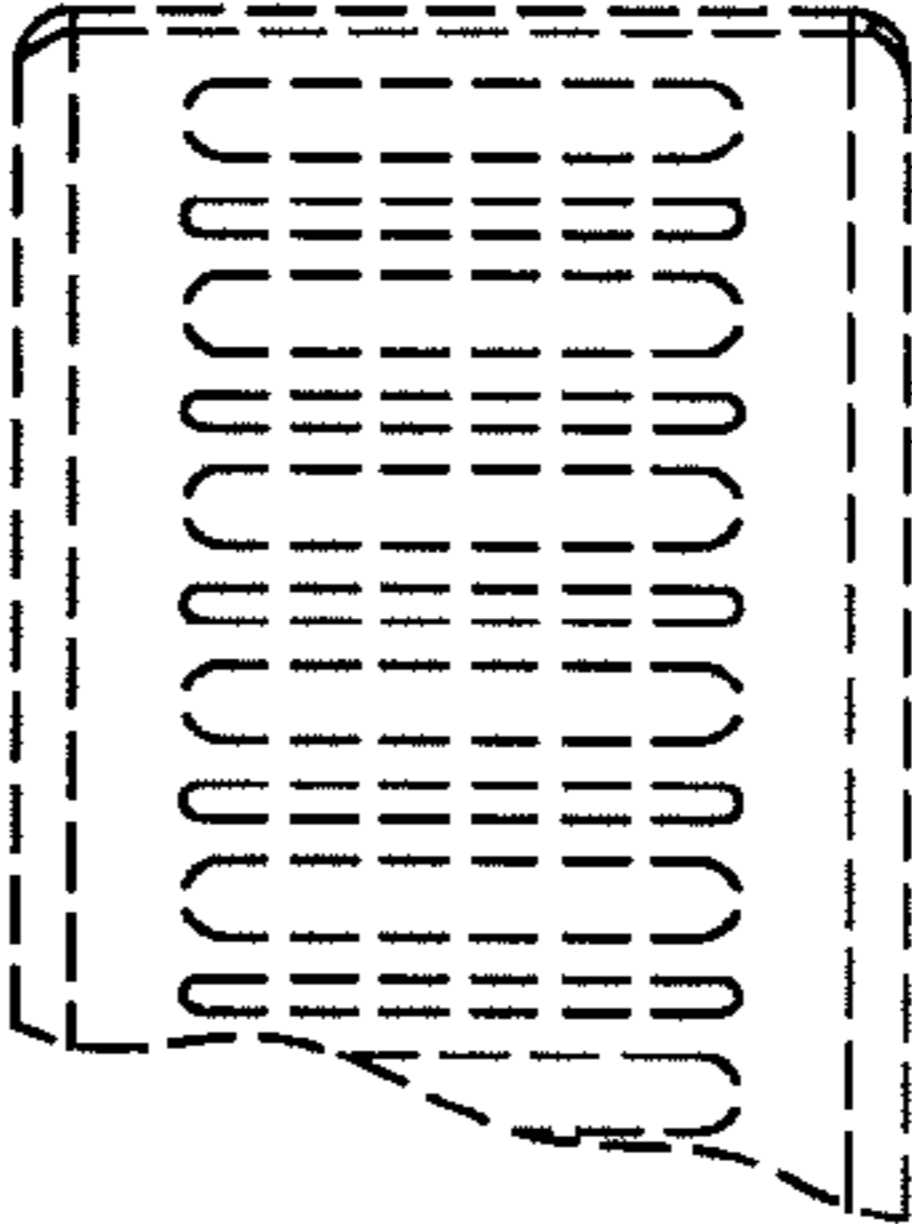

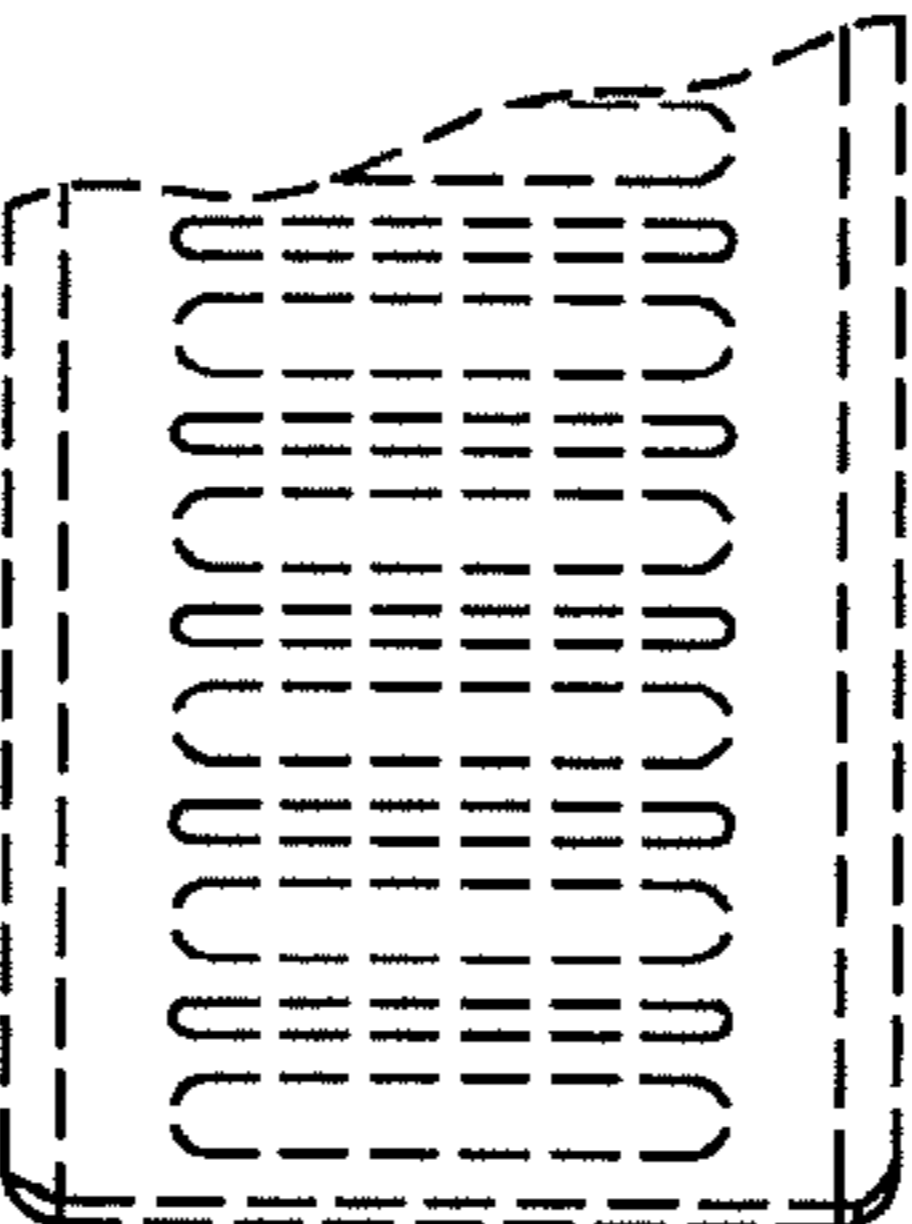
