FIG. 2 is a front view of another embodiment of a display screen or portion thereof with graphical user interface showing our new design;

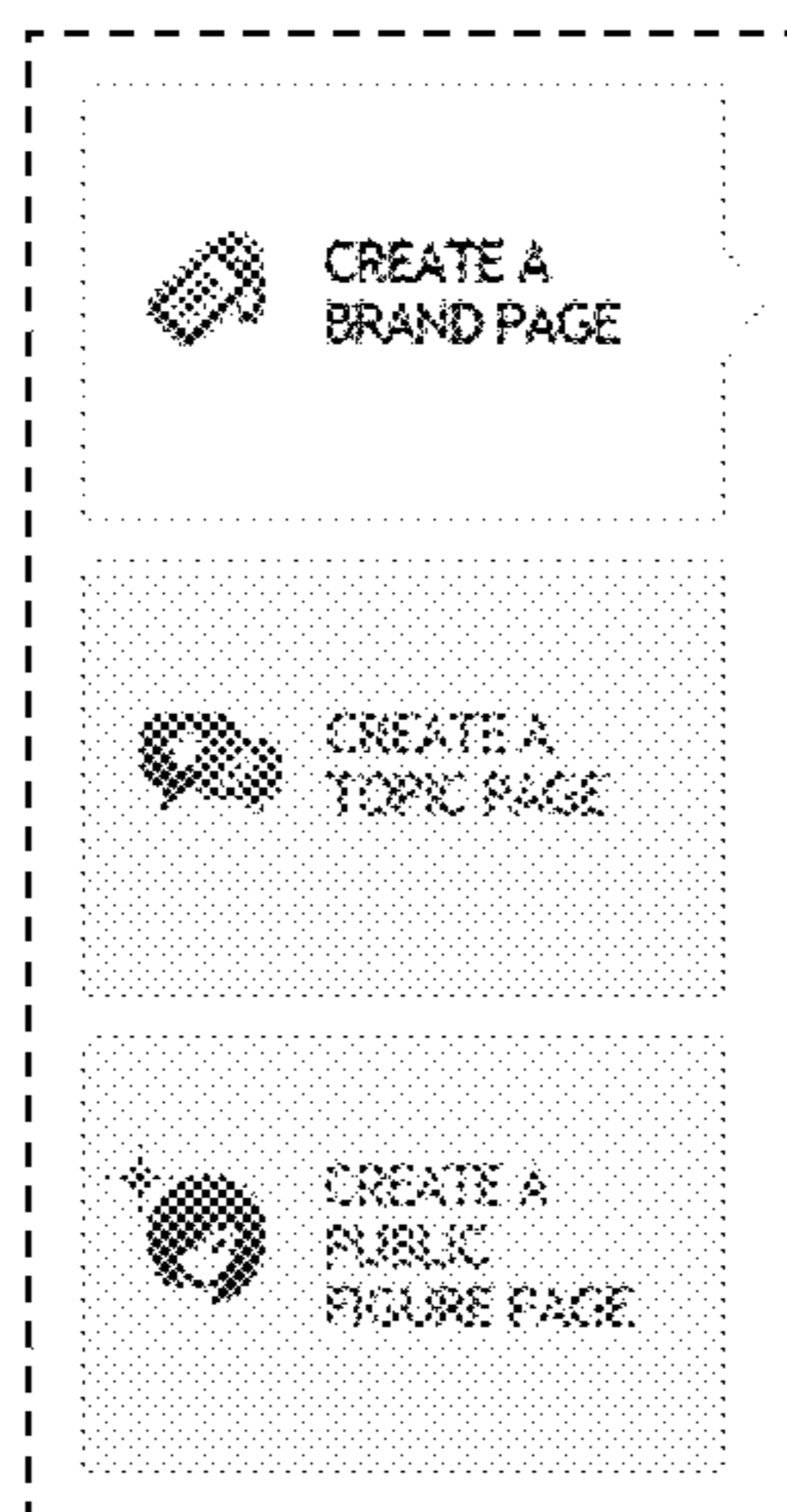
FIG. 3 is a front view of another embodiment of a display screen or portion thereof with graphical user interface showing our new design;

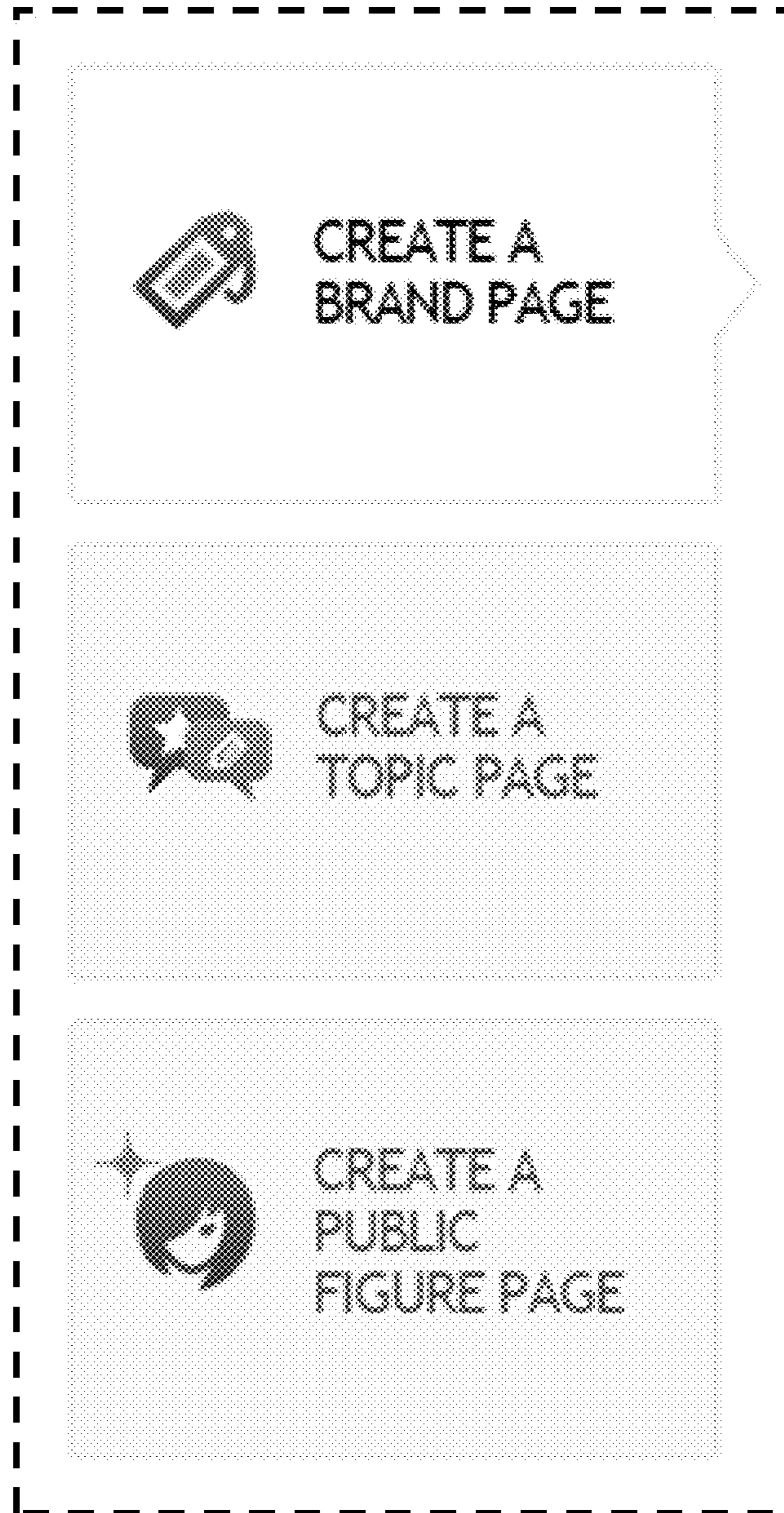

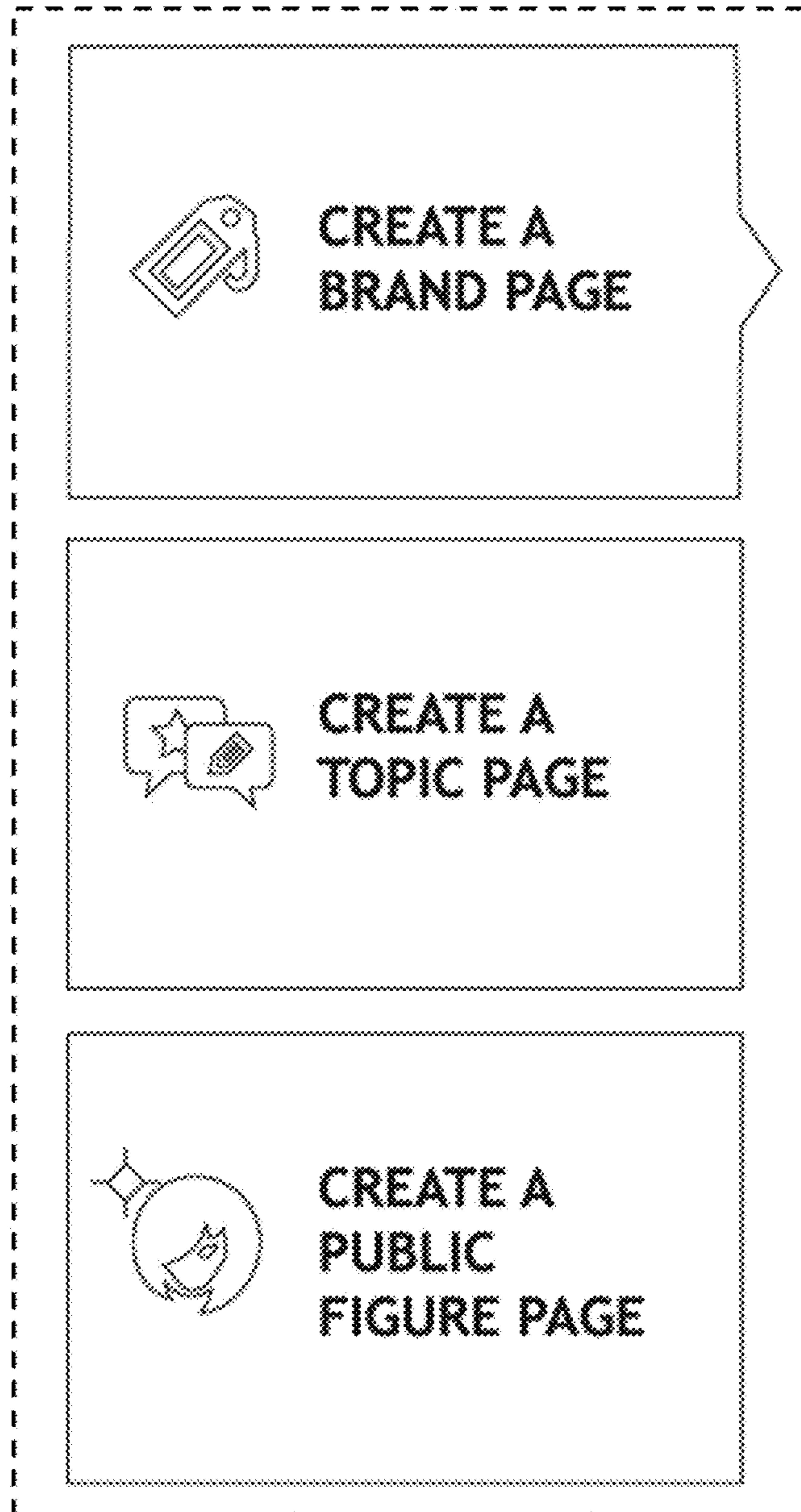

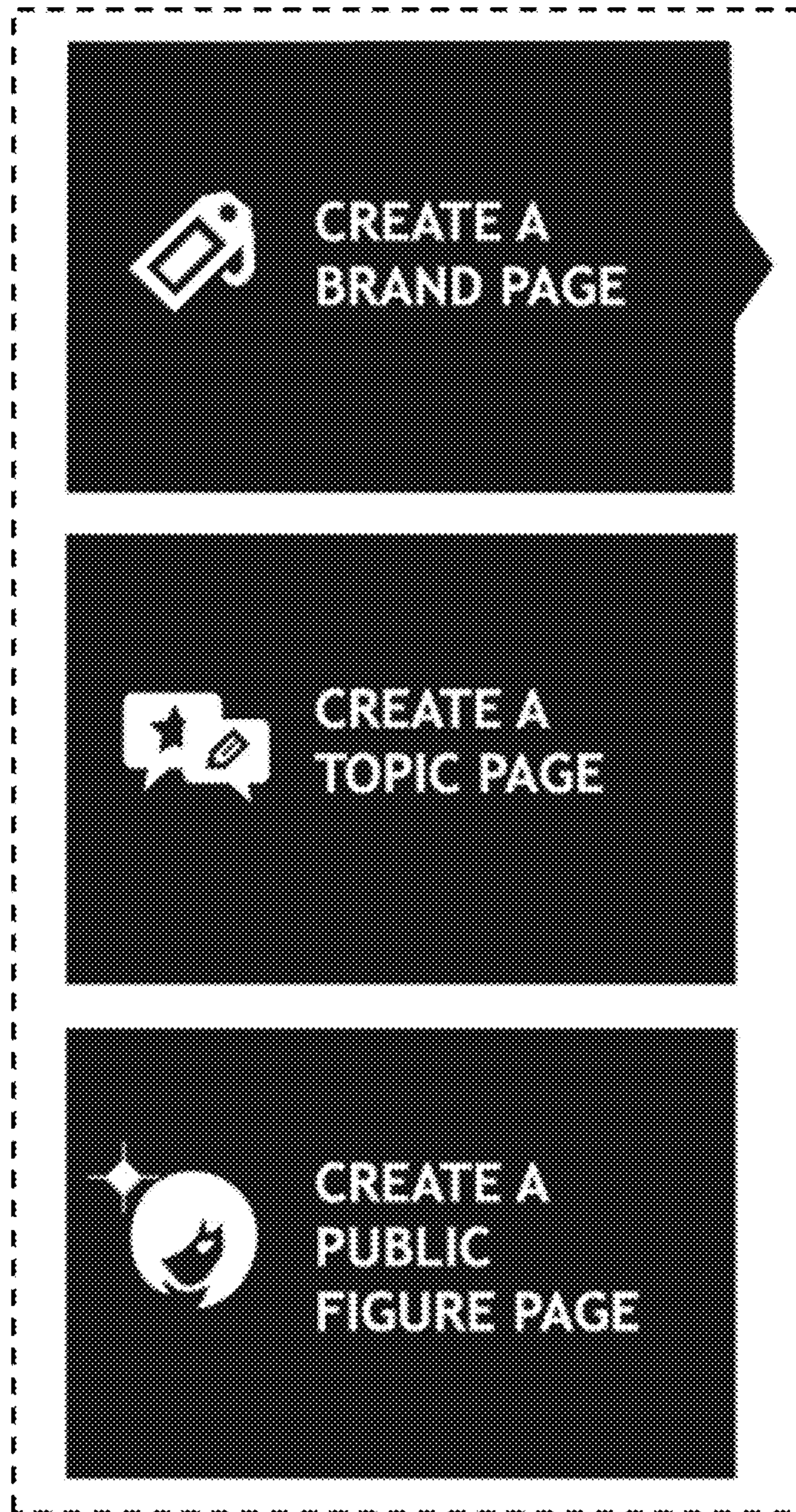

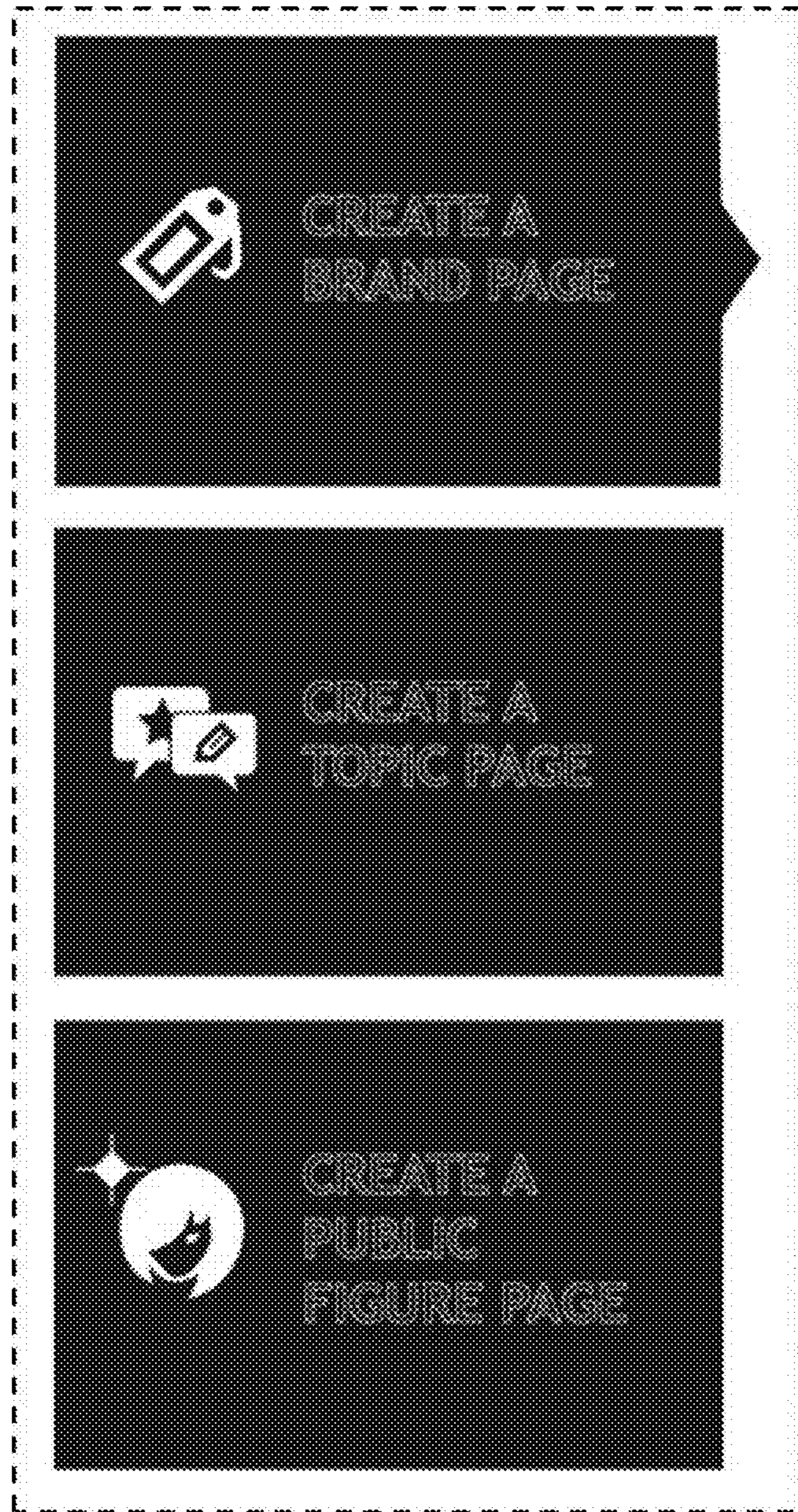

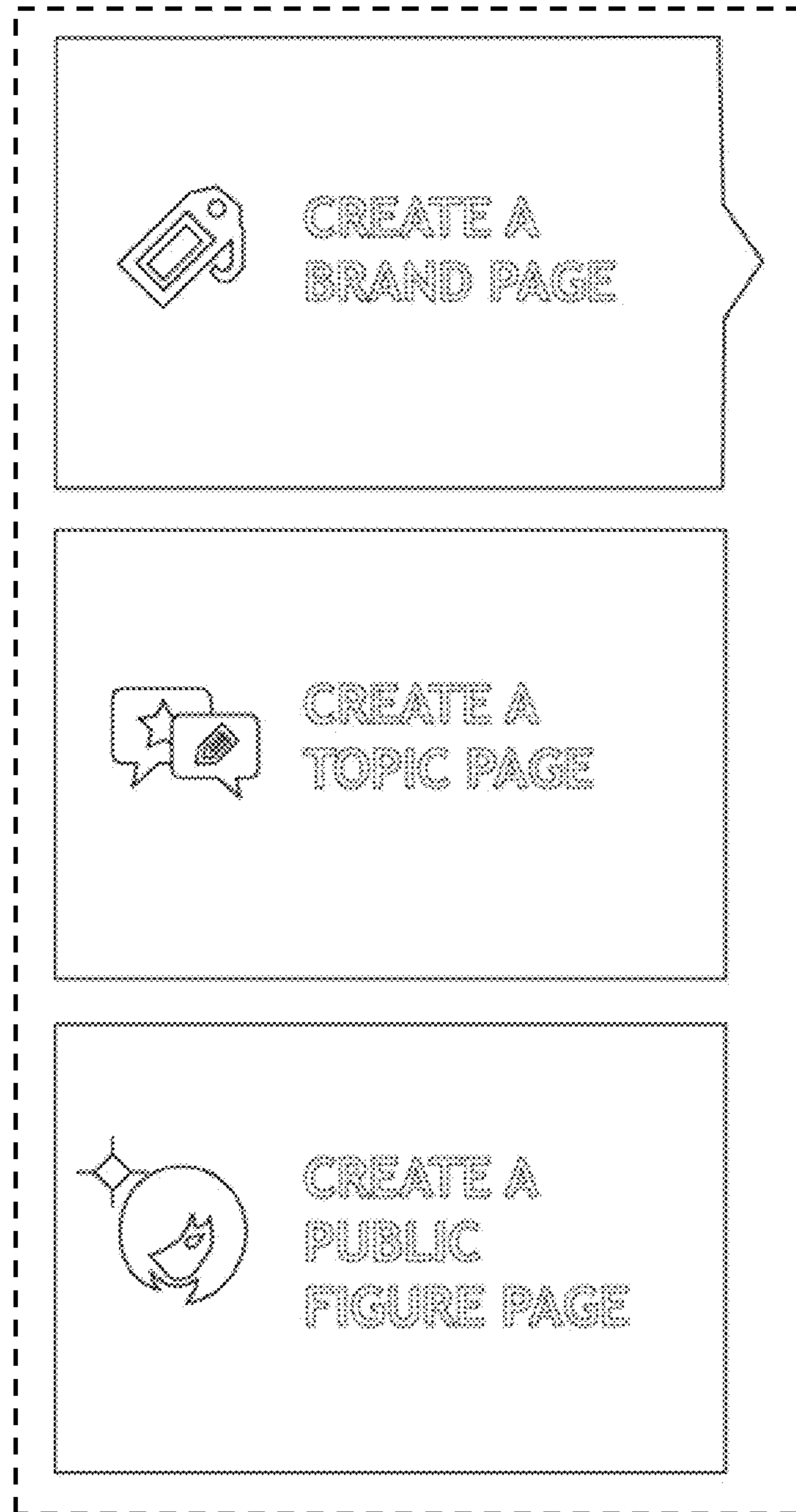
