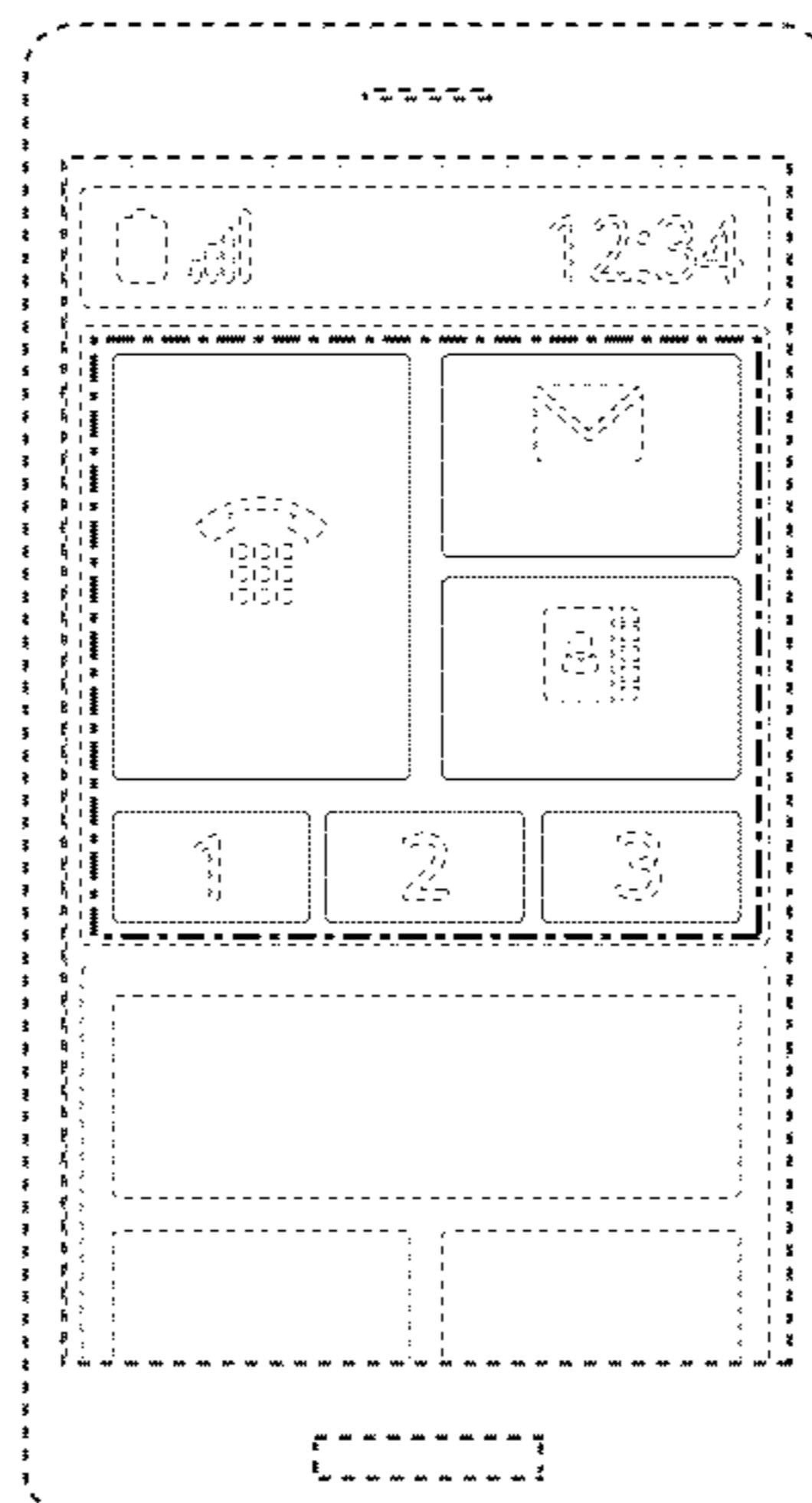
(57) **CLAIM**

The ornamental design for a display with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display with graphical user interface according to a first embodiment showing our new design; FIG. 2 is a front view of a display with graphical user interface according to a second embodiment showing our new design; and, FIG. 3 is a front view of a display with graphical user interface according to a third embodiment showing our new design. The broken lines showing the display and portions of the graphical user interface are included for the purpose of illustrating portions of the display with a graphical user interface and form no part of the claimed design. The dash-dot line represents the bounds of the claim and forms no part thereof.

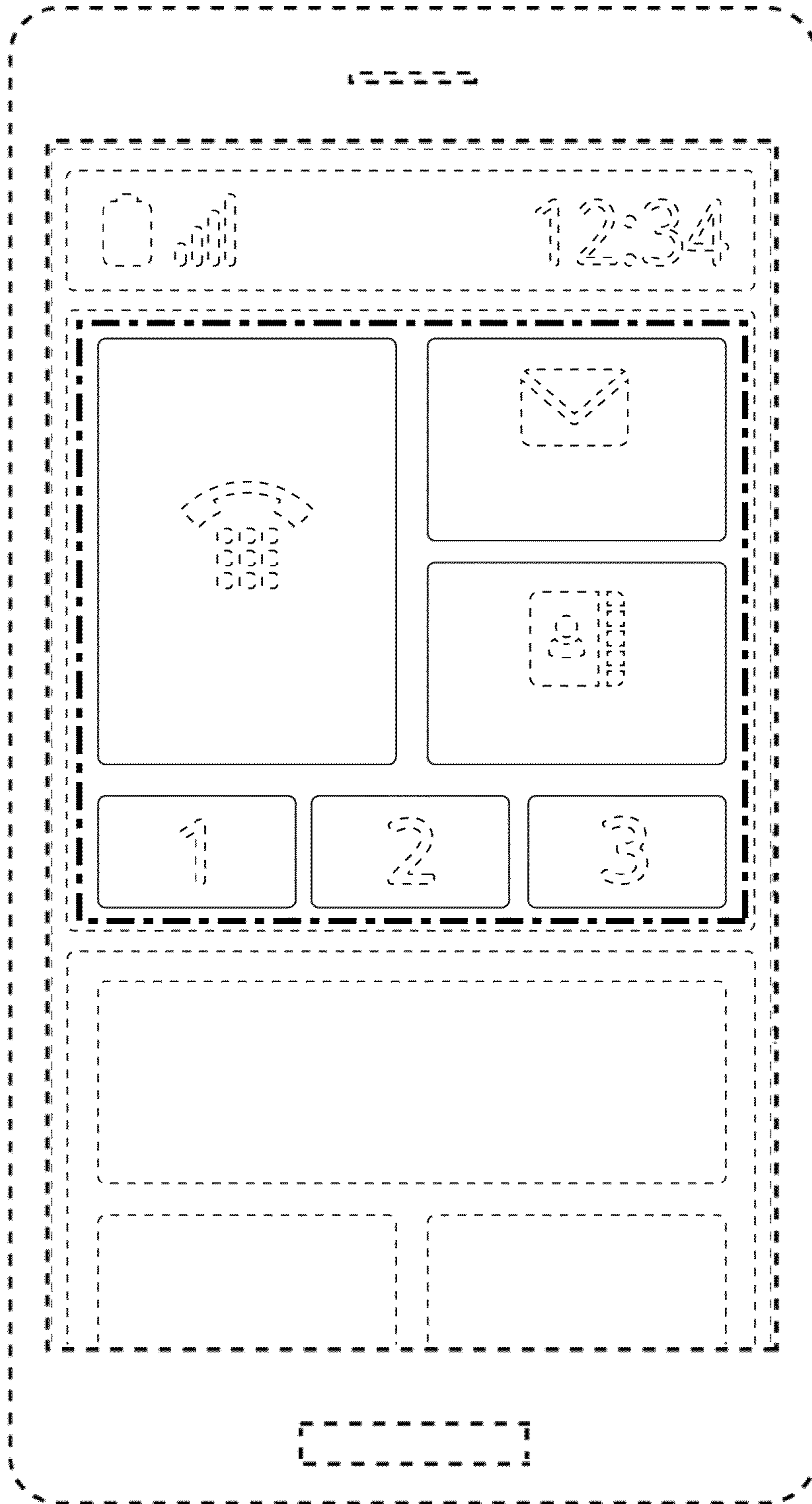

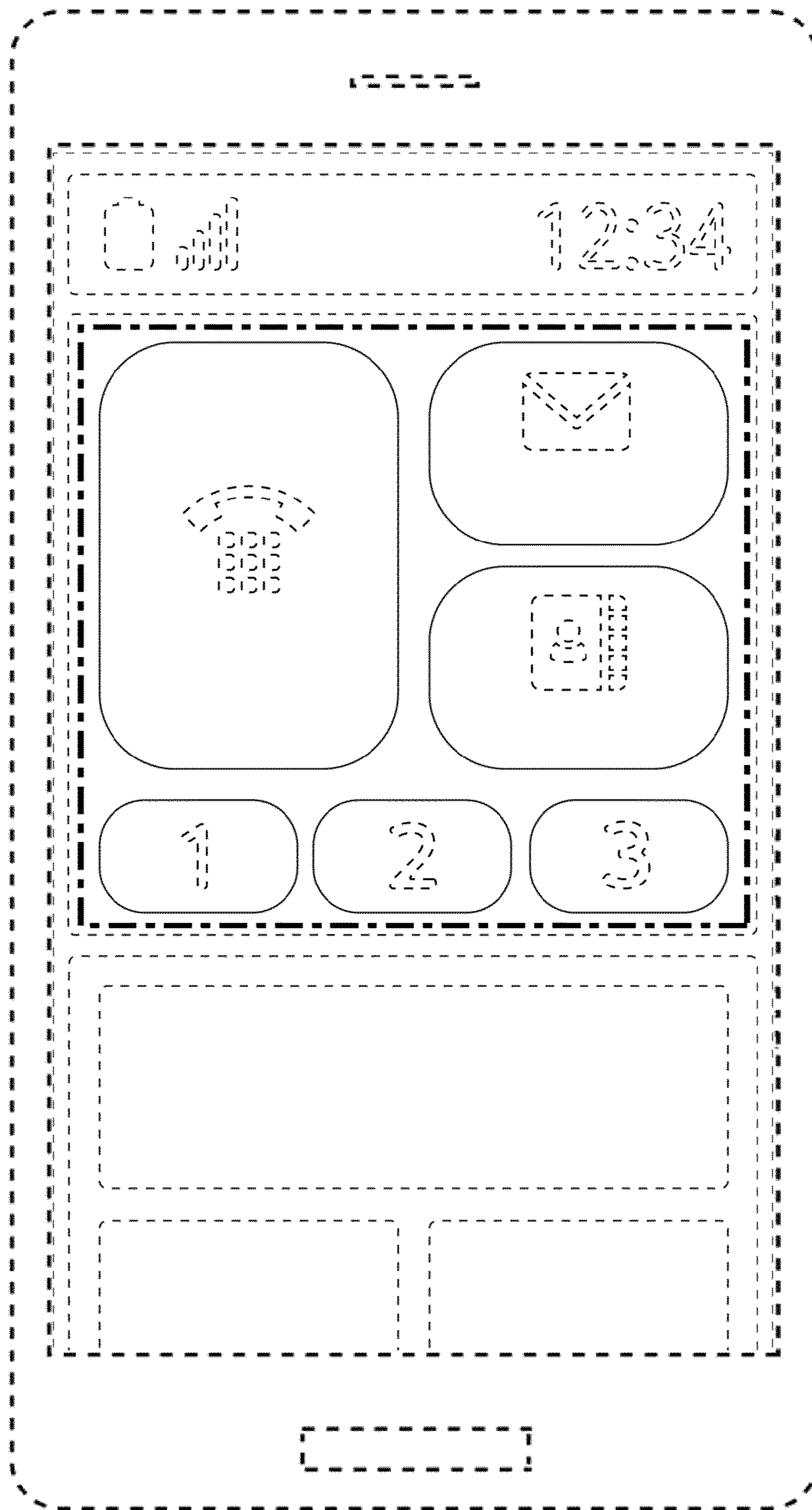
